Covid-19 clock ticking for Pakistan to learn from policy mistakes: Experts

ISLAMABAD: Pakistan still has a narrow window of opportunity to quickly learn from the experiences as well as errors of other countries in order to evolve innovative and comprehensive policy options for the coronavirus pandemic. The pandemic is also an opportunity for the nation to become self-reliant in pharmaceuticals, biomedical engineering and public health management on war footings.

This is not the time for a popularity contest and so some tough decisions, which could be politically costly, have to be taken to save lives and the economy, according to experts addressing the second session of a webinar series, 'Cov-

id-19: Global Challenge, National Response,' organized by Institute of Policy Studies (IPS).

Senior policy analyst Syed Muhammad Ali was the main speaker who covered different aspects of the pandemic challenges and presented viable policy recommendations. The event was jointly chaired by Dr Wagar Masood Khan, former federal finance secretary and member of IPS Academic Council, and Khalid Rahman, Executive President IPS. Regarding strategic measures that the government should initiate, Ali said these can include a national strategic medical supplies stockpile or database, national

and local levels, online crisis management training courses for quarantine center staff, initiation of a national crisis information management system, and monopoly of National Disaster Management Authority on all related information. He said in these trying times it is critical that Pakistan should lobby with other developing nations to ask the international financial institutions for a review of their financial arrangements and assistance programs based on humanitarian concerns.

Ali said the government has submitted a report with the Supreme Court that it expects 50,000 posi-

banking sectors as critical and manage them directly, he added. He stressed that ration distribution should be very effective in the areas that had been hit by insurgency in the past so that the anti-state elements are not able to exploit the crisis. Similarly, charity work and fund raising has to be legal, transparent and recorded to avoid serious consequences for Pakistan at Financial Action Task Force.

Ali said most of the strategic public sector organizations have more technical capacity than the private sector. As such the government has to decide which sectors can be used for crisis management. The Chamber of Commerce and Industry could review which goods can be produced locally by tailoring the production lines.

He was of the opinion that the large chain stores should create an app-based delivery system and collect payment through card swipe machines. The system could be extended to meat, poultry, milk, bakery and medical deliveries.

Speaking about the strategies adopted by countries with low infection rates, he said none of the Central Asian Republics - Kazakhstan, Kyrgyzstan, Tajikistan, Turkmenistan and Uzbekistan - along with Azerbaijan have reported more than 1,000 cases but the approach they have adopted is an example for the rest of the world. She said the nature of impacts in developing countries like Pakistan is different and the lack of resources in the situation of lockdown is having the worst impact on vulnerable segments of society including women. She said that the institutions that are

at the forefront while responding to the pandemic are coherently male-dominated and thus, the women's voices are excluded from the key decision-making on the response side. She said that drastic measures are required to ensure the access of women to healthcare and other essential services through inclusive decision-making.

Earlier, Dr Abid Qaiyum Suleri, Executive Director SDPI, noted that evaluating the impacts of the global pandemic on already marginalized segments including the women, is a pressing need of the hour. He said that the cash grants to most vulnerable families have been a positive step on the part of the government; however, "I would urge the authorities, especially the district administrations to disseminate the grant among the women while respecting their dignity and ensuring safe social distancing,' he emphasized.

State Bank Act

HE State Bank is a central pillar of Pakistan's economic management, and any reform of its constitutive law, especially if the reform is to touch on the core mission of the bank, must be carefully deliberated. At the moment, the State Bank Act endows the central bank with two core missions.

First is to ensure price stability and second is to support growth. There is nothing inherently unusual in this since many central banks around the world do have a mission to safeguard growth in addition to price stability.

The problem comes in when these two missions pull in opposite directions and the central bank leadership has to make a choice. Powerful political forces are unleashed in these times and the governor finds himself or herself in the centre of a policy storm which can get quite intense.

In the past, for example, the State Bank under the leadership of Ishrat Husain leaned too far in the direction of a permissive monetary policy to support the growth process ushered in by the Musharraf regime, thereby laying the groundwork for an inflationary spiral that began in 2005 and engulfed the entire economy by 2008.

Similarly, Shamshad Akhtar, his successor, found herself in the midst of a political storm when it became her job to put out the inflationary fire and safeguard the health of the financial system under the massive imbalances that had accumulated during the short-lived growth spurt that the Musharraf regime bequeathed to us.

Today, this history has gained new relevance because the State Bank Act is being amended under the ongoing IMF programme, and pressure from the Fund is to refocus the central bank's attention purely on the mission of ensuring price stability.

In an ideal world, this might sound like a good idea, since it has the virtue of ensuring that the monetary mistakes made in the Musharraf regime do not happen again.

But at the same time, it is important to understand that the State Bank cannot be a stand-alone entity altogether, and whatever amendments are made in its constitutive legislation carry the assent of the political leadership in Islamabad, along with the opposition.

The State Bank must, therefore, engage productively with the political leadership in helping draft these amendments, but it is the latter that will decide the limits of the possible in this case. In the meantime, the central bank clearly has a difficult balancing act to perform.

SDGs stress on ending poverty and deprivations, reduce inequality, improve health and education, and spur economic growth, while tackling climate change and working to preserve our oceans and forests, therefore all member nations adhered to accomplish these SDGs by year 2030. Pakistan has also, for example, ensured that the UN SDGs are taken seriously throughout domestic policy as well as framing the global 2030 Agenda for Sustainable Development, placing education, environment and healthcare at the forefront.In a sense, SDGs have become the cornerstone of global governance at all levels, even at the most micro-level of an institutional

and economic growth) and SDG9(industry, innovation and infrastructure) too. The impacts in the short-run are expected to be highly worrisome, because one very vitalelement to stimulate SDG8 and 9 is human capital that is under substantial strike.Moreover; the reliance on digital connectivity is a part of our life today and there is a possibility that digital or IT sector may grow faster in coming days, but consequentlywe got to ready to witness simultaneous crash and closures of traditional businesses. The developed countries may not have this situation as devastating, but as far as developing and under developed countries it is going to be dreadful. The reason is simple, a large part of the business sector in the developing world remains unorganized and does not have significant share in the digital space; causes include deficient human, physical and structural capacity.

This incapability or insufficiency of being accommodated in digital spaces will lead to more poverty, hunger, and inequalities thusobstructingachievements of SDGs1,2and 10 (reduce inequality) respectively. These are also the challenges to the equity dimension of holistic development by the pandemic and severely affecting SDG3 (good health and well-being).

They feel dejected and demotivated for almost no fault of theirs, and a probable demand for compensation by those responsible to cause them disease or hamper their economic activity, cannot be stated as unjustified. The relevant questionsappear: can the global justice system uphold such demand? can global and local institution put their foot down and let the peace prevail through justice by the strong institutions? is SDG16 still pragmatic and doable? Though current focus is on the alarming spread of Covid-19, but the developed world should focus on ultimate impacts on poorest and most vulnerable in social, economic and environmental terms, living in developing and underdeveloped countries, to leave no one behind, and that refers to SDG17 (Partnerships for the Goals). SDG17 restates a commitment of global partnership to realize the remaining 16 goals, and COVID-19 can be a decisively indicative test for this.

If economic giants particularly of the west do not offer a patronage and do not whole heartedly assist the countries with huge population but weak financialsettings, if financially settled countries remain blind to the miseries of people from underprivileged world during and due to COVID-19 crises, thenfulfilling SDG17 was never a true and sincere intention. Though UN working to fight COVID-19 but simultaneously the global community has to unite, learn lessons from each other and use this time to reset and to look at existing frameworks for some clarity including the SDGs.Our priority must be to inspire and enable the new dialogue for reform; how do we actually build the global and unified system that can deliver on the aspiration of the UN SDGs? Now more than ever the SDGs have reinforced the fact that how critical it is to have engagement of all sectors and industries, an approach that has been noticeably lacking in many areas including global public health. In context of Pakistan, pragmatically speaking, apparently COVID-19 has almost overpowered the majority, nearly all of SDGs and this detention seems not to finish soon, therefore Mr. Prime Minister must not overlook the matter and should assign the cabinet a task to find way-out for SDGs from the shackles of COIVD-19.

This is going to directly hit the SDG1(no poverty) and SDG2 (zero hunger), it seems that instead of alleviation, the poverty and hungerare most likely to experience elevation. This economic turmoil is associated and will gravely hit SDG8(decent work A recent report by UNESCO explicitly says that the COVID-19 pandemic is causing more than 1.6 billion children and youth to be out of school in 161 countries and impacting over91% of the world's enrolled students. The crisis crystallizes the dilemma for educational policymakers particularly of developing countries whether to completely suspend education or adapt to online learning systems. Developing countries like Pakistan is frankly not well equipped for traditional education even, and not at all ready for the hybrid educational mechanism, which means that the fundamental educational system is introuble already, thereforeSDG4 (quality education) presents a dream at a far distancefrom turning into areality.

SDG16 is about Peace, Justice, and Strong Institutions. And under COVID-19 crises many developing and underdeveloped world believes and views this pandemic as one spreadand imported by the privileged class through international travels and free mixing in the western ways

Pakistan-Bahrain bilateral relations: new dimensions

AKISTAN and the Kingdom of Bahrain share the most cordial brotherly relations that are finded in biotections. faith, social values and cultural fabric too. Bahraini people term Pakistan as their second home and state that Pakistan is the country which is held in the highest esteem by the leadership and the people of Bahrain.

Visit of H.E King of Bahrain, Sheikh Hamad Bin AL Khalifa in March 2014 was a paradigm shift in the history of bilateral relations of Pakistan and Kingdom of Bahrain. For the further strengthening of bilateral relations and fostering of bilateral trade volumes 17 agreements were inked signed during the state visit of King Hamad bin Isa Al Khalifa in March 2014, which also included a Bilateral Investment Treaty. Afterwards, there have been various spells of meeting to boost defense and security cooperation. Pakistan had helped Bahrain set up its naval forces and 18 percent of the Gulf States' Air Force comprises of Pakistani personnel. Moreover, there are over 400 companies currently operating in Bahrain, which are either jointly or wholly owned by Pakistani investors.

The Board of Investment (BOI) and the Economic Development Board (EDB) of Bahrain also played important role to promote business. It is now hoped that BOI and EDB will facilitate business meetings and exchange of delegations of the two countries in addition to bilateral visits, organization of road shows, exhibitions and business forums. It is hoped that mutual cooperation would be extended in various areas including agriculture, agro machinery, processed food, dry fruits, fresh fruits, cotton, milk and its by-products and leather to be processed at the earliest.

The business community of Pakistan urged the government to promote bilateral trade with Muslim countries particularly Halal food to earn maximum foreign exchange especially, with Bahrain. Being prominent regional expert of Kingdom of Bahrain it is suggested that the bilateral relations between the two brotherly nations may be further increased by initiating a number of diversified but integrated steps from both sides. Military cooperation between the two countries should be further increase and should not be taken as a regional security threat to any country. Pakistan may assist Bahrain in sophisticated defense & amp; security equipment and military training and resources including non-combatant equipment.

(SMEs) cooperation and trade and export may be further increased in areas such as textile, food and hospitality, which are found to have substantial scope for Pakistan. Telecommunications, tourism, infrastructural development and real estate development sectors are developing rapidly and offer attractive investment opportunities for Bahrain in Pakistan. Foreign investors are allowed to have 100 per cent ownership of their business, with no restrictions placed on capital repatriation, currency exchange and transfer of dividends in Bahrain. So, extended volumes of investments would bring desired dividends of greater economic integration, socio-economic prosperity and regional conflict resolution between the two countries in the days to come.

Being prominent regional expert of Kingdom of Bahrain it is strongly suggested that translating the political goodwill and fraternal bonds existing Pakistan and Kingdom of Bahrain into a strong economic and trade partnership to the mutual benefit of the people of the two countries private sectors of both the countries should play a leading role.

The Federation of Pakistan Chambers of Commerce and Industry (FPCCI) said that Pakistan is experiencing a new dawn of economic revival and Bahrain should partner with it for mutual benefits. Bahrain should look into the unmatched business opportunities in Pakistan with a special focus on the project-based financing and Islamic banking. Currently, almost 400 Pakistani companies are working in Bahrain and the number is on the rise. ahrain has central location in the Gulf with a highly diversified economy and enhanced linkages will boost flow of investments. Pakistan can learn from Bahrain's economic diversification and expertise in the energy sector. An early trade treaty between the two countries will benefit each other, as Pakistani textiles should find place in the US market due to Bahrain's free trade agreement (FTA) with the US and Manama can explore markets in Pakistan. i. Tajikistan ratifies accird on supporting families living in CASA 1000 area

EMBERS of Tajikistan's (NSIFT) and the World Bank. (Majlisi The World Bank's Board of Executive Directors approved the CASA 1000 Community Support Project for Tajikistan on March 21, 2019. Total Project cost is reportedly US\$ 26 million, including a \$24 million grant provided by the International Development Association (IDA) and \$2 million allocated from the CASA1000 Multi Donor Trust Fund (MDTF).

The objective of the CASA1000 Community Support Project for Tajikistan is to increase the quality of, and access to, energy, social and economic infrastructure services, and to contribute to the strengthening

of local governance in communities in the project area. There are four components to the project, the first component being rural electricity supply improvements.

Component one focuses on improving the quality of electricity supply in two target areas of the country: 1) the estimated 60 villages that lie within the CoI in the northern, central and southern segments of the Transmission Line as it passes through Tajikistan; and 2) selected villages in the district of Isfara of Tajikistan, located near the Transmission Line as it passes through the Batken oblast in Kyrgyzstan. This component includes three components: village electricity supply improvements in the corridor of impact; Isfara-1 substation and village electricity supply improvements in border areas; and energy-related project management, monitoring and evaluation, and communications. The second component is the community-led Investments in socio-economic infrastructure. This component includes two subcomponents: subgrants to communities in the corridor of impact, and subgrants to communities in border areas.

The third component is the community mobilization, capacity building and local governance. This component includes four subcomponents: community mobilization, youth engagement and capacity building, support for social accountability and transparency, and capacity building for improved local governance. Finally, the fourth component is the project management.

This component includes three subcomponents: project management and coordination, monitoring and evaluation, and communications.

In all, more than 130,000 people living in 60 villages and 24 jamoats in Sughd and Khatlon provinces as well as districts subordinate to the center are expected to get benefits from implementation of the CASA 1000 Community Support Project.
