ISLAMABAD: As many as 2,521 new coronavirus cases and 74 deaths were reported in the country over the past 24 hours, taking the national tally of cases to 248,872 and fatalities to 5,197. According to the National Command and Operation Centre, 2,521 new cases were detected after 24,211 tests were conducted in the previous 24 hours. 86,975 COVID-19 patients are undergoing treatment while 156,700 patients have recuperated from the disease. 15,626,38 tests have been conducted across the country so far.

ISLAMABAD: Kashmiris on both sides of the Line of Control and world over will observe Kashmir Martyrs Day tomorrow to pay homage to martyrs of July 13,1931. In occupied Kashmir, the All Parties Hurriyat Conference has appealed to the Kashmiri people mark it by a complete strike in the territory.

On the 13th July 1931, the troops of Dogra Maharaja had killed 22 Kashmiris, one after the other, outside the Central Iail in Srinagar during the court proceedings against one Abdul Qadeer who had asked the Kashmiri people to defy

the Dogra rule. The APHC spokesman in a statement issued in Srinagar said that on 13th July 1931, when it was time for Namaz-e-Zuhr, a young man, started the call for prayer (Azaan) but was shot dead by the Maharaja's soldiers. Thus, 22 youth sacrificed their lives till

the completion of Azaan. The spokesman said the aim of the strike call is to stress the urgent need for a peaceful and just solution to the Kashmir dispute and to end the cycle of oppression against the Hurriyat leaders and the Kashmiri people. He also appealed for a march towards the Mazar-e-Shuhada, Nagshband Sahib in Srinagar on the day where the martyrs of 1931 are buried.

KARACHI: Chief Minister (CM) Sindh has accused that the children of Gilgit-Baltistan were given wrong polio vaccine and demanded an investigation into the matter. Addressing a press conference in Karachi, he said that the polio spread in Gilgit-Baltistan last year was due to the wrong vaccine. Two cases were also reported in Karachi even though we had eradicated the polio virus in 2018.

Who is involved in the drug scandal should be investigated by the media and also to find out that who has been importing the vaccine, he said. CM Sindh Murad Ali Shah said that the way the federal government treats Sindh is not even done to an international agency.

ISLAMABAD: Pakistan's decision to impose smart or selective lockdowns in hotspot areas is yielding desired results. Country reports a 28% reduction in critical cases due smart lockdowns and implementation of SOPs As countries around the world juggle with strategies to flatten the Covid-19 curve, Pak strategy won an unexpected endorsement from the UN Secretary-General Antonio Guterres. In a subtle acknowledged on Twitter, Guterres said that there is no choice between health or jobs in the fight against the Covid-19 pandemic. "They are interlinked. We will either win on all fronts or fail on all fronts," said the UN Secretary-General. According to data collected by The Express

Tribune, a significant reduction in the num-

ber of positive cases has emerged as the

country crossed the 100-day mark in its fight against the respiratory disease which has claimed more than 5,000 lives.

"Smart lockdowns, a stronger enforcement effort, compliance of SOPs and the nationwide change in the behavior can be credited for the current gains in the fight against the Covid-19 virus," reduction was recorded in the number of critical cases as a result of the selective lockdowns and implementation of SOPs introduced by the National Command and Operation Centre (NCOC). The strategy "The prime minister was the first one to advocate for smart lockdowns. Countries around the world, Umar said, have realized that it is simply unsustainable to shut entire nations. "The only way is to identify high-density hotspots and target them accordingly.'

As long as the hotspot areas are taken out of the whole network, the minister said, the cumulative impact is reduced. "That coupled with behavioral change has helped Pakistan in controlling the contagion," he claimed. The concept of smart lockdowns, when presented by Prime Minister Imran Khan, was fiercely opposed.

But as the country appears to be on course to flatten the Covid-19 curve, its strategy is being endorsed by a number of developed nations. Germany, Italy, and Portugal are now considering local shutdowns to prevent a new surge of coronavirus infections. More and more countries are shutting down smaller regions as opposed to bringing their entire nations to a halt. Despite receiving flak from all corners, the prime minister stuck to his guns. He supported the smart lockdown strategy over nationwide shutdowns to prevent the spread of the disease and protect people below the breadline from economic hardship.

The policy, experts believe, appears to have been validated by a recent report by Oxfam. The leading UK-based charitable organizations focusing on the alleviation of global poverty warned that the Coronavirus pandemic could kill more people through hunger than the disease itself. "Many people in middle-income countries who were on the breadline are also said to have been tipped over the edge by the health crisis," said Oxfam.

Through the NCOC, the government has implemented a series of measures. In total, the government's central response unit has imposed more than 500 smart lockdowns to control the disease from spreading. "So far, we imposed 551 smark lockdowns across the country," said one senior official at the National Command and Operation Centre (NCOC), which serves as the nation's nerve centre in the battle against Covid-19. In total, 8.2million are currently under lockdown," he revealed.

PBF says country economic growth must **be at 7%**

ISLAMABAD: Businesses Forum (PBF) on Sunday said country has a dire and well-established need for wide-ranging structural and institutional reform. The required reforms encompass tax administration, the wider civil service, management of state-owned enterprises, the energy sector, regulatory agencies, the central bank as well as the regulation of the corporate sector, among other areas. Talking to business community, President PBF, Sahibzada Mian Usman Zulfiqar said even there is no political will to reform the police. The latest Police Reforms Committee report prepared in January 2019 is gathering dust. Police in Pakistan must be depoliticised through democratic institutional oversight. The role of police as service provider and an institution that protects citizens must be consciously pursued to change the present militarisation of internal security. He said Pakistan's low economic growth since 1990 is more to do with lack of institutional reforms rather than external factors. "The rot had set in somewhere be-

ISLAMABAD: Excise and Taxation department has asked the Islamabad registered vehicle owners to pay their token tax at any National Database and Registration Authority's (Nadra) e-sahulat centres across the country to avoid long queues amid COVID-19. The motorists can

avail the opportunity after getting them reg-

istered on City Islamabad app, developed by National Information Technology Board (NITB) for the federal capital dwellers to provide them public services of local administration department through online. The visitor would show the code at the e-sahulat center, received on the app so the payment could be done. The system was connected with all e-sahulat centre of NADRA, said Director Excise Bilal Azam while talking to APP.

To a query, he said there would be no gathering as there were multiple e-sahulat centres working across the country. The department was also considering direct online payment methods to pay vehicle token fee, registration and transfer fee through integrating credit cards, bank accounts and other payment methods, he said while responding to another query and hoped that the things would be done soon.

Meanwhile, the federal capital citizens have complained about the issues being faced while visiting e-sahulat centres and using the app. They urged the authorities to resolve their grievances on war footing to relief the masses and make the whole payment system online so the people may submit their fees without visiting the offices. - APP

Road accident claims one life in Matiari district

ISLAMABAD: A passenger coach collided with a motorcycle-rickshaw on the National Highway near Matiari district, killing at least one women and injuring four others. According to Rescue sources the accident occurred because the coach tried to overtake another vehicle on the road. It smashed into the rickshaw and claimed one life.

Rescue officials reached the site of accident and shifted injured and body to nearby hospitals. The police have impounded the coach and sent most of the passengers off in other buses, a private news channel reported. – APP

Hurriyat leader Ashraf Sehrai arrested in Srinagar

ISLAMABAD: In Indian occupied Kashmir, Indian police have arrested senior Hurriyat leader and Chiarman of Tehreek Hurriyat Jammu and Kashmir, Mohammad Ashraf Sahrai and booked him under the draconian Public Safety Act (PSA) in Srinagar, Sunday. According to Kashmir Me-Service, Mohammad Ashraf Sahrai was arrested from his residence at Baghaat Barzulla in Srinagar in the wee hours of Sunday. "Authorities have booked Ashraf Sahrai under Public Safety Act", a top police officer confirmed to media men in Srinagar.

Sehrai's son, Junaid Sahrai, was martyred by Indian troops during a cordon and search operation along with an associate at Nawakadal area of Srinagar recently. "He was wanted in multiple cases," Occupied Kashmir's Director General of Police (DGP) Dilbagh Singh said.

565 new cases of corna reported on in Puniab

LAHORE: The COVID-19 has taken away 21 more lives in the province, while the number of coronavirus cases in the province reached 86,556 after registration of 565 new cases till Sunday morning. According to the spokesperson of the Punjab Primary and Secondary Healthcare Department, total number of deaths has reached 2006 in the province. The Punjab health department conducted 589,523 tests for COVID-19 so far, while 55,175 confirmed cases have been recovered all together in the province. The department also appealed the masses to follow SOPs for their protection. - APP

Polio vaccination resume from July 20

ISLAMABAD: Pakistan will resume polio vaccination activities on July 20 with a campaign in selected districts after a four-month suspension of all polio vaccination activities due to COVID-19 pandemic. According to an official of the National Emergency Operations Centre (NEOC), Polio Eradication Programme, the government has decided to reach the eligible children with all essential vaccines and relaunch small scale door to door vaccination round since suspension during March in the context of COVID-19.

He said that the first round of the campaign will be launched in districts included Faisalabad, Attock, South Waziristan, and parts of Karachi and Quetta with a target to vaccinate almost 800,000 children under the age of five. He said that under the guidance of the Ministry of National Health Services and following the Global Polio Eradication Initiative (GPEI) guidelines and Polio Oversight Board recommendations, the Pakistan Polio Eradication programme had suspended all polio related activities in the last week of March, except surveillance.

TASHKENT: It is planned to save 3.3 billion kWh of electricity and 2.6 billion cubic meters of natural gas in the economy of Uzbekistan over 2 years due to energy efficiency measures.

Such parameters are provided for by the resolution of the President of the country PP-4779 adopted "On additional measures to reduce the dependence of economic sectors on fuel and energy products by increasing the energy efficiency of the economy and utilizing available resources" on 10 July 2020.

Energy efficiency or, in other words, the rational use of energy resources in economic and social sectors is an important

factor in increasing the profitability and competitiveness of the manufacturing sector and energy saving, which in turn has a serious impact on energy security, job creation, the growth of well-being of the population and in general development of the country. From 1 August, the document establishes a tariff for guaranteed purchase of electricity from newly commissioned solar, wind and biogas power plants, micro and small hydroelectric power stations (HPPs), including surplus electricity produced for own needs. It is fixed that the determination of investors for the construction and operation of industrial power plants based on renewable energy sources (RES), except for hydropower plants, is carried out only through tenders. The document for the

period from 15 July to 31 December 2020 establishes privileges for manufacturers who organized the third (night) shift in the form of applying a reduction factor in

payments for the used electricity. For enterprises with at least 50% of the state's share, the possibility of reducing the mandatory requirement for prepayment (up to 30%) for natural gas and electricity will not be used. The resolution approved the target parameters for saving fuel and energy resources in the sectors of the economy for 2020-2022, envisaging energy savings of 3.3 billion kWh, natural gas - 2.6 billion cubic meters, oil products - 16.3 thousand tonnes. The document also approved the Roadmap for improving energy efficiency in large enterprises and the schedule for

energy audits. The resolution approved the structure and identified sources of financing, the previously created extrabudgetary Interbranch Energy Saving Fund, which is part of the Ministry of Energy of the Republic of Uzbekistan. It has been established that the funds of this Fund are used for: financing the preparation of feasibility studies for projects to improve energy efficiency, including improving thermal protection of buildings and multi-apartment buildings; the creation of thematic training centers; development of relevant startups and participation in the authorized capital of enterprises for the production of installations of renewable energy sources, heat pumps, capacitor banks and other products

aimed at improving energy efficiency. The resolution gave a number of instructions to the responsible structures, including the Ministry of Energy. In particular, it is prescribed within 2 months to ensure the involvement of leading companies (domestic and international) for energy audits at 285 large industrial enterprises, as well as to make a proposal to expand their list. The document envisages the creation of the Unified Information System of the Ministry of Energy, commissioning, which is scheduled for the end of 2021. Based on the analytical data obtained from the Unified Information System. a mechanism for mandatory energy audits of enterprises with high energy consumption will be introduced.

The water level in the Jhelum River at Mangla Dam was 1224.60 feet, which was 184.60 feet higher than its dead level of 1040 feet whereas the inflow and outflow of water was recorded as 43,600 cusecs and 25,000 cusecs respectively. ISLAMABAD: Saudi Arabia has offered financial assistance for the construction of Pakistan's first sate-owned Quran complex in Islamabad, officials confirmed on Sunday.

Religious Affairs Minister Pir Noorul Haq Qadri announced that the government wanted to build the complex in the federal

capital to preserve historical manuscripts of the Muslim scripture. "This would be the first

government-owned Quran complex. We have got offers of financial assistance for the building of the complex from Saudi Arabia, the Saudi-based World Muslim League and some other Gulf countries," spokesman of the Ministry of Religious Affairs and Interfaith Harmony, Imran Siddiqui said in an interview with Arab News. He added that the ministry has already initiated the process of land acquisition near the Golra area of in the Islamabad Capital Territory.

The center will also oversee and set standards for the publication of the Quran in the country and would recycle worn pages of the holy book.

"This would be a huge complex on approximately 10 kanal land in Islamabad. The complex will have different sections like error-free publication of new Quran and a plant for the recycling of worn pages of the book gathered from all over the country," Siddiqui said. Dr. Masoom Yasinzai, rector of the International Islamic University Islamabad (IIUI), hailed the plan as one that can be unifying

for Muslims. "In this Quran complex they should also work on research to unite all the Muslim from different schools of thought in Pakistan. The government should take guidance from the Quran complex in Medina. It should have a proper board, editing, evaluation and monitoring system for the error-free printing of the Quran," he said.

According to Dr. Muhammad Khalid Masud, former chairman of Pakistan's

Council of Islamic Ideology, it is a constitutional obligation of the government to oversee the publication of the Quran.

"Under the Constitution of Pakistan, it is the responsibility of the government to ensure error-free publication of the Quran. It would be a good step if the government can implement standards like Saudi Arabia for the publication of the holy book in Pakistan," he said.

Airblue identifies two pilots with suspected fake degrees

ISLAMABAD: Airblue has submitted a report to the Supreme Court of Pakistan on the verification of its pilots' licences and said only two pilots possess suspected fake credentials. Chief Justice Gulzar had ordered the heads of Airblue, PIA and Serena Air to verify the licences of the pilots in their employ and submit a report. The Ministry of Aviation sent Airblue a list of nine pilots it employed that possess suspected fake licences. Seven pilots on the list left the airline in 2014, 2015 and 2018. The remaining two pilots, Fida Khalil and Naveed Khokhar, were still serving in Airblue. Khalil resigned on July 5 and Khokhar had been suspended on June 26.

He has filed an appeal so further action against him is pending until the appeal is decided on, read the report. "During the years 2018-19, 100 pilots were working in Airblue Ltd. All their educational certificates and degrees were put under verification and as per report of concerned institutions the educational certificates and degrees of 98 pilots were found correct and genuine."

PSA wants schools reopened

Kashmir marks the 89th Martyrs Day on 13 July

ISLAMABAD: Kashmir marks the 89th Martyrs Day on 13 July, the day in 1931 when twenty-two Kashmiri civilians gave their lives in a tragic incident that lives in the memory of millions as a story of courage and sacrifice. The 22 Kashmiris were killed for reciting the Muslim call to prayer, or azaan, which was banned in Kashmir at the time. One by one, they stepped forward to recite as each was killed by a single bullet.

In 1846, Britain as a colonial power sold Kashmir to a wealthy Indian Maharaja named Gulab Singh. He was a ruthless monarch. He set out to humiliate the majority Kashmiri Muslims. In July 1931, Singh banned the azaan, the call to prayer rendered at mosques.

A Kashmiri man, named Abdulgadir, was arrested by maharaja's soldiers and tried for sedition. On the day of his trial, on 13 July 1931, thousands of Kashmiris gathered outside the prison awaiting the result of the trial. During the wait, it was noon prayer time, known to Muslims as Zohr. One Kashmiri stood up and recited the azaan. Before he could complete it, he was shot and killed by maharaja's police. Another Kashmiri man took his place and attempted to complete the azaan but was shot to death. A third man rose, and then a fourth. In the end, a total of twenty-two men were killed, each one of them having recited a part of the call to prayer until it was read out in full. Every day for the past 89 years, Kashmiris have faithfully marked Kashmir Martyrs Day to commemorate the sacrifice of these men for freedom. History is made of such stories. Nations rise when its sons and daughters feed national pride with compelling examples of sacrifice.

RCCI urges Govt to address cottage industry issues

RAWALPINDI: The Rawalpindi Chamber of Commerce and Industry (RCCI) has urged the government of Pakistan to address the grievances of cottage industry amid Covid-19 and smart lock-down. RCCI President Saboor Malik in a statement said that due to lockdown, smart lockdown and complete lockdown on weekends (Saturday and Sunday) the business of cottage industry, Small industry and Retailer Furniture has been affected largely. The lock-down policy should be

based on ground realities. "The two major industries are believed to be the economic barometers of any country- one is small and medium enterprises and the second is cottage industry. The growth of these two important sectors help flourish the country's economy," he further added. Businesses linked with the

cottage industry should be open 7 days a week under strict SOPs, he suggested. The RCCI president said that the Chamber in its Budget recommendations



had demanded that tax incentives should be given to local industry to promote imports substitution and GST should be reduced to single digit level to bring down cost of doing business. Moreover, as huge loss is caused to the businesses since lockdowns implementations, the governments should provide interest free loans, he added. The status of cottage in-

dustry be revived and the government should through notifications should provide at least half concession against 6 months rents. Concession on property tax be also announced by the governments, he demanded. All Sales Tax of this year be exempted.

"People with comorbidity at high risk of severe COVID-19"

ISLAMABAD: "People with comorbidity are at high risk of severe status of COVID-19. Elderly people particularly with heart disease, lung disease, diabetes, obesity, liver disease and any other ailment going on must be very careful. The current pandemic is an emerging infectious disease.'

This was stated by the famous Physician Prof. Dr. Wasim Jafri while speaking at the COMSTECH webinar titled, "COVID-19 Pandemic and Related Health Issues." The webinar was attended by more than 78 health professionals from the OIC member states. Coordinator General COMSTECH Prof. Dr. M. Iqbal Choudhary also spoke on the occasion.

Prof. Wasim Jafri pointed out that diabetes could not be ignored at all as diabetes made everything worse including this fatal disease. The proportion of severe disease increases with age and so is the case of the death but must not neglect the younger population, he said. - DNA

ISLAMABAD: Experts and civil society representatives speaking to a webinar criticized Capital Development Authority (CDA) for its tug of war with Metropolitan Corporation Islamabad (MCI) since the inception of the latter for the last over four years. They said citizens have badly suffered from the illogical rift as the civic services and environmental conditions have deteriorated over a few years of the local government system in the federal capital. The tug of war between the two, the city managers and the peoples' representatives, over the funds and authority have spoiled the sustainability of the entire system of service delivery.

The civil society reps highlighted that water shortage, lack of proper management of domestic waste and sewage, broken roads, diminishing green cover and belts and irrational development have marred the sustainability of the city. Development Communications Network (Devcom-Pakistan) organized the webinar on the subject "Population and Sustainable Urban Practices for Islamabad" on Saturday to mark the UN World Population Day. The webinar was conducted and hosted by Devcom-Pakistan and

DTN Director Munir Ahmed who is a well-known environmentalist and climate advocacy expert. Zeeshan Naqvi said Metropolitan Corporation Islamabad (MCI) was allocated PKR 14 billion two years back for different project proposals but no penny was released so far. Even the MCI cannot use the tax it collects from different sources because the MCI Rules of Business are not approved as yet by the government. The MCI House has approved the schemes of small dams on eight natural streams originating from the foot of Margalla Hills, improvement in the sewage treatment plants, repair and provision of water, filter plants, maintenance of parks. They are all possible if the funds are provided. We are handcuffed by the government, perhaps, because we belong to the opposition party. Nagvi said the encroachments

cannot be removed without the support of ICT district management. Despite repeated requests MCI was not extended due cooperation by the district management to remove illegal constructions from the green belts and national park areas. However, he said, MCI is trying

to take care of the city with whatever limited human resources and funds are available. Collection of domestics waste has been improved while working on the landfill site, trying to improve the conditions of parks besides efforts are underway to overcome shortage of water supply. He asked the government to urgently start a process of amendments in the rules and regulations framed for the capital city to ensure rights to the locals. He said legislation is needed on the contradictions in the same zone that perturb the rights of citizens.

Talking about the new paradigm of sustainable urban management, the water and climate expert Ali Tauqeer Sheikh said resilience of the city matters that how good coping mechanisms are in place to face the disasters, urban flooding, impact of harsh weathers, water scarcity, recycling and waste management systems. He said the concept of smart city for Islamabad is already underway but without meaningful measures it would not be sustainable.

The population density becomes more productive in terms of socioeconomic outcomes if they have opportunities to be productive. The federal city is expanding beyond limits without any planning and resource management that would become liability soon if conditions remained so. Devcom-Pakistan Director Munir Ahmed said civil society representatives and experts should play their role in bridging the conflicts among the city managers ICT district management, CDA and MCI for the sake of citizens. He also urged the government to urgently release the funds so that development projects should begin to improve the civic and environmental conditions in the federal capital.

Mome Saleem urged the government to take immediate steps to remove encroachments from the green belts and national park areas. Saadat Ali said a comprehensive plan is required to segregate 750 ton waste at source and its disposal in an adequate manner.

Trade deficit

Decline in trade deficit is normally good news, but not if it shrinks by as much as 27 percent. According to reports, Pakistan's trade deficit shrank to slightly over \$23 billion in the last fiscal year. From July 2019 to June 2020 it was a 27 percent decrease in comparison with nearly \$32 billion in the previous fiscal year of 2018-19. The Pakistan Bureau of Statistics (PBS) has released its official data showing that Pakistan exported nearly \$21.4 billion worth of goods in the last fiscal year, whereas the target set for such exports was around \$24 billion. So, there was a shortfall of \$2.6 billion in exports showing a sluggish performance of the sector.

Exports in 2018-19 amounted to \$23 billion and the PTI-led government had set a pretty modest increase target in exports of just one billion dollar, but the country's economy could not even match the previous year's mark of \$23 billion. A nearly seven percent decline in exports is a reflection of the worsening potential of our domestic economy to compete in the world market. In terms of imports the country has seen \$44 billion worth of imports compared with nearly \$55 billion in the previous year. This decline by nearly 11 billion dollars is not a cause of any jubilation. If the trade deficit declines as a result of an increase in exports, it is good news, but a sharp decline in imports with no substantial improvement in exports shows a faltering economy that can neither export nor absorb import to fuel its potential. Though the government claims that the import bill compressed thanks to the plummeting oil prices in the international market, the fact is that it happened only in the last quarter of the fiscal year from April to June and that was the same period when the Covid-19 pandemic also surged in the country.

The point of concern is that the prices of oil in the international market are bouncing back and the Covid-19 pandemic is also likely to subside, but the economic and financial manager of the country appear to be lacking in initiative to tap the new opportunities. For the time being some relief in debt payments and some new loans have injected a pulse of life into the economy but the country needs a sound strategy to boost exports that will result in better tax collections. Frequent changes in the top slot of the Federal Board of Revenue are another cause of concern. The coming months will be challenging for the economy for the government, and its economic managers must brace for it.

URHAN Wani, the popular Commander of Hizb-ul-Mujahideen was martyred by the Indian government forces in the Indian Occupied Kashmir (IOK) on July 8, 2016. After the martyrdom of Burhan Wani, widespread and spontaneous protests erupted throughout the IOK. In order to control the mass movement, the Indian occupation forces unleashed reign of terror against the Kashmiri civilians. As a result more than 300 people embraced martyrdom and around 30,000 got injured. The uprising in the Indian Held Kashmir did not end within a few weeks or months. It continued, and still continues, as Wani's blood gave new strength to the Kashmir's struggle for independence.

Wani, in his early 20s, had become the face of

the struggle in Kashmir and over the last five years was using social media like Facebook to reach out to young Kashmiri men to continue their movement for the independence of Kashmir. He became voice of the Kashmiri youth and his popularity irritated New Delhi. When Indian fanatic Prime Minister Narendra Modi, the leader of the ruling party BJP, came to power, he accelerated anti-Kashmir moves. Since August 5, 2019 Modi's government ended special status of the Jummu and Kashmir to turn Muslim majority into minority in the Indian Controlled Kashmir Kashmir. Implementing the August 5 announcement, Indian central government issued a notorious map on October 31, 2019. In accordance with it, Jammu and Kashmir was bifurcated into two union territories-Jammu and Kashmir and Ladakh. Besides, Modi-led government's malevolent acts such as more than nine month's lockdown in the IOK, martyrdom of thousands of the Kashmiris there, introduction of new domicile law against the majority of Kashmiris, issuance of domicile certificates to 25000 non-Kashmiris, persecution of religious minorities especially Muslims, anti-Muslim laws-CAA/NRC, assaults on Muslims by the fanatic Hindus, blaming Indian Muslims and Pakistan for spreading coronavirus in India and the IOK etc. and intermittent shelling inside Pakistani side of Kashmir in relation to the Line of Control (LoC)-which has killed hundreds of innocent villagers, indicate 'Modi's fascist India'. Thus, New Delhi completely ended any sort of dialogue with Islamabad to settle the Kashmir issue.

Despite the deployment of 900,000 troops in the IOK and intensification of firing by the Indian forces in wake of shortage of foods and even medicines for the patients, innocent Kashmiris are still violating the lockdown by protesting against Indian illegal actions. In order to con- brated on July 8, 2017 by Pakistanis and Kashceal India's state terrorism, Indian Controlled Kashmir has been cut off from the world due to lockdown. But, some reports and images are appearing in the world and the social media, which show extrajudicial killings of the innocent people by the ruthless Indian forces.

Dreadful practice of Indian state terrorism could be judged from the martyrdom of a 65 years old person Bashir Ahmed Khan on July 1, this year in front of his grandson by Indian troops in Sopore, Srinagar, Local Kashmiris and family of the martyred said that the unarmed "Khan was dragged out of his car and shot dead by paramilitary troopers". His three-year-old toddler grandson, who was travelling with him, was later pictured sitting on his chest. The awful photo of the child, which appeared in the social media, shocked the international community.

Reacting to the incident, Amnesty India said, "It is a breach of the best interests of the child principle as required to be the basis of any action by authorities under the Convention on the Rights of the Child, to which India is a state party." A day after the horrifying event which triggered massive outrage and protests in Indian Kashmir, the UNO said that "whosoever responsible for the killing in Sopore, has to be made to account for it." Foreign Minister Shah Mehmood Qureshi stated that the image of the three-year-old sitting on his grandfather's "lifeless, bullet-ridden body exposed the real face of Prime Minister Narendra Modi's fascist India". Nevertheless, this merciless event displays that India does not have any qualms about murdering any Kashmiri civilian as part of extrajudicial killings. And many civilian Kashmiris have become permanently blind due to pellet guns shots and chemical weapons, used by the Indian military and paramilitary troops. Curfew-type shutdown remained in the IOK. Almost 14,000 people were arrested or detained. During special operations-house to house search, India military and paramilitary troopers have martyred and injured tens of thousands the Kashmiris, including women and children. These cruelties have compelled the Kashmiri youngsters to pick arms and to target the Indian forces, sacrificing their lives for the right of self-determination, as recognized by the related UNO resolutions. Therefore, intermittent gunbattle between the freedom fighters and Indian military continues in various regions of the IOK.

However, Burhan Wani was a great voice for freedom of the Indian Held Kashmir. Hence, every year his death anniversary is being cele-

miris to pay homage to him. On this very day, strikes, protests and demonstrations across the IOK and Pakistan take place to show solidarity with the Kashmiri freedom fighters who are demanding their legitimate right of self-determination, as recognized by the related UN resolutions. Since 1989, various forms of state terrorism have been part of a deliberate campaign by the Indian army and paramilitary forces against Muslim Kashmiris. It has been manifested in brutal tactics like crackdowns, curfews, illegal detentions, massacre, targeted killings, sieges, burning the houses, torture, disappearances, rape, breaking the legs, molestation of Muslim women and killing of persons through fake encounters.

In fact, Indian forces have employed various draconian and controversial laws like Armed Forces Special Powers Act (AFSPA) and the Public Safety Act (PSA) etc. in killing the Kashmiri people, and arbitrarily arrest of any individual for an indefinite period.

Besides Human Rights Watch, in its various reports, Amnesty International has also pointed out grave human rights violations in the Indian controlled Kashmir, indicating, "The Muslim majority population in the Kashmir Valley suffers from the repressive tactics of the security forces. Under the Jammu and Kashmir Disturbed Areas Act, and the Armed Forces (Jammu and Kashmir) Special Powers Act and Public Safety Act, security forces personnel have extraordinary powers to shoot suspected persons." It is mentionable that under the cover of draconian laws, most of the times, majority of the popular pro-movement leadership is detained or house-arrested by the Indian security forces, and mostly, without prior orders from the higher authorities. As per a Kashmiri human rights group, Voice of Victim (VOV), a total of 1 471 torture centers are operating in the Indian Controlled Kashmir where arrested Kashmiri leaders and the youth are subjected to severe torture.

Undoubtedly, martyrdom of Burhan Wani by the Indian brutal security forces has given a new strength to the Kashmir's struggle for independence, as it has been intensified, bringing the Indian atrocities in the occupied Kashmir in the limelight of the international community and their media.

Serbians join anti-govt protest

BELGRADE: Several thousand people gathered in front of the Serbian parliament building in Belgrade on Saturday for a fifth consecutive night of protests against government policies, including measures to contain the novel coronavirus outbreak. Demonstrators storm Serbian parliament over coronavi rus lockdown This week's demonstrations were initially driven by frustration over economically stifling measures to contain the spread of the novel coronavirus, but soon evolved into anti-government rallies that demanded Vucic's resignation.

Erdogan rejects global criticism over Hagia Sophia decision

Turkish President Recep Tayyip Erdogan defends move to reconvert iconic Hagia Sophia museum into a mosque

ANKARA: Turkish President Recep Tayyip Erdogan has rejected international condemnation over the decision to change the status of Istanbul's landmark Hagia Sophia from a museum to a mosque, saying it represented his country's will to use its "sovereign rights".

In the past, he has repeatedly called for the stunning building to be renamed as a mosque and in 2018, he recited a verse from the Quran at Hagia Sophia.

"Those who do not take a step against Islamophobia in their own countries ... attack Turkey's will to use its sovereign rights,' Erdogan said at a ceremony he attended via video-conference on

The colossal Hagia Sophia was built 1,500 years ago as an Orthodox Christian cathedral and was converted into a mosque after the Ottomans conquered Constantinople, now Istanbul, in 1453. The secular Turkish government decided in 1934 to make it a museum.

Churches appeal to Turkey on mosque decision

LONDON: The World Council of Churches has called on Turkey's President Recep Tayyip Erdogan to reverse his decision to turn the celebrated Hagia Sophia museum back into a mosque. In a letter to Mr Erdogan, the Council, which counts 350 churches as members, said the move would sow division. The Unesco World Heritage site in Istanbul has been a museum since 1934. The president announced his decision on Friday following a court ruling which annulled its museum status. The Hagia Sophia was built 1,500 years ago as an Orthodox Christian cathedral, but was converted into a mosque after the Ottoman conquest in 1453. It was converted to a museum on the orders of Mustafa Kemal Ataturk, the founding father of modern, secular Turkey. Since then religious services have been banned at the site, but devout Muslims have long campaigned for worship to be allowed. - DNA

How New Zealand's media endangered public health

minister, David Clark, has been forced to resign and the nation's hyperactive media have claimed their latest scalp. In the middle of a pandemic, no less.

Unseemly as the media's monthslong hit on Clark was - a classic example of trial by media - it was consistent with the borderline misconduct that has defined much of the reporting throughout the COVID-19 crisis.

While the response to the pandemic threat from the national capital, Wellington, can be held aloft, for now, as a rare success story in a world of disarray, the machinations of much of the nation's media leaves much to be desired. Taken over time, New Zealand's reporters have appeared focused on managing perceptions, berating and cajoling a fearful public on numerous the earliest stages of a four-level alert system, public health concerns have been eclipsed by a clamouring commentariat, all seeking to score political points and undermine the government's health-first priorities. A case can be made that the na-

tion's media, laundering many of the opposition's attack lines and big business talking points, have repeatedly endangered public health. This was driven not only by the country's clutch of prominent Fox News-style commentators - Mike Hosking, Heather du Plessis-Allan and Duncan Garner - each of whom hawks anger and division to drive ratings, but by senior reporters and editors. New Zealand entered alert level four at midnight on March 25.

Public fear had built throughout

February, sharpening to a peak

in the latter part of March.

Prime Minister Jacinda Ardern and her government had to rapidly scale up a response when it became clear in January that China had not contained the virus.

With multiple clusters across the country - a high school in Auckland, a wedding in the deep south, a bar in the tourist hub of Matamata - the government heeded the advice of leading epidemiologists. They opted for an elimination strategy. That would mean a strict and prolonged lockdown, easing over time. New Zealanders overwhelmingly endorsed this approach, putting public health above all other considerations specifically the economy.

The opposition, business elements and an instinctively conformist media moved quickly to set the

agenda, artificially narrowing the parameters of public discourse. There were, for example, no deepdive stories into the state of the health system, eviscerated by aggressive neo-liberalism since the late 1980s, yielding the country acutely vulnerable to COVID-19. Little was said about our hyper-globalised societies' increasingly fraught relationship with nature, of which COVID-19 is a symptom. Such discussions were omitted from the news agenda. Instead, economic considerations dominated media messaging. Then-leader of the National Party, Simon Bridges, began imitating Donald Trump, claiming that "the medicine should not be worse than the cure." Disinformation about a spike in suicides as a result of lockdown proliferated.

Trans-Tasman rivalry was cynically leveraged into the public domain, with claims that Australia was outperforming New Zealand on health and economic outcomes due to its less stringent lockdown. An organisation called Plan B, a "cross-disciplinary group of academics", became ubiquitous in the media. Its website read, "International health data and experience is showing that New Zealand's lockdown may now be unnecessary, and even more harmful than the problem we're trying to solve."

The messaging was clear: the government had "overreacted" and it was time to get back to work. With Ardern set to announce whether cabinet would move down alert levels on April 20, journalists and commentators brazenly agitated for a move to alert level three. which would allow for cafes and restaurants to offer contactless delivery and take away services, namedropping their favourite fast-food chains in a media-wide in-joke. - Courtesv Al Jazeera

Britain's border checks to get £705m boost

LONDON: A £705m funding package to help manage Britain's borders has been announced as the UK prepares to leave the EU customs union at the end of the vear. Plans include new border control posts and 500 extra Border Force staff.

Cabinet Office Minister Michael Gove said the move would help the UK "seize the opportunities" post-Brexit. Labour has accused the government of complacency in its preparations for the end of the Brexit transition period.

The funding follows a leaked letter from International Trade Secretary Liz Truss raising concerns about the readiness of Britain's ports. Under the plans, new border posts will be created inland where existing ports have no room to expand to cope with the extra checks that will be required at the existing entry points. It relates only to the external borders of England, Scotland and Wales. The government is expected to publish specific guidance and measures for Northern Ireland in the coming weeks.

China economy rebounds in Q2 after virus hit

BEIJING, July 12 (AFP/AP-P):China returned to growth in the second quarter after the coronavirus pandemic handed the world's second largest economy its first contraction in decades, according to an AFP poll of analysts. The survey of analysts from 11 institutions pegged China's growth at 1.3 percent - a far cry from the 6.1 percent expansion posted last year but in better shape than other countries still grappling with the contagion.

The coronavirus, which first emerged in China's industrial central province of Hubei late last year, has shut businesses worldwide and destroyed hundreds of millions of jobs. But analysts forecast China will be the only major economy to experience positive growth this year - partly because it was first to be hit by COV-ID-19 and therefore first to recover. China is expected to post 1.7 percent growth for the full year, according to the economists surveyed by AFP, compared with IMF forecasts of a global contraction. - APP

UN restarts cross-border aid to Syria

UNITED NATIONS: The UN Security Council passed a resolution to restart cross-border humanitarian aid to Syria, but only after caving to Russian pressure to close one of two access points into the war-torn country. Following a week of division and seven ballots, the Security Council passed a proposal submitted by Germany and Belgium allowing the use of the Bab al-Hawa crossing point for one year. The measure was approved by 12 of 15 members, with Russia, China and the Dominican Republic abstaining, diplomats said. Authorization for the continued transport of aid to Syria, a system in place since 2014, expired Friday night after Moscow and Beijing used their veto power and the Council then rejected a counter-proposal from Russia. With the approval of the German-Belgian proposal on Saturday, the Bab al-Hawa crossing point on Syria's northwestern border with Turkey will be maintained for a year, until July 10, 2021. This will allow badly needed humanitarian aid to continue flowing to several million Syrians living in the insurgent region of Idlib, which the Syrian regime does not control.

For weeks, Russia, Syria's most important ally, has been demanding an end to the use of the Bab al-Salam border crossing, which leads to the Aleppo region in northern Syria. European countries and the US had wanted to maintain both crossing points. "Russia controls this process,' said Richard Gowan of the International Crisis Group think tank. - APP

on this occasion, said that during the lockdown they were constantly taking up the issue of reopening of restaurants with the authorities, as they also wrote to the chief minister as well as the prime minister, asking them to kindly look after this industry, which is in a bad condition but all in vain. They said that the authorities' response was apparently quite encouraging, and even the provincial cabinet committee decided several times to allow restaurants to reopen but never implemented this decision. They said that the Punjab cabinet

committee also sent its recommendations to the federal government for its final approval from the National Coordination Committee (NCC) but no final date of restaurants opening was decided so far.

Mian Anjum Nisar said that the FPCCI was well aware of the miseries of this sector and had already taken level. He said that hotel industry has been allowed to reopen in several countries, as everyone has now to live with coronavirus like several other diseases. So, the government should manage and allow restaurants to reopen in line with other industries and sectors.

up the issues at the highest halls and restaurant industry has been very badly hit by COVID-19 and non-operational since March 20th, 2020. This pandemic has caused many restaurants to close down permanently while others are near to bankruptcy. He demanded that marriage

halls and marquees should also be allowed to reopen and operate at 50% capacity up to a maximum of 300 guests, duly following the SOPs as approved by government. He suggested that the restaurants should be allowed to operate during timings from 12:00 pm to 12:00 am.

Mian Anjum Nisar recommended that the rent of restaurants established at government owned properties and parks should be waived off at 50%.

He said that during the closure period restaurants have incurred operational expenditure without any revenue from their own resources including payroll, salaries, utility bills, rentals etc. Therefore, financial assistance package is required for restaurants by way of working capital facility of up to Rs.10 million as soft loan without markup. He asked the provincial

minister to recommend federal government that a similar package should be given to restaurants as given to small industries and commercial shops where 3 months for loads up to 70 kilowatts be waived off.

He asked the government to take appropriate necessary actions for possible implementation in order to revive the restaurant industry.

Pakistan to send mango gifts to 17 head of states

KARACHI: President of Pakistan will gift mangoes to heads of friendly states as well as potential buying countries to showcase the brilliance of Pakistani mangoes. The decision to sent gifts of Pakistan's best mangoes as a part of trade diplomacy has a well-defined objective to strengthen diplomatic relations with friendly countries, besides introducing the fruit to new markets so that the country's horticulture exports could be enhanced. President Dr Arif Alvi, has

decided that Pakistan would promote trade by gifting mangoes to all friendly countries. Federal Aviation Division in a letter to Director General Civil Aviation has directed to take steps for sending gifts of Pakistani mangoes to 17 heads of

states and governments. The mango gifts will be dispatched to Kuwait, Kingdom of Saudi Arabia, Turkey, Qatar, Oman, Malaysia, Morocco, Nepal, Singapore, Spain, UK, Italy and other friendly countries. The letter has demanded July and August flight schedules of Turkish. Qatari and Emirates airlines. as well as the schedule of flights of the national airlines to the concerned countries. Pakistan will dispatch overall

4,810 kilograms of mangoes to the heads of states of 17 countries. The CAA has also been directed to arrange and facilitate the special cargo and relevant services and provide details about timely and safe dispatch of the mango cargo. It is pertinent to mention here that in a meeting the president was apprised of the current state of export of the fruit and vegetable sector and the reasons behind Pakistan's meager share of less than 0.5pc in international trade.
