

## CJP, a convict in same event 'unfortunate'

Prime Minister referred to the alleged audio clip of former CJP Mian Saqib Nisar as a "drama"

ISLAMABAD: Prime Minister Imran Khan said on Wednesday it was unfortunate that the Chief Justice of Pakistan and a "convict" were being invited to speak at the same event. The premier made this remark at the Kamyab Jawan Convention 2021 in Islamabad, days after a controversy was created after PML-N supremo Nawaz Sharif's address via a video link was disrupted when the live stream was abruptly stopped at the Asma Jahangir Conference in Lahore. "There is a function in Lahore where the chief justice and Supreme Court judges are invited and who addresses that event? A man who has been convicted by the Supreme Court and who has absconded from the country," the prime minister said. "It is unfortunate." He continued that a nation was destroyed when it stopped considering looting money a bad thing. "When a nation's morals die, that nation dies." In this regard, he also gave the example of the state of Madinah, the foundation for which, he said, was laid on the basis of differentiating between right and wrong and denouncing the bad. "No one can wipe out a nation if its morality is intact," he remarked. Referring to the recent alleged audio clip of former chief justice of Pakistan Mian Saqib Nisar as a "drama", the premier said that it was necessary to understand where this started from. "A country where the head, prime minister and ministers start stealing and taking public funds abroad [...] country's are not poor because of a lack of resources, they become poor when government officials start stealing from the people.

## "PML-N can't face independent judiciary"

ISLAMABAD: Minister of State for Information and Broadcasting Farrukh Habib on Wednesday charge sheeted the Pakistan Muslim League-Nawaz (PML-N) for corrupting the system in past to cover up their corrupt practices. "PML-N cannot afford independent judiciary, nor tolerate independent working of institutions as they are the people who had corrupted the whole system," he said while talking to media.Flanked by Special Assistant to the Prime Minister on Political Communication Shahbaz Gill and Parliamentary Secretary Planning Development and Special Initiatives Kanwal Shauzab, the minister said, PML-N had a history of influencing and intimidating the institutions including judiciary for achieving their ulterior motives.

However, the Sharif family had to submit money trail in the court to justify the flats they had bought in London by laundering the public money abroad, he added. He said the PML-N had a history of attacking the court, getting decision in their favour, doing politics of 'briefcases' and appointing people of their own choice on important official positions.

## Political parties' consent vital to adapt to e-voting

Chairman NADRA says that it was the right time for to implement the law granting voting rights to overseas Pakistanis

ISLAMABAD: Chairman Pakistan's National Database and Registration Authority (Nadra) Tariq Malik has expressed the confidence of developing e-voting system for overseas Pakistanis, but that would only be done after the political parties show consensus over it. In an exclusive interview with Voice of America's Ali Furqan he said that it was

the right time for to implement the law granting voting rights to overseas Pakistanis. "We are waiting for two things, one is the grant responsibility by the Election Commission to us and secondly consensus of all political parties that this e-voting system was acceptable to them," he added.

Pakistan's government re-



cently approved a legislation allowing the overseas Pakistanis to exercise the right to vote amid strong protest by the mainstream opposition parties in the Parliament.

Talik Malik said that NAD-RA has the data of expatriates and according to that 6.5 million people would be eligible to cast their votes out of 8.6 million overseas Pakistanis.

He also spoke about the reforms and initiatives

taken by Nadra related to digitalization of the government departments, while the data base authority has recently developed a system Digital Power of Attorney (DPOA) which would provide a Power of Attorney certificate to a person through video conferencing. He added that around 10,000 fake ID cards were identified in the Nadra system and 107 employees involved in this malpractice have been terminated from service.

Talik Malik said that smart identity cards have been issued to 1.7 million registered Afghan refugees in the country and it has facilitated them to get their children admitted in schools, open bank accounts etc. Regarding, those Afghans

Nigel Casey held meetings with the Chief of Army Staff (COAS), National Security Adviser Moeed Yusuf, Foreign Secretary Sohail Mahmood, and Pakistan's Special Representative for Afghanistan, Muhammad Sadiq to cover matters related to Afghanistan. He discussed the humanitarian situation in Afghanistan, for which the UK has already pledged £50m of funding for 2.5m Afghans, most of them women and girls, drawn from the UK's £286 million aid commitment to Afghanistan this year. DAMASCUS: Israeli air assaults on Syria's central area killed two civilians and injured seven on Wednesday. Syrian air defences attempted to stop the airstrikes from reaching Homs (a city in western Syria). According to official reports, two people were killed and another was seriously injured in the strike, which also injured six Syrian military soldiers. – APP

### Russia, Ukraine stage combat drills

MOSCOW: Russia staged military drills in the Black Sea, south of Ukraine, and said it needed to sharpen the combat-readiness of its conventional and nuclear forces because of heightened NATO activity near its borders.

Ukraine, which with its ally the United States has said it believes Russia may be preparing an invasion, staged exercises of its own near the border with Belarus.

The increase of military activity on both sides follows weeks of rising tension that have raised the risk of war between the two neighbours, even though Russia denies aggressive intent and Western intelligence sources have told the Reuters news agency they do not see any invasion as imminent. - Agencies

ister for Energy Hammad Azhar, he said Maryam doled out Rs18 billion from national kitty to reward "blue-eyed journalists and media channels" at federal and Punjab levels during PML-N's last tenure. Initially, Fawad said 15 members were made part of the media cell and later, Rs20 million were allocated for additional recruitment and the cell was mandated to run targeted media campaigns, he added.

"Handling of public funds by a private person is a crime under the jurisdiction of the FIA, but also liable of disqualification," he said.

## SCCI seeks participation of business community in training

### Active corona cases drop to 78 in Faisalabad

FAISALABAD: The number of active cases of coronavirus dropped to 78 after the recovery of two more patients in the district during

the last 24 hours. According to spokespersons for the health department, a total of 25,850 coronavirus patients had so far recovered in the district. He said presently 37 patients were under-treatment at the Allied Hospital, 8 at DHQ Hospital and four at General

Hospital. He said that 16 confirmed patients were isolated at their homes in the district. He said that 200 beds were allocated at the Allied Hospital, 52 at the DHQ Hospital and 150 at Government General Hospital Ghulam Muhammad Abad for COV-

FAISALABAD: Over 4.42 million (4,428,873) people have so far been vaccinated against COVID-19 in the district.

Health Officer District Dr Ataul Munim said on Wednesday that 2,966,844 citizens were injected first dose while 1,399,846 were administered the second dose of vaccine. He further said that 38,378 health workers were given first dose while 23,805 received the second dose of vaccine. He said that sufficient stock of coronavirus vaccine was available in the district. As of now 188,876 first doses and 125,918 second doses were in the stock.

He said that 37 vaccination centers and 20 mobile vaccination camps were operational in Faisalabad where registered people were being vaccinated. - APP

He said that currently 64% patients are treated free of cost from Zakat, however they intend to increase these numbers to 70%.

## Oman celebrates 51st National Day of the Renaissance



HE Sultanate of Oman marked the 51st National Day of the Renaissance, the 18th of November Anniversary. The event comes around at a time when Omanis ponder about the achievements made so far and brace for further accomplishments, with firm resolve, under the astute leadership of His Majesty Sultan Haitham Bin Tarik who pledged to hold high the banner of Renewed Renaissance, since he assumed power in the country on 11 January 2020.

The Renewed Renaissance kicked off on a high



note when His Majesty Sultan Haitham Bin Tarik called upon the people of Oman to do their best to enrich domestic development and foster progress in all fields. This is considered one of the major principles of Renewed Renaissance in its quest to attain the supreme national objective of "making Oman the central point in all that we strive to achieve"-an objective whose salient features already materialized in terms of updated laws and refurbished programmes of action across all sectors.

In the beginning of this year, a Royal Decree No. 6/2021, promulgated the (updated) Basic Law of the State to serve as a basic pillar of continuous efforts to shape a better future for Oman and its citizens and to build a solid ground for their Renewed Renaissance.

The Basic Law of the State comprises 98 articles "enhancing the institutions of the State. safeguarding its territorial unity and its social texture, protecting its cultural foundations and consolidating public rights, liberties and duties". The Basic Law of the State lays down a stable mechanism of transfer of rule, which reflects positively on political and economic aspects and affirms the principle of sovereignty and independence of the judiciary. It also serves as a basis of rule in the State. It makes education compulsory till the end of the Basic Education stage. It establishes a scholarly method for thought, development of talents and encouragement of innovation-which all conform with Oman Vision 2040. Articles (5) to (11) of the Basic Law of the State organize the mechanism of entitlement or succession to the throne in the Sultanate of Oman and makes it more clear and straightforward. Article (5) states that "The system of rule is sultani and hereditary within the male descendants of Sultan Turki bin Said bin Sultan, in accordance with the following terms: Rule is handed down from the Sultan to his eldest son, then to the eldest son of the son, and henceforth, layer by layer. If the eldest son dies before assuming power, the rule shall pass down to his eldest son. If the deceased has brothers and in case the one entitled to the throne has no sons, the power shall be transferred to his eldest brother. If he (the deceased) has no brothers, the power to rule shall be transferred to the eldest son of his eldest brother. If the latter has no sons, then the rule shall be transferred to the eldest nephew of his other brothers, in accordance with age of the brothers. If the one entitled to the throne has no brothers or nephews, the rule shall be transferred to the uncles and then to their sons in accordance with the sequence indicated in the Second Clause of this Article. It is a condition that the Crown Prince to assume power shall be a Muslim and the legitimate son of the Omani Muslim parents".

Article (6) regulates the establishment of a Guardianship Council in case the power to rule is transferred to an heir aged below 21 years. The Guardianship Council exercises the powers of the Sultan provided the Sultan appoints prior to his death. If the Sultan does not appoint a Guardianship Council before he dies, then the Ruling Family's Council appoints a Guardianship Council comprising one of the brothers of the Sultan and two of (his cousins) sons of his uncles".

Article (7) provides for the appointment of a

Crown Prince under a Royal order in accordance with stipulation of Article (5) of the Basic Law of the State. The Royal order defines the powers and prerogatives of the Crown Prince, as well as the tasks delegated to him. It states that the Crown Prince shall be sworn in before the Sultan before undertaking the powers and tasks delegated to him. The oath shall be taken in accordance with Article (10) of the Basic Law of the State".

The Sultanate of Oman stands out for its exclusive practice of Shura-based democracy, set up on solid grounds emanating from Omani life realities. Shura practice evolved through various stages till it developed into present-day "Council of Oman", with its bicameral chambers—the "State Council" and "Shura Council". Each stage saw the addition of systems and laws that reinforce the tradition of Shura and respond to the expectations of citizens. To this effect, His Majesty Sultan Haitham Bin Tarik issued Royal Decree No. 7/2021 promulgating Council of Oman Law, which comprises 78 articles.

To contain coronavirus (Covid-19) that wreaked havoc in countries of the world, the Sultanate of Oman formed a Supreme Committee tasked with tackling developments resulting from coronavirus (Covid-19) pandemic. The Supreme Committee has been taking 'moderate' decisions and precautionary measures that ensure the safety of citizens and residents, while at the same time catering to social and economic implications on this benign land.

The Supreme Committee is responsible for co-

fines of some services. Special exemptions were sanctioned to small and medium enterprises and holders of Riyada Card for Entrepreneurs. This is in addition to a package of incentives for borrowers, individuals, banking institutions, financing and leasing firms.

The designation of a Youth Day in Oman (26October) reflects the attention accorded to the young generation by His Majesty Sultan Haitham Bin Tarik. It asserts the leadership's deep conviction in the potential of youth in promoting the country's development. Speaking at a meeting of the Council of Ministers he chaired in October 2021, His Majesty the Sultan underscored the significance of devising a mechanism and for opening channels of communication with youth to explain all the requirements of the development process in all sectors. He gave directives to listen to youth and study their needs and aspirations. He also instructed governors and the authorities concerned to hold regular meetings with youth for this purpose. He advised the officials to raise issues of interest or concern to youth, listen to their opinions and help them perform the role expected of them in contributing to the comprehensive nation-building march.

Meanwhile, HH Sayyid Theyazin bin Haitham Al Said, who presided over the Youth Day celebration last October, said that the Ministry of Culture, Sports and Youth launched a smart portal supplied with the latest techniques that make it a prime website for talented youth, artists and innovators.

The attention accorded by His Majesty Sultan Haitham Bin Tarik to Youth is also reflected in the Royal support to employment initiatives, a



set of which came around in May 2021, when coronavirus pandemic had its greatest toll on local and global economic conditions, leading to the shrinkage of the labour markets. The Royal attention resulted in the launch of an executive plan to provide more than 32,000 jobs.

His Majesty the Sultan also chaired a meeting of the Supervisory Committee of the Nation-

and cultural fields.



operation with the departments concerned and regulating social response. It worked for the procurement of internationally approved vaccines and oversaw the implementation of a national immunization campaign. This was commended by His Majesty Sultan Haitham Bin Tarik when he chaired the Supreme Committee's meeting on 18 August 2021 at Al Maamoura Palace in Salalah. On the occasion of the International Women's Day, celebrated last March, Her Highness The Honourable Lady Assayida Ahd Abdullah Hamed Al Busaidi, Spouse of the Sultan of Oman, commended the great efforts exerted by women in Oman and the rest of the world while building their nations, supporting their families and societies and contributing effectively to the management of human and global issues.

HH The Honourable Lady addressed women on Omani Women's Day this year. She said, "On the occasion of Omani Women's Day, the 17th of October, we would like to express thanks and appreciation for every woman who advocates good deeds and elevates the values of tolerance, amity and benevolence. Our greetings go to every woman who contributes to building this dear country from her position as an active participant delivering her social, national and humanitarian duties in all fields." To mark the same occasion, HH Sayvid Theyazin

bin Haitham Al Said, Minister of Culture, Sports and Youth issued a ministerial decision announcing the establishment of Omani Women's Sports and Cultural Innovation Club. The move comes in implementation of the basic principles espoused by the Sultanate of Oman in the field of women's empowerment. It is a symbolic gesture to promote women's contribution to domestic development and to promote their role in sports tors of the National Committee for Emergency Management (NCEM). As a result, the majority of services were restored at a rate of 100%. ## COVID-19 claims 09 more lives

ISLAMABAD: The national tally on Wednesday of total active COVID-19 cases was recorded 14,188 with 350 more people tested positive for the deadly virus while 09 more people died from the disease during the last 24 hours. All 09 corona patients died in the hospital during past 24 hours, according to the latest update issued by the National command and Operation Centre (NCOC). During the last 24 hours

most of the deaths had occurred in Punjab followed by Khyber Pakhtunkhwa. Out of the total 09 deaths occured during last 24 hours, 03 of the deceased

had died on ventilators dur-

ing their treatment. The maximum ventilators were occupied in four major areas including Multan 24 percent, Peshawar 19 percent, Islamabad 18 percent and Lahore 11 percent.

The maximum Oxygen beds (alternate oxygen providing facility other than ventilator administered as per medical requirement of COVID patient) were also occupied in four major areas including Multan 35 percent, Swabi 24 percent, Sargodha 17 percent and Lahore 15 percent.

Around 124 ventilators were occupied elsewhere in the country while no COVID affected person was on ventilator in, GilgitBaltistan (GB), Balochistan and AJK.

Some 380,38 tests were conducted across the country on Tuesday, including 10004 in Sindh, 15,121 in Punjab, 8,194 in Khyber Pakhtunkhwa (KP), 3,835 in Islamabad Capital Territory (ICT), 439 in Balochistan, 303 in GB, and 142 in AJK. – APP

### Imported tea consumption goes down

ISLAMABAD: The consumption of imported tea witnessed slight decrease of 0.55 during the first four months of the current fiscal year as compared to the corresponding period of last year.

The tea imports ly-October (2021-22) stood at \$188.307 million against the imports of \$189.339 million during July-October (2020-21), according to data of Pakistan Bureau of Statistics (PBS).

In terms of quantity, the tea imports decreased by 2.77 percent during the period under review as these shrunk from 86,999 metric tons to 84,590 metric tons, the data revealed.

The overall food imports increased by 36.99 percent from \$2282.457 million last year to \$3126.842 million during the current fiscal year. Meanwhile, on year-onyear basis, the tea imports decreased by 21.54 percent during the month of October 2021 as compared to the same month of last year. The tea imports during October 2021 were recorded at \$37.171 million against the imports of \$47.377 million in October 2020.

On month-on-month basis, the tea imports declined by 22.59 percent in October 2021 as compared to the imports of \$48.019 million in September 2021, the data revealed.

It is pertinent to mention here that the country's total merchandise exports surged by 24.94 during the first four month of the current fiscal year compared to the corresponding period of last year. - APP

### Police arrests three drug pushers

RAWALPINDI: Police have arrested three drug pushers and recovered more than 3 kg drugs from their possession, informed police spokesman, Saddar Barooni Police recovered 1 kg 420 grams of hashish from Saleem Khan. ## Capital to get another rehabilitation center

ISLAMABAD: Minister for Narcotics Control Syed Ijaz Shah Wednesday said that the government would open one more center in the federal capital for the rehabilitation of drug addicts. Addressing a drug-burning ceremony organized by the Anti-Narcotics Force (ANF) here, he said "We are fighting to eliminate the drug menace from the country effectively but there are only three drug rehabilitation centers which are extremely insufficient for treatment of the patients." Among others, the ceremony was attended by the diplomatic staff, students of universities, schools and colleges besides renowned actors. Drugs worth billions of dollars were burned at the end of the event.

The minister asked the private sector people, having enough resources, to come forward and play their role in establishing such facilities in the country so that timely treatment and rehabilitation of the treatment could be car ried out efficiently. The federal government alone could not deal with the problem as there were six million drug addicts in the country as per the year 2012-report, he said adding the federal and provincial departments, and masses would have to make joint efforts to purge the menace of drugs from the society. He asked the masses especially the youth to join hands with the government to eliminate drugs from society and ensure the safety of future generations.

The minister also stressed cutting the supply line besides taking measures for the drug reduction demand, with special focusing on the awareness-raising and rehabilitation of drug addicts in the society. "We are not the drug-producing state, but a victim of drugs." The minister appealed to the young generation to wage a holy war against the drug and work together to make Pakistan a drug-free state. "We have to fight on a war-footing against the menace by joining hands with each other," he added. He said Pakistan Tehreek-e-Insaf government had devised the first-ever Anti Drug Narcotics Policy at federal, provincial, and district lev els to fight against the menace with collective efforts. Pointing out the shortage of ANF staff, the minister said that 4,000 staff was not enough to fight this hazard. He also con gratulated ANF Director General Major General Ghulam ShabeerNarejo for arranging the drug-burning ceremony. On the occasion, the DG ANF said that a drug burning ceremony was an annual event in which drugs that recovered by the law en forcement agencies by putting their lives in danger to secure the future of the country's next generation. - APP

## Pak response to Covid: A commendable framework

ISLAMABAD: Of all the countries confronted with the pandemic, Pakistan has made some seriously commendable efforts to deal with COVID, mainly through the creation of the National Command Operation Centre (NCOC); an institute which adopted a phased approach to effectively attend to the health emergency, said Professor Gloria Taliani, Expert on infectious diseases at Sapienza University of Rome, Italy. She was addressing a gathering at the Institute of

Regional Studies (IRS), Islamabad. Sharing a timeline of the spread and control of Covid-19 in Italy, she emphasised the importance of awareness, management, and vaccination in controlling the pandemic. Reflecting on her experience(s) from Italy, Professor Taliani comment-

ed that a significant part of dealing with the pandemic was to ensure successful administration of the vaccine. In that, she said that as of 17 November 2021, a total of 7.370.902.499 vaccine doses had been administered world over.

Discussing the Italian instance, Professor Taliani said that while Italy had some lessons to learn, it was doing substantially well in the face of a pandemic which seems to only evolve further into more sophisticated variants. She added that Italy was currently confronting the fourth wave of Coronavirus and that the mortality rate had substantially decreased too.

Expressing her concern over some of the countries where people had not even received their first shot of the vaccine, Professor Taliani said that governments needed to realise the onus upon them in ensuring healthy livelihoods. In Europe, she said, the Covid-19 positivi-

ty ratio was on the rise. In Italy the fourth wave was however, less powerful than in other European countries thanks to the shield of the high number of vaccinations (76.7% of the total immunized population,

compared to 65% on average in the International Organization for Cooperation and Development (OCED)). In response to a ques-

tion on the seeming end to this post -Covid phase during the Q/A session, Professor Taliani said that the virus is here to stay and will only keep evolving unless the world comes up with a permanent solution for it. Meanwhile, she said, that the children born

during this time will be immune to battling Covd since birth, normalising it as much as seasonal cough and flue. However, this did not mean that world was free to let go off all precautionary measures. She added that the idea of getting both shots of the vaccine and becoming immune to Covid was clearly a misperception among people which must be corrected and that precautionary measures had to be accepted as the new normal now.

## Violence in the courtroom

disturbing video making the rounds on social media depicts the harrowing reality of the extent of vandalism and hooliganism that exists in certain legal circles, and of the ugly picture of sexism in public spaces. The video shows a group of lawyers beating up a woman complainant inside the

The violence seems to have reportedly started over a personal conflict—the alleged victim had lodged against her ex-husband, Advocate Hasnain, a case about a dishonoured cheque. Yet, whatever the reason, the video, which shows hoards of men appearing to be lawyers, beating and manhandling the woman and her brother, is absolutely unacceptable. This is not a simple matter of a personal dispute getting out of hand, as the Malir district bar association is trying to portray it. Firstly it exemplifies how unsafe the courts and public spaces have been made for women by male lawyers themselves. This is not the first incident of violence against a woman in a court—there have been many female lawyers and other women who dared to lodge a complaint against a male lawyer subjected to harassment and verbal abuse.

Secondly, it exposes how disorderly and ungovernable some groups of lawyers have become. Loyalty with the community is a regular feature of any career but taking it too far to defend crimes seriously breaches the credibility of the legal profession. We have seen time and time again some of the lawyer community pose an exaggerated and aggressive overreaction upon any case against one of their own.

Knowledge of the law does not mean one can flout it as a community. The Bar Councils, as well as the parliament, through amending the Legal Practitioners Act, needs to take the growing excesses of the legal community seriously and put in place a stricter accountability process. We are still to see action on the 2019 lawyers attack on a hospital in Lahore which led to the death of patients and destruction of property. We cannot have mobs of lawyers running around doing what they want without any action.

## Partial closure

N light of the worsening Air Quality Index (AQI) ratings in Punjab, the provincial government has issued directives to shorten the working week by closing down businesses and schools every Saturday, Sunday and Monday. This routine is to be followed until January 15, 2022, after which a reassessment will be carried out. While we may not have imagined matters to get this dire two or three years ago, now it seems as though even these measures are not enough—or rather appropriate—to curtail smog in the province. A more detailed strategy is needed that tackles the root cause of the problem.

For the past few months, the AQI of the country has been fluctuating constantly and never for the better. Even on a good day, the average rating reads 250 in Lahore which is severely toxic and requires people to either stay indoors or wear oxygen masks to protect themselves. In fact, Lahore was declared the most polluted city in the world after the numbers went up even further a few weeks ago. The consequences of this are being borne by the people who are suffering from ailments after having gone through an already strenuous life-altering pandemic.

The government took initiatives like introducing anti-smog squads and has now instructed all institutions to remain closed for three days of the week. While we can understand the protective sentiment behind this order, it is rather confusing because the citizens will be at the same kind of risk every day of the week. Shutting down for a few days will not cut down emissions drastically, especially when problems like unfiltered industrial waste and improper disposal, crop burning activities and unlimited carbon emission producing cars flooding the street still remain.

Without passing laws that prevent this or offer better alternatives like solar energy or environmentally-friendly cars, we can only achieve marginal improvement. More informed decisions must be made by the government instead of those driven out of a state of urgency and panic.

# Tackling migration crises: Fighting corruption may help

WENTY-three-year-old Mohamed Rasheed was at a loss after returning to Iraq from a grueling failed attempt to cross the Belarus-Polish border. "There's no life for us here. There are no jobs; there is no future," he told a Washington Post reporter.

Another man, who had just disembarked from a repatriation flight from the Belarus capital of Minsk to Erbil in Iraqi Kurdistan, frowned and obscured his face with a scarf, according to the reporter, as he responded to a question about why he had left.

"Those words cannot leave my mouth. Who dares to tell the truth here?" the man said.

The two men were returning to a country whose population has largely been excluded from sharing in the benefits of its oil wealth. Youth unemployment hovers at about 25 per cent. Public good and services are poor at best. Security forces and militias crackdown on and fire live ammunition at protesters demanding wholesale change.

Mohammed and his fellow returnee could have been from Lebanon, a middle-income country in which three-quarters of the population lives under the poverty line thanks to a corrupt elite unwilling to surrender vested interests irrespective of the cost to others.

In fact, they could have been from any number of countries in the Middle East, North Africa, and their African and Asian peripheries.

Almost half of the youth from non-Gulf countries in the Middle East and North Africa want nothing more than to leave in the absence of opportunities and prospects. They are exasperated with corrupt, self-serving elites.

This is a part of the world where devastating wars have wracked Syria, Yemen, and Libya. More recently, these countries were joined by Ethiopia while others in the Horn of Africa and the Sahel reel from jihadist violence that feeds on social and economic grievances.

To primarily hold responsible for the migrant crisis, human traffickers and cynical authoritarian leaders like Belarus President Alexander Lukashenko, who are willing to play power games and turn a profit on the back of innocent men, women, and children is swatting at symptoms of a problem that goes to the root of instability in the Middle East and North Africa.

To be sure, Mr. Lukashenko and the traffickers are part of the problem. Moreover, many Middle Easterners on the Belarus-Polish border appear to be economic, not political refugees with a legal right to asylum.

One could argue that the European Union's refusal to take in the refugees on humanitarian grounds led to their repatriation to Iraq and Iraqi Kurdistan, which may have shortened their ordeal. Many risked being ultimately rejected, even if they had been granted entry to the EU because they were not political refugees.

The jury is out on whether the refusal will serve as a warning to the many in the Middle East and North Africa contemplating ways to get to Europe by hook or by crook.

All of this describes the immediate aspects of a dramatic crisis. The danger is that the focus on the immediate will obstruct badly needed thinking of ways to prevent or reduce the risk of future such crises and human suffering, aggravated by the willingness of governments to fight their battles on the backs of the least protected.

The framing of the crisis as a security rather than a political, economic, and social problem further takes away from the development of policies and tools to tackle the root causes of repeated migrant crises – economic mismanagement; political, economic, and financial corruption; nepotism; and loss of confidence in political systems and leadership.

"Addressing population challenges, the youth bulge, and refugee and migration pressure from natural or man-made crises will require measures to promote sustainable economic growth and enhanced educational and healthy capacities," said George M. Feierstein, senior vice president of the Washington-based Middle East Institute and a former State Department official with multiple postings in the Middle East and North Africa.

Acknowledging that a broader US policy focus is likely to prove more challenging than one narrowly concentrated on security, Mr. Feierstein argued that the United States could "bring assets to the table that could potentially enhance its role in the region and strengthen its position as the preeminent outside power." The former diplomat was referring to big power rivalry with China and Russia in the Middle East and North Africa.

Adopting Mr. Feierstein's policy prescription would involve greater emphasis on regional approaches to global challenges, including climate change and public health; conflict management and resolution efforts to safeguard populations and minimize internal displacement and migration; and institutional capacity and resilience building; all backed by greater US private sector engagement.

Kyrgyzstan has potentially emerged in what could provide evidence that a de-emphasis of the security aspects of the migration crisis would not automatically surrender real estate and /or leverage and influence to China and Russia.

Part of a Central Asian world sandwiched between Russia and China on which the United States has seemingly turned its back with its withdrawal from Afghanistan in August, Kyrgyz President Sadyr Japarov is using his election pledges to fight corruption and offer financial rewards to whistleblowers to lure the US back.

Mr. Japarov's proposition, designed to rescue Kyrgyzstan from the clutches of Russia and China, is the central theme of a document that he has sent to the US State Department. The document outlines proposals to revive a broad political, economic, and civic engagement with the US bolstered by anti-corruption measures and affirmation of democratic freedoms.

S. Frederick Starr, founding chairman of the Central Asia-Caucasus Institute, suggested that Mr. Japarov is providing a template for US reengagement with Central Asia and Afghanistan. In fact, the Kyrgyz president is offering a formula equally relevant to the Middle East and North Africa.

If adopted by the Biden administration, Kyrgyzstan "would become 'The Mouse that Roared' to cite the title of the droll 1959 British film. This time, however, the lesser power will have advanced its cause not by threatening military action...but with a sensible proposal by which a great power—the United States—...can once more become a serious presence in a major part of Asia that lies on China's and Russia's

doorstep," Mr. Starr said. In contrast to Central Asia, the United States remains the dominant power in the Middle East and North Africa. But it's a power seeking to redefine the role it wishes to play going forward in a region struggling to come to grips with an uncertain but changing US approach. Kyrgyzstan could be showing the way for both United States and the Middle East. However, to make it work and reduce, if not stop, migration flows, the United States and its Western partners would have to prioritise confronting corrupt elites who will stop at nothing, including displacing populations, to preserve their illicitly gained privileges.

## The 'net zero' myth

ARLIER this month, the world's leaders got together to small talk about the weather and to big talk about the climate at the 26th edition of the UN's climate change conference (COP26) in Glasgow. On the sidelines, activists (myself included) campaigned to persuade governments to replace platitudes with attitude, inaction with action. Nevertheless, the hot air and greenwashing were plentiful, with delegates with ties to fossil fuel companies outnumbering even the largest country delegation. In the pavilion section, greenwashing came from the nuclear industry, representatives of which in banana suits claimed that living near nuclear power stations was as safe as eating a banana, as well as from major coal producers like Australia, and major oil producers such as the Gulf states, each of

whom had a gigantic stand. In the closing plenary, minister after minister urged consensus and collective action for the sake of their children or grandchildren and the future of humanity. However, despite the platitudes, rich countries, from the United States to EU states, showed little appetite to downscale their lifestyles and emerging economic powerhouses, such as China and India, exhibited little willingness to clean up their reliance on coal and other dirty fossil fuels.

This left low-income countries and island states feeling a profound sense of betrayal. This was eloquently expressed by Shauna Aminath, the environment minister of the low-lying Maldives, which could become uninhabitable by 2050 and possibly vanish from the map by the turn of the century, while its vital coral reef is dying off at an alarming rate.

"[This is] yet another conversation where we put our homes on the line, while those who have other options decide how quickly they want to act," she told her fellow ministers in the final session of the conference. "The difference between 1.5 and 2C is a death sentence for us." Beyond kicking the hot potato of meaningful climate action down the road to mid-century for future generations to deal with, another favoured tactic of countries and corporations is to make vague net-zero emission pledges. More than 140 countries have promised to be net zero mostly by 2050, with some countries aiming for sooner and others for later. China has set 2060 as its target date and India is aiming for 2070. Businesses, from giant multinationals to local

steakhouses in Glasgow, have also been falling over themselves to announce net-zero pledges. At least a fifth of the world's 2,000 largest corporations had already made such promises before COP26.

This is great news, right? Well, not really. There are indeed a few coun-

tries and companies that have seriously committed to lowering their carbon (and ecological) footprint through an ambitious strategy to reduce their emissions and pursue sustainable production and consumption models.

But, for many, climate strategies amount to little more than a PR exercise. Possibly the most ludicrous net-zero claims are the ones being made about fossil fuel products. One flagrant example of this was Shell's "Drive Carbon Neutral" campaign in the Netherlands, which claimed that consumers could offset their petrol emissions by paying just one euro cent (\$0.012) extra per litre at the pump.

To my mind, this is akin to a modern reincarnation of the indulgences sold by the medieval church. But, here, instead of "sinners", polluters pay a token amount to absolve themselves of guilt but without making any meaningful change to their destructive behaviour.

Although these indulgences may help Shell executives sleep better at night and motorists feel less guilty about their gas-guzzling vehicles, this stunt does next to nothing for the climate. For that reason, the Dutch advertising standards agency asked Shell to remove the ad after nine law students filed a complaint accusing the oil giant of greenwashing. Unfortunately, Shell is not alone in making these preposterous claims. There is a troubling new trend among fossil fuel companies of marketing gas and oil which they claim is carbon neutral. A recent investigation we conducted at Carbon Market Watch found that such claims currently being made by oil and gas companies amount to brazen greenwashing.

to brazen greenwashing. To the untrained ear, net zero (also known as carbon neutrality) sounds deceptively like zero - and therein lies the marketing genius behind this term and its rapidly gaining popularity. It gives the impression that emissions will be (largely) eliminated. However, while one factor in this equation relates to cutting down the level of greenhouse gas emissions, the other involves so-called offsetting, i.e. balancing emissions in one place against reductions in another. Offsetting can be achieved through natural solutions that enhance nature's carbon absorption capacity (such as afforestation or restoring wetlands), investing in renewable energy elsewhere, by buying someone else's emissions reductions, or by using largely unproven technologies in the future to capture carbon from industrial processes or the air.

If we were to attempt to offset all our emissions by planting trees, this would require at least 1.6 billion hectares (4 billion acres) of new forests, Oxfam estimates. This afforested land would cover five Indias or more than all the farmland on the planet. This would not only lead to mass hunger, it is impractical and impossible. We would need a Planet B to offset this Planet A.

The "net-zero" mantra can distort reality and present as equal yet wildly different realities. For instance, a serious country or company may have a carbon-neutrality plan which relies on slashing emissions by 90 percent and neutralising the remaining 10 percent through offsets. A company or country looking for easy solutions or to greenwash its image could aim for the inverse: 10 percent reductions and 90 percent offsets.

Even though these two hypothetical cases are both theoretically "net zero" or "carbon neutral", they are not equivalent nor equal. The first is about taking meaningful action to clean up the atmosphere, while the second is about atmospherics and cleaning up one's image.

The cover provided by the fig leaf of net zero allows the unscrupulous to dress up inaction as determined action. This helps explain why emissions on paper can appear to be falling while in the air, where it really matters, they continue to rise. After the temporary blip due to the COVID-19 pandemic, the world is on course to return to pre-pandemic emissions levels and, without radical action, emissions will continue to rise steadily in the coming years. In the vital near term, when we need to massively roll back emissions this decade if we are to keep global heating below or near the critical 1.5C threshold, ambition is severely wanting. When totted up, the combined commitments of world governments will shave a measly 7.5 percent off global emissions by 2030 compared with 2010 levels, according to a UN assessment of national plans, rather than the 65 percent scientific research says is imperative.

To make matters even direr, governments appear to have been underreporting their countries' emissions, partly thanks to creative "net" accounting that unrealistically exploits natural carbon sinks. The gap between actual and reported global emissions could be as high as 13.3bn tonnes a year, the equivalent of the exhaust of nearly 3 billion cars, a new Washington Post investigation estimates.

What all this reveals is that reporting net emissions and aiming for "net zero" is befogging the road ahead and leading to dangerous levels of procrastination and complacency on the part of governments and corporations.

part of governments and corporations. To properly illuminate the challenges on the horizon, we must abandon talk of "net zero" and speak about emissions and offsets separately. While offsetting can be used to compensate for essential and unavoidable economic activities, climate action must be overwhelmingly focused on reining in real emissions by 65 percent this decade. What we desperately need are climate heroes, not greenwashing

# Money laundering and economic policies

Sparing or allocating space for incorrect data is reasonable and safe when designing economic policy research responses NY economic policy requires a specific plan to be implemented during a particular period. The significance of that policy can be summarized as ensuring knowledge of the reality of the economic situation to develop it to a better position and status that contribute to the renaissance of the state and society in general. Undoubtedly, money laundering operations negatively affect the mechanisms used in formulating

the country's economic policies. As a crime, money laundering operations, in particular, take place on a large scale and are difficult to measure due to their secretive and discrete nature, which leads to a distortion of the economic data necessary for the formation of these policies, as mentioned above.

Due to the inaccuracy of the data and information needed to prepare these policies, they result in incorrect calculations that will not lead to achieving the objectives of these desired policies, such as overestimating inflation rates, tax, and unemployment

Many countries, especially those with free-flowing exchange rate economies, faced numerous obstacles due to the influx of large amounts of laundered money resulting in the high exchange rate or the expansion of the monetary base. In response, economic policymakers have wrongly responded to the data by adjusting fiscal or monetary policies, eroding the effectiveness of both financial and fiscal policies.

both financial and fiscal policies.

Moreover, work is currently under progress at the international level to develop the best mechanisms to counter the harmful impact of money laundering crimes on financial systems and the real economy. Perhaps modern financial technologies used in economic transactions will make the innovators and developers of these technologies face a more significant challenge and policymakers. But what is the most appropriate way at present to deal with the impact of money laundering on policymaking?

Gering on policymaking? Sparing or allocating space for incorrect data is reasonable and safe when designing economic policy research responses.

These policy measures consider essential topics such as the role of prudential supervision of the financial systems in each state and regional and international cooperation between states and institutions.

In addition to forgoing greater diligence in setting, developing the legal framework, and determining the institutional obligations to implement the measures and procedures that would contribute to countering money laundering and combating its implications, it would ensure that the risks associated with this crime are reduced as well.

## CDA to retrofit sodium street lights

Liver cancer is the malignant tumor with the highest mortality rate among adult men under 60 in China.- APP

### Kyrgyzstan reports 43 Covid cases

BISHKEK: Kyrgyzstan on Wednesday reported 43 new COVID-19 cases, bringing its total caseload to 182,996, according to data from the country's Republican Headquarters for Com bating COVID-19. The death toll from the virus rose by three to 2,732. Altogether 94 people recovered in the last 24 hours, bringing the total number of recoveries to 177.693, the data showed The Central Asian country launched a nationwide vaccination campaign on March 29 after the arrival of China-donated Sinopharm vaccines. It is also inoculating its population with the Sputnik-V, AstraZeneca and Pfizer vaccines. To date, 1,081,986 people have been inoculated in the country, 864,456 of whom have received both shots. - **APP** 

## Ethiopia PM's vow to join war front

ADDIS ABABA: Ethiopi an Prime Minister Abiy Ahmed's vow this week to head for the front lines of his country's brutal year-long war has boosted recruitment for the beleaguered armed forces.

At least one prominent distance runner - marathoner and Olympic silver medallist Feyisa Lelisa - has joined thousands of ordinary Ethiopians keen to follow Abiy's lead. World powers have voiced alarm about a military escalation that could scuttle efforts to broker a ceasefire, as rebels claim they are advancing towards the capital Addis Ababa and foreign governments tell their citizens to leave.

On Wednesday hundreds of new army recruits took part in a ceremony held in their honour in the Kolfe district of Addis Ababa.

As officials corralled sheep and oxen into trucks bound for the north, the recruits broke into patriotic songs and chants. "I was amazed when I heard" Abiy planned to join soldiers in the field one of the recruits, 42-yearold driver Tesfaye Sherefa, told AFP. "When a leader leaves his chair... and his throne it is to rescue his country. His focus is not to live, but to rescue this country, and I sobbed when he said 'follow me' and went to the front line." - APP

## Beijing mode may boost organic peach

BEIJING: Beijing mode may boost organic peach growing in Pakistan, says a report published by China Economic Net (CEN) on Wednesday. The report says, peaches are known as the "Queen" of fruits in Pakistan. It is a remarkable fruit, having a delicious taste and a good looking color. Pakistan's peach season usually starts in May and continues till the first week of September.

According to a report by the Crop Reporting Service of Khyber Pakhtunkhwa, a total of 6,330 hectares are dedicated to growing the fruit in the province. Swat produced 5,280 tonnes of peaches in 2018-2019, whereas Peshawar produced 1,066 tonnes. Nasir Khan, an orchard owner from Swat told China Economic Net that peach is becoming the main source of income for the farmers of Swat. "If we have advanced cultivating and processing technology, we can add value to our peaches and export to other countries," he said.

In Beijing's Pinggu district, this common fruit has become a business opportunity for local peach growers. In 2017, Pinggu government launched an "Ecological Bridge" project, which is a sustainable ecological cycle model of "resources-agricultural ucts-waste-renewable resources". - Agencies

### NASA launches mission to redirect asteriod

LOS ANGELES: A unique mission to test asteroid-deflecting technology was launched late Tuesday night from the Vandenberg Space Force Base in California, NASA announced.

"Asteroid Dimorphos: we're coming for you," NASA tweeted, adding that the SpaceX Falcon 9 rocket blasted off at 1:21 am EST (0621 GMT).

The Double Asteroid Redirection Test, or DART, "will be the first demonstration of the 'kinetic impactor' technique in which a spacecraft deliberately collides with a known asteroid at high speed to change the asteroid's motion in space," said Lindley Johnson, NASA's Planetary Defense Officer, on NASA's website.

'This technique thought to be the most technologically approach for mitigating a potentially hazardous asteroid, and it will help planetary defense experts refine asteroid kinetic impactor computer models, giving insight into how we could deflect potentially dangerous near-Earth objects in the future," he added. - APP

## France records 30,000 new virus cases

PARIS: France recorded more than 30,000 new coronavirus cases Tuesday, raising concerns about the precedented increase in the nation's fifth wave.

A total of 30,454 new infections were recorded in the last 24 hours, according to the latest health data. The last time that figure was recorded was Aug. 11, with 30,920 cases.

Health Minister Olivier Veran told lawmakers in the national assembly that the new cases marked "a very significant increase which attests that we are, unfortunately, in a fifth epidemic wave." He said 6 million adults remain unvaccinated and "that's

## Bangladesh resumes moving Rohingya

COX'S BAZAR: Bangladesh has resumed moving Rohingya refugees to a remote and flood-prone island, authorities said Wednesday, despite criticism from aid groups and claims some are being relocated against their will. Nearly 20,000 members of the stateless minority, who fled neighbouring Myanmar in 2017 after a brutal military crackdown, have already been sent to Bhashan Char island.

Bangladesh eventually wants to rehouse 100,000 of its approximately one million Rohingya refugees to the island, moving them from cramped relief camps on the mainland. But hundreds already sent there have since been arrested in coastal towns after fleeing the island, and dozens died in August after a fishing boat carrying escapees capsized.

Another 2,000 Rohingya will nonetheless be transferred this week, the country's deputy refugee commissioner Moozzem Hossain told AFP, more than six months after the last group was sent there. "Navy ships will bring them to the island on Thursday," he added.

The UN refugee agency signed a deal with Bangladesh authorities to provide help and protection to refugees on the island last month.

Hossain told AFP that all relocations were completely voluntary, but several refugees said they were being forced to move there. "We don't want to go to Bhashan Char," a Rohingya woman told AFP by phone, speaking on the condition of an-

She said a Rohingya community leader in the camps had added her name to a list of people seeking to relocate without her consent.

"If I go to Bhashan Char, I will not be able to go back to Myanmar. I will not go," she added. One Rohingya community leader, who also asked to remain anonymous, said Bangladeshi authorities had told him and his peers to each provide lists of at least five families to be relocated. - APP

### PM approves **ERRA's** merger with NDMA

ISLAMABAD: Prime Minister Imran Khan on Wednesday gave in-principal approval to the merger of Earthquake Reconstruction and Rehabilitation Authority (ERRA) into National Disaster Management Authority (NDMA).

The decision was taken at the 14th meeting of the ERRA Council chaired by the prime minister and attended by Punjab Chief Minister Usman Bazdar, Khyber Pakhtunkhwa Chief Minister Mahmood Khan, Gilgit-Baltistan Chief Min-Khalid Khurshid, Azad Jammu and Kashmir Prime Minister Sardar Abdul Qayyum Niazi, National Assembly members Saleh Muhammad, Abdullah Khan and Chairman ERRA Lt Gen Akhtar Nawaz.

The prime minister issued directives to hand over 2,200 completed projects of ERRA to the concerned provincial governments and departments and for early completion of 230 under-progress projects by the year's end. He stressed considering proper guidelines of construction in areas on geological fault lines to sustain earthquakes.

He also urged promotion of tourism in areas particularly northern areas, Khyber Pakhtunkhwa, Kashmir and Gilgit-Baltistan.

## EU health agency calls for 'urgent' measures

STOCKHOLM: The European Union health agency on Wednesday called on member states to "urgently" introduce measures to reduce the potentially "very high burden" from Covid-19 in December and January. The director of the European Centre for Disease Prevention and Control (ECDC). Andrea Ammon, recommended Covid booster shots for all adults over the age of 18,

above 40 years old". The agency also urged countries to increase their overall vaccination rates, especially those with low uptake. Under 70 percent of the overall population in the EU and the European Economic Area (Norway, Lichtenstein and Iceland) have been fully vaccinated.

"This leaves a large vaccination gap that cannot be bridged rapidly and gives ample room for the virus to spread," the ECDC said.

"We need to urgently focus on closing this immunity gap, offer booster doses to all adults, and reintroduce non-pharmaceutical measures," Ammon said in video remarks. - Agencies

## Morocco, Israel sign first-ever defence deal

RABAT: Israel and Morocco have signed a landmark agreement that lays the foundation for security cooperation, intelligence sharing, and future arms sales. The memorandum of understanding between Israeli Defense Minister Benny Gantz and his Moroccan counterpart Abdellatif Loudiyi was signed on Wednesday in Rabat, as part of the first official visit by an Israeli defence minister to one of the Arab states that normalised ties last year. Morocco, the United Arab Emirates, Bahrain and Sudan signed agreements to normalise relations with Israel in 2020 as part of the Abraham Accords, which were brokered by the Trump administration.

In a statement, Gantz said that the agreement was "very significant and will allow us to exchange ideas, enter joint projects and enable Israeli military exports here.'

Gantz also met with the Moroccan military chief of staff and was greeted by a colour guard of soldiers clad in red tunics, blue slacks and gleaming gold epaulets.

## Inter-civilizational dialogue vital to curb hunger, poverty

ISLAMABAD: Foreign Minister Shah Mahmood Qureshi on Wednesday emphasized the need for a genuine inter-civilizational dialogue and interfaith harmony to save billions of people from conflict, poverty, disease, and hunger. Addressing at the International Interfaith Peace Conference, the foreign minister said promotion of inter-faith harmony had assumed unparalleled significance in today's polarized world characterized by extremism, supremacist ideologies, onflicts, and festering disputes. The foreign minister said Pakistan was committed to sparing no effort to promote harmony and un-

derstanding between different re-

ligions, cultures, and civilizations.

He said the global Covid-19 pan-

demic was a wake-up call for all

that had led to the realization that shunning conflicts and intolerance and promoting understanding and cooperation hold the key to the survival of mankind. He mentioned that Pakistan was

at the forefront of efforts to promote understanding of the deep veneration held by Muslims for their Holy Prophet Muhammad (Peace be upon Him). He stressed that the West must

not encourage or tolerate the abuse of freedom of expression to injure the sentiments of nearly two billion Muslims. He said Islam firmly rejects notions of racial superiority and discrimination on the basis of caste and creed.

Despite malicious propaganda, he said, there was a growing realization in the world that Islam is a religion of peace that does not condone, encourage or promote terrorism or violent extremism.



The foreign minister referred to the Last Sermon of the Holy Prophet (PBUH) as the "most definitive and unequivocal rejection of racism" and a timeless beacon of hope for humanity.

He said Pakistan had a rich tradition of tolerance, understanding, and respect for the cultural values of minorities. The spirit of interfaith harmony is reflected in the green and white of our national

## Russia to boost military

MOSCOW: Russian Defence Minister Sergei Shoigu said on Wednesday that the country needed to further develop its armed forces in the face of "increased NATO activity" on

its borders. "The difficult military and political situation in the world and the increased activity of NATO countries near the Russian borders require further quality development of the armed forces," Shoigu told officials in televised remarks. Among the Russian armed forces' priorities are "increasing their effectiveness, maintaining the combat readiness of nuclear forces and strengthening the potential of non-nuclear deterrent forces," the defence minister added.

Western countries have this month raised the alarm over reported Russian military activity near Ukraine, with the US saying it has "real concerns" over a new troop build-up on the border.

STOCKHOLM: Sweden's parliament on Wednesday elected Social Democratic party leader and current Finance Minister Magdalena Andersson as the country's first woman prime minister, after she clinched a last-minute deal securing key support.

Andersson will succeed outgoing Prime Minister Stefan Lofven after a total of 117 members of parliament voted for

her, while 57 abstained, 174 voted against and one was absent. Under Sweden's system, a prime ministerial candidate does not need the support of a majority in parliament, they just need to not have a majority - or 175 votes - against them. The 54-year-old, who took over as leader of the Social Democrats earlier this month, reached a deal with the Left Party late on Tuesday to raise pensions in exchange for its backing in Wednesday's vote. She had previously received the support of the Social Democrats' coalition partner the Greens, as well as the Centre Party. However, Andersson faced her first setback even before her election on Wednesday.
