

Ukraine: 50 killed in train station strike

Zelenskiy called the strike a deliberate attack on civilians

KYIV: Ukraine said as many as 50 people, including five children, were killed and many more were wounded and lost limbs in a rocket strike at a railway station packed with civilians fleeing the threat of a major Russian offensive in the country's east. As regional authorities scrambled to rush civilians out of harm's way, a group of European Union leaders meanwhile visited Kviv to offer President Volodymyr Zelenskiy support and assure him there will be a path to EU membership for Ukraine. Zelenskiy called the strike on the station in Kramatorsk in the eastern region of Donetsk region a deliberate attack on civilians. Regional governor Pavlo Kyrylenko said the death toll rose to 50 from an earlier reported 39 as some of the several dozen wounded had died after being taken to hospital or medical centers. He said the station was hit by a Tochka U short-range ballistic missile that contained cluster munitions. which explode in mid-air, spraying small lethal bomblets over a wider area. They wanted to sow panic and fear, they wanted to take as many civilians as possible," he said.

IHC declares PECA ordinance unconstitutional

The media bodies had challenged the "draconian law" in the IHC following countrywide protests

ISLAMABAD: The Islamabad High Court (IHC) on Friday declared the Prevention of Electronic Crimes Act (PECA) 2016 ordinance "unconstitutional." The court instructed the federal government to investigate the abuse of law and submit a report in 30 days. The petition against the Peca ordinance was heard by IHC Chief Justice Athar Minallah. The petition was filed by the Pakistan Federal Union of Journalists (PFUJ). President Dr Arif Alvi promulgated an ordinance in February to amend the PECA law as the government moved to curb "fake news". According to journalists and experts, the government's move aimed to silence dissent on social media and control the media. The media bodies had challenged the "draconian

law" in the IHC following countrywide protests. The journalist associations, including Pakistan Broadcasters Association (PBA), All Pakistan Newspapers Society (APNS), Council of Pakistan Newspaper Editors (CPNE), Association of Electronic Media Editors and News Directors (AEMEND) and some senior journalists of the country, had filed the petition through senior lawyer Munir A Malik.

The four-page order of the IHC issued today stated that free speech protected under Article 19 and the right to receive information under Article 19-A of the Constitution are essential for the development, progress and prosperity of a society and suppression thereof is unconstitutional and contrary to the democratic values. Ms Marri said that Pakistan Peoples Party had already rejected darconian black law of PECA, today, Islamabad High Court has taken a constitutional step by declaring the PECA amendment ordinance as

Pakistan Muslim League-Nawaz (PML-N) Spokesperson Marriyum Aurangzeb on Friday commended the decision of Islamabad high court to strike down the Prevention of Electronic Crimes (Amendment) Ordinance, 2022. The spokesperson, in a tweet, congratulated the people of Pakistan, journalists, civil society, media institutions including Pakistan Broadcasters Association (PBA), All Pakistan Newspapers Society (APNS), Council of Pakistan Newspaper Editors (CPNE), Pakistan Federal Union of Journalists (PFUJ), and Association of Electronic Media Editors and News Directors (AEMEND).

arrest and imprisonment and the resultant chilling effect violates the letter of the Constitution and the invalidity thereof is beyond a reasonable doubt,' said the order authored by IHC Chief Justice Athar Minallah. The court ruled that the ordinance was promulgated in derogation of the Constitution and the fundamental rights guaranteed thereunder, particularly Articles 9, 14, 19 and 19-A.

"The jurisdictional preconditions were also not in existence," it further said.

"The Prevention of Electronic Crimes (Amendment) Ordinance, 2022 and promulgation thereof is declared as unconstitutional, invalid beyond reason-

able doubt and it is, therefore, struck down.' The offence under section 20 of the Prevention of Electronic Crimes Act, 2016 to the extent of the expression "or harms the reputation" and the punishment thereof is unconstitutional, invalid beyond reasonable doubt and is, therefore, struck down.

The court also quashed the proceedings against the petitioners. "The Federal Government is expected to review the defamation laws, particularly the Defamation Ordinance, 2002 and thereafter propose appropriate legislation to the Mailis-e-Shoora (Parliament) for making its implementation effective,' the court order stated. IHC CJ Athar Minallah also directed the Interior Ministry to probe the conduct of the officials of the Cyber Crime Wing of the Federal Investigation Agency, which had led to widespread abuse of powers and the consequent grave violations of the fundamental rights of the citizens. The secretary has been ordered

to submit the report within thirty days.

SBP urged to cut markup, export financing rates

KARACHI: President of Employer's Federation of Pakistan (EFP), Ismail Suttar, was completely perplexed by the Central Bank's actions towards the recent inflation rates, and affirmed that the State Bank's action to run riot in increasing the level of already augmented interest rates proves that there is an absolute uncertainty about the correlation between inflation and interest rates in our noble political structure. In a statement, Ismail

ister Imran Khan and his Suttar said that as per the Central Bank's decision the interest rates were increased, yet again, by 250 basis points to 12.25%. The State bank claimed that this increase in interest rate was due to heightened domestic political uncertainty along with increasing oil prices. The

abrupt and unstable decision to increase the interest rate in the country has led Pakistan to become one of the most inflated countries in the region, since the start of 2022.

"The point to be highlighted is that, the interest rates in corresponding countries such as India, Bangladesh, Sri Lanka and Bhutan are still in a range of 4% to 7.16%. Yet a country such as Pakistan, that is experiencing socio-economic instability to a large extent has been driven to sudden rash decisions in the name of stability", he opined.

Moreover, the Central Bank's decision has also spiked up the interest rates for the export financing under Export Finance Scheme (EFS) by 2.5% in line with the increase in policy rate announced in the MPC meeting held recently. If such actions subsist the business community of Pakistan is bound

to see another setback in terms of exports, the so called solution to the problem is actually adding fuel to the fire by spiking up prices of cost of goods sold for the business community of Pakistan and hence contributing to an increase in prices for the average everyday individual, eventually pushing the local businessman out of foreign markets. Analyzing the economic

structure at hand, Employers' Federation of Pakistan adheres to the belief that the economic structure of Pakistan, is in actual reality, a cost push inflationary structure, where an increase in interest rates will cause a boisterous rise in prices as opposed to a decrease. Shopkeepers fined over profiteering

FAISALABAD: Price control magistrates have imposed Rs 269,000 fine on 89 shopkeepers on the charge of profiteering in the district during the past 12 hours.

A spokesman for the administration said on Friday that price control magistrates inspected 583 shops in different markets and bazaars of Faisalabad and found dozens of shopkeepers involved in profiteering and overcharging.

Therefore, the magistrates imposed fine on them and warned that they would be sent behind bars if they did not mend their ways, he added.

Sudden rise in interest rates is worrisome

KARACHI: President of Korangi Association of Trade and Industry (KATI) Salman Aslam has expressed concern over the sudden increase in interest rate by SBP by 2.5% and setting the policy rate at 12.25%. He said that the unexpected meeting and decision of the Monetary Policy Committee would cause irreparable damage to the economy. Salman Aslam said that already due to increase in production cost, stabilization in electricity, gas and petrol prices, it is very difficult to compete with other countries in the region including India, China and Bangladesh. Salman Aslam said that increase in interest rates, export orders are also likely to be affected due to which the wheel of the industry is becoming extremely difficult to move. The country's economy is already under pressure due to the political crisis. In such a scenario, the abrupt rise in interest rates by the SBP is beyond comprehension. He said that in view of such measures, there were concerns over the undue autonomy of the SBP in the business community. - DNA

Covid-19 at ease

S the number of fatalities vanish from the Pakistani coronavirus pandemic for the fifth consecutive day, the rate of infections along with other Covid-19 indicators was also going down gradually.

Pakistan has reported the fifth continuous coronavirus death-free day with the number of single-day infections plunging to 141 during the last 24 hours (Thursday), showed the figures released by the National Institute of

Health Pakistan on Friday morning.

As per the latest NIH data, the death toll from the coronavirus remained unchanged for the fifth continuous day at 30,361, whereas the number of total infections now stood at 1,526,234 after adding the fresh 141 cases. During the last 24 hours, 27,003 tests were conducted throughout Pakistan whereas the positivity ratio stood at 0.52 percent. The number of patients in critical care was 280.

During the last 24 hours, as many as 116 patients have recovered from the virus whereas the total recoveries stood at 1,486,650. As of Friday, the total count of active cases in the country was recorded at 9,223.

As many as 576,110 coronavirus cases have so far been confirmed in Sindh, 505,307 in Punjab, 219,223 in Khyber Pakhtunkhwa, 135,112 in Islamabad, 35,479 in Balochistan, 43,286 in Azad Kashmir and 11,717 in Gilgit-Baltistan.

As many as 13,558 individuals have lost their lives to the pandemic in Punjab so far, 8,097 in Sindh, 6,322 in KP, 1,023 in Islamabad, 792 in Azad Kashmir, 378 in Balochistan and 191 in Gilgit Baltistan.



Yemen's new leadership council

EMEN'S President AbdRabbo Mansour Hadi practically stepped down on Thursday, delegating all his powers to a new presidential council in a move that will hopefully pave the way for peace in the 7-yearold war. The 8-member council, whose members come equally from the north and south of Yemen and represent the main political entities, is tasked mainly with negotiating with the Iran-backed Al Houthi militia to end the war, based on the United Nations-endorsed road map drawn by the Gulf Cooperation's Council (GCC). The move came as the UN-backed 2-month truce in Yemen has already taken effect at the start of Ramadan.

Hadi said he made this decision as per the results of the intra-Yemeni consultations that took place in Riyadh in recent weeks and out of his "historic responsibility" to pave the way for a peaceful settlement to the conflict. His decision to relinquish the presidential powers to the leadership council is expected to unite politically, militarily and financially influential Yemini parties with the aim to form a united block in the face of the Al Houthis' growing threat. A strong united front is needed at this stage to negotiate with the Iran-backed militia, which still controls large parts of the North, including the capital Sana'a.

All Gulf states have welcomed Hadi's decision because supporting this important move at this critical stage of the war will help create the right conditions for the UN and GCC efforts to revive the peace talks. In addition, it will encourage the anti-Al Houthi forces to unite and focus on the national goal of saving Yemen, restoring stability and preserving its territorial unity. But the main task is to unite all national forces to stop Al Houthi aggression and pressure the militia into ending its war on the Yemeni people.

Financial disparities in Civil Service of AJK

OST of the financial policies of the country including AJK and GB are originated, formulated and enforced by the Federal Finance Department, Islamabad. These financial policies are invariably adopted by the provinces, AJK and GB. As the Federal Finance department has no offices in the rural areas therefore they do not get feedback of their policies in rural areas. So they are not abreast of the difficulties and disorders generated by their policies in the rural and far flung areas of the country where the 80% of population lives. As such the unrealistic financial policies cause constant problems in rural areas and apparently it looks like pen-

ny wise pound foolish. As AJK government follows federal fiscal policies, therefore, AJK Civil Servants are also affected by some faulty policies regarding rural and hard areas having tough terrain. In Azad Kashmir pay and other privileges of civil servants are determined on the basis of principle of parity with Punjab.

The first and foremost problem of AJK civil servants posted in the far-flung and unattractive areas is their deprivation of Karnah Allowance. During winter Leepa valley is completely blocked by snow fall and the only way out is the Army Helicopter facility extended by the local army authorities on compassionate grounds. In Iran, our near and dear brother country, their medical staff opt for posting in rural area due to substantial amount of rural area allowance. Before 1947, at the time of liberation of AJK civil servants posted in Karnah area were granted a special allowance of Rs. 50 called Karnah allowance. Karnah allowance at a rate of Rs. 50/- continued up to the year 1990, then it was revised to Rs. 100/- per month and now it is Rs. 200 to every civil ance was also freezed in 1996 should be restored. The Karnah allowance has to be increased commensurate with present salary structure and obtaining hardships faced by the civil servants posted there.

Second and strange financial disparity is that in urban areas house rent is 45 % of pay whereas in rural areas it is only 30 %.

Logic and justice demands that if not more as an incentive atleast house rent must be equalized for the civil servants posted in rural areas. Further there is also big city allowance. The situation seems unreasonable and unfair for which financial policy makers need to attend to the genuine demand of the civil servants posted in rural areas and also for the benefit and development of rural population.

As a consequce, there is absenteeism in rural areas in schools and medical units. There is severe problem of on duty system whereby civil servants are attached in urban areas drawing their salary against their rural area post. In schools the teachers engage unqualified local teachers in rural areas and pay them petty compensation and thereby impair the quality of education. It also results in litigation in case of transfer from urban areas to rural areas as the transfer results in reduction of amount of emoluments. Buildings and offices built in rural areas for the health staff and education employees have gone waste. There are ghost schools also. Instead of extending incentives the staff posted in rural areas they are penalized and consequently the rural population suffers from the non-availability of essential facilities.

So it is imperative for the Finance Secretary of AIK, to take up the matter with the Federal

servants posted from outside. Hill allow- Finance Department. The Inspector General of Police, a lent officer however enjoys admirable reputation in AJK as there is the lowest crime rate and the area is an island of peace highly conducive for tourism. She is resident of Muzaffarabad city and was appointed adhoc lecturer on June1st, 2010, and posted in Authmagam for seven years, transferred to Kohi Ratta for 3 years and further posted to Girls Degree College Leepa for 2 years up to date). She is B.S in computer science with Silver Medal, M.Ed First division with advance diploma in computer science.

> Her result for 12 year has been 100 percent. She qualified Public Service Commission written test in 2019 and placed 3rd in top three. As per their practice the PSC called up only top two for interviews and she could not be called for interview. Despite 12 years meritorious adhoc service, Silver Medal, and cent per cent annual results. She is worried for her service career. This example shows the failure of supervision of education department at the secretariat level.

According to the official statistics, the crime rate of Pakistan in 2001 includes a total of 8,906 murders, which reached its all-time high in 2013 with 13,937 murders. It reduced to 8,490 in 2020. Kidnapping cases registered in 2001 were 7,126 as opposed to 19,658 in 2020. Robbery cases have seen an alarming increase, due to the lack of government interest, from 7,513 to 19,904. There were 6.618 reported cases of cattle theft in 2001, and it escalated to 8,649 in 2020

HERE is no country in the world, developed or developing, without the plague called crime. Since it tainted civilization, this characteristic has been passed on from generation to generation as a treasured family legacy. The question of how much it exists, on the other hand, has long been a cause of considerable disagreements. Understanding the amount of crime at any one moment is critical for enforcement agencies, lawmakers, and other political officials. The ability to quantify crime enables the establishment to analyze crime statistics. Those well versed with crime statistics can calibrate their contrivance with such trends and compare their statistics on a local level.

Crime may range from robbery, burglary, kidnapping and murder to rape and sexual assault. One thing that remains common in all these is the fear that makes its way into the hearts of the citizens of a country.

As reported by the FBI, the number of hate crime offenses in 2000(pre 9/11) was 28, which increased drastically to 481 in 2001. In 2001, approximately 17.7 percent of single-bias hate crimes were of religious prejudice. 26.2 percent of them were targeted due to intolerance against the Islamic religion.

The development of a country has a direct relation to its crime rate. Although it is not the only determinant, it does dominate the regress. In the Human development Index 2020Norway, Ireland and Switzerland are the top three countries that are given the title of highly developed countries with 31, 38 and 42 cases of intentional homicides in 2019. Chad, Central African Republic and Niger are at the bottom of this list with 1430, 1009 and 1244 cases of intentional homicides in a year. Pakistan at the 154th position has unusually high intentional homicides that reach up to 13000. Germany is ranked 6th in the development index yet there were 769 intentional homicides registered to its name in 2019. There has been an alarming increase in criminal activities in the past few years throughout the world.Pakistan is teeming with narcotics trafficking, political instability, domestic terrorism, mafias, income inequality, and extremist groups. Some dominant factors that influence the increase in crime rate are unemployment, inflation, and lack of education, poverty and Urbanization. It is indirectly affected by a number of factors all of which are common in Pakistan which includes Nepotism, lack of recreational ac-

tivities and drug abuse. The crime rate from 2010-20 increased from 642,762 to 876,430 - which is a 36 percent increase in crime as accompanied by a 33 percent increase in population. According to the official statistics, the crime rate of Pakistan in 2001 includes a total of 8,906 murders, which reached its all-time high in 2013 with 13,937 murders. It reduced to 8,490 in 2020. Kidnapping cases registered in 2001 were 7,126 as opposed to 19,658 in 2020. Robbery cases have seen an alarming increase, due to the lack of government interest, from 7,513 to 19,904. There were 6,618 reported cases of cattle theft in 2001, and it escalated to 8,649 in 2020. Data collected by Gender Crime Cell (GCC) of National Police Bureau (NPB) records 25,935 cases of gender-based violence (GBV) reported in the country in the year 2020 as compared to 28,095 reported cases in 2019. The trend analysis shows that there is a slight decline in crime cases of GBV in 2020 (48%) compared to 2019 (52%)

Punjab and KPK experience the highest number of crimes with values in 6 digits. From 2006-2019 numbers of reported crimes in Punjab increased from 342,149 to 490,313 which show a 43 percent increase. As opposed to Sindh, KPK, Baluchistan and Islamabad that show a 56 percent, -20 percent, 23 percent and 129 percent change respectively. The unemployment rate of Pakistan in 2006 was 0.58 which increased almost six times to 3.542 in 2019. It is an increase of 510 percent and it is not even the highest unemployment rate reached by Pakistan. Pakistan's highest unemployment rate was reached in 2018

which was 4.08. Both crime rate and unemployment show a direct relationship. There has been a gradual increase in unemployment just as there has been in crime rate. The only difference is that unemployment is not the only factor that affects the crime rate so it tends to fluctuate against that direct relationship. Moreover the data plotted is of every type of crime reported while studies show that it is more likely when a person becomes unemployed that they will cease to be a contributing member of the economy. If someone is unable to find a job they will shift towards criminal activities. The primary motive in a crime would be financial gain which usually includes property crime, theft and blackmailing. An unemployed person doesn't necessarily shift towards violent crimes. Although income inequality is one of the major issues that Pakistan faces, GDP per capita gives us a basic view of the Standard of living (SOL) of its inhabitants. It not only has a negative relation with Crime rate but also with the Unemployment rate.

To reduce the rate of criminal offences, the government and policy makers should take steps to address the issues that fuel the rate of crime. Politicians, for example, should focus on economic development rather than crime-fighting methods such as conviction and jail time. However, it is a temporary solution to a constant problem. The state has a crucial influence in lowering the rate of unemployment. Qualified individuals should be actively involved in income-generating ventures that will keep them busy while also providing for them. Employees' salary should be enticing so that they are not forced to engage in criminal activities such as the sale of harmful substances or taking bribes. To address unemployment, the government should prioritize economic growth. When the economy expands at a rapid pace, it immediately corresponds to an increase in work opportunities.

From Page 01 the premier said that he strongly believes that the judiciary is the guardian of justice in the country. The premier said that while he respected the country's judiciary, he complained that the Supreme Court should have at least initiated the probe on the "foreign conspiracy" matter.

"I respect the Supreme Court and the judiciary, but the apex court should have looked at the threat letter before issuing the verdict," he said. PM Imran Khan further complained that the apex court did not take the matter of the "threat letter" as seriously as it should have been taken.

PM Imran Khan further said that the decision on Article 63 (A), regarding horse-trading, also added to his disappointment. "The youth of Pakistan is our future and if they see leaders selling their conscience, what precedent are we setting for them?" he asked, adding that even MNAs who came on reserved seats have become sellouts. He said that nations must stand against wrong, otherwise, nobody can protect them if they don't raise their voices against the corruption and other evils prevalent in the country.

Speaking about the "threat letter", he explained what a cipher is - a coded message sent by embassies to their country - adding that this message cannot be shared with the media and public because if these codes are unveiled, all secret information of Pakistan will be unveiled.

On Thursday, the Supreme Court of Pakistan restored the National Assembly after it declared the government's decision to dissolve the assembly and NA Deputv Speaker Qasim Suri's ruling against the Constitution. The top court has ordered National Assembly Speaker Asad Qasier to summon the session on Saturday (April 9) and not later than on the no-confidence motion against the premier.

Earlier in the day, PM Imran Khan chaired a cabinet meeting, following which Minister for Information and Law Fawad Chaudhry said a commission will be formed that would probe the "threat letter".

would The commission present its report within 90 days after it investigates how many dissident MPs were in contact with foreign powers. "We have evidence of eight dissident MPAs being in contact with foreign dignitaries," Fawad said, adding: "The commission will look at a connection between local handlers and regime change." He said that the parliamentarians would be briefed regarding the details of the threat letter before the voting on the no-confidence motion.

EU froze \$32B in Russian, Belarusian assets amid war

BRUSSELS: The European Union has so far frozen nearly 30 billion euros in assets from blacklisted Russian and Belarusian individuals and companies under sanctions imposed over Moscow's offensive in Ukraine.

A total of \$32 billion (29.5 billion euros) "including assets such as boats, helicopters, real estate and artwork" have been seized, the European Commission said in a statement on Friday. Another over \$212 billion (196 billion euros) of transactions have reportedly

been blocked as well. The EU's figures were partial, based on data from around half of the EU's 27 member states given to the bloc's "Freeze and Seize" task force operating in coordination with G7 partners, including the United States. The EU and US have said they will aggressively hunt down and seize assets of those on their blacklists, deemed to benefit from the Kremlin and contribute to

Russian President Vladimir Putin and his two adult daughters are on them, along with oligarchs, influential business people and politicians including Russian Foreign Minister Sergey Lavrov, and their relatives. The blacklists of individuals and companies are part of waves of swingeing sanctions imposed by the EU, US and G7 countries

luxurious properties have been prominent assets targeted, with several seized in the EU while others have been sailed out of the jurisdictional reach of the G7 sanctions.

In many cases, ascertaining ownership is a tricky task for authorities, given fiscal smokescreens used by the ultra-wealthy, such as shell companies, trusts and proxies.

It's for that reason the EU and US have set up specific task forces to collate information and coordinate.

The commission said a joint meeting of the EU and US task forces would take place later on Friday, with Ukrainian officials participating. The next meeting of the EU's task force will be in two weeks.

The bloc's commissioner for financial services Mairead McGuinness said the sanctions were "crucial for imposing economic pain on Putin's regime and those complicit in the war" and implementation of them was "essential". - Agencies

Russia expels 45 Polish diplomats

MOSCOW: Moscow will expel 45 Polish diplomats, Russia's Foreign Ministry said Friday, in a tit-for-tat move after Warsaw expelled the same number of Russian diplomats over espionage charges last month. The ministry said it summoned the Polish ambassador in

Moscow to "strongly protest against the unjustified" expulsion of Russian diplomats from Poland on March 23. "The ambassador was told that we regard this step as confirmation of Warsaw's conscious desire to completely destroy bilateral relations," the ministry added.

"The blame for that lies wholly with the Polish side." The ministry declared "persona non grata" for 45 employees of the Polish Embassy in Russia and of Polish consulates in the cities of Irkutsk, Kaliningrad and Saint Petersburg "as a response to Poland's unfriendly actions." - APP

UK lifts defense export ban on Turkey

ANKARA: Amid war in Ukraine, the United Kingdom has lifted the defense industry export ban imposed on Turkey, Foreign Minister Mevlüt Çavuşoglu said Thursday. The minister hinted that Canada is also aiming to loosen the ban. Çavuşoglu was speaking at a press conference in Brussels, where he attended the NATO foreign ministers' meeting "We spoke with British Foreign Secretary

Liz Truss. We followed up the issues that came to the fore in the meeting between U.K. Prime Minister Boris Johnson and President Recep Tayyip Erdogan in this hall about 15 days ago," the minister said, emphasizing that one of the issues concerns engine procurement of the TFX National Combat Aircraft, Turkey's one of the most awaited defense projects. "The U.K. has lifted export restrictions. We are

pleased with that," Çavuşoglu said. However, he added that they want to improve cooperation with the U.K. in important defense projects, including warplanes, warships and aircraft carriers. Russia invaded its neighbor, Ukraine, on Feb. 24, though Moscow calls it a "special military operation." NATO ally Turkey shares a maritime border with Ukraine and Russia in the Black Sea and maintains good rela-

tions with both. While it has criticized Russia's offensive, Ankara is trying to balance its close ties and has positioned itself as a neutral party trying to mediate. Turkey, meanwhile, has also sold Ukraine its world-renowned combat drones, which were proven effective in Syria, Libya and Nagorno Karabakh - either operated by the Turkish army or the purchasing countries. - Agencies

Sales management in the textile sector of Pakistan

HE textile industry in Pakistan, especially in the product, is a fiercely competitive business in which sales teams compete for orders from large retail chains in Europe and the United States. As a result, sales management teams must showcase their firms' ability to imitate 'storyboards' (provided by the consumers' originators) at significant expenditures. A sales executive in the textile sector's success depends on their ability to turn a storyboard into a compelling instrument. A person's grasp of the components of a plan and the item's appearance and feel determines the cost of the product. For instance, the textile sector sales teams approach value-based pricing for textile dealing. Cost is a big differentiation in material since there is not anything else that a competitor can not copy. So sales managers also apply the approach of cost leadership for textile sales. As a

result, a few options at varied costs (and effects) are also presented to sellers in several parts of Pakistan. For instance, in Peshawar, Lahore and Karachi fabric markets. Indeed, even after the request has arrived, the sales team continues to devote resources to preparing for customer endorsements, which are expected to pre-orders from the (Project Plan Service) PPS inspection stage to mass production. This essentially means that there will be several consumers with whom separate entries are being made concerning both pre-order testing (for the upcoming season) and PPS tests at the same time (of the momentum season). Each goes through cycles, with a few tense messages and remarks from the authors thrown in. At both the inspection and mass-assembling processes, endorsements must be searched for sources of unpolished components. Sales management dilemma in

Pakistan's textile sector Existing consumers are closely monitored by the sales management teams, especially when new consumers are difficult to come by. The geographical criteria are first: the consumer isnot the same position as the maker. Furthermore, these consumers (massive retailers) are few, and those that are a good fit for a certain organization's manufacturing capability are even fewer. However, the most difficult test for the sales team will be getting the major meeting with another customer. Sales executives need to put in some effort, patience, and consistency to get in. For instance, the sales management team, "Alkaram's" sales team, is aware of the next consumer's opening business in their current store network. It can demonstrate relevant capabilities to fill the identified gaps. Similarly, the sales team of Alkaram also support the preliminary tests to decipher the consumer's preferences (item quality/ assortment/ cost/ innovations). They also obtain the underlying request, execute it, identify gaps in internal

creation abilities, and construct the business expansion plan (and consumer certainty) with limited

improvements. The core problems faced by sales management teams in Textile According to most businesses, consumers want to have all of their request-related talks with a single salesperson in the company, such as a "solitary window" of correspondence. It is also stated that a single individual must be assigned to secure the request edge, especially in 'Akhtar Group,' 'Gul Ahmed,' and 'ADM'. This is used to keep the edge from eroding while the request passes through the regular emphases and revisions at various stages. To protect margins in the piece of the clothing manufacturing sector, 'Akhtar Group' also smooths out all customer interaction through the sales management teams.

An alternate strategy When no orders are recognized into the framework without ensuring that the organization benefits

from the trade, the reaction of the sales team edges disintegrate in any way. Similarly, the group in charge of the various duties sales teamjuggles many balls at different levels - from pre-request through PPS to mass assembly. Occasionally, among the chaos, a ball is dropped. For example, among the many talks the business faculty is having about several things in various stages of development, a consumer email mentioning an extra pocket in a piece of clothing plan in the PPS test stage may be ignored. As a result, when the enraged customer finally brings it up, the organization loses credibility, but it also needs to change following the consumer's instructions. This causes the request to be postponed, resulting in the need for airfreight or the imposition of penalties. Such order edge disintegration reinforces the belief that it is critical to hold the outreach group accountable.



KYIV: Ukraine said as many as 50 people, including five children, were killed and many more were wounded and lost limbs in a rocket strike at a railway station packed with civilians fleeing the threat of a major Russian offensive in the country's east. As regional authorities scrambled to rush civilians out of harm's way, a group of European Union leaders meanwhile visited Kviv to offer President Volodymyr Zelenskiy support and assure him there will be a path to EU membership for Ukraine. Zelenskiy called the strike on the station in Kramatorsk in the eastern region of Donetsk region a deliberate attack on civilians. Regional governor Pavlo Kyrylenko said the death toll rose to 50 from an earlier reported 39 as some of the several dozen wounded had died after being taken to hospital or medical centers. He said the station was hit by a Tochka U short-range ballistic missile that contained cluster munitions. which explode in mid-air, spraying small lethal bomblets over a wider area. They wanted to sow panic and fear, they wanted to take as many civilians as possible," he said.

IHC declares PECA ordinance unconstitutional

ISLAMABAD: The Islamabad High Court (IHC) on Friday declared the Prevention of Electronic Crimes Act (PECA) 2016 ordinance "unconstitutional." The court instructed the federal government to investigate the abuse of law and submit a report in 30 days. The petition against the Peca ordinance was heard by IHC Chief Justice Athar Minallah. The petition was filed by the Pakistan Federal Union of Journalists (PFUJ). President Dr Arif Alvi promulgated an ordinance in February to amend the PECA law as the government moved to curb "fake news". According to journalists and experts, the government's move aimed to silence dissent on social media and control the media. The media bodies had challenged the "draconian

law" in the IHC following countrywide protests. The journalist associations, including Pakistan Broadcasters Association (PBA), All Pakistan Newspapers Society (APNS), Council of Pakistan Newspaper Editors (CPNE), Association of Electronic Media Editors and News Directors (AEMEND) and some senior journalists of the country, had filed the petition through senior lawyer Munir A Malik.

The four-page order of the IHC issued today stated that free speech protected under Article 19 and the right to receive information under Article 19-A of the Constitution are essential for the development, progress and prosperity of a society and suppression thereof is unconstitutional and contrary to the democratic values. arrest and imprisonment and the resultant chilling effect violates the letter of the Constitution and the invalidity thereof is beyond a reasonable doubt,' said the order authored by IHC Chief Justice Athar Minallah. The court ruled that the ordinance was promulgated in derogation of the Constitution and the fundamental rights guaranteed thereunder, particularly Articles 9, 14, 19 and 19-A.

"The jurisdictional preconditions were also not in existence," it further said.

"The Prevention of Electronic Crimes (Amendment) Ordinance, 2022 and promulgation thereof is declared as unconstitutional, invalid beyond reason-

able doubt and it is, therefore, struck down.' The offence under section 20 of the Prevention of Electronic Crimes Act, 2016 to the extent of the expression "or harms the reputation" and the punishment thereof is unconstitutional, invalid beyond reasonable doubt and is, therefore, struck down.

The court also quashed the proceedings against the petitioners. "The Federal Government is expected to review the defamation laws, particularly the Defamation Ordinance, 2002 and thereafter propose appropriate legislation to the Mailis-e-Shoora (Parliament) for making its implementation effective,' the court order stated. IHC CJ Athar Minallah also directed the Interior Ministry to probe the conduct of the officials of the Cyber Crime Wing of the Federal Investigation Agency, which had led to widespread abuse of powers and the consequent grave violations of the fundamental rights of the citizens. The secretary has been ordered

to submit the report within thirty days.

KARACHI: President of Employer's Federation of Pakistan (EFP), Ismail Suttar, was completely perplexed by the Central Bank's actions towards the recent inflation rates, and affirmed that the State Bank's action to run riot in increasing the level of already augmented interest rates proves that there is an absolute uncertainty about the correlation between inflation and interest rates in our noble political structure. In a statement, Ismail

ister Imran Khan and his Suttar said that as per the Central Bank's decision the interest rates were increased, yet again, by 250 basis points to 12.25%. The State bank claimed that this increase in interest rate was due to heightened domestic political uncertainty along with increasing oil prices. The

abrupt and unstable decision to increase the interest rate in the country has led Pakistan to become one of the most inflated countries in the region, since the start of 2022.

"The point to be highlighted is that, the interest rates in corresponding countries such as India, Bangladesh, Sri Lanka and Bhutan are still in a range of 4% to 7.16%. Yet a country such as Pakistan, that is experiencing socio-economic instability to a large extent has been driven to sudden rash decisions in the name of stability", he opined.

Moreover, the Central Bank's decision has also spiked up the interest rates for the export financing under Export Finance Scheme (EFS) by 2.5% in line with the increase in policy rate announced in the MPC meeting held recently. If such actions subsist the business community of Pakistan is bound

to see another setback in terms of exports, the so called solution to the problem is actually adding fuel to the fire by spiking up prices of cost of goods sold for the business community of Pakistan and hence contributing to an increase in prices for the average everyday individual, eventually pushing the local businessman out of foreign markets. Analyzing the economic

Sudden rise in interest rates is worrisome

KARACHI: President of Korangi Association of Trade and Industry (KATI) Salman Aslam has expressed concern over the sudden increase in interest rate by SBP by 2.5% and setting the policy rate at 12.25%. 

ISLAMABAD: Islamabad Capital Territory (ICT) Administration Friday imposed section 144, bounding shopkeepers to display rate list of essential items to counter profiteering in the federal capital.

According to a notification issued by Deputy Commissioner: "It has been brought to the administration's notice that essential commodities are being sold on high prices than the rates specified by the administration. Moreover, sellers/shopkeepers are not displaying the price list in their shops."

The DC ordered the sellers to display the price list as specified in the prevention of hoarding and profiteering (price control) Act. Officers of the food department, agriculture department, market committees, police and area magistrates are authorised to inspect shops and forward the violations to the concerned assistant commissioners for action, the order said. The order will come into force with immediate effect and will remain in force for two months.

Dr Shera gets honorary Doctorate

I went to college and university, in Europe, all on my own, at my initiative, without my parents knowing what I was doing. When I left home for Europe, I couldn't get an airline ticket. I decided to hitchhike and walk to Europe at the age of 22," he said while sharing his strug-

Having been brought up in a small rural community in Pakistan, Dr James Shera MBE, Labour councilor for Benn Ward, became the first Pakistani Mayor of Rugby in 1988.

Determined to pursue a scholarship at the Catholic University of Louvain in Belgium, Dr Shera hitchhiked from Pakistan to Europe in the late 1960s, eventually moving to the United Kingdom to complete his postgraduate degree.

Passionate about the power of education to change lives, he became a teacher at Newbold Middle School, later holding several governing roles at universities and schools in the region before joining the county council education department until his retirement. James has been involved with community relations and is currently Chair of the Equality and Inclusion Partnership. – APP

President asks insurance company to pay to the widow

ISLAMABAD: President Dr Arif Alvi has asked Jubilee Life Insurance Co. Ltd to pay Rs 1.2 million to the widow of a deceased policyholder. The company had ignored the payment of Rs 1.2 million as the unit price of the policy and simply returned an amount of Rs. 4.5 million, deposited by her late husband as premium, to the widow.

Mst. Iffat Naheed (the com-

to the widow. plainant) had filed a representation with the President against the order of the Federal Insurance Ombudsman (FIO) which had ordered the case to be closed as the insurance company had refunded Rs 4.5 million in an alleged amicable settlement to the widow. While accepting the widow's plea, the President held that the company after having invested the money of the policyholder in business must have earned considerable profits and it would be unjust to deprive the complainant of his contribution to the earned profits as per the principle of economic and distributive justice enshrined in the preamble of Pakistan's

As per details, Mr Muham-

a life insurance policy from Iubilee Life Insurance Co Ltd in 2016 and deposited Rs 4.5 million with the company. Mr Shafique died on 08.12.2018 and his widow filed the death insurance claim after which the company refunded her the Rs 4.5 million, paid by her late husband, as ex-gratia payment. Feeling aggrieved, the complainant approached FIO to seek justice which passed the impugned order. Subsequently, Mst Iffat Naheed filed a representation with the President for the redressal of her complaint. After investigating the matter,

the President for the redressal of her complaint. After investigating the matter, President Dr Arif Alvi accepted the representation of the complainant and ordered the company to pay an amount of Rs 1,235,339 to the complainant within 30 days. He observed that FIO had failed to notice that the amount of Rs 4.5 million refunded to the complainant under the garb of ex-gratia amount was the actual amount that was deposited by the deceased policyholder. The President termed the alleged amicable

settlement of Rs 4.5 million as against all norms of justice and fairness and stated that the complainant on account of acute financial hardships had accepted whatever was being paid by the company and it was not an act of free will and volition. Referring to Article 3 of the Constitution of Pakistan which provides that the State shall ensure the elimination of all forms of exploitation, the President underlined that Insurance Ordinance, 2000 had been promulgated to regulate the business of the insurance industry and to ensure the protection of the interests of the insurance policyholders. He emphasised that it was incumbent upon the State to ensure that people are not exploited because of their wants, needs and economic compulsions. The President stated that since the payable amount of Rs 1.2 million of the unit price of the policy had been totally ignored by FIO before disposing of the matter, therefore, the representation of the widow is accepted and the company is directed to pay Rs 1.2 million to the complainant within 30 days. - APP

Covid-19 at ease

S the number of fatalities vanish from the Pakistani coronavirus pandemic for the fifth consecutive day, the rate of infections along with other Covid-19 indicators was also going down gradually.

Pakistan has reported the fifth continuous coronavirus death-free day with the number of single-day infections plunging to 141 during the last 24 hours (Thursday), showed the figures released by the National Institute of

Health Pakistan on Friday morning.

As per the latest NIH data, the death toll from the coronavirus remained unchanged for the fifth continuous day at 30,361, whereas the number of total infections now stood at 1,526,234 after adding the fresh 141 cases. During the last 24 hours, 27,003 tests were conducted throughout Pakistan whereas the positivity ratio stood at 0.52 percent. The number of patients in critical care was 280.

During the last 24 hours, as many as 116 patients have recovered from the virus whereas the total recoveries stood at 1,486,650. As of Friday, the total count of active cases in the country was recorded at 9,223.

As many as 576,110 coronavirus cases have so far been confirmed in Sindh, 505,307 in Punjab, 219,223 in Khyber Pakhtunkhwa, 135,112 in Islamabad, 35,479 in Balochistan, 43,286 in Azad Kashmir and 11,717 in Gilgit-Baltistan.

As many as 13,558 individuals have lost their lives to the pandemic in Punjab so far, 8,097 in Sindh, 6,322 in KP, 1,023 in Islamabad, 792 in Azad Kashmir, 378 in Balochistan and 191 in Gilgit Baltistan.



EMEN'S President AbdRabbo Mansour Hadi practically stepped down on Thursday, delegating all his powers to a new presidential council in a move that will hopefully pave the way for peace in the 7-yearold war. The 8-member council, whose members come equally from the north and south of Yemen and represent the main political entities, is tasked mainly with negotiating with the Iran-backed Al Houthi militia to end the war, based on the United Nations-endorsed road map drawn by the Gulf Cooperation's Council (GCC). The move came as the UN-backed 2-month truce in Yemen has already taken effect at the start of Ramadan.

Hadi said he made this decision as per the results of the intra-Yemeni consultations that took place in Riyadh in recent weeks and out of his "historic responsibility" to pave the way for a peaceful settlement to the conflict. His decision to relinquish the presidential powers to the leadership council is expected to unite politically, militarily and financially influential Yemini parties with the aim to form a united block in the face of the Al Houthis' growing threat. A strong united front is needed at this stage to negotiate with the Iran-backed militia, which still controls large parts of the North, including the capital Sana'a.

All Gulf states have welcomed Hadi's decision because supporting this important move at this critical stage of the war will help create the right conditions for the UN and GCC efforts to revive the peace talks. In addition, it will encourage the anti-Al Houthi forces to unite and focus on the national goal of saving Yemen, restoring stability and preserving its territorial unity. But the main task is to unite all national forces to stop Al Houthi aggression and pressure the militia into ending its war on the Yemeni people.

Financial disparities in Civil Service of AJK

OST of the financial policies of the country including AJK and GB are originated, formulated and enforced by the Federal Finance Department, Islamabad. These financial policies are invariably adopted by the provinces, AJK and GB. As the Federal Finance department has no offices in the rural areas therefore they do not get feedback of their policies in rural areas. So they are not abreast of the difficulties and disorders generated by their policies in the rural and far flung areas of the country where the 80% of population lives. As such the unrealistic financial policies cause constant problems in rural areas and apparently it looks like pen-

ny wise pound foolish. As AJK government follows federal fiscal policies, therefore, AJK Civil Servants are also affected by some faulty policies regarding rural and hard areas having tough terrain. In Azad Kashmir pay and other privileges of civil servants are determined on the basis of principle of parity with Punjab.

The first and foremost problem of AJK civil servants posted in the far-flung and unattractive areas is their deprivation of Karnah Allowance. During winter Leepa valley is completely blocked by snow fall and the only way out is the Army Helicopter facility extended by the local army authorities on compassionate grounds. In Iran, our near and dear brother country, their medical staff opt for posting in rural area due to substantial amount of rural area allowance. Before 1947, at the time of liberation of AJK civil servants posted in Karnah area were granted a special allowance of Rs. 50 called Karnah allowance. Karnah allowance at a rate of Rs. 50/- continued up to the year 1990, then it was revised to Rs. 100/- per month and now it is Rs. 200 to every civil ance was also freezed in 1996 should be restored. The Karnah allowance has to be increased commensurate with present salary structure and obtaining hardships faced by the civil servants posted there.

Second and strange financial disparity is that in urban areas house rent is 45 % of pay whereas in rural areas it is only 30 %.

Logic and justice demands that if not more as an incentive atleast house rent must be equalized for the civil servants posted in rural areas. Further there is also big city allowance. The situation seems unreasonable and unfair for which financial policy makers need to attend to the genuine demand of the civil servants posted in rural areas and also for the benefit and development of rural population.

As a consequce, there is absenteeism in rural areas in schools and medical units. There is severe problem of on duty system whereby civil servants are attached in urban areas drawing their salary against their rural area post. In schools the teachers engage unqualified local teachers in rural areas and pay them petty compensation and thereby impair the quality of education. It also results in litigation in case of transfer from urban areas to rural areas as the transfer results in reduction of amount of emoluments. Buildings and offices built in rural areas for the health staff and education employees have gone waste. There are ghost schools also. Instead of extending incentives the staff posted in rural areas they are penalized and consequently the rural population suffers from the non-availability of essential facilities.

So it is imperative for the Finance Secretary of AIK, to take up the matter with the Federal

servants posted from outside. Hill allow- Finance Department. The Inspector General of Police, a lent officer however enjoys admirable reputation in AJK as there is the lowest crime rate and the area is an island of peace highly conducive for tourism. The intelligence agencies of the base camp have all along been vigilant and efficient. So tourism could flourish hence if government staff in rural areas is adequately paid to their satisfaction. At present, how the civil servants posted in hard areas are subjected to physical and mental torture would be evident from one concrete example of one adhoc lady lecturer Mrs. Sumaria Kashif posted in Girls Degree College Leepa. She is resident of Muzaffarabad city and was appointed adhoc lecturer on June1st, 2010, and posted in Authmagam for seven years, transferred to Kohi Ratta for 3 years and further posted to Girls Degree College Leepa for 2 years up to date). She is B.S in computer science with Silver Medal, M.Ed First division with advance diploma in computer science.

> Her result for 12 year has been 100 percent. She qualified Public Service Commission written test in 2019 and placed 3rd in top three. As per their practice the PSC called up only top two for interviews and she could not be called for interview. Despite 12 years meritorious adhoc service, Silver Medal, and cent per cent annual results. She is worried for her service career. This example shows the failure of supervision of education department at the secretariat level.

HERE is no country in the world, developed or developing, without the plague called crime. Since it tainted civilization, this characteristic has been passed on from generation to generation as a treasured family legacy. The question of how much it exists, on the other hand, has long been a cause of considerable disagreements. Understanding the amount of crime at any one moment is critical for enforcement agencies, lawmakers, and other political officials. The ability to quantify crime enables the establishment to analyze crime statistics. Those well versed with crime statistics can calibrate their contrivance with such trends and compare their statistics on a local level.

Crime may range from robbery, burglary, kidnapping and murder to rape and sexual assault. One thing that remains common in all these is the fear that makes its way into the hearts of the citizens of a country.

As reported by the FBI, the number of hate crime offenses in 2000(pre 9/11) was 28, which increased drastically to 481 in 2001. In 2001, approximately 17.7 percent of single-bias hate crimes were of religious prejudice. 26.2 percent of them were targeted due to intolerance against the Islamic religion.

The development of a country has a direct relation to its crime rate. Although it is not the only determinant, it does dominate the regress. In the Human development Index 2020Norway, Ireland and Switzerland are the top three countries that are given the title of highly developed countries with 31, 38 and 42 cases of intentional homicides in 2019. Chad, Central African Republic and Niger are at the bottom of this list with 1430, 1009 and 1244 cases of intentional homicides in a year. Pakistan at the 154th position has unusually high intentional homicides that reach up to 13000. Germany is ranked 6th in the development index yet there were 769 intentional homicides registered to its name in 2019. There has been an alarming increase in criminal activities in the past few years throughout the world.Pakistan is teeming with narcotics trafficking, political instability, domestic terrorism, mafias, income inequality, and extremist groups. Some dominant factors that influence the increase in crime rate are unemployment, inflation, and lack of education, poverty and Urbanization. It is indirectly affected by a number of factors all of which are common in Pakistan which includes Nepotism, lack of recreational ac-

tivities and drug abuse. The crime rate from 2010-20 increased from 642,762 to 876,430 - which is a 36 percent increase in crime as accompanied by a 33 percent increase in population. According to the official statistics, the crime rate of Pakistan in 2001 includes a total of 8,906 murders, which reached its all-time high in 2013 with 13,937 murders. It reduced to 8,490 in 2020. Kidnapping cases registered in 2001 were 7,126 as opposed to 19,658 in 2020. Robbery cases have seen an alarming increase, due to the lack of government interest, from 7,513 to 19,904. There were 6,618 reported cases of cattle theft in 2001, and it escalated to 8,649 in 2020. Data collected by Gender Crime Cell (GCC) of National Police Bureau (NPB) records 25,935 cases of gender-based violence (GBV) reported in the country in the year 2020 as compared to 28,095 reported cases in 2019. The trend analysis shows that there is a slight decline in crime cases of GBV in 2020 (48%) compared to 2019 (52%)

Punjab and KPK experience the highest number of crimes with values in 6 digits. From 2006-2019 numbers of reported crimes in Punjab increased from 342,149 to 490,313 which show a 43 percent increase. As opposed to Sindh, KPK, Baluchistan and Islamabad that show a 56 percent, -20 percent, 23 percent and 129 percent change respectively. The unemployment rate of Pakistan in 2006 was 0.58 which increased almost six times to 3.542 in 2019. It is an increase of 510 percent and it is not even the highest unemployment rate reached by Pakistan. Pakistan's highest unemployment rate was reached in 2018

which was 4.08. Both crime rate and unemployment show a direct relationship. There has been a gradual increase in unemployment just as there has been in crime rate. The only difference is that unemployment is not the only factor that affects the crime rate so it tends to fluctuate against that direct relationship. Moreover the data plotted is of every type of crime reported while studies show that it is more likely when a person becomes unemployed that they will cease to be a contributing member of the economy. If someone is unable to find a job they will shift towards criminal activities. The primary motive in a crime would be financial gain which usually includes property crime, theft and blackmailing. An unemployed person doesn't necessarily shift towards violent crimes. Although income inequality is one of the major issues that Pakistan faces, GDP per capita gives us a basic view of the Standard of living (SOL) of its inhabitants. It not only has a negative relation with Crime rate but also with the Unemployment rate.

To reduce the rate of criminal offences, the government and policy makers should take steps to address the issues that fuel the rate of crime. Politicians, for example, should focus on economic development rather than crime-fighting methods such as conviction and jail time. However, it is a temporary solution to a constant problem. The state has a crucial influence in lowering the rate of unemployment. Qualified individuals should be actively involved in income-generating ventures that will keep them busy while also providing for them. Employees' salary should be enticing so that they are not forced to engage in criminal activities such as the sale of harmful substances or taking bribes. To address unemployment, the government should prioritize economic growth. When the economy expands at a rapid pace, it immediately corresponds to an increase in work opportunities.

Will not accept 'imported' govt, says PM Imran

From Page 01 the premier said that he strongly believes that the judiciary is the guardian of justice in the country. The premier said that while he respected the country's judiciary, he complained that the Supreme Court should have at least initiated the probe on the "foreign conspiracy" matter.

"I respect the Supreme Court and the judiciary, but the apex court should have looked at the threat letter before issuing the verdict," he said. PM Imran Khan further complained that the apex court did not take the matter of the "threat letter" as seriously as it should have been taken.

PM Imran Khan further said that the decision on Article 63 (A), regarding horse-trading, also added to his disappointment. "The youth of Pakistan is our future and if they see leaders selling their conscience, what precedent are we setting for them?" he asked, adding that even MNAs who came on reserved seats have become sellouts. He said that nations must stand against wrong, otherwise, nobody can protect them if they don't raise their voices against the corruption and other evils prevalent in the country.

Speaking about the "threat letter", he explained what a cipher is - a coded message sent by embassies to their country - adding that this message cannot be shared with the media and public because if these codes are unveiled, all secret information of Pakistan will be unveiled.

On Thursday, the Supreme Court of Pakistan restored the National Assembly after it declared the government's decision to dissolve the assembly and NA Deputv Speaker Qasim Suri's ruling against the Constitution. The top court has ordered National Assembly Speaker Asad Qasier to summon the session on Saturday (April 9) and not later than on the no-confidence motion against the premier.

Earlier in the day, PM Imran Khan chaired a cabinet meeting, following which Minister for Information and Law Fawad Chaudhry said a commission will be formed that would probe the "threat letter".

would The commission present its report within 90 days after it investigates how many dissident MPs were in contact with foreign powers. "We have evidence of eight dissident MPAs being in contact with foreign dignitaries," Fawad said, adding: "The commission will look at a connection between local handlers and regime change." He said that the parliamentarians would be briefed regarding the details of the threat letter before the voting on the no-confidence motion.

EU froze \$32B in Russian, Belarusian assets amid war

BRUSSELS: The European Union has so far frozen nearly 30 billion euros in assets from blacklisted Russian and Belarusian individuals and companies under sanctions imposed over Moscow's offensive in Ukraine.

A total of \$32 billion (29.5 billion euros) "including assets such as boats, helicopters, real estate and artwork" have been seized, the European Commission said in a statement on Friday. Another over \$212 billion (196 billion euros) of transactions have reportedly

been blocked as well. The EU's figures were partial, based on data from around half of the EU's 27 member states given to the bloc's "Freeze and Seize" task force operating in coordination with G7 partners, including the United States. The EU and US have said they will aggressively hunt down and seize assets of those on their blacklists, deemed to benefit from the Kremlin and contribute to

Russian President Vladimir Putin and his two adult daughters are on them, along with oligarchs, influential business people and politicians including Russian Foreign Minister Sergey Lavrov, and their relatives. In many cases, ascertaining ownership is a tricky task for authorities, given fiscal smokescreens used by the ultra-wealthy, such as shell companies, trusts and proxies.

It's for that reason the EU and US have set up specific task forces to collate information and coordinate.

The commission said a joint meeting of the EU and US task forces would take place later on Friday, with Ukrainian officials participating. The next meeting of the EU's task force will be in two weeks.

The bloc's commissioner for financial services Mairead McGuinness said the sanctions were "crucial for imposing economic pain on Putin's regime and those complicit in the war" and implementation of them was "essential". - Agencies

Russia expels 45 Polish diplomats

Moscow to "strongly protest against the unjustified" expulsion of Russian diplomats from Poland on March 23. "The ambassador was told that we regard this step as confirmation of Warsaw's conscious desire to completely destroy bilateral relations," the ministry added.

"The blame for that lies wholly with the Polish side." The ministry declared "persona non grata" for 45 employees of the Polish Embassy in Russia and of Polish consulates in the cities of Irkutsk, Kaliningrad and Saint Petersburg "as a response to Poland's unfriendly actions." - APP

UK lifts defense export ban on Turkey

ANKARA: Amid war in Ukraine, the United Kingdom has lifted the defense industry export ban imposed on Turkey, Foreign Minister Mevlüt Çavuşoglu said Thursday. The minister hinted that Canada is also aiming to loosen the ban. Çavuşoglu was speaking at a press conference in Brussels, where he attended the NATO foreign ministers' meeting "We spoke with British Foreign Secretary

Liz Truss. We followed up the issues that came to the fore in the meeting between U.K. Prime Minister Boris Johnson and President Recep Tayyip Erdogan in this hall about 15 days ago," the minister said, emphasizing that one of the issues concerns engine procurement of the TFX National Combat Aircraft, Turkey's one of the most awaited defense projects. "The U.K. has lifted export restrictions. We are

pleased with that," Çavuşoglu said. However, he added that they want to improve cooperation with the U.K. in important defense projects, including warplanes, warships and aircraft carriers. Russia invaded its neighbor, Ukraine, on Feb. 24, though Moscow calls it a "special military operation." NATO ally Turkey shares a maritime border with Ukraine and Russia in the Black Sea and maintains good rela-

tions with both. While it has criticized Russia's offensive, Ankara is trying to balance its close ties and has positioned itself as a neutral party trying to mediate. Sales management in the textile sector of Pakistan

AHMER NAQVI

HE textile industry in Pakistan, especially in the product, is a fiercely competitive business in which sales teams compete for orders from large retail chains in Europe and the United States. As a result, sales management teams must showcase their firms' ability to imitate 'storyboards' (provided by the consumers' originators) at significant expenditures. A sales executive in the textile sector's success depends on their ability to turn a storyboard into a compelling instrument. A person's grasp of the components of a plan and the item's appearance and feel determines the cost of the product. For instance, the textile sector sales teams approach value-based pricing for textile dealing. Cost is a big differentiation in material since there is not anything else that a competitor can not copy. So sales managers also apply the approach of cost leadership for textile sales. As a

result, a few options at varied costs (and effects) are also presented to sellers in several parts of Pakistan. For instance, in Peshawar, Lahore and Karachi fabric markets. Indeed, even after the request has arrived, the sales team continues to devote resources to preparing for customer endorsements, which are expected to pre-orders from the (Project Plan Service) PPS inspection stage to mass production. This essentially means that there will be several consumers with whom separate entries are being made concerning both pre-order testing (for the upcoming season) and PPS tests at the same time (of the momentum season). Each goes through cycles, with a few tense messages and remarks from the authors thrown in. At both the inspection and mass-assembling processes, endorsements must be searched for sources of unpolished components. Sales management dilemma in

Pakistan's textile sector Existing consumers are closely monitored by the sales management teams, especially when new consumers are difficult to come by. The geographical criteria are first: the consumer isnot the same position as the maker. Furthermore, these consumers (massive retailers) are few, and those that are a good fit for a certain organization's manufacturing capability are even fewer. However, the most difficult test for the sales team will be getting the major meeting with another customer. Sales executives need to put in some effort, patience, and consistency to get in. For instance, the sales management team, "Alkaram's" sales team, is aware of the next consumer's opening business in their current store network. It can demonstrate relevant capabilities to fill the identified gaps. Similarly, the sales team of Alkaram also support the preliminary tests to decipher the consumer's preferences (item quality/ assortment/ cost/ innovations). They also obtain the underlying request, execute it, identify gaps in internal

creation abilities, and construct the business expansion plan (and consumer certainty) with limited

improvements. The core problems faced by sales management teams in Textile According to most businesses, consumers want to have all of their request-related talks with a single salesperson in the company, such as a "solitary window" of correspondence. It is also stated that a single individual must be assigned to secure the request edge, especially in 'Akhtar Group,' 'Gul Ahmed,' and 'ADM'. This is used to keep the edge from eroding while the request passes through the regular emphases and revisions at various stages. To protect margins in the piece of the clothing manufacturing sector, 'Akhtar Group' also smooths out all customer interaction through the sales management teams.

An alternate strategy When no orders are recognized into the framework without ensuring that the organization benefits

from the trade, the reaction of the sales team edges disintegrate in any way. Similarly, the group in charge of the various duties sales teamjuggles many balls at different levels - from pre-request through PPS to mass assembly. Occasionally, among the chaos, a ball is dropped. For example, among the many talks the business faculty is having about several things in various stages of development, a consumer email mentioning an extra pocket in a piece of clothing plan in the PPS test stage may be ignored. As a result, when the enraged customer finally brings it up, the organization loses credibility, but it also needs to change following the consumer's instructions. This causes the request to be postponed, resulting in the need for airfreight or the imposition of penalties. Such order edge disintegration reinforces the belief that it is critical to hold the outreach group accountable.

Slovakia sends S-300 to Ukraine

ANKARA: Slovakia's prime minister on Friday confirmed that his country has provided an S-300 air defense system to Ukraine against Russia's aggression.

"I would like to confirm that #Slovakia has provided #Ukraine with an air-defense system S-300. #Ukrainian nation is #bravely defending its sovereign country," Eduard Heger said on Twitter.

He added that it is his duty not to remain silent on the loss of lives.

The Russia-Ukraine war, which started on Feb. 24. has drawn international outrage, with the EU, US, and the UK, among others, implementing tough financial sanctions on Moscow.

At least 1.626 civilians have been killed and 2,267 injured in Ukraine, according to UN estimates, with the true figure feared to be far higher. More than 4.3 million Ukrainians have fled to other countries, with millions more internally displaced, according to the UN refugee agency. - APP

Finland to apply for NATO membership

STOCKHOLM: plans to apply for NATO membership in the first week of May, according to local news report on Friday. Finnish news outlet Iltalehti said Helsinki will start preparations to join the military alliance on April 14 and membership application will be submitted in the first week of May.

Meanwhile, Alexander Stubb, former prime minister of the Nordic country, said Finland "will apply within weeks" and latest by May.

In an interview with Anadolu Agency during last month's Antalya Diplomacy Forum, Finnish Foreign Minister Pekka Haavisto said "we keep the NATO option" and according to opinion polls "majority of the Finnish citizens are in favor of NATO partnership.

A mid-March poll by Finnish public broadcaster YLE found for the first time a majority of Finns saying yes to joining NATO, with 62%. Before Russia's war on Ukraine, which began on Feb. 24, polls in Finland showed most opposing membership in the alliance. Another recent survey by YLE said 112 of the deputies in the Finnish parliament support NATO membership, while 71 oppose and 17 of them are undecided. - APP



Debt to GDP ratio falls to 72 per cent

ISLAMABAD: Public debt. as a percentage of Gross Domestic Product (GDP), decreased to 72 percent during the fiscal year 2021, from 76.6 percent in FY 2020, finance ministry said here Friday while rebutting an article published in a section of press.

According to the latest published data, public debt to GDP is estimated to have declined further to 67% of GDP as of December 2021, said a press statement issued by the finance ministry.

In real terms, the increase in public debt during the 2018-2022 period is around 3.3% of GDP, which is less than the debt accumulated during 2013 to 2018 period of 8.2% of GDP, it said.

The article on 'Public debt soars by Rs18 trillion' "published by Express Tribune in its edition on April 6, 2022 is misleading and the author's comparison of the 2008 to 2022 period fails to take into account the significant changes in the size of the economy," the statement added.

It said, the economy's capacity to take loans today was higher than compared

GENEVA: The UN's top priority remains civilians' safe evacuation from "encircled places of hell" in Ukraine, such as Mariupol, where they are trapped, a senior UN official said on Friday.

In an ongoing visit to Ukraine, UN Humanitarian Affairs chief Martin Griffiths was in the capital Kyiv on Thursday, where he met Prime Minister Denvs Shmvhal and other officials, said Jens Laerke, Geneva spokesman for the UN Office for the Coordination of Humanitarian Affairs (OCHA).

"Griffiths witnessed firsthand the scenes of death and destruction in the nearby towns of Bucha and Irpin in the Kyiv district, following the withdrawal of Russian forces from the area," Laerke said at a UN press conference.

He said that last night, Griffiths said his first humanitarian concern was the need for the safe passage and evacuation of civilians from encircled "places of hell," Mariupol being the worst.

For weeks, the International Red Cross has tried to the rescue of many thousands of people trapped in the southern port city. Russia has bombarded Mari-

upol from the air and ground since it invaded Ukraine on Feb. 24. It is now encircled. and while tens of thousands have fled, many still remain. An International Committee of the Red Cross (ICRC) team had led a convoy of buses and private cars carrying more than 1,000 people to the city of Zaporizhzhia after the civilians fled besieged Mariupol on their own, the ICRC said on Wednesday.

Due to the actions of Russian forces, the ICRC has been unable to reach Mariupol and rescue civilians subjected to constant bombardment. Laerke said Griffiths had also warned that Luhansk

and Donetsk, separatist tarian concern.

He said Griffiths had urged Russia and Ukraine to "ensure safe passage" for civilians out of those areas, where Russian-backed forces have waged war since 2014.

"Within six weeks, UN agencies and humanitarian NGOs have dramatically scaled up operations, and some 160 partners are now present in all Ukraine's 24 oblasts," said Laerke. That compares with six weeks ago when operations were limited to Ukraine's two eastern oblasts of Donetsk and Luhansk.

"The war in Ukraine has triggered one of the fastest-growing displacement and humanitarian crises ever," UNHCR spokesperson Matthew Saltmarsh said at the UN press conference. "Within six weeks, more

than 4.3 million refugees areas that Russia says are have fled the country, independent, "are going while a further 7.1 million to be a very high humaniare displaced internally." He said that delivering aid remains challenging in the parts of the country where there is active fighting. "We continue striving to

reach hard-hit areas such as Mariupol and Kherson with life-saving assistance," said Saltmarsh. On Wednesday, he said one aid convoy had managed to reach Sievierodonetsk in Luhansk, eastern Ukraine.

"For weeks, people there have endured relentless shelling and shortages of basics like water, gas, and electricity. Our team was able to deliver solar lamps, blankets. hygiene kits, baby formula, and tarpaulin sheets to 3,000 people," said Saltmarsh.

Ukraine's President accuses Russia of seeking mercenaries

KIEV: Ukraine on Friday accused Moscow of trying to recruit mercenaries, militants, and terrorists to wage Russia's war against its western neighbor.

"They're looking for mercenaries from all over the world. They are sending the militants from all the terrorist groups and private armies that were established by some of the Russian officials," President Volodymyr Zelenskyy told Finland's par-

liament in a video address, continuing his addresses to foreign lawmakers, seeking a harder line against Moscow. Zelenskyy hailed Finland for imposing sanctions on Russia, also stressing that "the war of Russia against Ukraine is decisive" not only for the future of Ukraine and its people but also for all those bordering Russia. Russia and Finland share a 1,340-kilometer (833-mile) border, and in the early days of World War II Russian

troops invaded Finland. Zelenskyy further urged the cutting of all economic ties with Russia, pressing for a full European embargo on Russian oil. "We need to isolate all the Russian banks from the international banking system. It cannot be limited just by a partial response to the Russian threat in Europe and threat to the democratic world because freedom will not survive if we leave channels that will be fed

he added. Countries should search for new sources of energy besides Russia, said the Ukrainian president, asking: "How much longer can Europe ignore the introduction of an embargo against oil supplies from Russia?" Zelenskyv further noted that at least 928 educational facilities have been destroyed or damaged by Russian forces since the beginning of the war. - Agencies

Pakistan reports no Covid-19 death for fifth straight day

ISLAMABAD: Pakistan has reported zero COV-ID-19 deaths in the past 24 hours, the fifth straight day in a row, according to the National Institute of Health (NIH).

According to NIH database, as many as 141 new cases of the viral disease emerged when 27,000 samples were tested in the last 24 hours. The nationwide tally of confirmed cases stands at 1,526,234 while the death toll is 30,361.

The country's positivity rate was recorded at 0.52per cent, the NIH said, adding the number of patients in critical care in various hospitals across the country has fallen to 280.

It is pertinent to mention here that Pakistan last month announced the withdrawal of all Covid-19 related restrictions. Federal Minister for Planning and Development Asad Umar made the announcement, a key step for the country to move to normalization.

Earlier, Prime Minister Imran Khan congratulated National Command and Operation Center (NCOC) team for professional and nationally coordinated response in fight against COVID-19 pandemic. - DNA

Pakistani Rupee bounces back after **SC** ruling

KARACHI: The Pakistani rupee bounced back on Friday to gain Rs3.18 against the US dollar in intra-day trading after Supreme Court declared the NA deputy speaker ruling unconstitutional and restored National Assembly.

According to foreign currency dealers, the US dollar is trading at Rs185 after depreciating Rs3.18 against the local currency in early trade.

He said that this project is of vital importance owning to growing needs of veterinary education in Malakand Division adding that project on

completion would promote education and research on modern lines in this field. He issued the directive while chairing a meeting regarding establishment of University of Veterinary and Animal Sciences, Swat here the other day. Provincial Minister for Livestock Mohib Ullah Khan, Additional Chief Secretary Shahab Ali Shah, Secretary Livestock Muhammad Israr Khan and other concerned officials attended the meeting. While briefing the meeting about various aspects of the university, it was told that the university would be established in

Chota Kalam spanning over 263 Kanals of land with an estimated cost of Rs 8 billion. The university will provide education and research facilities to students in 20 different departments of three faculties.

Briefing about the proposed departments in university, it was informed that under the faculty of Bio Sciences, Anatomy, Physiology, Pharmacology, Fisheries, Wildlife, Biochemistry and Biotechnology departments would be established while Under the Faculty of Veterinary Science, Nine different departments including Pathology, Microbiology,

Medicine, Surgery and Pet Sciences would be estab-

lished. Similarly, under the Faculty of Animal Production and Technology, five departments would be established including Animal Nutrition, Livestock Management, Poultry Sciences, Breeding and Genetics and Department of Meat and Dairy Technology. Crisis-hit Sri Lanka hikes rates

COLOMB: Cash-strapped Sri Lanka's central bank hiked interest rates by a record 700 basis points Friday as police fired tear gas at hundreds of students protesting about the economic crisis. Severe shortages of food, fuel and electricity have led to widespread anti-government demonstrations with calls for President Gotabava Rajapaksa to resign. The latest protests saw students try to march to the national parliament on Friday.

Elsewhere demonstrators nationwide carried placards demanding Rajapaksa step down over the country's worst economic crisis since independence in 1948. Buddhists monks, who had largely led Rajapaksa's election bid in November 2019, were also seen joining demonstrations in the capital Colombo. The Central Bank of Sri Lanka said its benchmark lending rate had been raised to 14.5 percent to "stabilise the exchange rate" after the rupee tumbled over 35 percent in a month. The rate for deposits was also increased by seven percentage points to 13.5 percent as reports said Sri Lanka's rupee was the worst performing currency in the world, edging out the Russian ruble.

The bank said the shock-treatment rate hike was due to its belief that the embattled island's inflation, which is already at record levels, could get worse.

The Colombo Consumer Price Index rose 18.7 percent in March while food inflation stood at more than 25 percent, but private analysts placed inflation at over 50 percent in the month. International

agencies have downgraded Sri Lanka as fears grow that it could default on its \$51 billion external debt after foreign reserves fell below \$2 billion at the end of March. This week Rajapaksa appointed a panel of experts to organise a restructuring of foreign debt. His government is preparing for bailout negotiations with the International Monetary Fund, and finance ministry officials told AFP the panel will prepare a programme for sovereign bond holders and other creditors to take

KYIV: Predictions at the start of the invasion of a quick Russian victory have been upended by the Ukrainians' willingness to fight, but the war is settling into a long struggle that could still endanger the

wider world too. Remember how it was in Kyiv after the Russians invaded: thousands cramming bitterly cold railway platforms, pushing and shoving to get any train heading away from the Russians. At the height of it, in the week that straddled the end of February and the beginning of March, 50,000 people

were moving west from Kyiv station every single day. Rusty carriages that looked as if they had spent years pensioned off in some siding were hauled back into service so the railway company could lay on dozens of extra services.

Most of the passengers were women and children. Men stayed. The law stated they could not leave the country as Ukraine needed them to fight. I did not see any press gangs.
