Says damaging public property is an 'act of terrorism'

DNA ISLAMABAD: Prime Minister Shehbaz Sharif said Wednesday that strict action would be taken "state's enemies" as he slammed the Pakistan Tehreek-e-Insaf for violence that gripped the country after PTI Chairman Imran Khan's arrest in the Al-Qadir Trust corruption case. PM Shehbaz termed damaging public property an "act of terrorism" and "enhad been "very bitter". He added that never had revengeful acts in politics rendered good results. The prime minister said

"terrorists and elements who are enemies of the state" should immediately desist from their "anti-state activities", warning that the "miscreants" would otherwise be dealt with an iron hand. The premier said the " protection of the state and ideology of Pakistan is more precious to us than our lives and we will not allow anyone to conspire against it". He added, "Nor will we let their nefarious designs be accomplished." Prime Minister Shehbaz Sharif has said that the "real role" and responsibility of political leadership is to not allow their workers to trespass boundaries during any arrests. "As a political worker, we can't express happiness on any arrest.

Multiple arrested, dead as violent protests continue

Four dead in Peshawar, 84 injured; police say nearly 1,000 arrested in Punjab

RAWALPINDI: Following the arrest of PTI Chairman Imran Khan, violent protests continued across the country for second day. Education institutions across Khyber Pakhtunkhwa have been closed "until further orders", the province's education department has said. The death toll from violent protests in Peshawar has climbed to four, Lady Reading Hospital spokesperson Muhammad Asimsaid. He said more than 84 wounded people had been brought to the facility today, adding that the injured persons were being provided medical aid. Meanwhile, the spokesperson of the Khyber Teaching Hospital said that seven injured people were brought to the facility today. A constable, identified as Hakim Khan, was injured during firing by demonstrators, the Islamabad police have said. It added that the injured

Earlier, the Islamabad police had said that protesters at the Police Lines which was given the status of a court venue as a "one-time dispensation" before PTI chief Imran Khan was presented there in two cases - had repelled the law enforcers. "Law enforcers have been directed not to shy away from taking legal action against anyway moving towards Police Lines," it added. Police have arrested another 23 protesters in Karachi as demonstrations against PTI chief Imran Khan's arrest continue. Gulshan Superintendent of Police Zafar Siddique Chaanga said, "We have arrested a total of 23 miscreants -12 at the Insaf House on Sharea Faisal and 11 at Millenium Mall.' Protests were staged at the Insaf House near Nursery on Shrea Faisal - the metropolis' main thoroughfare – and the intersection between Rashid Minhas Road and Stadium Road near Millenium Mall.





Pak Army terms May 9 as 'black chapter' in history

Army showed extreme patience, tolerance, restraint; Military calls PTI's actions "an example of hypocrisy"

RAWALPINDI: In a rare response, the armed forces said on Wednesday that May 9, 2023



The ISPR called the PTI leaders "hypo-

crites" for inciting their workers against

the armed forces on the one hand, and oth-

er, they were praising the military - in a bid

to overshadow their criticism.

"On the one hand, these evil elements vigorously stir up public sentiments to fulfil their narrow and selfish goals and on the other, they do not get tired of highlighting the importance of the army for the country while throwing dust in the eyes of the people. This is an example of hypocrisy."

The military's media wing added that a group of people - draping political garb in their lust for power - have done unprecedented damages to the country that Pakistan's enemies since its inception have not. "The army showed extreme patience, tolerance and restraint and without caring about its own reputation worked with extreme patience and endurance in the wider interest of the country.' The statement mentioned that when such a situation was created under nefarious, a heinous bid was made to force the military to give an immediate response, which could be used for nefarious political purposes. ISLAMABAD: Ms. Shazia Marri. For the last one year it had kept the country unstable. He said some 78 policemen had been injured in the violent protests since the lawful arrest of Imran Khan. Moreover, an ambulance was torched in Peshawar, besides ransacking at the Army House in Lahore and the General Headquarters (GHQ) in Rawalpindi. He said it was Imran Khan who was responsible for all the destruction occurred across the country as he had been continuously instigating his party workers over the year for indulging in violent activities.-APP

Moreover, he said amid the prevailing scenario challenges to judicial independence and media integrity had also threatened democracies, he added.

The federal minister said sub-national and the local level governments were helpful in managing disasters and crisis management in any untoward situation.

He commented that the governments would need to avoid locking in old economic structures, business models and invest in information technology and high-tech infrastructure development.

The Minister noted that

an ambitious policy to address climate change made economic management better and it was needed to cut trade barriers to climate-friendly goods and bring reforms.

He also highlighted that social media and the spread of digital techs had posed more threats to the rights of the people. The tests for the govern-

ment private sector and tech community were created to ensure security and rights, he said. Senator Farooq Hamid Naik of Pakistan Peoples Party Parliamentarians (PPPP) said, "The Constitution protects citizens' rights and freedoms by limiting government powers and ensuring the rights of the masses. He added that stability was necessary for the smooth functioning and working of

functioning and working of the government. "Adaptability for Constitution is equally important so that it can live with the changing demands and needs of the time." "Changes in the constitution will have to be made in a responsible and balanced manner," he said. Senator Naik informed Parliament so far made 26 amendments to the Constitution, to address various challenges in prevailing times due to the growing influence of non-state actors, rising misinformation, and others. The democratic institutions remained responsible for the reach and rehabilitation of the people promoting transparency and accountability in the system, he added.

Climate change, terrorism, and migration needed to

be addressed by the democracies whereas digital platforms could help in managing natural disasters, the Senator said. Senator (R) Farahtullah Babar of PPPP said the constitutional democracies were facing challenges the world over but these have been pronounced more in Pakistan. The challenge of populism was rising in constitutional democracies and Pakistan was also facing it, he added. Fake news, he said had threatened democracies and institutions not only the private sector but also others involved in perpetrating wrong information. Majlis of Azerbaijan, Adil Abish Oglu Aliyev said the Constitution included the opinions of all the people that were being amended from time to time. "Internet and social media have become a part of our lives now that cannot be abolished," he said. He said the incidents of human rights violations and genocide were a matter of concern whereas legislation should be made in that regard.-DNA

NA speaker terms Parliament as centre of power ISLAMABAD: The Parliament House was

abuzz with delegates from more than 17 countries who have gathered for a two-day international constitutional convention aiming to celebrate the Golden Jubilee Celebrations of the Constitution of Pakistan here on Wednesday. The gathering has attracted speakers, deputy speakers, constitutionalists, and representatives from various walks of life also in the House. In his opening address, National Assembly (NA) Speaker Raja Pervaiz Ashraf highlighted the pivotal role of Parliament as the centre of power and the sole legislative organ of the state. He emphasized that the parliament represents the will of the people and, therefore, all state institutions are accountable to it. The speaker, besides sharing insights into the struggles and efforts involved in the journey towards the 1973 Constitution, expressed disappointment over the disruptions caused by multiple episodes of dictatorships, including the execution of the first democratically elected Prime Minister and architect of the Constitution, Shaheed Zulfiqar Ali Bhutto. Drawing attention to the significance of the 18th amendment, he noted that it restored the original spirit of the Constitution and ensured complete provincial autonomy envisioned by Quaid-i-Azam Muhammad Ali Jinnah. However, he stressed the need to fully fulfill the promises outlined in Article 26, Article 3, Article 25, and Article 25-A of the Constitution, thereby eliminating gaps between promise and performance.

Quoting late leader Shaheed Mohtarma Benazir Bhutto, the speaker reiterated that democracy is not a product but a continuous process. He emphasized that democracy encompasses essential elements such as free and impartial media, women's participation, transparent elections, and an impartial judiciary. These building blocks of democracy were promised in the 1973 Constitution, aiming to establish an ideal Islamic and federal parliamentary democracy. at night. The local party leaders and workers were rounded up from Rawalpindi and its suburbs and shifted to different police stations. Truss' Taiwan trip risky business

estern politicians wanting some attention have developed a penchant for popping up in Taiwan and throwing their weight behind its pro-independence authorities so they can buff up their image as principled politicians.

The upcoming visit to the Chinese island announced by Liz Truss, the former UK leader, who has the dubious distinction of being the country's shortest-serving prime minister, being a case in point. Although such visits are intended to convey principled integrity, they only serve to show the unscrupulous opportunism of the visitors who readily dismiss the fundamental truth that Taiwan is "a province of China with no separate status", as stated in a UN resolution and generally acknowledged by most of the international community, so they can mouth off about a China threat. For such is the distorted narrative that prevails that bashing Beijing for its steadfast resolve to pursue reunification plays well with the constituencies these high-minded day-trippers hope to appeal to. As Truss should know, the one-China principle serves as the political foundation of China's relations with other countries, including the United Kingdom. She should also know that bilateral ties between Beijing and London have deteriorated in recent years as a result of the UK constantly trying to stick its oar into Hong Kong affairs. And she should be aware that UK Minister of State in the Department for Business and Trade Dominic Johnson is paying an official visit to Hong Kong this week, the first in five years by a senior UK official, which is widely perceived as signaling there has been a thaw in the frosty relations between the two sides. President Xi Jinping's special representative Vice-President Han Zheng, who attended the coronation ceremony of King Charles III on Saturday and met with UK Prime Minister Rishi Sunak during his stay, was assured that the UK values its relations with China and it hopes to jointly tap the broad prospects for cooperation in areas such as the green economy and sustainable development.Likewise, in an opinion piece published in the Hong Kong-based South China Morning Post on Tuesday, Johnson said the "UK will continue to engage robustly and constructively" with China where their interests converge. Repair work on relations is clearly underway. Repair work that Truss threatens to sabotage with her trip.

The ball is now in the UK government's court to keep the dire consequences of Truss' upcoming visit to Taiwan at bay and catch up with the "relationship renewal" trend of its neighbors in Europe.




Putin's home front

here were no surprises during Vladimir Putin's short speech to commemorate the 78th Victory Day in Moscow on Tuesday. Just as last year, Mr Putin drew risible parallels between the Soviet Union's role in defeating Nazi Germany and his own illegal war in Ukraine. Even the brutal head of the Wagner mercenary force, Yevgeny Prigozhin, has questioned this narrative, which casts Ukraine as a neo-Nazi puppet regime manipulated by a west intent on destroying Russia. But the president resolutely stuck to the usual script. The boilerplate polemic was, however, delivered against a subtly changed backdrop. This was the most muted 9 May celebration since Mr Putin began to co-opt the anniversary for his own revanchist purposes. Fifteen months after Russia's blitzkrieg invasion ground to a halt last February, the blood-soaked war of attrition taking place in eastern Ukraine has limited the Kremlin's capacity to put on a show in Red Square. The parade was light on heavy military equipment, compared with previous years, and did not feature an air display. In other parts of Russia, events were cancelled altogether, with officials citing security grounds. A day traditionally devoted to memory was thus overshadowed by present anxieties. Following the recent drone assault on the Kremlin, the attempted assassination at the weekend of a prominent ultra-nationalist, and successful acts of sabotage across the country, there is a new sense of vulnerability on Mr Putin's home front. The provenance of these attacks is murky - Kyiv has denied responsibility for the Kremlin drones - but their combined effect has been to introduce some sense of war-related jeopardy in Russian everyday life. The fearsome rate of Russian casualties, in battles that have yielded paltry territorial gains, has been accompanied by a notably lacklustre response to a recruiting campaign for new volunteers. New legislation to prevent registered conscripts leaving Russia is generating widespread anxiety and fear among the young. The dropping from Tuesday's parades of the march of the "immortal regiment" - in which relatives display portraits of those fallen in combat during and since the second world war - was explained in relation to security concerns. A fear that it could be used to publicly mourn those lost in Ukraine seems more plausible. During the Putin years, Russia's 9 May celebrations have become increasingly bombastic displays of military pride and menacing intent. This year, reality undercut the performance. Mr Putin was unable to point to any recent successes in the field. Western estimates suggest more than 20,000 Russian troops have died in Ukraine since December, and more than 80,000 have been wounded. Should Ukraine's long-prepared counteroffensive yield significant results, further setbacks on the frontline will compound the new sense of domestic unease. Ahead of a new and crucial phase of the war, Mr Putin played the same old rhetorical tunes. As the home front becomes more volatile, amid tensions embodied by Mr Prigozhin, he may begin looking for some new ones.

am certain that Imran Khan's arrest by the rangers, an army offshoot commanded by army officers and staffed by army Jawans is a coincidence and not the result of a deliberate effort to exclude police from this operation and the entire operation was conducted with IG police on the driving seat against what has been alleged by certain quarters. The allegations were also not true that he was arrested by the order of the Accountability Court because the government this time around was not able to arm twist the judiciary to do what they wanted.

His arrest was portrayed by certain sections as breaking in and disgracing the high court and its chief justice, forcing and dragging a wounded and frail Imran Khan by defying the court's sanctity and while doing so invited visible wrath of annoyed sitting Chief Justice, who took immediate action but at the end declared the arrest in accordance with law and by doing so put the entire nation on a razor's edge.

According to the Pakistani Constitution, every citizen has the right to a fair trial and due process of law, including the right to be free of arbitrary arrest or detention. Article 10 of the Constitution expressly states that no one shall be detained without being informed of the reason for their detention, nor shall anyone be denied the right to consult and be defended by a legal practitioner of their choice.

Section 17(2) of the Criminal Procedure Code (CrPC) similarly prohibits police officers from entering the court's precincts to arrest an accused person who is attending or about to attend a high court hearing. This provision is intended to safeguard the judiciary's independence and the rights of the accused.

While there were over 140 cases against him being heard by the courts around the country, he was arrested on the spurious pretext of a six-year-old and forgotten case of Al-Qadir Trust, in which a petitioner had alleged the taking over of a piece of land by the KP government allegedly, without the consent of the trust, and held Imran Khan responsible for the takeover. The case is sub judice with Peshawar High Court since 2017 awaiting final ruling in which no instance of corruption or corrupt practices as yet proven with finality, no financial transaction between the trust and Imran Khan was involved, and the case was primarily between the KP Government and a trustee of the Al Qadir trust. In addition, the PHC was seized to determine whether the KP government acted within the law in acquiring the land and whether the Al-Qadir Trust's rights had been violated. Even if Imran Khan is ultimately found to have committed no wrongdoing, the Court was also investigating whether the case was used as a diversion from other issues in order to damage his reputation and credibility.

According to a country's legal system, a trial court cannot assume a case that is being heard by its appellate court due to distinct jurisdictions and functions as trial court at first instance hears and decides cases and if it is court premises while he was attending a hearing in a dissatisfied with the trial court's decision, it can appeal to a higher court, such as an appellate court. The arrest also attracted recent amendment made to the NAB ordinance, in which private transactions were excluded from NAB's purview, the NAB's pecuniary jurisdiction was limited to mega-scandals involving over Rs. 500 million, and the statute of limitations for filing a case was reduced to one year, with court permission. While the contested case is six years old, it is between a private trust and the government, and no government funds are involved. In fact, the government appeared to be the beneficiary, and land was acquired in the public interest. In addition, the case has not been classified as a mega scandal because no monetary value has been assigned to it to qualify it as such. The arrest hits Section 16 of the NAB Act which stipulates that an accused will be tried for an offense under the ordinance in the court under whose territorial jurisdiction the alleged offense was committed, as previously there were no territorial limits. This section specifies the territorial jurisdiction of the court, which means that the trial will take place in the area where the alleged offense occurred. This is intended to make it easier for the accused to defend themselves, reduce the burden on the accused and their families, and eliminate the need to travel long distances. Before this amendment, Section 16 did not specify any territorial limitations, and the accused could be tried in any accountability court in Pakistan. I hope while arresting Imran in Islamabad, all legal aspects were taken care of. It is also said in certain sections of the civil society that Imran Khan at the time of arrest was attending a high court hearing, at the orders of the said court and was under "judicial immunity" or "protection." This means that he could not have been arrested by any law enforcement agency while he was inside the court premises or during his transit to or from the court, unless there was a specific order from the court authorizing his arrest. Even if the law enforcing agencies had an arrest warrant issued by a lower court, such as a trial court that was subordinate to the high court, the law enforcement agencies were required to seek permission from the high court judge in session to execute the arrest warrant, and if the high court grants permission, then he could be arrested and taken into custody as the judicial immunity only applies to the jurisdiction of the high court and not to other courts. However, these apersions were set to rest by the order of Islamabad high court which termed the arrest in accordance with the law.

In any case, if an accused person is arrested without proper authorization or in violation of their judicial immunity while attending a high court proceeding, it is a serious matter and can lead to legal and administrative consequences for the law enforcement officials involved. For example, in India in 2019, the Delhi High Court reprimanded the Delhi Police for arresting a man within the case. The court stated that the arrest was a clear violation of the fundamental right to access justice and the independence of the judiciary.

Similarly, in the United States, in 2019, a federal judge in Massachusetts ruled that the U.S. Immigration and Customs Enforcement (ICE) violated the constitutional rights of an undocumented immigrant by arresting him inside a courthouse. The judge stated that the arrest undermined the court's ability to provide access to justice and maintain the integrity of the judicial process. The LAE, may have already set in place the damage controlled mechanism which includes deploy additional police forces, rioting units and specialized units to areas where protests are taking place to prevent violence and maintain public order, arrest protesters engage in violent behavior and charge them with offenses such as assault, destruction of property, or disorderly conduct, use of force to disperse the crowds or prevent them from causing harm to property or people by the use of non-lethal weapons such as tear gas or water cannons, initiating legal action against the opposition leaders or on account of violating the laws and inciting violence and above all curb of freedom on assembly, speech, movement and expression including ban on all communication and information means like stopping the cell phone services and banning conventional and social media to stop spread of rumours heresy and false and fabricated information to incite violence but they must do this by taking in account that it can have significant economic and social effects, particularly on small businesses and entrepreneurs who rely on these platforms to market their products and services, and on vulnerable populations who rely on these platforms for support and information. If Imran Khan or any other leader have committed any wrongdoing, financial bungling, misappropriation of public funds or using illegal means of acquiring money, like all other such persons, no laxity should be shown to him but while living within the confines of constitution and law of the land and without any fear or favor. Trespassing the constitution or law of the land especially by the Law Enforcing Agencies means socio economic disaster and breaking down of social order which is in no one's interest.

Permit me to quote the concluding remarks of a TV anchor who stated that he had never seen such an alarming, dangerous political situation in his professional career, and let us join him in pleading with all leaders, politicians, and influential stakeholders to have mercy on the unfortunate people, this country, and themselves, and to stop leading the nation towards total collapse and catastrophe.

ver since its inception, Pakistan has grappled with a series of institutional crises due to its unstable political system. Although the armed forces have played a significant role in the country's affairs, their involvement has never been formally declared. The military has ruled Pakistan for more than three decades and continues to hold sway over its political economy and key state institutions. In fact, several democratically elected governments have come to power with the military's approval, only to be ousted for infringing on military interests.

In recent times, Imran Khan has emerged as a major political figure, owing in large part to military support. His government, which was in power from 2018 to 2022, has been labeled a "hybrid government" due to this support. Imam hit two half-centuries during the first three matches of the recent-ly-completed ODI series against New Zealand, with the left-hander compiling a stylish 90 in the final game of the series to finish with 174 runs for the series at a healthy average of 58.

It helped Imam jump one place to fourth on the latest ODI batter rankings, with Pakistan now holding on to three of the top four players on the list ahead of this year's ICC Men's Cricket World Cup courtesy of skipper Babar Azam (first) and fellow opener Fakhar Zaman (third).

South Africa's Rassie van der Dussen is the only player sandwiched in between the Pakistan trio, with the right-hander in second place and some 109 rating points behind Babar.

Pakistan's 4-1 series triumph over New Zealand saw many of their best performers rewarded on the latest rankings that was updated by the ICC on Wednesday, with pace trio for ODI all-rounders. Haris Rauf, Shaheen Afridi and Mohammad Wasim

among the big winners. Rauf finished as the leading wicket-taker for the series with nine scalps and improved nine places to 42nd on the ODI bowler rankings as a result, while Wasim moved from outside the top 100 to 69th overall after his six wickets from three games. Afridi claimed eight wickets over the course of the

series, while his entertaining cameo of 23* in the fourth game helped the left-hander rise eight places to 36th on the list

New Zealand's bevy of stars did not leave the sub-continent empty-handed, with pacer Matt Henry rising one spot to fourth on the bowler rankings courtesy of his eight scalps against Pakistan at a decent economy rate of 5.68. Stand-in skipper Tom Latham rose eight spots to equal 21st on the batter rankings following 282 runs for the series, while teammate Will Young shot up 24 places to 75th following his impressive knock of 87 in the series finale in Karachi.

T least 410 people have been confirmed dead and more than 5,000 others received more than 5,000 others remain unaccounted for after the flooding and landslide disaster that struck the Democratic Republic of the Congo's South Kivu province last week, the Associated Press reported on Wednesday. The floods, which started as torrential rain on May 4 to 5, reportedly swept through the riverside villages of Nyamukubi and Bushushu, wiping out buildings along with fields of crops and livestock, leaving thousands of people homeless. Ulrich Crepin Namfeibona, the emergency coordinator for Médecins Sans Frontières (MSF) in South Kivu, described the situation as "dire" and said that some areas have become unrecognizable. "In Nyamukubi, almost half of the village was destroyed. Due to flood damage, the main road between Nyamukubi and Kalehe can no longer be used, hampering the arrival of humanitarian aid," Namfeibona said. Local authorities told the media on Tuesday that the death toll is still rising as efforts to rescue residents and recover bodies continue. "We're not able to deal with this many bodies as urgently as needed. We're searching for bodies with spades, with hands," John Kashinzwe Kibekenge, spokesperson for the Red Cross in South Kivu province, told Reuters. According to AFP, the government has delivered coffins to the affected communities after reports suggested many of the dead had been buried in mass graves. - Agencies

Spain plans to ban

outdoor work MADRID: Spain says it plans to ban outdoor work during periods of extreme heat. Second Deputy Prime Minister Yolanda Díaz told reporters Wednesday that the government will modify legislation covering occupational risks to prohibit outdoor work when the state weather agency, AEMET, issues red or orange alerts. The agency frequently issues such alerts when temperature increases pose a risk for citizens outdoors or for the environment. Last year was Spain's hottest since record-keeping started in 1961, and last month was the hottest and driest April on record. Much of the country is experiencing drought, and water reserves are below 50%. Díaz, who is also labor minister, said that the modifications would be announced by Spain's Cabinet, but gave no further details.

The government will hold a special Cabinet meeting on drought measures on Thursday. It wasn't immediately clear how the measure announced by Díaz would apply to workers such as farmers, farmhands, police, firefighters, gardeners or cleaners.—APP

Quadripartite foreign ministerial meeting on Syria held

A meeting between the foreign ministers of Türkiye, Russia, Iran, and Syria was held on Wednesday in Moscow. At the meeting, participants exchanged views on efforts to normalize relations between Türkiye and Syria and discussed counter-terrorism, the political processes, and humanitarian matters, including the voluntary, safe, and dignified return of Syrians, according to the Turkish Foreign Ministry.

In a tweet after the meeting, Turkish Foreign Minister Mevlut Cavusoglu said in the talks he stressed cooperation in the fight against terrorism, working together to establish a basis for the return of Syrians, bringing the political process in Syria forward,

and the protection of Svria's territorial integrity. Delivering an opening speech, Russian Foreign Minister Sergey Lavrov thanked the ministers for coming to Moscow, noting that the quadrilateral meeting itself is an achievement, as it took some time and a lot of effort to organize it. KSA invites Assad to Arab summit

RIYADH: Saudi Arabia on Wednesday invited head of the Syrian regime, Bashar al-Assad, to attend the Arab League summit for the first time since the country's civil war in 2011. The Syrian presidency said al-Assad received an invitation from Saudi King Salman bin Abdulaziz to attend the summit in the city of Jeddah on May 19. The invitation came only days after Syria was readmitted to the pan-Arab body on Sunday after 12 years of suspension following the regime's brutal crackdown on pro-democracy protests. On Tuesday evening, Saudi Arabia announced the resumption of the work of its diplomatic mission in Syria. The Syrian regime has recently begun to exchange official visits and contacts with several Arab countries in recent months. - Agencies

The minister proposed directing experts from the four countries to draft a road map for Syrian-Turkish normalization to set some benchmarks, necessary to move forward.

"This roadmap should clearly identify the position of the contracting parties of Syria and Türkiye on priority topics, including restoration of control of the Syrian government over the entire country, ensuring reliable security of the 950-kilometer border with Türkiye, excluding the possibility of cross-border attacks, infiltration of terrorists, conducting activities by individuals or groups of individuals aimed at to cause damage to a neighboring

The minister added that the four countries share the same view on the necessity to fight terrorism and separatism.

Last December, the defense ministers and intelligence chiefs of Türkiye, Russia, and the Syrian regime met in Moscow and agreed to continue tripartite meetings to ensure stability in Syria and the wider region.

Iran was also included in the talks, with Türkiye previously saying that Ankara would be "pleased if Iran is involved in this process." Syria has been mired in a vicious civil war since early 2011 when the Assad regime cracked down on pro-democracy protests with unexpected ferocity.-Agencies

EU court annuls **German aid** for Lufthansa

BERLIN: The European Court of Justice on Wednesday annulled the approval of 6 billion (\$6.6 billion) state aid to German airline Lufthansa during the COV-ID-19 pandemic.

Judges in Luxembourg ruled that the EU Commission's approval of the German state aid in 2020 was "vitiated by several errors and irregularities" such as the misjudgment of Lufthansa's significant market power at certain airports. The Commission committed several errors, in particular, by considering that Lufthansa was unable to obtain financing on the markets for the entirety of its needs, by failing to require a mechanism incentivising Lufthansa to buy back Germany's shareholding as quickly as possible," the court said in a statement. Budget airlines Ryanair and Condor pursued a legal campaign against the EU Commission for approving the German state aid to Lufthansa, stressing that it was unfair and not compatible with EU laws.-Agencies

Talks with Armenia in US moved 'one step forward'

Wednesday said the process of normalization of ties with Armenia moved "one step forward" in the US last week. "Over the course of four days in Washington, we had rather intensive discussions around the peace treaty," Azerbaijani Foreign Minister Jeyhun Bayramov told reporters in

Bayramov and his Armenian counterpart Ararat Mirzoyan took part in peace talks in the US capital between April 30 and May 3, with meetings at the White House and State Department. In a statement after the sessions, US Secretary of State Antony Blinken had said, "both demonstrated a sincere commitment to normalizing relations and ending the long-standing conflict between their two countries," adding that "with additional goodwill, flexibility, and compromise, an agreement is within reach." Putin signs decree terminating arms treaty with NATO

MOSCOW: Russian President Vladimir Putin signed a decree on Wednesday terminating the Treaty on Conventional Armed Forces in Europe (CFE). In the same decree, published on the government's portal, Putin delegated additional charge to Deputy Foreign Minister Sergey Ryabkov, who will also serve as a presidential representative in presenting the matter in parliament. "Appoint Sergey Alekseyevich Ryabkov, Deputy Minister of Foreign Affairs of the Russian Federation, as the official representative of the President of the Russian Federation when the Chambers of the Federal Assembly of the Russian Federation consider the issue of terminating by the Russian Federation of the Treaty on Conventional Armed Forces in Europe signed in Paris on November 19, 1990," the decree said. The CFE was a landmark post-Cold War arms control agreement signed on Nov. 19, 1990, in Paris between two military blocs, NATO and the Warsaw Pact.-APP

Russia could step up chemical attacks in Ukraine

BRUSSELS: "I'm NATO and the West would act if they [Russia] used weapons Ukraine. But having said that they stood by when Assad used such weapons in Syria," one expert told Euronews. An expert has warned Russia could use "horrific" chemical weapons in Ukraine, urging the international community to condemn their use.

The Kremlin says it does not have any intention to use chemical weapons.

On Sunday, Russia was accused of using phosphorus on the besieged city of Bakhmut, with Ukraine releasing footage purporting to show it raining down on its positions.

While phosphorus is not classified as a chemical weapon in international law, its use against civilian areas is considered a war crime under the Geneva Convention because of its "indiscriminate" and "traumatic effects".

Phosphorus creates flash fires that are incredibly hard to put out. If people are hit with the chemical they suffer horrendous burns, which actually accelerate if they come into contact with water.

It can, however, be legitimately used by military forces for night illumination and smoke screens.

Despite being an "absolutely horrific weapon", Hamish de Bretton-Gordon, a British chemical weapons expert, says from a military perspective it can be "incredibly successful" on the battlefield. "It was a favourite weapon of the Syrian regime," he explained. "It was used to burn whole towns and villages in the northwest "like some sort of mediaeval scorched earth policy."-DNA

Italian govt arrests smugglers of migrants

ROME: Italy's police arrested on Wednesday 29 people accused of smuggling migrants from Türkiye and Greece in an operation dismantling an international criminal group, authorities said. The authorities suspect the people arrested were part of a criminal gang with members in the three countries ferrying migrants across the eastern Mediterranean to southern Italy, normally on sailboats. The people are also accused of laundering the illegal proceeds from the migrants' trafficking activi-

ty. The arrests come after a four-year-long investigation by the Italian national police, coordinated by the anti-mafia prosecutor's office of Catanzaro, said Francesco Messina, anti-crime director of Italy's state police, in a statement. Italy has seen a massive rise in the arrivals of seaborne migrants from the beginning of the year although the majority of them come from northern African shores. The journey normally begins in Aksaray, where the migrants make their first contact with the Turkish cell

of the organization and are briefed about the details of the journey. Then they are taken across the border between Türkiye and Greece, first to Thessaloniki and then Athens. From the Patras port, they were then carried on sailboats to southern Italy. In other cases, the migrants were leaving directly from Türkiye, in particular from Izmir, authorities said. Italian smugglers then took the migrants to the north of Italy, from where they could reach the border cities of Ventimiglia or Trieste and attempt

to France and Slovenia, respectively, either by taxi, train, or hidden on trucks. The migrants were charged around 10,000 (\$10,949) per trip, police said. But the total cost of the journey could be up to 15,000, including the price of traveling across Italy for which local smugglers charged between 500 to 600. Authorities said the payment in Türkiye normally took place via the hawala system, an informal channel for transferring

GAZA: Palestinian resistance groups in Gaza have fired a barrage of rockets towards Israeli cities in retaliation for the regime's raids on the besieged coastal enclave, hitting targets as far as Tel Aviv. Israeli media also reported that a house was hit in Sderot. Dawood Shahab, an Islamic Jihad official, said the rockets were fired in response to Israel's intensified acts of aggression on Gaza, which has killed at least 17 Palestinians since early Tuesday, warning that the Israeli cabinet is responsible for the further escalation of tensions. Joe Biden restricts asylum access at border

WASHINGTON: The U.S. rolled out a new regulation on Wednesday that will deny asylum to most migrants crossing the U.S.-Mexico border illegally, a key part of President Joe Biden's enforcement plan as COVID-19 border restrictions known as Title 42 end this week.

The final version of the regulation, which becomes effective on Thursday, has no major changes from a draft published in February, a senior Biden administration official told reporters on Tuesday evening.

The regulation creates a new presumption that migrants arriving at the border are ineligible for asylum if they passed through other nations without seeking protection elsewhere first or if they failed to use legal pathways for U.S. entry. The new restrictions, which

will expire in two years, will apply to the vast majority of non-Mexican migrants since they typically pass through multiple countries en route to the United States.

China delivers two more frigates to Pakistan

ISTANBUL:China Wednesday delivered last two of total four navy frigates to Pakistan, state media reported. According to Chinese daily Global Times, China delivered two Type 054A/P frigates to the Pakistan Navy in Shanghai. "This means all four warships of this class been commissioned into the Pakistan Navy,' said the report. Islamabad entract with the China Shipbuilding Trading Company Ltd. (CSTC) for the delivery of two Type-054 A/P frigates in 2017. A deal for two more ships was signed in June 2018.

Beijing has long been an economic and defense partner to Islamabad. Pakistan sealed a \$5 billion deal with China in 2016 for the acquisition of eight Chinese Yuan-class type-041 diesel submarines by 2028 to "address force imbalance" with its archrival India.

Drama at IHC over Tyrian case judgment

ISLAMABAD: Unprecedented drama was witnessed at the Islamabad High Court (IHC) on Wednesday over the Tyrian White case against former prime minister Imran Khan when the majority judgment of Justice Mohsin Akhtar Kayani and Justice Arbab Tahir dismissing the petition was deleted from the court's website minutes after it was uploaded. The majority judgment, authored by Justice Kayani and assented to by Justice Tahir, a copy of which is available with Dawn.com, stated that the writ petition was "not maintainable from the very inception". It also deprecated the petitioner's conduct in filing the petition, noting that "the petitioner should have been mindful of the fact that the court is not a tool to be used by surrogates motivated for extraneous consideration."

A three-judge larger bench comprising IHC Chief Justice Aamer Farooq, Justice Mohsin Akhtar Kayani, and Justice Arbab Muhammad Tahir had reserved its verdict on April 30 on the petition seeking Imran's disqualification for concealing his alleged daughter Tyrian White in his nomination forms submitted to contest the 2018 general election. Not long after the majority judgment was deleted from the court's website, a press release was issued by the court, stating that the "opinion" of the two judges did not constitute judgment of the court and is against court rules and norms. It said the opinion of the judges was released without the issuance of a cause list or intimation to the parties and their counsels. It further said that the signature of Chief Justice Farooq, who is the third member of the bench, was also missing from it. - APP

In a related development, Moody's Investor Service warned that Pakistan could default without an IMF bailout, as the country faces uncertain financing options beyond June, according to Bloomberg. "We consider that Pakistan will meet its external payments for the remainder of this fiscal year ending in June," Grace Lim, a sovereign analyst with the ratings company in Singapore, was quoted as saying by Bloomberg. – **DNA**

Battles shake Sudan's capital as power struggle escalates

KHARTOUM: Fighting in Sudan's capital escalated on Wednesday with fierce clashes and air strikes, witnesses said, as delegations of rival military factions continued talks in Saudi Arabia aimed at securing a ceasefire and humanitarian relief. Residents reported ground battles in several neighbourhoods of Khartoum between the army and the paramilitary Rapid Support Forces (RSF), as well as heavy gunfire in the north of Omdurman and the east of Bahri, two adjacent cities separated from Khartoum by the River Nile. The army has been pounding targets across the three cities since Tuesday as it tries to root out RSF forces that have taken control of large residential areas and strategic sites since early in the conflict that erupted on April 15. "There's been heavy air strikes and RPG fire since 6:30 a.m.", said Ahmed, a resident of the Bahri neighbourhood of Shambat. "We're lying on the ground and there are people living near us who ran to the Nile to protect themselves there under the embankment.' The conflict has created a humanitarian crisis in Africa's third-largest nation by area, displacing more than 700,000 people inside the country and prompting 150,000 to flee to neighbouring states. It has also sparked unrest in Sudan's western Darfur region. The U.N. World Food Programme said that up to 2.5 million more Sudanese were expected to fall into hunger in the coming months because of the conflict, raising the number of people suffering acute food insecurity to 19 million. Army and RSF delegations have been meeting since the end of last week in talks sponsored by the United States and Saudi Arabia in the Saudi Red Sea port city of Jeddah. Negotiations aim to secure an effective truce and allow access for aid workers and supplies after repeated ceasefire announcements failed to stop the fighting. - Agencies

Ukraine says Russian brigade flees Bakhmut outskirts

KYIV: A Ukrainian military unit said on Wednesday it had routed a Russian infantry brigade from territory near Bakhmut, claiming to confirm an account by the head of Russia's Wagner private army that the Russian forces had fled. Moscow has not commented on the reports from either side that its 72nd Separate Motor-rifle Brigade had abandoned its positions on the southwestern outskirts of Bakhmut. The Russian ministry of defence did not immediately reply to a request from Reuters for comment, and Reuters could not independently confirm the situation in the area. A Russian brigade is typically formed of several thousand troops. The eastern Ukrainian city has been the primary target of Moscow's huge winter offensive and scene of the bloodiest ground combat in Europe since World War Two.

Russian mercenary boss Yevgeny Prigozhin, who has repeatedly accused Moscow's regular armed forces of failing to adequately support his private army that led the fight in Bakhmut, said on Tuesday that the Russian brigade had abandoned its positions. "Our army is fleeing. The 72nd

Brigade pissed away three square km this morning, where I had lost around 500 men," Prigozhin said. In a statement overnight, Ukraine's Third Separate Assault Brigade said: "It's official. Prigozhin's report about the flight of Russia's 72nd Independent Motorized Rifle Brigade from near Bakhmut and the '500 corpses' of Russians left behind is true." "The Third Assault Brigade is grateful for the publicity about our success at the front.' Early on Wednesday the unit, formed from Ukraine's nationalist Azov Battalion, reposted a video of one of Azov's founders, Andriy Biletsky, who said his forces had "defeated" the Russian brigade. "In fact, the 6th and 7th squadrons of this brigade were

almost entirely destroyed, brigade intelligence was destroyed, large number of fighting vehicles were destroyed, a considerable number of prisoners were taken," he said. "The attacks were implemented within a territory 3 km wide and 2.6 km deep, and this entire territory is completely liberated from the Russian occupying forces." Ukraine's General Staff, which typically withholds such detail from its regular reports, gave no specific account of fighting in the area, apart from saying that Russia had "conducted an unsuccessful offensive in the city of Bakhmut".
