Rule of law, investment friendly regulations key for economic revival

ISLAMABAD: Economic researchers have stressed the importance of strong political will, the rule of law, low-rated broad-based taxes, spending restraint, a robust currency, and business-friendly regulations to attract investments and foster economic growth in the country. In a Twitter space discussion titled "Can IMF Stand-By Arrangement and Budget 2023-24 Spark Economic Revival," hosted by PRIME, (Policy Research Institute of Market Economy), an economic expert Rizwan Rowji emphasized the importance of eradicating corruption and achieving sustained economic growth of over 8 per cent plus as key to minimising economic woes. He emphasized that economic revival is unattainable without strong political will, judicial reforms and ensuring the rule of law. The focus of the discussion was the latest addition of PRIME's latest quarterly economic report titled Prime Plus released on July 24. Dr Idrees Khawaja stressed

the importance of crucial reforms to revive the economy and tackle uncertainties. He emphasized the critical role of a robust judiciary and the rule of law in attracting investment. Swift dispute resolution and increased awareness about corruption in schools and colleges are equally vital. Ali Salman, the Executive Director of PRIME, remarked that the budget follows previous patterns with a few reforms and positive indicators. Nevertheless, there are no significant reductions in public expenditures, and the impact of privatization is limited. Increased taxes on the salaried class have led to tax evasion issues.

The differentiation between filers and non-filers continues to pose challenges. With the sales tax set at 18 per cent, Ali Salman suggests lowering it to 5 per cent as it is too high. Additionally, the tax exemption regime is doing more harm than good.

SSP conducts Khuli Katchery

RAWALPINDI: Senior Superintendent of Police (SSP) Investigation Rawalpindi, Zunera Azfar here on Tuesday held a 'Khuli Katchery' in Police Lines Headquarters to address public complaints.

According to a Police spokesman, the SSP issued directives to the officers concerned to take action and submit detailed reports on the complaints submitted by the citizens in 'Khuli Katchery'. She said that negligence on part of the officials concerned would not be tolerated. 'Khuli Katcheries' were being held to provide the citizens immediate relief and address their complaints besides it also helped improve standards of policing, she said and issued orders to the officers to complete inquiries and send reports within the given time frame. All-out efforts should be made to ensure the dispensation of speedy justice purely on merit to the people and improve service delivery standards in the district, she added. The spokesman informed that the Senior Police Officers under the Punjab government's open door policy were holding 'Khuli Katcheries' here to provide relief to the citizens.-APP held accountable. Laight added that only 37 confirmed cases had been reported in the district so far which were less than compared to other districts. Tuesday while issuing the monthly performance report disclosed that they responded to a total of 664 emergencies, providing timely and professional assistance to those in need. The report further revealed that during July, Rescue 1122 Abbottabad received an overwhelming number of calls, totaling 38,700. Among these, 17,387 were identified as unnecessary calls, while an alarming 20,649 calls were fake. The team demonstrated remarkable responsiveness, with an average response time of just 7 minutes.


The emergencies attended by Rescue 1122 in Abbottabad during the past month varied in nature. There were 52 medical emergencies due to road traffic accidents, 536 fire incidents, and 65 other critical situations, including recoveries. Unfortunately, seven people lost their lives in the course of these incidents, highlighting the importance of the swift and efficient rescue efforts the report stated that, a total, of 664 people were affected by these emergencies, and Rescue 1122 managed to rescue and provide initial medical aid to them. Additionally, 969 patients were rescued provided first aid and shifted to hospitals for further medical attention.-APP



ISLAMABAD: Parliamentary Secretary for Housing and Works Syed Mehmood Shah on Tuesday informed the National Assembly that compensation and plots had already been given in 2005 to residents/owners of 4880 kanals land acquired in sub-sectors 1 and 2 of sectors G-14. Re-

plying to a Calling Attention notice raised by Qadir Khan Mandokhel and others regarding nonpayment of compensation to residents/owners as per current market rates for build-up properties (BUPs) after fresh assessment of residential units constructed there, he said compensation of land and buildings/houses were paid to the residents in 2005 and 2009 respectively

as per the then market rates. Later, under the decision of the federal cabinet, plots were also given to them, he added. Some of them also file a writ in the court of law but the court had decided that very high compensation had been paid to the residents/ owners of the land, he added. He said now these people were again demanding compensation as per current

rates. Around 1200 people have passed away who had given the plots, he said.

Deputy Speaker Zahid Akram Durrani said that imposing of section four by Deputy Commissioner or Capital Development Authority (CDA) created such issues. The DC and CDA enforced Section Four without realizing the ground reality resulting emergence of such land issues, he added.

He said compensation should be given as per the existing market rate if it was not paid earlier. The Deputy Speaker directed the CDA and Federal Housing Authority to provide alternate plots in lieu of lands of the owners besides BUPs as per current market rates. The CDA was also directed to provide compensation to the affectees of E-12 as per the current rate.

Germany's unemployment rate rises to **3.1% in June**

ISLAMABAD: Germany's unemployment rate rose to 3.1% in July, from 2.9% in the same month last year, the country's statistical authority said on Tuesday. Destatis said that the number of unemployed people was 1.38 million as of June, up 119,000, or 9.5%, on an annual basis. "Roughly 45.7 million persons resident in Germany were in employment in June 2023," it said, adding that the number of employed people was up by 0.7% on a yearly basis. "A year-on-year comparison shows that the long-term upward trend on the labour market continued in June 2023, but at a slower pace,' it added.–**APP**

CPI inflation slides down to 28.3pc in July

ISLAMABAD: The Consumer Price Index (CPI)-based inflation came down to 28.3 percent during the month of July 2023 as compared to 29.4 percent recorded during June 2023, Pakistan Bureau of Statistics (PBS) reported Tuesday. According to PBS data, the CPI based inflation during the ame month of last year was recorded at 24.9%. On month-on-month basis, it increased to 3.5% in July 2023 as compared to a decrease of 0.3% in the previous month and an increase of 4.3% in July 2022. The CPI inflation Urban increased to 26.3% on year-on-year basis in July 2023 as compared to an increase of 27.3% in the previous month and 23.6% in July 2022. On month-on-month basis, it increased to 3.6% in July 2023 as compared to an increase of 0.1% in the previous month and an increase of 4.5% in July 2022. CPI inflation Rural increased to 31.3% on yearon-year basis in July 2023 as compared to an increase of 32.4% in the previous month and 26.9% in July 2022. On month-on-month basis, it increased to 3.3% in July 2023 as compared to a decrease of 0.8% in the previous month and an increase of 4.2% in July 2022. Meanwhile, the Sensitive Price Indicator based inflation on YoY increased to 29.3% in July 2023 as compared to an increase of 34.9% a month earlier and 28.2% in July 2022. On MoM basis, it increased by 2.8% in July 2023 as compared to an increase of 0.2% a month earlier and an increase of 7.3% in July 2022.

Water Management vital for stability of Pakistan

t is a recognized principle "Those who want to govern must know to listen". Experts on water management have all along been expressing their valuable ideas in the print media. Climate hazards have also been highlighted. The change of pattern of rains has caused havoc in last year flood. There is no denving the fact that conservation of water resources of the country is pre condition for food security. The incumbent PDM government is faced with shortage of food commodities and their price hike despite the fact that we have predominantly

an agrarian economy. The PDM government has assigned the major role to the Prime Minster and Finance Minister to face economic challenges. Whereas, the gigantic responsibility necessitates a team effort. Luckily the coalition government stands represented by most of the major political elements of the country with considerable experience and collective wisdom with common political fate and future. The country needs a government which could generate consensus of the political leadership to address the issue of Kalabagh Dam. In our view Maulana Fazal-ur-Rehaman, head of PDM, enjoy the support of his devotees in all provinces. He has sound footing in Baluchistan and KPK. If he makes it a mission to launch a movement for construction of the said vital dam he has the acumen and skill of dealing with political leaders. It goes without saying that the Prime Minister Mian Shahbaz Sharif, is genuinely struggling for good governance, to improve and reform the economy of country,

and provide maximum relief to common man. He has developed admirable relations with comity of nations. It is also just and logical to admit that major decisionss made by coalition government in this short span of their rule were launched without adequate homework, planning and without taking into confidence the stakeholders and also without appreciating the existing administrative structure available to the government. The sudden directive of Free Atta Scheme during the holy month of Ramzan is an example costing 89 billion of rupees. They could have supplemented the already available Cheap Atta Scheme in the field as the clientele was the same. So the outcome was not as had been envisaged.With the change of global climate, technology, and political scenario, the developing nations have to be updated to coup with unforeseen vistas. The old traditional mode of governance has to be reviewed. The annual tree plantation ceremonies should be re-

placed with new projects of water management with the same provision of funds. Each forest enclosure should undertake construction of lakes which could meet water requirements in addition to facilitating fire fighting in forest fires and conservation of water. Alarming fires in Algeria and some other countries are eye openers. There has been colossal loss of life and infrastructure in addition to wildlife. There is a boom of housing schemes with consequent need of tube wells. So there should be a directive for all housing schemes to manage water resources in their respective catchment areas. We have a substantial potential of saving water by huge gathering of Tablighi Jamiat whose volunteers have proved to be effective in maintaining law and order without any help of government agency. They can save water and use it for tree plantation, vegetables and vegetation. Saving water and raising fruit trees are perfectly in consonance with Islamic teachings. If they modify

their mandate and undertake participation in social welfare activities and help the nation in fighting with the havoc of calamities like floods, earthquakes etc. They can surpass any welfare and charitable organization due to their ideal discipline. The expert studies reveal that

we have only water storing capacity of 14 million hectares of water out of 145 million hectares available. The unforeseen and unexpected over flow of flood water release by India in 3 rivers namely Ravi, Beas, and Sutlej should be treated as a windfall instead of taking it as water terrorism. Why we cannot undertake studies to manage the additional source of water. The budget allocation for flood relief and rehabilitation should be diverted to save aforesaid 3 rivers surplus water and utilize for our agrarian objectives. Every year the people of Bahawalpur eagerly await the arrival of Sutlej river. Four years back when the Sutlei overflowed its banks people were jubilant and threw flowers into the river

near Empress Bridge. The issue here lies in India's highhandedness whereby it has deprived the dry regions known as Cholistan, Rohi from its due share of water. India has constructed the world's second largest dam on Sutlej river through which the eastern regions of Pakistan yearn for even a drop of this water. We must insist that Sutlej river flows its original course which passes through Cholistan. Secondly our objection could be that India must not discharge polluted water from its industries as it damages the environment, pollutes underground water, and spreads dangerous diseases such as cancer and bone deformaties

At the same time we should commence micro level water saving projects such as roof rain water as has been done by the several countries of the world like France and USA. In rural regions small nullahs should be converted into mini dams and lakes.

The prime minister also extended his best wishes for the ongoing relief and rescue efforts and extended all possible assistance.

According to CCTV, the Chinese state broadcast, and other global media, at least 11 people were killed and 27 others were reported missing after the torrential rains lashed the Capital city causing massive deluge in its outskirts.-APP

Six died in road mishap

ISLAMABAD: At least six people died and ten others sustained injuries in a head-on collision between a passenger coach and a car in Loralai District, here Tuesday morning. According to Rescue sources, the passenger coach was on its way when a car hit it due to over-speeding.

As a result, six people including women died on the spot, a private news channel reported. Police and rescue team reached the spot and shifted the bodies to the hospital. According to the rescue sources, the incident took place due to the overspeeding of the car. "More details will be shared later after the completion of the investigation," the sources added.-APP

ANF recovers over 33 kg drugs; arrests three

RAWALPINDI: Anti-Narcotics Force (ANF) while conducting three operations recovered over 33 kg drugs and arrested three accused, said an ANF Headquarters here on Tuesday. He informed that in a joint operation conducted by ANF and ASF at Islamabad International Airport, over 10.2 kg heroin was recovered from the possession of a Sri Lankan passenger. The accused was departing for Sri Lanka by flight number QR-613. In another raid, five kg hashish and one kg heroin were recovered from a vehicle intercepted in Mangopir area of Karachi. Two accused residents of Karachi were also arrested during the operation. In third operation, 17 kg hashish concealed for the purpose of smuggling was recovered in Jarobi, Zakhakhel area of Khyber. Separate cases have been registered against the accused while further investigations are under process, he added.-APP

ICCI terms hike in petroleum prices a blow to economy

ISLAMABAD: Ahsan Zafar Bakhtawari, President, Islamabad Chamber of Commerce & Industry (ICCI) said that the government has made a massive hike of almost Rs.20 per litre in the prices of petrol and diesel, which would prove to be a blow to the economy. He said this while addressing a meeting of the business community.

He said that it would unleash a new wave of high inflation and further increase the cost of doing business in the country. The decision would badly squeeze the purchasing power of the already crushed common man leading to a sharp decline in the growth of business activities. The government has also hiked electricity price by Rs.7.5/unit that would multiply the production cost. He said that the price of petrol has



jumped from Rs. 227/litre on 1st August 2022 to almost Rs.273/ litre on 1st August 2023. Similarly, the price of diesel has surged from Rs.245/litre on 1st August 2022 to more than Rs.273/litre on 1st August 2023. This unprecedented hike in POL prices would multiply the energy and transport costs and further increase the cost of doing business

due to which trade and industrial activities would badly suffer. He urged that the government should reconsider such decisions to save people, businesses and the economy from their devastating consequences. Ahsan Bakhtawari said that the SBP has already increased the policy interest rate to 22 percent, making credit cost unaffordable for the business community. The recent hikes in POL and electricity prices would make our products very uncompetitive in the international market and cause decline in our exports. He wondered who would do business and invest in Pakistan in an environment of frequent hikes in the utility tariffs and POL products. He stressed that the government should make drastic cuts in all non-development expenditures and reduce the profit margins of OMCs instead of putting an unbearable burden on the masses and the businesses. He urged that in these difficult times, the government should avoid taking harsh measures and focus on promoting ease of doing business to improve exports and steer the economy out of current challenges.

Faad Waheed, Senior Vice President and Engr. Azhar ul Islam Zafar Vice President ICCI said that the repeated hikes in the POL prices and utility tariffs would shatter the confidence of investors who needed stable prices and tariffs to make longterm investment decisions in Pakistan. They urged that the government should reconsider the latest hikes in POL and electricity prices to save the masses, businesses and the economy from further troubles.

Investigating a migrant tragedy

or the relatives of the hundreds of migrants who drowned in June when a fishing trawler packed with human cargo capsized off the coast of Greece, there has been no body to mourn and no prospect of closure. Eighty-two bodies were recovered after the sinking, and 104 people managed to survive. But as many as 750 migrants were on board the Adriana, which never got close to Italy – its theoretical destination.

The news agenda has moved on. But those lost to the sea must not be forgotten. The Council of Europe was therefore right last week to urge the Greek prime minister, Kyriakos Mitsotakis, to step up efforts to locate the missing, presumed drowned, and to identify the dead. Just as important was its demand for a transparent, thorough and independent investigation into the events of 13-14 June - the worst migrant shipwreck for many years. Why was this appalling disaster not averted despite the Adriana being under observation for about 15 hours before it sank? At a time when European policymaking on irregular migration appears to be focused exclusively on deterrence and prevention, it is vital that such an investigation takes place. The need to do everything possible to safeguard the lives of migrants imperilled at sea is, or should be, a non-negotiable obligation for all civilised states. But in recent years, harassment of NGOs dedicated to that goal has been accompanied by a rise in illegal pushbacks in Greece and elsewhere. The circumstances surrounding the shipwreck of the Adriana are extremely murky. In interviews, multiple survivors have testified that the Greek coastguard attempted to tow the overcrowded trawler towards Italian waters, causing it to topple over. Coastguard officials have denied this.

Separately, it has emerged that, on three occasions, the Greek authorities turned down offers of assistance by Frontex, the EU border and coastguard agency. The coastguard vessel eventually dispatched from Crete to assist the migrants failed to film its operation, meaning no footage of the catastrophe is available. Other vessels, much closer by, were not sent to lend capacity to a potential rescue operation, although distress calls were being made by some migrants to activist groups. According to the coastguard, those on board the boat resisted offers of help and were determined to head to Italy. Responding to the Council of Europe, the Greek minister for migration and asylum, Dimitris Kairidis, cited a judicial investigation into the disaster that is currently under way. But he also deplored a "frenzy" of politically motivated criticism of Greece, allegedly orchestrated by advocates of "open border" policies. Rightly, the European ombudsman last week announced a Brussels investigation into the part played by Frontex in the tragedy in June. One coastguard source told the Guardian: "It should have been a send everything you've got situation." The families of those lost deserve to know why that didn't happen.

West's role in food shortage cannot be ignored

he panic buying of rice in some countries dependent on imports for food, after India, Russia and the United Arab Emirates suspended their rice exports recently, is an acute reminder of how delicate the world food security situation is.

Although there are weather causes – heavy monsoon rains causing serious crop losses in India - geopolitical reasons should be held accountable for this. As was predictable, the West attributes the looming food shortage around the world to Russia, after Moscow refused to renew the Black Sea Grain Initiative on July 17, the day the one-year deal expired. It accuses Russia of imposing a technical blockade of Ukraine's grain exports through the Black Sea, and some have urged the developed economies to form a NATO-type of organization in grain production and trade in response. That accusation is unfair, and that proposal is absurd. To begin with, the West has failed to deliver on a promise to free up Russian agricultural exports that have been blocked by its sanctions. Although Russia's food and fertilizer exports are not under sanctions, the West's sanctions-related restrictions on Russia's banking, transit and insurance make its trade in agricultural products untenable. The West shouldn't force the less-developed countries, mostly those in Africa, to pay the price for its Ukrainian-proxied offensive against Russia. The United Nations is obliged to hold emergency meetings on the extension of the Black Sea Grain Initiative to make it reflect the appeals of the two conflicting sides in a more balanced manner. That is crucial to preventing the initiative that was originally made to minimize the Ukraine crisis' impacts on world food security from being exploited as a new part of the conflict. That's actually what the responsible countries should have done even before Moscow signaled its intention to withdraw from the initiative. It is a pity that none of the Western countries has shown any interest in doing that. These countries' studied silence over Moscow's complaint that their across-board sanctions have affected Russia's food exports is a telling sign that the sanction imposers are well aware that the "green channels" they opened for Russia's grain trade were only to forestall any flak that might come their way. They don't want to be held responsible for the food crisis because of their actions in instigating and prolonging the Ukraine conflict. Yet the greater the moral burden they try to put on Russia's shoulders, the more their own actions come under scrutiny. The agricultural and food companies of the West already dominate the world grain market and food industry. If the developed countries are allowed to go further to form a "grain NATO", they will effectively hollow out such world food bodies as the Food and Agriculture Organization of the UN and the UN World Food Programme. In doing that, they will gain control of the industries and technologies related to food as well as the policymaking and decision-making mechanisms related to world food security. The West's culpability for the global food shortage is both clear and callous.

ithin a month, Special Investment Facilitation Council (SIFC) has launched its fourth high value Flagship project, "Dust to Development," with the goal of garnering \$6.1 trillion in investment in the country's mining sector. Two friendly countries have already pledged investment of \$ 40 billion and \$ 22 billion, respectively, with an immediate commitment of \$ 10 billion ready to be inked. These investments are mostly in Balochistan; thus, the SIFC envisions the establishment of cutting-edge mining infrastructure, such as building new roads and railways to access mineral deposits and developing new mining technologies, as well as providing maximum employment to the local population by opening schools, hospitals, and providing quality urban infrastructure to Balochistan's cities and towns, in order to bring the hitherto neglected areas of Balochistan at par with the developed regions of the country.

The SIFC selected the mining, information technology, and agriculture industries as economic drivers solely on the basis of their merit. Pakistan has the world's second largest coal reserves, estimated at 185 billion tonnes. Pakistan has the fifth largest copper reserves in the world, estimated at 5.9 billion tonnes in Reko Dik only. It was also the right time to choose the mineral sector for seeking investment as the global demand for minerals and metals is growing, and they contribute significantly to the global economy. By 2022, the mining industry had generated approximately \$940 billion in revenue. In addition, the sector employs more than twenty million people globally. The mining industry is anticipated to grow in the coming years. This increase will be fueled by the rising demand for minerals and metals as well as technological advancements that will make mining more efficient. However, the high global demand for metals was not the only reason that Pakistan attracted \$ 62 billion in mining sector investment. A new mining and investment policy devised by SIFC and approved by the Cabinet was the main reason for attracting investment in the mining sector. Since this policy has the consent and agreement of prospective investors, the International Seminar on mining, which is being held on August 1, 2023, has attracted participants from over 30 countries, some of whom are represented at the ministerial level, some of whom are representatives of top mining companies, legal firms, and engineering firms who will spend their entire time in Pakistan developing and fine tuning the investment regime, loan structure, and financial closure mechanisms. The new mining policy, which was developed with input from all countries interested in the mining sector, has four main pillars: creation of a one-stop shop for mining investors to streamline the process of obtaining licences and permits and make it easier for investors to do business in Pakistan; introduction of a mineral exploration fund to provide financial support to companies exploring for new mineral deposits in Pakistan; and relaxation of foreign ownership restrictions. The implementation of these measures, which appears simple in theory but is challenging in practice, will make Pakistan a more attractive destination for foreign investment, increased mineral production, and exports, thereby boosting the economy of the country. In addition, investors will receive investment security, immunity from any litigation process, and assurance that there will be no policy change by any succeeding government, but in exchange, they will be required to mine the mineral, develop smelting plants in and around Gwadar, and develop downstream industries in Balochistan to transform the raw mineral obtained from smelting into value-added products for export. This will guarantee the development of the community, improve the socioeconomic outlook of the province, develop cities and urban centres, and transform Balochistan into an economic hub for Pakistan, its regional neighbours, and the rest of the world. SIFC has also introduced the slogan "From Red Tape to the Red Carpet." It implies that the entire bureaucracy, from top to bottom, will be reoriented from its master-servant relationship with its clients to providing doorstep services to their clients. In the new paradigm, all employees, departments, organisations, regulators, and ministries involved with or pertinent to the investment will receive the investors on their own, providing them with a single point of contact for all their documentation, registration, and licensing needs. According to the news system, as soon as the investor registers its interest with SIFC, the investor will no longer be responsible. SIFC will oversee the conclusion of legal, licencing, registration, and NOC requirements on its own, without the intor's involvement. He will also be provided with the utilities and basic materials necessary for the success of his investment, whereas the new law will provide the investor with all the security, permanence of policies, and future investment protection. SIFC also intends to consolidate all laws pertaining to foreign investment into a single law, which will provide much-needed respite and encourage investors to invest in Pakistan. Members of the SIFC are members by designation rather than by name, which implies that the SIFC will not be reconstituted after each change in government, but any new government member with the same designation will automatically become a member of the SIFC. Furthermore, because the SIFC has representation from the federal and provincial levels, as well as the Army chief, it is the ideal forum for resolving issues, developing consensus, and speeding up the decision-making process without delay or communication gaps. Once an agreement is reached within SIFC, the project will be referred to the Executive Committee, which will ensure that all requirements are met on behalf of the investors, and the ball will be passed to the Implementation Committee, which will ensure that the investment is applied on the ground without delay, utilities are provided within the timeline allocated, roads and transport needs are met, and the investor is not harassed. The new policy will also be applied to the Reko Diq project. The project will begin producing 400,000 metric tonnes of copper and 400,000 ounces of gold per year by 2025, which, when converted into monetary value as of July 31, 2023, the value of 400,000 metric tonnes of copper is \$3,7 billion and the value of 400,000 ounces of gold is \$718 million, for a total annual value of \$4.418 billion. This output will be doubled following the installation of all machinery and equipment, which is expected to be completed by 2028, implying that the facility will generate around \$8.828 billion per year. Taking into account the project's whole life span of 40 years, the total aggregate profit from this project will be \$ 353.12 billion. In an interview with a

prominent TV programme today (31st July), the project manager of Barrick Company made the following interesting remarks. Reko Diq is one of the world's largest and finest undeveloped copper-gold deposits, owned 50%by Barrick, 25% by three federal state-owned firms, 15% completely supported by the Province of Balochistan, and 10% free carried by the Province of Balochistan. The province's stake in the mine will be completely funded, which means that Balochistan will receive the earnings, royalties, and other benefits associated with its 25% stake without having to contribute financially to its development or management. The Reko Diq project was reconstituted in December 2022, which was a critical step towards developing Reko Diq into a world-class, long-life mine that would significantly expand Barrick's strategically significant copper portfolio and benefit its Pakistani stakeholders for generations to come.

The firm is currently reevaluating the feasibility study completed by the previous Tethyan Copper firm (TCC) because technology has evolved, necessitating a re-evaluation of the full feasibility study. Reko Diq, a truckand-shovel open pit operation with processing facilities generating a high-quality copper-gold concentrate, is expected to last at least 40 years. Construction is projected to be completed in two phases, with the first phase completed by 2024 and the first production scheduled or 2028, with a combined process capacity of 80 tonnes per annum. Meanwhile, the corporation is substantially investing in the community's socioeconomic outlook. To uplift and improve the living conditions of the communities in and around Reko Diq, it is constructing hospitals, schools, water, electricity and gas supply schemes, as well as schools and vocational training centres. It has already repaired the airfield and residential facilities to meet the project's transportation and accommodation needs, as well as identified aquifers for water supply. It is in the process of establishing a 150 megawatt fuel-powered power project and a 150 megawatt solar power project, and it is also looking for dead or live volcanoes in and around the area to generate power from thermal energy as one of the creative solutions to provide the enormous energy required to run and operate the entire facility at peak efficiency. Reko Diq will be a significant contributor to Pakistan's economy, with a transformative influence on the undeveloped Balochistan province, where, in addition to economic benefits, it will create jobs, stimulate regional economic growth, and invest in development programmes. These pledges, forecasts, and promises appear very promising and mouth watering, but as we all know, every government makes such promises shortly after coming into or leaving power, but those promises fade quickly after the government is embroiled in its own survival and all promises and priorities are pushed aside, swept under the rug, or taken over by the instinct of survival first. The policies of previous governments were never bad, nor were their intentions, but none of their promises could be translated into reality, despite the fact that we have abundant natural resources. We always fell short of achieving political stability, providing a strong legal framework, a favourable tax regime, reliable infrastructure, access to skilled labour, and a red carpet for investors. None of these conditions are out of reach; we simply need to choose national interest over personal interests. Let us hope that this time, national interests triumph over vested interests.

India's Supreme Court on Trial

fter nine years of Mr Narendra Modi's rule, the Supreme Court of India is timid, tentative, fragmented and vulnerable, wary of hurting the central executive which has grown mighty in strength. As an electoral facilitation service to the ruling RSS-BJP duo, the top court of India has decided to conduct "day-to-day" hearings on 23 petitions challenging the abrogation of Indian Illegally Occupied Jammu and Kashmir's (IIOJK) special status from August 2. The matter was last heard in March 2020 before going into limbo. After a four years' hiatus, the timing and the indecent haste of hearing is rather intriguing. Jammu and Kashmir is a disputed territory; it is one of the longest pending disputes on the United Nations' agenda. There are numerous UNSC resolutions acknowledging its disputed status; the latest such resolution came in June 1998. Parties to this dispute are: China, India, Pakistan, the people of the State of Jammu and Kashmir; and above all the UNSC, whose responsibility is to ensure that all UN resolutions are implemented by all members, both in letter and spirit. Packed by the judges of far right mind-set by the BJP-RSS nexus, the top court has chosen to hear the case when election bell are ringing in India. The judicial trajectory of India's Supreme Court is quite disappointing, especially when adjudicating matters where Muslims are a party. Verdicts on the desecration of Babri Masjid and building of Ram temple in its place, and death sentence of Afzal Guru are two contemporary cases where the Indian top court did 'mob' trials. Moreover, all those convicted by trial courts in high profile cases like Gujarat pogrom 2002, and burning of Godra train & Samjhota Express have been systematically absolved by India's superior judiciary. An emerging trend seen in the Indian Supreme Court during the Mr Modi's rule is the evasion of decision-making by delaying the hearing of high profile cases where judgement is likely to displease the Union government. For example, after the announcement of demonetisation in November 2016, several petitions were filed in SC challenging the decision. The petitions had raised substantial legal points such as whether the decision was unilaterally announced by the government without proper consultation with the Board of the Reserve Bank of India. The hearing remained pending for quite some time. Another disturbing concern stems from the revelations made by the Supreme Court judges regarding the Executive's interference in the matters of judiciary. Hints regarding this were dropped at the historic press conference held by four senior judges of the top court, on January 12, 2018. Justice Chelameswar, who did most of the talking at the presser, said that administration of justice was not in order and that "many things which are less than desirable have happened in the last three months". The judges handed over to the media a letter written by them to the then Chief Justice of India Dipak Misra, which, among other things, stated that "cases having far-reaching consequences for the nation and judiciary were selectively assigned to benches of preference without any rational basis". More clarity on this issue was provided by Justice Kurian Jospeh, who in a post-retirement interview to Times of India said that there was "outside influence" in judiciary. Condemning such practices Justice Chelameswar asserted that "bonhomie" between the judiciary and the government "sounds the death knell to democracy". Controversies emanating from the court make it look like a divided house and has resulted in the erosion of moral authority it once enjoyed among the public. The pre-2014 apex court was not hesitant in going against the Central Executive in matters involving high political stakes. But post-2014 Indian Supreme Court presents a meeker version when it comes to dealing with cases that could prick the political interests of the ruling party. India's 2014 elections had thrown up an interesting political mosaic. For the first time in the past 30 years, the electorate had returned a mandate with absolute majority.

Since then, India's Supreme Court has not been able to stand on its feet and assert its independence in the face of new found aggressiveness exhibited by the Union government having a far right mind-set. In 2019, the BJP had outstripped the special status of the IIOJK by repealing Articles 370 and 35A of the Indian constitution. This unilateral decision by India threw open the IIOJK territory for external meddling and demographic interventions. This move has opened flood-gates of people from all over India to acquire property and settle in the occupied state, impacting its populace balance and property rights of the locals. The constitution of India had guaranteed that no outsider would get a Kashmiri domicile, and would not own property in Kashmir. This constitutional guarantee was stampeded through a berserk act of parliament, which is illegal under all norms of law. Commenting on the hearing, a former chief minister of the IIOIK. Mehbooba Mufti, took to twitter to express her apprehensions about the top court's decision to take up the pleas after "remaining silent for four years". "There are legitimate apprehensions about why SC has taken up the Article 370 with such alacrity... After remaining silent for four years the decision to hear the case on a daily basis does evoke misgivings," she said. Headed by Chief Justice Chandrachud, the "honourable" judges will be in the spotlight of history as they go on to interpret a politically-motivated decision by a hardline government regarding annulment of Article 370 and 35A, which has literally stripped the Kashmiris off their identity bestowed by the constitution. Actually, this is not the trial of 23 constitutional petitions, rather, it is the Supreme Court of India which is on trial. This is where the top-line judiciary of India will always be quoted and rememered, this way or that way. Will the Indian top court do justice to Kashmiris? Let us hope against hope!

17 killed as crane collapses in Maharashtra

NEW DELHI: At least 17 workers were killed and three others injured Tuesday after a crane collapsed at a road construction site in the western Indian state of Maharashtra, officials said. The incident occurred near Shahapur in Thane district, about 71 km northeast of Mumbai, the capital city of Maharashtra, and India's National Disaster Response Force (NDRF) teams were rushed to the spot. YANGON: Myanmar reduced ousted civilian leader Aung San Suu Kyi's 33year prison sentence by six years in a partial pardon on Tuesday, as the junta struggles to quell bloody resistance to its rule.

Thousands urged to evacuate in southern **Japan** ahead of typhoon

TOKYO: A powerful typhoon sweeping towards southern Japan on Tuesday triggered the cancellation of hundreds of flights, with officials urging hundreds of thousands of peo-

ple to seek shelter. Typhoon Khanun was packing maximum sustained wind speeds of 180 kilometres (112 miles) an hour as it crossed the Pacific Ocean towards the Okinawa region. The Japan Meteorological Agency said the storm, which it described as "very strong", was about 170 kilometres southeast of the regional capital of Naha at 0600 GMT. The centre of the typhoon was expected to brush past Okinawa late Tuesday or early Wednesday before crossing to eastern China later in the week. Cities across Okinawa advised more than 760,000 people to leave their homes as the weather agency warned waves of up to 12-metres (39-feet) high could pummel the group of islands. The typhoon was expected to bring fierce winds and heavy rain.

"Many people stay at home because their houses are concrete," a disaster management official at the Okinawa regional government told AFP, speaking on condition of anonymity.

"But we are asking people who live alone or in wooden houses in low-lying areas to consider seeking shelter before the typhoon gets bad.' More than 500 flights were cancelled on Tuesday, while regional ferry and bus services were suspended ahead of the typhoon, national broadcaster NHK reported. Japan Airlines and All Nippon Airways said more than 74,000 passengers in total would be affected by flight cancellations on Tuesday and Wednesday.-APP

Core Inflation Rate in Pakistan increased by 18.5% in June 2023. Inflation rate rose to 38% in May and this was a record-breaking jump. Weekly inflation rate has reached all times high 38%. We don't have money to pay for imports stuck at ports. Floods of last year still having its effects on shaking economy, striving to getting back to some stability. We suffered \$30bn financial loss, with 3 crore people displaced

er and closer to default situation. Energy crisis is getting horrible. Lawlessness in country is making things even worse over all. Things might be new, but revising pages of history we never find such thing as a stable economic policy in this country. Absence of a sustainable economic policy is always been an unfortunate to this country. Among many reasons, one is of course the never completing tenure of any democratic government. Every proceeding government replaced the policies of previous one to prove them wrong. It seemed like their first priority to prove their rivals wrong in every capacity, at the cost of national damage. Then this 'new government' comes up with their 'new policies' from the lowest starting point again and the cycle continues. Since 1947, we have experienced a complete roller coaster of policies over policies, not getting us any long term good, for a long spam of time. We did not have a constitution for first 9 years of creation of Pakistan. Whatever the reasons were there, we were a nation with no future layout, not knowing anything what we were looking for. Our economy went through

different phases back and forth. In phase I 1947-77, we name it Era of experimentation, we saw, Ayub khan came up with Harvard Trickle Down Model, a capitalist model. This model was then replaced by Bhutto's socialist model that was built on idea of nationalization. Later, we enter second phase, Era of twisted economy, lasted from 1979-2000. Zia ul Haq followed the footsteps of his ideological father, Ayub, and again revived the capitalist mode of economy in country. This was the time period of Soviet war in the region. Pakistan was clearly a queen of chess in the game. Our economy was booming up on 'aids' from America. Benazir Bhutto became then prime minister of Pakistan, saving the pieces of democracy in country. The war has ended. The aid is cut. Now we were having nothing at hand to run a state by its own. We once again asked for help from IMF in the form of, of course, loan. The series of changing government between Benazir and Nawaz Sharif kept on going and so was the seeking of loans from IMF until 2000. Here, we entered a new era, Era of Problematic Economy, started from 2000 and we still getting through tough

times. A big change comes once again breaking repeating cycle of Bhutto and Sharif's loan seeking policy, in the form of another military general, Musharraf. In 2000, Gen. Pervaiz Musharraf introduced Model of Subsidized Scheme, in which Gen. gave loans to educated youth for small level domestic business or entrepreneurship. This never-ending search for a stable and strong policy needs many serious initiations towards a strong Pakistan. This is 23rd time since 1947 we have begged before IMF for loans and aids. IMF, WB or whatever the monetary body, they give us loan just for their own benefits. We need to understand the fact that a state can never be run on loan money for a longer period. Core issues of Pakistan's economy mainly include policy framework, inconsistent policy doctrines, agricultural problems, industrial issues, fiscal policy problem, taxation problems, monetary policy problems, neoliberal structural programs, Pakistan development paradox, poverty and inequality issues, issues of class policies, bureaucracy issues, bad governance structure, and many others. One major issue today seems to me

is wrong investment in agriculture department and ignoring the space of development in industrial sector. Pakistan invests 45% of its population input in agriculture every year and it yields only 19% output in GDP. On the other hand, 19% our population is involved in industry and it yields almost 30% output in GDP. It clearly depicts our wrong directions of economic investments towards progress. Moreover, Lack of mechanization, water issues, commercialization of agricultural land, lack of agricultural education, no facilities for farmers are also factors deteriorating agricultural sector. Pakistan Textile Industry, for example, is one of the largest industries of the country and is badly ignored since years. Another reason of worse economy is malfunctioning of our state-owned enterprises. These are the companies that are directly owned by state and they make incentives for state. PIA, WAPDA, PTCL, steel mills, are major among them. According to stats, our state-owned enterprises are losing in millions on daily basis. PIA- has lost 600bn rupees, and steel mills lost 500bn rupees in last 3 years. Steel mill loses 5m rupees per hour, when

working. Pak-railways lose 50bn rupees per year. PTCL, WAPDA, PTV, xyz also follows the trend as well. Reason behind may be lack of technical and professional operating hands in industrial sector. Technical and professional supervisors are being replaced by politicians, bureaucrats, or retired military officers who have no background knowledge of subject, causing heavy loss in industries. Brain drain is also the reason we have no competent expertise left behind in country to boost the economy. There is a long series of problems one can enlist, but every problem comes with a solution. FBR decentralization, knowledge economy, strong local government, better tax collection mechanism, digitalization, economic driven policy, tourism, services lead economy, strong IT sector, CPEC execution, Hi-Tech manufacturing, education are still the options helpful for survival of economy of Pakistan. It is never too late to mend the ways. We all hope we play our part in better future.

He said during the floods last year and afterward, in the post-flood scenario, the international community came to support Pakistan in the relief and rehabilitation efforts. The UN General Assembly members focused on Pakistan during the relief efforts and subsequently, they successfully arranged the Climate Resilient Pakistan summit in Geneva receiving 'a substantive and qualitative response'.

Foreign Minister Bilawal, to a media query, reiterated that Pakistan was not keen to join the 'blocs policy' and would take decisions in the larger national interests. Pakistan had stressed upon resolution

Political crisis distracts from urgent climate challenge

ISLAMABAD: The ongoing political turmoil in Pakistan is distracting its government and the public from the critical challenge of climate adaptation. One of the key challenges being neglected is the aftermath of last year's August floods, which displaced nearly eight million people in Pakistan.

The Internal Displacement Monitoring Centre named the floods the world's largest disaster displacement event in 10 years. But ever since April 2022, when the former Pakistani prime minister Imran Khan lost a no-confidence motion, the country has seen violent face-offs and heavy-handed state action. The shift in attention has been most evident in how official periodic updates on the state of flood-affected people stopped in November 2022, resulting in a lack of transparency regarding rehabilitation efforts.

Zubair Tiwana appointed as new FBR chief

ISLAMABAD: Malik Amjad Zubair Tiwana, a grade-21 officer of the Inland Revenue Service (IRS), has been appointed as the new chairman of the Federal Board of Revenue (FBR), sources told media on Tuesday.

According to a summary forwarded in this regard, three candidates' names were proposed for the coveted position: Rashid Mahmood Langrial, an officer of the Pakistan Administrative Service group; Amjad Zubair Tiwana, presently serving as FBR member IRS Operations; and Syed Nadeem Rizvi, member administration and most senior among the contenders.

However, Prime Minister Shehbaz Sharif approved the appointment of Tiwana as the new head of the tax collection body. Asim Ahmed, who was appointed as the tax body's chief by the Shehbaz-led government on April 27 last year, completed his tenure and retired after reaching the age of superannuation on July 30.

Drone hits tower housing Russian ministries

MOSCOW: A high-rise building in Moscow's business district that houses three Russian government ministries was struck by a drone for the second time in three days on Tuesday, in what Russia called an attempted Ukrainian "terrorist attack". A Ukrainian presidential adviser said Moscow should expect more drone attacks and "more war". The building that was hit is known as the "IQ quarter", which houses the ministry of economic development, the digital ministry and the ministry of industry and trade. Video obtained by Reuters showed a section of its glass facade, high above the ground, had been destroyed by the impact.

"At the moment, experts are assessing the damage and the state of the infrastructure for the safety of people in the building. This will take some time," Darya Levchenko, an adviser to the economy minister, said on Telegram. She said staff were working by video-conference. Moscow has come under repeated drone attacks since early May, when two drones were fired at the roof of a building in the Kremlin complex. While the incidents have not caused casualties or major damage, they have provoked widespread unease and sit awkwardly with the Kremlin's narrative that Russia's "special military operation" in Ukraine is proceeding according to plan.

"Indeed, a threat exists, it is obvious, but measures are being taken," Kremlin spokesman Dmitry Peskov told reporters, declining to comment further. Ukraine has drawn satisfaction from the attacks, though without directly claiming responsibility for them. "Moscow is rapidly get-ting used to a full-fledged war," Ukrainian presidential adviser Mykhailo Podolyak wrote on X, the social media platform previously known as Twitter. - Agencies


