# Bisham attack aimed to harm Pak-China ties

PM said the government would ensure that the perpetrators and culprits of March 26 incident should get the exemplary punishment

DASU: Prime Minister Muhammad Shehbaz Sharif on Monday assured foolproof security measures for the Chinese nationals working on Dasu Hydropower Project as well as across the country and resolved to ensure exemplary punishment for the perpetrators of March 26 incident. Addressing a gathering of the Chinese engineers and workers, he said the government would ensure that the perpetrators and culprits of March 26 incident should get the exemplary punishment, so that it would be a lesson and that no one could commit such dastardly act in future. The prime minister said that the sole purpose of his visit was to offer deep and sincere condolences and express feelings to the Chinese brothers and sisters in Dasu over a sad incident that took place on March 26 in which five Chinese and one local lost their lives. He said it was a cowardly act on part of the terrorists to kill innocent Chinese and a Pakistani for no other reason except to disturb and damage exceptional friendship between Pakistan and China.

## CTD 'arrests' over 10 terrorists, facilitators

Confirms TTP's hand behind Besham terror attack

**PESHAWAR: The Counter Terror**ism Department (CTD) has "arrested" more than 10 terrorists, facilitators involved in the attack on Chinese engineers in Shangla's Bisham city last week, sources told Geo News on Monday. As per the sources, a Tehreek-e-Taliban Pakistan (TTP)-affiliated outfits are believed to be involved in the March 26 deadly attack. During the attack, five Chinese citizens, including a woman, and a Pakistani driver were killed when their vehicle was attacked in Shangla's Besham city as a suicide bomber crashed his exploves-laden vehicle into the car carrying the victims. Following the incident, the country's civil

and military leadership notably Prime Minister Shehbaz Sharif, President Asif Ali Zardari and Chief of Army Staff (COAS) General Asim Munir condemned the attack vowing that the perpetrators responsible for the heinous attack would be brought to justice. Meanwhile, a wreath-laying ceremony was held at Rawalpindi's Nur Khan Airbase and a 30-second silence was observed as bodies of the deceased Chinese nationals were airlifted back to China. Floral wreaths were laid on behalf of the president, prime minister, army chief, Air Chief Marshal Zaheer Ahmad Babar Sidhu and Chairman Joint Chiefs of Staff Committee (CJCSC)

# **Israel hits consular section** of Iranian embassy in Syria

A commander of the Quds Force of Iran's Islamic Revolution Guards Corps (IRGC) in Syria and Lebanon has been martyred in an Israeli attack on the Consular Section of the Iranian Embassy

DAMASCUS: The Consular Section of the Iranian Embassy in the Syrian capital of Damascus has come under a missile attack, with immediate reports of casualties as a result of the act of aggression. Syria's official news agency, SANA, said the strikes were carried out by "the Israeli enemy" and targeted the Mezzeh neighborhood in Damascus on Monday afternoon. "At approximately 00:17 p.m. , the Israeli enemy launched an air aggression from the direction of the occupied Syrian Golan, targeting the Iranian consulate building in Damascus," SANA said, citing a military source as saying. "Our air defense media responded to the aggression's missiles and shot down some of them. The aggression led to the destruction of the entire building and the martyrdom and injury of everyone inside, and work is underway to recover the bodies." SANA, citing one of its correspondents, said the Israeli aggression also caused major destruction to "neighboring buildings." A commander of the Quds Force of Iran's Islamic Revolution Guards

ISLAMABAD: The Supreme Court on Monday took suo motu notice of the Islamabad High Court (IHC) judges' letter alleging interference by intelligence agencies in judicial matters despite the government forming a commission to probe the matter. A seven-member bench led by Chief Justice of Pakistan Qazi Faez Isa will hold the maiden hearing on the issue on Wednesday. Apart from the CJP the bench also comprises Justice Syed Mansoor Ali Shah, Justice Yahya Afridi, Justice Athar Minallah, Justice Mussarat Hilali, Justice Jamal Khan Mandokhail and Justice Naeem Akhtar Afghan. The explosive letter which surfaced last week triggered a crisis and the Supreme Court led by CJP Isa has been under pressure to hear the matter under Article 184(3) of the Constitution.



# Online mobilisers to push vaccination

#### Move aimed at countering misinformation regarding polio

LAHORE: The Punjab Operation Emergency Centre is set to launch an online campaign to help eradicate poliovirus from the province. The campaign will be launched in Lahore and other districts under an online global strategy in the coming weeks. The emergency operation centre has decided to take help of online social mobilisers to spread awareness about polio vaccination and the disease. According to sources, the Punjab Emergency Operation Centre will solicit the services of top social mobilisers to dispel misinformation about the vaccination, disease and health issues. The decision had been taken because misinformation and propaganda about the vaccination and disease on social media were confusing the public. Although Punjab has been polio-free for the past three years, the threat of polio per-

sists. Especially the detection of wild poliovirus last year in environmental samples from Gulshan-e-Ravi in Lahore left the Punjab government, health department and related officials concerned. After the development, several major anti-polio campaigns were launched, but it has been evident that still area instances of denial in some areas amidst misinformation regarding polio vaccination, especially on social media. In view of the situation, the departments concerned are focusing on strategies to counter the misinformation. For the first time, the focus will also be on online awareness to eradicate polio. In this regard, an event was organised in Lahore under the UInfluencers umbrella. The initiative, supported by a network of social media influencers, aimed to tackle health-related misinformation, particularly that concerning polio vaccination. According to a

statement, with a turnout of over 10,000 volunteers from the country, UInfluencers emerged as a powerful advocate to promote children's health and immunisation across digital platforms. The event marked a milestone as it transitioned from the digital realm to a physical gathering, bringing together 36 online volunteers from the outskirts of Lahore. The young individuals, representing a cross-section of society, immersed themselves in the realities of polio vaccination through hands-on experiences and informative presentations. The online social mobilisers also visited the Lahore Railway Station for a firsthand look at the dedicated efforts of health workers vaccinating the children. They learned about the scale of the campaign, with approximately 20,000 children vaccinated each day during the

## Ophthalmologist emphasizes preventive measures against eye allergies

He advised the eye patients to use eye drops provisionally to treat severe chronic ocular allergies while prolonged use of these drops can lead to negative effects

RAWALPINDI: Leading ophthalmologist at Al-Shifa Trust, Dr. Tayyab Afghani on Monday said that pollen allergy effects could be avoided through preventive measures. Talking to media, he said that the springtime brings an extremely high pollen count, which can cause burning and redness in the eyes, adding eye allergies can cause watery and puffy eyes, but the same therapies and self-care practices that relieve the symptoms of slurred allergies also work for eye allergies. In addition to sneezing and a stuffy runny nose, the symptoms can include red eyes, irritation, itching, tearing or runny eyes, swollen eyelids, soreness, burning, or pain, he added. Dr. Tayyab said that optical allergies result from the body overreacting to an allergen like any other allergy. "The immune system produces antibodies that release histamine and other chemicals from the eyes, causing red, watery eyes and irritation," he added. Typically, seasonal allergies occur in early spring during the summer, he said and added that allergens in the atmosphere such as spores from mold and pollen from grasses, trees, and weeds, were known as triggers. He claimed that aside from causing momentary blurriness, ocular allergies, commonly known as allergic conjunctivitis or eye allergies do not significantly endanger vision. In many cases, symptoms appear as soon as the allergen comes into contact with the eyes. Dr. Tayyab Afghani said the first step was to avoid triggers by staying inside during high pollen count periods which were often mid-morning and early evening. In order to protect their eyes from pollen people should drive with closed windows and wear sunglasses or eyeglasses, he suggested. # IGP instructed to speed up crackdown on kite flying

Special teams ensure action against law breakers across the province under zero tolerance, IG Punjab Dr. Usman Anwar



LAHORE: Inspector General Police Punjab Dr. Usman Anwar issued orders to intensify the crackdown against kite flying..IG Punjab Dr. Usman Anwar said that special teams should ensure action against law breakers across the province, IG Punjab said that there is zero tolerance against the accused involved in the manufacture, sale and use of metal strings and kites. Spokesman Punjab Police said that during the last 24 hours, 41 suspects were arrested while registering 32 cases under the Kite Flying Act across the province. 957 kites and 23 strings were recovered from the possession of the accused. The spokesperson

of Punjab Police further said that during the last 34 days, 3603 suspects were arrested under the Act of Anti-Kite Flying across the province, including Lahore, while 3469 cases were registered. 217461 kites and 14693 strings were recovered from the possession of the accused. IG Punjab Dr. Usman Anwar appealed to the parents to stop their children from flying kites. Dr. Usman Anwar directed that the supervisory officers should personally monitor the crackdown against metal strings and kites. Earlier on, Inspector General Police Punjab Dr. Usman Anwar has directed to intensify tge crackdown against electricity thieves. IG Punjab said that FIRs of electricity theft should be registered immediately in all districts of the province, arrest of the accused and timely execution of challans should be ensured. IG Punjab said that Punjab Police's performance against electricity thieves is clearly better than other provinces. Punjab Police registered 83 thousand 645 cases against electricity thieves during 06 months. Dr. Usman Anwar said that the security of the Chinese residents has been tightened as well as the traffic routes have been secured. IG Punjab Dr. Usman Anwar directed to increase checking at inter-provincial police check posts to prevent terrorism and smuggling. He issued these instructions today while presiding over a video link meeting at the Central Police Office anf talking to the officers. In the meeting, tasks given by chief minister

Punjab, such as crime control, kacha area operation, and implementation of other tasks were reviewed. IG Punjab also reviewed the ongoing measures to prevent kite flying, drug selling, motorcycle theft, crimes related to women and children. IG Puniab issued orders to speed up measures to improve traffic flow on the highways. IG Punjab said that zero tolerance should be adopted against aerial firing, display of weapons, vehicles with dark glasses. In the meeting, the security arrangements on the martyrdom day of Hazrat Ali (RA) were also reviewed. CCPO Lahore Bilal Siddique Kamyana, DIG Operations Lahore, DIG Special Branch Faisal Ali Raja, DIG Investigation Azhar Akram, DIG CTD Usman

Dr. Tayyab Afghani said that ocular allergies result from the body overreacting to an allergen, just like any other allergy. The immune system produces antibodies that release histamine and other chemicals from the eyes, causing red, watery eyes and irritation. Typical-

ly, seasonal allergies occur in early spring, during the summer, and into the fall. He informed that allergens in the atmosphere, such as spores from mold and pollen from grasses, trees, and weeds, are known as triggers. He claimed that aside from causing momentary blurriness, ocular allergies, commonly known as allergic conjunctivitis or eye allergies, do not significantly endanger vision. In many cases, symptoms appear as soon as the allergen comes into contact with the eyes.

According to Dr. Tayyab Afghani, the first step is to try to avoid triggers by staying inside during high pollen count periods, which are often mid-morning and early evening. In order to protect their eyes from pollen, people should drive with their windows closed and wear large sunglasses or eyeglasses. He said people frequently use eye drops to treat severe, chronic ocular allergies. However, prolonged use of these drops can lead to negative effects;


## **Tarbela** power house generation to touch 6418 MW in 2025

#### Chicken, eggs prices reach at Rs 445 per kg, Rs 290 per dozen ISLAMABAD: The price

of poultry chicken during the second half of the holy months of Ramazan reached at Rs 445 per kg and the price of poultry eggs reached Rs 290 per dozen in the open market in the twin cities of Islamabad and Rawalpindi. The meat of the poultry chicken has reached Rs 650 to 660 per kg in the open market, according to the survey conducted by APP here on Monday. The price of poultry chickens and eggs has been going above Rs 445 to 290 per kg and dozen for the last months, which is getting away from the purchasing power of consumers day by day. The prices of poultry items have increased by 30 percent in the twin cities during the last month after Ramazan began, which has created huge volatility in the market. According to the market survey, during the last two months in the twin cities, a 28% increase was witnessed in the price of poultry chicken, while as same a 30 percent increase in the price of poultry eggs in the same period. Meanwhile, talking to APP, the former Chairman of the Pakistan Poultry Association (PPA), Dr Sajjad Arshad said that the increase in the current prices of poultry was due to demand and supply factors during Ramazan.

He said that the increase in poultry business inputs and cost of doing business was seen across the country due to which the market was in crisis. Sajjad said that the country's economic conditions are also an important issue and the poultry feed ingredients imported from foreign countries are expensive, in which sovbean is important. He said that many soybean ships have stopped at Karachi port, which has an inevitable impact on poultry

The objective is to determine the percentage of complaints initially marked as resolved but later deemed invalid, thereby enhancing accountability and transparency within the sector. The Minister emphasized the importance of making this data accessible to the general public, In efforts to expedite complaint resolution, Minister Leghari directed a thorough reevaluation of complaint redressal timeframes. He also reiterated the importance of strict adherence to load shedding guidelines.-APP

#### **ANF accelerates** Teachers call for end operation against drug to centralized exams This proposal aims to relieve teachers of the

financial burden associated with centralized exams and ensure a more sustainable and equitable system for teachers and institutions.

ISLAMABAD: Teachers engaged in conducting centralized primary and middle standard exams under the Federal Directorate of Education (FDE) have come forward with grievances regarding unpaid remuneration and burdensome expenses incurred during exam duties for the last three years. Frustrated by unmet promises and financial strain, these teachers advocated for a shift towards local exams to alleviate their plight. Despite assurances from FDE authorities, teachers allege that for the past three years, they have not received their rightful remuneration for conducting exams and assessing papers. Speaking on condition of anonymity, several female teachers while talking to APP lamented the dire situation, highlighting the financial hardships they endure to fulfill their duties. One of the teachers revealed, "FDE conducts centralized exams and teachers have to bear the exams expenses from their own pocket which is ridiculous. The expenses include transportation costs to exam centers, purchasing materials for sealing answer scripts, and covering transport expenses to deliver materials to FDE." Another teacher recounted, "I hired a taxi, collected the exam material from FDE and deposited answer scripts on daily basis during the exams but FDE never provided transport facility or paid transportation cost. I paid from my personal pocket. The absence

during exam duties has left me feeling undervalued and disrespected. Promises made by FDE officials regarding payment for exam duties remain unfulfilled." "For three consecutive years, the FDE has failed to reimburse teachers for their diligent efforts in administering exams and assessing papers. While appointing teachers for examination duty, teachers are assured for payment but unfortunately, the promise of FDE officers never fulfilled, shared another teacher. The situation is compounded by the lack of support from FDE in providing necessary materials and facilities for conducting exams. Teachers report purchasing materials such as cloths, sealing wax, and packing material with their own money, without any reimbursement from FDE. Additionally, the absence of paper collection facilities further adds to the logistical challenges faced by the teachers. Despite assurances of payment, teachers lament the recurring excuse of the Accountant General Pakistan Revenue (AGPR) withholding funds, leaving them to shoulder the expenses personally. In light of these grievances, teachers have proposed the abolition of the centralized exam system in favor of local exams conducted within respective schools. This proposal aims to relieve teachers of the financial burden associated with centralized exams and ensure a more sustainable and equitable system for teachers and institutions.

## Haitian crisis and its causes

NCE upon a time, sailors and travelers considered Haiti the pearl of the Caribbean. But now this territory is beset by a wide range of problems, including an economic crisis, a surge in crime, internal civil conflict, and rising poverty levels. Prospects are vague: few people can currently accurately predict how events will develop. Against the backdrop of ongoing armed clashes in Port-au-Prince, which are still ongoing, this article delves into the root causes of the turmoil. Formally, the current crisis in Haiti began in 2018, when unrest broke out due to fuel shortages. However, this interpretation is too simplistic. In reality, the Haitian crisis has persisted for several decades, with its roots tracing back to the American occupation that began in 1915. In fact, the events a hundred years ago caused irreparable damage to Haitian statehood. For 19 years, US troops illegally controlled the territory and resources of the Caribbean republic. And even after Haiti managed to regain its independence, American influence did not dissipate. It continued and was aimed at economic exploitation. This was 20th-century colonialism. However, now they rarely remember this. Describing current events in Haiti, the Western press does not talk about their background. Not a word about the forced labor of Haitian citizens, which American sugar companies used in the 20s of the last century on the island's plantations. Not a word about how, during the occupation, Haiti's financial structures were dominated by US banks. Not a word about how the American military regime in Haiti from 1915 to 1934 violated the rights of the Haitian population and harmed the culture and traditions of the occupied country.

But those events explain a lot. In 1915, American Marines invaded Haiti, under the pretext of "protecting American interests"; especially economic interests (American sugar companies were afraid of losing control over Haitian plantations). Now, in 2024, the US Army Command and the State Department have not publicly ruled out sending troops to Haiti. What has changed in 109 years? It turns out... almost nothing. America still considers the Caribbean its backyard and interferes in the internal affairs of the regional countries. The American occupation of Haiti was so brutal that since 1915, a guerrilla war for liberation from US troops had been ongoing on the island. In 1919, Haitian guerrilla leader Charlemagne Péralte died at the hands of the American soldiers. But his name forever became a symbol of heroism in Haiti. As in those days, so do many Haitians now stand for the sovereignty and independence of their homeland against colonial dependence on the United States, because they understand well that the plight of their state is the consequence of Western colonialism. From all of the above, three conclusions can be drawn: The severe consequences of the American occupation of Haiti in 1915-1934 still have a dire impact on the internal life of the republic. The economic interference of Western companies in the affairs of Haiti has persisted from then until the present.

### Polarization in the US

ROWING political polarization within the US is increasingly serving as a potent catalyst propelling the burgeoning "prepper" movement forward, reflecting a broader societal disquietude regarding the nation's political and economic trajectory. Spanning the entire ideological spectrum, Americans are grappling with mounting apprehension surrounding the state of the economy and the increasingly fractured political landscape. This pervasive sense of uncertainty has engendered a marked uptick in individuals harboring profound distrust toward both governmental institutions and societal frameworks, prompting them to adopt a proactive stance toward self-sufficiency and preparedness. Recent data cited by Reuters, drawing from comprehensive research on the subject, indicates a staggering doubling in the number of "preppers" in the US since 2017, with an estimated 20 million individuals now identifying as adherents of this movement. What was formerly primarily associated with far-right ideologies has now permeated mainstream America, with individuals hailing from diverse political backgrounds embracing practices such as firearm ownership, stockpiling essential supplies and fortifying their residences against potential crises. While prior analyses predominantly focused on the ramifications of events such as the COVID-19 pandemic and its attendant disruptions, along with incidents like the Texas power grid failure, attention is increasingly being redirected toward the broader backdrop of political polarization within the country.

The occurrences of recent years, including the surge of civil unrest sparked by movements such as Black Lives Matter, have laid bare the deep-seated fault lines running through American society. This polarization transcends mere ideological and policy disagreements, encompassing fundamental questions regarding the role of government, the essence of democracy and the legitimacy of societal institutions. Set against this backdrop, episodes such as the storming of the Capitol in 2021 serve as stark reminders of the fragility of democratic norms and the potential for political instability to escalate into full-blown crises. Such events coupled with ongoing partisan skirmishes and heightened rhetoric across the political spectrum have contributed to a pervasive sense of uncertainty and insecurity among the populace. In addition to political tumult, concerns regarding environmental degradation and climate change are also assuming an increasingly prominent role in shaping the trajectory of the "prepper" movement. The escalating frequency and intensity of extreme weather events, juxtaposed with the gradual but inexorable march of climate change, have underscored the imperative for individuals to prepare for a future characterized by environmental instability and ecological disruption. The trajectory of the "prepper" movement reflects a broader shift toward individual empowerment and autonomy in the face of perceived threats. From concerns about government overreach to fears of environmental catastrophe, this movement represents a diverse array of motivations united by a shared desire to mitigate risk and safeguard their families and communities. Moreover, the evolution of the "prepper" movement from a fringe subculture to a mainstream phenomenon underscores the depth of societal disquietude and the widespread desire for proactive solutions to pressing challenges.

# "Beyond interference: Redefining the scope of judicial protection"

HIEF Justice Qazi Faez Esa, nearing the end of his tenure, chose not to address the complaint filed by six serving judges through the Supreme Judicial Council or by convening a full court of the Supreme Court. Instead, he passed it onto the civilian government, which many perceive as being under the complete influence of the powerful establishment. This decision has been viewed as a missed opportunity to restore judicial independence from the alleged overwhelming control exerted by the establishment, which is often equated with the state itself. This control extends to all facets of governance, including the parliament, governments, cabinets, electoral processes, judicial proceedings, and foreign policy decisions, as well as the management of trade, business, investment, agriculture, and livestock.

The Chief Justice's decision to avoid addressing the complaint prompted over 300 members of the legal fraternity to stage a protest before the Supreme Court today (31.03.2024), urging the Court to take responsibility for adjudicating the matter under Article 184(3) of the Constitution. They argued that any government-led commission would lack the necessary independence and authority to properly investigate the claims. Analysts, jurists, and lawyers have widely criticized the appointment of Tassaduq Hussain Jillani, who served as the 21st Chief Justice of Pakistan from 2013 to 2014, to head the one-man commission tasked with adjudicating the complaint of six judges. Many have deemed this appointment highly inadequate, inappropriate, and out of context, given Jillani's agebarely two years younger than Pakistan itself. They argue that since the complaint directly implicates the executive branch as the culprit, appointing a commission headed by someone associated with the executive undermines the integrity of the process. It's seen as illogical and unfitting for the accused to be tasked with providing justice to the complainants.

Meanwhile, the PTI, emerging as one of the largest stakeholders, has been particularly affected by judicial decisions allegedly manipulated by the establishment. These decisions have targeted the incarceration of PTI's former chairman and top-tier leadership, resulting in significant upheaval within the party. PTI has not only lost its founding chairman, top and second-tier leadership, but also its iconic symbol and brand name. Currently, it has been absorbed into an irrelevant and sectarian party, Sunni Itehad, thereby alienating sympathizers from other sects. The heavy toll this has taken on PTI appears irreversible at this juncture. The terms of reference assigned to the commission are notable for their focus on investigating direct involvement of officials in judicial interference

and recommending appropriate action against implicated agencies, departments, or state institutions based on evidence uncovered. However, the absence of mention regarding indirect involvement suggests a potential gap in the scope of the inquiry. Additionally, the commission's starting assumption that no interference has occurred places the burden of proof on the six judges, who must substantiate their claims comprehensively with evidence, witnesses, and circumstantial evidence. Failure to do so could lead to the judges facing accusations of lodging false or concocted complaints, adding a significant layer of complexity to the proceedings. Moreover, granting the commission the authority to explore additional matters deemed totally inappropriate.

Rejecting the Terms of Reference (TORs), analysts and jurists argue the letter written by the six judges transcends mere complaints or allegations. Instead, it resembles a decision by a six-member high court bench. After conducting investigations, gathering facts, and recording witness testimonies, the bench unequivocally declared the unlawful elements within the country's prime spying agency and the establishment guilty of blatant and brute interference in judicial matters.

The bench highlighted that the unlawful elements within the establishment use coercive tactics, including intimidation, blackmail, and eavesdropping, to influence bench formations and court decisions aligning with their political and administrative agendas. Furthermore, by openly defying or frustrating court orders that contradict their objectives, the unlawful elements within the establishment undermines the judiciary's independence. The bench sought guidance from the Supreme Judicial Council on defensive measures to safeguard against such unlawful interference and ensure the judiciary's autonomy to dispense justice impartially and transparently.

Analysts and jurists criticize the use of the phrase "interference of the executive". They argue that the type of interference faced by the judiciary transcends constitutional boundaries and legal frameworks. Rather than being categorized as executive interference, it should be characterized as unlawful coercion perpetrated by rogue elements within state institutions. These elements employ illicit means to manipulate and intimidate the judiciary, undermining its independence and impartiality therefore cannot be legally termed as executive. As such, they should not be regarded as lawful actors but as unlawful elements seeking to subvert the rule of law through coercion and intimidation tactics. Henceforth, the Terms of Reference (TORs) for the Commission should reflect a proactive approach, beginning with the acknowledgment that unlawful interference with the judiciary has already been substantiated. The Commission should then focus on recommending measures to safeguard the judiciary from undue, unlawful, and blatant interference perpetrated by rogue elements within state security institutions.

Secondly, the Commission should provide practical and actionable recommendations regarding how the lower and higher judiciary can respond effectively to such unlawful interference. These recommendations should empower the judiciary to maintain its independence and integrity in the face of external pressures. Thirdly, the Commission must address the challenge of fixing responsibility on unlawful elements within the state security apparatus, even in the absence of concrete evidence and witnesses. Given the sophisticated techniques employed by these elements to conceal their activities, the Commission should explore innovative strategies for holding them accountable. Fourthly, the Commission should propose the enactment of new legislation and regulations aimed at establishing dedicated security forces tasked with protecting the lower and higher judiciary from unlawful interference, whether originating from within state institutions or external nonstate actors. Lastly, the Commission should recommend mechanisms to ensure the implementation of court decisions and prevent their violation or frustration through selective administrative, legal, or illegal means. These measures should reinforce the rule of law and uphold the authority of judicial decisions in the face of external pressures. The proposed Terms of Reference (TORs) present a comprehensive and proactive approach to addressing the issue of unlawful interference with the judiciary. They prioritize acknowledging the existing problem and recommending concrete measures to safeguard judicial independence and integrity. By focusing on empowering the judiciary to respond effectively, holding accountable those responsible for interference, and proposing legislative reforms, the proposed TORs offer a robust framework for addressing the challenges at hand.

NEW group of leaders in Iran is coming up NEW group of leaders in Iran is coming up and they are stricterin their beliefs than those who have been in charge for the past 45 years. This change is happening because the government wants to stay in control, especially since many people in the country are losing faith in the system that has been run by religious leaders for a long time. In the 2024 elections, there is a big internal power struggle happening as the country prepares for a new top leader. The elections on March 1 had the lowest voter turnout since the government was established in 1979. Only about 40% of eligible voters participated and some reports say it might be even lower. Key figures, like the speaker of the outgoing parliament, Mohammad Bagher Ghalibaf, did not do well in the elections. In Tehran, the capital, only 25% of people voted. In the Assembly of Experts, which is a group that helps choose the top leader, Sadegh Larijani lost his position. Even former President Hassan Rouhani could not run for the Assembly of Experts. This manipulation of the elections has been going on since 2004, when the Guardian Council, a group that approves candidates, disqualified many reformists. Instead of solving political issues, this move made things worse over the next 20 years, leading to conflicts between different conservative groups. The struggle between more practical thinkers and strict ideologues continued during the presidencies of Mahmoud Ahmadinejad and Hassan Rouhani, who both served two terms from 2005 to 2021.

Supreme Leader Ayatollah Ali Khamenei has been mediating between different groups trying to gain power and influence for a long time. In Before the 2021 presidential elections in Iran, the the past 20 years, this process, usually done in private, increasingly needed his direct involvement and became more public. This was most noticeable during the Ahmedinejad era (2005-13) when the then-president not only clashed with fellow conservatives but also opposed Khamenei in his second term. This made divisions among conservatives more pronounced, especially when the U.S. imposed more sanctions. To address this, Khamenei allowed the return of pragmatic conservative forces. In the 2013 elections, Rouhani, a pragmatic conservative, won decisively. This move helped Khamenei in two ways. First, it restored public support for the regime, which had suffered from the controversial 2009 elections and the subsequent uprising. Second, it created room for Tehran to negotiate a nuclear agreement with the U.S. amid severe sanctions.

Despite serious financial difficulties and the need for domestic stability, talks with the U.S. caused divisions in the Iranian political establishment. Rouhani's pragmatic approach clashed with the more ideologically driven clerics and the IRGC. The 2015 nuclear deal was a win for the pragmatists, but it didn't last. The Trump administration's 2018 decision to withdraw from the deal and reinstate sanctions undermined Iran's pragmatic conservatives. In response, Iran retaliated, leading to the U.S. killing Qassem Soleimani in early 2020, further strengthening the ideologues and weakening the pragmatic conservatives, who had already lost ground during Rouhani's second term (2017-21).

This move also weakened the power of others, like Ali Larijani, who was disqualified despite attempts to reverse the decision. Over the years, Supreme Leader Khamenei's influence declined and the IRGC-led security establishment gained strength. Raisi's presidency marked a shift to a more conservative government.

To solidify control, especially after protests due to economic hardships, Raisi's administration enforced stricter public restrictions, especially for women's dress codes. This led to the death of Mahsa Amini in 2022, triggering widespread protests that lasted almost a year. The government faced criticism from within, with senior figures expressing concerns about the regime's stability. Khamenei had to defend the government's actions and there were promises to revise laws related to women's dress codes, although no concrete actions followed. The protests eventually subsided in mid-2023. Amidst public discontent, economic challenges, and internal power struggles, the upcoming elections were crucial. Ideologues aimed to secure a majority in the parliament and the Assembly of Experts, which plays a role in choosing the next supreme leader. While ideologues controlled the Guardian Council, runoffs for parliamentary seats were expected and the Assembly's composition remained uncertain. With widespread dissatisfaction, economic issues and power struggles among elites, the future of the Iranian regime might hinge on the armed forces which are not immune to public sentiments.

#### **Greece hikes** Golden visa price amid housing **crisis**

ATHENS: Greece tight ened the rules on its popular "Golden Visa" program increasing the required investment threshold to as much as 800,000 euros (\$864,000) in a bid to help ease a housing crisis. The successful program that has attracted thousands of Chinese launched in 2014 granting foreigners a renewable, five-year residence permit in return for a 250,000-euro property investment. The finance ministry announced that from Sunday, the threshold would climb to 800,000 euros in attractive regions. such as Attica, around Thessaloniki, Athens, Mykonos, Santorini and the islands with a population of over 3.100. In other areas. it would start at 400,000 euros. "These measures are part of the government's overall housing policy, which aims, in cooperation with the private sector, to ensure affordable and quality housing for all citizens," Finance Minister Kostis Hatzidakis said. According to Bank of Greece data, rents have increased by 20% since the country officially exited a near-decadelong crisis in 2018.-APP

#### Türkiye 'neutralizes' 5 PKK terrorists in n.Iraq

ISTANBUL: Turkish security forces "neutralized" five PKK terrorists in northern Iraq, the National Defense Ministry said on Monday. The terrorists were targeted in the Hakurk region via airstrikes, the ministry said on X. "We will continue our fight with great perseverance and determination to free our noble nation from terrorism," it added, Turkish authorities use the term "neutralized" to imply the terrorists in question surrendered or were killed or captured. PKK terrorists often hide out across the border in northern Iraq to plot terror attacks in Türkiye. In its more than 35-year terror campaign against Türkiye, the PKK - listed as a terrorist organization by Türkiye, the US, and EU - has been responsible for the deaths of over 40,000 people, including women, children, and infants.-APP

#### Western France on red alert due to flood risk

ANKARA: The western French department Indreet-Loire remains on red alert Monday due to flood risk, according to the country's weather authority, Meteo France. The French towns and rivers in western France were flooded over the weekend, and residents were evacuated, according to local media. Rescuers continue searching for a kayaker who went missing in the flooded La Vienne river on Saturday, the La Depeche newspaper reported. La Vienne rose on Sunday evening up to 5.24 meters (17.19 feet), and the Creuse river rose to 6.78 meters, surpassing the record in 1982.-DNA

#### Tokyo shares close lower on profittaking

TOKYO: Tokyo stocks shed early gains to close lower on profit-taking on Monday, as investors sought fresh direction after the Easter break in the United States. The benchmark Nikkei 225 index fell 1.40 percent, or 566.35 points, to end at 39,803.09, while the broader Topix index dropped 1.71 percent, or 47.40 points, to 2,721.22. Before the opening bell, the Bank of Japan's Tankan poll showed that business confidence among large manufacturers slipped in March - the first decline in the past four quarters, although it was slightly higher than market expectations. # report Russia behind 'Havana Syndrome'

MOSCOW: The Kremlin on Monday dismissed a report that Russian military intelligence may be behind the mysterious "Havana syndrome" ailment that has afflicted U.S. diplomats and spies globally. Insider, a Russia-focused investigative media group based in Riga, Latvia reported, opens new tab that members of a Russian military intelligence (GRU) unit known as 29155 had been placed at the scene of reported health incidents involving U.S. personnel. The year-long Insider investigation in collaboration with 60 Minutes and Germany's Der Spiegel also reported that senior members of Unit 29155 received awards and promotions for work related to the development of "non-lethal acoustic weapons". "This is not a new topic at all; for many years the topic of the so-called 'Havana Syndrome' has been exaggerated in the press, and from the very beginning it was linked to accusations against the Russian side," Kremlin spokesman Dmitry Peskov told reporters when asked about the report. "But no one has ever published or expressed any convincing evidence of these unfounded accusations anywhere," Peskov said. "Therefore, all this is nothing more than baseless, unfounded accusations by the media." A U.S. intelligence investigation whose findings were released last year found that it was "very unlikely" a foreign adversary was responsible for the ailment, first reported by U.S. embassy officials in the Cuban capital Havana in 2016. Symptoms of the ailment have included migraines, nausea, memory lapses and dizziness. The Insider report said the first incident of "Havana Syndrome" symptoms may have happened earlier than 2016. It said "there were likely attacks two years earlier in Frankfurt, Germany, when a U.S. government employee stationed at the consulate there was knocked unconscious by something akin to a strong energy beam". #### Germany gives controversial green light to cannabis BERLIN: Germany on

Monday became the biggest EU country to legalise recreational cannabis, despite fierce objections from opposition politicians and medical associations. Under the first step in the much-debated new law, adults over 18 are now allowed to carry 25 grams of dried cannabis and cultivate up to three mariiuana plants at home. The changes leave Germany with some of the most liberal cannabis laws in Europe, alongside Malta and Luxembourg, which legalised recreational use in 2021 and 2023, respectively. The Netherlands, known for its permissive attitude to the drug, has in recent years taken a stricter approach to counter cannabis tourism. As the law took effect at midnight, hundreds of people cheered by Berlin's iconic Brandenbrug Gate, many of them by lighting up ioints in what one participant, a very happy 25-yearold Niyazi, called "a bit of extra freedom". As the next step in the legal reform, from July 1 it will be possible to legally obtain weed through "cannabis clubs" in the country. These regulated associations will be allowed to have up to 500 members each, and will be able to distribute up to 50 grams of cannabis per per-

son per month. Until then, "consumers must not tell the police where they bought their cannabis" in the event of a street check, Georg Wurth, director of the German Cannabis Association, told AFP. Initial plans for cannabis to be sold via licensed shops have been ditched due to EU opposition, though a second law is in the pipeline to trial the sale of the drug in shops in pilot regions.

The German government, a three-way coalition led by Chancellor Olaf Scholz's Social Democrats, argues that legalisation will help contain the growing black market for the popular substance.

But health groups have raised concerns that legalisation could lead to an increase in use among young people, who face the highest health risks.

Cannabis use among young people can affect the development of the central nervous system, leading to an increased risk of developing psychosis and schizophrenia, experts have warned. "From our point of view, the law as it is written is a disaster," Katja Seidel, a therapist at a cannabis addiction centre for young people in Berlin, told media.-APP

#### Northern Irish DUP leader resigns amid charges

BELFAST: Jeffrey Donaldson, the leader of Northern Ireland's largest unionist party, stepped down on Friday, the Democratic Unionist Party (DUP) said, after he was charged over historical sex offences.

Donaldson, 61, is one of the British region's best-known politicians and is Northern Ireland's longest-serving lawmaker in the British parliament, to which he was first elected in 1997. He is also a former member of the Northern Irish Assembly. "The Party Chairman has received a letter from Sir Jeffrey Donaldson MP confirming that he has been charged with "allegations of an historical nature" and indicating that he is stepping down as leader of the Democratic Unionist Party with immediate effect," the DUP said in a statement. "In accordance with the party rules, the party officers have suspended Mr Donaldson from membership, pending the outcome of a judicial process." The Police Service of Northern Ireland (PSNI) said earlier on Friday that detectives had arrested and charged a 61-year-old man for "non-recent sexual offences".

A 57-year-old woman was also arrested and charged at the time "for aiding and abetting additional offences". Both are due to appear in court on April 24, police said. "It's been a devastating revelation and has caused tremendous shock not just for myself personally or my colleagues within the DUP, but for the community right across Northern Ireland," Robinson told Sky News in an interview.—

#### Mali political parties demand elections amid junta's backtrack

BAMAKO: Political parties in Mali have requested a time frame for presidential elections after the ruling junta failed to organise polls within a promised 24-month transition back to democracy. Mali has been under military rule since August 2020, the first of eight coups in West and Central Africa over four years, including in its neighbours Burkina Faso and Niger. Regional blocs have been trying to negotiate transitions but the interim governments are dragging their feet. Mali's current junta seized power in a second 2021 coup and later promised to take 24 months from March 2022 to restore civilian rule, with a start date of March 26, 2024 and elections in February. It passed a new electoral law in June 2022, but said in September last year that it would postpone February elections for technical reasons, sparking outrage among political groups. Many reacted again after last month's transition deadline lapsed without a vote. In a joint statement late on Sunday, some of Mali's main political parties and civil society groups called on authorities to set up an institutional framework for polls as soon as possible. "We will use all legal and legitimate avenues for the return of normal constitutional order in our country," they said in the statement, which has over 20 signatories, including a major opposition coalition and the toppled ex-president's party. Mali's military rulers already failed on a first promise to hold elections in February 2022, prompting stiff sanctions from the Economic Community of West African States (ECOWAS).

SEOUL: SEOUL: South Korean President Yoon Suk Yeol said on Monday his government is open to talks with doctors who oppose his plan to increase medical school admissions, while accusing critics of offering no reasonable alternative to ease a doctor shortage. In a 50-minute address to the country, Yoon signalled his willingness for the first time to seek a compromise on his medical reform proposals after the government called for dialogue with striking doctors. Yoon apologised for the inconvenience caused by the ongoing strike by trainee doctors but accused the medical sector of putting their own interests ahead of public health. "If you come up with a more proper and reasonable solution, we can discuss it as much as you want," he said. "If you present better opinions and rational grounds, government policy can change for the better."

figure we came up with. We have thoroughly reviewed relevant statistics and research and reviewed present and future medical situations," Yoon said, adding that the government's reforms aimed to create "a medical environment where all people can receive treatment with a peace of mind". Yoon said doctors opposed to the plans should stop "making threats" and present a "unified blueprint with clear scientific reasoning". "If a more valid and reasonable plan is brought forward, we can discuss as much as they want," he said. Some 12,000 junior doctors in South Korea have been on strike since early February over the proposals, forcing hospitals to cancel treatments and surgeries. South Korea's government has argued that the reforms are necessary to alleviate staff shortages and manage the country's rapid transition to an aged society. South Korea had 2.6 doctors per 1,000 people in 2022, according to the Organisation

for Economic Co-operation and De-

velopment (OECD), well below the average among developed nations. Previous governments have devised measures to tackle deepening shortages of doctors in essential services including paediatrics and emergency units, as well as clinics outside the greater Seoul area, but their efforts fell apart amid strong opposition from the medical sector. Some medical professionals have said the Yoon ad-

ministration had failed to consult in advance, and its plan would do little to fix the current situation including low pay for trainee doctors. Trainee doctors argue that the medical system is not equipped to handle such a steep increase in new recruits and that medical services will suffer as a result. Doctors participating in the walkout face the risk of losing their medical licences after the government last month began taking steps to suspend them. Yoon urged the doctors to return to work before the process to suspend their licences was complete, saying collective action should only be considered "when I do not keep my promises". Yoon also expressed regret at the inconvenience caused to the public, saying he was sorry he had been unable to "quickly resolve the inconveniences of the people". Public approval of Yoon has declined as the strike has dragged on. with just over 36 percent of South Koreans expressing a positive view of the president in a RealMeter poll

#### **Delhi CM** Kejriwal gets further detention

NEW DELHI: An Indian court renewed detention on Monday for key opposition leader Arvind Kejriwal until April 15 in a graft case, his lawyers said, less than three weeks before voting begins in general elections. In a move that sparked protests last month, India's financial crime-fighting agency arrested Kejriwal, the chief minister of Delhi, over graft accusations related to the city's liquor policy and remanded him to custody until April 1. Opposition parties say the arrest, along with government action against other opposition groups and their leaders, shows the government is denying them a level playing field in the elections, charges it denies.

Kejriwal's Aam Aadmi Party (AAP) says he has been falsely arrested in a fabricated case, but Prime Minister Narendra Modi's Bharatiya Janata Party (BJP) denies political interference. Lawyers for the agency, the Enforcement Directorate, said on Monday that Kejriwal had been non-cooperative and gave evasive replies, asking the court to hold him in custody for 15 days longer, the website Live Law said.

BEIJING: France's top diplomat said Monday that Paris expects China to send "clear messages" to its close partner Russia over its war in Ukraine, after meetings with his counterpart in Beijing. France and China have sought to strengthen ties in recent years and, during meetings in Paris in February, Foreign Minister Wang Yi told President Emmanuel Macron that Beijing appreciated his country's "independent" stance. But Paris has also sought to press Beijing on its close ties with Moscow, which have only grown closer since the invasion of Ukraine. While China says it is a neutral party in the Ukraine conflict, it has been criticized for refusing to condemn Moscow for its offensive. Paris has, in contrast, become one of Kviv's firmest backers, with Macron in February even refusing to rule out putting troops on the ground in Ukraine. And Foreign Minister Stephane Sejourne said Monday it wanted "China to send very clear messages to Russia" over its war in Ukraine. "We are convinced that there will be no lasting peace if it is not negotiated with the Ukrainians," he told a press conference

## Russia demands extradition of Ukraine security chief

A Russian foreign ministry statement listed violent incidents that have occurred in Russia since the full invasion of Ukraine in February 2022, including bombings that killed the daughter of a prominent nationalist and a war blogger, and an incident in which a writer was seriously hurt. The ministry said investigation of these incidents showed that "the traces of these crimes lead to Ukraine". "Russia has turned over to Ukrainian authorities its demands ... for the immediate arrest and extradition of all those connected to the terrorist acts

## **Reserved seats verdict** KP Assembly speaker files review petition

PESHAWAR: On the eve of the Senate elections, Khyber Pakhtunkhwa (KP) Assembly Speaker Babar Saleem Swati on Monday filed a review plea in the Peshawar High Court (PHC) over the direction issued by the court to administer the oath to the lawmakers elected on reserved seats. The writ petition, submitted by Speaker Swati through Advocate Ali Azim Afridi, stresses that no requisition was received by him regarding the summoning of the session. "The elected person has to be administered oath before the provincial assembly within the meaning of Article 65 of the Constitution, which is only possible when an assembly session is summoned or requisitioned," the plea argues citing the court's judgement in the Baldive Kumar's case. Meanwhile, expressing his views on the issue, KP Assembly Speaker Swati said that he was advised by his legal team and law department that the governor does not have the authority to summon a session - as he did so earlier this month on the opposition's request. "We believe in the rule of law," he said while speaking to the media in Peshawar. On the upcoming Senate polls, slated for April 2 (tomorrow), Swati said that the assembly secretariat has finalised the preparations for Tuesday's elections wherein the assembly hall has been declared as the polling station. The development comes as last week a two-member PHC bench comprising Justice Attique Shah and Justice Shakeel Ahmad – in response to the petition filed by opposition parties in the provincial assembly - ordered swearing-in of members elected on reserved seats.

# Erdogan concedes defeat in Turkiye local elections

ANKARA: Turkish President Recep Tayyip Erdogan conceded defeat on Sunday in the country's local elections, saying the vote was a "turning point" for his party after two decades in power. Partial results from across the nation of 85 million people showed major advances for the Republican People's Party (CHP) at the expense of Erdogan's Justice and Development Party (AKP).

Istanbul's mayor, the opposition's Ekrem Imamoglu, claimed re-election with nearly all ballot boxes opened, telling a euphoric crowd of supporters: "Tomorrow is a new spring day for our country." Final results are expected to be released on Monday (today) by the country's electoral commission. Erdogan, 70, had launched an all-out personal campaign to win back Istanbul, the economic powerhouse where he was once mayor. Rampant inflation and an economic crisis have, however, hit confidence in the ruling party. Large crowds filled the square outside the opposition party's Istanbul city headquarters waving Turkish flags and lighting torches to celebrate the result.

After casting his vote, Imamoglu emerged to applause and chants of "Everything will be fine", the slogan he used when he first took the city hall from the AKP in 2019.

The 52-year-old is increasingly seen as the biggest rival to Erdogan's AKP ahead of the next presidential election in 2028. In Ankara, mayor Mansur Yavas - also of the CHP - claimed victory in front of large crowds of supporters, declaring "the elections are over, we will continue to serve Ankara". "Those who have been ignored have sent a clear message to those who rule this country," he added.

Yavas led with 58.6 per cent of the vote to 33.5pc for his AKP opponent, with 46.4pc of ballot boxes opened. Opposition supporters celebrated victory in Izmir, Turkiye's third-largest city, as well as in the southern city of Antalya. Some AKP stronghold towns were at risk of being lost, results indicated. "Voters have chosen to change the face of Turkiye," said CHP chairman Ozgur Ozel as the results emerged. "They want to open the door to a new political climate in our country." Erdogan acknowledged the electoral setback in a speech to supporters at the headquarters of his party. "Unfortunately, we have not obtained the results that we wanted," he told a subdued crowd.

The Secretary Agriculture in his briefing on various projects for the development of agriculture in Punjab apprised that 1.7 MAF of water can be saved by paving 7300 water courses (Khalaas) in Puniab. A proposal to return rainwater to the ground by reverse pumping to improve groundwater levels was also reviewed in the meeting. Moreover, necessary measures to increase the rate of farm mechanization from 35 to 60 percent in Punjab were also discussed. It was decided in the meeting that Rs 150-billion loan will be given to farmers for Rabi and Kharif crops. Quaid Muhammad Nawaz Sharif directed to formulate a simple eligi-



bility criteria for the farmers to avail loans. Chief Minister Maryam Nawaz Sharif said,"When a farmer applies for a loan, it should be ensured that the loan is issued as soon as possible."
