Shehbaz stresses need to ensure economic stability

Premier reflects on opposition's skepticism about mini-budget being necessary to secure IMF deal

ISLAMABAD: ISLAMABAD: Hailing the successful conclusion of a staff-level agreement with the International Monetary Fund (IMF) for a new \$1.3 billion arrangement, Prime Minister Shehbaz Sharif emphasised the need to eliminate debt and pave the way for sustainable economic growth. Addressing the federal cabinet meeting on Wednesday, the premier acknowledged that achieving economic stability is a long and challenging journey but expressed confidence that Pakistan will progress through relentless hard work and dedication. The prime minister also commended the collective efforts of the deputy prime minister, finance minister, planning minister, commerce minister, economic affairs minister, FBR chairman and other key members of the economic team for their diligent work in securing the IMF agreement.

He reflected on the skepticism from opponents, who had predicted that a mini-budget would be necessary to secure the deal. However, the premier asserted that the agreement was achieved without the need for additional taxation measures, proving the government's resolve and planning.

Shehbaz also acknowledged the hardships faced by the common people who bore the burden of the price hike during the process of achieving economic stability. Besides, he paid tribute to the salaried persons who contributed a major portion in tax collection. The government will receive \$1.3 billion from the IMF, which will bolster Pakistan's foreign reserves to \$8.3 billion, the prime minister said, terming it a big achievement to stabilise the county's economy. He also highlighted the contributions of all the provincial governments and their relevant chief ministers in supporting the federal government in securing the IMF agreement. Highlighting the government's success in surpassing tax collection targets, he said the IMF had aimed for a 10.2% tax-to-GDP ratio, but with strong Rs436 billion. Despite severe resource constraints,

Federal Govt approves Rs1.3tr mega projects

Infrastructure projects see cost hikes; allocation exceeds annual budget

ISLAMABAD: The government approved over a dozen mega projects worth Rs1.3 trillion, many of which were already under implementation but have seen significant cost escalations. Among them is the construction of a new federal-funded motorway in Punjab, now costing Rs436 billion. The Executive Committee of the National Economic Council (EC-NEC), the country's top project approval authority, sanctioned these projects, including major infrastructure developments and a satellite initiative. Chaired by Deputy Prime Minister Ishaq Dar, EC-NEC approved 13 schemes, including two flood-related projects in Sindh. According to a statement issued by the Deputy PM's Office, these 13 projects span key sectors, including transport, communications, railways, space technology, and public infrastructure. The Rs1.3 trillion allocation exceeds this year's annual federal development budget, with some new projects also receiving provincial funding. Among the most significant approvals was the Lahore-Sahiwal-Bahawalnagar Motorway, stretching 295 kilometres. Initially approved in August 2023 for Rs264 billion, its cost has now increased by 65% to

IMF reaches staff-level agreement with Pakistan

"Over the past 18 months, Pakistan has made significant progress in restoring macroeconomic stability and rebuilding confidence despite a challenging global environment," the IMF said in a statement. The new 28-month deal would support Pakistan's efforts to mitigate and adapt to climate change, the Fund said in the statement announcing its decision. Both the new programme and the loan review require approval from the Fund's executive board, which is largely a rubber-stamping exercise. Pakistan's inflation is expected to remain steady in March, in the 1% to 1.5% range, according to the country's finance ministry in its monthly economic outlook. This follows a slowdown to its lowest level in almost a decade the previous month. 

WASHINGTON: The United States has added 80 companies from various countries, including Pakistan, to its export blacklist. The US added six subsidiaries of Inspur Group, China's leading cloud computing and big data service provider, and dozens of other Chinese entities to its export restriction list on Tuesday. The Inspur units were listed for contributing to the development of supercomputers for the Chinese military, the Commerce Department said in a posting. Five of the subsidiaries are based in China and one in Taiwan. Inspur Group itself was placed on the list in 2023. The Inspur units

Punajb CM launches women police squad



ISLAMABAD: The Council of Islamic Ideology (CII) on Wednesday convened a meeting in which members deliberated on a total of 19 agenda items. The session was chaired by Dr. Muhammad Raghib Hussain Naeemi, Chairman of the Council. In the meeting, four experts from the Sindh Institute of Child and Neonatology were invited to present a briefing on the establishment of a human milk bank. They provided detailed responses to 33 queries raised by the council members. Additional questions from the members were also addressed. The council decided to conduct an in-depth study on the matter and will present its final decision in the next meeting. The council ruled that organ transplantation, particularly of the kidney and liver, is permissible as long as the donor's life is not endangered. It was decided that Islamic terms such as Salah (prayer), Ayah (verse),

and Masjid (mosque) should be retained in their original Arabic form instead of being translated into English. The council emphasized that scholars and intellectuals should raise awareness at their respective levels regarding the issue of electricity theft. The council ruled that newly hired employees can be required to participate in the contributory pension system, but existing employees cannot be compelled to join it. Additionally, it stressed that pension funds must be entirely free from interest-based financial systems. It was decided that pre-

It was decided that premarital testing for thalassemia or other contagious diseases can be included in the Nikahnama (marriage contract) as an optional provision. However, the decision to marry will remain solely at the discretion of both parties under Islamic law. The council ruled that granting a first wife the right to annul her marriage if her husband

remarries without her permission is un-Islamic. Any judicial ruling that permits such annulment contradicts Islamic teachings. The council stressed that Zakat funds should be distributed to deserving individuals without unnecessary delays. However, if administrative procedures cause delays, these funds can be placed in profit-generating Islamic bank accounts. In the event of any financial losses, the government will be responsible for compensating them. The council reaffirmed its previous stance that the Khyber Pakhtunkhwa (KP) Transgender Bill contains the same un-Islamic elements as the Transgender Act of 2018, which had been declared inconsistent with Islamic principles by the council and the Federal Shariat Court. Additionally, the council expressed concerns over the bill's inclusion of the Guru-Chela (mentor-disci-

ple) concept, deeming it un-Islamic. At the

conclusion of the meeting, prayers were offered for the late mother of Chief of Army Staff General Syed Asim Munir.

He said the police thwarted the attack with remarkable bravery and ofessionalism, preventing the suspects from escaping. He said inter-provincial dacoit Saim Ali was involved in 56 cases of robbery. He said another suspect, Muhammad Taimoor, had nine cases registered against him for serious crimes. He said police are conducting raids to apprehend the remaining accomplices.—APP

PMD forecast intermittent rain

ISLAMABAD: The Pakistan Meteorological Department (PMD) has forecast intermittent rain, windstorms, and thunderstorms, with snowfall over high mountains, for multiple regions of the country on Wednesday. Khyber Pakhtunkhwa, Gilgit Baltistan, and Kashmir are expected to experience widespread rain, while upper Punjab, Islamabad, and northeastern Balochistan will also receive showers. Heavy rainfall and hailstorms are likely in upper Khyber Pakhtunkhwa, Gilgit Baltistan, and Kashmir. Strong winds and thunderstorms may damage infrastructure, including electric poles, trees, vehicles, and solar panels. Agricultural concerns arise as windstorms and hailstorms could damage standing crops in the plains of Punjab and Khyber Pakhtunkhwa on March 26 and 27. Landslides and slippery roads may affect travel in hilly areas, including Murree, Galliyat, Naran, Kaghan, Chitral, Dir, Swat, Kohistan, Mansehra, Abbottabad, Shangla, Astore, Hunza, Skardu, Neelum Valley, Bagh, Poonch, and Haveli. Flash floods could occur in Chitral, Dir, Swat, Kohistan, and Mansehra due to heavy rainfall. Islamabad is expected to experience partly cloudy weather with a 55% chance of rain and thunderstorms. In Khyber Pakhtunkhwa, rain and thunderstorms with snowfall over high mountains are forecasted for several districts, including Peshawar, Abbottabad, Swat, and Mansehra, with hailstorms likely in the southern areas. Punjab will see partly cloudy conditions, with isolated rain and thunderstorms in Rawalpindi, Murree, Lahore, Faisalabad, and other areas. Sindh will remain mostly dry, with gusty winds and partly cloudy conditions in upper districts during the afternoon. Balochistan will experience dry to partly cloudy weather, with rain and thunderstorms expected in Quetta, Ziarat, Zhob, and other regions. Kashmir and Gilgit-Baltistan will have partly cloudy conditions with rain, thunderstorms, and snowfall over hilly areas. Dry conditions prevailed in most parts of the country in the past 24 hours, with isolated rain in upper Khyber Pakhtunkhwa and Gilgit Baltistan. The highest temperatures recorded were 42C in Shaheed Benazirabad, 41C in Dadu, and 40C in Mithi. The authorities urge residents in affected regions to take precautions against potential flooding, landslides, and storm-related damage. Farmers should secure their crops, and travelers in mountainous areas are advised to be cautious of slippery roads and landslides.-DNA

People seek action against encroachment

RAWALPINDI: A massive crowd of buyers has created mess on main roads. Despite continued anti-encroachment operations by Rawalpindi Cantonment Board (RCB) in many areas, the challenge of congestion remains still standing. The residents of Tench Bhatta, Mughalabad, Kamalabad and other adjacent localities have complained of difficulty in their movements. "On return from the offices, we have to combat long cues from Octroi No 22 for a long time" said Fawad a resident of Tench Bhatta. Fawad said the issue of encroachments still stands as it was before the

anti-encroachment operations. "Because of the absence of follow up by the authority, moveable stalls and carts re-enter to the main bazaars. The campaign of removing encroachments by RCB continued for more than 2 weeks in which various concrete sheds and moving shops were destroyed. However, one can't walk an inch during the rush hour. "Symbolic presence of traffic wardens at partial timings will never tackle the issue, instead it needs regular deployment of traffic police officials and continuous movement by RCB personnel are required on an urgent basis", said Aziz Butt who resides and runs a shop in Tench Bhatta. The residents also criticized the bazaars' trade unions in this regard. They said that elected representatives of the market should not allow the moving carts remain stay in front of the shops. "Even the shopkeepers wrongly park their bikes on main rods in a way to creat hurdles in traffic flow", said Tariq who resides in Kamalabad. He blames the business owners for letting the small spaces to be rented out for such moving stalls. The residents appealed to the authorities to take urgent collective actions for restoration of traffic flow and easy pedestrian movement. They demanded for special deployment of traffic wardens and regular monitoring of encroachers in Tench Bhatta and Kamalabad roads, particularly during the month of Ramadan.

ISLAMABAD: Pakistan's Roomi Agriculture Company and China's Zibo Academy of Agricultural Sciences signed a Cooperation Framework Agreement focused on the castor industry, China Economic Net (CEN) reported on Wednesday. The agreement outlines their collaboration in scientific breeding, planting technology, deep processing, and marketing of castor products. Castor seed cultivation is highly sensitive to environmental factors, particularly water availability. Under the agreement, a Shandong-based agricultural company will oversee seed production, provide technical support, develop digital cultivation technologies, and research and manufacture digital water-fertilizer equipment. Additionally, they will design digital models for the pre-planting, mid-planting, and post-harvest stages. Zibo Academy of Agricultural Sciences has developed castor germplasm resources that are resistant to herbicides and tolerant of salt and alkali through

field hybridization, biotechnology, and molecular breeding. The academy will oversee variety selection, cultivation techniques, and provide support for industry chain information. Roomi Agriculture will promote large-scale castor bean cultivation on its own farms as well as on partner farms. According to World Bank data, India accounts for over 80% of global castor oil production, playing a crucial role in the supply chain. Data from China's General Administration of Customs indicates that in 2024, China imported castor oil and chemically unmodified derivatives valued at RMB 3.75 billion, with India supplying RMB 3.74 billion of that total. The demand for castor oil is anticipated to remain strong, especially in the cosmetics and pharmaceutical industries. This reliance renders global markets susceptible to price fluctuations caused by supply constraints, according to industry experts. Industry experts note that innovations in breeding and improved irrigation techniques could alleviate supply constraints; however, castor oil prices are likely to remain elevated due to persistent demand outpacing supply.

Eastern Europe's anxiety

ECENTLY, "strategic autonomy" has become a central issue in Europe and a focal point of global attention. The Russia-Ukraine conflict has and a tocal point of global attenuon. The Adoction of Significant drastically altered Europe's security landscape, exposing significant weaknesses in the European security system. After the new US administration openly "betrayed" Europe, the illusion that Europe's security could rely on the US was shattered, and "strategic autonomy" finally gained the attention of the EU and its member states. The core of achieving "strategic autonomy" for Europe is to build an independent and strong European security system. France and Germany are particularly focused on this issue. French President Emmanuel Macron publicly declared the goal of providing a nuclear umbrella for Europe, while German chancellor-in-waiting Friedrich Merz has led the push for a fiscal expenditure plan to inject one trillion euros into Germany's infrastructure and defense industries over the next decade, which has been passed by Germany's parliament. Although many European countries have signaled positive intentions toward achieving "strategic autonomy," divisions still exist within Europe regarding the approach to this issue. Notably, differing opinions from Eastern European countries are particularly evident. For a long time, the differences between Eastern and Western European countries in terms of economy, society, culture and development - particularly the differing values surrounding "European identity" - have often led to disputes over major policy issues. This contradiction is also reflected in the attitudes of Eastern European countries toward the European "strategic autonomy" plan. For example, Poland strongly supports continued aid to Ukraine and the EU's proposed "rearming Europe" plan, and it has announced plans to increase defense spending to 5 percent of its GDP by 2025. In contrast, Hungary has shown indifference to aid for Ukraine and opposed the EU's defense strengthening proposal. While the UK and France are leading efforts to actively form a "peacekeeping force" for Ukraine, Poland, which shares a border with Ukraine, has stated that it will not send troops. Regarding the nuclear umbrella, Polish President Andrzej Duda publicly called on the US to deploy nuclear weapons to Polish soil, indicating that Poland is not as enthusiastic about Macron's proposal of a nuclear umbrella. The significant differences and disagreements among Eastern European countries on European security issues can be attributed to two main reasons. First, the European "strategic autonomy" plan fails to alleviate the longstanding security anxieties of Eastern European countries. Additionally, with the US military presence in Eastern Europe, countries like Poland and Romania rely, to varying degrees, on US security guarantees. With Europe's longstanding state of "military neglect," these countries are clearly more willing to trust the protection offered by the US. Poland's reluctance to deeply engage in the Russia-Ukraine conflict and Hungary's decision to ease relations with Russia are examples of "self-preservation" actions that are directly related to the belief that Europe cannot provide adequate security guarantees. Second, the interests of Eastern European countries do not completely align with the EU's security plan. When faced with the choice between "building infrastructure" and "en-

suring security," Eastern European countries generally prioritize the former.

Trump upending rules-based order

HE world's major growth engines are about to run in reverse. The policies and uncertainties of US President Donald Trump's second administration have hit a sluggish global economy with a transformational exogenous shock. Risks are especially worrisome in both the United States and China, which have collectively accounted for a little more than 40 per cent of cumulative global gross domestic product growth since 2010. America is now the problem, not the solution. Long the anchor of the rules-based international order, the US has turned protectionist, posing major risks to an already-fragile global trade cycle. At the same time, Trump's "Make America Great Again" movement has driven a powerful wedge between the US and Europe and divided North America, with Canada's very independence in Trump's crosshairs. The central role of the US in sustaining post-World War II geostrategic stability has been shattered. The US will be unable to put the genie back in the bottle. Trump's shocking actions have eroded the trust that has underpinned America's global leadership, and the damage will be evident long after Trump has left the scene. Having once abdicated its moral authority as the anchor of the free world, who is to say it can't happen again? This breakdown in trust will cast a long and lasting shadow over economic performance, not least in the US itself, where it is affecting business decision-making, especially the costly long-term commitments associated with hiring and capital spending. Businesses need to scale their future operations relative to confident expectations of future growth trajectories - now an increasingly uncertain proposition. Asset values and consumer confidence, too, have been shaken. Uncertainty, the enemy of decision-making, is likely to freeze the most dynamic segments of the US economy. For China, state-directed policy guidance might temper the initial blow of a Trump policy shock. But the pressures of Trump's tariff escalation will undermine China's export-led growth model, which is especially problematic for economic growth, given the lingering weakness of China's domestic demand. China vows to take 'all necessary measures' after imposition of latest US tariffs The country's long-promised consumer-led rebalancing of the economy remains more of a slogan than an actual shift in the sources of Chinese growth, especially with a deficient social safety net that continues to encourage fear-driven precautionary saving. China's just-announced 30-point action plan to boost household demand draws much-needed attention to the seemingly chronic plight of the Chinese consumer, but it offers only modest support to an inadequate social safety net. The Trump shock is likely not only to exacerbate the Sino-American conflict but also weaken both countries' growth prospects significantly. Don't count on other economies filling this void. Eventually India might be able to take up some of the slack, but its relatively small share of world GDP - currently 8.5 per cent in purchasing-power-parity terms, compared to 34 per cent for China and the US combined – means that day is in the distant future. The same is true of Europe.

The tale of two deserts

It is a land suspended between ancient endurance and modern abandonment. Yet, halfway across Asia, I had once witnessed a desert of similar character—unforgiving and untamed—undergo...

S a television news producer (1986-1991), I've covered my share of human tragedy, bureaucratic inertia, and moments of quiet hope. But few stories have stayed with me as powerfully as a journey through the deserts of Balochistanwhere a tragic accident illuminated not just systemic neglect, but also the remarkable contrast between two deserts: one forsaken and fossilized in time, and the other transformed into a symbol of possibility through vision, science, and human resolve. Our assignment began with a grim dispatch: a head-on collision between two passenger buses near Dalbandin, a remote town in southwestern Pakistan, roughly 400 kilometers from Quetta. Departing from the provincial capital at dusk, we drove through fading light and battered roads, arriving in Naushkey by midnight. At dawn, we resumed our journey. But as the sun rose, the road disappeared altogether-claimed by the vast, unmarked expanse of the Dasht-e-Margo, literally the "Desert of Death." There was no map to follow, only hardened mud plains, windswept dunes, and the intuition of our local cameraman, who led us like a nomadic guide across the skeletal terrain.

By midday, we reached Dalbandin, where we were received in a modest roadside rest house by the local Assistant Commissioner. What awaited us was chilling. The two buses, barreling at speeds exceeding 100 kilometers per hour along an unmarked track, had collided head-on and burst into flames. There were no survivors—just twisted steel, scorched earth, and the acrid scent of human tragedy. It was a disaster shaped not only by fate but by decades of neglect. In a desert of over 347,000 square kilometers—larger than Germany—there were no roads, no signs, no

protections. Just emptiness and vulnerability. The Dasht-e-Margo is a desert etched into history. In 325 BCE, Alexander the Great lost thousands of his soldiers to thirst and exhaustion while attempting to cross this merciless landscape. More than two millennia later, its terrain remains untouched, unreclaimed, and largely uninhabited—where nomadic tribes still live as they did centuries ago, and modern development has yet to arrive. Yet, halfway across Asia, I had once witnessed a desert of similar character—unforgiving and untamed—undergo a profound transformation. The Taklamakan Desert in China's Xinjiang region,

slightly smaller in size at 337,000 square kilometers, was once considered one of the most dangerous deserts in the world. Its very name means, "Go in, and you won't come out." Silk Road traders feared its shifting sands and sudden storms. For centuries, it remained a death zone for caravans and a barrier to settlement. But in the past few decades, the Taklamakan has defied its ancient reputation. Since the 1980s, the Chinese government has undertaken one of the most ambitious ecological projects in human history: the creation of a "Green Wall" to contain the desert's expansion and regenerate its periphery. Over 100 million drought-resistant trees-poplars, tamarisks, and desert willows-have been planted, stretching over 3,000 kilometers around the desert's edge. Drip irrigation systems, soil stabilization techniques, and satellite-guided planting have reclaimed thousands of hectares of land. What satellite images once showed as a yellow void now reveals a ring of green steadily encroaching on the sands.

And beyond the ecological triumph lies a deeply human story: that of how Xinjiang's local populations-Uyghurs, Kazakhs, and others-were turned from desert survivors into stakeholders of transformation. Former herders and subsistence farmers were trained as tree planters, irrigation workers, and forest guardians. More than 300,000 jobs have been created in Xinjiang's forestry and agricultural sectors since 2010. Eco-compensation programs paid villagers to plant trees instead of overgrazing livestock, and fruit orchards-producing pomegranates, walnuts, and dates-have flourished where once there was only dust. This economic revitalization has drastically improved livelihoods and reduced the appeal of insurgent ideologies, replacing alienation with agency. It is no coincidence that the Taklamakan's transformation coincided with broader development in Xinjiang. Once plagued by separatist unrest and violence, Xinjiang has seen its GDP per capita rise from \$3,000 in 2010 to over \$8,000 in 2023. Poverty rates have fallen from over 30 percent to near zero. High-speed rail now links its cities to the rest of China. New industries-textiles, solar energy, food processing-have taken root, and tourism has emerged around the newly greened belts of desert. Terrorist incidents have dropped by over 90 percent in the last decade, not solely due to security measures, but because people were offered a stake in stability.

A key to this success lies in water. Like Balochistan, Xinjiang is bone-dry and vulnerable to drought. But China's investment in water management has been transformative: the construction of reservoirs and canals, the deployment of solar-powered pumps, and the implementation of efficient drip irrigation. These systems were built not only by state planners but by local laborers, whose participation ensured sustainability. Ownership of forest zones was assigned to communities, linking environmental restoration with livelihood security.

The comparison between these two deserts-Balochistan's Dasht-e-Margo and China's Taklamakanreveals the stark divergence between potential and action. It is not geography but governance that determines whether a desert remains a death zone or becomes a cradle of renewal. In Balochistan, where underground aquifers are vanishing and over 62 percent of the land is water-stressed, similar rehabilitation could be attempted. The ancient karez system, once used to irrigate Baloch settlements, could be revived and augmented with solar desalination technologies. And afforestation programs, modeled after Pakistan's successful Billion Tree Tsunami in Khyber Pakhtunkhwa, could stabilize soil and restore ecological balance. What the Taklamakan has shown is that with vision, investment, and inclusion, even the harshest terrain can bloom. What is needed in Balochistan is not merely funding, but a shift in philosophy: from command to collaboration, from marginalization to empowerment. The story of these two deserts is not just about climate or culture. It is a story about choices. One desert was seen as doomed, but was transformed by patience, science, and people. The other, still majestic and mysterious, waits under the sun for a similar awakening. Pakistan has the land, the talent, and the tools. What it needs is the will-the kind that sees deserts not as dead zones, but as frontiers of possibility. If the sands of Taklamakan can host orchards, if once-forgotten plains can hum with new life, then surely the Dasht-e-Margo too can echo with the sounds of roads being paved, trees being planted, water flowing once more. The desert will always whisper to us. The question is-will we finally listen?

From the cold war to Ukraine

HE Cuban Missile Crisis of 1962 remains one of the most pivotal moments in Cold War history, serving as a foundational case study for nuclear strategy, deterrence and the psychology of brinkmanship. The crisis demonstrated the perils of nuclear escalation, highlighting that the threshold for nuclear warfare was exceedingly high due to the principle of mutually assured destruction (MAD). The central criterion for a nuclear first strike rested on the assumption that the opposing side's command-and-control system had either collapsed leaving it incapable of retaliatory action-or that the adversary's nuclear arsenal had been grossly misrepresented. Despite various theoretical scenarios that have been proposed, the reality remains that nuclear weapons are almost never deployed due to their catastrophic implications. Nonetheless, contemporary geopolitical actors continue to invoke nuclear threats as strategic leverage. Russian President Vladimir Putin's rhetoric surrounding nuclear warfare in the context of the Ukraine conflict exemplifies a contemporary iteration of this strategic posture what may be termed the "insanity gambit." Throughout the Cold War and beyond, scholars and policymakers have grappled with the question of whether nuclear weap-

ons could ever be feasibly used in conflict. The historical record suggests that nuclear arsenals function primarily as deterrents rather than offensive weapons. A nuclear-armed state must consider several variables before initiating an attack: the potential for retaliation, the strategic gains versus losses and the rationality of leadership decision-making. The fundamental constraint is mutually assured destruction. Even if one side possesses superior intelligence and can pinpoint enemy nuclear assets with high precision, the likelihood of total nuclear disarmament through a first strike remains dubious. Technological advancements in second-strike capabilities such as submarine-launched ballistic missiles (SLBMs) and hardened silos ensure that a retaliatory response remains possible even in the wake of a large-scale nuclear attack. This reinforces the logic that nuclear war is an instrument of deterrence rather than a practical tool of warfare. Further complicating nuclear strategy is the advent of alternative operational doctrines. During the Cold War, there were proposals to neutralize enemy nuclear capabilities through clandestine operations, including deploying special forces to penetrate command centers or utilizing chemical agents to incapacitate launch personnel. However, these strategies faced significant ethical, legal and logistical obstacles.

Ultimately, any direct nuclear strike on a nuclear power would precipitate a global crisis, reinforcing the MAD doctrine. Despite these constraints, there exists a theoretical loophole in nuclear deterrence: the perception of irrationality. The "insanity gambit" hinges on convincing adversaries that a leader is willing to accept national annihilation in pursuit of strategic goals. This doctrine is not entirely novel figures such as Richard Nixon reportedly employed a "madman theory" to make adversaries believe he was unpredictable and capable of extreme measures. However, unlike Nixon's strategy, which relied on calculated unpredictability, the insanity gambit requires a leader to genuinely convince both external and internal audiences that nuclear war is a plausible outcome. Putin's nuclear rhetoric in the Ukraine war illustrates an application of this gambit. On multiple occasions, he has suggested that Western military support for Ukraine risks escalating into a nuclear confrontation. By invoking nuclear warfare, he aims to instill fear among Western policymakers, compelling them to adopt more accommodating policies toward Russia. The underlying premise is that the West, believing Russia might irrationally resort to nuclear arms, would be forced into strategic concessions to avert catastrophe. For the insanity gambit to succeed, several conditions must be met:

1. Credibility The leader must convincingly portray an intention to use nuclear weapons, even at great personal and national cost.

Conviction The leader's own government and military must believe in the plausibility of such an action.
 Strategic LeverageThe gambit must create a significant shift in adversarial policies

cant shift in adversarial policies. However, the viability of this strategy is questionable. Unlike conventional deterrence, which relies on rational calculations, the insanity gambit requires an actor to appear so irrational that even their own military and political elites fear escalation. This paradoxically weakens internal cohesion and risks miscalculations. If Russia's leadership, military command and citizens do not perceive an imminent existential threat, then the credibility of the insanity gambit collapses. Furthermore, the historical precedent set by Hiroshima and Nagasaki underscores the reluctance of nuclear-armed states to engage in direct nuclear conflict. Since 1945, nuclear weapons have functioned as strategic deterrents rather than offensive tools. Even during the Cuban Missile Crisis when the world stood on the brink of nuclear, war both the United States and the Soviet Union ultimately sought diplomatic resolutions over military escalation. The existence of second-strike capabilities further disincentivizes first-use scenarios, as retaliation remains assured. Understanding the insanity gambit within the broader context of international relations reveals several key insights:

1. Psychological Warfare and Diplomacy – Nuclear threats, even if unlikely to materialize, can shape diplomatic engagements. By introducing nuclear risk-taking into the strategic calculus, Russia aims to influence Western policy on Ukraine.

2. Risk of Escalation – While the probability of an actual nuclear strike remains low, persistent nuclear rhetoric heightens tensions and increases the likelihood of miscalculations or accidental escalations.

3. Erosion of Deterrence Stability – If nuclear threats are used too frequently without follow-through, their deterrent value diminishes. Repeated invocations of nuclear war without action can lead adversaries to call a bluff, thereby undermining strategic credibility.

4. The Role of Second-Strike Capabilities – The United States and NATO's established second-strike capabilities serve as a fundamental check against Russia's nuclear threats. Even if Russia were to use nuclear weapons, a retaliatory strike would ensure its own destruction.

The Cuban Missile Crisis demonstrated the fragility of nuclear risk-taking and the necessity of diplomatic resolution in high-stakes confrontations. Contemporary applications of nuclear threats, particularly in the context of Russia's war in Ukraine, reflect a calculated attempt to manipulate adversarial policy through strategic deception. The insanity gambit, while theoretically compelling, remains an unreliable and high-risk strategy. For it to work, Putin must convince both external adversaries and internal elites of his willingness to embrace nuclear catastrophe. However, the structural realities of deterrence, second-strike capabilities and historical precedent render actual nuclear conflict unlikely. Rather than heralding a new era of nuclear warfare, Putin's nuclear rhetoric underscores the enduring relevance of deterrence theory. The lessons of the Cuban Missile Crisis remain pertinent: nuclear weapons are tools of deterrence rather than instruments of war and strategic stability depends on credible but rational leadership. The insanity gambit, while an intriguing theoretical construct, ultimately serves as a psychological maneuver rather than a viable military strategy. In this sense, nuclear risk-taking remains a precarious endeavor-one that, despite its rhetorical impact, is unlikely to alter the fundamental dynamics of global power structures

"This performance reflects a 26% increase in tax collection so far", he added. "Pakistan's tax collection target for the year 2024-25 was set at Rs12.9 trillion, and despite the IMF initially suggesting a downward revision of this target, I personally insisted on maintaining the original figure. Following successful negotiations, the target, which was initially revised down to Rs12.1 trillion, was adjusted to Rs12.3 trillion," he added. PM Shehbaz underscored that the government had planned to fast-track the cases relating to taxes pending in the tribunals worth billions of rupees and informed that as a result of this decision, the government had recovered Rs34 billion.

Djokovic trounces Musetti to reach Miami quarters

MIAMI: Novak Djokovic won 12 of the last 14 games of his match against Lorenzo Musetti to crush the Italian 6-2 6-2 and move into the quarter-finals of the Miami Open in his best performance since the Australian Open. The momentum in the rain-delayed match seemed to swing in Djokovic's favour when he complained to the chair umpire in the opening set over a serve clock warning. That frustration seemed to spark the Serbian, who broke the next game for a 4-2 lead and never looked back in the presence of an adoring crowd that included Tennis greats Serena Williams and Juan Martin del Potro. "I was star-struck. It was amazing to see first DelPo, obviously a long-time friend and a rival, so happy to have him around and get his support from the box," Djokovic said. "It was amazing, it was (the) first time to have DelPo in the box, so I want to thank him really for coming. And Serena, that was a surprise." Six-times Miami champion Djokovic crushed an exquisite backhand winner for a 5-2 second-set lead and sealed the win when Musetti double-faulted on match point. "Actually, when I had that

down-the-line passing shot, I pointed to her and asked her whether it was okay," he added. "She said, 'yeah, it was fine'. If Serena says it was fine, then it was amazing by everyone else's standards." Next up for fourth-seeded Novak Djokovic

Turkiye, US want to lift defense industry restrictions after talks

Ties between the US and Turkiye have drifted away from a strategic partnership in recent years as disagreements between the two long-standing treaty allies have widened

ANKARA/WASHINGTON: Turkiye and the United States want to remove obstacles to defense industry cooperation, a Turkish Foreign Ministry source said on Wednesday, after talks between the NATO allies' top diplomats in Washington. On Tuesday, Turkish Foreign Minister Hakan Fidan kicked off a two-day visit to Washington, where he was expected to ask Secretary of State Marco Rubio and other US officials to remove US sanctions on Turkive and allow it back into a crucial fighter jet program. The visit comes as Ankara seeks warmer ties with Washington under the administration of President Donald Trump and just days after a phone call between Trump and Turkish President Tayyip Erdogan that a top Trump aide described as "transformational." The top Turkish diplomat's visit also comes at a critical time for Erdogan, after his main political rival and Istanbul's mayor, Ekrem Imamoglu, was jailed pending trial on

anti-government protests in over a decade. Ties between the US and Turkiye have drifted away from a strategic partnership in recent years as disagreements between the two long-standing treaty allies have widened. The administration of former President Joe Biden kept Turkiye at arm's length over what it saw as the fellow NATO member's close ties with Russia. Under Trump, who views Moscow much more favorably, Ankara is hoping for a warmer relationship with Washington. It also plans to capitalize on the personal ties between the two leaders. During the meeting between Fidan and Rubio on Tuesday, both sides "clearly put forth their political will to lift obstacles to cooperation in the defense industry field," the source said, adding they also followed up on matters discussed between Trump and Erdogan. 'Technical talks will be held for the resolution of existing problems," the person added, without elaborating. During his first term, Trump initially

ignored advice from his aides to impose sanctions on Turkiye under its Countering America's Adversaries Through Sanctions Act (CAATSA) over Ankara's acquisition of Russian S-400 air defense missile systems in 2019. He then took the step in 2020. That acquisition also led to Turkiye's removal from the F-35 jet program, where it was a manufacturer and buyer. Ankara says its removal is unjust and illegal, and has demanded to rejoin or be reimbursed for its investment in the program. Conversations between the allies on how to resolve the S-400 deadlock were ongoing under Biden. Turkive had pledged to keep the systems non-operational, a source familiar with the discussions said, but a breakthrough never came. A Turkish official, requesting anonymity, told Reuters ahead of Fidan's visit that Ankara was aiming to agree with Washington that keeping the S-400s non-operational can be enough to resolve the matter. During the Biden era, the allies had settled

into a new phase of relations. with a more transactional focus rather than based on shared values, as differences over policies on Syria, the war in Gaza, and judicial matters persisted. Since coming back into office on January 20, Trump upended Biden's policy to isolate Moscow and provide unwavering support to Kyiv and instead focused on ending Russia's war in Ukraine. His shift spooked European leaders who feared Washington could be turning its back to Europe and bolstered Ankara's role as a potential partner in reshaping European security. The Turkish official said discussions between Washington and Ankara had "taken a new dimension" after Trump's shift in approach to Moscow.

"If US sanctions on Russia are to be lifted, it becomes illogical for CAATSA to be implemented on third countries. As much as this issue is about Turkiye-USA ties, it is also about Turkiye-Russia ties," the official added. Sources familiar with the matter said the phone call between Erdogan and Trump may bring positive momentum to conversations in coming days, though no promises were made. "The president had a great conversation with Erdogan a couple of days ago. Really transformational, I would describe it," Trump's special envoy for the Middle East Steve Witkoff said in an interview with right-wing podcaster Tucker Carlson. Exclusion from the F-35 program pushed Turkiye to purchase 40 Lockheed Martin Block-70 F-16 fighter jets. However, despite agreeing on the procurement, there has been little progress on the acquisition for months. The Turkish source said Fidan and Rubio also discussed head of state-level visits to be held in the coming period, without elaborating.

The two also emphasized the importance of stability in Syria and in the Balkans, while discussing efforts to end the Russia-Ukraine war, and the need for a ceasefire in Gaza, the source added.-Agencies

Ramadan, a month of fasting and worship for Muslims from sunrise to sunset, is set to conclude at the weekend. The last 10 days of the holy month are a time when some Muslims dedicate themselves to worship. The Jerusalem Waqf and Al-Aqsa Mosque Affairs Department, which is responsible for administering the site, said that most of the 100,000 worshippers were residents of Jerusalem and Palestinian citizens of Israel. However, thousands of Palestinians from various cities and towns in the occupied West Bank were prevented from entering Jerusalem due to Israeli military checkpoints. Restrictive measures have been implemented by Israel since the start of Ramadan and age and security screenings have played a part in determining whether access to the city is allowed. Upon the conclusion of Ramadan on Saturday or Sunday, majority-Muslim countries celebrate the holiday of Eid Al-Fitr over three days, marking the festivities of breaking the fast with family visits and trips.—APP

Turkive protesters fill streets, defving crackdown

ISTANBUL: Thousands of protesters returned to the streets of Istanbul on Tuesday after a week of the biggest protests to hit Türkiye in over a decade, defying a crackdown that has seen almost 1,500 arrested. The demonstrations erupted after the arrest of the mayor of Istanbul Ekrem Imamoglu, the main political rival of President Recep Tayyip Erdogan, in a move opposition supporters see as a blatant violation of the rule of law. The authorities have hit back with a crackdown that has alarmed rights groups, with seven journalists who covered the protests remanded in custody by an Istanbul court on Tuesday. Among them was AFP photographer Yasin Akgul, drawing a sharp rebuke from the Paris-based news agency. "His imprisonment is unacceptable. This is why I am asking you to intervene as quickly as possible to obtain the rapid release of our journalist,' the agency's CEO and chairman Fabrice Fries said in a letter to the Turkish presidency. The court charged Akgul, 35, and the others with "taking part in illegal rallies and marches," though Fries said Akgul was "not part of the protest" but only covering it as a journalist. Media freedom group Reporters Without Borders (RSF) denounced the decision as "scandalous," with its Türkiye representative Erol Onderoglu saying it "reflects a very serious situation in Turkiye."-APP

heads to China for first state visit

DHAKA: The head of Bangladesh's interim government, Muhammad Yunus, departed on Wednesday for China, where he will meet President Xi Jinping and also mark his first bilateral state visit since assuming the role of chief adviser, his office said. Yunus, Nobel Peace Prize laureate and economics professor, will address the Boao Forum for Asia in Hainan, southern China – an annual conference focusing on the changing role of Asia - from where he will travel to Beijing. His bilateral with Xi is scheduled for Friday, marking their first meeting since Yunus assumed office in August 2024. "The main focus of this visit is to boost economic cooperation ... We are expecting that a number of (memoranda of understanding) will be inked during this visit. The MoUs will cover mostly the areas of economic cooperation," Azad Majumder, Yunus' deputy press secretary, told Arab News. "One of the main focuses of discussion will be bringing more investments from China in our dedicated Chinese Economic Zone." Munshi Faiz Ahmad, Dhaka's former envoy to Beijing, said it was significant that Yunus was choosing China for his first state visit, especially as relations with another regional superpower, India, have soured since the change in government. India was a close ally of former Prime Minister Sheikh Hasina's government. She has also sought refuge in New Delhi after deadly protests that unseated her last year. Until now, India has not responded to Bangladesh's request to send her home for trial. The situation opens the door for China – India's key rival – to expand its footprint. "For our interim government, this China visit is very significant. It's the first bilateral visit to any country by Prof. Yunus as the chief adviser, Ahmad said. "It's an opportunity for Bangladesh to boost the relationship with China and explore new areas of cooperation It's an issue of mutual benefit for Bangladesh and China." Yunus' office said he will also seek Chinese investment in healthcare and the establishment of a large hospital in Bangladesh to reduce the trend of medical tourism abroad.-DNA

Bangladesh's Yunus Tesla to launch in Saudi Arabia next month

The upcoming launch of Tesla also aligns with Saudi Arabia's broader strategy to reduce its dependence on crude revenues.

RIYADH: US-based electric vehicle manufacturer Tesla will begin its operations in Saudi Arabia next month, the company has announced. Scheduled to launch on April 10 at the Bujairi Terrace in Riyadh, the EV maker - led by CEO Elon Musk- has been active in several countries in the Middle East but is yet to establish its presence in the Kingdom, the largest market in the Gulf region. The upcoming launch of Tesla also aligns with Saudi Arabia's broader strategy to reduce its dependence on crude revenues. The move is also expected to contribute to the Kingdom's sustainable journey, with the nation targeting to achieve net-zero emissions by 2060. "You and your family are warmly invited to our launch event at the Bujairi Terrace on April 10. Explore our global bestselling lineup and step into a world powered by solar energy, sustained by batteries, and driven by electric vehicles," the company said on its website. It added: Experience the future of autonomous driving with Cybercab, and meet Optimus, our humanoid robot, as we showcase what's next in AI (artificial intelligence) and robotics." The company did not disclose when these electric vehicles will be available for purchase in Saudi Arabia. Tesla's entry into the Kingdom comes at a tumultuous time for the company, as it is facing a decline in sales across various markets like Europe and the US. According to data from the European Automobile Manufacturers Association, Tesla has witnessed a 42.6 percent drop in sales on the continent in 2025, even as overall purchases of electric vehicles in the region continue to rise. In the US, widespread protests have been organized against Tesla in recent months, following Musk's appointment as the head of the Department of Government Efficiency under the Donald Trump administration. The Saudi government has actively promoted the EV industry to achieve economic diversification and sustainability. The Kingdom's Public Investment Fund is the majority investor in Lucid Group, a startup competing with Tesla in the global market. In January, Lucid Motors became the first global automotive company to join the Kingdom's "Made in Saudi" program. The milestone grants the firm the right to use the "Saudi Made" label on its products, representing the Kingdom's focus on quality and innovation. In September 2023, Lucid also launched its first manufacturing plant outside the US in the Kingdom, with an initial capacity to produce 5,000 electric cars in a year. Aside from investing in established companies, Saudi Arabia is pushing ahead with its own homegrown electric vehicle brand, Ceer. Announced in November 2022 by Saudi Arabia's Crown Prince Mohammed bin Salman, the company is expected to contribute SR30 billion (\$7.9 billion) to the Kingdom's gross domestic product by 2034. In February, during the Private Sector Forum organized by the Public Investment Fund, Ceer signed 11 deals worth SR5.5 billion ahead of its model launch in 2026.-DNA

This was conveyed during a session on 'Pakistan-Afghanistan Economic and Trade Ties' held at the Institute of Policy Studies (IPS), Islamabad. The session was addressed by Khalid Rahman, chairman, IPS, Ambassador (r) Syed Abrar Hussain, vice chairman IPS and Pakistan's former ambassador to Afghanistan, Ambassador (r) Ayaz Wazir, Pak-Afghan affairs expert, Brigadier (r) Said Nazir, senior analyst, Junaid Ismail Makda, president, Pakistan Afghanistan Joint Chamber of Com-

The speakers noted that challenges in Pakistan-Afghanistan trade relations are longstanding, largely due to political

changes, which continue to disrupt economic productivity. The key obstacle remains the repeated closure of trade routes, particularly at the Torkham border, which hampers transit trade and affects access to key international markets, including Europe. In addition, structural issues such as smuggling, limited infrastructure, banking and payment challenges, weak border management, poor implementa-



digital trade processing, absence of a transparent digital supervision system, and outdated trade regulations also hinder ease of doing business. These challenges, coupled with an unstable security environment, have led regional players like Central Asian states to explore alternative trade routes. The speakers highlighted that, on the one hand, it might seem to reduce Afghanistan's reliance on Pakistan, but, on the other hand, geographical limitations of alternative options like Iran's Chabahar Port would be less feasible, keeping Afghanistan's interest in trading with Pakistan intact. To address these challenges, experts emphasized the need to strengthen the Afghanistan-Pakistan Transit Trade Agreement (APTTA) by ensuring the rule of law, improving banking facilities, and revising trade regulations to facilitate smoother business operations. It was also suggested that a dedicated trade development policy should be introduced, along with a stakeholder-led management committee, to resolve minor trade issues promptly and

prevent unnecessary disruptions. Moreover, it was observed that the Torkham border, a key trade gateway, must be managed more effectively, with a focus on maintaining uninterrupted trade flows rather than using border closures as a tool. Engaging external partners and implementing cross-border tariff strategies can also enhance economic cooperation. To ensure the stability of long-term trade relations, the discussants suggested a comprehensive economic treaty between both countries is necessary, ensuring mutual benefits that remain unaffected by security concerns. Additionally, integrating local communities into trade discussions, strengthening digital supervision, and fostering collaboration with regional and international organizations can help sustain economic ties. In his concluding remarks, Khalid Rahman pointed out that while Pakistan declared a shift toward a geo-economic strategy in 2018, its implementation has

Journalist Waheed remanded for two days

ISLAMABAD: A judicial magistrate approved a twoday physical remand for senior journalist Waheed Murad on Wednesday and handed him over to the Federal Investigation Agency (FIA). Murad - taken into custody last night from his residence where his mother-in-law was also residing was presented before Magistrate Abbas Shah's court in Islamabad after being named in an FIA case related to spreading fake news. During the hearing, he took the rostrum, saying: "My mother-in-law is a cancer patient and has come from Canada for treatment." He further claimed, "I was handed over to them [FIA] just 20 minutes ago.

His defence counsel, Hadi Ali, requested access to the FIR, arguing that Murad was subjected to unlawful treatment. "Police broke into his house and even assaulted his mother-in-law," he alleged. Another defence lawyer, ImaanMazari, informed the court that a petition had already been filed against his alleged illegal detention. When questioned by the judge about the time of Murad's arrest, the FIA prosecutor confirmed that he was taken into custody last night. The prosecution argued that Murad had shared a post related to a banned organisation in Balochistan and that further investigation was required regarding his social media accounts. They also requested the recovery of his mobile phone.

BYC's Baloch challenges detention in SHC

KARACHI: Baloch Yakjehti Committee (BYC) leader Sammi Deen Baloch challenged her 30-day detention in the Sindh High Court (SHC) on Wednesday, a day after she was apprehended during a protest against the arrest of the movement's leadership in Balochistan. A two-member bench will hear the petition tomorrow, according to the petitioner's counsel. Karachi police, a day earlier, apprehended Sammi and several others for violating Section 144, using force to disperse their demonstration as the BYC pressed on with its protest. However, as soon as a judicial magistrate ordered her release, police attempted to rearrest her, leading to resistance from lawvers present at the court. Shortly after, they detained the Baloch leader from the court premises and shifted her to jail for 30 days under the MPO. According to the Sindh Home Department, the decision was made on the recommendation of Inspector General (IG) Sindh, citing security concerns.

Sanctions must be lifted before ceasefire: Russia

MOSCOW: Russia has said Western sanctions must be lifted before it begins a maritime ceasefire with Ukraine. Within hours of the US announcing the two sides had agreed to halt strikes in the Black Sea in separate deals, the Kremlin said it would only take place once sanctions on a number of Russian banks were lifted. The demands include revok ing sanctions on the state agricultural bank Rosselkhozbank and restoring the firms' access to the Swift interna tional payment system. Overnight, Moscow launched a drone attack on the port city of Mykolaiv, Ukrainian officials said, with President Volodymyr Zelensky saying the strikes were "a clear signal" Russia did not want peace. After Russia's full-scale invasion of Ukraine, the EU and its allies suspended access to Swift for a number of Russian financial institutions

Aurangzeb calls for inclusive approach to globalization

Aurangzeb warns that if inequalities persist, the gap between rich and poor nations will continue to widen

BEIJING: Finance Minister Muhammad Aurangzeb has emphasized the urgent need for an inclusive approach to globalization that benefits all nations, particularly the developing economies. He made this call while attending a high-level session titled 'Inclusive Globalization That Benefits All - Pathways and Actions' at the Boao Forum for Asia Annual Conference 2025 in China. Highlighting the growing inequalities within

the global economic system, the Minister said globalization has lifted over one billion people out of poverty but it still remains unequal, disproportionately benefiting developed economies while marginalizing the Global South. He said risks of rising protectionism, unilateralism, and trade wars are exacerbating global divisions, threatening to disrupt supply chains and weaken international cooperation. For globalization to

survive, it must be rebalanced to allow fairer participation for all nations, particularly those currently disadvantaged by restrictive trade rules and limited financial access. Muhammad Aurangzeb underscored that the time for rhetoric has passed and decisive action is needed. He said Pakistan advocates for a more balanced model of globalization that promotes fair trade, sustainable growth, and equitable financial systems. He said this model must be multilateral, innovation-driven, and inclusive to foster development and prosperity across all regions.

The Minister noted that the widening wealth and opportunity gap is one of the key challenges for inclusive globalization. He said the developed nations continue to gain from high-tech sectors, digital trade, and broad financial access, while developing nations are held back by high tariffs, restrictive investment policies, and limited infrastructure. Muhammad Aurangzeb highlighted that Pakistan has consistently

called for greater regional connectivity, fairer market access, and stronger multilateral cooperation. He said China-Pakistan Economic Corridor and the Special Investment Facilitation Council are significant steps in the right direction. The Minister also called for a global coalition among developing nations to collectively demand fairer trade rules and greater representation in international financial institutions. He said these alliances are necessary to combat the disproportionate tariffs and trade restrictions that hinder the integration of developing economies into global markets.

He pointed out that Pakistan's textile and agricultural sectors face significant challenges due to protectionist policies in developed countries and non-tariff barriers that limit their access to Western markets. Addressing the issue of financial inequality, the Minister stressed the need for debt relief and financial justice through restructuring sovereign debt mechanisms to prevent cyclical debt crises, which are impeding the economic growth of many emerging economies, including Pakistan.

He called for reforms in international financial institutions to offer developing economies greater financial flexibility and sustainable debt relief mechanisms.

Muhammad Aurangzeb emphasized the transformative potential of technology in bridging global disparities. He called on governments and international bodies to establish global AI and fintech funds to support digital inclusion in developing economies. Talking about the climate change, he said developing nations contribute less than ten percent of global carbon emissions yet suffer disproportionately from the consequences of climate disasters. He said Pakistan, despite contributing less than one percent of global carbon emissions, is one of the world's most climate-vulnerable countries. He said the devastating floods of 2022 inflicted 30 billion dollars in damages and displaced 33 million people. The Minister said Pakistan continues to advocate for urgent climate financing, green technology transfers, and fair global climate policies to support climate resilience in developing economies. He urged developed nations to fulfill their 100 billion dollars annual climate finance commitments and prioritize renewable energy cooperation to help emerging markets transition to low-carbon economies. He said carbon-intensive trade restrictions that penalize export-dependent economies in the Global South must be reduced. He also called for reforms in the global financial architecture, including the enhancement of Special Drawing Rights allocations and the promotion of green bonds and blended finance models to attract private-sector investment in emerging markets. The Minister reiterated that the future of globalization must be one of inclusivity, fairness, and shared prosperity.

FIA seeks access to **Armaghan's Bitcoin** trading platform

KARACHI: The FIA has sought the court's approval to access the Bitcoin trading platform used by Armaghan Qureshi, the prime accused in the Mustafa Amir murder case, in a money laundering case registered against him. During the hearing on Wednesday, the FIA requested the court to issue orders for obtaining account details from the platform, citing that the suspect had created accounts under the names of his two employees. The agency also urged the court to direct trading platforms to provide details of Armaghan's accounts, transactions, trading histo-

ry, and IP addresses. Meanwhile, the court sought information from foreign cryptocurrency trading companies regarding the case. Armaghan was booked in another case earlier; a FIR was filed alleging his involvement in money laundering and fraud. With the FIR registered on behalf of the government in the Anti-Money Laundering Circle, the FIA accused Armaghan of being involved in hawala-hundi, digital currency and other illegal activities.

24 dead in S. Korea's 'worst ever fires'

SEOUL: At least 24 people have been killed as multiple wildfires continue to ravage South Korea's south-east region. Most of the victims are in their 60s and 70s, authorities say, adding that some 26 people are injured with 12 in critical condition. More than 23,000 people have been forced to flee their homes. The "unprecedented" crisis is "rewriting the record books for the worst wildfires in our nation's history", acting pres dent Han Duck-soo has said. The fires gutted 1,300-year-old temple in Uiseong city, where many cultural relics were removed and transported to safer ground. The fires started in Sancheong county on Friday and later spread to Uiseong county. Fuelled by strong and dry winds, they spread to the neighbouring counties of Gyeongbuk, Uiseong, Andong, Cheong-Yeongyang song, Sancheong. - **Agencies**

Five sentenced to death for blasphemy by court

RAWALPINDI: A Rawalpindi court sentenced five men acof 100 years in prison, according to the court's orders issued on Tuesday. Per the copy of the first information report (FIR) the case was filed by the Federal Investigation Agency (FIA) under Sections 109 (punishment of abetment if the act abetted is committed in consequence and where no express provision is made for its punishment), 295A (deliberate and malicious acts intended to outrage religious feelings of any class by insulting its religion or religious beliefs), 295B (defiling, etc, of [a] copy of Holy Quran) and 295C (use of derogatory remarks, etc, in respect of the Holy Prophet) of the Pakistan Penal Code (PPC) and Section 11 (hate speech) of the Prevention of Electronic Crimes Act (Peca). The complainant submitted an application alleging that blasphemous content was being shared

A technical analysis of the phone's data confirmed that the alleged Facebook account had been logged into, showing multiple blasphemous images, which, according to the FIR, were a "clear attempt to hurt the religious sentiments of Muslims". Four other suspects were identified through the Facebook account, According to the court order, announced and issued on Tuesday by Rawalpindi Additional Sessions Judge Muhammad Tariq Ayub, the five accused were all sentenced to death under Section 295C, awarded life imprisonment under Section 295B, and awarded 10 years imprisonment and a fine of Rs100,000 under Section 295A.

US body urges sanctions against Pakistan, RAW

WASHINGTON: A US panel on religious freedom has said the treatment of minorities in Pakistan and India is deteriorating, and it recommended sanctions be imposed on the former's officials and government agencies and the latter's external spy agency over its alleged involvement in plots to assassinate Sikh separatists. The commission is a bipartisan US government advisory body that monitors religious freedom abroad and makes policy recommendations. The US Commission on International Religious Freedom (USCIRF) said, in its annual report, "In 2024, religious freedom conditions in Pakistan continued to deteriorate. Religious minority communities - particularly Christians, Hindus and Shia [Muslims] and [Ahmadis] continued to bear the brunt of persecution and prosecutions under Pakistan's strict blasphemy law and to suffer violence from both the police and mobs, while those responsible for such violence rarely faced legal consequences. Such conditions continued to contribute to a worsening religious and political climate of fear, intolerance, and violence." The report released on Tuesday pointed out that accusations of blasphemy and subsequent mob violence continued to severely impact religious minority communities in the country, as it listed several incidents in the last year. It also noted that "violent attacks and systematic harassment" against the Ahmadi community persisted throughout the year, resulting in four deaths in total. Another issue highlighted was the "worsening pattern of forced conversions" among the country's Christian and Hindu women and girls." The commission recommended that the US administration "impose targeted sanctions on Pakistani officials and government agencies responsible for severe violations of religious freedom" by freezing those individuals' assets and/or barring their entry into the US under human rights-related financial and visa authorities, citing specific religious freedom violations.

Journalist Farhan Mallick remanded to FIA custody Court grants FIA custody after journalist

linked to call centre fraud case

KARACHI: Journalist Farhan Mallick has been remanded to the Federal Investigation Agency's (FIA) custody for five days in a fraud case after being presented before Judicial Magistrate Malir-I. The journo was arrested in a new case on Tuesday instead of being sent into judicial remand as per court's orders in the first case registered against him last week. Mallick - who worked for a private news channel as its director news and now owns a YouTube channel - was taken into custody on March 20 for charges of spreading anti-state content. He was due to be remanded to judicial custody after the completion of a 4-day physical remand in the first case, yesterday. As per the latest development, the FIA claimed to have raided a call centre a day earlier, alleging that its employees were involved in stealing data from foreigners and defrauding them. Two suspects were arrested, who reportedly told authorities that the call centre was being operated under Mallick's orders.
