Massive cut in electricity rates unfurled

The prime minister unveiled the package, saying that the average per unit price for the domestic consumers had been brought down by Rs 7.41 and Rs 7.69 industrial sector; says government was taking structural reforms especially in power sector

ISLAMABAD: Prime Minister Shehbaz Sharif on Thursday announced a significant reduction in the electricity prices of up to Rs 7.69 per unit for the consumers, pledging to provide further relief in near future through structural reforms in the power sector. The prime minister, addressing a ceremony to unveil the package, said that the average per unit price for the domestic consumers had been brought down by Rs 7.41 and Rs 7.69 industrial sector. "In June 2024, the per unit price for industrial sector was Rs 58.5 which was first reduced by Rs 10.3 and further by Rs 7.69," he added. The prime minister pointed out that the government was taking structural reforms especially in power sector to ensure further relief for the consumers and overall development of the "This reduction will help industrialists to produce cheaper and more competitive products," he added. He noted that the common people had to suffer a lot in the the past due to high inflation rate and electricity bills.

PSX hits all-time high as PM slashes tariffs

KARAHCI: The capital market continued its bullish momentum on Thursday, surging to an all-time high amid strong investor sentiment driven by a major government relief package for electricity consumers and improving economic indicators. The Pakistan Stock Exchange's (PSX) benchmark KSE-100 Index rose by 1,131.37 points, or 0.96%, to finish at 118,938.11. The market touched an intraday high of 119,179.45, climbing 1,372.71 points, or 1.17%, from the previous close of 117,806.74. The day's low was recorded at 117,508.07. The rally was sparked by Prime Minister Shehbaz Sharif's announcement of a significant reduction in electricity tariffs for

in Islamabad attended by cabinet members, industrialists, and business leaders, the premier said domestic electricity rates had been slashed by Rs7.41 per unit, bringing the cost down to Rs34 per unit. Industrial users also saw a reduction of Rs7.59 per unit. The move comes as part of the government's broader strategy to boost economic productivity and ease inflationary pressures on households and businesses. The reduction in electricity prices follows a prior request submitted to the National Electric Power Regulatory Authority (Nepra), which was approved after consultation with the International Monetary Fund (IMF).

BAKU: The Republic of Azerbaijan welcomes the Opinion of the UN Human Rights Council Working Group on Arbitrary Detention, which was published on 13 March 2025, rejecting Armenian side's claims regarding the case of Ruben Vardanyan. In its Opinion, the Working Group explicitly rejected Armenian side's claims that Ruben Vardanyan was arrested for his freedom of expression and political activities. The aforementioned Opinion especially emphasizes that Ruben Vardanyan is accused by the Republic of Azerbaijan of committing crimes such as the death of numerous individuals, large-scale property destruction, financing of terrorism, establishment of illegal armed groups, and other crimes, and was detained on the basis of these charges. Furthermore, Armenian side's claims that Ruben Vardanyan was arrested for defending his rights and making statements in this context have been deemed baseless. The Opinion

of the Working Group states that freedoms of expression and association are not absolute rights and can be subject to restrictions, for reasons relating, in particular, to national security and public order. According to the Opinion the charges against R. Vardanyan allows to conclude that indeed his actions posed a threat to national security.

At the same time, in response to Armenian side's claims that actions allegedly invalidating R. Vardanyan's presumption of innocence were committed during the indictment and trial process, the Opinion states

WASHINGTON: US President Donald Trump ignited a potentially ruinous global trade war Wednesday as he slapped 10 percent tariffs on imports from around the world and harsh extra levies on key trading partners. Holding up a chart of the sweeping measures in the White House Rose Garden, Trump unveiled particularly stinging tariffs on major trade partners China and the European Union on what he called "Liberation Day." "This is one of the most important days, in my opinion, in American history," said Trump. "It's our declaration of economic independence." The announcement triggered immediate anger, with China warning the tariffs could "endanger" global economic development, US ally Australia blasting them as "not the act of a friend," and threats of retaliation from around the world. Stock markets looked set for major volatility Thursday, with Tokyo's Nikkei leading an Asian selloff, collapsing more than four percent. US futures plummeted and safe haven gold hit a new record as investors took fright. Trump reserved some of the heaviest blows for what he called "nations that treat us badly." That included an additional 34 percent on goods from superpower rival China - bringing the newly added tariff rate there to 54 percent.



Hundreds of subpar items destroyed during Ramazan in KP

PESHAWAR: The Khyber Pakhtunkhwa Food Safety and Halal Food Authority has released a report of its actions during Ramazan, revealing that hundreds of substandard and harmful food items were confiscated and destroyed across the province. According to the Food Authority report on Thursday, food authority teams conducted 10,112 inspections of food-related businesses throughout Khyber Pakhtunkhwa. During these inspections, a total of 112,595 kilograms of substandard and harmful food products were seized and disposed of. The highest number of inspections took place in Peshawar, where 1,682 checks were carried out, leading to the seizure and discarding of 31,242 kilograms of unsafe food items. In Mardan, 49,485 kilograms of substandard food were discarded following 883 inspections. Other districts with significant inspections included Bannu (593), Abbottabad (559), Swat (596), Mansehra (563), and Haripur (512). Additionally, 2,201 food samples, including milk, beverages, cooking oil, ghee, and spices, were tested in mobile food testing labs. Among these, 1,904 samples met safety standards, while 297 were declared substandard. As part of enforcement measures, 25 businesses were sealed, and fines totaling 15.75 million rupees were imposed for violations of hygiene and food safety regulations. The authority also renewed and issued 2,477 business licenses, generating 9.64 million rupees in revenue. Furthermore, 1,147 businesses received improvement notices and eight training sessions along with 155 awareness sessions were conducted during Ramazan. Khyber Pakhtunkhwa Minister for Food, Zahir Shah Toru, emphasized that the government is committed to eliminating substandard and hazardous food products from the province. He assured that strict action would be taken against those involved in selling unhealthy food, stating that public health will not be compromised under any circumstances.-DNA



Food allergy awareness crucial for public health

ISLAMABAD: A health expert Thursday stressed that food allergies necessitate an immediate attention, emphasizing the critical need for public awareness for timely, cost-effective treatment which are entirely curable if proper precautions are taken. "Neglecting it can have severe and potentially life-threatening consequences" Food Allergy Expert Dr Anwar ul Haq Roomi talking to a private news channel, explained food allergies can manifest at any stage of life, from early childhood to adulthood and occur when the immune system mistakenly identifies certain foods as harmful, triggering a defensive response. He further noted that food allergies can be inherited and alarmingly, adding, approximately 80% of food allergies manifest in children, making them significantly more prone to developing these allergies compared to adults and the elderly. He emphasized that in South Asian countries, including Pakistan, there is a growing need for holistic treatment approaches that not only address the physical aspects of food allergies but also provide rehabilitation and support for affected individuals. Dr Roomi highlighted that common food allergens in Pakistan include gluten, wheat, chicken and nuts which can trigger severe allergic reactions in sensitive individuals. He assured that the treatment for food allergies is not only effective but also cost-effective, making it accessible to a wider population in Pakistan. He emphasized the need for nationwide awareness programs to educate citizens about food allergies and their implications. Additionally, he stressed the importance of conducting more extensive research on food allergies specific to Pakistan, highlighting the need for a better understanding of the prevalence, causes and consequences of these allergies in the local population.-APP

ISLAMABAD: Pakistan's exports to the seven regional countries increased by 6.64 per cent in the first eight months of the current fiscal year (2024-25) compared to the corresponding months of last year. The country's exports to the regional countries including Afghanistan, China, Bangladesh, Sri Lanka, India, Nepal, and the Maldives account for a small amount of \$3.101 billion, which is 14.21 per cent of Pakistan's overall exports of \$21.820 billion during July-February (2024-25), State Bank of Pakistan (SBP) reported China tops the list of countries in terms of Pakistan's exports to its neighbouring, leaving behind other countries such as Afghanistan and Bangladesh. Pakistan carried out its border trade with farther neighbour Sri Lanka, India, Nepal, and Maldives.

Lanka, India, Nepal, and Maldives. Pakistan's exports to China witnessed a decrease of 10.54 per cent from \$1895.959 million last year to \$1695.941 million this year whereas exports to Afghanistan surged to \$592.840 million from \$321.754 million. The country's exports to Bangladesh also increased by 26.48 per cent to \$525.133 million this year from \$415.167 million whereas exports to Sri Lanka rose by 4.63 per cent to \$279.295 million from \$266.930. The exports to Nepal decreased to \$1,693 million from \$2.160 million in the previous year. Pakistan exports to Maldives increased by 2.15 per cent to

\$6.127 million from \$5.998 million while exports to India increased to \$0.404 million from \$0.230 million, it added. On the other hand, the imports from seven regional countries were recorded at \$10.462 billion during the period under review as compared to \$8.316 billion during last year, showing an increase of 25.79 per cent. The imports from China during July-February 2024-25 were recorded at \$10.188 billion against the \$8.094 billion during July- February 2023-24, showing an increase of 25.86 per cent. US anti-immigrant frenzy unsustainable

EXICAN border, the locus of much of the Trump administration's concerns about uncontrolled access to the US. But none of this materialized at the airport, which was relaxed and welcoming. The staff, including immigration officials, were drawn mostly from America's minorities, especially Hispanics and Asians, the same groups vilified by far-right opponents of immigration. The lines moved quickly and the passport screening process took about a minute per passenger, many of whom had flown from Mexican airports nearby. Countries are of course entitled to protect their borders. Immigration policies are usually discretionary, according to economic and security prerogatives. The US should be no exception, especially since it has suffered more than its share of illegal immigration: it is estimated that there are more than 11 million people living there without legal status, about 3 percent of the population. Some have committed heinous crimes in the US or were escaping the consequences of crimes they had committed in their home countries. However, the Trump administration has been criticized for how it is enforcing the law and the rhetoric employed to justify it. For example, it has targeted those holding political views at variance with the administration's, on the war in Gaza for example and the Palestinian issue in general. Many lawful residents have had their status revoked for expressing their views on these matters. Permanent residents, green card holders, were told that they could no longer stay in the US. Valid visas were revoked for students, faculty and researchers, and they were ordered to be deported for expressing their views. There has also been enforcement on ethnically selective grounds, targeting Hispanics, for example. The tactics have been frighteningly reminiscent of those employed by totalitarian or authoritarian regimes that have been roundly panned by the US as violations of the right to free expression and due process. Other states, especially those run by Democrats or with sizable immigrant or foreign-born populations, are also voicing objections to the federal overreach and accompanying xenophobia. The census showed that 50 percent of Texas and 49 percent of New Mexico's population are minorities, especially Hispanics. The District of Columbia and states such as Maryland also have sizable minority populations. Overall, more than 42 percent of the US population were minorities according to the 2020 census. Hispanics and Asians accounted for 60 percent of the minority population. Targeting students and faculty with opposing views has also been criticized by other states, especially those with large student populations. Massachusetts Rep. Stephen Lynch recently said: "Snatching an international student off our streets who is lawfully in our country and attending one of our universities and then bundling her off to an ICE detention center 1,700 miles away without a hearing is a sickening reminder of the Gestapolike conduct from another age." He added that his district had about 80,000 foreign students "precisely because we have a reputation as a center of learning and intellectual, religious, and cultural tolerance. HE re-election of Donald Trump as President of the United States marks a pivotal moment in the nation's history. Known for his aggressive style, disregard for diplomatic norms, and hardline stance on global issues, Trump's return signals a continuation of policies that prioritize confrontation over cooperation. His transactional approach, akin to running a corporation, risks undermining America's long-term interests. A superpower must go beyond profit-driven logic, embracing justice, understanding, and strategic patience to maintain global influence. During his first term, Trump disrupted global normspublicly criticizing allies, withdrawing from international agreements like the Paris Climate Accord, and engaging in feuds with world leaders. His re-election suggests that this approach was not an anomaly but a deliberate strategy. His early speeches and policies hint at doubling down on economic and military aggression, favoring ultimatums over diplomacy. Trump has threatened to escalate trade wars with punitive tariffs and confront adversaries like Iran through coercion rather than dialogue. While such tactics might secure shortterm concessions, they risk isolating the United States. Nations are not business subsidiaries that can be forced into compliance. Over time, this approach could erode trust, alienate allies, and embolden rivals, leaving the U.S. increasingly isolated.

A key aspect of Trump's leadership is his disregard for diplomatic etiquette. He prefers megaphone diplomacy—direct, abrasive, and often unfiltered. His off-the-cuff remarks about foreign leaders, dismissive attitude toward international institutions, and public shaming of allies disrupt long-standing relationships. While some view this as strength, it undermines alliances critical to U.S. hegemony. NATO, for instance, has endured for decades through mutual respect. Trump's rhetoric—such as threatening tariffs on Canada or demanding higher financial contributions from European allies—weakens the alliance and creates divisions within the West.

Trump's unpredictability sends a dangerous signal to adversaries. Iran, already in his crosshairs, may interpret his blunt threats as an incentive to escalate its own provocations. If Trump's aggressive style exacerbates tensions, the U.S. may struggle to rally international support in times of crisis. His rejection of diplomatic conventions weakens America's ability to lead, making it appear erratic and unreliable. His threats to impose higher tariffs illustrate this approach. During his first term, Trump imposed tariffs on China, Canada, and the European Union, framing them as necessary for American workers. Post-re-election, he hints at expanding this strategy. Similarly, his messaging to Iran suggests a continuation of the "maximum pressure" campaign through sanctions and military posturing. While such tactics might seem effective in the short run, they carry long-term risks. Tariffs disrupt global supply chains, raise consumer costs, and invite retaliation. China, for

example, responded to U.S. tariffs with its own, targeting American agricultural exports. A renewed trade war could strain an economy still recovering from inflation

and post-pandemic challenges. Geopolitically, a hardline stance risks alienating key allies. Canada, a major trade partner, could suffer under Trump's tariff threats. The U.S.-Canada economic relationship is deeply intertwined—Canadian oil powers American refineries, Canadian lumber supports U.S. construction, and manufacturing ties sustain both economies. Tariffs would damage this balance, disrupt supply chains, and create uncertainty. Canada's alienation could push it closer to economic alliances with China or the European Union, reducing U.S. influence.

Trump's reliance on business figures in his administration reinforces his transactional outlook. Figures like Elon Musk and corporate leaders reportedly shape his policies, reinforcing the belief that governance should function like a business. In business, relationships are often disposable, and short-term profits take precedence. In statecraft, however, long-term alliances and stability matter more than immediate gains. Running a state is not akin to running a corporation; a superpower's strength lies in enduring partnerships, international norms, and moral leadership.

Trump's tariff threats and Iran policy exemplify this businesslike mindset. Tariffs are bargaining chips, used to extract better trade terms, while his Iran strategy resembles a high-stakes negotiation rather than nuanced diplomacy. However, nations are not corporations. Iran, backed by resilient leadership and regional proxies, is unlikely to surrender under pressure alone. Tariff wars, meanwhile, could drive allies like Canada to seek closer ties with China, diminishing U.S. leverage.

A fundamental flaw in Trump's approach is the assumption that global relationships function like business deals-where dominance guarantees success. History suggests otherwise. Superpowers thrive by blending strength with diplomacy. The Marshall Plan, for instance, helped rebuild Europe after World War II, cementing U.S. influence. Trump's approach, prioritizing coercion over cooperation, risks squandering this legacy. His stance on Canada is particularly perplexing. Canada has long been a stable partner, sharing the world's longest undefended border and deep economic ties with the U.S. Yet, Trump has repeatedly treated Canada as a competitor rather than an ally. His tariff threats disregard the interdependence between the two nations. Canadian oil, minerals, and goods are essential to U.S. industries. Trade disruptions could damage American businesses, increase costs for consumers, and weaken cross-border cooperation on key issues like security and climate change. A superpower cannot afford to alienate its closest neighbors. Trump's approach risks turning Canada from an ally into a wary partner, reducing trust and cooperation on critical global issues. Economic ties alone do not define the U.S.-Canada relationshipshared values, strategic interests, and security cooperation are equally vital. If Trump continues treating allies as adversaries, he may weaken the very alliances that sustain American power. Trump's hardline approach is also evident in his Iran policy. His first term saw the U.S. withdraw from the Joint Comprehensive Plan of Action (JCPOA), reimpose harsh sanctions, and assassinate Iranian General Qassem Soleimani, escalating tensions. His second term promises more of the same, with blunt warnings to Iran about compliance with U.S. demands. However, history shows that sanctions alone do not topple regimes. Instead, they push adversaries to seek alternative alliances. Iran, for example, has strengthened ties with Russia and China, reducing the impact of U.S. pressure.

His aggressive tactics may deliver temporary victories-photo ops, trade concessions, or political gains. However, they do not guarantee long-term prosperity or security. The world is too interconnected, its challenges too multifaceted, for a superpower to rely on confrontation alone. The difference between business and statecraft is fundamental. Trump's leadership focuses on striking deals, but a nation must build enduring relationships. Where he sees dominance as success, a superpower must seek legitimacy. The U.S. now stands at a crossroads: it can follow Trump's path, risking isolation and decline, or reclaim its role as a leader based on justice, diplomacy, and mutual respect. Trump, Iran, and the Threat of War

UST weeks after declaring his desire to be remembered as a "peacemaker, not a warmonger," the U.S. President Donald Trump issued a shocking ultimaum to Iran: "If we don't make a deal, there will be bomb-'This threat, made during a phone interview and widely reported by global media in late March 2025, underscores the dramatic contradictions in Trump's foreign policy persona. He either fails to grasp the implications of his own statements and actions, or he is fully aware of what he is pledging-and of the stark contrast between his words and his ultimate intentions. His behavior has become increasingly predictable, forming a clear pattern: he keeps both allies and adversaries guessing-will he follow through on his commitments, reverse course entirely, or oscillate unpredictably between extremes before returning to square one? At the heart of this unfolding crisis is a familiar playbook reminiscent of the Trump doctrine: begin with provocative rhetoric, escalate tensions through threats of force, and use pressure to force opponents into negotiating so-called "better deals."

While this approach yielded mixed results in previous instances-such as with North Korea and China-it may prove far more dangerous with Iran. As a major regional power with strategic depth, proxy networks, and nuclear ambitions, Iran is not easily swayed by pressure tactics. Since late 2023, U.S.-Iran tensions have surged, with Tehran accused of backing over 150 proxy attacks on U.S. assets across Iraq, Syria, and the Red Sea corridor. Above all, unlike many secular governments, Iran operates under a deeply religious power structure. The Supreme Leader, Ayatollah Ali Khamenei, and his inner circle see themselves as accountable only to Allah. To them, divine will supersedes all worldly authority, including the United States. This makes them inherently resistant to coercive tactics. In Iran, the concept of jihad is not just warfare-it is a sacred duty. Fighting for justice, especially against what is perceived as tyranny or oppression, is seen as a moral obligation. Even in the face of overwhelming firepower, the regime believes that sacrifice will not only be rewarded in this world but also in the hereafter. Thus, threats of bombing do not intimidate them; they fortify their resolve. During the U.S.-Iran confrontations, Washington relied heavily on a robust network of allies—Europe, Canada, and the Middle East. Today, those alliances are eroding. Trump's confrontational style has alienated traditional partners. The EU is investing in independent security frameworks. Canada has distanced itself from U.S. foreign policy. Even once-loyal Gulf states are hedging their bets.

The cost of full-scale U.S. war with Iran without allied support could initially reach \$300-500 billion, with long-term expenses-including veterans' care and reconstruction—pushing the total to \$1.5-2 trillion. The U.S. military losses could range from 5,000 to 10,000, while Iranian civilian deaths could exceed 250,000-500,000, alongside a potential refugee crisis displacing up to 10 million people. The war's duration could range from a few months (in a limited air and cyber campaign) to 5-10 vears in the event of a full invasion and occupation, with no guarantee of success and a high risk of repeating the mistakes of Iraq and Afghanistan. Recently, the United States escalated its military response against the Houthis, an Iran-backed proxy group, drawing sharp controversy reminiscent of past U.S. interventions-most notably Operation Desert Storm. Though initially hailed as a show of strength, Desert Storm not only failed but also followed by a series of diplomatic setbacks, including the deeply criticized deal with Iran to secure the release of American embassy hostages in 1981.

The current operation also revealed weaknesses in the U.S. decision-making structure after an unauthorized journalist was included in high-level strategic discussions, raising concerns about the integrity and competence of national security planning and drawing widespread criticism from both the media and defense analysts. The resulting perception of disarray within the U.S. leadership appeared to embolden the Houthis and Iran, who interpreted the confusion as divine validation—reinforcing their belief that their actions are sanctioned by Allah and that they are fighting a righteous cause. Beyond the geopolitical fallout, a military strike on

Iran could send economic shockwaves across the

globe. Iran controls access to the Strait of Hormuz, through which about 20% of the world's oil supply passes. A blockade or retaliation in this region could paralyze global trade. Commodity prices would skyrocket, inflation would surge, and recession could ripple across developed and developing nations alike. Ironically, the country most affected by such a crisis could be the United States itself, where energy markets, supply chains, and investor confidence are tightly interwoven with global stability. Trump's approach also assumes that opponents will act rationally in the way the U.S. understands rationality. But Iran's ideology-driven worldview does not conform to that model. In fact, the more it is cornered, the more defiant it becomes. Rather than saber-rattling, what's urgently needed is

a viable via media-a middle path that respects Iran's sovereignty while addressing global security concerns. This could include: lifting economic sanctions to encourage goodwill, recognizing Iran's government without trying to reshape its internal politics, reestablishing trade and diplomatic relations to create interdependencies and engaging multilaterally with Europe, Canada and other allies to form a unified diplomatic front. A policy based on respect, economic engagement, and mutual interest can shift Iran from a pariah state to a responsible member of the international community. When a nation becomes economically and diplomatically integrated into the global system, it is more likely to act in ways that preserve its prosperity rather than pursue confrontation. A war with Iran will not just be regional skirmish-it could spiral into a global crisis. It will strain already weakened alliances, damage America's standing, collapse economies, and create humanitarian disaster. No amount of military might can overcome the ideological conviction of a nation ready to sacrifice everything in the name of faith and sovereignty. Peace is not achieved through intimidation but through understanding, strategy, and respectful negotiation. Extending a hand of friendship, not the threat of bombing, is the only sustainable way forward.

Highlighting the structural reforms to be taken in power sector, the prime minister said the government will ensure halting power theft which was around Rs600 billion per year. Similarly, he said by establishing open market, the electricity tariffs will be further decreased. He said there was no option but to privatize or commercialize Power Distribution Companies (DISCOs) to reduce the burden of line losses and power theft on the national exchequer. "I have directed the team concerned to work diligently to implement reforms in the sector as soon as possible," he added. Appreciating the task force formed to finalize power reforms, the prime minister said the force worked really hard and through their innovative thoughts, they brought different options and managed to convince the IMF to reduce the power tariffs. Myanmar's junta chief arrives for Bangkok summit as quake toll surpasses 3,000

ta arrived in Bangkok on Thursday for a regional summit, as the death toll from his country's devastating earthquake passed 3,000. Min Aung Hlaing will join a BIMSTEC gathering -- the seven littoral nations of the Bay of Bengal -- where he will raise the response to Friday's 7.7-magnitude quake.

The junta chief arrived at Bangkok's plush Shangri-La hotel, the venue for Friday's summit, amid tight security, AFP journalists saw. Many nations have sent aid and teams of rescue workers to Myanmar since the quake, but heavily damaged infrastructure and patchy communications - as well as the country's rumbling

Myanmar has been engulfed in a brutal multi-sided conflict since 2021, when Min Aung Hlaing's military wrested power from the civilian government of Aung San Suu Kyi. Following reports of sporadic clashes even after the recent earthquake, the junta on Wednesday joined its opponents in calling a temporary halt to hostilities to allow relief to be delivered.

AFP journalists saw hectic scenes on Wednesday in the city of Sagaing - less than 15 kilometres (nine miles) from the epicentre - as hundreds of desperate people lined up for the distribution of emergency supplies. Roads leading to the city were packed with traffic on Thursday, many of

Search for Malaysia's missing MH370 suspended

KUALA Lumpur: The latest search for Malaysia Airlines flight MH370 has been suspended by maritime exploration firm Ocean Infinity as it is "not the season" Kuala Lumpur's transport minister said, more than a decade after the plane went missing. "They (Ocean Infinity) have stopped the operation for the time being, they will resume the search at the end of this year," Transport Minister Anthony Loke said in a voice recording sent to AFP on Thursday by his aide. Ocean Infinity, based in Britain and the United States, led an unsuccessful hunt in 2018, before agreeing to launch a new search this year. "Right now, it's not the season," Loke said in the recording, which was made during an event at Kuala Lumpur International Airport on Wednesday. The Boeing 777 carrying 239 people disappeared from radar screens on March 8, 2014, while en route from Kuala Lumpur to Beijing. the largest search in aviation history, the plane has not been found.-APP

Rupee sheds 40 paisa against US Dollar

ISLAMABAD: The Rupee on Thursday depreciated by 40 paisa against the US Dollar in the interbank trading and closed at Rs 280.56 against the previous day's closing of Rs 280.16. However, according to the Forex Association of Pakistan (FAP), the buying and selling rates of the dollar in the open market stood at Rs 280.40 and Rs 281.90, respectively. The price of the Euro increased by Rs5.62 to close at Rs 307.94 against the last day's closing of Rs 302.42, according to the State Bank of Pakistan (SBP). The Japanese yen went up by 04 paisa and closed at Rs 1.90, whereas an increase of Rs 5.68 was witnessed in the exchange rate of the British Pound, which was traded at Rs 368.64 as compared to the last day's closing of Rs 362.96. The exchange rates of the Emirates Dirham and the Saudi Riyal also increased by 11 and 09 pasia to close at Rs 76.38 and Rs 74.78 respectively.-APP

Belgium urged to end violations of asylumseekers' rights

LONDON: Amnesty International on Thursday condemned Belgium for denying asylum applications from thousands of people, "forcing them into homelessness." Amnesty accused the EU member of "discrimination against racialized single men," which has "impacted the lives, dignity and human rights of people seeking asylum."

It added: "To date, national and international courts have ordered the authorities in Belgium to provide reception more than 12,000 times. "Belgium has consistently refused to fully comply with the judgments, despite these being final and legally binding.' Amnesty interviewed people who have experienced homelessness while navigating Belgium's asylum system since 2021. Many said as well as being denied accommodation, access to healthcare is a major problem. Sayed, who traveled from Afghanistan, spent time in a squat in Brussels with other homeless migrants from October 2022 to 2023. "In the beginning it was good enough, there were toilets and showers, and some people brought food in the afternoon," he told Amnesty. "But slowly it was turned completely into a graveyard. Showers and toilets were broken, with the passage of time ... Pee was coming up to the place where you were sleeping." He said ordinary Belgians and local charities had been welcoming, but the state had not been. "People were feeling our pain, but not the authorities,'

he added.-_APP

Pakistan urges UNSC to act on attacks against Aid workers

UNITED NATIONS: Amid record high Killing of humanitarian personnel in conflict zones around the world, Pakistan has called on the UN Security Council to push for sanctions and legal action against violators. "Impunity must end," Ambassador Asim Iftikhar Ahmad, permanent representative of Pakistan to the UN, told the 15-member Council during a debate on Protection of Civilians in Armed Conflict. "Impunity is not merely a failure of justice - it is a license for repetition, he said, adding, "Timely, independent and impartial investigations must hold perpetrators accountable." In this regard, the Pakistani envoy urged the creation of a "global implementation dashboard" for that resolution - it should provide real-time public tracking of violations, investigations and their outcomes "for everyone to see and follow". The escalating attacks on humanitarian personnel are not just isolated incidents -"they reflect a growing disregard for international norms," Ambassador Asim said, adding that it is unacceptable that those who work to provide "dignity amidst

displacement" are met "not with gratitude, but with gunfire". According to the Aid Worker Security Database, 379 humanitarian personnel were killed in 2024, making it the deadliest year on record. While there are challenges in various situations such as Democratic Republic of Congo, Sudan, Haiti, Lebanon and Yemen, the Pakistani envoy said, nowhere is this crisis more evident than in Gaza, where 399 humanitarian workers, including 408 humanitarian workers, including 284 UN-RWA personnel, have been killed since the October 23 Israeli war in the enclave. "We are failing those who risk their lives and act as a lifeline to serve others." UNSC Resolution 2730, he said, unequivocally reaffirmed that humanitarian personnel must be protected in accordance with international law, underscoring that the promise of protection must be backed by action. Pakistan also supports the call for mandatory integration of safety provisions into all UN mission mandates, especially during peacekeeping drawdowns and transitions. Bureaucratic hurdles, and weaponization of humanitar-

"Let us ensure that the courage of humanitarian workers is matched by collective international resolve to protect them: This will be important to restore the credibility of this Council's decisions." Earlier, two senior UN officials appealed in the Security Council for an end to attacks against humanitarians and personnel working for the global organization. Joyce Msuya, Assistant Secretary-General with UN aid coordination office OCHA, and Gilles Michaud, head of the UN Department of Safety and Security (UNDSS) were speaking during a meeting on the protec-

tion of civilians in armed conflict. "Since we are here today to discuss the protection of aid workers, I must ask this Council: what are you going to do to help us find those answers and achieve justice - and avoid more killings?" While there is no shortage of robust international legal frameworks to protect humanitarian and UN personnel, she said political will to comply is lacking. Ms. Msuya noted that the vast majority of those killed, roughly 95 per cent, are local aid workers who are the cornerstone of relief efforts. "These colleagues deserve our highest respect. Yet, conduct harming our local staff rarely elicits reaction or makes the news," she remarked.

Humanitarians also face other challenges, such as the criminalization of their work. They are increasingly being detained, interrogated and accused of supporting terrorism simply for delivering aid to people in need. Aid organizations are also targets of disinformation and misinformation campaigns in places such as Haiti, the Occupied Palestinian Territory, and Yemen. Moreover,

funding shortfalls threaten to

make matters worse, forcing the humanitarian community to make impossible choices, Ms. Msuya underscored. She described the adoption of Resolution 2730 as an important step in the right direction, then made three requests to the Council and Member States at large. "First, act to ensure respect for international law and to protect humanitarian and UN workers," she said, listing tangible steps such as Security Council visits, fact-finding missions, or withholding of arms transfers. She also called for speaking out and condemning harm to UN and humanitarian personnel, including local staff, because "silence, inconsistency, and selective outrage only embolden perpetrators." Her final request was for accountability, highlighting the need to strengthen domestic and international legal frameworks to prosecute international crimes. "The Security Council should play a key role in pushing for accountability; for instance, by asking concerned governments to pursue justice and by following up with them," she suggested.-Agencies

tivities has cleared the skies over Indonesia's notoriously polluted capital, offering a respite for residents who throughout the year are regularly exposed to some of the world's most toxic air. The Jakarta metropolitan area - home to about 31 million people - recorded "good" and "moderate" air on Thursday afternoon, with an air quality index reading between 22 and 76, according to data released by the Ministry of Environment. The numbers showed a marked improvement for a city that regularly records above 100 AQI and "unhealthy" levels of PM 2.5, a measurement of particulate matter - solid and liquid particles suspended in the air that can be inhaled and cause respiratory diseases. 'These 'good' and 'moderate' levels of air quality are possibly due to a drop in public activities during Eid holidays, as there has been a marked decrease in transportation and industrial activities in the city," Edward Nixon Pakpahan, air quality protection and management director at the ministry, told Arab News. "We are working to keep the air quality index for Jakarta metropolitan area below 100." Jakarta residents have long complained about the health risks posed by persistent air pollution from heavy traffic, industrial emissions and coal-fired power plants, which have consistently placed Jakarta among the 10 most polluted cities globally. The streets of Jakarta and its satellite cities have been mostly empty since last weekend, after millions of people traveled back to their hometowns Eid holidays.-APP

"If you want to enter Greece illegally and are not entitled to asylum, we will do whatever we can to send you back where you came from," Prime Minister Kyriakos Mitsotakis said in parliament on Wednesday. "Smugglers and NGOs cooperating with them will not determine who enters our country," he said

ATHENS: Seven people, including two children, died and 23 others were rescued Thursday when an inflatable boat carrying migrants capsized off the Greek island of Lesbos, the coast guard said. The coast guard initially said four bodies had been discovered in the Aegean Sea but after a search by patrol boats, three others were found, a spokeswoman told AFP The boat was carrying about 30 people and capsized in mild weather a short distance from the coast of neighbouring Turkey. "Their boat took on water and started to sink," the spokeswoman said, adding that searches for any other survivors were ongoing. Among the dead were four women, a boy and a girl, the coast guard said. No details have been released about the three others, including their country of origin. Greece's location in the far southeast of Europe in the eastern Mediterranean Sea makes its islands a common passage for undocumented migrants from Asia and the Middle East trying to reach western Europe. Deaths are commonplace during the perilous crossing. The UN said nearly 2,500 people were reported to have died last year. Last month, Greek maritime police said one migrant died and 18 others were rescued after a smuggler abandoned them as they tried to cross from Turkey. According to the UN refugee agency, nearly 9,000 people have entered Greece since the start of the year, most of them by sea. There were over 54,000 entries in 2024, according to the agency's figures. Greece's conservative government has hardened the country's stance on migration. Libya crackdown forces aid groups to cease operations

TUNIS: Diplomats in Libya have said in a letter to authorities seen by news agency that several international humanitarian organizations were forced to suspend operations after threats by security services and forced resignations. In the letter, which was obtained by AFP on Wednesday, 17 mainly European ambassadors and a UN official accuse the Internal Security Agency (ISA) of an "ongoing crackdown" on non-governmental groups and humanitarian aid workers In war-torn Libya split between two rival administrations, the ISA reports to the interior ministry in the capital

Tripoli, seat of the UN-recognized government. "Between March 13 and 27, the ISA summoned at least 18 staff members from six international NGOs for questioning," said the letter addressed to the Tripoli-based foreign ministry. ISA agents "seized some of their passports," forced them to 'resign from their positions" and pledge in writing never to work for an international NGO again, the letter added. It also said the security service "sealed some of their offices." Beyond the six groups directly affected, the diplomats said that "many other organizations are suspending activities as a matter of precaution." AFP was not able to independently verify the claims made in the letter, dated March 27. The authorities in Tripoli did not immediately comment on the matter, but announced a press conference later on Wednesday to address "the work of international NGOs." Libya has struggled to recover from the chaos that followed the 2011 NATO-backed uprising that overthrew longtime dictator Muammar Qaddafi. It remains split between the UN-recognized government in Tripoli and a rival authority in the east, backed by military strongman Khalifa Haftar. The diplomats' letter does not name the organizations affected by the ISA's alleged measures, but a source familiar with the issue said on condition of anonymity that they include

the International Rescue Committee, the International Medical Corps and the Danish Refugee Council. Contacted by AFP, the Danish Refugee Council said it "could not comment" on the matter. There was no immediate comment from the other groups. The source said that some foreign NGO staff members had been ordered to leave Libya, while others had been barred from returning after recent trips abroad. The source mentioned that the authorities had already imposed visa restrictions on foreign humanitarian workers between July 2022 and December 2023, but operations had continued using local staff or individuals who did not re-

quire visas. In their letter, the diplomats from the European Union, France, Britain and other countries as well as a top UN humanitarian representative voiced concern about the impact of the measures. The crackdown including detention and questioning of staff members has had a "particularly alarming" effect "on the provision of humanitarian primary health assistance," the letter said. It urged authorities to allow the NGOs to "reopen their offices and safely restart humanitarian operations as soon as possible." It also demanded that seized passports be returned to staff members, and "any resigna-

tion letters or pledges signed

at the ISA office" invalidated.

Unexploded munitions a threat to Gaza children

JERUSALEM: War has left Gaza littered with unexploded bombs that will take years to clear, with children drawn to metal casings maimed or even killed when they try to pick them up, a demining expert said.

Nicholas Orr, a former UK military deminer, told AFP after a mission to the war-battered Palestinian territory that "we're losing two people a day to UXO (unexploded ordnance) at the moment." According to Orr, most of the casualties are children out of school desperate for something to do, searching through the rubble of bombed-out buildings sometimes for lack of better playthings.

"They're bored, they're running around, they find something curious, they play with it, and that's the end," he said. Among the victims was 15-year-old Ahmed Azzam, who lost his leg to an explosive left in the rubble as he returned to his home in the southern city of Rafah after months of displacement. - APP



PPP won't construct Cholistan Canal: CM

announce the termination of the Marot Canal project

KARACHI: As the Cholistan Canal project becomes a matter of contention between the federal and provincial governments, Sindh Chief Minister Syed Murad Ali Shah on Thursday said that the PPP won't allow the Centre to proceed with the construction without the province's consent. Firmly opposing the proposed construction of the Marot Canal before the media in Garhi Khuda Bakhsh, Shah stated: "How can the canal be constructed when it hasn't even received approval?" He stated that as long as the PPP existed, the canal would not be built. He lamented that some political parties, instead of opposing the canals, have taken to the streets to protest against the PPP. Shah was accompanied by provincial ministers Saeed Ghani and Nasir Hussain Shah. It may be noted that the Marot Canal is a proposed irrigation canal designed to extend from the Sulemanki Barrage on the Sutlej River to Fort Abbas in the Cholistan Desert. Shah clarified that in July, only preliminary profiling covering a few hundred feet was conducted, which does not equate to the commencement of construction. He criticised certain news channels for spreading misinformation regarding the canal project and urged them to report responsibly. Highlighting the Bilawal Bhutto-led party's commitment to Sindh's interests, the chief minister asserted that the party is prepared to make

Shah calls upon PM to promptly any sacrifice to protect the province's rights. He recalled past allegations against the PPP, including that former premier Benazir funds for the controversial Kalabagh Dam, which were proven unfounded. Murad Shah emphasised the necessity of consulting provinces on water-related issues, as mandated by the constitution. He revealed that despite multiple requests for a Council of Common Interests (CCI) meeting to discuss the canal project, no response

had been received from the federal government. "They cannot evade this issue; the constitution requires provincial consultation on water matters." CM Murad said that the Indus River System Authority (IRSA) has approved Punjab's request for 0.8 million acre-feet (MAF) of water for the Cholistan Canal project, a decision that has generated strong opposition in Sindh, and his government has opposed it strongly. Murad noted that Punjab argues, based on historical data from 1976 to 2022, that an average of 27 MAF of water flows downstream to Kotri Barrage annually, while the officially required environmental flow is 8.5 MAF which he said should be 10 MAF. In contrast, Sindh maintains that at least 20.5 MAF is essential to prevent seawater intrusion and sustain the Indus Delta ecosystem. The chief minister added that with an existing national water shortage of 11 MAF and only 8 MAF currently reaching the Arabian Sea, Punjab claims that 7 MAF constitutes surplus water, justifying its demand. However, Sindh has raised concerns regarding the potential depletion of its water resources, warning that further diversions could exacerbate water shortages in its agricultural regions and endanger the fragile delta ecosystem.

Norwegian party faces backlash

Imran Khan nomination For noble peace prize

Critics accuse Norway's Partiet Sentrum party of "using a possible Peace Prize nomination to win votes"

THE Partiet Sentrum, a Norwegian political party, has come under fire for nominating former prime minister and Pakistan Tehreek-e-Insaf (PTI) founding chairman Imran Khan for the Nobel Peace Prize for services related to human rights and democracy – a move that has ignited a wave of criticism against the party in the Scandinavian country. The Norwegian party announced via social me-

dia that they, in collaboration with an unnamed individual possessing nomination rights, had put forward the name of the ousted premier, Anadoulu Agency reported. "We are pleased to announce on behalf of Partiet Sentrum that in alliance with somebody with the right to nominate, have nominated [Imran] Khan the former prime minister of Pakistan to the Nobel Peace Prize for his work with human rights and democracy in Pakistan," the party said on X. The Nobel Peace Prize is one of five Nobel Prizes established by the will of Swedish industrialist, inventor, and armaments manufacturer Alfred

Nobel, along with the prizes in Chemistry, Physics, Physiology or Medicine, and Literature. The prize aims to recognise and encourage efforts towards peace, international cooperation, and the reduction of conflict. Every year, the Norwegian Nobel Committee receives hundreds of nominations, after which they select the winner through a lengthy eight-month process. The nomination period for this year's prize concluded on

January 31, and the committee registered 338 candidates for the 2025 Peace Prize, of which 244 are individuals and 94 are organisations. However, the committee does not disclose the names of the nominators or nominees for the prize. The party refrained from disclosing the identity of the intermediary who facilitated the nomination, adding to the growing controversy. However, former PTI leader

Shabaz Gill also took to X to announce Khan's Nobel nomination. "Nobel For Khan! Thank you to the Centre Party, Norway @partiet_sentrum Geir Lippestad for keeping his promise from our Oslo meeting to support former PM [Imran] Khan's Nobel Peace Prize nomination. Grateful to him, Miss Samina T and party officials for their efforts," Gill wrote on X, along with two videos featuring his meeting with Geir Lippestad, the leader of Partiet Sentrum and the Khan's nomination announcement. for Nobel Peace Prize. The jailed founder of the PTI lost power following a no-confidence vote in April 2022 and has been incarcerated at Rawalpindi's Adiala jail since September 2023, owing to his legal woes comprising around 100 cases.

Pakistan records lowest inflation in 711 months

Headline inflation increased by 0.9% MoM in March, compared to 0.8% fall in February

KARACHI: Pakistan's Consumer Price Index (CPI) inflation has hit a historic low, with the reading dropping to 0.7% yearon-year in March 2025— the lowest in 711months since December 1965. The Consumer Price Index (CPI) inflation rose 0.7% year-on-year (YoY) in March 2025, down from 1.5% in the previous month and significantly lower than the 20.7% recorded in March 2024, according to the Pakistan Bureau of Statistics (PBS). The data suggests that CPI inflation increased by 0.9% monthon-month (MoM) in March 2025 compared to a 0.8% decrease in the previous month. "This is the lowest reading since December 1965, i.e. 59-year low, according (AHL) in a report. CPI inflation during 9MFY25 averaged 5.25% as compared to 27.06% in 9MFY24. Urban CPI inflation slowed to 1.2% year-on-year (YoY) in March 2025 from 1.8% in February 2025 and 21.9% in March 2024. The month-onmonth increase for urban CPI was 0.8% in March 2025, following a 0.7% decrease in the previous month. Policymakers will likely welcome the continued moderation of headline CPI inflation. The State Bank of Pakistan will need to balance the need to support economic growth to maintain price stability. In its meeting last month, the SBP decided to pause its rate cuts, maintaining the interest rate at 12%.
