## Imposition of US tariffs can have far-reaching effects

Said the recent discontinuation Global Undergraduate Exchange Programme between Pakistan and the United States marks the end of a fifteen-year engagement which has played a pivotal role in the academic and cultural enrichment of thousands of Pakistani students

ISLAMABAD: Pakistan says that considering the interconnected nature of global trade, the imposition of tariffs by the United States can have far-reaching effects, particularly on developing countries. At his weekly media briefing in Islamabad on Thursday, Foreign Office Spokesperson Shafqat Ali Khan said Pakistan hopes for a swift and mutually beneficial resolution of the issue. He mentioned that, as for the imposition of tariffs on Pakistan is concerned, he said Prime Minister Shehbaz Sharif has constituted a steering committee and a working group to examine the new tariffs. Replying to a question, the Spokesperson said the recent discontinuation Global Undergraduate Exchange Programme between Pakistan and the United States marks the end of a fifteen-year engagement which has played a pivotal role in the academic and cultural enrichment of thousands of Pakistani students. He said Pakistan believes that student exchange programmes play an important role in strengthening bilateral relations by focusing on education, scientific and technological collaborations and people-to-people contacts. Regarding the prevailing situation in Gaza, the Spokesperson reaffirmed Pakistan's full support for the upcoming high-level international conference on the peaceful settlement of the Palestine dispute and the implementation of a two-state solution, hoping that the moot would rise to the occasion and restore hope in peace and justice through meaningful action. He also lauded France and Saudi Arabia for co-chairing the preparatory consultations for the June 2025 Conference, Shafgat Ali Khan said Pakistan sincerely hopes that the June Conference

Video clips surfacing on social media soon after the incident showed a mob attacking the building in the DHAs Phase IV, known for housing outlets of different food chains.

## Afghan refugees being repatriated in dignified manner: Talal Chaudhry

Repatriated Afghan citizens can visit, work, and stay in Pakistan under one-document regime policy: minister

ISLAMABAD: Amid the ongoing countrywide drive against illegal foreigners and Afghan Citizen Card holders, Minister of State for Interior Talal Chaudhry on Thursday said that the Afghan citizens were being repatriated in a dignified manner. Addressing a press conference in Islamabad, Talal said that transit points were established in all the provinces to facilitate Afghan citizens, adding that a helpline was also set up for the citizens of the neighbouring country. He maintained that the repatriation of illegal foreign nationals, including Afghan Citizen Card holders, will continue with no extension to the deadline that expired last month. He said so far, 857,157 illegal foreign nationals and Afghan Citizen Card holders had been repatriated to their respective countries.

ISLAMABAD: The senior leadership of the Pakistan Tehreek-e-Insaf (PTI) is engaged in a verbal sparring over the matter of meeting the party's founding chairman, Imran Khan. Sources claimed that the list provided to Rawalpindi's Adiala jail officials did not include the names of PTI Chairman Barrister Gohar Ali Khan and Barrister Ali Zafar, but they both still met the party founder. Upon which, some senior PTI members have raised objections, The News reported. Barrister Gohar on

Wednesday voiced grave concerns regarding the usage of the term "manzoor-e-nazar"(favourite). Talking to journalists at the Parliament House, he stated that the PTI founder has faith in everyone and that Zafar is an honest person. "I express serious reservations about the word manzoor-e-nazar, but I want to unite the party even if I have to leave the position,"he emphasised. The leader of the opposition in the Senate, Senator Zafar then expressed regret over PTI Secretary General Salman Akram Raja's "allegations". Speaking to journalists outside the Islamabad High Court (IHC), the PTI legislator claimed that Raja's remarks about the meeting with the party's founder had sparked a fresh dispute. ## Ethiopia-Pak relations given new dimensions: Amb. Jemal

Ambassador of Ethiopia to Pakistan Jemal Beker Abdula gave an exclusive interview to CENTRELINE, Daily Islamabad POST and Diplomatic News Agency (DNA). Here are excerpts from his interview. Here is the Part-1 on of the interview

## Ansar Mahmood Bhatti

1: Could you share insights into your journey as a diplomat/politician and how it led you to your current role as the Ethiopian ambassador to Pakistan?

Let me say it with great humility that my deep passion for my country and diverse experiences has made my journey to becoming Ethiopia's Ambassador to Pakistan a fascinating and fulfilling one. It all began in 2003, fresh out of university, with a deep commitment to education. Those four years spent as an educator were truly formative, shaping my understanding of human potential and the power of knowledge. The classroom was my first diplomatic arena, where I honed my skills in communication, understanding diverse

perspectives, and fostering growth. But the call to serve my country on a larger scale motivated me to the foreign services in 2010. In a first, I joined the Ministry of Foreign Affairs of the Federal Democratic Republic of Ethiopia (FDRE) after getting six months diplomatic training, initiating my journey as



an International Organization Officer that further launched me into a dynamic path where I had both the honor and privilege of serving in various capacities from consular services and public diplomacy to the Director for Middle East. Each role presented unique challenges and opportunities, allowing me to develop a comprehensive understanding of



international relations.

My dedication and proactive approach didn't go unnoticed. Soon, I was entrusted with the crucial task of establishing Ethiopia's Embassy in Canberra, Australia, as Minister Counsellor for Economic Diplomacy. Laying the groundwork for a new diplomatic mission was incredibly rewarding. It demanded strategic thinking, resourcefulness, and a proper skill for building bridges between nations.

This experience stimulated a passion into me for pioneering new frontiers. So, when I was appointed State Minister of Innovation and Technology in 2018 upon returning from Australia, I got the chance to drive transformative change.

I along with my team spearheaded initiatives like technological solutions for agriculture, industry, office services, startups, and fintech, modernizing government operations and fostering a culture of innovation and creativity. Perhaps, this pioneering spirit led me to

KARACHI: The government will seek new expressions of interest (EoI) for the sale of PIA later this month, following the national carrier's first annual profit in over 20 years, a government adviser announced on Thursday. Efforts to privatize PIA were hindered by unresolved issues regarding taxation and the airline's balance sheet. Muhammad Ali, government adviser on privatization, stated that these issues have now been addressed. The new EoI is expected to be published by the end of April 2025, with plans to complete the privatization before the end of the year.

## **Tessori opens Air Asia flight** operation from Pakistan

KARACHI: Sindh Governor Kamran Khan Tessori inaugurated the flight operations of Malaysian private airline "Air Asia" from Pakistan. The formal flight operation will start from next month. A ceremony was held here at a local hotel on Thursday, where Malaysian Consul General in Karachi Herman Hardyanta Ahmad and the airline's CEO and other distinguished guests were in attendance. Addressing the ceremony, Governor Sindh said SIFC is a project that has also attracted Malaysian investment. Governor said bilateral relations between Pakistan and Malaysia would continue to flourish with passage of time. He expressed hope that with the start of Sir Asia operation, bilateral economic and cultural cooperation of both the countries will be strengthened. He said the President, Prime Minister, and the Chief of the Army were working day and night to improve the economy of the country. Governor assured his full support to the Malaysian private airline operation. Kamran Tessori said that the entire nation must stand together for the development of Pakistan. Governor said that the arrival of the private airline will give Karachi a prominent place on the global aviation map and this development is in line with the vision of the Government of Pakistan.—APP

### **KP** Police mull special team to counter terrorism: IGP

PESHAWAR: The Khyber Pakhtunkhwa (KP) Police has taken a step forward to counter terrorism by deciding to form a special police team dedicated to monitoring terrorist activities. Inspector General of Police (IGP), Zulfigar Hameed on Thursday announced the formation of a special unit, with rapid progress being made on the plan particularly in the southern districts of the province. To address the shortage of weapons, the force is procuring submachine guns (SMGs) and advanced weaponry, details of which kept undisclosed for security reasons. Additionally, nine Armored Personnel Carriers (APCs) are being added to the force to boost operational capabilities. -APP

### **KP CM** concerned over rising beggary announces crackdown

PESHAWAR: Chief Minister (CM) Khyber Pakhtunkhwa Ali Amin Gandapur has expressed grave concern over the growing menace of organized beggary in urban centers, calling it a threat to public order and dignity. In a high-level directive, the CM ordered immediate measures to regulate begging, curb exploitation by professional syndicates and rehabilitate vulnerable individuals forced into the practice. The provincial government will introduce the Khyber Pakhtunkhwa Vagrancy (Control and Rehabilitation) Act, a new law targeting exploitative begging rings that often use children, disabled persons, and drugged individuals for profit. A multi-departmental committee has been formed to draft the legislation within 30 days, while Divisional Commissioners will lead enforcement task forces to declare key public spaces as no-begging zones. Enhanced surveillance, including AI-powered facial recognition, CCTV monitoring, and geo-tagging of hotspots, will aid authorities in tracking offenders. For rehabilitation, the Social Welfare Department will expand shelters and partner with NGOs to provide vocational training, ensuring sustainable livelihoods for

rescued beggars.-APP

## WB's delegation visits Tarbela 5th extension Hydropower Project

ISLAMABAD:A 3-member delegation of World Bank. headed by its Regional Director for Infrastructure in South Asia Pankaj Gupta, visited under-construction 1530 MW-Tarbela 5th Extension Hydropower Project. The delegaof several key sites and witnessed ongoing construction activities. These sites included raised intake, tunnel, penstock and power house, said a press release. Earlier, Chairman WAPDA Engr Lt Gen Sajjad Ghani (Retd) welcoming the delegation. thanked World Bank for their support in harnessing the vital resources of water and hydropower in Pakistan.

He expressed the hope

between World Bank and WAPDA would further strengthen in the days to come.

During the on-site briefing, the GM/PD Tarbela 5th Extension Hydropower Project apprised the delegation that construction work on all seven key work fronts are progress-

Highlighting the milestones achieved so far on the Project, the delegation was briefed that excavations at raised intake shaft, penstock, power house and switch yard have been completed whereas concrete works at raised intake, power house, switch yard, tailrace culvert and canal are in progress. Draft tubes of all three generating units have been installed. Likewise, installation of

penstock pipes and electro-mechanical works at the switch yard are also in progress. Electricity generation from the Project is likely to commence in 2026. Tarbela 5th Extension Hydropower Project is a component of green, clean and least-cost energy generation plan of WAPDA. World Bank is tance amounting to US\$ 390 million for the Project. Under the 5th Extension, three generating units-510 MW each - are being installed at Tunnel No 5 of Tarbela Dam Project and to provide 1.347 billion units hydel electricity to the National Grid on the average every year. Installed capacity at Tarbela Dam will surge to 6418 MW after completion of Tarbela 5th Extension Project.

### **PTI's tenure** led to economic ruin, democracy erosion: Kiani

ISLAMABAD:State Minister for Railways Bilal Azhar Kiani on Thursday accused the previous PTI government of causing economic collapse and weakening democracy, as the country marks over three years since its removal from power On the third anniversary of former Prime Minister Imran Khan's removal through a no-confidence vote (April 10, 2022), state minister took to social media platform X to accuse the deposed premier of subverting democratic norms while alleging foreign involvement in his government's collapse. He said the National Assembly was unlawfully dissolved by the PTI through deceit. The same elements that stole former prime minister Nawaz Sharif's electoral mandate in 2018 went on to plunder the nation's wealth, pushed the economy to the verge of collapse.-APP

## Musadik urges high-polluting nations to buy carbon credits

ISLAMABAD: Federal Minister for Climate Change Dr. Musadik Masood Malik on Thursday called for climate justice, urging industrialized nations to take responsibility for their carbon emissions by purchasing carbon credits from climate-vulnerable countries like Pakistan.

Addressing a press conference, the minister asserted that Pakistan was no longer a weak nation but a respected one committed to climate action for future generations. Despite facing severe climate disasters, the country remains dedicated to sustainable development and a green economic transition. Dr. Malik criticized the global disparity in climate financing, revealing that 85% of green finance is

funneled to the U.S., China, and Western nations, while developing countries like Pakistan are pressured to pay additional taxes. "Pakistan is not begging for loans-we are seeking investment to build a green economy,' he declared, emphasizing the need for fair climate funding mechanisms. Under Prime Minister Shehbaz Sharif's directives, he said Pakistan has finalized regulations for its Green Climate Fund, which will soon be unveiled. The initiative, Musadik said, aims to boost green jobs, sustainable infrastructure, and renewable energy projects, aligning with the PM's appeal at COP 29 for global investors to support Pakistan's eco-friendly transition. The minister praised provincial initiatives contributing to climate resilience, including, Punjab's plans to install 250 water treatment plants and the Ravi Urban Development Authority's carbon credit schemes to combat pollution. Sindh's expansion of mangrove projects to enhance carbon trading and coastal protection and Margalla Hills' pilot carbon credit project to restore ecosystems damaged by climate change. To streamline green financing, Dr Malik said Pakistan is establishing a Carbon Exchange Company, positioning itself as a key player in global climate markets. "We welcome global partnerships to fight climate change while ensuring prosperity for our people," Dr. Malik stated, reinforcing Pakistan's commitment to climate justice and sustainable growth.

As per the PSL 2025 schedule announced by the Pakistan Cricket Board (PCB), matches will be played from February 8 to March 24, 2025, in Karachi, Lahore, Rawalpindi and Multan, with Rawalpindi hosting a significant number of matches, affecting Islamabad traffic due to close proximity. Due to the team movements, heightened security measures have been implemented at Expressway, Faizabad, Club Road, Murree Road, Faisal Avenue, 9th Avenue, and Srinagar Highway at various times of the day. ITP officials said traffic may slow down temporarily on Srinagar Highway and Expressway due to movement along designated routes. Citizens traveling to Blue Area have been advised to use the H-8 underpass, while those heading to sectors I and H should utilize Rawalpindi-Peshawar Road via the IGP check post and adjacent service roads. Murree Road from Serena Hotel to Faizabad via Rawal Dam will remain closed during team movements. Citizens should opt for service roads linked with Srinagar Highway. Traffic heading toward Red Zone and Serena Hotel should take Margalla Road, Express Chowk, Jinnah Avenue, Bari Imam and NAD-RA Chowk. Commuters can also use service roads from Islamabad Chowk to G-11 via Jinnah Avenue and Margalla Road. Heavy traffic will be prohibited from entering Islamabad during team arrivals and departures. Travelers from Bahara Kahu have been advised to use Korianwala Chowk and Highway.—APP

## China views pursuit of common prosperity as a key principle

ISLAMABAD: At a seminar hosted by the Institute of Regional Studies (IRS) titled "Analyzing China's Approach to 'Peace through Development' and the World's Response," Professor Gao Jian, a Senior Expert and Secretary General of Shanghai Academy of Global Governance and Area Studies at Shanghai International Studies University, provided an in-depth analysis of China's modernization model. Exploring its historical evolution, economic impact. and influence on the global order he noted that modernization narratives have historically been West-centric, shaped by European industrialization. However, China has emerged as a major global player, challenging traditional Western

frameworks and offers an alternative modernization model rooted in economic growth, political stability, and cultural heritage. Tracing China's moderniza-

tion efforts back to the 19th century, Professor Gao explained how Chinese intellectuals recognized modernization as essential for national survival, leading to various reform attempts. The turning point came in 1979, when Deng Xiaoping introduced social and economic reforms under the Open-Door Policy, setting China on its rapid trajectory of economic growth.

Over the past four decades, China has become the world's second-largest economy, and has surpassed USA in certain metrics. Professor Gao attributed this success to China's strategic economic policies, continuous learning, and prioritization of stability and prosperity, underlining that despite global discussions on economic decoupling and de-risking, China remains committed to further opening its economy to the world.

Addressing the core theme

of peace through development, Professor Gao emphasized that economic growth is central to modernization, while peace remains a fundamental aspiration in international relations. He argued that a successful modernization strategy, like China's, can contribute to global stability by fostering interdependence and cooperation.

Professor Gao also underscored that peace and development cannot be separated. China upholds "common prosperity" as not only a domestic principle but also an international value. "For lasting peace, it is essential to consider the interests of

all countries, irrespective of their size and status. Every nation should have access to economic development, which is why Chinese modernization focuses on sharing and opening doors wider", he noted.

Ambassador Jauhar Saleem, President IRS, in his remarks on the occasion, highlighted the need for inclusive economic growth and enhanced global engagement, emphasizing Pakistan's commitment to peaceful development and mutual prosperity. He credited China's rise as the world's largest trading nation and its success in lifting 800 million people out of poverty to policies focused on building economic cooperation. He also called for enhanced cooperation between nations for resolving international conflicts through peaceful dialogue, global governance reforms, multilateralism.



## US trade war against China

NSTEAD of retaliating, China should celebrate: US President Donald Trump's economic and tariff plans are making China great again. What Trump called "Liberation Day" – as he announced global import tariffs ranging from 10 per cent to as much as 34 per cent for China, 46 per cent for Vietnam and 49 per cent for Cambodia - House Minority Leader Hakeem Jeffries denounced as "recession day". Indeed, economists expect Trump's tariffs to accelerate inflation and dampen US economic growth, causing stagflation as prices remain painfully high. The stock market reacted sharply the day after the announcement, with trillions of dollars wiped out. Since then, the US' trade war with China has only escalated. After China raised its levies on US imports to 84 per cent in response to further tariff increases by the US, Trump raised the US tariff rate on China to 125 per cent and instituted a 90-day pause on steep "reciprocal" tariffs on non-retaliating countries such as Switzerland. The 10 per cent baseline tariff on all US imports stands. The US stock market remained volatile to the tit-for-tat tariff war between the two. This dramatic sell-off was driven by investor fears over the potential economic impact of the tariffs, which are expected to also disrupt global supply chains. As companies scramble to restructure their supply chains to mitigate the impact, American consumers rushed to buy cars and other goods before the new tariffs took effect. Dealerships reported a surge in sales, particularly for vehicles from manufacturers like Honda and Toyota. This rush highlighted the more immediate economic disruptions caused by Trump's trade policies. Since his first term, Trump has viewed the US trade relationship with China as unfair, and launched tariffs and export controls to address this perceived imbalance. Among the nations subject to the reciprocal tariffs announced on April 2, Trump singled out China as a major target. Trump also signed an executive order to eliminate the "de minimis" duty exemption for low-value parcels from China, effective from May 2. This means Chinese companies such as Shein and Temu will no longer be able to ship their low-value packages to the United States free of customs duties - the impact will be significant as Chinese companies ship over 1 million packages daily to the US. While Trump's tariffs and the elimination of the de minimis rule seem to harm China's economy, they also weaken the US position in global trade. Raising tariffs on so many countries across the globe, including US allies, only pushes them to strengthen their trade relationships. China's export-driven economy is especially sensitive to changes in international trade and Trump's tariffs are expected to strain China's economic growth. But China can leverage its membership in Brics - an alliance initially comprising Brazil, Russia, India, China and South Africa, and recently expanded to include several other economies - and the Regional Comprehensive Economic Partnership (RCEP), a 15-country freetrade agreement, to boost trade with other nations. Trump may have believed that raising tariffs on Chinese imports would force China to lower its import tariffs to appease the US, but this did not happen. Instead, China has retaliated.

## Le Pen ready to divide France

**7** OW to punish a corrupt politician while preventing democracy from being tarnished? And how to prevent an opportunist political party from instilling doubt in the justice system of a country, US-style? This is the test that is facing France due to the affair of its rising populist politician Marine Le Pen, who was found guilty of diverting EU funds to pay for her party's political staff, falsely claiming that they were working as assistants to its deputies in the European Parliament. Last week's court ruling in Paris led to the sentencing of Le Pen and 24 of her associates belonging to the National Rally party with a myriad of fines, prison terms and bans from campaigning, a ruling that landed like a bombshell in French political life. It was only normal for the party's leader and her allies to attack the ruling. It is in the far-right populist playbook everywhere in the democratic Western world to claim to be the victim of a political witch hunt. Some believe that Le Pen's sentence – she was barred from running for public office for five years, which means sitting on the sidelines in the 2027 French presidential election, which she stood a good chance of winning - was harsh and others believe it was appropriate. Nowhere has this divide been more visible and likely to spell more headaches for France as a country - than in the slogans at Sunday's demonstration organized in support of Le Pen. It was normal that Le Pen, though convicted by a court of law, would evoke decades of fighting injustice and state that she plans to continue to fight like her father, Jean-Marie, did before her. But symbolism could not be discarded when thousands of her supporters gathered in central Paris, near the golden dome of Les Invalides and the tomb of Napoleon. They tried to claim her martyrdom through what was billed as a protest, but one could not dismiss that it was mainly electioneering and a campaign rally. The choice of Les Invalides for the location of the demonstration pointed to a revolution in the making, or at least to the revolutionary mood among National Rally supporters. Louis XIV ordered the building of Les Invalides in recognition of the sacrifices made by the soldiers who fought in his wars. The location reflects some foundational periods in French history. It was the place from which a mob stormed the Bastille prison, using firearms and cannon they had looted from the Hotel des Invalides, during the French Revolution. Chants heard at the protest referred to Le Pen and her supporters' defiance. They voiced opposition to the "politically motivated" verdict, adding "Marine for president" and "they won't steal 2027 from us." This was reminiscent of the populist defiance of Trumpism and was aimed squarely at the French institutions as a whole. Jordan Bardella, Le Pen's 29-year-old protege, made a speech in which he accused France's judges of trying to silence the opposition and claimed that the date of the verdict was a dark day for France. In fact, it was the day of the protest that was a dark day for France, as more poignant than the allegations were the shirts bearing the slogan "Je suis Marine" (I am Marine) or comparing Le Pen's situation to that of US President Donald Trump, who, despite being found liable for civil fraud, was able to run for election. So, if Trump could run, why not Le Pen, they asked.

## Trump's 90-day tariff pause: A strategic recalibration?

N a surprising and dramatic policy reversal, President Donald Trump has announced a 90-day pause on his sweeping new tariffs for nearly every trading partner-except China. The move, announced just hours after the tariffs went into effect, sent markets soaring, calmed international anxiety, and opened a temporary window for diplomatic negotiations. But behind the scenes, this abrupt about-face reveals a complex interplay of economic realities, political pressures, and global trade dynamics that forced the president to back down from a central tenet of his economic ideology. The president's post on Truth Social-"a 90 DAY PAUSE"-marked a decisive pivot. While car, steel, and aluminum tariffs remain intact, the suspension of broader trade taxes sent the S&P 500 soaring over 9% in a single day, its best performance since the 2008 financial recovery. Tech stocks, airlines, and auto manufacturers all rallied sharply. Even companies still burdened by tariffs, like Ford and GM, saw significant gains.

In justifying his reversal, Trump said he acted on "instinct' and felt that markets and citizens alike were getting "yippy" and "a little bit afraid." His folksy language barely concealed the broader truth: the markets were plummeting, and with them, investor confidence in the administration's economic management. The president's change of course was likely motivated by a convergence of several powerful factors. The bond market had shown signs of panic, signaling fears of a looming recession. Meanwhile, the dollar wobbled against global currencies, further stoking anxiety. Perhaps most compellingly, spontaneous demonstrations against the tariffs erupted across the country-from New York to San Francisco-as thousands of Americans protested what they saw as an unjustified and reckless trade war that risked jobs, raised prices, and destabilized global partnerships. Economists and business leaders had warned for weeks that a prolonged tariff war would increase production costs, especially in key industries reliant on imported raw materials and components. American companies—particularly small- and medium-sized manufacturers-began sounding the alarm, saying they could not pivot supply chains overnight. Even powerful corporate allies of Trump began voicing discontent.

The president's isolation of China in this tariff pause also

underscores the deep geopolitical rivalry between the two economic superpowers. The decision to raise tariffs on all Chinese imports to 125% followed Beijing's retaliatory move of increasing levies on U.S. goods to 84%. Both sides have now entered a tit-for-tat escalation, further straining relations already tested by restrictions on technology firms.

China's Ministry of Commerce responded harshly, placing export controls on 12 American companies and designating six more as "unreliable entities"-effectively banning them from Chinese markets. Trump's team insists that the tariff approach is working, pointing to concessions from countries like Vietnam, Cambodia, and Ecuador, which have signaled willingness to reduce trade barriers and open markets to American products. Still, there is a growing debate over whether tariffs are the right mechanism to restore American industrial dominance. While the idea is to incentivize domestic production, there are challenges. For instance, the U.S. auto industry has struggled with quality and innovation, leading many consumers to prefer foreign-made vehicles known for their durability, fuel efficiency, and after-sales service. If the administration hopes to make tariffs a long-term policy tool, American industries will need to dramatically improve their competitiveness, not just rely on protectionism.

Trade barriers alone cannot revive domestic manufacturing unless paired with major investments in innovation, training, and infrastructure. History shows that protectionism, while politically appealing, can often stifle innovation by reducing competition. In today's fast-paced global economy, the U.S. must invest in research and development, automation, and green technologies if it wants to lead again. Beyond economics, international reaction has played a significant role in shaping the administration's response. Canada, a historically close ally, reacted with rare public fury. As one of the U.S.'s largest trading partners, Canada's retaliatory measures and national outrage rattled policymakers. The idea that America's most dependable neighbors were being punished indiscriminately undermined Trump's case for fair trade and weakened U.S. leadership on the world stage.

The pause also raises deeper concerns about governance. During a congressional hearing on Wednesday, the president's trade representative, Jamieson Greer, was caught off guard by the announcement. Lawmakers expressed frustration, with Rep. Steven Horsford of Nevada shouting, "This is amateur hour." The last-minute decision, made without consulting key officials or allies, raises questions about how trade policy is being formulated and whether it reflects a coherent long-term strategy or moment-to-moment reactions.

Meanwhile, Trump's broader policy direction continues to raise alarms. On the same day as the tariff pause, he reaffirmed plans to revive fossil fuel extraction and reopen coal mines, reversing years of environmental progress. Critics warn that such policies could trigger a global race toward dirty energy production, exacerbating climate change and harming public health. In light of these developments, it would be prudent for the administration to extend the spirit of the 90-day tariff pause to its energy agenda as well. Just as tariffs deserve reevaluation, so too does America's environmental policy. Rethinking coal and fossil fuel revival with the same urgency and pragmatism could prevent long-term damage to the planet and bolster America's standing as a responsible global leader. In the end, Trump's 90-day pause on tariffs is both a concession and an opportunity. It reflects the limits of unilateralism in a globally connected world and offers a chance to recalibrate.

The U.S. can use this moment not only to renegotiate fairer trade deals but also to reinvest in its own industrial base, green technology, and diplomatic alliances. Whether this pause leads to a sustainable strategy-or merely delays another storm-remains to be seen.

Bangladesh replace hosts Pakistan at the top of the standings

LAHORE: Skipper Nigar Sultanas brisk century, followed by five-wicket hauls by Fahima Khatun and Jannatul Ferdus, propelled Bangladesh to a resounding 178-run victory over Thailand in the third match of the ICC Womens Cricket World Cup Qualifier here at the Lahore City Cricket Association Ground on Thursday. Thailand captain Naruemol Chaiwais decision to bowl first backfired as Bangladesh registered a massive total of 271/3 in their allotted 50 overs, courtesy of a combined effort by their batting unit. The Asian side, however, had a contrasting start to their innings as they lost their opener Ishma Taniim (eight) in the fourth over with just 15 runs on the board. Following the early hiccup, Sharmin Akhter joined Fargana Haque in the middle and together 53 off 82 deliveries, laced with four boundaries. Akhter was then joined for a match-defining 152-run partnership for the third wicket with centurion Sultana, who perished on the final delivery of the innings. Akhter remained unbeaten on 94 off 126 deliveries with the help of 11 fours, while Sultana top-scored with 101 off just 80 balls, studded with 15 fours and a six. For Thailand, Phannita Maya, Thipatcha Putthawong and Onnicha Kamchomphu made one scalp apiece. Chasing a daunting 272-run target, Thailand were bowled out for a meagre 93 in 28.5 overs and thus succumbed to a gruelling 178-run defeat in their campaign opener. Openers Nattaya Boochatham and Chanida Sutthiruang gave Thailand a solid start by putting together 38 runs for the first wicket before Khatun dismissed the latter. Sutthiruang remained the top-scorer for Thailand with a 26-ball 22, comprised of four boundaries. Her dismissal sparked an astounding collapse which saw Thailand lose their remaining nine wickets for just 55 runs. become Ethiopia's First Ambassador to the Kingdom of Bahrain in 2020. Once again, I found myself building something new, strengthening ties, and fostering collaboration between the two nations. And now, I have the immense honor of serving as the first Ethiopian Ambassador to Pakistan-a nation I deeply admire, respect and love. For the last two and half years, I have been striving to cultivate a strong and long lasting partnership between our two countries, working day in and day out to foster understanding and establish cooperation. You could say, I have become something of an expert at establishing new missions, forging fresh connections and pioneering innovative approaches. I really thrive on the challenge of building something meaningful and lasting. And, now I am incredibly excited to embark on this new chapter in Kyrgyz Republic, and Turkmenistan where I have presented my credentials as a non-resident Ambassador of Ethiopia in December 2024, whereas the same honor I had in the Republic of Tajikistan in January 2025.

2: How would you describe the historical and current state of diplomatic relations between Ethiopia and Pakistan?

Historically, the FDR Ethiopia and the Islamic Republic of Pakistan are the two brotherly nations that share a lot of commonality. Ethiopia, the land of revered figures like Hazrat Bilal Habeshi and King Nejashei, holds a special place in Islamic history that fosters the affinity between the two countries. Bound by a deep sense of brotherhood, rooted in historical, cultural and religious connections, these two nations have developed a bond of mutual respect and understanding since establishing the formal diplomatic ties in 1958.

This connection went one step further with landmark visit of President Zulfikar Ali Bhutto to Ethiopia in 1972, which paved the way for enhanced collaboration and the establishment of Pakistan's Embassy in Addis Ababa a year later.

Over the decades, Ethiopia and Pakistan have consistently demonstrated their commitment to mutual support on the world stage. They have stood shoulder-to-shoulder in international forums, championing shared interests and pursuing collaborative initiatives that uplift their people and contribute to

global well-being. The dawn of a new era in Ethiopian foreign policy, ushered in by Prime Minister Dr. Abiy Ahmed in 2018, brought renewed focus to the relationship with Pakistan. Recognizing Pakistan's strategic significance, its unwavering support during challenging times, and its potential as a valuable partner, Ethiopia has actively sought to deepen ties. Pakistan, in turn, has long recognized Ethiopia's vital role in the Horn of Africa and African continent, a region rich in economic promise and natural resources. This recognition is embodied in Pakistan's "Look and Engage Africa Initiative," which identifies Ethiopia as a key gateway to the African continent. Today, the bilateral relationship between Ethiopia and Pakistan is flourishing. The opening of the Ethiopian Embassy in Islamabad is a manifestation of this deepening bond and has facilitated increased trade, investment, and people-to-people exchanges. The Ethiopian Airlines now connects Karachi and Addis Ababa with four weekly flights, fostering greater connectivity and facilitating business and tourism.

Furthermore, high-level delegations from both countries have exchanged visits, culminating in the signing of multiple Memoranda of Understanding in diverse sectors like trade, investment, science and technology. These agreements pave the way for enhanced cooperation and shared prosperity. As the world undergoes rapid transformation, Ethiopia and Pakistan are all set to elevate their relationship to a strategic partnership. By building on their historical ties and shared values, they have the potential to bolster bilateral, regional, and multilateral cooperation for the mutual benefit of their people and the international community.

3. What are the key areas where Ethiopia and Pakistan are collaborating economically? Are there untapped sectors with significant potential? Economic collaboration between Ethiopia and Pa-

kistan is gradually increasing, particularly since the establishment of the Ethiopian Embassy in Islamabad. This has facilitated numerous trade delegations and agreements, fostering partnerships in sectors like pharmaceuticals, surgical, agriculture, agro processing and textiles.

In the past two years, high-level delegations from both sides have explored avenues for collaboration in each other countries. A prime example is the

75-member Pakistani business delegation that visited Ethiopia in 2023, representing major chambers of commerce and prominent companies from all spheres and sectors of Pakistan. This visit resulted in the Islamabad Chamber of Commerce signing a crucial agreement with its Ethiopian counterpart, laying the groundwork for enhanced bilateral trade. Furthermore, leading Pakistani corporations like Arif Habib Group and Roshan Packages have also signed MoUs with the Ethiopian Investment Commission in 2023, pledging significant investments in key sectors such as fertilizer production, construction, and packaging.

The momentum continued with a reciprocal visit by a 50-member official and business delegation from the FDR Ethiopia in May 2023 which signed multiple agreements with the different business cham-

bers including Islamabad and Karachi. Likewise, we have facilitated an 80-member business and investment delegation from Pakistan to Ethiopia in 2024, which included representatives from the Trade Development Authority of Pakistan and various trade associations and companies. This visit yielded further agreements, with the Faisalabad and Sialkot Chambers, along with the Sundar Trade and Industry Association, signing MoUs with the Ethiopian Investment Commission. These agreements have opened doors for collaboration in diverse fields including agriculture, pharmaceuticals, surgical equipment, sports and leather goods. Current trade between the two countries includes pharmaceuticals, surgical supplies, agricultural products, textiles, and leather goods. However, both the nations need to recognize the vast untapped potential for growth. Ethiopia, for instance, imports a substantial portion of its pharmaceutical and surgical products, presenting a significant opportunity for Pakistani exporters. Conversely, Ethiopia's fertile lands offer Pakistan access to high-quality agricultural commodities like coffee, tea, pulses, soybeans, and oilseeds.

By capitalizing on these untapped opportunities and fostering a spirit of partnership, Ethiopia and Pakistan are set to reap significant mutual benefits and drive economic growth for both nations.

4: What measures are being taken to enhance trade volume between Ethiopia and Pakistan, and what products or industries

Ethiopia and Pakistan are actively pursuing a multi-pronged approach to bolster bilateral trade. Beyond the high-profile trade delegations and agreements, a concerted effort is underway to cultivate deeper economic ties. The Ethiopian Embassy in Islamabad has played a pivotal role to this end. Through targeted outreach, the embassy has engaged with chambers of commerce across Pakistan, from the Federation of Pakistan Chambers of Commerce & Industry to local chambers in key cities like Karachi, Lahore, Faisalabad, Sialkot, Multan, Gujranwala, Shekupura Rawalpindi and Islamabad. These engagements have included presentations and briefings highlighting the diverse investment opportunities in Ethiopia's burgeoning economy. I personally visited all those business chambers and addressed to the queries of the business community. Likewise, in 2024, the Embassy organized multiple business forums across Pakistan, coinciding with the second Pakistani trade delegation visit to Ethiopia. These forums provided a valuable platform for businesses from both countries to connect, explore partnerships, and gain insights into specific sectors ripe for collaboration. Formalizing this commitment, Ethiopia and Paki-

stan have also signed and ratified a bilateral trade agreement, providing a framework for enhanced trade and investment.

Further strengthening these ties, Ethiopian Airlines now offers direct flights to Pakistan, facilitating seamless travel for businesses and fostering people-to-people exchanges between Pakistan and Ethiopia and the rest of Africa. These combined efforts have successfully established institutional linkages between the two countries, leading to a regular exchange of delegations across various sectors. This momentum promises to unlock the immense potential for trade between Ethiopia and Pakistan. This year, Trade Development Authority of Pakistan along with Ministry of Commerce in Partnership with Ethiopian Embassy organizing the Single Country Exhibition in Addis Ababa, Ethiopia in between 15-17 May 2025 where many African countries join the forum to connect with the participants from Pakistan. In this regard, I kindly invite the interested companies to seize the availed opportunities.

The exchange rates of the Emirates Dirham and the Saudi Riyal decreased by 06 pasia each to close at Rs76.38 and Rs74.73, respectively.—APP

A total of 638,089,718 shares were traded during the day as compared to 448,693,567 shares the previous trading day, whereas the price of shares stood at Rs36.924 billion against Rs26.585 billion on the last trading day. As many as 451 companies transacted their shares in the stock market, 347 of them recorded gains and 63 sustained losses, whereas the share price of 41 companies remained unchanged. The three top trading companies were Cnergyico PK with 86,573,180 shares at Rs 8.52 per share, K-Electric Limited with 57,922,646 shares at Rs4.54 per share and Sui South Gas with 44,734,661 shares at Rs 39.13 per share. Rafhan Maize Products Company Limited witnessed a maximum increase of Rs 158.17 per share closing at Rs 8,999.00 whereas runner-up was Hoechst Pakistan Limited with Rs 144.31 rise in its share price to close at Rs 3,200.00. Nestle Pakistan Limited witnessed a maximum decrease of Rs 22.87 per share price, closing at Rs 7,183.48, whereas the runner-up was Is-Industries Limited with Rs 16.83 decline in its per share price to Rs 1,756.91.-APP

### US has hit more than 100 targets in Yemen since mid-March

WASHINGTON: The United States has struck more than 100 targets in Houthi-controlled areas of Yemen since beginning the latest phase of its air campaign against the Iran-backed militia last month, a US defense official said Wednesday. American forces have hammered the Houthis with near-daily air strikes since March 15 in a bid to end the threat they pose to civilian shipping and military vessels in the Red Sea and Gulf of Aden. "The US has hit more than 100 targets in Houthi-controlled parts of Yemen," the defense official said in response to a question on the number of American strikes since mid-March. "We have destroyed command and control facilities, weapons manufacturing facilities, and advanced weapons storage locations," said the official, who spoke on condition of anonymity. Despite the strikes, the Houthis - who control large swathes of Yemen and have been at war with the internationally recognized government since 2015 - have continued to claim attacks against both US vessels and Israel. The militants began targeting shipping in late 2023, claiming solidarity with Palestinians in the Gaza Strip, which has been devastated by a military campaign launched by Israel after a shock Hamas attack in October of that year.-APP

### Egypt's annual inflation rises to 13.1% in March

RIYADH: Egypt's annual

inflation rate rose to 13.1

percent in March, up from

12.5 percent in the previous month, according to the latest official data. The monthly consumer price index also increased by 1.5 percent compared to February, reaching 250.6 points, Egypt's Central Agency for Public Mobilization and Statistics reported. Higher prices in key food categories including fruits, vegetables, and meat, drove the change, with some items double-digit experiencing vear-on-year surges. data indicates continued inflationary pressures across essential sectors, affecting households nationwide. The increase comes as Egypt continues to contend with the effects of currency devaluations, subsidy reforms, and global food and fuel price shocks. The CAPMAS report revealed that the food and beverage division was the primary contributor to the March inflation increase, with year-on-year prices for fruits soaring by 76.7 percent and vegetables climbing by 6.6 percent. Meat and poultry rose by 6.2 percent, while the price of cereals and bread jumped 8.1 percent compared to March last year. Across North Africa, inflation trends remain mixed as neighboring economies contend with varying degrees of price pressures. Algeria's annual inflation rate rose to 4.7 percent in January, its highest since October, according to data platform Trading Economics. Morocco saw a sharper increase to 2.6 percent in February from 2 percent, while Tunisia's rate edged up to 5.9 percent in March from 5.7 percent, driven by higher food, clothing, and household costs. Sudan, still grappling with hyperinflation, saw a slight easing to 142.34 percent in February from 145.14 percent, though it remains among the world's highest. In Egypt, notable annual increases were recorded in the clothing and footwear segment, which rose 18.3 percent, driven by a 22.9 percent spike in shoes and a 19.4 percent rise in ready-made garments. Housing and utility costs also advanced, registering a 17.4 percent

## UAE to develop Indonesia's new 100 MW floating solar power plant

JAKARTA: Indonesia has signed an agreement with the UAE to develop a 100 MW floating solar pow-er plant in West Java, its second collaboration with Emirati giant Masdar after the Cirata project - Southeast Asia's largest floating photovoltaic installation. The project was announced by Indonesian President Prabowo Subianto's office following his meeting with **UAE President Mohammed** bin Zayed in Abu Dhabi on Wednesday. Masdar will help Indonesia's state utility company PLN to build a solar power infrastructure on West Java's Jatigede reservoir, more than 200 km east of the capital Jakarta. "Indonesia and the UAE, we have such close and friendly relations ... Masdar is also one of the best com-

it comes to renewable energy," Husin Bagis, Indonesia's ambassador to the UAE, told Arab News on Thursday. The project will be Masdar's second floating solar plant, after the 145 MW Cirata Floating Solar Photovoltaic Plant on a reservoir, also in West Java. It was inaugurated in November 2023 by then President Joko Widodo and cost \$100 million. Aside from being the biggest in Southeast Asia, the Cirata plant, which can power around 50,000 households, is the third-largest floating solar plant in the world. During Subianto's Abu Dhabi visit. Indonesia and the UAE also agreed to increase the capacity of the Cirata solar power plant. "UAE is looking for joint ventures in Indonesia ... There have been talks of more renewable energy projects in

## **Draft amendments** to streamline the public offering regime

ISLAMABAD: The Securities and Exchange Commission of Pakistan (SECP) on Thursday issued draft amendments to the Public Offering Regulations, 2017 and Public Offering (Regulated Securities Activities Licensing) Regulations, 2017, for initiating a final round of public consultation. The regulations provide key framework governing public offer of shares, debt securities and units of REIT Schemes, said a news release. The notification of the draft amendments follows an extensive SECP driven consultation process including multiple sessions with key stakeholders, including Pakistan Stock Exchange (PSX), Central Depository Company (CDC), National Clearing Company of Pakistan Limited (NCCPL), listed issuers, consultants, securities brokers, banks, DFIs, potential IPO companies, REIT Management Companies, shariah advisors, credit rating companies, Pakistan Stock Broker Association and MUFAP.-APP

gional bloc committed on Thursday "to not impose any retaliatory measures" against the United States over sweeping tariffs and said they were ready to engage in talks. ASEAN, being the fifth largest economy in the world, is deeply concerned over the recent introduction of unilateral tariffs by the U.S., including the tariffs announced on 2 April 2025 and subsequently the most recent suspension on 9 April 2025," the Association of Southeast Asian ministers said in a statement issued after a video conference meeting. Despite their concern, the ministers said they were ready "to engage in a frank and constructive dialogue with the U.S. to address trade-related concerns". "Open communication and collaboration will be crucial to ensuring a balanced and sustainable relationship. In that spirit, ASEAN commits to not impose any retaliatory measures in response to the U.S. tariffs," they said. The special meeting was chaired by Malaysia's Minister of Investment, Trade and Industry Tengku Zafrul Aziz. Malaysia holds the rotating chair of the 10-member regional bloc. Its members, which count on the United States as their main export market, were among those hit with the toughest levies by US President Donald Trump. Manufacturing powerhouse Vietnam was hit with a 46 percent tariff on exports to the United States while neighbouring Cambodia - a major producer of low-cost clothing for big Western brands - was slapped with a 49 percent duty. The other ASEAN members hit with hefty tariffs are Laos (48 percent), Myanmar (44 percent), Thailand (36 percent) and Indonesia (32 percent). Malaysia, Southeast Asia's third-largest economy, was hit with a lower tariff of 24 percent. Brunei also faces a 24 percent tariff, while the Philippines was hit with 17 percent and Singapore 10 percent.-APP

## Rebels in Indonesia's Papua kill 17 people disguised as soldiers JAKARTA: Rebels in Indonesia's Papua region said on Thurs-

day they have killed more than 17 people since the weekend, claiming that they were soldiers disguised as gold miners, and police said the insurgents were holding two hostages. A low-level but increasingly deadly battle for independence has simmered between security forces and rebels in resource-rich Papua ever since it was controversially brought under Indonesian control in a vote overseen by the United Nations in 1969. Sebby Sambom, a Papuan rebel spokesperson, said in a statement the rebels had killed more than 17 people since April 6, including five on Wednesday, and claimed they were military members disguised as gold miners. "If the Indonesian government military wants to chase us, please come to Dekai town, we are in the town," Sebby said, referring to a town in Yahukimo district, where the incident took place. Frega Wenas, a spokesperson for the country's defense ministry, told reporters that 11 illegal miners were ruthlessly killed in the area and denied they were military officers, adding this was the rebels' propaganda. Separately, police said in a statement on Thursday that 35 people in the area were evacuated to another district, while two residents were still being held hostage by the rebels. Frega said the attack was one of the deadliest in recent years. In 2018, a separatist group killed 21 road construction workers in the highland area of Nduga. Rebels in Papua have in recent years managed to acquire better weapons, taken in raids on army posts or sourced from the black market. They have also abducted foreigners, including a New Zealand pilot who was released last year after being held for 19 months.-APP

## Saudi Arabia records 89% growth in licensed tourism hospitality

RIYADH: Saudi Arabia's tourism sector saw significant growth in 2024, with the number of licensed hospitality facilities increasing by 89 percent to 4,425 across various regions of the Kingdom. In a post on X, the Ministry of Tourism's official spokesperson Mohammed Al-Rasasimah described the surge as "remarkable," adding that it reflects efforts "to support the sector's growth and enhance its investment attractiveness." He added that the expansion comes amid a significant boom in the Kingdom's tourism sector, driven by an influx of travelers and the ministry's commitment to fostering a world-class hospitality environment. The ministry reported in March that the number of licensed hospitality facilities in Makkah reached 1,030 by the end of 2024, marking an 80 percent rise compared to the previous year. This increase positions the province as the leader in the Kingdom for the highest number of licensed facilities and rooms, underscoring the region's dedication to enhancing visitor experiences, the Saudi Press Agency reported. This move also reinforces the ministry's dedication to protecting the rights of visitors and Umrah pilgrims using hospitality services in Makkah as part of its ongoing efforts to improve service quality. "The ministry's inspection teams conduct regular monitoring and inspection visits throughout the year to ensure that all facilities comply with licensing requirements, detect violations, and impose fines under the Tourism Law and Regulations of Tourist Accommodation Facilities," SPA said. Saudi Arabia's hospitality sector is growing beyond Makkah. By the end of the third quarter of 2024, the total number of licensed hospitality facilities across the Kingdom surpassed 3,950, a 99 percent increase from the third quarter of 2023. Licensed rooms climbed to 443,000, a 107 percent jump from the 214,000 recorded a year earlier. According to CoStar, a global real estate data provider, Makkah and Madinah have 17,646 and 20,079 rooms, respectively, in various stages of development in 2025. This comes as Saudi Arabia recorded 30 million inbound tourists in 2024, up from 27.4 million in 2023, government data revealed. The Kingdom aims to attract 150 million visitors annually by 2030, with plans to raise the tourism sector's gross domestic product contribution from 6 percent to 10 percent. Saudi Arabia's aggressive expansion in hospitality and tourism underscores its ambition to position itself as a global travel hub, catering to religious and leisure visitors. -DNA

## KSA once a green oasis, study of ancient caves reveals

DNA

RIYADH: A groundbreaking scientific study led by Saudi Arabia's Heritage Commission has revealed that the Arabian Peninsula, now largely arid desert, was a lush green oasis nearly eight million years ago. Announced at a press conference, the study, published in the prestigious journal Nature analyzes 22 cave formations in the "Duhool Al-Summan" sinkholes northeast of the capital. According to Dr. Ajab Alotaibi, Director General of Antiquities at the Heritage Commission, the research presents the longest continuous climate record ever documented in the

Arabian Peninsula, spanning an extraordinary eight million years. "This is one of the most significant climate records in the Arabian Peninsula," Alotaibi said, highlighting that the findings offer vital insights into the region's environmental past and its pivotal role as a corridor for the migration of humans and animals between Africa, Asia, and Europe. The study, titled "Recurrent Humid Phases in Arabia Over the Past 8 Million Years," is a central component of the Kingdom's flagship Green Arabia Project - an ambitious initiative for uncovering Saudi Arabia's natural and environmental history. The project brought together 30 scientists from 28 institutions worldwide, including mites and stalactites from sevthe Saudi Geological Survey, King Saud University, the Max Planck Institute (Germany), Griffith University (Australia), and multiple research centers across Europe and the United States. Using advanced geochemical techniques such as oxygen and carbon isotope analysis, and precise Uranium-Thorium and Uranium-Lead dating, the team identified a series of humid climatic phases stretching from the late Miocene through the Pliocene and into the late Pleistocene. These wet periods transformed the Arabian Peninsula into fertile landscapes with rivers, lakes, and diverse ecosystems. The deposits studied, stalag-

en sinkholes near Shawyah in Rumah Governorat, preserved rich geological data that reflect dramatic environmental shifts over millions of years. The research supports fossil evidence of once-thriving populations of water-dependent animals, including crocodiles, hippos, elephants, giraffes, and large predators, species now extinct in the region. Beyond reconstructing a vibrant prehistoric ecosystem, the study also sheds light on the role of climate in shaping patterns of human migration and biodiversity across continents. Understanding these ancient humid phases helps us trace how early humans and animals moved between continents and

adapted to shifting environments," Alotaibi noted. The Heritage Commission hailed the study as a major milestone in Saudi Arabia's scientific and cultural journey and reaffirmed its commitment to promoting global research collaboration. Officials also emphasized the untapped potential of the Kingdom's cave systems, many of which remain unexplored and could hold further secrets about the region's ancient past. As part of ongoing efforts, the Green Arabia Project continues to lead international research aimed at documenting and preserving Saudi Arabia's natural and cultural heritage in the face of evolving climate and environmental challenges.

## Omar denies infighting in PTI ranks

ISLAMABAD: Pakistan Tehreek-e-Insaf (PTI) leader and National Assembly Opposition Leader Omar Ayub has reiterated that the party remained united under Imran Khans leadership and dismissed interference from PML-N and PPP in PTIs internal matters.

Speaking to the media outside the district court in Islamabad, Omar Ayub thanked the court for confirming his bail, noting that he was simultaneously facing cases in multiple cities. Even if I had a flying saucer, I couldnt be in three cities at once,he said. He stressed the urgent need for reforms in Pakistans judicial and policing systems. Two days ago, we were denied a meeting with party founder Imran Khan in Adiala, and several people were arrested. Pakistan should be a hard state, but built on the foundation of the constitution and law. A state built on oppression is hollow,he remarked. Addressing speculation about internal divisions

Addressing speculation about internal divisions within PTI, Omar Ayub dismissed such claims. PML-N and PPP have nothing to do with our internal affairs. PTI is not a feudal party, everyone is equal. Imran Khan listens to everyone, and the party is united under his leadership.

Commenting on legislative matters, Ayub said, Passing or not passing the Minerals Bill is the domain of the provincial assembly and government. Referring to senior PTI leader Azam Swati, he added, Swati is a respected elder. I wasnt in the meeting, but what he said must be true. Imran Khan and others are political prisoners. When the government demands an apology from him, it clearly shows these are political cases.

### EU pauses counter measures after Trump's reprieve

BRUSSELS: The European Union will pause its first countermeasures against US tariffs after President Donald Trump temporarily lowered the hefty duties he had just imposed on dozens of countries, European Commission chief Ursula von der Leven said on Thursday. The bloc was due to launch counter-tariffs on about 21 billion euros (\$23.25 billion) of US imports from next Tuesday in response to Trump's 25% tariffs on steel and aluminium. It is still assess ing how to respond to US car tariffs and the broader 10% levies still in place. "We want to give negotiations a chance,"von der Leyen said on X. "While finalis ing the adoption of the EU countermeasures that saw strong support from our Member States, we will put them on hold for 90 days." Trump's sudden decision on Wednesday to pause most of his hefty new duties

Trump's sudden decision on Wednesday to pause most of his hefty new duties brought relief to battered global markets and anxious global leaders, even as he ratcheted up a trade war with China. His turnabout, which came less than 24 hours after steep new tariffs kicked in, followed the most intense episode of financial market volatility since the early days of the COVID-19 pandemic. – Agencies

### SC schedules hearings for May 9 cases

# Pakistan, UNDP finalize key green investment portfolio

ISLAMABAD: Federal Minister for Finance and Revenue, Senator Muhammad Aurangzeb, held a follow-up meeting today with Dr. Samuel Rizk, Resident Representative of the United Nations Development Programme (UNDP) Pakistan, who was accompanied by his team. During the meeting, the UNDP team presented an overview of UNDPs ongoing technical assistance to

Pakistan in the development of bankable projects aimed at attracting investment and climate financing. Dr. Rizk also provided a briefing on the upcoming 4th International Conference on Financing for Development (FfD4) to be held in Spain later this year. Key discussions focused on finalizing a portfolio of bankable projects and ensuring Pakistan's proactive participation in FfD4 with a robust, investment-ready pipeline. Dr. Rizk acknowledged the Government of Pakistans policy leadership in steering in-

vestment and climate financing initiatives in collaboration with government stakeholders and development partners

holders and development partners. Highlighting the significance of Pakistans improving macroeconomic indicators and enhanced market ratings, Dr. Rizk noted that FfD4 presents a strategic platform for Pakistan to engage global investors and unlock international climate and development financing. In line with the Finance Ministers earlier guidance, Dr. Rizk informed that UNDP, in coordination with

ronmental Coordination (MoCC&EC) and the Public-Private Partnership Authority (P3A), has identified five preliminary bankable projects valued at over USD 1 billion. These projects span critical sectors, including green exports, biowaste management, road infrastructure, domestic green private sector development, and green real estate. Dr. Rizk also shared that a preparatory mission from the UN Department of Economic and Social Affairs (DESA) will visit Islamabad next week. The mission will facilitate planning and capacity-building sessions with federal and provincial governments, key stakeholders, and private sector partners in preparation for Pakistans participation in FfD4. Minister Aurangzeb expressed appreciation for UNDPs continued support in advancing Pakistans climate and Sustainable Development Goal (SDG) financing agenda. He reaffirmed the governments commitment to a whole-of-governmentapproach, directing the Inter-Ministerial Committee-comprising senior officials from the Ministries of Foreign Affairs, Planning &Development, Climate Change, Economic Affairs Division, Finance, and P3A-to work collaboratively on a dynamic, investment-attractive portfolio aligned with Pakistans structural reform and climate resilience priorities.

Concluding the meeting, the Finance Minister reaffirmed the Government of Pakistans resolve to work closely with UNDP and other development partners to drive sustainable, inclusive economic growth and enhance Pakistans role in global climate and development financing forums.

## New Zealand rejects rights bill

AUCKLAND: A controversial bill seeking to reinterpret New Zealand's founding document, which established the rights of both Māori and non-Māori in the country, has been defeated at its second reading. The Treaty Principles Bill was voted down 112 votes to 11, days after a government committee recommended that it should not proceed. The proposed legislation sought to legally define the principles of the 1840 Treaty of Waitangi - causing widespread outrage that saw more than 40,000 people taking part in a protest outside parliament last year. The bill had already been widely expected to fail, with most major political parties committed to voting it down. Members of the right-wing Act Party, which tabled it, were the only MPs to vote for it at the second reading on Thursday. Act's leader David Seymour has promised to continue campaign-

ing on the issue.
"I believe this Bill or something like it will pass one day because there are not good arguments against its contents,"he wrote on social media. Tensions were high during a parliamentary debate on the bill in November. Labour MP Willie Jackson was told to leave after refusing to withdraw a comment he made calling Seymour a "liar". – Agencies

### Dumper crushes motorcycle in Karachi

KARACHI: A high-speed dumper collided with several motorcyclists near North Karachi Power House, resulting in three individuals being injured. Following the incident, enraged protesters launched severe protests against the dumper, setting fire to five dumpers, one water tanker, and one truck at various locations, Express News reported.

According to rescue sources, the injured individuals were immediately transferred to the hospital. After the accident, local residents chased the dumper driver and caught him on Manghopir Road. The public assaulted the driver, after which the police arrived at the scene and took him into custody. Despite the police's presence, the protesters continued their violent actions, pelting stones at several dumpers.

## World Bank arm's \$ 300 million lifeline sets tone for Reko Diq

Pledge signals global investor confidence as Barrick-led Reko Dig races to lock in fresh investment for mine's revival

ISLAMABAD: The World Bank's private investment arm, International Finance Corporation (IFC), will provide \$300 million in debt financing for Pakistan's Reko Diq copper-gold mining project, according to a disclosure issued by the lender. Located in the Chagai District of Balochistan province, the mine is considered one of the world's largest underdeveloped copper-gold areas and its development is expected to have a significant impact on Pakistan's struggling economy. Barrick Gold owns a 50% stake in the Reko Diq mine, and the governments of Pakistan and Balochistan own the other 50%. The mine's Project Director, Tim Cribb, told Reuters on Tuesday that Barrick Gold's Reko Diq copper and gold project in Pakistan intended to lock in upwards of \$2 billion in financing from international lenders, with term sheets signed by early Q3. In an interview with Reuters at the

Pakistan Minerals Investment Forum 2025, Cribb said the mine was looking at \$650 million from the International Finance Corporation and International Development Association. Cribb further said that the funding would support the development of the mine, and hoped to generate \$70 billion in free cash flow and \$90 billion in operating cash flow. Barrick Gold and the governments of Pakistan and Balochistan own the project jointly. The financing for phase one of the project, which is expected to start production in 2028, is being discussed with multiple lenders. The Reko Dig project director added that the mine was also in talks with the US Export-Import Bank for \$500 million to \$1 billion in financing, as well as \$500 million from development finance institutions, including the Asian Development Bank, Export Development Canada, and Japan Bank for International Cooperation. He said railway financing talks were underway with the IFC and other lenders, with infrastructure costs estimated at \$500-800 million, with roughly \$350 million as the initial cost.

# LHC launches integrated criminal justice system

LHC CJ Aalia Neelum inaugurates pilot project for Lahore and Rahim Yar Khan

LAHORE: The Lahore High Court took a significant step towards judicial transparency and efficiency with the launch of the Integrated Criminal Justice System (ICJS), aimed at ensuring connectivity and documentation from the First Information Report (FIR) to the final orders. The ICJS, now operational as a pilot project in Lahore and Rahim Yar Khan, was formally inaugurated by LHC Chief Justice Justice Aalia Neelum. The system enables one-click access to complete case records, marking a milestone in the digital transformation of the provinces legal landscape. In recognition of her leadership, the Punjab Inspector General of Police, Prosecutor General Punjab Syed Farhad Ali Shah and PITB chairman paid tribute to CJ Neelum for her role in spear-

ed by LHC Registrar Amjad Iqbal Ranjha, Director General District Judiciary, Additional Secretary Home Department Punjab, Secretary Prosecution Punjab, Advocate General Punjab, and Prosecutor General Syed Farhad Ali Shah. Speaking at the event, Chief Justice Neelum described the system as revolutionary, congratulating the Provincial Justice Committee for their efforts. She noted that the need for an integrated solution became evident when it was discovered that challans for hundreds of thousands of cases had not been submitted to courts - prompting the urgent need for reform. With the implementation of this project, delay tactics will become a thing of the past, she asserted. Additional Registrar (IT) Jamal Ahmed gave a detailed briefing on the functionalities of the new system. Farhad Ali Shah remarked that the vision of Chief Justice Neelum had significantly improved the criminal justice process, while the Punjab IGP echoed the sentiment, applauding her for her critical role in the development and deployment of the ICJS.

## Hamas urges UK government to overturn terror designation

Official slams Britains unwavering support for Zionism, apartheid, occupation, ethnic cleansing

LONDON: Hamas has submitted a legal filing in Britain demanding it be removed from the governments list of proscribed terror groups. The organization is arguing that it is a Palestinian Islamic liberation and resistance movement whose goal is to liberate Palestine and confront the Zionist project, and not a terrorist group. The claim includes a witness statement by Mousa Abu Marzouk, Hamass head of international relations and the applicant for the filing. It was submitted to Home Secretary Yvette Cooper.

Abu Marzouks statement said: The British governments decision to proscribe Hamas is an unjust one that is symptomatic of its unwavering support for Zionism, apartheid, occupation and ethnic cleansing in Palestine for over a century. Hamas does not and never has posed a threat to Britain, despite the latters ongoing complicity in the genocide of our people. The UK proscribed Hamass military wing, the Al-Qassam Brigades, in 2001, and added its political wing to the list of terror organizations in 2021.

At the time, the government described the distinction between the two wings as artificial and said Hamas was a complex but single terrorist organization. Support for proscribed organizations is a criminal offense in Britain. Hamass legal team at Riverway Law, which is representing the organization pro brono because it is illegal to receive funds from proscribed groups, sent a document to Drop Site News summarizing its arguments. The team said: Hamas does not deny that its actions fall within the wide definition of terrorismunder the Terrorism Act 2000.

Instead, it notes that the definition also covers all groups and organizations around the world that use violence to achieve political objectives, including the Israeli armed forces, the Ukrainian army and indeed the British armed forces. The team added: Rather than allow freedom of speech, police have embarked on a campaign of political intimidation and persecution of journalists, academics, peace activists and students over their perceived support for Hamas. People in Britain must be free to speak about Hamas and its struggle to restore to the Palestinian people the right to self-determination.

Hamas is the only effective military force resistingIsraels illegal occupation of the Palestinian territories, the team said, highlighting Britains obligations under international law to prevent genocide and crimes against humanity.

The proscription is also disproportionate as Hamas does not pose any threat to Britain or British citizens, the team added. Hamass presence on the list of terrorist organizations is hindering its ability to broker a political solution to the Israeli-Palestinian conflict, the lawyers said. Riverway Laws director, Fahad Ansari, is leading the legal challenge.
