

# **Rumours dispelled** 'No US pressure on Pakistan to recognise Israel'

"Our policy towards Israel is consistent with Quaid-e-Azam's ideology," says Ambassador Rizwan Saeed Sheikh

WASHINGTON: Islamabad is under no pressure from Washington to recognise Israel, Pakistan's Ambassador to the US Rizwan Saeed Sheikh has said during a community event in Dallas. Addressing the gathering, the ambassador spoke on a range of national and international issues, reaffirming that Pakistan's position on Israel remains unchanged and is rooted in the vision of the country's founder, Quaid-e-Azam Muhammad Ali Jinnah.

"Our policy towards Israel is consistent with Quaid-e-Azam's ideology," Ambassador Sheikh said, adding that Pakistan's approach to the issue is based on longstanding principles and not influenced by external pressure.

The remarks come amid ongoing speculation in international media about changing dynamics in the Muslim world's relations with Israel. Pakistan, which has no diplomatic ties with Israel, maintains that normalisation will only be possible after a just settlement of the Palestinian issue. During the recent confrontation between the Middle Eastern arch-rivals Iran and Israel, Pakistan supported Tehran on its right to defence against the Is-

raeli aggression. Commenting on bilateral ties, Ambassador Sheikh said Pakistan-US relations are improving, noting that both countries are working to strengthen cooperation in areas such as trade, energy and technology. In response to a question about investment opportunities, he pointed out that Pakistan has ample electricity reserves to support ventures like cryptocurrency mining - a sector gaining attention in the global digital economy.

It may be noted that Pakistan officially commenced the drafting of a comprehensive regulatory framework for digital and virtual assets, signalling a significant move by the government to formally oversee the booming cryptocurrency ecosystem last month. Later, Islamabad and New York each launched dedicated Crypto Councils to promote responsible growth of the digital asset sector. Earlier this month, the federal cabinet formally approved the summary for the creation of the Pakistan Virtual Assets Regulatory Authority (PVARA), a step towards establishing a legal and institutional framework for overseeing the country's digital assets ecosystem. As the country ramps up efforts to modernise its financial system, State Bank of Pakistan (SBP)

NEW DELHI: Separatist militants in northeastern India said the Indian army carried out cross-border drone strikes on the group's camps in neighbouring Myanmar on Sunday, killing three of its leaders. Some rebel groups in northeastern India have ethnic, linguistic and cultural ties with minorities across the border in Myanmar and maintain a presence there. A top commander of the United Liberation Front of Asom (ULFA) was killed and 19 others wounded in a drone attack in Myanmar near the border, the separatist group said in a series of statements. "Two more senior commanders were killed" in subsequent strikes, the ULFA said, adding: "Several other members and civil ians were also wounded."

# Minister Naqvi arrives in Iran

TEHRAN: Federal Interior Minister Mohsin Naqvi has arrived in Iran on an official visit. Upon his arrival at Imam Khomeini International Airport, he was warmly received by Iranian Interior Minister Eskandar Momeni. Senior officials from Iran's Ministry of Interior, Pakistan's Ambassador to Iran Muhammad Mudassir Tipu, Consul Aftab Butt, and other diplomatic staff were also present to welcome the Pakistani minister. During his visit, Minister Mohsin Naqvi held a meeting with his Iranian counterpart. The two leaders discussed matters of mutual interest and the strengthening of bilateral relations between Pakistan and Iran. "We warmly welcome our brother to Iran," said the Iranian Interior Minister. "Your visit will undoubtedly contribute to further enhancing the relationship between our two countries."

ISLAMABAD: KHYBER Pakhtunkhwa Chief Minister Ali Amin Gandapur on Saturday called on state institutions to engage in dialogue with the PTI, but demanded that they hold themselves accountable. # **IMF** official praises **Pakistan's 'strong'** progress

Mahir Binici emphasises structural reforms key to Pakistan's long-term economic sustainability

ISLAMABAD: International Monetary Fund (IMF) Resident Representative for Pakistan Mahir Binici said that the country's performance under the Extended Fund Facility (EFF) has been "strong so far" and expressed hope that its economic growth would strengthen this year. Binici delivered a comprehensive guest lecture at the Sustainable Development Policy Institute (SDPI) in which he shed light on the evolving economic landscape across the MENA region and Pakistan. He reaffirmed the Washington-based lender's continued support for the country's economic and climate reform agenda. Addressing economists, researchers and policy experts, Binici said that the growth across the Middle East, North Africa (MENA) region and Pakistan was expected to strengthen in 2025 and beyond. However, he cautioned that elevated trade tensions, geopolitical fragmentation and weakening global cooperation continued to generate exceptional uncertainty and weigh on the global economic outlook, underlining the urgent need for prudent and forward-looking policy actions, said a press release issued today.

Focusing on Pakistan, Binici said that the country's performance under the IMF's EFF has been "strong so far", adding that the successful completion of the first review by the IMF Executive Board in May 2025 was a key milestone. "Early policy measures have helped restore macroeconomic stability and rebuild investor confidence, despite persistent external challenges," Binici remarked.

He emphasised that structural reforms remain central to Pakistan's long-term economic sustainability, particularly reforms that strengthen tax equity, improve the business climate, and encourage private-sector-led investment. He also spotlighted Pakistan's progress on climate-related reforms under the IMF's Resilience and Sustainability Facility (RSF). According to Binici, the RSF is designed to help countries like Pakistan bolster resilience to climate-related vulnerabilities and meet international climate commitments. He mentioned that the key areas of reform under the RSF included enhancing public investment planning, promoting efficient and sustainable use of water resources,

**Favoritism clouds HEC's official** delegation to Germany

ISLAMABAD: The Higher Education Commission (HEC) is facing strong criticism over the composition of its official delegation to the upcoming FISU World University Games 2025, scheduled from 16th to 27th July in the Rhine-Ruhr region of Germany. Despite frequently citing budget limitations as a reason for curtailing academic and sports development initiatives, HEC has approved a large delegation consisting of 17 officials and 24 athletes. According to a letter issued by the Pakistan Sports Board (PSB) on 2nd July 2025, the PSB has granted a formal No Objection Certificate (NOC) for the said delegation. However, the list has sparked outrage among university sports circles, particularly in Khyber Pakhtunkhwa (KP), as no official from KP has been included in the list despite the province's known contribution to national-level

sports. Sources within the university community allege that Director Sports HEC, Mr. Javed Ali Memon, has filled the list with favorites and personal associates, bypassing the university Directors of Sports, who are traditionally involved in such international representations. Even more alarming are the claims that some university owners and their spouses have been included as part of the delegation under the guise of officials. Observers note that the same HEC that claims financial crisis for holding intervarsity tournaments, sports training camps, or infrastructure development, has now found sufficient funding to send non-athlete delegates on an international trip. This contradiction has raised concerns over misuse of public funds, lack of meritocracy, and the absence of transparency in the selection process. Stakeholders are now demanding immediate accountability from HEC. "We want Mr. Javed Ali Memon to clarify the se-

lection criteria for the officials," said a university representative. "This is a clear case of favoritism and reflects the misuse of a prestigious international platform for personal networking, rather than sports promotion.

The matter is now being raised for public debate on media platforms and talk shows, with calls for judicial intervention. According to concerned parties, if no action is taken, they will approach the Prime Minister, and in case of no satisfactory outcome, will pursue legal avenues, including filing for a stay order on the participation of the non-merit-based officials in the World University Games.

As the games approach, many within the university sports community urge the government to take notice of this unjust practice and ensure that deserving professionals and athletes not well-connected officials represent the country on international platforms.

# Society's reaction to change - Newton's third law

Ir Isaac Newton was Sa 17th century's Eng-lish physicist, mathastronomer, ematician, philosopher, and chemist, considered one of the most significant figures in history. Newton's three laws gained worldwide recognition and are still commonly known today. Newton's famous third law states that every action has an equal and opposite reaction. This law also applies to real life. A simple example of this is the violence towards children in educational institutions. Until a while ago, corporal punishment was a common practice in schools. It was normal to impose severe punishment for minor mistakes. When the teacher would raise a stick and look angrily at the children, they would become terrified. Many children would leave school just because of this

olence started spreading among parents and children, leading to voices being raised against it. A solution to this problem was found at the governmental level. Now, corporal punishment in schools has been completely banned. However, religious institutions are fully exempt from this rule. While corporal punishment was banned in schools, the outcome turned out to be even more alarming. The new generation has stopped taking teachers and education seriously. At the college level, the status of teachers has become devalued. Now, teachers must conform to the students' desires and preferences. Teachers making sarcastic remarks, engaging in violence, and going on strikes have become common practices. Now, the sole purpose of education is to obtain a degree with higher marks, whether through recommendations, cheating, or financial means. This is just as wrong as the previous culture was. However.

with Newton's law. Another example is the distancing of youth from religion. In our everyday lives, religion has the most influence, but unfortunately, religious leaders and scholars have failed to introduce people to the teachings of Islam. Everyone emphasizes beliefs and various types of dua (prayers), but no one teaches moral values. Asking questions about religious matters is even considered taboo. When a young person looks at Western societies, where people, despite being far from religion, still respect each other's rights-where unnecessary honking, loudspeakers, and tape recorders are not heard in the streets, where people don't litter the streets or parks, where deception and adulteration are rare, and food and medicine are pure-he wonders how, despite being far from religion, they maintain such moral values. Meanwhile, we, as religious people, are deprived of these qualities. In our society, religion is often used for hatred, violence. and politics. Seeing these

circumstances, a large num-

ber of young people are drifting away from religion and preferring Western culture instead.

Recently, the tragic death of a famous actress and TikTok influencer, and the discovery of her body after eight months, has raised many questions. What happened that a daughter, a sister, left her parents and siblings to create her own world? The dazzling lights of the camera, the lure of followers and likes, and the race for ratings left religion, Eastern culture, and parental respect behind. Under the guise of gender freedom and rights, some people have targeted the minds of the younger generation for their selfish purposes. This is an illusion that appears very beautiful from a distance but is hollow and baseless from within.

It is true that women faced many injustices in the past. They were denied the rights that Islam granted them as mothers, sisters, and daughters. Many customs and traditions in society violate women's rights. Practices like Wani and Kari are among the most horrific, where only women suffer. In many communities, marriage outside the family is prohibited. These

mismatched marriages lead to domestic violence, discord, and divorce. The disdain with which divorced women are viewed in society severely harms their self-respect. The differential treatment between sons and daughters, forced marriages, deprivation from inheritance, blackmail under the name of dowry, and violence from in-laws all add to these issues. Although such incidents are rare, they certainly do happen. Women's rights NGOs take full advantage of these customs. They particularly target women who are victims of domestic violence. These organizations play a significant role in the destruction of the family system, encouraging women to run away and marry, as well as promoting moral degradation. Many educated people, especially women, become part of this campaign after being influenced by attractive advertisements and catchy slogans. TV channels and social media are at the forefront of this campaign. TV anchors and journalists, to present themselves as liberals, become strong spokespeople for these NGOs, which contrib-

# Court upholds cancellation of e-parking contract with AJCL

ISLAMABAD, Jul 13 (DNA): A lower court in Islamabad has upheld the decision by the Directorate of Municipal Administration (DMA) and Metropolitan Corporation Islamabad (MCI) to cancel the e-parking contract awarded to AJCL company, terming the termination fully legal and in accordance with administrative procedures. The court dismissed AICL's appeal, reinforcing the government's commitment to transparency, legal supremacy, and public interest. Senior advocate Nazir Jawad, representing CDA and DMA, presented what the court described as "solid legal evidence" to defend the cancellation of the contract. The contract with AJCL was officially revoked in June 2025 after the company was found to be in serious breach of multiple clauses, including financial irregularities and failure to implement a cashless system for parking. The CDA spokesperson told that, multiple First Information Reports (FIRs) were also filed by both the DMA and concerned citizens at local police stations against the company. AJCL subsequently challenged the contract termination, requesting that parking sites not be reclaimed and that the proposed re-auctioning of smart parking sites be halted. However, the court rejected all such claims, declaring them baseless and upholding the DMA's actions as legally sound and procedurally proper. Legal experts and civic stakeholders alike have praised the decision, calling t a major step toward enforcing transparency, upholding the rule of law, and improving urban services in Islamabad. This judgment empowers us to take stronger, more effective steps for enhancing public amenities," said a senior CDA official. "This verdict is a testament to our commitment to good governance, transparency, and merit-based decisions," said Chairman Capital Development Authority (CDA) and Chief Commissioner Islamabad, Muhammad Ali Randhawa in a statement on Sunday. The verdict has been hailed by CDA officials as a precedent-setting move of Member Administration Talat Mahmood and Deputy DG Enforcement and Director DMA Dr. Anam Fatima. The CDA reiterated its commitment to modernizing urban infrastructure, promising that no lapses in governance or public service delivery would be tolerated. "All future projects, especially smart parking systems, will be executed with utmost transparency and accountability," the CDA said in an official statement.-DNA

# Islamabad trails Rawalpindi in food safety infrastructure

ISLAMABAD: The Islamabad Food Authority (IFA) faces serious operational challenges in carrying out effective food safety enforcement, hampered by limited staff, minimal infrastructure, and the absence of essential testing facilities. In sharp contrast, the Rawalpindi Food Authority (RFA) operates with significantly better resources, including more vehicles, trained personnel and fully equipped labs, enabling it to enforce food safety regulations more efficiently across the district. Both the Islamabad and Rawalpindi Food Authorities are tasked with regulating an estimated 30,000 food businesses each. However, the difference in their capacity to enforce food safety standards is striking. The IFA operates with just one field vehicle and 10 technical staff members. It lacks a food testing laboratory, training institute, mobile food labs, and a designated public relations officer. While the number of non-technical staff is reported to range between 20 and 50, the authority's limited technical expertise and lack of mobility severely restrict its operational reach. In contrast, the RFA is equipped with 10 vehicles, 30 technical staff, a dedicated food testing lab, training school, and two mobile testing labs-allowing for routine field inspections and on-the-spot sampling. Speaking to this reporter, an official of IFA, acknowledged the constraints: "Our team covers the city as best as possible with the available resources. We're committed to ensuring food safety despite the limitations." However, food vendors in various parts of Islamabad, particularly Farooqia Market (F-6), say that in addition to operational shortages, the licensing process is being disrupted by external interference. Multiple shopkeepers alleged that Khalid Chaudhry, identified as a former member of the Islamabad Chamber of Commerce, discourages businesses from obtaining food licenses. They claim he uses the name of the Chief Commissioner to apply pressure and has reportedly misbehaved with inspection teams. "His interference delays the process and affects everyone," said a local trader. "He's making it difficult for us to comply with the law.-DNA

# Food contamination linked to sharp rise in 'Youth **Cancer**'

ISLAMABAD: On Sunday, a cancer specialist highlighted a worrying increase in colorectal, liver, oral cancer cases among young people, pointing to plastic use, food contamination, environmental factors as major causes, calling for timely detection to ensure successful treatment. A leading Oncologist Dr. Muhammad Ali Memon, while speaking to a local news channel, highlighted that these cancers have seen a 79% rise in the last two decades, underscoring the urgent need for awareness and prevention. He described this sharp rise as a significant public health concern, emphasizing the urgent need for increased awareness, early screening and preventive measures among the younger population. He further explained that chemical preservatives used in processed foods, consumption of frozen and contaminated items and the presence of plastic in soil and the food chain are major contributing factors. According to him, these elements disrupt bodily functions and reproductive health, increasing the risk of developing serious cancers at a younger age. - APP

# 10 MW provided to Gwadar Port, South Free Zone ISLAMABAD: In a mega development, 10 MW has finally

# A Nation on the Frontlines of Climate Breakdown

PAKISTAN is experiencing its hottest and most extreme summer of the decade, with temperatures soaring close to 50°C across multiple areas of the country. Entire cities have transformed into scorching heat zones, triggering widespread health emergencies, straining energy infrastructure, and deepening water scarcity.

This crisis is not a natural occurrence, but the result of years of unchecked environmental degradation that have pushed the climate system to a breaking point. What was once considered an anomaly is now becoming an alarming new norm.

In the first half of 2025 alone, Pakistan has been struck by two major climate-related disasters: an extreme heatwave in Sindh and a devastating glacial lake outburst flood (GLOF) in Gilgit-Baltistan. The heatwave pushed temperatures in Jacobabad beyond 52°C, while the GLOF wiped out entire communities in Hunza Valley, displacing thousands.

Since April 2025, a series of intense heatwaves have struck Pakistan, with June bringing the most brutal temperatures. Dera Ghazi Khan recorded highs of 50°C, while Lahore, Sargodha, and other

urban centers soared around 47°C to 49°C. Even regions like Gilgit-Baltistan and Khyber Pakhtunkhwa, historically known cooler zones, have reported unseasonably high temperatures. Countless factors contribute to the single, predominant challenge of climate change. While Pakistan battles record-breaking heatwaves and growing climate instability, it's important to acknowledge a harsh truth: the country is suffering the consequences of a crisis it did not create.

Despite contributing less than 1% to global greenhouse gas emissions, Pakistan faces some of the most devastating impacts of climate change. Pakistan's climate change vulnerability is deeply linked to its geography.

Pakistan lies at the crossroads of melting glaciers, arid zones, and low-lying coastal areas. The Intergovernmental Panel on Climate Change (IPCC, 2021) places Pakistan among the ten most climate-vulnerable countries. Global warming, which is driven largely by industrialized nations, has raised baseline temperatures around the world, setting the stage for more frequent and intense heat events. Shifts in atmospheric patterns, including high-pressure systems that trap heat, further exacerbate the problem. In Pakistan's rapidly expand-

ing cities, heat is magnified by the urban heat island effect, as concrete structures and reduced green cover retain and radiate warmth. Meanwhile. widespread deforestation and soil degradation leave the land dry and unable to cool naturally. Adding to the crisis is a fragile and overburdened power system that often fails during the hottest parts of the day, cutting off electricity

to millions. Without reliable power, many households are left without fans, air coolers, or even access to clean drinking water when they need it most.

The human cost of the heatwave is staggering. Hospitals in Sindh, Punjab, and Balochistan have reported surges in cases of dehydration, heatstroke, and heat-induced miscarriages. Outdoor laborers, street vendors, and elderly residents are at high risk, with minimal access to cooling centers or relief services. In 2024, over 568 heat-related deaths were recorded during a similar period, and current trends suggest a repeat of that grim statistic.

In response to the intensifying heat, authorities and humanitarian organizations have set up over 1,000 heat relief camps in high-risk areas, offering water, shade, and first aid.

Public advisories encourage people to stay indoors during peak heat hours, while hospitals have opened dedicated heatstroke counters. Despite these efforts, gaps in

access, medical supplies, and public awareness remain, particularly in low-income and remote communities.

While emergency responses provide short-term relief, longterm resilience depends on integrating sustainable urban planning, efficient water and energy management, and climate-conscious infrastructure. Expanding green spaces, strengthening early warning systems, adopting heat-resilient building designs, and ensuring social protections for vulnerable groups are critical to reducing future risks. These measures, combined with international support and climate finance, are essential for Pakistan to adapt to a hotter, more unpredictable future. The climate catastrophe facing Pakistan is no longer hypothetical; it is a present-day emergency. The events of 2025 should erase any remaining doubts about the urgency of the crisis. Heatwaves, glacial floods, and displacement are not rare events; they are becoming the new normal. Pakistan's battle with deadly heatwaves is a stark reminder that climate change knows no borders and demands urgent, unified action before survival becomes the exception, not the norm. If Pakistan fails to act decisively now, it risks spiraling into a future of perpetual recovery, where every season brings devastation, and every year resets developmental progress. # PTI girds up loins against the Government: Will it succeed?

HE Pakistan Tehreek-e-Insaf (PTI) is once again gearing up for a decisive showdown with the federal government, signaling the start of what could become a significant political movement. While the party's chances of immediate success appear slim given the current power dynamics, its efforts may lay the groundwork for a larger, more sustained campaign in the future. At the very least, PTI's mobilization will keep the ruling coalition under pressure, exposing the growing fissures within the government and testing the establishment's tolerance for political instability. Reports suggest that the Pakistan Peoples Party (PPP), a key ally in the ruling coalition, is increasingly frustrated with its partners. Initially, the PPP was reportedly promised the prime minister's office after two and a half years as part of a power-sharing arrangement. However, the current leadership, particularly the Pakistan Muslim League-Nawaz (PML-N), shows no intention of relinquishing power. This has left the PPP disillusioned, raising questions about the longevity of this uneasy alliance. If the PPP decides to distance itself from the government-either by withdrawing support or publicly criticizing its coalition partners-it could create an opening for PTI to exploit. A divided ruling bloc weakens the government's ability to counter opposition movements effectively, giving PTI more room to maneuver. The role of the establishment remains pivotal. Historically, Pakistan's power dynamics have been shaped by the military's preference for a controlled political environment. There are indications that the establishment may allow-or even subtly encourage-political turbulence to keep the civilian government in check. By letting PTI protest and exert pressure, the establishment could remind the ruling coalition of its dependence on institutional support. However, the establishment is unlikely to let the situation spiral into chaos. Its primary concern is stability, and any movement that threatens to destabilize the country excessively will likely be reined in. PTI's challenge, therefore, is to maintain momentum without crossing red lines that could trigger a harsh crackdown. Another factor that could energize PTI's movement is the possible return of Imran Khan's sons, Qasim Khan and Sulaiman Khan, to Pakistan. If they choose to join the political fray, their presence could galvanize PTI supporters, adding emotional and symbolic weight to the movement. Given their father's incarceration and the party's narrative of victimization, their involvement could attract greater public sympathy and media attention. However, their influence will depend on how they engage with politics. If they take a prominent role in rallies and public mobilization, they could become rallying points for PTI loyalists. Conversely, if they remain passive or are sidelined by more experienced party leaders, their impact may be limited. In the short term, PTI faces significant hurdles. The government still holds the levers of state power, including control over law enforcement agencies. Moreover, the judiciary's recent rulings have not favored PTI, and the party remains fractured due to crackdowns on its leadership. Without a clear, unified strategy, PTI may struggle to force early elections or secure Imran Khan's release.

# PSB's failures threaten the future of sports in Pakistan

HE Pakistan Sports Board (PSB), once envisioned as the guardian and promoter of sports in the country, has sadly become a symbol of fail-ure, mismanagement, and neglect. In what can only be termed as an alarming decline, sports in Pakistan-particularly hockey, our national gameare reportedly being stifled under the weight of corruption, nepotism, and ill-conceived policies. The PSB, instead of nurturing talent and encouraging athletic excellence, has turned into a bureaucratic hub of incompetence and favoritism. The latest controversies surrounding the PSB paint a grim picture. # The U.S. Sanctions on Francesca Backfired

N A jarring move that sent shockwaves across the globe, the United States imposed sanctions on Francesca Albanese, the United Nations Special Rapporteur on the Occupied Palestinian Territories, accusing her of "systematic demo-nization" of the U.S. But behind this vague allegation lies a disturbing truth: Albanese's real "offense" was exposing the industrial economy of genocide-one fueled not just by the Israeli government but by a vast network of corporations, hedge funds, universities, and pension systems across the West. Her latest report, "The Economy of Genocide," and a subsequent viral interview laid bare the machinery of death behind the war on Gaza. She revealed how weapons manufacturers, bulldozer suppliers, and construction conglomerates are not merely supporting genocide-they are profiting from it. Israeli bulldozers raze entire neighborhoods, while construction contracts to rebuild illegal settlements flow rapidly. For every bomb dropped, there's a dividend earned; for every displaced family, a new high-rise emerges. But what shocked the conscience of the global public was not merely her confirmation of genocide-it was the financial lifelines she traced. From American surveillance and cloud-computing firms to European pension funds and elite universities, Albanese exposed how deeply this war is sustained by capital flows. Norway's Government Pension Fund alone holds over \$122 billion invested in companies complicit in Israeli occupation and military operations. Similar financial trails lead to Sweden, Germany, France, and the United Kingdom. Even Ivy League institutions like Harvard, Stanford, and NYU-often hailed for social justice advocacyare enmeshed through opaque endowment investments and silent third-party fund managers. These universities, while professing solidarity with Palestine in student forums, funnel capital into firms that supply arms and equipment to Israeli forces. Francesca Albanese did not stop at the economic trail. She painted an unflinching picture of Gaza's humanitarian catastrophe. "More than 75% of those killed in Gaza and the West Bank are women and children," she said, emphasizing that these victims cannot be labeled militants by any legal or moral standard. "Their only crime is being Palestinian." This demographic devastation is not accidental. It is systematic, targeted, and genocidal. Albanese called Gaza

"a living textbook of genocide," fulfilling every criterion under international law-deliberate killings, destruction of living conditions, forced displacement, and erasure of cultural identity. She described how Israeli raids have decimated Palestine's knowledge ecosystem: universities bombed, professors assassinated, students slaughtered, libraries turned to dust. Gaza's last remaining research centers and cultural hubs have been wiped out. It is not only the bodies, but the collective memory and future of a nation being erased. Commerce and civil society lie in ruins. Shops, bakeries, factories, and schools have been obliterated. Gaza is left with no one to educate, to trade, or to heal. The goal is clear: to reduce an entire people to dependency, silence, or oblivion. And yet, this extermination campaign is not funded solely by Tel Aviv or condoned solely by Washington-it is driven by a war economy backed by multinational private contractors. Security firms, tech companies, arms manufacturers, and logistics contractors have turned Gaza into a testing ground and a profit center. These corporations operate in sync with the IDF, often surpassing state authorities in reach and precision. Private surveillance firms now work alongside Mossad, analyzing data harvested by U.S.-built platforms. Francesca Albanese warned: "This is not just a war-it's a joint venture. A business enterprise of destruction." She highlighted that decision-makers in boardrooms, not just war rooms, control this carnage. A faceless ecosystem of fund managers, politicians, and lobbyists keep the war alive. Private defense contractors mint money; lawmakers receive donations; media pundits get scripts. Israel's military policy has become a business model. And what especially rattled the U.S. and Israeli establishments was Albanese's courage in naming these links, not as bystanders but as primary beneficiaries and drivers of genocide. The sanctions on her backfired spectacularly. Francesca Albanese became an instant global icon. Her voice, once confined to UN documents, exploded across media platforms. She became a symbol of defiance, truth, and moral clarity. " have done my job," she stated. "And for that, I was sanctioned. But if telling the truth is punishable, then justice is already dead." She revealed she had contacted 48 of the entities named in her report, offering them a right of reply. Only

15 responded-most with evasive statements. None denied the facts. None divested. "They stay in with full knowledge and full intent," she said. "That makes them complicit." In her concluding message, Albanese offered not just a diagnosis but a remedy. She called for immediate divestment from Israeli-linked corporations, a complete boycott of products manufactured or distributed by complicit companies, and full transparency from universities and public institutions on their financial entanglements. Symbolic gestures are not enough, she argued-only strategic, financial, and civic disassociation from genocide will force change. Yet, as Francesca's voice grows louder, a larger consensus is forming across the political and analytical spectrum. Experts and former officials now agree: the key to stopping the Gaza genocide rests squarely with the United States. A policy reversal by the White House-if backed by public will-could alter the tide. President trump, or his successor, must face the moral and political reckoning of this complicity. No Israeli prime minister, not even Netanyahu, can sustain such a war without uninterrupted U.S. arms, aid, and vetoes. Many now identify Netanyahu's war-mongering policies as the root cause of perpetual conflict. His government must be forced, through sanctions and international legal pressure, to abandon expansionism and militarism. But there's a third force equally dangerous: the war economy itself. Fueled by private contractors, weapon lobbies, and pro-Israel institutions like AIPAC, this machine funds lawmakers, shapes CNN and Fox coverage, and pressures legislatures globally to maintain the killing spree for profit. The time has come for people-not governments-to act. The collective conscience of the world, including Americans, Israelis, and the global Islamic community, must rise. It is time to boycott Israeli goods, end all economic support to war profiteers, and demand democratic action from parliaments to stop the slaughter. If we remain silent now, history will not only condemn the leaders who enabled genocide-it will also judge the nations, societies, and individuals who watched, calculated, and did nothing. Francesca Albanese showed us that genocide is no longer hidden-it's televised, monetized, and outsourced. The question now is not whether we know, but whether we will act.

# Kashmir Martyrs' Day: A Legacy of Defiance and a Call for Justice

Every year on 13 July, Kashmiris pause to remember a day that is not just about grief but also resistance. On this day in 1931, twen-ty-two unarmed Kashmiri Muslims were shot dead by the Dogra regime for giving the adhan (call to prayer) outside Srinagar Central Jail during the trial of Abdul Qadeer. They were not armed rebels. Their only rebellion was faith and the unvielding desire to speak. This day does not mark the beginning of Kashmir's struggle but symbolises a moment when oppression was met with unwavering courage, when prayers were louder than pellets, and when martyrdom became the heritage etched into the soul of the people. Kashmir bleeds again, but this time under a different guise. The uniforms may have changed, the weapons have become more modern-Armed Forces Special Powers Act (AFSPA), pellet guns, digital surveillancebut the intent feels eerily familiar. It is still about silencing Kashmiri identity, erasing memory, and undermining resistance. In many ways, it echoes the events of 1931, when Dogra forces responded to dissent with gunfire. Today, it manifests in curfews, raids, and the slow suffocation of a people's will. What have we actually learned if the international community continues to remain silent, masking its inaction as neutrality? Since the revocation of Article 370 in August 2019, thousands of people, including minors, have been arrested under draconian laws such as the Public Safety Act (PSA) and Unlawful Activities Prevention Act (UAPA). The

region has seen intermittent internet shutdowns, disruptions to education, and limitations on access to healthcare, a humanitarian aspect frequently overlooked in the global arena. The abrogation of Article 370 enabled India to justify militarising Kashmir and staging false flag operations. The Pahalgam incident this April speaks volumes, shrouded in ambiguity and exploited by India to intensify repression and military aggression. something deeper than diplomacy. The way India responded with "Operation Sindoor", bombarding areas in Azad Kashmir along the Line of Control (LoC) and mainland Pakistan, was anything but precise. However, the Pakistan Air Force (PAF) delivered a befitting response to the Indian strikes and shot down seven Indian aircraft including three Rafales and Heron Drone. Following Pakistan's decisive retaliation, India was left no choice but to plead with the US President Donald Trump to mediate a ceasefire and seek Pakistan's cooperation to defuse tensions.

Furthermore, in a tweet on the social media platform X, President Trump publicly expressed his willingness to work with both India and Pakistan toward a lasting resolution on Kashmir. He stated that even if the issue had not been formally discussed, he would "work with [India and Pakistan] to see if, after a thousand years, a solution can be ar-rived at concerning Kashmir". His remarks reinforced what has long been evident: Kashmir is not just a bilateral matter; it is a critical nuclear flashpoint with significant global consequences. Yet, despite diplomatic efforts, India's militarisation and suppression of Kashmiri identity persist unabated. When narratives becomes weaponised, it is the innocent who pay the price, and once again, Kashmir suffers.

But history has a longer memory than power does. The movement that began in 1931 was not about borders, it was about dignity. That fire has not gone out. While official statements are often dismissed as rhetoric, Pakistan's solidarity with Kashmir is rooted in something deeper than diplomacy. It is felt in the sorrow of our poets, in the prayers of our people, in the silence that follows every news bulletin from the Valley. We do not support Kashmir because it is convenient. We support it because we must. Because silence, in the face of such suffering, would make us complicit. Until Kashmiris are allowed to speak freely, live freely, and decide their own future, Pakistan's commitment cannot waver.

Kashmiris have not given up. Resistance has simply changed shape. Where once it was mass protests, it is now poetry, journalism, photography, and quiet acts of resilience. Students, writers, doctors, and civil society activists are continuing the struggle, even when it is less visible to the outside world.

Thus, as we mark this year's Kashmir Martyrs' Day, the question we must ask is not merely how do we remember, but how we honour. Memory is not passive; it is a political act. To remember is to take responsibility. To commemorate is to commit. The 22 martyrs of 1931 did not die to become names in history books or hashtags on social media. They died for a future they believed in-a future where the Kashmiri people could live with dignity, speak without fear, and pray without being punished. That future remains unfinished. And so, our work continues. Let us remember not only the sacrifice but also the vision. Let us not only glorify the past but fight for a just future. For in the echoes of July 13, there is not just sorrow but strength.

# Club World Cup proves it is imperfect but here to stay

EAST RUTHERFORD: The first edition of the expanded Club World Cup wraps up this weekend with FIFA president Gianni Infantino already hailing it as a huge success while the world of football faces up to the idea that an imperfect tournament is here to stay.

Infantino's flagship competition - initially supposed to be launched in 2021 before the pandemic intervened - was derided by many, especially in Europe, before it kicked off. It was seen as an unnecessary addition to a crowded calendar, while there were also doubts as to whether it would win over the public.

Even after it began former Liverpool manager Jurgen Klopp dismissed the competition as the "worst idea ever implemented in football".

However, the last month in the United States has shown that such a viewpoint is surely an exaggeration.

FIFA has earned criticism for the number of empty seats at many matches, but fans have turned out, with around 2.5 million attending games across the country.

South American supporters in particular helped create vibrant and colourful atmospheres, and the average crowd of almost 39,000 before Sunday's final between Paris Saint-Germain and Chelsea was just below that of the English Premier League last season.

"The decisive factor is if the fans like it or not, and the attendances were much higher than expected," insisted Arsene Wenger, FIFA's Chief of Global Football Development. "I don't share the opinion of Jurgen Klopp at all because I feel a real Club World Cup is needed and if you ask all the clubs who were here at this competition I am sure all of them would want to do it again.'

What they would prefer not to have to deal with again is the kind of temperatures that come with playing during the afternoon in a North American summer.

Many matches were impacted by the heat and several faced long delays due to thunderstorm warnings. That looks set to cause major headaches for FIFA at the World Cup in North America next year. "Playing in these temperatures is very dangerous, and obviously for the spectacle... the pace of play is not the same, it slows everything down," complained Chelsea's Enzo Fernandez. That can be looked at for future tournaments, but it will surely be harder for FIFA to do anything about the dominance of Europe's leading clubs. - Agencies

DAZHOU: Japan defeated Pakistan 3-0 to claim the Men's U18 Asia Cup 2025 title at the National Hockey Training Centre on Sunday. # Nai Gaj Dam project stalls again amid funding crisis

Over Rs 23 billion already spent, but construction halts again as WAPDA awaits funds from federal government for payment to the Contractor ; project faces threat of abandonment

KARACHI: The much-anticipated Nai Gaj Dam project a crucial infrastructure development meant to control floods and ensure round the year water supply to transform water and agriculture landscape of region in Dadu district, is now teetering on the brink of collapse due to persistent funding delays, price escalations, and administrative bottlenecks. Nestled in the Kheerthar Range and fed by the seasonal Gaj River, the dam is being constructed under the supervision of WAPDA to address frequent flooding in the Kachho region, enhance irrigation for 28,800 acres, and provide water to Manchar Lake through a 52-kilometer pipeline. It also includes plans to generate 4.2 MW of electricity. However, according to Syed Ali Akhtar Shah, a WAPDA Water Wing official, the project's fate is increasingly uncertain due to the non-release of promised funds. He warned that further delays could nullify the years of effort and billions already invested.

Initially approved by ECNEC in 2009 with a cost of Rs. 16.924



billion, the project was marred from the beginning. The lowest bid in 2012 came in at Rs. 38.792 billion, creating a funding gap and delaying the start. By 2012, a revised PC-I estimated Rs. 59.414 billion, was submitted but at the cost of major cutbacks, including the powerhouse, access roads, and pipeline to Manchar Lake it was approved for Rs. 26 Billion Despite, expectations

to finish by 2015, only 38% of the project had been completed by 2018, with Rs. 11.543 billion released. A scandal in 2018 involving a fake performance guarantee forced WAPDA to terminate the contractor, halting the project for 40 months, until the matter was resolved through Arbitration under directives of High Court of Sindh. In 2021, WAPDA submitted a second revised PC-I

of Rs. 47.732 billion, restoring the key components cut earlier. The work was restarted on October 2021 with understanding to complete the Project in three years by October 2024. However progress again remained slow due to unprecedent price hike in construction inputs followed by Flood ls 2022 which caused flooding and damages of access roads and suspension of work

for about six months. Even after a 2023 agreement to unfreeze the price escalation clause under judgement of Sindh High Court in November 2022 WAPDA faced fresh difficulties in payment to the Contractor.

In FY 2024-25, the federal government allocated Rs. 5 billion, but released only Rs. 3 billion, insufficient to maintain momentum but this financial year 2025-26, the total 500 million rupees were allocated which caused more disturbance in the completing of work of the project as contractor halted work site. By March 1, 2025, work was suspended once again due to non-release of further funds. Rafiq Ahmed Jamali, PPP MNA from Dadu, told this Correspondent that chronic underfunding has made it impossible for the project to meet targets. He emphasized the importance of resuming and sustaining progress. Former federal minister Liaquat Ali Jatoi warned that the contractor may terminate the contract entirely if dues are not cleared promptly. "This would mean a total waste of over Rs. 23.231 billion already

invested," he said, urging immediate intervention by both federal and provincial governments.

# BMP warns of severe backlash as FBR refuses to roll back controversial law Anjum Nisar warns entire business community gearing up for a nationwide agitation

ISLAMABAD: Mounting anger is sweeping through Pakistan's industrial and trade sectors as the Businessmen Panel (BMP) of the Federation of Pakistan Chambers of Commerce and Industry (FPCCI) sharply criticized the Federal Board of Revenue's refusal to withdraw controversial tax measures, particularly the arrest powers granted under new income tax laws. In a forceful statement on Sunday, BMP Chairman Mian Anjum Nisar warned that the entire business community, backed by all major chambers and associations, is gearing up for a nationwide agitation if the government fails to reverse the "anti-business" steps and continued enforcement of e-invoicing and harsh cash transaction penalties. He said that the authorities have chosen a confrontational path at a time when the economy is still recovering from years of instability, high inflation, currency depreciation, and shrinking purchasing power. According to him, empowering the Federal Board of Revenue (FBR) to arrest taxpayers on mere allegations of fraud, without due judicial process, violates the fundamental principles of justice and commercial trust. Mian Anjum warned that if these draconian powers are not repealed, it will become nearly impossible for the business community to cooperate with the tax administration. The use of coercive instruments to force compliance will only lead to distrust, fear, and ultimately the collapse of whatever formal economic activity remains. He said the entire industry, including textile, retail, manufacturing, services, and even the export sector, is disturbed by the growing interference of tax authorities in day-to-day operations, particularly the mandatory deployment of FBR staff in factories, the compulsion of e-invoicing, and restrictions on cash dealings. He emphasized that businessmen across the country are not against documentation or reform, but such changes must be introduced through consultation, confidence-building, and reasonable timelines. Forcing compliance through fear will not only hurt genuine tax filers but will also discourage new entrants into the tax net, which is contrary to the stated goals of broadening the base.

He echoed similar concerns, stating that the new rules introduced under Section 21 of the Income Tax Ordinance are impractical and insensitive to ground realities. He pointed out that small and medium enterprises (SMEs), which form the backbone of Pakistan's economy, often rely on partial cash dealings due to supplier terms, payment cycles, or banking limitations in remote areas. Penalizing 50% of such expenses by treating them as income is an unfair and illogical

# Ahsan reviews implementation of sectoral action plan

ISLAMABAD: Minister for Planning Development and Special Initiatives Ahsan Iqbal on Sunday chaired a high-level meeting to review the implementation and finalization of the sectoral action plan based on the Chinese Experts' Report. The meeting was attended by Secretary Planning Awais Manzur Sumra, Vice Chancellor PIDE, Chief Economist, Project Director CPEC Secretariat and senior officials from various ministries and divisions, said a press release. The report shared by the Chinese Embassy was prepared by Chinese Working Teams following their visit to Pakistan to assess potential areas of enhanced economic cooperation. The report outlined key observations and recommendations in different sectors such as connectivity, the development of a national agricultural plan, Gwadar Port linkages, IT collaboration, and other strategic areas. The ministries were requested to review the report and provide feedback. In line with the directions of Prime Minister Muhammad Shehbaz Sharif, 10 federal focal groups were constituted to develop sector-specific action plans in response to the technical assessments presented by the Chinese expert teams. Since then, the Ministry of Planning under the chairmanship of Minister Ahsan Iqbal, has held multiple rounds of meetings to shape the final action plan and has consistently encouraged the ministries to align their inputs with Chinese recommendations and outline a clear path forward. Today during the meeting, all relevant ministries discussed the sectoral suggestions made by the Chinese teams and presented updates on their respective projects. Minister Ahsan Iqbal directed that each ministry must prepare a comprehensive response based on the Chinese Experts' Report so that the CPEC Secretariat can compile and submit a unified, detailed reply to the Chinese side.-APP

# **Pak-Vietnam** explores renewal of bilateral banking framework

HANOI: Federal Minister for Commerce, Jam Kamak Khan held a meeting today with Dr Hoang Trung, Deputy Governor of the State Bank of Vietnam (SBV), to discuss avenues for enhanced financial cooperation between Pakistan and Vietnam.

Both sides recalled the Memorandum of Understanding (MoU) signed in 2004 between the State Bank of Pakistan (SBP) and SBV, and welcomed the proposal to renew and modernize the agreement in view of evolving financial landscapes and growing bilateral trade, said a release issued here on Saturday. It was acknowledged that a renewed MoU could serve as a foundational framework to support banking cooperation, promote cross-border investment, and facilitate regulatory collaboration. In particular, both parties recognized the importance of incorporating emerging areas such as digital transactions. QR code-based payment systems, and financial inclusion into the future scope of cooperation. The Minister appreciated Vietnam's advancements in digital banking and expressed interest in leveraging Vietnam's experience to support Pakistan's financial innovation efforts. Both sides reaffirmed the role of central banks in enabling an environment conducive to economic and commercial engagement. The meeting concluded with a commitment to maintain institutional linkages through the SBP's International Relations Department for structured follow-up.-APP

# Syria wildfires contained after 10 days

DAMASCUS: Syria's civil defense agency on Sunday said wildfires in the country's west, which have burned vast tracts of forest and farmland and forced evacuations. had been brought under control after 10 days. In a statement on Facebook, the agency said that "with the spread of the fires halted and the fire hotspots brought under control on all fronts" on Saturday. teams on the ground were working to cool down the affected areas while monitoring any signs of reignition. The blazes in the coastal province of Latakia broke out amid an intense heatwave across the region. The UN humanitarian agency OCHA said they destroyed about 100 square kilometers of forest and farmland. As the fires raged, Syrian emergency workers faced tough conditions including high temperatures, strong winds, rugged mountainous terrain and the danger of explosive war remnants.-APP

# **Punjab Finance Minister** meets CAP delegation

LAHORE: Punjab Finance Minister Mian Mujtaba Shuja-ur-Rehman held a meeting with a delegation of Chainstore Association of Pakistan (CAP) at here Civil Secretariat on Saturday. The meeting was convened in response to CAP's concerns regarding the recent imposition of 16 percent sales tax on commercial property rent by Punjab Revenue Authority (PRA). The delegation formally requested a review of the decision, citing its potential impact on the organized retail sector. During the meeting, the Finance Minister briefed the delegation about the provincial government's fiscal policies, tax reforms, and budgetary priorities. He clarified that no new taxes have been introduced in the provincial budget over the past two years. Instead, the government's focus remains on ensuring the effective enforcement and collection of already applicable taxes in line with the broader reform agenda. Mujtaba highlighted that PRA is working to broaden the tax base and enhance provincial revenue collection capacity to achieve greater fiscal autonomy. The Minister noted that while most taxes, including income tax, fall under the jurisdiction of the federal government, the PRA is responsible for collecting sales tax on services within the province. To improve clarity and transparency in tax policy, the PRA is currently developing a "negative list" - a comprehensive list of services that will be exempt from sales tax. This initiative aims to simplify compliance and create a business-friendly tax environment. Acknowledging the concerns raised by the business community, he reaffirmed the government's commitment to supporting businesses, promoting ease of doing business, creating employment opportunities, and fostering economic growth. He assured the delegation that their recommendations would be thoroughly reviewed and that the government would extend relief where feasible. Finance Minister also urged traders to fulfill their tax obligations responsibly and play their role in supporting the province's economic progress. The delegation included CAP's Patron-in-Chief Rana Tariq Mehmood and Chairman Mr. Asfanyar Farrukh. The representatives appreciated the Punjab Government's reform initiatives and assured their full cooperation in efforts aimed at strengthening the provincial economy.-APP

# Are CF Gujranwala and DFO Changa Manga more powerful than the Punjab government?

Hollow claims and slogans will not suffice; the Punjab government must demonstrate its resolve through concrete steps

HE Punjab Forest Department faces significant challenges that undermine its effectiveness in managing and preserving the region's vital forest resources. Despite the department's critical role in environmental conservation, systemic issues such as absenteeism, favoritism, and corruption among senior officials, coupled with inadequate accountability measures, have hindered progress.

To restore the department's integrity and functionality, the Punjab government must prioritize practical reforms over empty promises, including transparent investigations, forensic audits, and stricter tenure policies for forest officers. One of the primary concerns is the absenteeism and misuse of authority by senior forest officers. For instance, Forest Officer Mazhar, previously the Deputy Project Director of UGPP and now Conservator in Gujranwala, exemplifies this issue. Reports indicate that he rarely attends his office in Gujranwala, instead spending most of his time in Lahore to curry favor with senior officials, such as the Secretary Forest. He visits his post only during meetings or inspections.

Mazhar allegedly claims allowances for fictitious field visits, exploiting the system for personal gain. Can Mazhar's posting be limited to Lahore and its surrounding areas, rather than South Punjab,

since he resides in Lahore? This behavior sets a poor example for junior staff, who are unlikely to maintain discipline or commitment when their leadership is absent or disengaged. Such absenteeism undermines the department's operational efficiency and erodes public trust. The mismanagement of Changa Manga, one of Punjab's most significant forests, further highlights the department's challenges. Illegal logging and timber theft have plagued this forest, with investigations in 2011-2012 exposing widespread corruption. The Anti-Corruption Establishment (ACE) registered cases against

27 forest department officials for timber theft, and in June 2012, then-Chief Minister Shahbaz Sharif took decisive action by designating the Chief Conservator and Conservator as Officers on Special Duty (OSD) due to their negligence. The Chief Minister ordered a comprehensive inquiry by the Punjab Anti-Corruption Establishment and the Chief Minister's Inspection Team (CMIT) into all Divisional Forest Officers (DFOs), Sub-Divisional Forest Officers (SD-FOs), Block Officers, and Forest Guards posted in Changa Manga since 1990. These efforts failed to deliver meaningful results, as no significant punishments were enforced, allowing corrupt practices to persist. A striking example of ongoing issues is the repeated posting of Agha Hussain as both DFO and SDFO in Changa Manga. Despite the forest's history of

mismanagement, Agha Hussain's recurring appointments raise questions about favoritism and political influence within the department. The consistent placement of certain officers in key positions, particularly those backed by political figures or senior officials, suggests a lack of merit-based assignments. This practice not only stifles accountability but also enables the continuation of exploitative activities, such as illegal logging, under the protection of influential networks. To address these systemic issues, the Punjab government must adopt practical and transparent measures. First, it should immediately remove officers like Mazhar and Agha Hussain from their current posts and conduct a thorough, impartial investigation into their conduct.

A forensic audit of their offices,

focusing on financial records and attendance, would provide clarity on the extent of their absenteeism and potential financial impropriety. Second, the government should enforce a policy limiting the tenure of forest officers to three years in any single post, preventing entrenched networks of corruption from forming. Officers who have served beyond this period should be reassigned to ensure fresh perspectives and accountability. A special audit of the Kasur Forest Division, which includes Changa Manga, should be conducted for the past decade to uncover any irregularities in management and resource allocation. This audit must be transparent, with findings made public to restore trust in the department. The government should also strengthen the implemen-

tation of past directives, such as the 2012 inquiry ordered by the Chief Minister, ensuring that those found guilty of negligence or corruption face appropriate consequences.The Punjab Forest Department's challenges are not insurmountable, but they require decisive action and a commitment to reform. Hollow claims and slogans will not suffice; the government must demonstrate its resolve through concrete steps. By addressing absenteeism, curbing favoritism, and enforcing accountability, the Punjab government can revitalize the department and protect the region's forests for future generations. The question remains whether the government will rise to the occasion or continue to rely on rhetoric without action.







# Briefs Israeli strikes kill at least 27

GAZA CITY: Gaza's civil defence agency said Israeli air strikes on Sunday killed at least 27 Palestinians, including six near a water distribution point. Civil defence spokesman Mahmud Bassal told AFP that Gaza City was hit by several strikes over night and in the early morning, killing eight people "including children and women' and wounding others.

An Israeli air strike hit a family home near Nuseirat refugee camp, south of Gaza City, resulting in "10 martyrs and several injured", Bassal said.

Another strike "hit a potable water distribution point... in an area for displaced people west of the Nuseirat camp", Bassal added, reporting "six martyrs and several injured".

In the territory's south, three people were killed when Israeli jets hit a tent sheltering displaced Palestinians in the coastal Al-Mawasi area, according to the civil defence spokesman. There was no immediate comment from the Israeli military, which has recently intensified its operations across Gaza, more than 21 months into the war triggered by Hamas's October 2023 attack. - Agencies

# No change in electricity peak hours

ISLAMABAD: The Power Division has refuted reports claiming an increase in electricity peak hours, reaffirming that no changes have been made to the existing schedule. The specified four-hour window is standard, as electricity demand surges after sunset due to increased lighting and air-conditioning usage, especially in urban commercial centres that remain open late into the evening. This pattern adjusts seasonally based on sunset timings and has been consistently followed for years. To meet the high demand, several power plants - including expensive ones not operated during normal or low load conditions - must be run.

# Macron to raise French defence targets, citing **Russia threat**

PARIS: President Emmanuel Macron is on Sunday to set new French defence targets in the face of a menacing Russia and a potential United States disengagement from Europe, his office said. "Defence efforts" must be made in the face of mounting threats and a disintegrating world order, Elysee officials said ahead of the president's 7:00 pm (1700 GMT) speech to the armed forces, traditionally held on the eve of France's nation-

al Bastille Day holiday. Despite France's difficult budgetary situation, the president's announcements will be "major", they said. French military and se-

curity officials have been warning of global threats weighing on France, with Defence Chief of Staff Chief Thierry Burkhard saying on Friday that Russia posed a "durable" threat to Europe and that the "rank of European countries in tomorrow's world" was being decided in Ukraine, invaded by

Russia in 2022. Russia currently views France as its "main adversary in Europe", Burkhard said. He also warned of the consequences of a diminished US commitment to Europe, along with cyber threats, disinformation campaigns and the risk of terror attacks. - Agencies

# NDMA Spokesperson calls for public caution

ISLAMABAD: NDMA Tech Team Lead & Spokesperson Dr. Tayyab Shah Sunday urged citizens to avoid crossing bridges, streams or inundated roads during periods of high water flow and called for enhanced inter-agency cooperation to ensure effective emergency response and public safety. Talking to a local news Spokesperson channel, said that according to the latest weather predictions by the Meteorological Department, the third spell of monsoon is expected to begin on Monday. He warned that this could lead to heavy rainfall in several regions, increasing the risk of urban and flash flooding in vulnerable areas.

SEOUL: North Korean leader Kim Jong Un offered Moscow his full support for their war in Ukraine during talks with Russian Foreign Minister Sergei Lavrov, Pyongyang state media said Sunday. Lavrov's visit to North Korea was the latest in a series of high-profile trips by top Moscow officials as both countries deepen military and political ties amid Russia's offensive against Kyiv. Pyongyang sent thousands of troops to Russia's Kursk region to oust Ukrainian forces and has also provided the Russian army with artillery shells and missiles.

Kim and Lavrov met on Saturday in "an atmosphere full of warm comradely trust", North Korea's official KCNA news agency reported. Russia's foreign ministry posted a video on Telegram of the two men shaking hands and greeting each other with a hug.

It said the talks were held in Wonsan, a city on North Korea's east coast where a massive resort was opened earlier this month - one of leader Kim's pet projects.

# Four members of woman's family killed by husband

PESHAWAR: Four members of a woman's family were shot dead on Saturday in the Tatara area of Khyber Pakhtunkhwa's Nowshera district, allegedly by her husband and inlaws over a domestic dispute, police said.

Nowshera police spokesperson, Turk Ali Shah, told Dawn.com that a first information report (FIR) has been lodged at the Akbarpura police station under section 302 (Punishment for Qatl-i-amd) and section 324 (Attempt to commit murder) of the Pakistan Penal Code on the complaint of the woman, whose parents, brother, and uncle were killed in the attack allegedly by her hus-

band, his brothers and father.

Lavrov told Kim that Putin "hopes for continued direct contacts in the very near future", according to the Russian state-owned news agency TASS. - DNA

According to the FIR, a copy of which is available with Dawn.com, the complainant, a mother of two, said she married her husband a few years ago, but since then had been facing domestic issues and was living with her parents for the last four months. Police spokesperson Shah said, "Efforts were underway to arrest the suspects who had fled the scene after the incidents."



# **Farm worker** dies after US immigration raid

WASHINGTON: DA farm worker has died after being injured during a raid by US immigration agents on a legal cannabis farm in California, his family said on Saturday. Raids on agricultural sites on Thursday resulted in the arrests of 200 undocumented migrants, as part of US President Donald Trump's wide-ranging anti-immigration crackdown, and clashes between law enforcement officials and protesters. The farm worker's family had started a page on the fundraising platform GoFundMe to help support his relatives in Mexico. On Saturday, the page posted an update to say he had "passed away." Trump campaigned for the presidency on a harsh anti-immigration platform, likening undocumented migrants to "animals" and "monsters," and since taking office he has delivered on promises to conduct a massive deportation drive. On Friday, he called demonstrators involved in attacks on Immigration and Customs Enforcement (ICE) agents "slimeballs" and said they should be arrested. The chaotic raid on the cannabis plantation in Ventura County, about 90 kilometres from Los Angeles, saw the worker who later died being chased by ICE agents, his family said. "My uncle Jaime was just a hard-working, innocent farmer," said a post on the GoFundMe page. "He was chased by ICE agents, and we were told he fell 30ft (9 meters)." The page described his injuries as "catastrophic." Tricia McLaughlin, a Department of Homeland Security (DHS) spokeswoman, said he was never in custody. "Although he was not being pursued by law enforcement, this individual climbed up to the roof of a green house and fell 30 feet," McLaughlin said. "(Customs and Border Patrol) immediately called a medevac to the scene to get him care as quickly as possible." DHS said 200 undocumented migrants were arrested during raids on marijuana growing sites in Carpinteria and Camarillo on Thursday and 10 children were rescued "from potential exploitation, forced labor, and human trafficking." Glass House Brands, which owns the farms, said in a statement that it has "never knowingly violated applicable hiring practices and does not and has never employed minors." DHS said more than 500 "rioters" had attempted to disrupt the operation and four US citizens are facing charges for assaulting or resisting officers. Tear gas was used against the protesters, some of whom were seen in television footage throwing projectiles at law enforcement vehicles.
