# **Cross border issues Pakistan hits** back at India

"It is India which actively sponsors, aids and abets terrorism in my country and beyond," Ambassador Usman Jadoon, deputy permanent representative of Pakistan to the UN, told the 15-member body

UNITED NATIONS: Rejecting Indian allegations of cross-border terrorism, Pakistan has asked India to change its behaviour, instead of resorting to its "tired narrative of victimhood and blame-shifting" during a UN Security Council debate on 'Promoting International Peace and Security through Multilateralism and Peaceful Settlement of Disputes'. "It is India which actively sponsors, aids and abets terrorism in my country and beyond," Ambassador Usman Jadoon, deputy permanent representative of Pakistan to the UN, told the 15-member body on Tuesday evening, while responding to the allegations made by India's UN Ambassador Parvathaneni Harish.

"Rather than being blinded by hubris and a misplaced sense of impunity, and instead of resorting to its tired narrative of victimhood and blame-shifting, India must introspect seriously, change its behaviour and comply with its international legal obligations on all counts," he said in the debate convened by Pakistan to promote pacific settlement of disputes between nations. Ambassador Jadoon said it was especially regrettable that the Indian Ambassador targeted Pakistan on Tuesday when earlier in the day, the Council spoke with a unanimous voice to reaffirm the purposes and principles of the UN Charter and the imperative of peaceful settlement of disputes, respect for international law and effective implementation of the resolution of the Security Council. The Indian envoy was reacting to Pakistani Deputy Prime Minister and Foreign Minister Mohammad Ishaq Dar who underscored the need for the resolution of Kashmir dispute in a speech he gave in his national capacity after the adoption of Pakistan-sponsored resolution calling for the peaceful settlement of disputes.

### Dar for inclusive dialogue

**NEW YORK: Deputy Prime Minister and Foreign** Minister (DPM/FM), Senator Mohammad Ishaq Dar, on Wednesday called for an inclusive dialogue and cooperative diplomacy over confrontation amid times of growing turbulence across the world as "the cost of unresolved disputes, long-running conflicts, unilateral actions, and disregard for international law are being felt in every region."

In his address delivered at the reception hosted by Pakistan's Mission in New York on the occasion of Pakistan's Presidency of the UN Security Council, the DPM emphasized Pakistan's unwavering commitment to multilateralism, peaceful dispute resolution, and the foundational principles of the UN Charter. Speaking to diplomats, UN officials and representatives of member states, Dar underscored that at the heart of Pakistan's foreign policy was a firm belief in multilateralism and the rule of international law. "The purposes and principles enshrined in the UN Charter, especially the peaceful settlement of disputes and the non-use or threat of force, are foundational to the United Nations and indispensable for a just international order," he stated.

In the midst of higher United States (U.S.) tariffs and global trade uncertainty, Pakistan provisionally grew 2.7 percent in FY2025 (ended 30 June 2025), resulting in the slight upward revision for FY2025, while the sustainable growth forecast for FY2026, according to Asian Development Outlook (ADO) July 2025 released Wednesday. In Pakistan, the accelerated decline in food and nonfood prices for the first 11 months of FY2025 revised the inflation forecast for FY2025 downward, Continued on Page 06

### India to resume issuing tourist visas to Chinese

Tourist visas for Indian nationals remained restricted until March this year

**T**NDIA will resume issuing tourist visas to Chinese citizens from July 24 this year, its embassy in China announced on Wednesday, marking the first time in five years that both countries are working to repair

their rocky relationship. Tensions between the two countries escalated following a 2020 military clash along their disputed Himalayan border. In response, India imposed restrictions on Chinese investments, banned hundreds of popular Chinese apps and cut passenger routes. China suspended visas to Indian citizens and other foreigners around the same time due to the COVID-19 pandemic, but lifted those restrictions in 2022, when it resumed issuing visas for students and business travellers.

**Total audit-flagged** irregularities: Over **Rs 17 billion** 

Minister Distances Himself from Gorakh Hills Audit Scandal, Blames Predecessor; Tourism Minister Syed Zulfigar Ali Shah says no funds were spent during his tenure; blames ex-Chairman PPP MNA Rafiq Ahmed Jamali for financial mismanagement

KARACHI: An important meeting regarding the Gorakh Hill Station was chaired by Sindh Minister for Culture and Tourism, Syed Zulfiqar Ali Shah. The meeting was attended by the acting secretary, Director General of Gorakh Hill Station, MD Tourism, and other concerned officials. The participants expressed grief over recent unfortunate incidents involving tourists in northern areas and offered pravers for the deceased. Minister Syed Zulfiqar Ali Shah was briefed on the current situation of Gorakh Hill Station, including developmental works and funding, after the dissolution of the Gorakh Hill Authority. The Minister issued strict instructions for action against corruption and irregularities in Gorakh Hill Station's funds. He revealed that no new budget or funds have been issued since the hill station was merged into the Department of Culture and Tourism. Syed Zulfigar Ali Shah clarified that since the merger, no new corruption cases have surfaced. He emphasized that the Auditor General's report highlighting irregularities is from two years ago, during the time when Gorakh Hill operated as an independent authority. He announced that the Culture and Tourism Department has decided to refer past corruption matters related to Gorakh Hill to the Anti-Corruption Establishment and NAB (National Accountability Bureau). Furthermore, he stated that the recruitment of surplus employees at the hill station has been canceled and inquiries have been initiated. Strict action is being taken against officers, contractors, and employees found involved in corruption. With the special attention of Chief Minister Sindh Sved Murad Ali Shah, a highway-style road is being constructed to improve access to Gorakh Hill Station. The Minister also highlighted that under the Public-Private Partnership model, providing better facilities and resources for tourists remains a top priority Amid a damning audit exposing massive financial irregularities at the Gorakh Hills Station Authority, while, exclusively talking to a Senior Journalist, Sindh's Minister for Culture and Tourism, Syed Zulfiqar Ali Shah, has publicly distanced himself from the scandal, attributing all questionable transactions to the tenure of former Chairman and PPP MNA Rafiq Ahmed Jamali. In a formal statement, Minister Shah clarified that he took charge as Chairman of the Authority only a year ago and has not utilized even a single rupee from the Rs 250 million grant allocated to the Authority under his leadership. "No payments have been made during my tenure, neither to contractors, daily wage staff, nor to any contract employees," he stated. He further noted that no official meetings of the Gorakh Hills Authority have taken place during his chairmanship, reinforcing his stance of non-in-

volvement in any of the audit-flagged transactions. Minister Shah affirmed that while the Culture and Tourism Department's other projects have been executed with transparency and in full compliance with rules, Gorakh Hills remains the only project under audit scrutiny. "This is precisely why I have chosen to stay away from its new destinations and infrastructure to boost domestic and international tourism. The statement comes as the audit report accuses the Gorakh Hills Authority of awarding fake contracts, overspending by billions, avoiding taxes, and failing to deliver on ground despite years of funding. The total audit-flagged mismanagement is estimated at over Rs 17 billion. Minister Shah's distancing signals potential political tension within PPP ranks, as accountability questions mount and pressure builds for judicial inquiry and recovery of funds misused under previous administrations.

### Nuclear Security in the Middle East The Role of Saudi Arabia as rising stakeholder discussed the critical importance of nuclear portunities and challenges associ-

ISLAMABAD: The Institute of Regional Studies (IRS) hosted an insightful talk on "Nuclear Security in the Middle East: The Role of Saudi Arabia as a Rising Stakeholder", focusing on the country's evolving nuclear trajectory amidst the complexities of a volatile regional landscape. Dr. Rizwan Naseer, Senior Research Fellow at the Institute of Regional Studies, delivered the opening remarks, emphasizing

politics for scholars in the field of strategic studies. He highlighted the growing relevance of nuclear governance regimes such as the Non-Proliferation Treaty (NPT) in light of increasing proliferation challenges and international pressure on nuclear-capable states. The principal talk was delivered by Dr. Zafar Nawaz Jaspal, Dean and Meritorious Professor at the School of Politics and International Relations, Quaid-i-Azam University. Dr. Jaspal discussed both the op-

ated with nuclear energy for Saudi Arabia, noting its evolving nature, particularly in response to ongoing conflicts in the Middle East including the resurgence of inter-state warfare after nearly three decades. . Jaspal identified four primary drivers behind Saudi Arabia's nuclear policy. "One of the drivers of Saudi Arabia's nuclear policy is the strategic competition with Iran, followed by Iran's ability to remain within the NPT and pursue its nuclear potential. The third driver is the transformation in international politics, followed by the sustainability and

durability of nuclear energy." Addressing concerns surrounding nuclear energy, Dr. Jaspal contended that much of the alarm is rooted in the nuclear energy's capacity to reshape the nature of warfare. He argued that while all forms of energy carry risks, the consequences of nuclear accidents are statistically less severe than those associated with coal mining, a point often highlighted by nuclear energy proponents.

Water Tank Islamabad.....0321-5744480 ISLAMABAD: The price control magistrates on Wednesday sealed one shop and arrested five shopkeepers as part of ongoing operation by the Islamabad district administration against retailers charging above the official sugar price. According to the spokesman of ICT administration, in response to rising complaints about overpriced sugar in markets, the Islamabad Capital Territory (ICT) administration has intensified its action against profiteers.

Five held, one shop

Acting on the directives of Deputy Commissioner Irfan Nawaz Memon, the price control magistrates carried out surprise inspections in various parts of the city Several grocery stores were found selling sugar at rates higher than those set by the government. As a result, one shop was sealed, and five shopkeepers were taken into custody for violating official price guidelines. Deputy Commissioner Irfan Memon has directed that action must be taken without discrimination against all retailers who fail to comply with the notified sugar rates. He instructed officials to ensure that no store is allowed to overcharge, and strict penalties should be imposed where violations are found. The crackdown aims to ensure price stability and protect citizens from unjustified increases in daily-use commodities. Memon emphasized that any officer found negligent in enforcing the official sugar rate in their assigned area would also face disciplinary action. "Strict enforcement is necessary. If sugar is being sold at inflated prices in any locality, the concerned area officer will be held accountable,' he stated during a meeting with monitoring teams. The district administration has also urged the public to support the effort by reporting shops that are charging more than the official rate. "We request citizens to help us identify those selling sugar at inflated prices. Their cooperation is important to keep prices under control," the DC said. To improve monitoring, the Additional Deputy Commissioner General has been tasked with submitting detailed reports on price compliance across all zones of Islamabad. The goal is to maintain transparency in market operations and address pricing irregularities quickly. Teams of price control magistrates will continue inspections in both urban and rural sectors, including busy commercial areas and small neighborhoods. They have been told to check not only sugar prices but also other essential items listed under government-fixed rates.-APP

### Drive to comprehensively address marine pollution

ISLAMABAD: The Ministry of Maritime Affairs launched the campaign to comprehensively address the marine pollution threatening to the blue economy, harming biodiversity, fisheries, and tourism, while contributing to climate change, public health risks, and economic losses. Talking to APP, Ministry of Maritime Affairs' official told on Wednesday that Federal Minister for Maritime Affairs Muhammad Junaid Anwar Chaudhry has already established two committees to identify issues and submit a report with suggestions to promote cleaner coastlines, a healthier marine ecosystem, and a stronger system for pollution control. He said that the committees will focus on the Sewage Treatment Plant-III (SPT-III) project and the Combined Effluent Treatment Plant (CETP), a treating wastewater from various industrial sources and will submit report to the Marine Pollution Control Board within 20 days. He stressed the urgent need for a comprehensive public awareness campaign, calling for the active involvement of all stakeholders to foster community engagement in efforts to combat marine pollution. "Land-based marine pollution particularly the discharge of untreated sewage and solid waste into coastal waters can be reduced by up to 90 percent through targeted and effective measures," he added. He elaborated on the wide-ranging consequences of marine pollution, noting that it undermines fisheries and tourism, inflicts economic losses, poses public health risks through contaminated seafood, exacerbates climate change, and endangers the livelihoods of fishermen and coastal communities. To combat solid waste pollution, the official said several mitigation measures have been taken by the ministry such as installing nets on stormwater drains (nullahs), fencing rivers, and deploying systems to remove floating trash from the harbor.-APP

### Pakistan not ready for any water crisis: Sherry

ISLAMABAD: Chairperson of Senate Standing Committee on Climate Change, Senator Sherry Rehman, convened the committee meeting on Wednesday to address the alarming scale of climate-induced disasters and Pakistan's growing vulnerability to ex-

treme weather events. The committee took serious note of the monsoon devastation, outdated disaster response infrastructure, and rapid groundwater depletion that is exacerbating the country's water crisis, said a press release. Senator Rehman underscored that from June 26 to July 22, Pakistan has already lost 242 lives, while 598 people have been injured due to heavy monsoon rains. "Just in the past 24 hours, 21 people have died, and 6 were injured. This is not a oneoff tragedy-this is climate change in motion, and Pakistan is ranked number one in climate vulnerability," she stated. She condemned the unplanned construction on natural waterways, citing

Saidpur Village and DHA Rawalpindi as examples where negligence led to lives lost and infrastructure destroyed. "We cannot call this a natural disaster anymore. That absolves us of responsibility. These are human-induced disasters fueled by poor planning and inaction in the face of climate change," she remarked. Senator Rehman noted that search operations are still underway for a father and daughter swept away in DHA Rawalpindi. She stressed that tourist activity must be restricted in Gilgit-Baltistan, where emergency conditions continue. Sherry Rehman noted that no ministry could provide a map of Pakistan's groundwater extraction on any scale. Groundwater extraction and water scarcity were on the agenda of the Senate Standing Committee for Climate Change. The Water Resource Ministry was also struggling with answers on surface water consumption per capita, as well as how many tube wells we have working in the country for agriculture,

and how many are recharging. No ability to map the scale of usage for irrigation or normal consumption. She noted, "For a country that has been declared water scarce by the U.N. this year, no evidence of harvesting water in PSDP or other planning, especially while we go through a torrential monsoon. It was a totally fragmented and inadequate response." Senator Rehman further pointed out that Pakistan lacks a modern early warning system, despite the UN Secretary-General's repeated calls to treat early warning as a basic human right. "We are still using a 1912 model to issue warnings. Meanwhile, the rest of the world is using real-time, AI-enabled systems," she said. Officials requested that the Senate Committee issue directions to the provinces to strengthen their early warning efforts, to which Senator Rehman assured full cooperation, stating that directives would be issued to both provincial and district administrations.-APP

# Dam spillways reopened as rain raises water level

According to the spokesperson of the ICT administration, heavy and uninterrupted rainfall in Islamabad pushed the water level in Rawal Dam to 1,749 feet, slightly above its prescribed limit. After reviewing the situation, the administration decided to reopen the dam's spillways to control the excess water

ISLAMABAD: The district administration of Islamabad decided to reopen the dam's spillways on Wednesday to manage the rising water, as Rawal Dam's water level crossed the safety threshold following continuous rainfall. According to the spokesperson of the ICT administration, heavy and uninterrupted rainfall in Islamabad pushed the water level in Rawal Dam to 1,749 feet, slightly above

its prescribed limit. After review-

ing the situation, the administration decided to reopen the dam's spillways to control the excess water. Official sources confirmed that the spillways were opened at 11 a.m. today. The step aims to ensure safe water discharge and prevent any overflow that could impact surrounding areas. The district administration has also directed all relevant departments to implement precautionary measures. Authorities have been instructed to remain alert and follow standard procedures during the water release. Residents liv-

ing in nearby areas have also been advised to stay cautious. The administration urged people in low-lying and adjoining localities to remain informed and take necessary safety steps. There have been several instances in recent days when the spillways were opened due to rising water levels. With forecasts predicting more rain, officials say the situation is being closely monitored.

All concerned departments, including the Islamabad Capital Territory (ICT) administration, Rescue 1122, and the Water and Sanitation Agency (WASA), remain on high alert. Rescue and emergency teams have been placed on standby to handle any emergency. Meanwhile, the public has been asked to avoid unnecessary movement near the spillway and dam areas during the water release operation. Officials reiterated that the measure is a routine response to prevent flooding and ensure the safety of infrastructure and nearby communities. Continuous rain

in Islamabad over the past few days has led to waterlogging in various parts of the city. Drainage teams have been deployed to clear blocked water channels, and field staff are inspecting low-lying zones.

Authorities have urged citizens to report any emergencies via the helplines established by the district administration. The administration stated that it will issue further updates if the situation changes and has appealed for public cooperation during this period.

### **Pakistan's** seafood exports to China surge in H12025

ISLAMABAD: Pakistan's seafood exports to the Chinese market showed significant growth in the first six months of 2025, with several categories experiencing a sharp increase in demand, according to data from the General Administration of Customs of the People's Republic of China (GACC). A major contributor to this trend was frozen fish (HS Code 03038990), with exports from H1 2025 valued at \$27.51 million, a 26% increase from the \$21.88 million recorded during the same period last year. Pakistan shipped 15.47 million kilograms of this product, at an average price of \$1.77 per kilogram. Other seafood categories also performed strongly during this period, sources from Pakistan's Ministry of Commerce told Gwadar Pro.

Frozen cuttlefish exports \$14.31 million reached from 5.76 million kilograms shipped. Chilled crab exports grew by 12% to \$12.85 million. Frozen octopus exports saw a remarkable 63% rise, reaching \$9.018 million compared to \$5.53 million in the previous year. Notably, Frozen sardines, sardinella, and brisling category experienced a 340% surge in value, with exports totaling \$7.49 million, up from \$1.70 million last year. The export volume was 12.39 million kilograms, making Pakistan the top supplier of this category to China.

### ANF recovers over 738 kg drugs

ISLAMABAD: Anti-Narcotics Force (ANF) while conducting 11 operations across the country managed to recover over 738 kg drugs worth more than over Rs 253 million and arrested 12 drug traffickers during two days. According to an ANF Headquarters spokesperson, in an operation at Allama Iqbal International Airport, cargo shed, 300 grams opium was recovered from a parcel booked for Canada. In second operation at Faisal Bus Terminal near Islamabad, 2.5 kgs heroin, 2.4 kgs hashish, & 1 kg ice were recovered from the possession of three suspects. ANF recovered 56 kgs hashish from a vehicle checked near University Road, Peshawar, and a drug trafficker was arrested. In 4th operation near Garh Mor Road, Muzaffargarh, 7 kgs ice was recovered from two suspects, traveling in a truck while in an operation near DG Khan Road in Loralai, 168 kgs heroin hidden for smuggling was recovered. In an operation against drug traffickers near Toll Plaza Road, Mansehra, 18 kgs hashish was recovered from a vehicle and a drug smuggler was rounded up. The spokesperson informed that in an operation, 2 kgs hashish and 7 kgs suspicious material were recovered from a parcel sent to Karachi at a Cargo Office in Rawalpindi. Near RCD Road, Hub, 24 kgs hashish was recovered from a vehicle and two accused arrested while in a operation near RCD Road, Hub, 64.8 kgs hashish was recovered from the secret cavities of a vehicle. ANF also arrested an accused during the operation.-APP

Under this agreement, there is a need to establish joint working groups and conduct regular review meetings, focusing on cooperation in areas such as digital trade, renewable energy, agriculture, and pharmaceuticals. However, in order to truly boost bilateral trade, a formal Free Trade Agreement (FTA) is essential, Pracha stressed.

He further noted that a "Trade Dialogue Mechanism Agreement" has also been signed between the two countries, aimed at reinforcing bilateral economic cooperation, exploring trade opportunities, removing barriers, and promoting mutual investment. Pakistan can also benefit from the UK's Developing Countries Trading Scheme (DCTS), which will help boost exports in sectors like IT, agricultural technology, and pharmaceuticals. Pracha highlighted the need to engage the Pakistani diaspora in the UK to promote trade between the two countries. He pointed out that the current trade volume between Pakistan and the UK stands at around £4.7 billion, and that non-tariff barriers affecting this trade must be addressed. He acknowledged that while negotiating an FTA requires significant resources and time, such an agreement would align with the economic priorities of both nations. At present, no bilateral FTA exists between Pakistan and the UK, but authorities on both sides are working realistically towards laying the groundwork for a possible future agreement. Pracha also emphasized that Pakistan's technology and digital services sector is the most dynamic segment of its economy, and the UK is interested in having more Pakistani tech companies use the UK as a platform to access European and global markets. British development finance institutions are playing a key role in this effort, helping promote digital infrastructure and financial inclusion in Pakistan. Meanwhile, UK Export Finance is supporting Pakistani companies looking to expand exports or partner with British firms. He urged the Pakistani government to pay special attention to this opportunity.-DNA

ISLAMABAD: The Islamabad district administration Wednesday launched on a crackdown on retailers charging above the official sugar price and several shops have been sealed and shopkeepers arrested as part of the ongoing operation led by price control magistrates. According to the spokesman of ICT administration, in response to rising complaints about overpriced sugar in the Islamabad markets, Capital Territory (ICT) administration has intensified its action against profiteers. Acting on the directives of Deputy Commissioner Irfan Nawaz Memon, price control magistrates carried out surprise inspections in various parts of the city. Several grocery stores were found selling sugar at rates higher than those set by the government. As a result, multiple shops were sealed, and one shopkeepers were taken into custody for violating official

price guidelines. Deputy Commissioner Irfan Memon has directed that action must be taken without discrimination against all retailers who fail to comply with the notified sugar rates. He instructed officials to ensure that no store is allowed to overcharge, and strict penalties should be imposed where violations are found. The crackdown aims to ensure price stability and protect citizens from unjustified increases in daily-use commodities. Memon emphasized that any officer found negligent in enforcing the official sugar rate in their assigned area would also face disciplinary action. "Strict enforcement is necessary. If sugar is being sold at inflated prices in any locality, the concerned area officer will be held accountable," he stated during a meeting with monitoring teams.

The district administration has also urged the public to

support the effort by reporting shops that are charging more than the official rate. "We request citizens to help us identify those selling sugar at inflated prices. Their cooperation is important to keep prices under control," the DC said. To improve monitoring, the Additional Deputy Commissioner General has been tasked with submitting detailed reports on price compliance across all zones of Islamabad. The goal is to maintain transparency in market operations and address pricing irregularities quickly. Teams of price control magistrates will continue inspections in both urban and rural sectors, including busy commercial areas and small neighborhoods. They have been told to check not only sugar prices but also other essential items listed under government-fixed rates.-APP

# Justice or political targeting?

**I**N a development that has sent shockwaves through Pakistan's political landscape, several senior leaders of Pakistan Tehreek-e-Insaf (PTI), including the Leader of the Opposition in the Punjab Assembly, have been sentenced to ten years in prison in connection with the May 9 incident. While there can be no disagreement that those who break the law must be held accountable, the line between justice and political persecution is growing increasingly blurred.

There is no doubt that the events of May 9, 2023, were deeply troubling. Acts of vandalism, arson, and attacks on military installations are unacceptable in any democratic state. Those found guilty through a transparent judicial process must face consequences. However, what is equally important is that justice must not only be done but must be seen to be done – and that includes ensuring due process and avoiding the appearance of selective or politically motivated trials.

In the current case, the optics are difficult to ignore. With nearly all top PTI leaders now behind bars or facing long-term disqualification, one cannot help but question whether the true goal is justice or political annihilation. The Punjab government's role in this is especially concerning. Rather than demonstrating political maturity and engaging with its opponents, it appears to be pursuing a scorched-earth strategy — one that aims to clear the field of any viable opposition

strategy — one that aims to clear the field of any viable opposition. This is not how democracies function. The elimination of political rivals through the courts — even under the veneer of legality — is a dangerous precedent. Today, the government may believe it is securing stability or clearing space for unchallenged governance, but tomorrow, the same instruments of state power could be used against them. Political vendettas dressed up as accountability are a game no one wins in the long term. More importantly, the marginalization of a major political force like PTI, which still commands a substantial support base across the country, weakens the democratic fabric of the state. A healthy democracy thrives on competition, dialogue, and the ability of all political actors to participate freely and fairly. By sidelining opponents through legal overreach or administrative muscle, the

state risks fostering resentment, polarization, and long-term instability. Pakistan's fragile democracy does not need another era of political engineering. It needs inclusivity, a commitment to constitutionalism, and an end to the cycle of winner-takes-all politics. The courts must ensure that justice is blind — not selective. And the government must remember that a strong democracy is built not by eliminating dissent, but by engaging with it.

If Pakistan is to move forward, it must resist the temptation to use accountability as a political weapon. Law must take its course, yes - but it must do so in a way that commands public confidence and upholds democratic norms. Anything less would be a disservice to both justice and democracy.

### Businessmen reject federal budget: FBR powers draw fire

The business community has strongly rejected the federal budget for the fiscal year 2025–26, particularly objecting to the controversial proposal granting arrest powers to Federal Board of Revenue (FBR) officials. Terming the move "draconian," several trade and industry bodies have warned the government of a nationwide strike if the provision is not immediately withdrawn. This backlash is not surprising. At a time when businesses are already reeling under inflation, high energy costs, and economic uncertainty, this additional threat of arbitrary arrest has only deepened their sense of insecurity and alienation. Business leaders argue-rightfully—that the move will further erode confidence and deter investment. The FBR, they say, already has a reputation for harassment and overreach. Giving its officials unchecked authority to arrest businessmen without due process could open the floodgates for abuse, vendettas, and corruption. While the intent behind the move may be to tighten the nose around habitual tax evaders, in practice, it may end up targeting genuine taxpayers—those who are already contributing to the national exchequer and struggling to stay afloat. The reality is that Pakistan's tax base is narrow not because of a lack of

legislation, but because of inconsistent implementation and selective accountability. There is no doubt that tax evasion is a serious problem. It has long plagued the country, depriving the national treasury of critical revenues needed for infrastructure, health, and education. But blanket punitive measures against the entire business class are not the solution. They risk alienating key economic players who are vital to job creation and growth.

Reports indicate that the government is reconsidering this proposal after severe backlash, which is a step in the right direction. However, a mere rollback is not enough. There must be a clear and transparent mechanism to distinguish between habitual tax dodgers and compliant taxpayers. Technology, data analytics, and third-party audits can play a vital role in achieving this without infringing on individual rights or disrupting economic activity. Moreover, the FBR itself needs institutional reform. Without improving internal accountability, training, and efficiency, no legislative change will yield long-term results. Trust between the tax authorities and the business community is essential-and that can only be built through transparency, fairness, and dialogue, not intimidation. Ultimately, while tax reform is crucial for Pakistan's financial future, it must be pursued with wisdom and balance. Policies that scare away business will only deepen the economic crisis. The government must adopt a consultative approach, address genuine concerns, and ensure that any anti-evasion measures are implemented with justice and due process. A thriving business community and an efficient, accountable tax system are not mutually exclusive-they are two sides of the same coin.

### **Replacing India with China in SAARC: A Strategic Masterstroke**

FOR decades, the South Asian Association for Regional Cooperation (SAARC) was envisioned as a platform for unity, prosperity, and regional integration among the diverse and populous nations of South Asia. With over two billion people and a wealth of natural and human resources, the SAARC region held tremendous promise. Yet despite this potential, SAARC has remained paralyzed-reduced to ceremonial meetings, unfulfilled resolutions, and a legacy of frustration. The principal reason for its failure has been the hegemonic posture and political intransigence of India, which consistently prioritized its own bilateral disputes over collective regional interests. Whenever India had tensions with Pakistan, Nepal, Bangladesh, or Sri Lanka, it weaponized its influence within SAARC to paralyze the forum, suffocating any genuine attempt at regional cooperation.

Now, a new door has opened, and through it lies the opportunity for a historic transformation. Pakistan and China are reportedly working toward creating a new regional bloc that excludes India-the very actor that has repeatedly blocked progress-and instead includes willing and cooperative regional players. The envisioned alliance includes Pakistan, China, Afghanistan, Bangladesh, Nepal, Sri Lanka, Bhutan, Maldives, Nepal, and potentially Iran. By replacing India with China, this restructured bloc is poised to deliver what SAARC never could: unity, stability, and development rooted in mutual respect and economic advancement. It is a masterstroke in regional diplomacy, one that offers South Asia a second chance at integration-this time with an engine powerful enough to carry the weight of transformation. China's inclusion brings with it unmatched potential for infrastructure development, trade expansion, digital connectivity, and strategic outreach. Having already committed over \$62 billion to the China-Pakistan Economic Corridor (CPEC), and more than \$1 trillion across its global Belt and Road Initiative (BRI), China's proven commitment to long-term infrastructure and investment is unparalleled. High-speed rail corridors, smart ports, integrated energy grids, and region-wide highway systems could form the physical backbone of this new South Asian alliance.

in South Asia could rise to 20% by 2030, translating into over \$250 billion in trade volume, compared to \$67 billion today. China's economic ties with Bangladesh, Sri Lanka, and Nepal are already strong, and its access to Pakistan's warm-water ports offers landlocked Central Asian and South Asian countries a direct outlet to global markets. The potential for growth in textiles, agri-processing, electronics, construction materials, and green technologies is immense, laying the foundation for self-sustaining regional value chains.

Foreign direct investment is also expected to surge. China, the world's second-largest source of outbound FDI, invested over \$136 billion globally in 2023. In the current SAARC bloc, most Chinese FDI is confined to Pakistan. But a restructured bloc with China at the center could see FDI flows jump from the current \$10 billion to over \$100 billion by 2035. These funds would likely target special economic zones, digital infrastructure, energy projects, manufacturing clusters, and agricultural modernization-unlocking employment and industrialization at a scale the region has never witnessed before. The digital revolution would also accelerate. China's Digital Silk Road offers undersea cables, fiber optics, cloud computing, AI platforms, and next-gen telecom. Expansion of this model to the region could deliver high-speed internet to over 400 million currently underserved users, transforming education, healthcare, banking, and governance. Regional cloud computing systems, digital currency interoperability, and fintech solutions would enable real-time trade, financial inclusion, and cyber-resilience. China's BeiDou satellite navigation system could replace the region's dependence on U.S. GPS, empowering the bloc with sovereign control over aviation, logistics, and defense mapping-an essential step in building technological independence. Strategically, the inclusion of Afghanistan is a geopolitical pivot. Afghanistan connects the bloc to Central Asia and, through China and Pakistan, to Iran and the Middle East. With Iran's Chabahar Port and Pakistan's Gwadar Port acting as twin maritime gateways, and with China constructing transit and trade corridors through the region, this alliance becomes a global artery of commerce. Central Asian energy and minerals could flow southward to the Arabian Sea, while South Asian goods find shorter, cheaper routes to Europe and Africa. Transportation costs across the region could fall by 30-50%, according to the Asian Development Bank, directly improving the competitiveness of exports and reducing the price of imports. The human impact is equally transformative. With China's support, the region could lift over 300 million people out of poverty by 2040 through job creation, industrial expansion, and rural upliftment. Unemployment across Pakistan, Bangladesh, and Afghanistan could decline by 15 to 20%, and access to clean water, electricity, healthcare, and digital literacy would expand exponentially. China's model of non-interference—unlike Western or Indian models—ensures that sovereignty remains intact. Beijing does not fund regime change, nor does it meddle in domestic politics. It delivers roads, power plants, ports, and platforms—not political ultimatums. It respects its partners and uplifts their capacity.

India's exclusion is not an act of retaliation but of necessity. Its leadership has repeatedly failed to grasp the essence of regional cooperation. New Delhi's rigid nationalism, refusal to separate bilateral issues from multilateral platforms, and its track record of stalling progress made SAARC unworkable. Its foreign policy has alienated neighbors and irritated allies. Even its Western backers are increasingly wary of India's refusal to align on key global issues, such as sanctions on Russia or trade cooperation. India sees itself as a regional giant, but in practice it has been a disruptive force in South Asian diplomacy. This realignment offers South Asia a future where roads replace borders, where fiber optics replace fences, and where mutual progress replaces mutual suspicion. It envisions a regional community where ports connect producers to consumers, where satellites link students to teachers, and where dignity replaces desperation. The potential is no longer theoretical. It is tangible, measurable, and achievable--if the political will aligns with regional ambition. South Asia has waited long enough. While other regions moved forward, we remained frozen in a structure designed to fail. But with China's entry and India's exclusion, we now have the opportunity to design a platform that works-for people, for peace, and for prosperity. It is not merely about replacing a nation with another. It is about replacing a mindset of dominance with one of partnership. It is about building a future that no longer depends on the whims of one capital but is driven by the shared dreams of a billion people. If the vision is pursued with clarity and courage, this new South Asian bloc-backed by China's resources and guided by mutual interest-will not only transform the region. It will set a global example of how fractured regions can reinvent themselves, not through confrontation, but through cooperation.

### Infanticide at the heart of Gaza genocide

Israel is already facing genocide charges at the International Court of Justice. Prime Minister Benjamin Netanyahu and his former defense minister are wanted by the International Criminal Court for crimes against humanity. But the list of charges should not stop there. Israel is in clear and direct violation of a handful of international legal instruments that protect children in armed conflicts. These include the Fourth Geneva Convention of 1949, which establishes fundamental protections for

civilians, including children, during times of war

ITH tens of Palestinian infants and children dying daily as a result of starvation rect outcome of of denying more than 2 million Gazans unfettered access to food, water, baby formula, fuel and medication since March – the war on Gaza is entering its final stage: extermination or depopulation. The images of starving children are harrowing, but the world's inability to stop this human-made catastrophe is staggering and shameful. This multifarious tragedy is not the result of a natural disaster, but a war crime, a crime against humanity and a form of genocide that is a sanctioned Israeli government policy. It is indefensible. The extermination of Gazans, whether by constant Israeli bombardment of homes, schools, hospitals, places of worship, shelters and tent camps or through other means, is now normalized. The Israeli blockade is a matter of fact. The killing of more than 20,000 children since Oct. 7, 2023, is a mere statistic. More than 70,000 children under the age of five are at risk of acute malnutrition within the year if the blockade and conflict persist, according to the UN.

Approximately 17,000 children are reported to be struggling with severe malnutrition amid medical shortages due to this engineered humanitarian crisis. Healthcare workers report that mothers are unable to breastfeed due to their malnutrition, forcing them to resort to unsafe feeding methods. Press reports speak of elderly Gazans dropping in the streets or at Israeli-run aid distribution centers, which have become death traps, claiming the lives of more than 1,000 people in the past two months. Children have become an easy target at these centers, which are staffed by American and Israeli contractors. Western doctors who have served at the few remaining health centers and hospitals in Gaza speak of children sustaining bullet wounds in the head, torso, neck and legs. With UN aid agencies declaring that their storage facilities are now empty across the beleaguered Strip, the number of children dying as a result of starvation will only increase daily. But we are yet to see a serious move on behalf of the UN Security Council, the Trump administration, the EU or the UK to order Israel to stop the carnage and open the borders so that aid can flow into Gaza. Monday's statement by the UK, France and more than 20 other countries will do nothing unless it is backed by action.

Israel is already facing genocide charges at the International Court of Justice. Israel is in clear and direct violation of a handful of international legal instruments that protect children in armed conflicts. Israel is also in violation of the Convention on the Rights of the Child, adopted in 1989, which is the world's most widely ratified human rights treaty. The UNSC has adopted several resolutions on this issue, particularly 1612 of 2005, which established monitoring and reporting mechanisms for

grave violations against children in armed conflict. Israel's use of collective punishment against Palestinians is not new. It has resorted to such criminal acts in the past, both in Gaza and the West Bank. As of this month, Israeli forces have killed at least 204 Palestinian children in the West Bank, including East Jerusalem, since Oct. 7, 2023, accounting for about 20 percent of all child fatalities in the West Bank since the year 2000. Despite growing condemnation by UN agencies and human rights organizations of Israel's weaponization of food and its use of starvation as a state policy, there are no signs that Israel is about to roll back its policy. It is not coming under enough pressure from Western governments, especially the US, to end its illegal blockade and let aid into Gaza. It is doubling down by expanding the areas under its military control, while doing nothing to address the spreading famine and deliberate starvation. It is moving ahead with the forced transfer of millions to Rafah, where it plans to build a concentration camp ahead of pushing Gazans to leave the Strip. On average, it is killing between 80 and 120 people daily, with the majority shot dead at food distribution centers under its control.

Israel's sense of impunity is on the rise, even when its military declares that displacing people by force is a war crime. It does not have to defend itself when images of starving children in Gaza go viral on social media. That task is handed to US lawmakers and the White House, which waste no time in imposing sanctions on international courts and UN Special Rapporteur Francesca Albanese for opposing the ongoing genocide.

While ceasefire talks in Doha are going nowhere, Netanyahu is using the stalemate to drive Gazans to the brink, to carry out their mass displacement. Even if a temporary truce is reached, there are no guarantees that Netanyahu will not resume the war, under false pretexts, to realize that final goal. There are two key considerations to take into account. One, the rebuilding of Gaza – a multibillion-dollar task that will take decades to achieve – is unlikely to happen.

If and when the war does stop, there will be an endemic humanitarian crisis in Gaza that will keep the world busy for years. Many children will die of disease and malnutrition. Tens of thousands of surviving children will need physical and psychological treatment for years to come. There are thousands of amputees and orphans with no surviving relatives.

# FIH set to offer 2026 Pro League spot to Pakistan

### New Zealand's withdrawal opens door for Pakistan; PHF faces uphill task amid financial woes

ISLAMABAD: : In what could potentially mark a defining moment in Pakistan's hockey history, the country is set to receive a formal invitation to compete in the 2026 edition of the FIH Pro League, the International Hockey Federation's premier global competition. The opportunity has arisen following New Zealand's official withdrawal from the tournament due to financial constraints

New Zealand, winners of the 2025 FIH Nations Cup, were initially slated to participate in the 2026 Pro League. However, after missing the FIH's July 21 deadline to confirm participation, the Kiwis formally informed the federation of their inability to manage the financial demands of the elite competition. "Yes, we have received written confirmation from Hockey New Zealand that they will not be in a position to compete in the 2026 Pro League," a senior FIH official confirmed. "As per the structure, the next-in-line, in this case, Pakistan - the silver medalist of the 2025 Nations Cup - will be officially offered the place, along with a formal

deadline to confirm their acceptance.' Pakistan's return to the FIH Pro League, after years in the international wilderness, could mark a long-awaited comeback for a nation that once dominated world hockey. Once the proud home of multiple World Cup and Olympic titles, Pakistan has

gradually slipped from the top tier due to internal mismanagement, dwindling investment, and the rise of professionalism in other countries' hockey setups. The FIH Pro League features top-ranked international sides battling it out in a competitive home-and-away format. Beyond prestige and exposure, participation provides vital ranking points, financial opportunities, and a more direct pathway to Olympic qualification - all of which could breathe new life into Pakistan hockey if managed correctly.

However, the opportunity does not come without substantial challenges. According to sources within the Pakistan Hockey Federation (PHF), participa-

The cost of participation is significant, but so are the potential returns in terms of player development, international visibility, and the revival of the

nounced Tuesday a "massive" trade deal with Japan, as a deadline looms for other major US trade partners to strike agreements before the end of the month. In an attempt to slash his country's colossal trade deficit, the US president has vowed to hit dozens of countries with punitive "reciprocal" tariffs if they do not hammer out a pact with Washington by August 1.

The Japan agreement, along with another pact with the Philippines also announced on Tuesday, means Trump has now secured five agreements since his administration promised in April "90 deals in 90 days.

The others were with Britain, Vietnam and Indonesia, which the White House said Tuesday would ease critical mineral export restrictions.

percent on steel and aluminium. Japanese Prime Minister Shigeru Ishiba said that the autos levy had now been cut to 15 percent, sending Japanese car stocks soaring, with Toyota and Mitsubishi up around 14 percent each. The Nikkei rose 3.5 percent.

"We are the first (country) in the world to reduce tariffs on automobiles and auto parts, with no limits on volume," he told reporters. "By protecting what needs to be protected, we continued the negotiations with an aim to reach an agreement that meets the national interest of both Japan and the United States,

envoy Ryosei Akazawa, who secured the deal on his eighth visit to Washington, said the 50 percent tariffs on steel and aluminium would remain. Akazawa also said increased defense spending by Japan - something Trump has pressed for - was not part of the agreement.

Trump said Tuesday Japan has also agreed to "open their Country to Trade including Cars and Trucks, Rice and certain other Agricultural Products, and other things." Rice imports are a sensitive issue in Japan, and Ishiba's government - which lost its upper house majority in elections on Sunday - had previously ruled out any concessions. Japan currently imports 770,000 tonnes of rice tariff-free under its World Trade Organization commitments, and Ishiba said it would import more US grain within this. Ishiba said Wednesday that the deal does not "sacrifice" Japan's agricultural sector. Tatsuo Yasunaga, the chair of Japan Foreign Trade Council welcomed the trade deal announcement but said the business community needed to see details to assess its impact. - Agencies

### Britain's Norrie ousts Musetti to advance at DC Open

WASHINGTON: Britain's Cameron Norrie rallied to defeat world number seven Lorenzo Musetti 3-6, 6-2, 6-3 on Tuesday, reaching the third round at the ATP and WTA DC Open. Norrie, seeking his sixth ATP title, captured his first victory over a top-10 player in 2 1/2 years by eliminating the second seed at the first hardcourt tuneup for the US Open. "I made it very difficult for him," Norrie said. "My backhand was coming through the court low. My forehand was jumping. I'm just enjoying my tennis a lot more these days.'

Norrie, whose most recent title was in February 2023 at Rio, snapped a 14-match losing streak against top-10 foes with a fightback after taking a time violation to reset in the fifth game of the last set. "I was sweating so much I literally had to, my sweatband was moving on my arm and my shirt was bothering me," Norrie said. "I said whatever, I'm just going to take the time violation and reset... I think I played maybe the three best points of the match after that.

"Held that game and I think that was the difference. It was a great move looking back." Norrie said he was playing "like a kid again." "I just kind of let go of the expectations and I'm playing tennis more to enjoy now," he said. "You've got to enjoy it otherwise you can get burned out on this long schedule." Also hoping to turn back the clock was seven-time Grand Slam singles champion Venus Williams, who will make her return to singles after a 16-month hiatus later. The 45-year-old American will face compatriot Peyton Stearns while Japan's Naomi Osaka, a four-time Grand Slam champion, meets Yulia Putintseva of Kazakhstan in another later match. Musetti, who had a first-round bye, reached three semi-finals and a final on clay earlier this year, falling to eventual champion Carlos Alcaraz in a French Open semi-final. But he dropped his opener at Wimbledon and suffered his third loss in a row at Washington. Norrie managed only three winners in the first set, two of them on aces, but dominated the second set to force a third. Norrie saved five break points to hold in the fifth game of the final set then broke Musetti on his fourth chance in the sixth game, grabbing a 4-2 lead on an errant backhand by the Italian. Musetti fought off two match points in the final game, one on a Norrie double fault, but fell to the 29-year-old left-hander by sending a backhand beyond the baseline after two hours and seven minutes. Chinese qualifier Wu Yibing beat France's Gael Monfils 6-3, 6-1 for his first tour-level triumph since last year at Shanghai after the Frenchman ran into a clock at the rear corner of the court in the first set, hitting it with his right ankle. "I saw him falling down there," Wu said. I don't know what happened but after I asked him. He said his foot actually maybe stuck under the clock. "Hopefully he's OK. I didn't feel any difference (in his game). He was still reaching balls and good rallies." - Agencies

### **England coach Wiegman hails** reaching Euro 2025 final

GENEVA: England coach Sarina Wiegman said she felt "many emotions" after her team produced another dramatic comeback to beat Italy in extra time on Tuesday and reach the final of the Women's Euro 2025. "I have many emotions again. I feel relief, I feel happy - it feels a bit surreal but we are here and we are going to the final,' Wiegman said following the 2-1 win in Geneva, secured thanks to a Chloe Kelly goal in the 119th minute.

Italy were seconds away from a shock victory over the defending champions and a place in the final as they led deep into injury time thanks to Barbara Bonansea's 33rd-minute goal. But substitute Michelle Agyemang equalised for England in the sixth minute of stoppage time to force the extra period, before Kelly - who had also come off the bench - followed in to score the deciding goal after her penalty had been saved, just as another shoot-out loomed. 'It does feel like a movie. When it finishes like that I am enjoying it but it was a little bit dramatic," smiled Wiegman. Her team had already produced a stunning comeback against Sweden in the guarter-finals, when they trailed 2-0 before two goals by Lucy Bronze and Agyemang in the space of three minutes late on forced extra time and they eventually advanced on penalties. "We know with the players we have in the squad that we can always score more because we have shown that multiple times," Wiegman added. "At the end we did it and then we got extra time, and then we got the penalty. We were a bit lucky to score it in the second stage but we are through.

England, who saw winger Lauren James come off at half-time with an ankle injury, will now go to Basel for the final on Sunday against either Spain or Germany they meet in their last-four clash on Wednesday.

It will be a third consecutive major tournament final for the Lionesses, who beat Germany in extra time in the Euro 2022 final at Wembley and then lost to Spain in the deciding game at the following year's World Cup in Sydney. "That is what happens when a great team comes together and makes things happen - three consecutive finals playing under an unbelievable manager in Sarina," said Kelly, the Arsenal forward who got the winner in the 2022 Euro final. "It is incredible to be part of this special team. I am so proud." She added: "I can't believe what has just happened. The belief in the squad, the resilience and the togetherness in this group is just so special." - Agencies

### Italy, Algeria agree to tackle terrorism and migration at summit

ROME: Italy and Algeria agreed to work together to fight terrorism and control migration during an intergovernmental meeting in Rome on Wednesday, documents showed, while companies signed off on deals on sectors including energy and telecommunications. Italian Prime Minister Giorgia Meloni met Algerian President Abdelmadjid Tebboune at the 17th-century Villa Doria Pamphili, after a trip to Algiers by Foreign Minister Antonio Tajani in March. Algeria is Rome's leading trading partner in Africa, with trade worth almost 14 billion euros (\$16.4 billion) while Rome's investments there amount to 8.5 billion, Italy said. According to a document seen by Reuters, a memorandum will be signed between Italy and Algeria on fighting terrorism and its financing. The document did not say which threats the countries were focused on. The two nations will also agree on a plan to coordinate the search and rescue operations for migrants who attempt the dangerous sea crossing from North Africa to Europe. Meloni's right-wing government was elected in 2022 on a mandate to curb migrant arrivals. On the business side, Italian energy group Eni this month signed a production sharing contract with oil and gas company Sonatrach worth \$1.3 billion to explore and develop hydrocarbons in Algeria. A document said the two companies will sign an additional agreement on the sidelines of the summit to strengthen their cooperation. APP

### Turkiye, Britain sign preliminary deal for Eurofighter Typhoon jets

ANKARA: Türkiye and Britain on Wednesday signed a preliminary agreement for the sale of Eurofighter Typhoon fighter jets to Turkiye, a significant step in Ankara's efforts to modernize its air fleet. Turkish Defense Minister Yasar Guler and his British counterpart, John Healey, inked a memorandum of understanding during a defense industry fair in Istanbul, Türkiye's Ministry of National Defense said. NATO member Türkiye has long aimed to buy 40 Eurofighter jets, which are built by a consortium of British, German and Italian companies. Germany reportedly initially opposed the sale but later reversed its position. Britain led negotiations on behalf of the consortium. A Turkish defense ministry statement said the memorandum takes the two countries "one step closer to a full agreement on the Typhoon." "Both Ministers welcome signature as a positive step toward bringing Turkiye into the Typhoon club and share a mutual ambition to conclude the necessary arrangements as soon as possible," it added. Britain's BAE Systems, which is part of the consortium, welcomed the agreement, saying it would continue working with the Turkish and British governments to finalize the procurement deal. Turkish officials have said that they are still negotiating over pricing and technical terms, saying that they have received an initial offer and expect to submit a counter-proposal. - APP

### Heat wave hits water, electricity supplies across much of Iran

TEHRAN: A severe heat wave sweeping Iran has disrupted water and electricity supplies in much of the country, with reservoir levels falling to their lowest in a century, state media said on Tuesday Extreme temperatures, which began on Friday, are expected to ease gradually by Thursday Government offices in at least 15 of Iran's 31 provinces, including the capital Tehran, have been ordered to close on Wednesday in a bid to conserve water and electricity. The measure comes as temperatures in parts of southern and southwestern Iran topped 50 degrees Celsius. Government spokeswoman Fatemeh MoHajjerani said authorities would extend office closures "if it deems necessary," while warning of the "critical situation" in Tehran regarding water supplies. The heat wave has been accompanied by drought, with the capital experiencing its lowest rainfall in 60 years. Water levels in the reservoirs which supply Tehran have fallen to "their lowest level in a century," said the Tehran Provincial Water Supply Company, advising people to use a tank and pump to cope with mains disruption. Tehran provincial governor, Mohammad Sadegh Motamedian said the dams are only filled to 14 percent, adding that the capital is going through its fifth year of drought.\_APP

Speaking from Amman, she stressed that seeking food "has become as deadly as the bombardments". The development comes as the UN human rights office, OHCHR, announced on Tuesday that more than 1,000 Palestinians have now been killed by the Israeli military.-APP

### Audit report not reflective of current reforms: Power **Division clarifies**

ISLAMABAD: The Power Division on Wednesday clarified a news appeared in a section of press related to an audit report, stating that it pertains to the fiscal year 2023-24 and does not reflect the performance or actions of the present government. According to the spokesperson for the Power Division, the audit report under discussion is outdated and covers a period prior to the current administration's tenure. "This is not a report of the current financial year, and it must not be viewed in the context of the reforms and corrective measures introduced by the present government," he added. The Power Division added that the report is preliminary in nature and is subject to review, further documentation, and evidence submission. "The findings will be examined across relevant forums, and final figures are yet to be presented," it said, urging stakeholders not to draw conclusions from the initial observations. The spokesperson said that both the ministry and the government were already aware of the systemic challenges in the power sector, particularly the long-standing issue of overbilling and inaccurate meter readings. "This has been repeatedly highlighted by Minister for Power Sardar Awais Ahmad Khan Leghari," the spokesperson added. In response to these concerns, the Power Division said the government has launched decisive and far-reaching reforms. Among these initiatives is the introduction of the "Power Smart" app under the "Apna Meter, Apni Reading" campaign. \_DNA

### Call for actionable outcomes of 'Socio-Economic Domain' committee

ISLAMABAD: Federal Minister for Planning, Development and Special Initiatives Ahsan Iqbal on Wednesday chaired the fifth meeting of the Prime Minister's Committee on the Socio-Economic Domain. It brought together key stakeholders, including Secretary Planning Awais Manzur Sumra, representatives from NACTA, Finance Ministers from all four provinces and Azad Jammu & Kashmir, senior officials from federal and provincial ministries, and members of provincial socio-political committees, a news release said. Member Governance Dr Adnan Rafiq presented a detailed review of the progress made by provincial governments on the committee's earlier decisions, alongside the compliance status of outcomes from the fourth meeting. Discussions centered around ensuring equitable socio-economic development in Balochistan, Newly Merged Districts (NMDs), South Punjab, and Interior Sindh. Minister for Planning Ahsan Iqbal emphasized that meetings of this nature should not merely serve as discussion forums; rather, they must produce actionable outcomes with a strong focus on implementation. "If we only take decisions without ensuring implementation, there will be no tangible results," he stressed. He called for a robust mechanism to evaluate performance based on implementation metrics and urged the provinces to develop and share their respective action plans and KPIs so that a consolidated report could be prepared with mutual consensus. He particularly asked Balochistan to expedite its action plan for submission to the APEX Committee. Ahsan Iqbal highlighted the need to reframe the national narrative around conflict prone areas. "This is a fifth-generation war", the nation that produces better ideas and narratives will succeed," he stated, underlining the importance of transforming the youth mindset in Balochistan and other vulnerable districts through positive engagement, education, and skill-building. He directed that targeted interventions begin with select districts in FATA and Balochistan, focusing on youth development, entrepreneurship, alternative livelihoods, macro-level and socio-economic empowerment. Special emphasis was laid on creating inclusive opportunities and removing ethnic biases, especially within universities and hostels. "No hostels will allow allotments based on caste or ethnicity. Allotments will be mixed, and this directive must be implemented strictly," he directed. The Minister also expressed concern about the lack of engaging mechanisms for scholarship recipients. He revealed that from 2013 to 2018, scholarships were awarded to over 5,000 students in Balochistan, but there is little to no data on their current status or contributions. "The state must ensure that those it supports financially are given opportunities to contribute positively to society, he remarked. Ahsan Iqbal emphasized the importance of nurturing a culture of good citizenship from the primary level to university education and called upon the Higher Education Commission (HEC) to work in this domain. He also directed vice-chancellors across Punjab and Federal universities to take direct responsibility for mentoring students from Balochistan and the Newly Merged Districts, suggesting biweekly career counseling sessions and a structured mentorship program.-DNA

## Taxes on mobile devices: It's FBR, not PTA



ISLAMABAD: FBR taxes and duties-commonly referred to as PTA taxes on mobile phoneshave become a growing concern across Pakistan, affecting users from all walks of life. In a country with a rapidly expanding digital landscape, mobile phones are more than just devices-they are essential tools for communication, commerce, education, and daily living. With over 198 million mobile subscribers, a teledensity of 80.10%, and more than 150 million broadband users (penetration rate of 60.14%), the telecom sector continues to thrive. In this context, mobile connectivity is deeply integrated into the everyday lives

of citizens. Yet, a widespread and persistent misconception remains that the Pakistan Telecommunication Authority (PTA) is responsible for the FBR taxes and duties imposed on mobile phones. This is not only inaccurate but also misdirects public frustration away from the actual authority: the Federal Board of Revenue (FBR). FBR's Role in Mobile Phone Taxes and Duties In reality, all mobile phone taxes and duties-related matters fall under the jurisdiction of the Federal Board of Revenue (FBR), not PTA. The organization responsible for setting and collecting all mobile device levies (taxes and duties) is the FBR, not the PTA. The FBR is the sole institution responsible for defining, imposing, and collecting taxes and duties on mobile devices in Pakistan. It has issued key regulations and various statutory notifications such as S.R.O. 50(I)/2019, S.R.O. 51(I)/2019, and Customs General Order No. 01 of 2019, along with subsequent amendments. Additionally, the FBR publishes updated duties charts based on different models and market categories, which can be accessed on the FBR website. All payments made during the

device registration process are deposited directly into FBR's account. Attributing such levies to PTA is misinformation and shifts liability away from the actual organization. PTA neither levies nor collects any taxes and duties on mobile phones; its actual role is regulatory, involving technical evaluation and support. This distinction is crucial but often overlooked, particularly in online discussions, social media posts, and even marketplace conversations, where the term "PTA tax" is casually thrown around. What is DIRBS and How Does It Work? To understand the process of mobile device registration, it is important to look at the Device Identification, Registration and Blocking System (DIRBS). Launched in 2019 under the broader framework of the Telecom Policy 2015, DIRBS ensures that all mobile devices in use meet quality and authenticity standards. It prevents the use of non-compliant, smuggled, or counterfeit devices by identifying and blocking those with lost/stolen, fake, tampered, cloned, or duplicate IMEIs. The system adheres to both GSMA international standards and PTA's type approval criteria. DIRBS is fully automated and links PTA, FBR, GSMA, mobile network operators, and users into a unified digital ecosystem that enforces device compliance. Mobile users can register their phones via: • Dialing \*8484# Visiting the DIRBS web portal (https://dirbs. pta.gov.pk) Visiting any cellular mobile network franchise Once a user submits device IMEI(s) for registration, FBR, through its system WeBOC, generates a Payment Slip ID (PSID) based on the applicable taxes and duties. The user then pays this amount directly to FBR's account by visiting any commercial bank in Pakistan. It is essential to note that all payments go to FBR-not PTA. PTA does not charge even a single penny for individual registration. Upon successful payment and confirmation from the FBR, the device IMEIs are shared with Mobile Network Operators (MNOs), enabling them to operate on Pakistani mobile networks. Consumers can check their mobile device registration status by: Sending the IMEI number to 8484 via SMS Visiting the PTA website Using the DIRBS (DVS) app FBR Revenue and Overseas Pakistani Incentives Since the introduction of DIRBS in 2019, individual mobile users have paid approximately Rs. 83 billion in taxes and duties to the FBR. When commercial import duties are included, the total rises significantly. To encourage overseas Pakistanis to comply with legal registration requirements, the government has introduced incentives and facilities: 10% discount on taxes/custom duties for international travelers if the device is registered within 60 days of arrival A 120-day temporary tax-free registration window for one mobile device per visit These measures provide relief and promote legal imports while discouraging black-market alternatives. On average, 150 to 200 people visit the PTA headquarters daily for assistance with registration, IMEI compliance, or device activation issues. In 2024 alone, PTA received and resolved 199,722 DIRBS-related complaints. PTA's Broader Role:

Regulation, Industry Growth & Consumer Protection Parallel to its regulatory functions, PTA also plays a vital role in developing Pakistan's local mobile phone manufacturing industry. In 2024, over 31 million devices were produced locally. Between January and May 2025, another 12.05 million devices were manufactured. These figures signal a promising shift toward import substitution and greater economic self-reliance. PTA's contributions to the national exchequer are also significant. with: • Rs. 112.71 billion deposited in 2021–22 Rs. 99 billion in 2022–23 Rs. 54 billion in 2023–24

These revenues arise from regulatory activities such as license fees, spectrum auctions, and compliance penalties-not from mobile taxes and duties.

PTA also ensures service quality across Pakistan. It conducts regular Quality of Service (QoS) surveys and issues show-cause notices, followed by fines for licensees who fail to meet their obligations. In addition, PTA plays a key role in monitoring and regulating online content under the Prevention of Electronic Crimes Act (PECA)–blocking access to illegal material such as hate speech, pornography,

and content harmful to children. The Need for Tax Reform To address public dissatisfaction with mobile taxes and improve compliance, policymakers may consider revising the current duties structure. Suggested reforms include: • Reducing duties on older or mid-range devices, using the GSMA TAC database • Adjusting duty slabs for high-end smartphones to encourage legal registration Such reforms would expand the legal tax net and support revenue generation without overburdening the public.

While FBR mobile phone taxes and duties are a necessary source of national revenue, criticism and concerns regarding high mobile taxes should be directed to the FBR-not the PTA. The Pakistan Telecommunication Authority (PTA) is a regulatory body, not a tax-collecting agency. Understanding this distinction between regulation and taxation is crucial for fair public debate, informed policy advocacy, and responsible journalism. A better-informed public can help drive smarter dialogue and policy reforms that support digital inclusion, legal imports, and a stronger digital economy in Pakistan.

### **Scientists** develop vaccine to target all types ofcancer

BAKU: University of Florida (UF) scientists have developed a groundbreaking mRNA vaccine capable of activating the immune system to destroy various types of tumors, offering hope for a universal cancer treatment, Kazinform News Agency reports.

The experimental vaccine, which builds on a successful glioblastoma trial, uses mRNA technology similar to COVID-19 vaccines. However, instead of targeting viruses, it trains immune cells to recognize and attack tumors regard-

less of cancer type. "This paper describes a very unexpected and exciting observation: that even a vaccine not specific to any particular tumor or virus - so long as it is an mRNA vaccine - could lead to tumor-specific effects," said Dr. Elias Sayour, principal investigator at the UF RNA Engineering Laboratory. "This finding is a proof of concept that these vaccines potentially could be commercialized as universal cancer vaccines to sensitize the immune system against a patient's individual tumor." - APP

### Afghan national arrested

MANSEHRA: Mansehra Police on Tuesday claimed to have solved the mystery behind the brutal murder of a 9-year-old boy, a guest from Karachi, whose decapitated body was recovered in the jurisdiction of Baffa Police Station. Following directives, DPO Gandapur constituted a special investigative team led by SP City Resham Jahangir and SP Investigation Shiraz Khan. The team launched a thorough investigation, examining the case from multiple angles and interrogating several individuals. # Pakistan presses for global emissions cuts

BAKU: Federal Minister for Climate Change and Environmental Coordination Dr Musadik Malik has called for urgent and equitable global action to tackle climate change including deeper emission cuts and enhanced resilience financing for vulnerable nations. He made these remarks during bilateral meetings with COP-29 President and Special Envoy on Environment to the President of Azerbaijan, Mukhtar Babayev, and Azerbaijan's Deputy Foreign Minister and COP-29 Lead Negotiator, Yalchin Rafivev The meetings were held on the sidelines of the COP

Heads of Delegation Retreat in Shamakhi. The minister stressed that while countries of the Global South face the harshest consequences of climate disasters, the Global North continues to be the primary contributor to historical and present-day greenhouse gas emissions.

Malik said that Pakistan's location next to two of the world's top carbon emitters compounds its climate vulnerability. He reiterated the need for developed countries to fulfil their climate finance commitments and lead the charge in reducing emissions.

He highlighted that climate change is a transboundary challenge, with environmental degradation and extreme weather impacting populations across borders. He called for strengthened international cooperation rooted in justice, science, and sustainability.

The two sides also discussed avenues for deepening green cooperation between Pakistan and Azerbaijan, including renewable energy, climate-smart agriculture, disaster risk reduction, and adaptation strategies. Malik reaffirmed Pakistan's support for multilateral climate governance and expressed hope that COP-29 would deliver meaningful progress toward inclusive and science-based global climate solutions.



Tehreek-e-Insaf (PTI) and former Punjab gov ernor, passed away in Lahore on Tuesday after a long illness.

He was the father of PTI leader Hammad Azhar and had been seriously unwell for several months. Mian Azhar held important roles throughout his long political career. He served as Punjab's governor during Nawaz Sharif's first term as prime minister in the early 1990s and later became the federal commerce minister. After the 1999 military coup, he helped form the Pakistan Muslim League-Quaid (PML-Q).



### Third round of Ukraine-Russia takes place in Turkey

ISTANBUL: Ukrainian and Russian officials could meet in Istanbul for a third round of peace talks, their first meeting in more than seven weeks amid US pressure to reach a ceasefire. Expectations of a breakthrough are low. The two sides previously met in May and June, but failed to agree an end to the nearly three-and-a-half year war.

The Kremlin has not explicitly confirmed it will attend on Wednesday, but cautioned earlier not to expect any "miraculous breakthroughs" if it does. The two sides have wildly different positions for ending the conflict. Russia has called on Ukraine to effectively retreat from the four Ukrainian regions it claims to have annexed in September 2022, a demand Kyiv has called unacceptable.

Ukraine has ruled out any negotiations on territory until after a ceasefire and says it will never recognise Russia's claims over occupied territory - including Crimea, which Moscow annexed in 2014.

Russia's full-scale invasion, launched in February 2022, has ravaged parts of eastern and southern Ukraine and result-

ed in tens of thousands of military and civilian deaths. Ukrainian President Volodymyr Zelensky said he hoped the two sides would discuss the release of prisoners and prepare a meeting between himself and Russian leader Vladimir Putin. Moscow has said that "a lot of work" is needed before even discussions can take place about possible talks between Putin and Zelensky, who last met in 2019.

### **Noor Mukadam murder: Zahir Jaffer files** review plea in SC against death sentence

Petition highlights reliance on video recording, lack of formation of medical board to assess Jaffer's mental state

ISLAMABAD: Noor Mukadam's convicted killer Zahir Jaffer on Wednesday filed a review petition in the Supreme Court against the top court's May 20 verdict which upheld his death sentence for gruesome murder of the 27-year-old at his sprawling Islamabad mansion in 2021.

A three-member bench, led by Justice Hashim Kakar and comprising Justice Ishtiaq Ibrahim and Justice Ali Baqar Najafi had upheld Jaffer's death penalty and fine earlier this year. The apex court further reduced the sentences of



co-accused i.e., Jaffer's watchman and gardener and ruled that the punishments already served by both would suffice. The high-profile case had garnered public attention back in 2021 when Jaffer, the son of an industrialist, brutally assaulted and murdered Mukaddam, the daughter of a former ambassador. The victim had made repeated attempts to escape the night she was killed, but was blocked by two members of Jaffer's household staff. The killer then resorted to torturing her with a knuckleduster and used a "sharp-edged weapon" to behead her. Mukadam had made repeated attempts to escape the night she was killed, but was blocked by two members of Jaffer's household staff. In February 2022, a district and sessions court sentenced Jaffer to death, alongside a 25-year prison term with hard labour and a fine of Rs200,000, concluding the trial that continued for over four months.

Almost a year later, in March 2023, the Islamabad High Court upheld Jaffer's death sentence and upgraded his 25year sentence to an additional death penalty, on the appeals filed against the punishment awarded to the convicts. In the review petition filed by Advocate Muhammad Usman Mirze, Jaffer has argued the prosecution's reliance on video recordings. The plea argues that the May 20 SC judgment failed to consider the fact that the recordings were not proved during the course of the trial.

40 weeks - classifying them as extremely premature. All five infants have very low birth weights and required immediate oxygen support due to underdeveloped lungs, a frequent concern in preterm deliveries. They are currently under round-the-clock care in the neonatal intensive care unit (NICU), with their condition being closely monitored. Hospital officials confirmed that while all five infants are showing signs of gradual improvement, the first few weeks remain critical. Premature babies born before 32 weeks are at a high risk of life-threatening complications including respiratory distress syndrome, brain haemorrhage, infections and long-term developmental delays. "The birth of quintuplets is extremely rare and medically challenging for both mother and babies," a neonatologist at the hospital told The News. "Survival and healthy development depend heavily on immediate neonatal support and ongoing specialized care.
