ISLAMABAD: The government is reportedly preparing to introduce the 27th Constitutional Amendment, a move that has already begun to stir political debate and speculation across the country. According to well-placed sources, the proposed amendment seeks sweeping changes to the existing constitutional framework - including a rollback of key provisions of the 18th Amendment, which devolved significant powers to the provinces. If enacted, the 27th Amendment would

effectively bring crucial departments such as health and population welfare back under the control of the federal government, reversing one of the hallmark features of Pakistan's decentralization process introduced in 2010. The proposed shift is being seen by many as a centralization of authority at a time when the federation is struggling with governance and fiscal coordination issues. ISLAMABAD: Deputy Prime Minister Ishaq Dar said on Tuesday that the federal government would present the 27th Constitutional Amendment in accordance with the Constitution and only after consultation with coalition partners. The ruling Pakistan Muslim League-Nawaz (PML-N) formally approached its key ally – the Pakistan Peoples Party (PPP) – for its support in introducing the amendment, which would establish a

Constitutional Court, and make certain changes to the National Finance Commission (NFC) Award. This tweak also sought to amend Article 243 – which pertains to the supreme command of the armed forces — as well as several other key constitutional adjustments, according to PPP Chairman Bilawal Bhutto Zardari. Other proposals included the introduction of executive magistrates, provisions for the transfer of judges,

LHC bans commercial activities on Sundays

LAHORE: The Lahore High Court (LHC) on Tuesday ordered a complete ban on commercial activities every Sunday in Lahore as part of efforts to curb worsening smog and environmental

pollution in the city. LHC Justice Shahid Karim heard a set of petitions on environmental issues and ordered the complete closure of commercial activities on Sundays and strict enforcement of the 10pm closure for marriage halls in Lahore. Lahore, the capital of Punjab province, was ranked as the most polluted city in the world again on Tuesday.

Lahore recorded an Air Quality Index (AQI) of 372, categorised as "hazardous" at 8:30am on Tuesday, according to the Swiss air monitoring agency IQAir. During the hearing today,

Deputy Commissioner Lahore Musa Raza appeared before the court and presented notifications mandating the closure of markets and restaurants by 10pm.

"The purpose is not merely to issue notifications but to ensure their implementation," the LHC judge remarked. The court further ordered that a director-level officer from the environment department appear at each hearing to brief the bench on progress.

A commission member informed the court that ongoing excavation near Khayaban-e-Firdousi was causing daily traffic iams. WASA's legal adviser, Irfan Akram, responded that the sewerage system across Lahore was being upgraded, and progress reports would be shared in the next hearing.

ISLAMABAD: Pakistan has struck a deal to cancel 21 liquefied natural gas (LNG) cargoes under its long-term contract with Italy's Eni as part of a plan to curb excess imports that have flooded its gas network, according to an official document and two sources. The document from state-owned Pakistan LNG Ltd (PLL) to the country's Ministry of Energy, dated October 22, said 11 cargoes planned for 2026 and 10 for 2027 would be cancelled at the request of gas distributor SNGPL. Only the planned January shipment in both years, and the December shipment in 2027, would be retained to meet peak winter demand,

PIA flights grounded as engineers halt clearances

PIA's international flights hit since Monday night; at least dozen affected, leaving many Umrah pilgrims stranded

DISPUTE between Pakistan International Airlines (PIA) management and its aircraft engineers has brought flight operations to a near halt, as the disgruntled staff have stopped granting clearances, leaving planes grounded and causing widespread disruption for passengers across the country.

Sources said the engineers' protest has severely disrupted flights. Since around 8pm on Monday, not a single international flight of the airline has been able to depart. At least 55 flights have been affected, with five cancelled across the Karachi, Lahore, and Islamabad airports, they said.

Twelve international flights have also been affected so far, leaving passengers in a difficult spot. A large number of them are Umrah pilgrims. Two Karachi-Skardu flights and one Lahore-Karachi flight were cancelled, while Lahore-Muscat flights PK-329

and PK-330 were also cancelled. Similarly, the Karachi-Lahore flight PK-302 was delayed by over 14 hours, while Karachi-Islamabad's first flight, PK-300, could not take off as scheduled. Islamabad-Gilgit flights PK-601 and PK-602 also failed to operate due to operational disruption. The Society of Aircraft Engineers of Pakistan (SAEP) said its members would not return to work until the airline's CEO changed his attitude. They've stopped issuing airworthiness clearance for the aircraft, the union said.

Junaid seeks stronger maritime ties with Romania to boost blue economy

KARACHI: Federal Minister for Maritime Affairs Muhammad Junaid Anwar Chaudhry and Romanian Ambassador Dr. Dan Stoenescu discussed closer cooperation between Karachi Port and Romania's Port of Constan?a, focusing on logistics integration, trade facilitation, and regional connectivity. Rear Admiral Atiq-ur-Rehman, Acting Chairman of the Karachi Port Trust, also attended the meeting. The minister said Pakistan wants to play a bigger role in global maritime trade by building linkages that connect the Middle East, Central Asia, Eastern Europe, and Africa. He highlighted the potential of connecting Pakistani ports with the Port of Constan?a to expand access to European

markets and advance the blue economy. Junaid Chaudhry noted that Pakistan's number of operational ports is expected to rise to six in the coming years, with existing ports reaching full capacity before 2047. Strengthening maritime infrastructure and connectivity, he said, is key to turning Pakistan into a major industrial and trade hub. Both sides discussed capacity building and agreed to explore training and exchange programs in areas such as maritime safety, port operations, environmental management, and digital logistics. The minister said developing a skilled workforce to manage next-generation port systems is central to Pakistan's modernization plans. Ambassador Stoenescu praised the quality of Pakistani exports and expressed Romania's interest in importing sports goods,

surgical instruments, and agricultural products. He reaffirmed Romania's commitment to strengthening economic and diplomatic ties with Pakistan, calling maritime cooperation a practical way to deepen regional integration and shared prosperity. The talks also covered opportunities for private sector participation and investment in port infrastructure. Both sides expressed optimism about opening new trade routes and reinforcing Pakistan's position as a regional maritime hub. Junaid Chaudhry said stronger partnerships with European countries like Romania would help diversify Pakistan's export markets while supporting regional stability through economic cooperation and innovation. Both sides reaffirmed their resolve to expand collaboration across economic, educational, and cultural sectors, reflecting the growing partnership between Pakistan and Romania

Call for institutional reforms to tap loss, damage fund ahead of COP30

gears up for COP30, Pakistan faces an urgent need to strengthen governance, institutional readiness, and local resilience, and clarify access mechanisms to effectively benefit from the Fund for Responding to Loss and Damage (FRLD). While the fund presents a critical opportunity for Pakistan, persistent gaps in governance, capacity, accreditation, and project preparedness continue to impede timely access Building climate resilience demands integrated planning, a better understanding of financing processes, bankable projects, and locally driven approaches. Without these, Pakistan risks remaining on the margins of emerging global climate finance flows, designed to compensate developing nations for climate-induced losses. Climate experts stressed this during a roundtable titled 'Operationalizing the Loss and Damage Fund: Expectations

ISLAMABAD: As the global community Ahead of COP30,' held at the Institute of Policy Studies (IPS), Islamabad. The event was addressed by Khalid Rahman, chairman IPS, Ali Tauqeer Shaikh, senior climate expert and FRLD board member, Afia Malik, senior energy economist, Muhammad Hammad Bashir, climate finance expert, Dr Saira Qaiser, director policy, Pakistan Academy of Science, Talha Tufail, research officer, Institute of Regional Studies, Dr Irfan Yousaf, climate expert and consultant, World Bank, and Hamid Sarfaraz, climate expert. Speaking on the evolving global framework of the Loss and Damage Fund, Ali Taugeer explained that loss and damage financing is distinct from mitigation and adaptation efforts, as it compensates developing countries for the costs of building resilience. He informed that direct budget support under the fund has been confirmed but remains non-operational, pending adoption of the risk

management framework. Taugeer further pointed out that procedural obstructions are slowing direct access to the fund, and until national accreditation is achieved. countries will have to rely on multilateral entities for access. He emphasized that projects must demonstrate country ownership, measurable results, and complementarity with national systems, with 50 percent allocation for least developed countries and geographic balance as guiding principles. Furthermore, Afia Malik highlighted that extreme weather events are already imposing heavy costs on Pakistan's energy infrastructure. She pointed out that power distribution companies have not upgraded their systems to make them climate-resilient, emphasizing the need for climate risk assessments in procurement processes and least-cost planning that accounts for resilience.—DNA

ISLAMABAD: "This year's sesame varieties were selected by the expert, and with the accompanying planting techniques, my sesame is now of high quality and high yield, which can also be exported to generate income," China Economic Net (CEN) reported on Tuesday. Sesame is one of Pakistan's traditional crops, with Punjab province as the largest sesame-producing region in Pakistan. Historically, local varieties have suffered from slightly weaker resistance to adverse conditions, lower yields, and significant annual yield fluctuations. Musadik Malik warns of 'weaponisation of water'

The minister warned that lower riparian countries – those located downstream on shared rivers – faced growing risks as powerful upstream nations sought control over water flows

ISLAMABAD: Federal Minister for Climate Change and Environmental Coordination, Senator Dr Musadik Malik, on Tuesday warned that the world is moving towards a dangerous new order marked by the "weaponisation of water" and growing injustice in global climate politics.

Speaking at the Sustainable Development Policy Institute's (SDPI) 28th Sustainable Development Conference at the Allama Iqbal Open University in Islamabad, Dr Malik said the collapse of multilateral cooperation was pushing the world into an era of conflict and competition.

"Multilateralism is dying," he told delegates. "It's landing its way to bilateralism, and now mostly to unilateralism. The new politics of the world is not moving towards cooperation. You are going to see more wars, more conflict, and more weaponisation."

The minister warned that lower riparian countries - those located downstream on shared rivers faced growing risks as powerful upstream nations sought control

"Water is becoming the next weapon," he said. "Once the precedent is set for upper riparian countries to control water, what will come next - the weaponisation of wind?" Dr Malik also criticised what he described as hypocrisy in global climate finance, accusing major polluters of benefiting the most from green funding. He said that 40% of the world's carbon emissions were produced by just two countries, while ten nations accounted for 75% - yet the same ten received around 85% of global green financing. "Countries like Pakistan and Bangladesh emit less than one

percent of global emissions," he said. "The countries that consume the environment don't pay the price. They should be charged for the oxygen they consume and the carbon dioxide and methane they emit. This is not justice - it's the industrial policy of big carbon emitters." Recalling Pakistan's 2022 floods, which killed up to 2,000 people and displaced more than eight million, Dr Malik said the disaster underscored the human cost of climate change. Economic losses were estimated between \$32bn and \$40bn - about 15-18% of the country's GDP.

He added that Pakistan ranked 167th out of 180 nations in progress towards the UN's Sustainable Development Goals, saying the country must "find sustainability in an era of global disorder." "This conference is not about the past — it's about the future," he said. "We must speak the truth and stand up for climate justice.'

The SDPI's annual Sustainable **Development Conference brings** together international experts, academics and policymakers to discuss the challenges of achieving sustainable growth amid climate and geopolitical instability.

Citizens urged to stay alert as dengue

ISLAMABAD: concern over the growing number of cases, health experts Tuesday appealed to healthcare professionals, district administrations and other stakeholders to step up awareness and prevention measures as the situation could worsen through December While speaking with a local news channel, dengue expert Dr. Faheem expressed serious concern over the rising number of dengue cases across several districts, adding, if timely preventive measures are not taken. the situation could worsen in the coming weeks, with cases likely to remain high through December. Dr. Faheem emphasized that the recent surge is largely due to stagnant water accumulation following intermittent rains, which provides ideal breeding grounds for mosquitoes. He urged local authorities to intensify fumigation drives, clear clogged drains, and promote awareness about early detection and treatment. Highlighting the critical role of public cooperation, Dr. Faheem called on citizens to regularly inspect their homes and surroundings, eliminate standing water, and use mosquito repellents.—APP



Thar Power Projects reach completion milestone ISLAMABAD: The lenders of two 330-megawatt coal-fired power projects in Thar, developed under the China-Paki-

CPEC's 2×330 MW

stan Economic Corridor (CPEC), have declared the Project Completion Date (PCD) on October 31, 2025, according to filings made by Fauji Fertilizer Company Limited (FFC), The Hub Power Company Limited (HUBCO), and Thal Limited to the Pakistan Stock Exchange (PSX). According to official documents available with Gwadar Pro, lenders of Thar Energy Limited (TEL) and Thal Nova Power Thar (Private) Limited (TN) have declared the occurrence of the PCD for their respective 2×330 MW mine-mouth coal-fired power plants on October 31, 2025. The announcements were formally conveyed to the Pakistan Stock Exchange (PSX) on November 3 by FFC, HUBCO, and Thal Limited, the key stakeholders in the Thar energy complex. In its disclosure, FFC stated, "We are pleased to inform you that the lenders of Thar Energy Limited (TEL) have declared the occurrence of 'Project Completion Date' of the 330 MW power plant on October 31, 2025 ... TEL is a mine-mouth coal-fired IPP operating in Thar, which successfully achieved Commercial Operations Date on October 1, 2022. FFC holds 30 percent shares in TEL." Encroachments in Islamabad's sector G-8 growing unchecked

NCROACHMENTS in Islamabad's Sector G-8 have reached alarming proportions, turning once orderly streets into congested corridors of chaos. Despite repeated complaints from residents, the Capital Development Authority (CDA) and Islamabad Traffic Police (ITP) appear to be doing little beyond issuing hollow statements and conducting superficial operations that fail to address the root of the problem. Over the past several years, open spaces, service roads, and even footpaths in G-8 Markaz and surrounding areas have been overtaken by car showrooms, workshops, and informal businesses. What was originally planned as a commercial and residential hub has now become a sprawling encroachment zone, where every inch of public space seems to have been commercialized.

The most glaring violations are visible outside car showrooms that have virtually taken over service roads and footpaths, using them as parking lots and display areas for their vehicles. In some stretches, particularly in G-8 Markaz and G-8/4, pedestrians are forced to walk on the roads as sidewalks are completely blocked by cars. Residents complain that the CDA enforcement teams turn a blind eye to these blatant encroachments, allowing businesses to operate freely in violation of municipal by-laws. "The situation has become unbearable," said a resident of G-8. "We cannot even park our own cars near our homes because showrooms and workshops occupy every available space. The CDA only wakes up when media highlights the issue, and even then, they just remove a few temporary setups and leave the main violators untouched." The Islamabad Traffic Police, too, have been criticized for what locals describe as "lip service" and "cosmetic actions." Despite visible traffic chaos in and around the Markaz, ITP's response has been limited to placing cones or posting officers for a few hours. Vehicles parked illegally on footpaths, greenbelts, and double lanes remain unchecked.

Traffic congestion during peak hours has become routine, particularly around the main commercial areas and near the G-8/4 government offices such as AGPR, PEM-RA, PTCL, POST OFFICE etc. Commuters often find themselves trapped in long lines of traffic, made worse by haphazard parking and unauthorized roadside businesses. "Every other day there's a traffic jam here. Instead of clearing the encroachments, the authorities just fine a few drivers and move on," complained a shopkeeper. Urban planners and civic activists say the unchecked encroachments reflect a deeper governance failure. "The CDA's enforcement wing is either under pressure from commercial interests or simply lacks the will to act. This kind of neglect not only ruins the city's aesthetics but also discourages law-abiding citizens," remarked a former CDA official on condition of anonymity. Residents have demanded immediate and meaningful action not just symbolic drives to reclaim public spaces. They are calling for strict enforcement of building and parking regulations, removal of illegal car showrooms, and continuous monitoring to prevent re-encroachment.

Negligence and fee hike render Naseer Bunda Hockey Ground practically useless

THE once-vibrant Naseer Bunda Hockey Ground in Islamabad lies in a state of disrepair, a stark reminder of the Pakistan Sports Board's (PSB) negligence and poor administrative decisions. A place that once echoed with the rhythm of hockey sticks and the dreams of young athletes now wears a deserted look. The reasons are many, but the most glaring is the sharp increase in ground usage fees that has effectively priced out local clubs and athletes. In recent months, the PSB raised the ground usage fee by nearly 300 percent, a move that has shocked and disappointed the local hockey community. What was once an affordable space for budding players and clubs to train has now become inaccessible to most due to the exorbitant charges. With no teams or clubs able to afford the revised fee, the ground sees little to no activity - leading to rapid wear and tear of the turf, unmaintained facilities, and a visible decline in its overall condition. Reports suggest that washrooms are in a filthy condition, water pumps are out of order, and general maintenance is non-existent. The very turf that was supposed to be preserved through better financial planning is now deteriorating faster due to non-usage and lack of upkeep. Ironically, the PSB's decision to increase revenue through the hike has likely backfired, as the absence of bookings means less revenue instead of more. One wonders whether anyone at PSB has formally assessed the revenue trends before and after the price hike - a basic step in policy-making. It appears not.

Despite repeated appeals and written requests by local clubs to reconsider the revised fees or to offer concessions for student and grassroots teams, both the Pakistan Sports Board and the Ministry of Inter-Provincial Coordination have remained unmoved. Their inaction signals not only indifference but also a disturbing disconnect from ground realities and the needs of the hockey community. Pakistan's national sport has long been in decline, and missteps like these only further alienate young players from pursuing hockey professionally. Naseer Bunda Hockey Ground was meant to be a cradle of talent, nurturing the next generation of national players. Instead, it now symbolizes the decay of the sport itself. There is a pressing need for introspection at the PSB and the ministry level. If the goal is to promote sports, particularly hockey, then facilities must be made affordable, accessible, and maintained to a standard that encourages participation. Charging steep fees while failing to provide basic amenities is a disservice not only to the sport but also to the nation's youth. Until the authorities take corrective action - including revisiting the fee structure, restoring basic facilities, and consulting with stakeholders - the future of hockey in Islamabad, and by extension in Pakistan, remains bleak.

Canada Ad That Rattled Trump

Polls conducted by the Toronto Star indicated that 42% of Canadians supported the ad, while 47% thought it was ill-timed and diplomatically irresponsible N October 2025, a seemingly harmless Canadian public-service announcement featuring Ronald Reagan's 1987 speech on tariffs ignited an international political storm. What began as a provincial media campaign by Ontario quickly escalated into a full-blown trade confrontation with the United States—one that exposed the fragility of U.S.-Canada relations in the Trump era and the fine line between political messaging and economic provocation.

The ad opened with archival footage of Reagan declaring, "Protectionism is destructionism. Tariffs and quotas are barriers that protect the few at the expense of the many." The message, originally delivered at the height of the Cold War, was reinterpreted by Ontario's communications bureau as a critique of modern tariff nationalism. The closing frame read, "Free trade built North America. Tariffs break it." The timing was deliberate. It aired just days after President Donald J. Trump announced a 5% tariff increase on Canadian steel, aluminum, and agricultural imports—part of his renewed "America First Fair Trade" agenda.

For Trump, the ad wasn't merely a disagreement over policy; it was personal. The president viewed the Reagan montage as a deliberate distortion of a conservative icon's legacy—one that painted Trump as an economic isolationist rather than a nationalist reformer. Within hours of the broadcast, the White House communications team condemned the ad as "foreign political interference in U.S. policy discourse." Trump himself took to Truth Social, writing: "Fake Reagan quotes, fake Canada leadership. We're done talking until they apologize. New tariffs coming."

The fallout was swift. Trump's administration suspended ongoing trade negotiations aimed at refining the U.S.-Canada Economic Partnership Framework. He ordered a 10% across-the-board tariff increase on all Canadian imports, including automotive parts, lumber, dairy, and consumer goods. For two economies intertwined through \$800 billion in annual trade, the move sent shockwaves through industries on both sides of the border. Trucking associations, small exporters, and retail chains immediately warned that price hikes were inevitable before the 2025 holiday season.

In Ottawa, Prime Minister Mark Carney acted quickly to contain the crisis. Although the advertisement originated from Ontario's provincial government rather than the federal cabinet, Trump's

reaction forced Ottawa to intervene. In a carefully worded statement, Carney expressed "regret for any misunderstanding" and emphasized that "the ad does not reflect Canada's federal stance on U.S. trade policy." According to The Washington Post, Carney even reached out to Trump personally to offer an apology—an unusual act in modern diplomacy that underscored how high the stakes were. Trump acknowledged the apology publicly but refused to lift the suspension of trade talks. "I appreciate Prime Minister Carney's words," he said during a Mar-a-Lago press briefing. "But actions speak louder than apologies. We'll see if Canada really wants fair trade—not propaganda."

The ad's creators defended their intent, claiming it was meant to "highlight the historical value of free trade" rather than criticize Trump personally. Yet political analysts in both countries saw it as a textbook case of how symbolic gestures can spiral into real-world consequences. "Reagan's words were about global cooperation against communism, not about contemporary tariff disputes," explained Professor Samuel Pritchard of the University of Toronto. "Re-contextualizing them during an active negotiation with a protectionist White House was politically reckless, even if rhetorically clever."

For small business owners in Ontario and Quebec, the timing could not have been worse. Tariff hikes immediately disrupted auto-parts exports and timber shipments. The Canadian Chamber of Commerce estimated losses exceeding \$2.4 billion within the first two weeks of the new tariff regime. The Toronto Stock Exchange saw its manufacturing index fall by nearly 4% in a single day—its steepest drop since early 2023.

In the United States, the political narrative was equally polarized. Trump's supporters hailed the move as evidence of his "uncompromising defense of American workers," while his critics accused him of hyper-

sensitivity and using trade policy to punish political speech abroad. Several U.S. senators from border states, including Michigan and New York, quietly urged the administration to de-escalate, citing mounting pressure from local businesses dependent on cross-border supply chains. Mark Carney's apology, intended as a pragmatic gesture, triggered heated debate in Canada's Parliament. Opposition leader Pierre Poilievre accused the prime minister of "bowing to American intimidation" and undermining Canadian sovereignty. Carney countered that leadership demanded "preventing a rhetorical dispute from turning into an economic war." His cautionary tone reflected the grim reality that Canada could ill afford another prolonged tariff standoff, especially after years of global inflation and energy-price volatility.

Meanwhile, the United States began leveraging the dispute in broader trade negotiations with Europe and Mexico, signaling that Washington was prepared to use tariffs not merely as economic tools but as instruments of political discipline. Analysts warned that such tactics risked eroding trust even among America's closest allies. The Reagan-ad episode, they argued, revealed how fragile diplomatic etiquette had become in an era of social-media-driven politics and impulsive leadership.

For historians, the irony was impossible to miss. Ronald Reagan—whose words were meant to defend free markets—had unintentionally become the centerpiece of a 21st-century trade war. The contrast between Reagan's optimism and Trump's transactional realism encapsulated a profound shift in American conservatism: from a belief in open exchange to a strategy rooted in economic nationalism and leverage.

The "Reagan Ad Affair," as international media dubbed it, may one day be remembered less for its economic cost and more for its symbolic power. It captured a moment when an old speech from the Cold War could still shake the foundations of modern diplomacy—when images, not policies, defined the fate of nations. In an age where political theater travels faster than policy restraint, one provincial ad in Canada became a global lesson in the perilous intersection of media, ego, and economics.

A History of Faith, Wisdom and Victory

ISTORY has a curious way of drawing parallels across centuries, linking men of destiny whose courage and conviction transcend time. More than eight hundred years apart, two commanders — Sultan Muhammad Ghauri and Field Marshal General Syed Asim Munir — stood in moments of national trial and triumph, defending faith, honour, and sovereignty against formidable adversaries. Though separated by centuries, the essence of their missions and the spirit of their victories reveal a striking resemblance; both Chief faced India as the principal foe, both emerged victorious through strategy and perseverance, and both carried the banner of a Muslim commander whose faith guided his sword.

mander whose faith guided his sword. In the late 12th century, Sultan Muhammad Ghauri, the ruler of Ghor in present-day Afghanistan, rose from the rugged mountains to become the founder of Muslim rule in northern India. His historic encounter with Prithvi Raj Chauhan, the ruler of Ajmer and Delhi, marked a turning point in the subcontinent's destiny. The First Battle of Tarain, fought in 1191, saw Ghauri defeated and wounded. But rather than surrendering to despair, he returned the following year -1192 – with renewed resolve, reorganized forces, and divine faith. On the plains near Tarain once more, he crushed the Rajput confederacy and captured Prithvi Raj Chauhan. The victory at Tarain was not merely a military conquest; it opened the gates of India to centuries of Muslim rule and civilizational synthesis. Eight centuries later, another commander from the soil of Pakistan mirrored this determination and strategic brilliance. On the nights of 8 and 9 May 2025, when India sought to test Pakistan's resolve through a sudden and treacherous strike, General Syed Asim Munir, then serving as Pakistan's Chief of Army Staff, led the nation through what became known as the One-Day War. The Indian offensive – planned with precision but motivated by arrogance – met with swift and decisive retaliation from Pakistan's armed forces. Within hours, Indian military installations across the Line of Control were neutralized, and their aerial and ground incursions repelled. The night that was meant to bring Pakistan to its knees became the dawn of its renewed pride and unity.

Both Sultan Ghauri and Gen. Asim Munir displayed the attributes of leaders who believed that battles are not merely won by weapons but by faith, discipline, and conviction. Ghauri's empire was born from the ashes of repeated defeats, while Asim Munir's triumph emerged from years of subversive warfare waged by India through its proxies in Afghanistan. In both cases, the enemy underestimated the power of belief — a mistake history has never forgiven.

These extremist, supported and financed by hostile agencies, particularly Indian intelligence networks, sought to destabilize Pakistan from Afghan soil – a strategy reminiscent of medieval alliances between Hindu Rajputs and Central Asian chieftains against emerging Muslim powers.

chieftains against emerging Muslim powers. The modern commander's challenge was not of cavalry and swords but of drones, intelligence, and hybrid warfare. Yet the essence remained unchanged — defending Pakistan's ideological and territorial integrity against forces that refused to accept its right to exist in peace. General Asim Munir's strategic doctrine combined deterrence with restraint, faith with professionalism, and national security with moral clarity. His background as a Hafiz-e-Quran and his reputation for integrity lent a spiritual depth to his leadership, recalling the piety and discipline of the early Islamic commanders.

discipline of the early Islamic commanders. Both Sultan Ghauri and Gen Asim embodied an unwavering trust in divine will while employing the finest strategies of their age. When Ghauri faced the Rajput confederacy, he used trickery, speed, and tactical flexibility to counter the traditional elephant corps of the Indian armies. His cavalry maneuvered with precision, turning what seemed an equal fight into a resounding victory. Likewise, General Asim Munir used the modern tools of warfare - surveillance, cyber intelligence, and swift precision strikes - to neutralize a numerically larger adversary. The speed and surprise of Pakistan's counteroffensive during the May 2025 conflict echoed Ghauri's own mastery of battlefield timing eight centuries earlier. The aftermath of both victories was equally telling. Ghauri's triumph laid the foundations for the Delhi Sultanate, which would last for centuries and nurture the composite civilization of the Indo-Muslim world. In the same way, Asim Munir's leadership restored confidence to a nation fatigued by internal challenges and external conspiracies. The victory of May 2025 was not merely military – it reaffirmed the unity of Pakistan's people and the resilience of its institutions.

It is said that leaders are born in the crucible of adversitv. Sultan Muhammad Ghauri was once captured by his enemies but rose to become the conqueror of Hindustan. Gen. Asim Munir, too, faced challenges from political turbulence, terrorism, and regional hostility, yet emerged as the guardian of Pakistan's sovereignty. Their lives reflect the principle that true commanders fight not for glory but for faith, duty, and the endurance of their nation. In the final analysis, history does not merely repeat itself; it echoes the virtues of courage, faith, and perseverance through men who understand the weight of command. Sultan Muhammad Ghauri and Field Marshal Syed Asim Munir, though separated by eight centuries, stand as twin reflections in the mirror of time - soldiers of faith who defended their frontiers against India's aggression, one through the sword and the other through strategy, both guided by conviction that victory belongs only to those who fight with righteousness and trust in Allah.

Sources suggest that the move aims to provide legal cover for the potential appointment of a Field Marshal, a development that could have profound implications for Pakistan's civil-military balance. Moreover, the powers of the judiciary may also be curtailed under the new constitutional scheme. Reports indicate that the government intends to establish a full-fledged Constitutional Court, separate from the existing Supreme Court structure. A similar concept was floated earlier under the 26th Amendment, which created a constitutional bench, but it failed to achieve its intended objectives. Critics argue that the new amendment is less about reform and more about consolidating power. "One thing is clear - this amendment has nothing to do with the welfare of the people of Pakistan. It's purely a power game, an exercise in dominance," a senior political analyst remarked. The Pakistan Peoples Party (PPP), which was the chief architect of the 18th Amendment, has strongly opposed the proposed changes. Party leaders fear that undoing provincial autonomy will undermine the federal structure of the state. However, political insiders suggest that despite its initial resistance, the PPP may ultimately strike a deal if it receives certain political concessions. As deliberations continue behind closed doors, the 27th Amendment appears set to reshape Pakistan's political and constitutional landscape once again - though not necessarily in favor of the common citizen. Another leading political party the PTI has also decided to oppose the amendment. The PTI leadership made it clear that any attempt to cut powers of the judiciary or to

Worker dies after medieval tower partly collapses in Rome

ROME: A worker who was pulled from the rubble of a medieval tower that partly collapsed in Rome died on Tuesday, Italian media reported citing hospital sources. The man, a Romanian national, had remained conscious during the long rescue operation before being hospitalised in critical condition, according to authorities. "Resuscitation attempts were made for about an hour to save Octay Stroici, Italian news agency ANSA said, citing the Umberto I hospital. "Despite this, spontaneous cardiac activity could not be restored" and his "death was pronounced at 12:20 am." He had been helping to renovate the Torre dei Conti, which partially collapsed shortly before midday Monday, sending rubble into the street and a thick white cloud of dust into the air. Three other workers were earlier evacuated from the site, one of them in critical condition, a spokesman for the fire service told AFP. The tower is in a busy area, just off the Imperial Forum and close to the Colosseum, Italy's top tourist site. A second partial collapse of the tower about one and a half hours later sent up further billowing clouds of dust. After the first collapse, firefighters managed to "put up some protection" around the trapped man, so when the second collapse occurred he was shielded, Rome Prefect Lamberto Giannini said.

One worker inside at the time of the first collapse told AFP he escaped from a balcony. "It was not safe. I just want to go home," said the man, white dust covering his uniform, who gave his name as Ottaviano and his age as 67. The Torre dei Conti, dating from the early 13th century, was being restored with European Union funds. Monday's collapses affected a buttress and part of the tower's base, then stairwell and the roof, Rome's

"Got married, had some really great days on the track, but nothing ever, ever compares to this feeling right now I'm feeling." She joined Michelle Payne, who famously steered 100-1 outsider Prince of Penzance to glory in 2015, as the only women to win the race.

South Korea to triple AI spending, boost defence budget

SEOUL: South Korea will triple spending on artificial intelligence and make its biggest defence budget increase in six years, President Lee Jae Myung said Tuesday in his annual parliamentary budget speech. Lee said 10.1 trillion won (\$7 billion) would go towards "a major transformation aimed at propelling South Korea into the ranks of the world's top three AI powers" alongside the United States and China. "We will significantly expand investment to usher in the 'AI era'," he said, noting the amount was more than three times the current year's AI-related budget.

The proposal was made in a speech outlining his government's spending plans for 2026. Overall, the budget plan totals 728 trillion won, an 8.1 percent increase from this year. Lee now needs parliament to pass the budget proposal, which is likely given his party's majority. On the defence budget, the president said his government wants to see an 8.2 percent increase from this year to 66.3 trillion won. If passed, it will mark the highest defence spending increase since 2019. "We will overhaul conventional weapons systems into state-of-the-art systems suited for the AI era and swiftly transform our military into an elite, smart force," Lee said.

Of next year's AI budget, 2.6 trillion won "will be invested in introducing AI across industry, daily life and the public sector, while 7.5 trillion won will

go towards talent development and infrastructure building", Lee said. South Korea is home to two of the world's leading memory chip makers, Samsung Electronics and SK hynix. The two tech giants manufacture chips essential for AI products and the power-hungry data centres that the fast-evolving industry relies on. Jensen Huang, the CEO of US chip titan Nvidia, announced last week plans to supply 260,000 of the firm's most advanced chips to South Korea. After the announcement on Friday, Huang described that goal as "ambitious".

But, he said, "there's no reason why Korea cannot achieve it - you have the technology, you have the software expertise and you also have a natural ability to build manufacturing plants". The US, a key military ally, stations about 28,500 troops in South Korea to help it fend off military threats from the North.

Since taking office in June, Lee has vowed to "re-

spect" North Korea's political system and pursue dialogue without preconditions, in a sharp break with the policies of his hawkish predecessor.

Lee noted on Tuesday that South Korea already spends "1.4 times North Korea's annual GDP" on defence alone and is "ranked fifth in global military strength". Seoul and Pyongyang technically remain at war as the 1950-53 Korean War ended in armistice, not a peace treaty. - Agencies

At least 5 people killed in train crash in central India

NEW DELHI: A passenger train crashed into a cargo train in central India Tuesday, killing at least five people and injuring several others, a senior government official said The incident happened near Bilaspur, about 116 kilometers (72 miles) from Chhattisgarh's state capital, Raipur. Television channels showed images of one train colliding with another near the accident site. Rescuers are searching through the debris for survivors. The local passenger train hit the goods train from behind and toppled over some coaches, senior government official Sanjay Agarwal told The Associated Press. "Rescue team is trying to cut through the train to take out a few passengers trapped inside," he said. Train collisions aren't uncommon in India where the vast rail network faces issues of aging infrastructure and human error._APP

In his opening remarks, Minister Jam Kamal Khan underscored the urgent need for enhanced economic cooperation, digital integration, and sustainable development among OIC member states, describing COMCEC as a vital platform to advance shared prosperity across the Muslim Ummah. "It is an honor to address this distinguished gathering at a time when the world faces profound economic, political, and environmental challenges," he stated. "For us in the Islamic world, economic cooperation is not merely about trade-it is about forging stronger bonds of partnership and mutual benefit." The minister emphasized that intra-OIC trade and investment must be significantly strengthened to overcome global challenges. Despite immense potential, intra-OIC trade remains below its capacity, largely due to regulatory barriers, limited connectivity, and infrastructural gaps. He proposed reducing non-tariff barriers, streamlining customs procedures, and harmonizing trade regulations across member states to promote freer movement of goods and services. "Pakistan believes the OIC Trade Agreement should become a real tool for trade liberalization and cross-border facilitation," he added. Highlighting Pakistan's commitment to regional collaboration, the minister called for greater private-sector engagement and public-private partnerships to unlock new avenues for investment and job creation. Jam Kamal Khan also urged member countries to prioritize digital transformation, particularly in areas like e-commerce, fintech, and digital infrastructure, to expand opportunities for youth and entrepreneurs. "By promoting digital integration, we can enhance market access and create new prospects for innovation and growth," he noted. On sustainability, he reiterated Pakistan's dedication to the UN Sustainable Development Goals (SDGs) and proposed the establishment of an OIC Green Finance Mechanism to fund climate-resilient and renewable-energy projects. "Our economic growth must go hand in hand with environmental stewardship to ensure prosperity for future generations," he emphasized. The minister further suggested the creation of an OIC Center of Excellence for knowledge sharing, capacity building, and innovation across sectors such as agriculture, manufacturing, and renewable energy. During the same session, Pakistan also delivered a joint statement on behalf of the Asia Group, reaffirming collective commitment to strengthening economic cooperation and advancing digital transformation among OIC countries. Representing the Asia Group, Minister Jam Kamal Khan extended deep appreciation to the Government of Türkiye and President Recep Tayyip Erdogan for hosting the session and for their continued leadership in promoting economic solidarity among Muslim nations. He highlighted that while digital technologies are transforming trade, logistics, and financial systems in many Asian OIC countries, digital disparities persist in broadband coverage, data governance, and cross-border payment systems. "The Muslim Ummah must act decisively to ensure that no member state is left behind in this digital transformation," he stated, urging member states to strengthen secure, resilient, and inclusive digital infrastructure and promote Shariah-compliant financial solutions for small and medium enterprises. The statement also called for greater data-driven cooperation among OIC institutions-such as SESRIC, IsDB, ICDT, and IOFS-to promote evidence-based policymaking, while encouraging youth participation and digital-skills development as key drivers of inclusive economic growth. The Asia Group reaffirmed support for achieving the OIC's target of 25 percent intra-OIC trade share by 2025 through the adoption of digital customs and single-window systems, and urged closer collaboration on developing regional digital payments and trade facilitation platforms.-DNA

Those convicted could face up to six months in prison "The level of abuse faced by those taking part in British politics is truly shocking - it's a threat to our democracy," security minister Dan Jarvis said in a statement. "People should be able to participate in our politics without fearing for their own or their family's safety." A parliamentary survey found that 96 percent of British lawmakers had experienced harassment, while an independent body that oversees elections in Britain said more than half of candidates in the last general election faced threats or intimidation. Before winning the election last year, the now Prime Minister Keir Starmer was targeted, when pro-Palestinian activists left children's shoes and a banner outside his London home, urging him to back an arms embargo on Israel. Thank God it's there ... so give me the excuse for the presence of 86 states (in a coalition)," he said in an interview in Baghdad, referring to the number of countries that have participated in the coalition since it was formed in 2014. "Then, for sure there will be a clear program to end any arms outside of state institutions. This is the demand of all," he said, noting factions could enter official security forces or get into politics by laying down their arms. 'No side can pull Iraq to war', says Sudani Iraq is navigating a politically sensitive effort to disarm Iranbacked militias amid pressure from the US, which has said it would like Sudani to dismantle armed groups affiliated with the Popular Mobilization Forces, an umbrella group of mostly Shiite factions. The PMF was formally integrated

with Iran. At the same time, the US and Iraq have agreed on a phased withdrawal of American troops, with a full exit expected by the end of 2026. An initial drawdown began in 2025. Asked about growing international pressure on non-state armed groups in the region such as Lebanon's Hezbollah, part of Iran's so-called Axis of Resistance created to counter US and Israeli influence in the Middle East, Sudani said: "There is time enough, God willing. The situation here is different than Lebanon." "Iraq is clear in its stances to maintain security and stability and that state institutions have the decision over war and peace, and that no side can pull Iraq to war or conflict," said Sudani. Shiite power Iran has gained vast influence in Iraq since a USled invasion toppled Saddam Hussein in 2003, with heavily armed pro-Iranian paramilitary groups wielding enormous political and military power. Successive Iraqi governments have faced the challenge of keeping both arch-foes Iran and the US as allies. While the US slaps sanctions on Iran, Iraq does business with it. Securing major US investment is a top priority for Iraq, which has faced severe economic problems and years of sectarian bloodletting since 2003. Us companies increasingly active in Iraq, says Sudani

"There is a clear, intensive and qualitative entrance of US companies into Iraq," said Sudani, including the biggest ever agreement with GE for 24,000 MW of power, equivalent to the country's entire current generation capacity, he said In August, Iraq signed an agreement in principle with US oil producer Chevron (CVX.N), for a project at Nassiriya in southern Iraq that consists of four exploration blocks in addition to the development of other producing oil fields. Sudani said an agreement with US LNG firm Excelerate to provide LNG helped Iraq cope with rolling power cuts. Sudani praised a recent preliminary agreement signed with ExxonMobil, and he said the advantage of this agreement is that for the first time Iraq is agreeing with a global company to develop oilfields along with an export system. Sudani said that US and European companies had shown interest in a plan for the building of a fixed platform for importing and exporting gas off the coast of the Grand Faw Port, which would be the first project there. Sudani said the government had set a deadline for the end

of 2027 to stop all burning of gas and to reach self-sufficiency in gas supplies, and to stop gas imports from Iran. "We burn gas worth four to five billion (dollars) per year and import gas with 4 billion dollars per year. -DNA

RCCI welcomes Roshan Maishiat package

RAWALPINDI: The Rawalpindi Chamber of Commerce and Industry (RCCI) on Tuesday lauded the government's Roshan Maishiat package and its decision to allocate additional power supply to the industrial and agricultural sectors, terming it a landmark initiative toward revitalizing Pakistan's productive economy. In a statement, RCCI President Usman Shaukat commended the government's move to reduce electricity tariffs for the agricultural and industrial sectors. He said the decision demonstrates a strong commitment to supporting key pillars of the national economy Under the new package, the electricity tariff for agricultural consumers has been reduced from Rs38 to Rs22.98 per unit, while the industrial tariff for additional units has been brought down from Rs34 to Rs22.98 per unit. Shaukat noted that high electricity costs have long been a major burden on businesses, directly affecting production, employment, and overall economic activity. "This substantial reduction will significantly lower the average cost of doing business, enabling industries and farmers to boost their productivity and competitiveness," he added. He emphasized that agriculture and industry are the twin pillars of Pakistan's economy-providing employment opportunities, ensuring food security, and contributing significantly to exports. The RCCI president expressed confidence that the Roshan Maishiat package will play a pivotal role in strengthening these sectors and driving sustainable eco-

nomic growth.-APP Turkish flights to Iraq's Sulaimaniyah resume

SULAIMANIYAH, Iraq: Flights between Turkiye and the Iraqi Kurdish city of Sulaimaniyah resumed on Monday after a twoand-a-half year ban due to accusations from Ankara of increased militant activity in the province. Airport spokesman Dana Mohammed said that the first Turkish Airlines flight landed in Sulaimanivah Airport from Turkiye, with 105 passengers on board ... before departing to Istanbul with 123 passengers." Turkiye had announced in April 2023 a ban on flights to and from Sulaimaniyah International Airport over allegations that the outlawed Kurdistan Workers' Party had infiltrated the airport and boosted activity in the province. Mohammed said that Monday's flights marked "the end of the ban" on the airport, adding that "Turkish airspace has been reopened as of today to flights from Europe to the (Sulaimaniyah) airport and vice versa." Turkiye is the main transit point for flights in and out of the key city in Irag's autonomous Kurdistan region._APP

UK govt orders poultry restrictions as avian flu spreads

LONDON: The UK government on Tuesday ordered all poultry in England to be kept inside due to escalating cases of avian influenza. The order takes effect from Thursday "The new measures mean bird keepers across the whole of England must house all poultry and captive birds if they keep more than 50... or if they sell or give eggs away," a statement said. Similar limited restrictions were made in parts of north, central and eastern England last week. "Given the continued increase in the number of avian influenza cases in kept birds and wild birds across England, we are now taking the difficult step to extend the housing measures to the whole of England," said UK Chief Veterinary Officer Christine Middlemiss. The risk to human health remained "low" and that "properly cooked" poultry and eggs were safe to eat, the Department for Environment, Food and Rural Affairs said.-APP

Heavy Rain, hailstorm and first winter snowfall hit **Dir and Swat**

PESHAWAR: Heavy rain and hailstorms accompanied by thunder and lightning on Tuesday morning hit the districts of Dir and Swat in Khyber Pakhtunkhwa, intensifying the cold across the region. In Dir, dark clouds covered the sky as rain and hail lashed the area, causing flash floods in streams and disrupting traffic on the GT Road. Landslides and road erosion in upper areas forced residents to remain indoors.

The downpour and hailstorms damaged standing crops, fruit orchards and several vehicles. The heavy rain also disrupted the power supply, plunging large parts of the district into darkness. In Swat, heavy rain and hail also brought a sharp drop in temperature. In Mingora city, torrential rain caused local streams to overflow. Poor performance by the Water and Sanitation Services Company (WSSC) was once again exposed, as the failure to clean drainage channels in time led to waterlogging on roads.

Rainwater flowing onto streets caused severe inconvenience to residents. In upper areas including Kalam, Mahodand, Utror and Gabral, the season's first snowfall has turned the weather chilly and picturesque. Meanwhile, lightning struck in Chakdara, damaging a 132,000-volt transmission line and cutting off power to several areas. According to WAPDA Swat, efforts are underway to restore electricity, though officials have not provided a timeframe for full restoration. - Agencies

Govt to announced plan for Gaza, says PM Mustafa

RAMALLAH: Prime Minister Dr. Mohammad Mustafa announced that the government will circulate its executive program for Gaza's recovery and reconstruction to all relevant countries and international institutions.

The program outlines a strategic vision for recovery and reconstruction priori ties and coincides with the publication of the updated Gaza Losses and Needs Assessment, prepared in cooperation with the World Bank and UN agencies.

The Prime Minister emphasized that this initiative reflects the readiness of both the government and international partners to implement the program swiftly, within the constraints posed by the current circumstances. At the start of today's (Tuesday) weekly Cabinet session, Prime Minister Mustafa reaffirmed ongoing coordination with UN agencies, international partners, friendly nations, and donor entities to ensure coordinated and integrated interventions.

Blue economy to be 'a game changer', says Aurangzeb

Pakistan's starting point in this sector is "pretty modest" but ambition is right, says finace czar

ISLAMABAD: Finance Minister Muhammad Aurangzeb has said that Pakistan's blue economy will be a "game changer" for the country, backed by a clear roadmap and ambitious targets set by the Ministry of Maritime Affairs. Speaking at a virtual maritime conference, Finance Minister Muhammad Aurangzeb said Pakistan's starting point in the blue economy sector is "pretty modest", contributing around 0.4% to 0.5% of the national GDP, or roughly one billion dollars. He said the Ministry of Maritime Affairs has set an ambitious but achievable goal to grow this figure to \$100 billion by 2047.

"This billion dollars getting to a 100 billion blue economy number by the time we get to 2047 is transformational, and it's the right ambition that we have set ourselves as we go forward," he said. The minister emphasised that this sector has huge potential for national economic transformation. Aurangzeb highlighted that strong international relationships and trade links would support Pakistan's economic stability. "[...] relationships, which have been strong for the longest time, are moving from government-to-government discussions to trade and investment flows into the country," he said. "This, Inshallah, should help us in terms of moving across to a sustainable growth path." He outlined the roadmap to achieve the \$100 billion target, which is backed by strong pillars. Excellence in fisheries and aquaculture is a priority, through



value-added processing, modernising cold chain logistics, and ensuring world-class hygiene standards. Seafood exports, currently worth around \$500 million, could rise to \$2 billion over the next three to four years.

Aurangzeb added that these efforts will be guided by a national fisheries and aquaculture policy in strategic partnership with the FAO, ensuring policy consistency over the long term. The minister also spoke about modernising Pakistan's ports and logistics. "We digitise and upgrade operations, whether it's Karachi, Port Qasim, and Gwadar, to replicate international best practices and strengthen regional trade partnerships," he said. These measures aim to boost trade and logistics efficiency while promoting regional cooperation. Aurangzeb also stressed the importance of renewable energy and marine biotechnology in the blue economy. "We are launching pioneering pilot projects in tidal and offshore wind generation, and developing marine biotechnology value chains, which represent significant opportunities for innovation and growth," he said.

Innovative financing mechanisms, including blue bonds and blended funding models, will support these projects and ensure sustainable development. He said that, along with improved trade and investment flows and ongoing structural reforms, these initiatives would help Pakistan move towards a sustainable growth path. "This is a game-changing sector, where the potential is huge," Aurangzeb said. The finance minister concluded that the blue economy, alongside other transformative sectors such as digital infrastructure, artificial intelligence, and mining, represents a critical engine for Pakistan's long-term growth. "With clear targets and policy consistency, this sector will play a central role in propelling the economy forward," he added.

Explosion at sc building causes panic

ISLAMABAD: An explosion has taken place at the Supreme Court building in Islamabad, according to local media. Media reports initially said the explosion was caused by a gas cylinder but later linked it to an air conditioner.

In multiple videos received by Dawn following the incident, the damaged interior of parts of the SC building is visible with blood stains on the floor. One of Dawn's court correspondents identified one of the areas as a cafeteria located in the building's basement.

In other videos recorded outside, people, including lawyers, could be seen spilling out of the building. At least one person, who was visibly injured and bleeding, could be seen being taken away. Another person, with no visible inuries but apparently badly affected, could also be seen being brought out of the building. Another video also showed policemen present at the site.

Fierce mountain storms kill 9 in Nepal

KATHMANDU: Days of ferocious snowstorms and an avalanche in Nepal's treacherous Himalayan peaks have killed nine people, including five Italian climbers, officials said Tuesday. The deaths occurred in two separate accidents since Friday. On Monday, an avalanche hit a group of 12 people at the base camp of 5,630-metre (18,471-foot) Yalung Ri peak, in central Nepal.

Seven people died in that disaster, including three Italians, two Nepalis, a German and a French climber, Phurba Tenjing Sherpa, from expedition organiser Dreamers Destination, told AFP. Sherpa, whose company had arranged the expedition for some of the group, said he had "seen all the seven bodies".

The rest of the group were rescued and airlifted to the capital Kathmandu on Tuesday morning, said senior police officer Gyan Kumar Mahato, from Dolakha

EU scrambles to seal climate deal

BRUSSELS: EU environment ministers will Tuesday make a last-ditch attempt to reassert the bloc's climate ambitions by nailing down key emissions targets in the run-up to the UN's climate summit in Brazil. "To come empty-handed to Belem," where the COP30 talks are taking place from November 10 to 21, "would really undermine the EU's credibility," warned an EU diplomat. Talks are expected to stretch into the night among the European Union's 27 member states, which have been haggling for months over two separate targets for slashing greenhouse-gas emissions: one for 2035 and the other for 2040.

Behind only China, the United States and India in terms of emissions, the EU has been the most committed of the major polluters to climate action and has already cut emissions by 37 percent compared to 1990. But after blazing a trail, the EU's political landscape has shifted to the right, and climate concerns have largely taken a back seat to defence and competitiveness. Ministers' most urgent challenge on Tuesday is to reach a unanimous deal on an emissions target for 2035, known as a Nationally Determined Contribution (NDC), which Paris Agreement signatories are supposed to bring to the Brazil summit. Beyond that, they hope to lock in the support of a weighted majority of countries for the next big climate target set out by the European Commission on the path to carbon neutrality by 2050. The EU executive said in July it wanted to cut emissions by 90 percent by 2040, compared to 1990 levels - a major step towards net-zero. - Agencies

Pakistan's inflation rises to 6.2% in October, highest in 12 months

Food prices climb after floods, border disruptions disrupt supply chains, shows data

ISLAMABAD: Inflation surged to its highest level in a year in October, fuelled by sharp increases in food prices after floods and border disruptions disrupted supply chains. The renewed price pressures have raised concerns about challenges ahead for the central bank's cautious monetary policy approach. Headline inflation measured by the consumer price index (CPI) rose 6.2% in October 2025 from a year earlier, up from 5.6% in September, as food prices surged 5.6% – the fastest pace since April 2024. Perishable items led the climb, with tomato prices skyrocketing 127%, sugar up 34.8%, wheat 22.6% and wheat flour 15.7%,

The supply shocks, triggered by flood-damaged farmlands and the closure of the Afghan border following clashes, squeezed agricultural trade routes and caused some food item shortages, spilling inflationary pressure across other sectors. Price pressures spread beyond food, with housing and utilities inflation quickening to 4.2% from 3.7% and transport costs jumping to 6.7% from 4.2%. Clothing and footwear edged up to 8.1%, while miscellaneous goods

and services surged to 18.2% from 14.9%. Inflation held steady for restaurants and hotels at 6.1% and eased slightly for household furnishings to 4.0%. Recreation and culture prices, however, extended their decline, falling 3.7%. On a monthly basis, consumer prices rose 1.8%, driven by a sharp 14.9% spike in perishable food costs. Notably, on October 27, the State Bank of Pakistan kept its key interest rate unchanged at 11% for the fourth meeting in a row, taking a cautious approach as it faces rising inflation and a weak economic recovery. The central bank is holding off on further cuts, worried that supply problems and higher food prices could push inflation up again.

Core inflation – which excludes volatile food and energy prices – also picked up pace. Urban core inflation climbed to 7.5% year-on-year from 7.0% in September and 8.6% in October 2024, while rural core inflation advanced to 8.4% from 7.8% and 11.7% in October 2024, highlighting persistent underlying price pressures. Urban inflation stood at 6.0%, while rural areas saw 6.6% inflation, from 9.3% and 4.2%, respectively, in the same month last year. The Wholesale Price Index (WPI) increased 1.1% in October, as compared to an increase of 0.6% in the previous month and 3.9% in the same month of last year.

United States seeks UN approval for Gaza security force

NEW YORK: The United States is seeking approval from the United Nations for the establishment of an International Security Force (ISF) in Gaza with a mandate of at least two years, Axios reported on Tuesday. According to the report, the US sent several UN Security Council (UNSC) members a draft resolution yesterday outlining the establishment of its proposed security force to maintain security in the Palestinian enclave. Axios, which obtained a copy of the draft, said that the resolution was designated "sensitive but unclassified". It reported that the resolution would give the US and other participating countries a broad mandate to deploy security forces to govern Gaza until the end of 2027, and allowed the possibility of extensions beyond that time. The force would be established "in consultation with the

Gaza 'Board of Peace'", to be chaired by US President Donald Trump, the publication reported. The Board of Peace is

also to remain in place "at least through the end of 2027".

However, a US official told Axios that the ISF was to be an

"enforcement force and not a peacekeeping force". The official said that the goal was to vote to establish the force in the next few weeks and deploy the first troops to Gaza by January. The publication said the draft would serve as the basis for upcoming negotiations between UNSC members. It further said that the proposed resolution tasked the ISF with "securing Gaza's borders with Israel and Egypt, protecting civilians and humanitarian corridors, and training a new Palestinian police force, with which it's to partner in its mission".

The ISF would also "stabilise the security environment in Gaza by ensuring the process of demilitarising the Gaza Strip, including the destruction and prevention of rebuilding of military, terror, and offensive infrastructure, as well as the permanent decommissioning of weapons from non-state armed groups," the draft stated, as well as taking on "additional tasks" as required to support the Gaza peace deal. Axios said that this suggested that the mandate included disarming Hamas if it does not do so of its own volition. The resolution further said that the ISF would deploy in Gaza "under unified command acceptable to the Board of Peace" and stressed that there would be "close consultation and cooperation with Egypt and Israel".

Saudi Crown Prince MBS will visit US on Nov 18

Visit comes as Trump pushes Saudi Arabia to join list of nations that have joined Abraham Accords

WASHINGTON: Saudi Arabia's Crown Prince Mohammed bin Salman will be at the White House on November 18 for an official working visit with US President Donald Trump, a White House official said on Monday. The visit comes as Trump pushes Saudi Arabia to join the list of nations that have joined the Abraham Accords. In 2020, Trump reached deals with United Arab Emirates, Bahrain, Sudan and Morocco to normalise relations with Israel. The Saudis have been hesitant to join in the absence of steps toward Palestinian statehood. Trump told CBS' "60 Minutes" in an interview broadcast on Sunday that he believed the Saudis would ultimately join the accords. Trump and bin Salman may also discuss a US-Saudi defence agreement. The Financial Times reported two weeks ago that there were hopes

A senior Trump administration official told Reuters that "there are discussions about signing something when the crown prince comes, but details are in flux." The Saudis have sought formal US guarantees to defend the kingdom as well as access to more advanced US weaponry. Saudi Arabia is one of the largest customers for US arms, and the two countries have maintained strong ties for decades based on an arrangement in which the kingdom delivers oil and Washington provides security. During Trump's visit to Riyadh in May, the United States agreed to sell Saudi Arabia an arms package worth nearly \$142 billion. - Agencies

the two countries could sign such an agreement during bin Salman's visit.

Pak-Afghan confrontation more than a bilateral dispute

ISLAMABAD: Pakistan-Afghanistan confrontation is more than a bilateral dispute, as it might have a wide-ranging impact on regional level as well as affecting international peace as a whole. Stakeholders needed to sit together to set aside the raising conflict, lowering the temperature between the two sides. Regional analysts view the confrontation as more than a bilateral dispute. The whole scenario should be looked into the background of Pakistan's closer counter-terrorism coordination with the United States sits alongside its strategic and economic ties with China, including plans to extend connectivity through western corridors.

The frontier's stability will not be read without the lens of US-China competition and a reshaping of influence in Central Asia. In this context, any perception of disproportionate force or legally ambiguous actions could complicate Islamabad's diplomacy as well. It is heartening to note that Pakistan and Afghanistan remain in a fragile calm after mid-October ground clashes and Pakistani airstrikes, including inside Afghanistan, were followed by a ceasefire mediated by Qatar and Türkiye and announced in Doha on the 19th of October. UN monitors urged "a lasting end to hostilities" after recording at least 18 killed and more than 360 wounded on the 16th of October. The heaviest fighting was reported around Spin Boldak in Kandahar and parts of Paktika, underscoring how quickly the frontier can tip from skirmishes to

wider confrontation. Torkham, the main Khyber Pass crossing linking Pakistan's Khyber district with Afghanistan's Nangarhar, has since been partially reopened to allow Afghan nationals to return. Pakistan resumed limited movement on the

1st of November to let stranded Afghans cross back under its repatriation plan, while commercial traffic remained shut. Mediators said both sides agreed in Istanbul to keep the truce in place and to set up a mechanism to monitor and verify alleged ceasefire violations, including cross-border fire, incursions and support for militants. The consequences for non-compliance are

to be decided at the next meeting on the 6th of November. Islamabad claims that the confrontation stemmed from militant attacks launched from Afghan soil and has tied any durable truce to Kabul taking action against the Tehreek-i-Taliban Pakistan. "We have a ceasefire agreement as long as there is no violation," Defence Minister Khawaja Muhammad Asif said on the 20th October, adding that the truce "hinges" on curbing attacks from across the border. In later interview he warned that, if talks fail, Pakistan has the "option of open war." The Taliban administration firmly denies harbouring anti-Pakistan militants. In Doha, spokesman Zabihullah Mujahid said "neither country will take hostile actions against the other" and that there would be no support for groups attacking Pakistan.m - Agencies
