27th Amendment Bill sails through Senate amid opposition uproar

Presented by law minister, Bill passes after receiving 64 votes; tweaks aim to change military command, judicial structures

ISLAMABAD: The Senate passed the 27th Constitutional Amendment Bill on Monday, which aims to overhaul the military and judicial structures, amid the opposition's walkout and protest - tearing their copies. Law Minister Azam Nazeer Tarar presented the 59-clause Bill, which

received the required 64 votes (two-thirds majority in the 96-member

House). It will now be presented in the National Assembly for voting. No

member voted against it - as the opposition opted to boycott. Apart from the treasury members, the Awami National Party (ANP), Pakistan Tehreek-e-Insaf (PTI)-backed Saifullah Abro and Jamiat Ulema-e-Islam-Fazl's (JUI-F) Ahmed Khan were among the senators who voted in favour of the amendment.

Interestingly, Abro did not partake in the protest as well and later, during his speech, also announced his resignation as a senator. Highlights of new amendment

- Objections on transfers to be reviewed by Supreme Judicial Council Deputy Prime Minister and Foreign Minister Ishaq Dar congratulated the House on the passage of the historic bill in the Senate. He recalled that former prime ministers Nawaz Sharif and Benazir Bhutto had signed the Charter of Democracy, which was also endorsed by all political parties.

Abro quits Senate after defying PTI line

"I came here to vote for Asim Munir, not for anyone else," says opposition lawmake

ISLAMABAD: Pakistan Tehreek-e-Insaf's (PTI) Senator Saifullah Abro on Monday resigned from the House after voting in favour of the 27th Constitutional Amendment exclusively for Field Marshal Syed Asim Munir and the Pakistan Army. "If anyone is mistaken, let me say that I came here to vote for Asim Munir, not for anyone else," he said on the floor of the Upper House of the Parliament. The Senate passed the 27th Constitutional Amendment Bill, which aims to overhaul the military and judicial structures, amid the opposition's walkout and protest.

Apart from the treasury members, the Awami National Party (ANP), PTI-backed Abro, and Jamiat Ulema-e-Islam-Fazl's (JUI-F) Ahmed Khan were among the senators who voted in favour of the amendment. He said that the Pakistan armed forces inflicted a humiliating defeat on India in May this year, adding: "While India was initially hesitant to accept the defeat. However, the situation was ultimately 'cleared' by the United States President Donald Trump as he showed [ultimate] respect to Field Marshal Syed Asim Munir." Abro also emphasised the significance of this

UAE 'probably' won't join Gaza stabilisation force

DUBAI: The United Arab Emirates is not planning to join the international stabilisation force for Gaza because it lacks a clear framework, a senior official said on Monday. "The UAE does not yet see a clear framework for the stability force, and under such circumstances will probably not participate in such a force," Emirati presidential advisor Anwar Gargash told the Abu Dhabi Strategic Debate forum. The US-coordinated international force has been seen as likely to include troops from Egypt, Qatar and Turkey, as well as the UAE. The health ministry in Hamas-run Gaza said it had received the bodies of 15 Palestinian prisoners under the US-brokered ceasefire exchange deal.

Attack on cadet college foiled in Wana

WANA: Security forces on Monday thwarted a terrorist attack on Cadet College Wana in Khyber Pakhtunkhwa's South Waziristan district, reportedly carried out by the banned Tehreek-i-Taliban Pakistan (TTP), security sources said. "A suicide bomber belonging to Fitna al Khawarij detonated explosives at the main gate of the college, injuring six civilians," security sources said in a statement. Fitna al Khawarii is a term the state uses for terrorists belonging to the banned TTP. "Swift action by security personnel prevented the attackers from breaching the premises."

Forces kill 20 terrorists in KP areas

Indian proxy terrorists killed in North Waziristan and Dara Adam Khel, says ISPR

DNA ISLAMABAD: The securi-

ty forces have neutralised at least 20 terrorists in two separate engagements in Khvber Pakhtunkhwa, the Inter-Services Public Relations (ISPR) said on Monday. In a statement, the military's media wing said that the operations took place between November 8-9 against the terrorists belonging to the Indian proxy, Fitna al-Khwarij. The first IBO was conducted in Shawal, North Waziristan district, where troops effectively engaged the terrorists' location and killed eight Indian-sponsored khwarij. In another IBO, 12 more khwarij were neutralised after an intense fire exchange in KP's Dara Adam Khel district.

At least 9 killed in Indian explosion

NEW DELHI: An explosion was reported near the Red Fort in the Indian capital of New Delhi on Monday, in which at least 9 people were killed, local television channels reported. TV channels added that at least 11 people were injured. The Delhi police spokesperson said that the explosion took place in a car and that the exact details of the cause of the explosion were being ascertained.

At least six vehicles and three autorickshaws caught fire, Delhi's deputy fire chief said, adding that the flames had been doused by firefighting teams. "We heard a big sound, our windows shook," one resident, who did not give a name, told NDTV. Police tried to clear crowds that gathered around the site of the incident.

Visuals on local media showed flames and smoke billowing from more than one vehicle in what was described as a congested street located near a metro station in the old part of Delhi. According to Indian outlet NDTV, the fire brigade was on site, while The Times of India reported that the fire caused by the explosion engulfed three to four other vehicles. Local TV channels


emote, the Apostolic Nuncio to Pakistan, has lauded Pakistan's commitment to peace, security, and interfaith harmony, describing the country as a "land of great potential and hospitality." In an exclusive interview with Daily Islamabad Post, Centreline, and Diplomatic News Agency (DNA), the Holy See envoy reflected on six decades of Pakistan-Vatican relations, the mission of the Catholic Church in the country, and his vision for promoting education, dialogue, and mutual understanding among all faiths. Appointed Apostolic Nuncio to Pakistan in 2023, Archbishop Penemote said his mission has been guided by the core values of Vatican diplomacy - dialogue, compassion, and service to humanity. "The diplomacy of the Holy See, one of the oldest and most respected in history, seeks to promote the common good through understanding and peaceful coexistence," he said. "Since my arrival in Pakistan, I have sought to meet people, listen to their concerns, and work with them for solutions. I have brought neither gold nor silver, but a heart full of esteem and respect for the beloved Pakistani people.'

The Nuncio emphasized that his efforts are focused on strengthening bilateral ties between the Holy See and the Islamic Republic of Pakistan, while supporting the Catholic Church's humanitarian and educational work in the country. "Our institutions



continue to serve all Pakistanis - Muslims, Christians, and people of other faiths - in education. healthcare, and social welfare," he added. "We do not sound trumpets or seek publicity; our mission s quiet but constant - to serve humanity.

Reflecting on the long-standing diplomatic ties between Pakistan and the Vatican, Archbishop Penemote said relations have been strong and stable since their formal establishment in 1965. "We are about to celebrate sixty years of the Apostolic Nunciature's es-



tablishment in Pakistan, a symbol of mutual respect and uninterrupted friendship," he said. "The Nuncio has always lived and worked in Pakistan, which speaks to the strength of our relationship.

However, he noted the need for a formal legal framework to further facilitate Catholic institutions' contributions to national development. We hope to conclude a legal agreement that will ensure our schools, hospitals, and social organizations can continue serving all Pakistanis



effectively," he explained. "It is heartening to meet Pakistanis who proudly say they studied at Catholic schools - institutions known for providing quality education and nurturing responsible citizens." One of the Nuncio's most ambitious ideas is the establishment of a Catholic University in Pakistan – a center for inclusive, high-quality education open to students of all faiths.

Cheating attempt foiled at examination center

RAWALPINDI: The inspection teams at the Board of Intermediate and Secondary Education (BISE) Rawalpindi have cracked down on exam malpractice, nabbing a student in the act during the ongoing Intermediate Second Annual 2025 exams Controller of Examinations Tanveer Asghar Awan made surprise visits to several exam centers, inspecting security setups, seating arrangements, and staff attendance to uphold strict standards. At Government Graduate College in Satellite Town, a candidate with Roll No. 804637 was caught cheating on his Physics paper. The invigilators seized the evidence on the spot, and a formal case was immediately filed and forwarded to the board's Discipline Branch for further action. Dengue on prowl as 41 new cases reported across KP

PESHAWAR: Dengue cases continue to rise across Khyber Pakhtunkhwa, including the provincial capital Peshawar, as the health department confirmed 41 new cases in the latest report on Monday According to the Khyber Pakhtunkhwa Health Department, there are currently 390 active dengue cases in the province. So far this year, a total of 5,497 dengue cases have been reported. During the last 24 hours,10 new patients have been admitted to various hospitals, bringing the total number of hospitalized dengue patients to 29 across the province. The report further stated that since the beginning of the year, 1,915 patients have been admitted to hospitals, of which 5,105 have recovered, while two deaths have been recorded due to the virus.—APP

KP moves towards digitization: CM

Minister Muhammad Sohail Afridi on Monday said that all affairs of the province are gradually being moved toward digitalization for better service delivery Presiding over a meeting here, he said that Digital Payment Act has been prepared and will soon be presented to the cabinet for approval.

Under this system, he said all payment transactions between the government, the public, and traders will be made digital. He said the purpose of digitalization is to ensure transparency, convenience, and efficiency in financial matters. So far, 170 different services have been identified to be included in the digital system, and digitalization of 14 different

These services include property transfer tax, property tax, arms licenses, water charges (Abiana), driving licenses, plot registration, HEC admissions, and hunting license fees, among others. An additional 34 services will be digitized by December 2025, which is expected to save approximately 12.3 billion rupees.

The digitalization of all 170 services will be completed by June 2026. The chief minister said a review meeting will be held every two weeks to assess the progress of digitalization. "We will make Khyber Pakhtunkhwa economically self-reliant and a model of modern governance," he added.-DNA



The APU team's analytical depth, balanced arguments, and strong grasp of IHL principles earned them first place among top universities across Japan. With this victory, the APU team will represent Japan at the 24th Red Cross International Humanitarian Law Moot Court Competition in Hong Kong in March 2026. ICCI President for steps to enhance industrial competitiveness

Frequent policy changes, he said, disrupt industrial planning and discourage both domestic and foreign investors. "Without reducing energy costs, it will be difficult for our export-oriented sectors to compete internationally," he warned. Pakistan marble export to China on rise

ISLAMABAD: Pakistan's overture to introduce a National Marble Policy aimed at tapping the country's vast marble reserves for local use and export promotion, Pakistan's marble is witnessing strong demand from China.

Pakistan Stone Development Company (PASDEC) official told Gwadar Pro that Chinese buyers remain a key destination for Pakistani stone exports, even amid challenges like higher shipment costs. He said the demand from China continues to be resilient, providing Pakistan with a unique opportunity to strengthen its foothold in one of the world's largest stone markets. "Pakistan could capture even greater market share in China and beyond if processing was localised and supported with better infrastructure. Mechanised mining has created a complete value chain - from extraction to processing - which allows our products to compete internationally", he added. With proper finishing and value addition, Pakistani stone could penetrate premium global markets as well. He said kitchen slabs sold in America's outlets retail for thousands of dollars but if Pakistan processes its granite and marble with the right technology, the same demand can be tapped in China and the West. He highlighted that industrial clusters, such as Marble City in Risalpur where 80 units are operational, are playing a central role in making Pakistani stone products export-ready.

ISLAMABAD: A new Policy Viewpoint by the Pakistan Institute of Development Economics (PIDE) warns that Pakistan's protectionist and overly complex tariff system is costing the economy billions annually, suffocating industrial competitiveness, and trapping the country in a cycle of inefficiency. Authored by Dr. Uzma Zia, Senior Research Economist at PIDE, the study titled "Rationalizing Pakistan's Tariff Regime for Export-Led Growth" presents a compelling case for urgent, growth-oriented reform of Pakistan's trade and industrial policy

According to the study, Pakistan's tariff regime-dominated by Regulatory Duties (RDs), Additional Customs Duties (ACDs),

and 5th Schedule exemptions-has long protected inefficiency, distorted price signals, and raised production costs. As a result, both manufacturers and consumers face inflated costs, while export-oriented industries are handicapped by an anti-export bias. "Every additional year under the current tariff system slows export growth, raises production costs, and deepens the trade deficit. Pakistan can no longer afford this inefficiency," warns

The upcoming National Tariff Policy (NTP) 2025-30 provides a clear roadmap for reform, aiming to eliminate ACDs within four years and RDs within five, while transitioning products from the 5th Schedule to the 1st Schedule. If implemented effectively, PIDE projects that the new policy could increase exports by 10-14%, strengthen industrial competitiveness, and reduce the trade deficit while lowering inflation through reduced input costs. To achieve these outcomes, the PIDE study recommends a comprehensive rationalization of the customs duty structure from five slabs to four (0%, 5%, 10%, and 15%) within five years, alongside a complete phase-out of tariff peaks exceeding 20%. Duties should be harmonized by product category - lowest on raw materials, moderate on intermediates, and highest on consumer goods - to promote industrial upgrading and attract investment in high-value sectors. In addition, PIDE proposes aligning auto-sector tariffs with competitiveness and consumer choice under the Automotive Industry Development and Export Plan (AIDEP 2021-26), including duty reductions, removal of ACDs and RDs, and allowing controlled import of used vehicles under strict quality and environmental standards.

The author cautions that resistance from protectionist industries and external shocks, such as commodity price volatility and exchange rate shifts, may slow progress. However, it emphasizes that the cost of inaction is far higher - in lost investment opportunities, stagnant exports, and persistent consumer hardship.

PIDE concludes that Pakistan now stands at a pivotal moment: by embracing tariff rationalization and aligning trade policy with competitiveness and global integration, the country can transition from revenue-driven protectionism to export-led, sustainable growth. n"Tariff reform is not just an economic necessity - it is a national imperative," Dr. Zia affirms. "Simplifying tariffs, eliminating distortions, and aligning policy with long-term growth goals can reshape Pakistan's economic future."

Pakistani gemstones getting popular in Chinese market

These policy signals collectively chart a clear course for the continued expansion and upgrading of China's consumer market. Against this backdrop, the CIIE saw strong attendance and active participation, becoming a vital window into China's dynamic consumer market. For many overseas enterprises, the vitality of the Chinese market remains a source of optimism, shifting their focus from "whether to enter" to "how to deepen engagement." Multinational brands are increasingly unveiling innovative products at CIIE, using the event to make their global debuts and build brand awareness. Their strategic focus has shifted from expanding distribution channels to understanding regional consumer habits in China, driving product iteration and localization through market demand, ensuring precise alignment with growth opportunities. In the fresh food supply chain, Good Farmer Group, a leader in the industry, debuted new products at this year's CIIE, including organic Peruvian blueberries. Key infrastructure projects, such as the Chancay Port-part of the China-Peru Belt and Road initiative—are further facilitating the movement of high-quality imported goods, with the port cutting shipping time between China and Peru to just 23 days and reducing logistics costs by more than 20%, CEN's report added.

ISLAMABAD: Business leader and former president of the Islamabad Chamber of Commerce and Industry Shahid Rashid Butt has expressed confidence that the 27th Constitutional Amendment will help Pakistan restore fiscal balance, strengthen the federation, and create a stable environment for investment and growth. Butt said Pakistan's economy cannot grow under a fragmented governance structure where the centre bears most fiscal responsibilities while provinces run large surpluses without improving public services or expanding their tax base. The amendment can correct these distortions, improve economic discipline, and ensure that national priorities, from defence to debt repayment are adequately funded, he said. Speaking to the business community, he noted that provinces collectively posted hundreds of billions in surplus in FY25 while the federal government struggled to finance development and social programs. A revised resource distribution formula, he said, would ensure fairer allocation of funds and push provinces to mobilise their own revenues, particularly from agriculture and services, sectors long exempt from effective taxation.—APP

The 27th amendment a step backwards

THE government's move to push through the 27th Constitutional Amendment appears to be one of the most consequential and controversial constitutional interventions in Pakistan's recent history. Reports suggest that the amendment seeks to abolish the office of the Chairman Joint Chiefs of Staff Committee, creating a new and far more powerful post of Chief of Defence Staff (CDS). Under this arrangement, the CDS would effectively become the supreme head of the armed forces, exercising authority over the Army, Navy, and Air Force an unprecedented concentration of military power in a single office. While the government insists that this change is meant to "streamline command structures" and "ensure coordination among the three services," critics view it as an attempt to militarize the system further, blurring the constitutional separation between civilian and military domains. The creation of such an office, without adequate parliamentary debate or public consensus, risks disturbing the delicate institutional balance that the Constitution seeks to maintain.

Equally alarming are the proposed changes to the judiciary, which strike at the very heart of Pakistan's democratic framework. The amendment reportedly seeks to clip the powers of the Supreme Court and establish a new Constitutional Court, which will replace or override some functions of the apex court. Justice Aminuddin Khan is said to be under consideration as the first Chief Justice of this new court. This move, if implemented, would amount to a restructuring of the judicial hierarchy, undermining both the independence and authority of the Supreme Court as the guardian of the Constitution.

Understandably, legal experts, senior lawyers, and civil society leaders have sounded the alarm. They have written to Chief Justice, urging him to convene a Full Court meeting to deliberate on the implications of the proposed amendment. Their concern is not misplaced. If passed in haste and without judicial input, the 27th Amendment could deliver a fatal blow to the independence of the judiciary, which is already under immense political and institutional pressure. Adding to the controversy, the opposition has announced a complete boycott of the amendment process, arguing that legislation of such historic significance cannot and should not be passed without consensus. The absence of opposition participation will inevitably rob the process of legitimacy and credibility. Constitutional changes should reflect national consensus, not partisan expediency. Yet, government appears determined to rush the amendment through Parliament, reportedly before November 27, when the current Chairman Joint Chiefs of Staff Committee is due to retireba timeline that raises serious questions about intent and urgency.

The haste itself is revealing. Rarely in Pakistan's history has a constitutional amendment been introduced to empower the public, strengthen democracy,



or improve governance. Most amendments have served the ruling elite political or otherwise. If the 27th Amendment goes through it will once again demonstrate how constitutional engineering is used to consolidate power,

One of the most disturbing elements of the proposed amendment is the provision shielding the President from prosecution, effectively granting lifelong immunity. Such a clause not only contradicts the principles of accountability and equality before the law but also runs counter to Islamic injunctions, which emphasize that no individual is above justice.

Moreover, while the amendment to Article 243, which deals with the command of the armed forces, may appear to have little immediate impact on the daily lives of ordinary citizens, the provisions affecting the judiciary will directly influence the lives of the common people. When judicial independence is compromised, justice becomes selective, delayed, or denied-especially for the poor and marginalized. The ordinary citizen depends on the courts for protection from abuse of power, for the enforcement of fundamental rights, and for the redress of grievances. A weakened judiciary means a weakened democracy, and ultimately, a weakened society.

Sadly, Pakistan's constitutional amendments have almost always been self-serving exercises. No amendment has ever been proposed to eliminate corruption, ensure universal education, or guarantee free healthcare. None have sought to make justice accessible or public service efficient. Instead, amendments have been introduced to extend tenures, neutralize opponents, or legitimize unconstitutional actions after the fact. This pattern continues unabated, eroding the very spirit of constitutionalism.

The 27th Amendment, as it stands, risks plunging Pakistan into another period of institutional imbalance and democratic uncertainty. Rather than focusing on national priorities economic recovery, education reform, poverty alleviation, and governance the state seems preoccupied with political maneuvering and institutional restructuring. The country's constitutional architecture is being reshaped not for the people, but around personalities. If history is any guide, constitutional amendments passed in haste, without consultation or consent, have always led to long-term instability. The 8th and 17th Amendments are stark reminders of how such moves can distort power structures for decades. The proposed 27th Amendment risks joining that ignominious list. It is time for Parliament, the judiciary, civil society, and the media to raise their collective voice. The Constitution is not a tool for convenience it is the sacred contract between the state and its people. Any attempt to weaken its foundations in the name of expediency or reform must be resisted. Pakistan's future depends not on more power for the powerful, but on stronger institutions, an independent judiciary, and a government accountable to the people. The 27th Amendment, as proposed, threatens all three. If democracy is to survive, this amendment must be revisited, debated, and, if necessary, rejected. In the end, the real strength of a nation lies not in its generals or politicians, but in the rule of law and the will of its people.

Did Trump's Second-Term Tariff Crusade Backfire on America?

7 HEN Donald Trump returned to power in January 2025, he came as a man on a mission – a self-proclaimed savior who promised to restore America's greatness by reversing what he called decades of "plunder" by foreign nations and betrayal by domestic elites. His message was sharp, emotional, and divisive: America had been looted by others, invaded by outsiders, and weakened by globalists. His rallying cry -"Stop the plunder, make America win again" - became the cornerstone of his campaign and the moral justification for his economic, immigration, and security agenda. But ten months into his presidency, that crusade appears to have collapsed under its own contradictions. His main policy weapon, tariffs, has crippled rather than strengthened the U.S. economy. His promise to expel immigrants and Chinese students has triggered outrage, legal challenges, and civil unrest. His use of National Guards to quell protests and enforce federal directives has been condemned by constitutional scholars as authoritarian overreach. And his deliberate targeting of Democratic-governed states with funding cuts, while rewarding Republican ones, has deepened America's internal divide. The second Trump presidency, which began with boasts of discipline and destiny, now stands mired in disorder and disbelief.

Trump's signature economic doctrine rested on tariffs - sweeping, unilateral duties imposed on nearly every country trading with the United States. On April 5, 2025, he invoked the International Emergency Economic Powers Act (IEEPA) to impose a 10 percent baseline tariff on virtually all imports, rising to punitive levels against countries with trade surpluses. His justification was moral as much as economic: America, he said, had been "robbed blind," and now it was time to make offenders pay.

By July, the Institute for International Economics reported that the U.S. Treasury had collected \$122 billion in new tariffs, with projections of \$300 billion by year's end. The administration celebrated the figure as proof of success. Yet, beneath the headlines, economists saw a darker reality. According to Yale's Budget Lab, the average American household lost \$3,800 in purchasing power due to higher consumer prices, while corporations suffered \$34 billion in combined cost increases and sales losses. Imported machinery, metals, electronics, and everyday goods became more expensive; factories dependent on foreign parts slowed or shut down.

Meanwhile, trading partners retaliated. China imposed reciprocal duties and restricted exports of rare-earth minerals, choking U.S. semiconductor and electric-vehicle production. Canada, long the closest ally, saw its aluminum and energy exports to the U.S. plunge by 40 percent. The European Union, facing tariffs averaging 20 percent, redirected nearly \$75 billion in trade toward Asia and Africa. India, another supposed ally, tightened its own import barriers, favoring European suppliers over American ones.

By late 2025, the United States had collected roughly \$300 billion in tariffs but lost more than \$600 billion in trade, investment, and consumer wealth - a net loss twice as large as its revenue. Exporters saw foreign markets evaporate; inflation returned; industrial confidence plunged. The "tariff revolution" that promised to rebuild America instead produced higher prices, weaker factories, and broken partnerships. The very slogan that won Trump re-election - "Amer-

ica First" – had turned into America alone. In October 2025, a federal appeals court ruled that large portions of Trump's tariff regime violated constitutional limits under the IEEPA. The case, now before the Supreme Court, threatens to nullify the program entirely. If upheld, the ruling could force Washington to refund up to \$1 trillion in illegally collected tariffs to importers and foreign companies - turning a perceived fiscal victory into a staggering liability

Abroad, allies have grown disillusioned. Canada, once America's most dependable partner, has frozen joint energy projects and suspended several defense procurement agreements. The European Union has accelerated plans for "strategic autonomy" - reducing reliance on U.S. markets and military backing. Even India, which Trump once courted as a counterweight to China, has shifted toward a more balanced, nonaligned stance. The geopolitical cost of Trump's tariff crusade may, in time, exceed its economic toll

While the tariff policy faltered on the global front, Trump's domestic agenda ignited turmoil at home. His pre-election vow to expel Chinese students from American universities and remove undocumented immigrants from the United States ran into fierce institutional and popular resistance. University presidents, state governors, and business leaders across the country denounced the policy as self-destructive, depriving the nation of talent and labor. Mass arrests by Immigration and Customs Enforcement (ICE) - often televised and heavy-handed - shocked the public conscience.

Detention centers overflowed; protests erupted in California, Illinois, Michigan, and New York; and civil-rights groups accused the administration of orchestrating what they called "state-sponsored social division." Even Republican mayors in Texas and Florida warned that the crackdown had disrupted local economies dependent on migrant workers. The plan to "secure America's borders" has instead fractured its communities, producing social tension, moral outrage, and economic stagnation in key industries like

agriculture, construction, and services. Adding to the domestic crisis was Trump's repeated deployment of the National Guard in Democrat-led states, ostensibly to maintain order amid protests and labor unrest. Governors and constitutional lawyers called it an unprecedented intrusion into state sovereignty. Several state legislatures passed resolutions condemning the federal overreach, while civil-liberties groups filed lawsuits accusing the administration of violating the Posse Comitatus Act.

Simultaneously, the White House began punishing Democratic states by withholding federal infrastructure funds while granting bonuses and subsidies to Republican-governed regions. This selective disbursement of national resources has widened America's internal divide, transforming fiscal policy into a partisan weapon. The attempt to project strength has instead exposed weakness - a federal government at war with its own states.

Ten months into Trump's second term, nearly every pillar of his campaign stands eroded. The tariffs meant to punish foreign "plunderers" punished American workers and consumers instead. The immigration clampdown intended to restore "law and order" has generated chaos and shame. The National Guard deployments, framed as decisive leadership, now symbolize federal authoritarianism. And the selective funding of states has alienated millions of Americans who feel their taxes are being used to reward political loyalty rather than public need. The economic cost of the tariffs – roughly \$600 billion in losses - combines with the social and political cost of division: a fractured society, disillusioned allies, and a democracy tested at its seams. Even conservative economists concede that the "America First" project has yielded America isolated, economically weaker, and morally diminished.

As 2025 draws to a close, the central question remains: Can a nation become great again by taxing its own people, dividing its own states, and alienating its own allies? The numbers answer before the historians can. America collected \$300 billion but lost nearly twice as much in trade, consumer spending, and trust. Its factories are quieter, its allies colder, its campuses emptier.

Donald Trump's second term began with roaring confidence and ends, barely a year in, with a silent admission: the slogans that once stirred the crowds - Stop the Plunder, Secure the Border, Restore the Greatness - have fallen flat, leaving behind a trail of broken promises and broken partnerships. All those promises that lifted him to power - tariffs, immigration reform, national security, and federal supremacy - have failed to deliver. Now, as the first year of his presidency closes in turmoil and uncertainty, one question looms large over Washington and the world: does Donald Trump still have the legal, moral, and ethical basis to remain in power? That question may, in the end, define not only his legacy but the fate of American democracy itself.

From Commander-in-Chief to Prime Minister and President

HERE are some truths in history that rest quietly in the pages of books and official documents. They remain hidden from the public eye, awaiting discovery by those who devote themselves to research. Many episodes of Pakistan's political evolution fall into this category, where the general perception of events does not always align with their factual depth. Among such historical realities lies the multifaceted career of one of Pakistan's most powerful and some extent controversial figures - Field Marshal Muhammad Ayub Khan. Most Pakistanis know him as the first military ruler of Pakistan, the man who imposed the country's first Martial Law and later became its President. Yet few realize that, for a time, Ayub Khan also held the office of Prime Minister – making him one of the rare individuals in the nation's history to simultaneously embody military, executive, and political authority.

Muhammad Ayub Khan was born on May 14, 1907, in the village of Rehana, District Haripur in the North-West Frontier Province (now Khyber Pakhtunkhwa). After early education, he joined the Royal Military Academy at Sandhurst in 1926 and was commissioned into the British Indian Army in 2 February 1928. His steady rise through the ranks reflected his discipline and administrative ability. When Pakistan came into being in 1947, Ayub Khan was among the senior-most Muslim officers in the Indian Army and was chosen by Prime Minister Liaquat Ali Khan to serve in Pakistan's newly established military.

In January 17, 1951, Ayub Khan was appointed as the Commander-in-Chief of the Pakistan Army, succeeding General Sir Douglas Gracey, the last British officer to hold that position. This appointment made Ayub Khan the first Pakistani to command the national army. His tenure as Commander-in-Chief lasted until 27 October 1958 – a period during which he gradually became a dominant figure in Pakistan's civil-military structure. The turning point came on October 7, 1958, when President Iskander Mirza abrogated the 1956 Constitution, dissolved the national and provincial assemblies, and declared Martial Law across the country. He appointed General Ayub Khan as the Chief Martial Law Administrator (CMLA), giving him sweeping powers to run the country.

According to the Gazette of Pakistan on 27 October 1958, President, Chief Martial Law Administrator, Command-

"President Iskander Mirza has been pleased this twentyseventh day of October 1958, to appoint General Mohammad Ayub Khan, Supreme Commander of the Armed Forces of Pakistan and Chief Martial Law Administrator, to be the Prime Minister, it is hereby notified that the said General Mohammad Ayub Khan has taken upon himself the execution of the office of the Prime Minister in the forenoon of this twentyseventh day of October 1958"

Along with that, the President also appointed Lt. General Mohammad Azam Khan, Lt. General W.A. Burki, Mr. Mohammad Ibrahim, Lt. General K.M. Sheikh, Mr. Abdul Qasim Khan, Khan F. M Khan, Mr. Zulfikar Ali Bhutto and Mr. Muhammad Hafizur Rahman to be Ministers of the Government of Pakistan. According to the archives and newspapers of 28 October 1958, the following President's Proclamation was issued by the President of Pakistan, General Mohammad Ayun Khan: "Whereas by his declaration made at 10 o'clock this night of the 27th of October 1958. Major General Iskander Mirza, lately President of Pakistan, has relinquished his office of President and has handed over all power to me, General Mohammad Ayub Khan, Chief Martial Law Administrator and Supreme Commander of Armed Forces of Pakistan. Now, therefore, I have this same night of the 27th day of October 1958, forthwith assumed the said office of President and have taken upon myself the exercise of the said power and all other powers enabling me in this behalf." As President of Pakistan (1958-1969), Ayub Khan introduced sweeping administrative and economic reforms. His rule was marked by efforts to industrialize Pakistan. promote infrastructure, and attract foreign investment. His "Decade of Development" from 1958 to 1968 saw significant growth in agriculture, manufacturing, and education. The construction of Mangla and Tarbela Dams, the establishment of new universities, and the promotion of the "Green Revolution" marked this period as one of visible progress. However, his policies also widened the economic gap between regions, giving rise to discontent, particularly in East Pakistan (now Bangladesh). During this transitional phase, Ayub Khan concentrated all executive authority in his own hands - simultaneously holding the offices of

er-in-Chief of the Army, and Prime Minister of Pakistan. In 1962, Ayub Khan introduced a new Constitution of Pakistan, replacing the abrogated 1956 version. The new system replaced parliamentary democracy with a presidential form of government, concentrating power in the office of the President – a position he himself occupied. Hence, from 1962 to 1969, Ayub Khan ruled as both the constitutional and executive authority of Pakistan.

However, power and popularity seldom walk together for long. The growing political awareness in both wings of the country, the widening regional disparities, and opposition movements led by political figures like Mohtarma Fatima Jinnah and later Zulfikar Ali Bhutto gradually eroded his authority. By early 1969, mass protests and civil unrest had swept the nation, forcing Ayub Khan to resign on March 25, 1969, handing power to General Yahya Khan.

Ayub Khan retired from politics and lived quietly until his death on April 19, 1974. He was buried in his native village of Rehana, where his grave remains a symbol of a man who rose from humble beginnings to the highest offices of the state - and whose name continues to provoke debate among historians and political thinkers. Some remember him as the builder of modern Pakistan, a visionary who brought discipline and development. Others recall him as the founder of the military's dominance in national politics and the initiator of a pattern that would recur in Pakistan's history. Yet, the lesser-known fact of his simultaneous control as President, Prime Minister, and Army Chief reveals the full extent of his authority. It was an era when one man governed Pakistan in its entirety - politically, militarily, and administratively. The study of Ayub Khan's rule is not merely a reflection on one man's ambition; it is a mirror to the nation's recurring struggle between democracy and discipline, between elected

representation and guided leadership. In revisiting these chapters of history, one realizes that facts often lie beyond the horizon of popular memory. They wait to be rediscovered, not merely to glorify or vilify individuals, but to understand how nations are shaped by the personalities who lead them – for better or for worse.

"There will be no compromise on the equal representation of provinces in the Constitutional Court," he said. "There will be as many judges from Balochistan as from Sindh. There will be as many judges from Punjab as there will be from Khyber Pakhtunkhwa.'

The 27th Amendment was passed with 64 votes in the Senate after Law Minister Azam Nazeer Tarar presented the 59-clause Bill. Apart from lawmakers

from the ruling coalition, the Awami National Party (ANP), Pakistan Tehreeke-Insaf (PTI)-backed Saifullah Abro and Jamiat Ulema-e-Islam-Fazl's (JUI-F) Ahmed Khan cast a vote in favour of the amendment.

The constitutional amendment would introduce a new position, Chief of Defence Forces, as head of the armed forces. The proposed amendment, in addition to the creation of the FCC, would also reduce certain powers of the Supreme Court, with some shifted to the proposed FCC.

The law minister, in the Bill's text, said that the ruling coalition introduced the tweaks following proposals from political parties and various bar councils for the establishment of an FCC.

UAE raise medal tally to 11 at 2025 World Youth Jiu-Jitsu Championship

BANGKOK: The UAE jiu-jitsu national team, sponsored by Mubadala Investment Co., raised their total medal tally to 11 at the 2025 World Youth Jiu-Jitsu Championship on Sunday in Thailand. The tournament, which has age categories under 16, 18 and 21, began on Nov. 8 and ends on Friday in Bangkok. The girls' under-16 team added four medals on Sunday, including one silver and three bronze, to the seven medals won by the boys' team on the opening day.

Sara Farook won silver in the 48 kg category, Mathail Alhammadi and Ghaiaheb Alrashdi earned bronze in the 36 kg division, and Maitha Alkarbi claimed bronze in the 40 kg division. From Page 01 The security forces commenced sanitisation operations to eliminate any other terrorists in the area. The ISPR said that a relentless counterterrorism campaign under the vision "Azm e Istehkam" – as approved by the Federal Apex Committee on the National Action Plan - by security forces and law enforcement agencies will continue at full pace to wipe out the menace of foreign-sponsored and supported terrorism from the country. Pakistan has been grappling with rising terror incidents, particularly in KP and Balochistan, since the Afghan Taliban regime took power in 2021. Since then, terrorists have carried out hundreds of cross-border terror attacks in Pakistan, leading to the martyrdom of soldiers and countless civilians, including women and children. During the first eight months of 2025, KP alone recorded over 600 terror incidents, resulting in the martyrdom of at least 138 civilians and 79 police personnel. Pakistan has long urged the Afghan Taliban regime to prevent its soil from being used to launch attacks inside Pakistan. The cross-border terrorism also resulted in tense border clashes between forces from the two neighbouring countries in October. Pakistan struck multiple Taliban posts along the border on October 12 after they, aided by affiliated militants, resorted to unprovoked firing. Pakistan's retaliatory strikes resulted in the killing of over 200 Afghan Taliban and affiliated militants. As many as 23 Pakistani soldiers also embraced martyrdom during the clashes. Security forces also destroyed terrorists' multiple strongholds in "precision strikes" in Afghanistan's Kandahar province and Kabul. The two countries have since stopped hostilities after a ceasefire

residency for the WTA Finals in the Saudi capital. Rybakina had an up and down season that included a sixmonth stint without her suspended coach and was the last of the eight singles players to qualify for the WTA Finals, yet somehow she found a way to salvage her year by win-

ning her biggest title since Wimbledon in 2022. The Kazakh played herself into form in the last four weeks of the season, going on an 11-match winning streak across three tournaments, including five consecutive top-10 victories in Riyadh. Despite battling a shoulder issue all week, Rybakina produced 48 aces during the WTA Finals, 28 of which came in the semi-finals and final. She was near-unplayable against world No. 1 Aryna Sabalenka in the championship match - which she won 6-3, 7-6 (7-0) – and will have the rest of the field very

worried at January's Australian Open next season. "Definitely we need to analyze and try to carry the good things for the next big moments," said Rybakina, 26, who will rise to No. 5 in the world when the new rankings are released on Monday. Sabalenka ends banner year on a losing note. Sabalenka has every reason to board that plane to the Maldives feeling proud of her 2025 campaign. - Agencies

NEW Delhi: Indian police detained dozens of people during a rare protest at the famed India Gate monument in New Delhi, who were demanding action to curb an annual scourge of toxic air swathing the capital and its surrounding region. Sunday's protest by crowds of all ages holding banners and chanting slogans before police bundled them away was a scarce event, even though Delhi and the national capital region have battled such fumes every winter for years. "We have only one problem, and that is of clean air," said Neha, a mask-wearing protester, who gave only one name. "This problem has been going on for many years, but no action is being taken," she told news agency ANI, in which Reuters has a minority stake. Visuals from the agency showed police dragging protesters, some holding banners that read, "Breathing is killing us," while others chanted slogans such as "Our right, clear air" into waiting buses before they were driven away. The city's air quality index of 345 on Monday ranked as "very poor", compared to ratings of "good" in the category from zero to 50, and "severe" in the range from 401 to 500, according to the Central Pollution Control Board. Police had called for the spot to be vacated as it was not a designated protest site, they told reporters earlier, while opposition leaders criticised the removal of the protesters. "The right to clean air is a basic human right," Rahul Gandhi, leader of the Congress party that has ruled India for much of its history as an independent nation, said on X. "The right to peaceful protest is guaranteed by our constitution. Why are citizens ... peacefully demanding



clean air being treated like criminals?" The Delhi government was taking steps to prevent pollution, said its environment minister, Manjinder Singh Sirsa. "We will continue every possible effort to rid us of pollution." he said in a statement from BIP.

The ruling is expected in early afternoon Sarkozy, 70, became the first former French head of state in modern times to be sent behind bars after his conviction on Sept. 25. He denies any wrongdoing. He was jailed on Oct. 21 pending appeal but immediately filed for early release. During Monday's hearing, Sarkozy, speaking from Paris' La Santé prison via video conference, argued he has always met all justice requirements. "I had never imagined I would experience prison at 70. This ordeal was imposed on me, and I lived through it. It's hard, very hard," he said. Sarkozy also paid tribute to prison staff who he said helped him through "this nightmare." Sarkozy's wife, supermodel-turned-singer Carla Bruni-Sarkozy, and two of his sons. attended the hearing at the Paris courthouse. Monday's proceedings didn't involve the motives for the sentencing. Still, Sarkozy told the court he never asked Libya's longtime ruler Moammar Gadhafi for any financing. "I will never admit something I didn't do," he said. Under French law, release is set to be the general rule pending appeal, while detention remains the exception. Judges will weigh whether Sarkozy presents a flight risk, might pressure witnesses, or could obstruct justice. Advocate General Damien Brunet, who represents the public interest, asked for Sarkozy to be released and placed under judicial supervision.-APP

Bangladeshi workers protest in Malaysia over unpaid wages

DHAKA, Bangladesh: About 100 Bangladeshi workers who were employed by Malaysian companies rallied Monday to demand unpaid wages, fair compensation and an end to alleged abuse by Malaysian employers The Migrant Welfare Network, a Bangladeshi migrant group based in Malaysia and Bangladesh, organized the protest at the Ministry of Expatriates' Welfare and Overseas Employment in Bangladesh's capital Dhaka. The demonstrators said the event was organized to protest what they say is widespread mistreatment of migrant workers in Malaysia, one of Southeast Asia's richest nations. Γhey demanded unpaid wages and compensation for 431 Bangladeshi workers they said were exploited by two Malaysian companies, Mediceram and Kawaguchi Manufacturing. The Associated Press could not immediately reach the companies for comment. Many factories in Malaysia and other Southeast Asia countries rely on migrant workers, often from Bangladesh, Myanmar and Nepal, to fill labor-intensive jobs in manufacturing, plantations or construction. Local workers usually avoid such jobs because of their poor conditions and low wages. The Migrant Welfare Network urged Bangladeshi and Malaysian authorities and international buyers to take immediate action to ensure workers receive wages already owed, fair compensation and "justice for systemic abuses." The group said in statement Monday that a complaint claiming forced labor and neglect has been filed with the Malaysian government against Australian company Ansell, a major customer of Mediceram, which manufactures gloves for medical, industrial and domestic use. A separate complaint was filed against Kawaguchi, which supplied plastic components to large Japanese companies, including Sony Group. In May, around 280 Bangladeshi migrant workers for Kawaguchi demanded hundreds of thousands of dollars in back wages and other money owed to them after the company closed five months earlier. Workers at Kawaguchi's factory in Port Klang filed complaints in Malaysia and Bangladesh claiming the company withheld their wages for up to eight months before closing after Sony and Panasonic Holdings Corp., two of Kawaguchi's main customers, halted orders in response to allegations the workers were mistreated. In the beginning, they used to pay the salary in parts, meaning they would give 500-1000 ringgit (about \$120-\$240) per month as food expenses," said former Kawaguchi employee Omar Faruk, who began working for the manufacturer in 2022. "After withholding the salary, the company started considering shutting down. Later, we filed a complaint at the Bangladesh High Commission in Malaysia." Harun Or Rasid Liton, who worked at Mediceram, accused the company of not paying despite an order by the Malaysian Labor Court "The court ruled that the company would pay us 1,000 ringgit per month, but the company paid only the first installment and then stopped paying," he said. "Later, we had no choice but to return to Bangladesh. Now we are facing severe hardship in maintaining our families." There have been widespread reports of abuse of Bangladeshi workers in Malaysia and disputes between employees and companies have become a diplomatic sore point between Bangladesh and Malaysia. Workers' rights groups have demanded stringent scrutiny on the powerful group of recruitment agencies and middlemen who monopolize such jobs. -DNA

African Union calls for urgent action in insurgency-hit Mali

BAMAKO: The African Union has called for an urgent international response, including intelligence-sharing, to address worsening security conditions in Mali, where insurgents are imposing a fuel blockade and kidnapping foreigners. An Al Qaeda-linked militant group active in West Africa's Sahel region has blocked fuel imports since September, attacking convoys of tankers and creating a shortage that forced schools and businesses to shut. The latest show of force by the group, Jama'at Nusrat Al-Islam wal-Muslimin, has raised concern that it might eventually try to impose its rule over the landlocked country. Western countries including the US, France, Britain and Italy are urging their citizens to leave. In a statement on Sunday, Mahmoud Ali Youssouf, chairperson of the African Union Commission, expressed "deep concern over the rapidly deteriorating security situation in Mali, where terrorist groups have imposed blockades, disrupted access to essential supplies, and severely worsened humanitarian conditions for civilian populations." He said there should be "enhanced cooperation, intelligence-sharing and sustained support" for countries in the Sahel affected by violent extremism. He also called for the immediate release of three Egyptian nationals he said were recently kidnapped. JNIM has targeted foreign nationals for kidnapping to finance its operations in West Africa. Reuters reported in October that a deal was reached to free two citizens of the United Arab Emirates in exchange for a ransom payment of roughly \$50 million. Schools re-opened in the capital Bamako on Monday, a Reuters witness said, after being suspended for two weeks because of the fuel shortage.-Agencies

When justice leaves: The silent suffering of women in Islamabad

ISLAMABAD: The capital city of Pakistan, a place where the law is expected to protect every citizen equally has, unfortunately, become a city where many women no longer feel safe. When a woman dares to report harassment or assault, her courage is often met with disappointment. Even if she approaches the police late at night, seeking protection or justice, her complaint is rarely taken seriously. Instead of immediate action, she is made to visit the police station repeatedly, explaining her ordeal again and again while the culprit roams free, confident that no one will ever hold him accountable. Weeks pass, yet no progress is made. The victim is told that her application will be sent to the SDPO Office under standard procedures SOP's. It stays there for days, only to be returned with objections and the case goes

back to the police station. By the time weeks have gone by, the woman's hope for justice begins to fade, while the offender walks around with arrogance, believing he is untouchable. What makes this pain even worse is the way society and the police system treat these women. Their character is questioned, their dignity attacked, and their suffering dismissed. Often, police officers advise them to "reconcile," as if peace with the perpetrator is the solution. Yet reconciliation only fuels the offender's confidence, leading him to harass the same woman again knowing that the system will once again fail to act. Many women remain silent not because they don't have the strength, but because they fear the consequences. They want their issue to be resolved quietly. without their family or community finding out. They fear judgment, gossip, and scandal. But even that privacy is denied. Once a complaint is filed, it spreads within the police stations; officers and even unrelated people begin

to talk about her case, turning her pain into public gossip. In a society where a woman's honor is often valued more than her safety, silence becomes her only shield. She endures humiliation to protect her family from shame, while the perpetrator lives freely, protected by a broken system. It is time to ask: If women are not safe in the federal capital, then where are they safe in Pakistan? The Prime Minister and the Minister of Interior must take this issue seriously. Thousands of women work in Islamabad in offices, organizations, and institutions. They are not only supporting themselves but their families too. They deserve security, respect, and justice not endless rounds of police stations and the agony of being unheard.

Justice should not demand courage; it should guarantee protection. Until our system stands with victims instead of silencing them, the capital will remain a city of fear not safety.

China-Japan edu exchange moot seeks to deepen academic coop

TOKYO: The 11th China-Japan Education Exchange Conference has been held in Tokyo as representatives from over 100 universities and educational institutions gathered to discuss new directions for bilateral educational cooperation.

The conference on Sunday, themed "Mutual Learning and Collaborative Innovation – Looking Ahead to the Next Decade of China-Japan Educational Exchange," also attracted nearly 1,000 educators and experts.

In his remarks, Zhao Baogang, minister counselor at the Chinese Embassy in Japan, said educational exchange remains a vital and long-term component of China-Japan relations.

Currently, around 130,000 Chinese students are studying in Japan, and more than 600 Japanese high schools offer Chinese language courses, he said.

Over 9,000 inter-university cooperation agreements have been signed between the two countries, Zhao noted, expressing hope that the conference would inject new vitality into bilateral education ties and contribute to the long-term development of China-Japan relations Takafumi Yamamoto, associate managing director of the University of Tokyo. emphasized the importance of providing more international opportunities for young students. He noted that cross-border learning and communication broaden academic horizons and enhance mutual cultural understanding, saying that understanding diverse ways of thinking will be a valuable asset for the younger generation.-APP

Jordan sends aid convoy to southern Syria

LONDON: The Jordan Hashemite Charity Organization sent an aid convoy to Syria on Sunday. The JHCO, in coordination with the Ministry of Foreign and Expatriate Affairs and the Jordan Armed Forces, sent 16 trucks loaded with prefabricated homes, as well as medical supplies and medicines. Hussein Shibli, secretary-general of the JHCO, said the charity partnered with the Helping Hand Foundation, MedGlobal, and Hikma Pharmaceuticals. The Syrian Crescent will distribute the aid in the southern Suwayda governorate and Daraa. The JHCO collaborated with Qatar in September to deliver aid in Suwayda. –APP

Mexico unveils security operation in violent

MEXICO CITY: The government of Mexican President Claudia Sheinbaum on Sunday unveiled plans to fight organized crime and improve security in the violence-ridden state of Michoacan after the brazen public assassination of a local mayor sent shockwaves through the country More than 10,500 members of Mexico's army, air force and National Guard are part of the operation, called the Michoacan Plan for Peace and Justice, to crack down on criminal groups, combat extortion and dismantle drug labs and training camps, officials said at a press conference. The plan implies an investment of 57 billion pesos, Sheinbaum said. Michoacan state has seen new waves of violence after Carlos Manzo, mayor of the city of Uruapan in Michoacan, was shot dead during Day of the Dead celebrations on November 1. Manzo had been an outspoken critic of the federal government for not doing more to confront organized crime. Officials said they will strengthen Michoacan state police and the state attorney general's office. Helicopters, surveillance aircraft and drones are among the technology resources dedicated to the operation. The plan also includes bolstering resources for welfare, agriculture, infrastructure, employment.-APP

President extends greetings to Poland

IHC orders new investigation into Rs1.42bn bitcoin ransom threat

ISLAMABAD/DUBAI: The Islamabad High Court (IHC) has ordered a new investigation into an FIR alleging that an unidentified person demanded 50 bitcoins, valued at over Rs1.42 billion, as ransom from property tycoon Malik Riaz, and threatened harm to his family in Pakistan and abroad if the demand was not met.

Court papers show the IHC set aside an order by the Judicial Magistrate (Sec-30) that had dismissed the matter. Justice Muhammad Asif allowed writ petition No 1346/2025, filed by Col (retd) Khalil-ur-Rehman, and remanded the case for a proper investigation under Section 173 of the CrPC.

FIR Number 117/25 was registered on January 29, 2025, under Section 506 of the PPC (criminal intimidation). The case file contains screenshots and email headers referencing Malik Riaz and Bahria Town, alongside the demand for 50 bitcoins accompanied by threats.

A cancellation report was prepared on February 4, 2025. Despite the complainant's non-appearance on the date fixed, the trial court proceeded and passed the impugned order. The high court found process hasty and non-transparent and directed a fresh, lawful inquiry.

Saudi Arabia doubles down on its terms for Israel ties

RIYAD: Saudi Crown Prince Mohammed bin Salman is set to visit the White House this month, but despite US President Donald Trump repeatedly touting an imminent breakthrough, diplomats say Riyadh is unlikely to seal any deal to normalise ties with Israel during the trip.

The establishment of diplomatic relations between Israel and Saudi Arabia after decades of enmity could shake up the political and security landscape in the Middle East, potentially strengthening US influence in the region. Trump said last month he hoped Saudi Arabia would "very soon" join other Muslim countries that signed the 2020 Abraham Accords normalising ties with Israel. But Riyadh has signalled to Washington through diplomatic channels that its position has not changed: it will sign up only if there is agreement on a roadmap to Palestinian statehood, two Gulf sources told Reuters.
