Islamabad ready to enhance economic cooperation with Manama in fields including AI, IT and agriculture

MANAMA: Prime Minister Shehbaz Sharif on Thursday said that the Gulf Cooperation Council Free Trade Agreement (GCC FTA) has been "nearly finalised" and is expected to be signed soon, adding that the pact would significantly boost Pakistan's trade with GCC member states, particularly Bahrain. The premier made these remarks while addressing the business community in Manama, a day after arriving in the Bahraini capital, where he held delegation-level talks with the country's leadership at Al Qudaibiya Palace.

Addressing the gathering, the prime minister said the agreement would open new avenues for economic cooperation, investment and market access. He urged Bahraini investors to explore opportunities in Pakistan's industry, agriculture, IT and fintech sectors. "This will enhance trade between Pakistan and the GCC countries, particularly with Bahrain," he said, inviting Bahraini businesses to form partnerships with Pakistani firms.

"I address you not just as the Prime Minister of Pakistan but as the CEO of a nation eager to partner with Bahraini entrepreneurs ready to support joint ventures, facilitate your investment plans and assist in the mutually-rewarding journey ahead of us... CM Afridi says weighing 'last option'

PESHAWAR: Khyber Pakhtunkhwa (KP) Minister Sohail Afridi on Thursday said the Pakistan Tehreek-e-Insaf (PTI) was discussing its "last option" to secure a meeting with jailed party founder Imran Khan, amid rumours about his health. The Adiala jail administration issued an update on the former premier a day earlier, following speculation about his health and relocation from the facility. However, speaking to the media at Rawalpindi's Gorakhpur checkpoint today, the KP chief minister said that the party's concerns were growing over the refusal to allow a meeting with the PTI founder. He added that the party was left with its "last option" after "adopting all legal and democratic courses" to ensure a meeting with Khan inside the prison. "We want a oneon-one meeting with PTI founder to inquire about his health," the CM said.

CM Afridi maintained that he wanted to join the earlier sit-in outside the prison; however, the PTI founder's sisters stopped him from doing so. Khan, who has been incarcerated since August 2023, faces a plethora of cases, including corruption and terrorism, since his ouster from power via the opposition's no-trust motion in April 2022. The Adiala jail administration, in its clarification, said that there was no truth to reports about the PTI founder's transfer from the facility.

Rana Sanaullah blames 'past establishment' for destruction in Pakistan Adviser to PM says consultations

held with PPP regarding appointment of Sindh governor

ISLAMA BAD: Adviser to the Prime Minister on Political Affairs Senator Rana Sanaullah has held the establishment during the Pakistan Tehreek-e-Insaf (PTI) government responsible for the "destruction in Pakistan". "The PTI founder and those who brought him to power in 2018 are responsible for the destruction in Pakistan," he said while speaking to the media outside the Parliament House on Thursday.

Sanaullah maintained that the chaos that occurred during the PTI government has not been undone "despite the incumbent government's great efforts". "The establishment of that time is responsible for all this ruin. General Faiz Hameed is currently on trial," he added. However, he said that holding those actors accountable was not the PML-N's priority right now. "Our current focus is stabilising the country."

The PML-N leader asserted that the government would complete its term with the support of its allies, including the Pakistan Peoples Party (PPP).

Responding to a question regarding a change in the Sindh governorship, Sanaullah said that they have held consultations with the PPP regarding the same.

The PML-N-led government was currently addressing the PPP's reservations about a decision to bring a change in Sindh, he added. Sanaullah downplayed the International Monetary Fund's (IMF) recent report on Pakistan, saying: "The IMF report on corruption has no significance."

He noted that no scandal of corruption surfaced in the current government or the previous Pakistan Democratic Movement (PDM) government.

His comments come hours after Finance Minister Mohammad Aurangzeb pledged the government would address all gaps and issues identified in the IMF report.

Attack near White House

US govt stops processing Afghan immigration requests

Washington shooting leaves two Guardsmen critical, with White House placed under lockdown

WASHINGTON: The US Citizenship and Immigration Services said late on Wednesday it has stopped processing all immigration requests relating to Afghan nationals indefinitely, after two National Guard soldiers were shot and critically wounded in Washington. President Donald Trump said that the shooting near the White House was "an act of terror," saying the suspect came from Afghanistan in 2021.

The move follows Trump's call for his government to re-examine Afghan immigrants who entered the United States when Joe Biden was President. "The protection and safety of our homeland and of the American people remains our singular focus and mission," the U.S. Citizenship and Immigration Services said in a post on X. The National Guard soldiers were shot earlier on Wednesday in what officials described as a targeted ambush, and the suspect was in custody after suffering gunshot wounds during the attack. Investigators identified the suspect as Rahmanullah Lakanwal, a 29-year-old Afghan national from Washington State, according to a Justice Department official who

spoke on condition of anonymity. The attack is being investigated as an act of terrorism, the official said.

Trump is at his resort in Palm Beach ahead of Thursday's Thanksgiving holiday, while US Vice President JD Vance is in Kentucky. In a social media post, Trump called the suspected shooter an "animal" who was also "severely wounded." He also ordered 500 more guard soldiers deployed to Washington, Secretary of Defence Pete Hegseth told reporters, joining about 2,200 already in the city as part of the president's contentious immigration and crime crackdown targeting Democratic-led cities.

Lakanwal came to the US in 2021 on a special visa programme for Afghans who assisted the US during the Afghanistan war and were vulnerable to reprisals from the ruling Taliban after the US withdrawal, the official said. But he overstayed his visa and is in the country illegally, according to the official. President Donald Trump was in Florida at the time of the attack, which prompted the White House to go into lockdown as law enforcement from multiple federal and city agencies swarmed the area.

Meeting discuss protection of KP children from intestinal worms

Special Secretary Health, Khalid Parvez on Thursday chaired a meeting of Multi-Sectoral Steering Committee to discuss protection of children from intestinal (stomach) worms in KP Meeting was attended by senior officials of health department and other relevant departments. The meeting was informed that under the ongoing De-worming Program in Khyber Pakh tunkhwa, approximately 18 million children have been provided with free, safe and effective medicines from 2019 to date. The upcoming campaign would be conducted from 8 December to 12 December during which around 8 million more children across the province would be administered medicine to eliminate intestinal worms.

It was told that under this campaign, a target has been set to protect over 8 million children aged 5 to 14 years in 22 districts of KP from intestinal worms. This target includes children from all public and private schools, primary and middle educational institutions and madaris. To ensure the success of the campaign, more than 35,000 teachers, health department staff, Lady Health Work ers and other supporting personnel are deployed every year. Teachers are provided special training and assigned the responsibility of administering the medicine and creating awareness at educational institutions, while the health department ensures technical supervision, availability of medicines and monitoring. Offi-

cials stated that intestinal worms negatively affect children's health, physical growth, nutrition and academic performance. Due to De-worming Program, a significant reduction in anemia, weakness, and other diseases among children has been observed, meeting was told. According to health department, strict implementation of all safety protocols would be paign and children would be provided with safe and effective medicines in accordance with international standards. Meeting also urged parents, teachers, religious scholars and all segments of society to fully cooperate in this national welfare initiative so that the children of the province may move towards a healthy and secure fu-

Slow internet hampering digital economy targets

LAHORE: Lahore Chamber of Commerce and Industry (LCCI) President Faheem-ur-Rehman Saigol said on Thursday that the quality of internet service in Pakistan has declined sharply in recent years. while the world is rapidly advancing in IT and technology. He said Pakistan is falling behind in the race for innovation, even though freelancing and the digital economy offer major opportunities for the country. He said freelancing, the digital economy and startup culture are growing fast, but Pakistan's internet system is unable to meet their needs. Due to lack of fiber networks and data centers, Pakistan has fallen behind other countries in the region.

He said that if the government focuses on the technology sector, speeds up the development of special tech zones, and upgrades internet services to international standards, Pakistan's digital economy can grow many times over and create significant job opportunities for young people.-APP



Building resilience in education through advancing DRSI

ISLAMABAD: UN-Habitat hosted a high-level gathering to highlight progress made in advancing disaster-resilient school infrastructure and to present the achievements of the Disaster Resilient School Infrastructure (DRSI) Project. This marks an important milestone in efforts to create safer and more resilient learning environments for children in Pakistan's disaster-prone regions. Khyber Pakhtunkhwa has long been one of Pakistan's most affected provinces, facing repeated earthquakes, floods, and climate-induced hazards that have severely damaged school infrastructure. Many buildings constructed before the introduction of Pakistan's 2007 Building Code remained vulnerable due to the absence of seismic provisions. To respond to these challenges, the DRSI Project was initiated by UN-Habitat to improve the structural safety of schools through retrofitting, repair, and the upgrading of essential facilities. This project was funded with 471 million Japanese Yen by the Government of Japan and Japan International Cooperation Agency (JICA), and jointly

implemented by UN-Habitat and UNDP in close coordination with the Elementary and Secondary Education Department, Khyber Pakhtunkhwa Province, the initiative strengthened 150 schools across eight districts. The project improved the learning environment for 31,000 students, including 13,595 girls, and rehabilitated 300 gender-responsive WASH facilities, including facilities in 66 girls' schools. Speaking at the event, Mr. Jawed Ali Khan, Senior Advisor and Programme Manager at UN-Habitat, emphasized UN-Habitat's leadership in delivering safer school environments. He noted that the retrofitted schools now provide structurally stable classrooms, improved ventilation and lighting, and essential WASH services that allow children to learn with confidence and security. JICA's Chief Representative, Mr. Naoaki Miyata, said this project would contribute to enhance resilience of primary, middle and high school buildings in disaster prone areas of Khyber Pakhtunkhwa in 8 districts, Buner, Swat, Malakand, Peshawar, Chitral Upper & Lower and Dhir Upper and Lower. The Ambassador of Japan to the Islamic Republic of Pakistan, H.E. Mr. Akamatsu Shuichi appreciated the collaborative effort and reaffirmed Japan's support to Pakistan's resilience agenda. He said that strengthening school infrastructure is a vital investment in protecting children and ensuring that education continues even in the face of natural disasters. Mr. Hamid Mumtaz, Deputy Programme Manager at UN-Habitat, highlighted the urgent need to strengthen resilience in schools across disaster-prone regions. With two decades of experience in Pakistan, UN-Habitat has guided disaster risk reduction, safer reconstruction, national guidelines for earthquake- and flood-resistant construction, and multi-hazard risk assessments, contributing to safer and more resilient learning environments for children across Khyber Pakhtunkhwa. The Secretary of the Elementary and Secondary Education Department, Government of Khyber Pakhtunkhwa, expressed appreciation for the support of the Government of Japan, JICA, UN-Habitat, and UNDP noting that the project has strengthened school safety in districts previously hit hard by earthquakes and floods. He emphasized that continued collaboration is essential to ensure long-term resilience across the education sector. The improved school environments have strengthened trust within communities and encouraged regular attendance.

tion of Islamabad has stepped up its anti-dengue operations on Thursday to get control over the situation and move toward making the city dengue-free Officials said the overall condition remains stable as district teams continue daily surveillance and field actions. A daily surveillance report issued by the district teams highlighted the measures taken during the past 24 hours. Under the ongoing anti-dengue operation, teams carried out fogging in 445 high-risk zones and sprayed 23 houses identified during monitoring activities.

ISLAMABAD: The district administra-

rural and urban localities. According to the report, Islamabad recorded only 2 new dengue cases in the past 24 hoursone case from rural areas and one from urban areas. Hospitals in the capital are currently treating 4 dengue patients, and doctors have described all of them as stable. Officials said there has been no alarming rise in cases, and hospital admissions remain limited. During larva checking activities, teams detected positive larva at 20 commercial hotspots, while all open areas were found clear. Only one negative larva case surfaced and was addressed on the spot by field staff. Deputy Commissioner Islamabad Irfan Memon said the district teams' efficient actions, combined with public cooperation, have

helped keep dengue under control. He added that identifying larva in time has allowed teams to increase checking and surveillance in commercial areas, which are more prone to breeding activity. He noted that teams have been instructed to strengthen monitoring in these locations to prevent new cases from emerging. The administration has also taken strict action against individuals violating dengue SOPs, making arrests on the spot and initiating legal proceedings wherever required. DC Irfan Memon said the anti-dengue operation will continue without interruption until the city is fully cleared of the virus.

IFA gives food outlets 3 days to register

ISLAMABAD: The Islamabad Food Authority (IFA) has called on every restaurant and food point in the federal capital to finish their registration process within the next three days, warning that action will begin immediately after the deadline According to Deputy Director of Islamabad Food Authority (IFA) Dr Tahira Siddique, all businesses serving food must complete their registration by November 30 without delay. She said that the upcoming action will cover the entire city and no unregistered outlet will be allowed to continue operations once the deadline ends. Dr Tahira said that from December 1, any restaurant or food point operating without registration will not be permitted to function. She added that IFA inspection teams will conduct daily inspections across Islamabad to check compliance. Officials explained that unregistered outlets will face closures and heavy fines. The Islamabad Food Authority has clearly stated that the enforcement drive will begin right after the deadline, leaving no room for extensions or leniency. To facilitate business owners, the Food Authority has set up a special registration desk at the Business Facilitation Centre. According to the Deputy Director Operations, this desk is designed to help owners complete the licensing process quickly. The authority's staff is ensuring on-spot registration through a simple and timely procedure. In her statement, Dr Tahira reiterated that the department is focusing on bringing every food outlet under the registration system. She said that all outlets, regardless of size or location, must follow the same rules and finish the process within the given time. The authority has appealed to all restaurant and food point owners to complete registration by 30 November to avoid penalties. Officials said the drive aims to maintain public health standards and ensure that every food outlet meets the basic requirements set by the

Pakistan launches First Genomics venture


ISLAMABAD: Pakistan has launched its first public-private genomics joint venture, receiving strong support from Chinese scientific institutions and technology partners. The initiative, unveiled Tuesday at the National Institute for Genomics and Advanced Biotechnology (NIGAB), is a collaboration between NIGAB, PARC-Agro Tech Company (PATCO), and Blazon Diagnostics, Gwadar Pro reported on Thursday. A Chinese delegation of researchers attended the inauguration at NARC, pledging

"their full support toward the success of this pioneering initiative." The event marked a new phase in China-Pakistan collaboration in high-tech biotechnology, especially in agriculture and diagnostics. Chairman Pakistan Agricultural Research Council (PARC). Dr. Sved Murtaza Hassan Andrabi, called the project a milestone for Pakistan's scientific development, launched under the guidance of the Federal Minister for National Food Security and Research (NFS&R), Rana Tanveer Hussain. "By developing indigenous genomic capabilities, we are laying the foundation for self-reliance in advanced research and diagnostics," said Dr. Andrabi. "This initiative will accelerate innovation that directly benefits our farmers, researchers, and healthcare sector." Chinese researchers welcomed the project as a natural extension of the China-Pakistan Economic Corridor (CPEC), reflecting shared goals to modernize agriculture through technology. The venture is expected to

reduce Pakistan's reliance on foreign DNA sequencing services, save foreign exchange, and open new channels for China-Pakistan cooperation in biosciences. China's agricultural technology is already widely used in NARC. A Chinese JDF 1304 tractor (JDAF NG) was deployed on Tuesday for regenerative wheat planting, while a day before a rice harvesting was conducted using a Chinese rice harvester, highlighting China's growing role in agricultural modernization-DNA

Agricultural chemicals worth 3.686b imported

ISLAMABAD: The imports of agriculture and other chemicals during the first four months of the current financial year grew by 8.41 per cent as compared to the imports of the corresponding period of the last year. During the period from July to October 2025, different agricultural and other chemicals valued at \$3.686 billion were imported as compared to the imports of \$3.374 billion of the same period of the last year, according to the data of the Pakistan Bureau of Statistics. However, the imports of the fertilizers manufactured in the country decreased by 9.69 per cent as 511,828 metric tons of fertilizers costing \$338.411 million were imported as compared to the imports of 612,684 million valued \$374.706 million of the same period of the last year. Meanwhile, 11,120 metric tons of the insecticides valued at \$59.268 million were imported during the period under review, as compared to the imports of 8,854 metric tons worth of \$45.213 million of the same period of the last year, the data revealed. In the first four months of the current financial year, the import of plastic material grew by 14.38 per cent as 834,292 metric tons of plastic material worth \$974.079 million were imported as compared to the imports of 666,825 metric tons valued at \$851.630 million of the same period of the last year, it added. The import of medicinal products also grew by 19.74 per cent as 14,131 metric tons of medicinal products costing \$500.162 million were also imported during the period under review, as compared to the imports of 12,181 metric tons valued at \$417.720 million.-DNA



A tale of two ceasefires

OLLOWING the historic Sharm El-Sheikh summit on Donald Trump's Gaza peace plan in October and since the UN Security Council adopted that plan under Resolution 2803 last week, the US has claimed on several occasions that it has finally brought peace to the Middle East and that "a golden age" awaits the troubled region. Like many such declarations, one must separate the hyperbole from the improbable. In Gaza's case, nothing could be further from the sad and dismal reality that more than 2 million Palestinians have been going through since the so-called ceasefire came into effect last month. For Israel, particularly Prime Minister Benjamin Netanyahu, "ceasefire" can mean many things, but not the cessation of hostilities.

Since the plan was signed by Trump and the guarantors of the agreement, Israel has killed more than 300 Palestinians in Gaza. The multiple ceasefire violations by the Israeli side have included using gunfire against civilians, shelling, airstrikes, property demolitions and arrests. Israel has brazenly reiterated that it is committed to the ceasefire after carrying out every breach, blaming Hamas and others for its response, which is always justified under the guise of self-defense. But that is not all. Under phase one of the agreement, Israel must open crossing points to allow the unfettered flow of humanitarian aid, medicine, mobile homes, tents and salvaging equipment. The UN and other international agencies have repeatedly described the situation in Gaza as extremely harsh since the ceasefire began, with only a limited improvement in safety and aid access. According to the UN, the situation remains a major humanitarian emergency, with widespread hunger, disease and inadequate shelter despite the pause in large-scale fighting.

For Israel, particularly Netanyahu, 'ceasefire' can mean many things, but not the cessation of hostilities Harsh winter conditions have exacerbated the situation, leaving most people still struggling to secure basic necessities such as food, clean water, healthcare and sanitation. With 90 percent of the population displaced and most lacking proper shelter, famine conditions and "catastrophic" hunger persist, with tens of thousands of children suffering acute malnutrition. Despite setting up a monitoring site inside Israel, the US and other international observers have failed to hold Israel responsible for failing to meet its obligations under the Trump plan or to call it out for breaching the ceasefire multiple times by carrying out strikes and shelling, as well as mass demolitions in areas it occupies in Gaza. In fact, the US has blamed Hamas for threatening the faltering ceasefire, while never blaming Israel for failing to meet its obligations.

The reality is that Israel violates the ceasefire agreement while acting with impunity. It is punishing the entire population of Gaza – forcing them to live in subhuman conditions. Israel has brushed aside appeals by the UN and other agencies to allow more aid in, including 1 million syringes that UNICEF says are needed to inoculate Palestinian children. The agency has said that at least two children are being killed in Gaza every day during the ceasefire.

Israel is using the ceasefire deal to achieve its goals: ethnic cleansing, collective punishment, infanticide, displacement, artificial famine, mass demolitions and controlling aid to prevent most essential foodstuffs, including fresh meat, from entering the Strip. In fact, it is now becoming clear that Israel does not want to see the deal move into phase two, in which an international stabilization force is to be deployed in Gaza, thus delivering the internationalization of the crisis. Nor does it want to see any reconstruction effort take place.

And, according to observers, Israel, which now occupies more than 44 percent of the enclave, does not want to withdraw - ever. In fact, Israel has been tampering with the so-called Yellow Line to encroach on even more Gazan territory. Another virtual ceasefire deal negotiated by the US is also on the verge of collapse. The one-year-old truce between Lebanon and Israel is one-sided, with Tel Aviv free of any commitment to it. According to the UN Interim Force in Lebanon, Israeli forces have been responsible for more than 7,500 air violations and nearly 2,500 ground violations in the past year. This amounts to almost 10,000 breaches in less than a year of the ceasefire, which took effect on Nov. 27, 2024. According to the UN, Israeli forces carried out more than 500 airstrikes in Lebanon over the first 10 months of the ceasefire, killing at least 108 civilians, including 16 children. Israel has said it was targeting Hezbollah fighters and weapons caches. Still, this week it escalated the situation further by killing the group's second-in-command and top military leader, Ali Tabatabai, in a strike on Beirut's southern Dahieh district. According to the UN, Israel carried out more than 500 airstrikes in Lebanon over the first 10 months of the ceasefire

Netanyahu and his defense minister have repeatedly warned that, unless the Lebanese government disarms the pro-Iran group, Israel will do the job itself. The Israeli army, which occupies five strategic points in southern Lebanon, has been carrying out maneuvers in preparation for a possible invasion.

The US has again defended Israel's right to attack Lebanon, even when such attacks clearly violate the ceasefire agreement and UNSC Resolution 1701. Israel claims, without providing evidence, that Hezbollah has been rearming itself, even as it admits that the party was gravely wounded during last year's war. In Lebanon's case, Washington has clearly taken the side of Israel, while putting pressure on a weak Lebanese government to carry out what has been described as an impossible task: disarming Hezbollah. At the same time, the US has offered no guarantees that, once Hezbollah is neutralized, Israel will withdraw entirely from southern Lebanon and allow the rebuilding of the tens of villages it has destroyed. In both Gaza and Lebanon, Israel's concept of a ceasefire clearly has nothing to do with meeting its obligations. Such agreements apply only to the other side, which must withstand Israeli blows without responding. And God forbid if the other side does retaliate. Israel's military might would be unleashed to punish the culprit. In Gaza's case, the US is key to overseeing the deal's implementation. But it has failed to put pressure on Netanyahu to open the crossing points and allow all humanitarian aid to flow to end the horrific and inhumane conditions that more than 2 million Palestinians are being forced to endure. In the case of Lebanon, Washington is allowing Israel to wage war under the guise of a ceasefire against a weak and damaged country. Both cases present untenable situations that render the claim of peace in the region comical, if not tragic.

HERE was a time when the rhythm of life flowed with a natural grace, unhurried and unfragmented, when families found contentment in gathering around their elders and absorbing the wisdom of their years. Among the memorable figures of that simpler age was the maternal grandfather of my Tai Ammi, whom everyone affectionately called Mianji. He lived to be about 108 years old, and age had done little to diminish the sharpness of his mind or the calm composure of his spirit. Whenever he came to our home, it was as though a quiet festival had arrived. All the children would instinctively gather around him, sitting on the floor near his Charpai, waiting for him to speak. We would bombard him with questions-some sensible, some utterly childish-and he would never show the slightest sign of fatigue or irritation. His patience seemed endless, his affection inexhaustible. If we asked him the secret of his long life and ro-

If we asked him the secret of his long life and robust health, he would smile, stroke his beard, and repeat the same few principles that had shaped his existence. Walk as much as you can, he would say; eat fresh and simple food; fill your plate with vegetables and fruits; rise early and sleep early; never abandon the five daily prayers; and, he would add with a hint of pride, never sleep under a fan. In those days, this last habit sounded strange even to us children, but for him it was part of a disciplined, self-controlled life. He would narrate eye-witness accounts of events from a distant past, tell instructive stories, and share what he called "the secret of success"—contentment, gratitude, honest work, and trust in Almighty Allah.

In those times, nearly every household followed a similar pattern. Elders were not merely present; they were central to the moral and emotional life of the family. Serving them was not deemed a burden but an honour. People took pains to care for their elderly parents and grandparents, to sit with them after meals, to listen to their memories and advice. Children were gently pushed to spend time with their elders, to learn from their experience, and to absorb, almost unconsciously, the etiquette of life. Perhaps it was the absence of modern distractions,

perhaps it was the habit of being content in every situation, or perhaps it was the cleanliness of the eyes and heart that comes from living closer to nature and faith. But one thing is certain; the home was more of a living, breathing institution, and less of a hotel with isolated rooms.

Then came a silent revolution in the form of mobile phones and digital devices. On the surface, it promised connectivity and convenience. In practice, it quietly rearranged the architecture of our relationships. Today, it is common to see a father, mother, son, and daughter all sitting in the same room, yet each imprisoned within the small glowing screen held in their hand. They are physically together but emotionally scattered in four different worlds. Conversations are reduced to brief interruptions between notifications. Laughter, once shared across the room, is now directed at short videos made by strangers.

We often say, "Mobile phones are a necessity of modern life," and to some extent this is true. Yet, for many young people, the device has moved far beyond necessity and entered the realm of addiction. The idea of spending even a few hours without a phone feels unbearable. When, due to security concerns, mobile services are suspended for a day or two, life itself appears to be suspended. People panic, feel restless, and behave as though some vital organ of the body has been removed.

The tragedy is not confined to adults. It has seeped into the nursery. It is now a common sight that a child will only eat if cartoons are playing on a mobile phone. To gain a few moments of peace, mothers place a device in the small hands of their children, believing that this will give them time to manage other chores. The child sits mesmerised for hours, eyes fixed, mind numbed, and body inactive. Later, when that same child calls out, the parents often do not respond. Their own ears are occupied by earphones, their own attention captured by the same digital demon they once placed in their child's hands.

As a nation, we appear to have been taken hostage by this tiny piece of technology. It has invaded our bedrooms, our dining tables, our mosques, our classrooms, and even our funerals. If this trend continues unchecked, the future will not merely be uncomfortable; it will be frightening and painful. We risk raising a generation that is physically present but emotionally absent, connected to the world yet detached from their own families, informed about everything yet wise about nothing.


The way forward, however, does not lie in rejecting technology altogether. That would neither be realistic nor fair. The solution lies in restoring balance and reclaiming control. Families must consciously design "phone-free zones" and "phone-free times" inside the house—such as at meals, during family gatherings, and in the hour before sleeping. Parents must recognise that the first model of behaviour for a child is not a cartoon hero on a screen, but the adults in the home. If the parent is permanently glued to the phone, any lecture about reducing screen time will ring hollow.

Schools and religious institutions can also play a vital role by educating children and parents alike about the psychological and physical harms of excessive screen use, from weakened attention span to disturbed sleep and fractured relationships. Community campaigns and media programmes should highlight stories like that of my beloved Mianji, reminding us that health, longevity, and inner peace have long been linked to movement, simplicity, moderation, spirituality, and human connection—not to endless scrolling and virtual applause. On an individual level, each of us must ask a hard question: who is the master and who is the servant? The mobile phone was made to serve us, not to rule us. We can begin with small, firm steps. Keep the phone away while talking to parents and grandparents. Visit them without the excuse of a "missed call" or a "WhatsApp message." Listen once again to their stories, even if we think we have heard them before. Replace one hour of mindless browsing with a quiet walk, a page of a good book, or a meaningful conversation.

If we manage to do this, perhaps we will not only protect the future of our children but also regain a precious part of our past. We may not live to be one hundred and eight like Mianji, but we can surely strive to live lives that are richer in love, calmer in spirit, and closer to the values that once made our homes true schools of character.

HE issue of rape in Pakistan remains one of the most disturbing and persistent challenges within the domain of public safety, criminal justice and gender relations. Understanding the legal, social and structural dimensions of the problem is necessary for an honest discussion on why sexual violence continues at alarming levels and why so many survivors remain without justice.

In Pakistan, rape is defined under Section 375 of the Pakistan Penal Code (PPC) 1860. According to this provision, rape occurs when a man has sexual intercourse with a woman without her consent. Several specific conditions clarify this definition. Consent obtained through threats of death or serious harm is not considered valid. A woman below sixteen years of age is legally unable to consent, making intercourse with her rape regardless of circumstances. Furthermore, consent given under the mistaken belief that the man is her husband also falls under the definition of rape. These provisions show that the law recognizes both physical force and coercion as central elements of the crime, while also acknowledging deception and age-related vulnerability. Legal definitions alone, however, provide only part of the picture. Rape in Pakistan is situated within a complex social structure shaped by gender norms, cultural expectations and deep-rooted inequalities. Attitudes toward sexual violence are affected by several factors: restrictive views on sexuality, limited knowledge about bodily autonomy, increasing exposure to global cultural trends, weak social protection systems and the exploitation of vulnerable individuals by those in positions of influence. Psychological aspects further complicate the situation. Survivors often experience long-term trauma, anxiety, fear and mistrust. Childhood abuse, adverse family environments and the normalization of gender-based violence contribute to a cycle in which harm continues across generations.

The importance of openly addressing rape in Pakistan cannot be overstated. Silence and denial only deepen the suffering of victims and strengthen the social obstacles they face. Large segments of the population have limited understanding of how widespread the problem is or what legal protections exist for victims. The number of reported cases is far smaller than the actual number of incidents. Fear of blame, pressure from family or community and widespread distrust in the justice process stop survivors from coming forward. Many who do report are subjected to harsh questioning, stigma and isolation. According to the Human Rights Commission of Pakistan, more than eleven cases of rape are report-

ed every day, while countless others remain hidden due to fear and lack of support. Awareness, education and preventive measures are therefore essential for reducing violence and encouraging victims to seek help.

Historical and contemporary data highlight both longterm patterns and recent fluctuations. A study conducted in 1988 revealed that 72 percent of women who were held in custody had experienced some form of abuse, while 20 to 30 percent of women across the country faced domestic violence. Between 2002 and 2004. Karachi recorded between 61 and 78 rape cases annually based on local FIRs, already a troubling figure given how many incidents go unreported. A 2004 report documented 728 rape cases, including gang rapes, along with other acts of violence such as assault, acid attacks and murder. From 2006 to 2016, Punjab saw reported cases double-from around 1,500 per year to nearly 3,000. More recent national data from 2017 to 2024 shows sharp ups and downs: 3,300 cases in 2017, rising to over 4,300 in 2019, decreasing in 2020, then jumping to more than 5,100 in 2021. Reports dropped again in 2022, rose to around 6.600 in 2023 and saw a modest decline in 2024. These numbers, although alarming, still fail to reflect the full magnitude of the problem because underreporting remains widespread.

Mass harassment incidents, such as the Minar-e-Pakistan case in 2021, demonstrated that collective violence against women is not limited to isolated criminals but can occur in public spaces. Cases like Dua Zehra (2022) and Fatima (2023) continued to raise concerns about child protection and legal loopholes. By 2024, Lahore remained the city with the highest number of documented rape cases, although conviction rates stayed low across the country. Child abuse is another deeply troubling aspect. Early 2023 data from Punjab showed 1,390 incidents of child abuse, many involving boys and typically committed by people known to the victims. Such cases highlight the need for stronger safeguards for children at home, in schools and in workplaces. Section 376 of the PPC addresses punishments for rape. Sentences range from ten to twenty-five years imprisonment, or the death penalty in certain cases. Aggravated forms of rape-such as crimes involving children, persons with disabilities, severe physical harm, or the misuse of official authority-carry harsher penalties, including life imprisonment. Over the years, legal reforms have attempted to strengthen the system. The Criminal Law Amendment of 2016 expanded the scope of Section 376, introduced greater protections for vulnerable victims and required the use of scientific evidence such as DNA. The 2006 amendments earlier separated rape from the Hudood Ordinance, which had long created legal complications for victims seeking justice. More recently, the 2020 Anti-Rape Ordinance introduced special courts for swift trials, crisis cells for victim support, improved forensic procedures and chemical castration for repeat offenders. Reports from 2018 to 2021 documented high levels of sexual violence, workplace harassment and custodial abuse, with Punjab again reporting the most incidents. Government and civil society responses included awareness campaigns, helplines, legal amendments and school-based safety initiatives.

Survivors of rape face numerous obstacles not only in the legal process but also in their daily lives. Cultural norms frequently blame victims rather than perpetrators. Many fear retaliation from the offender or from community members who want to suppress the incident. Weak investigative procedures, delayed trials and gaps in forensic capabilities further discourage reporting. Psychological effects such as depression, fear, post-traumatic stress and social withdrawal often last for years. International estimates from the United Nations suggest that less than ten percent of rape cases are reported and Pakistan's rate is likely even lower. Addressing sexual violence requires multiple, consistent efforts. Legal reforms must be matched with effective implementation. faster trials, trained investigators and reliable forensic processes. Consent education in schools and communities is important for reducing harmful attitudes. Public awareness campaigns can help counter victim-blaming and encourage families to support survivors. NGOs and community groups play an important role in providing safe spaces, counseling and legal guidance. Young people can contribute by volunteering in awareness programs, using social media responsibly to highlight safety issues and promoting respectful behavior in their surroundings. Reducing rape in Pakistan is not only a legal challenge but also a social one. It reguires a collective willingness to confront uncomfortable realities, protect those who come forward and build systems that prioritize safety, dignity and justice for all.

Emmanuel Macron to announce France restoring voluntary military service

PARIS: President Emmanuel Macron is Thursday to announce that France is restoring military service on a voluntary basis in the face of the growing threat posed by Russia and the risk of a new conflict breaking out in Europe. Almost three decades after France scrapped conscription, the head of state is due to lay out the change in a speech from 1000 GMT on a visit to an infantry brigade stationed in the Alps in southeastern France, said a presidential official, asking not to be named.

The announcement will come more than three and a half years into Russia's fullscale invasion of Ukraine, with Macron and other French officials warning that Moscow risks not stopping at Ukraine's borders. France's top general, armed forces chief of staff Fabien Mandon, sparked uproar at home last week by warning that France must be ready "to lose its children", adding that Russia is "preparing for a confrontation by 2030 with our countries". Macron told the RTL broadcaster he would be

Anthony Edwards recorded 31 points and eight rebounds for the Timberwolves, who have lost three games in a row. Oklahoma are only the fifth team in NBA history to begin a season with 18 wins and one defeat, while they have won all three NBA Cup games to lead West Group A. The NBA Cup is an in-season tournament where teams compete for a trophy, but results also count towards the overall season standings. The Thunder host the Phoenix Suns on Saturday, while the Timberwolves welcome the Boston Celtics. The Toronto Raptors qualified for the quarter-finals with a 97-95 home win against the Indiana Pacers. Brandon Ingram scored in the last second to seal the Raptors' ninth victory in succession. Reed Sheppard put in a career-best 31-point performance as the Houston Rockets beat the Golden State Warriors 104-100 in San Francisco. - Agencies

The IMF board's upcoming decisions will show the way forward." The Fund's Governance and Corruption Diagnostic Assessment (GCDA) on Pakistan, which was released last week, warned that persistent corruption and weak institutions continue to undermine the country's economic development even as it stabilises under an Extended Fund Facility (EFF). "Corruption is a persistent challenge in Pakistan, with significant adverse implications for economic development," the report states. It said indicators reflect weak control of corruption over time, with negative consequences for the effectiveness of public spending, revenue collection and trust in the legal system. The publication of the report is a precondition for the IMF executive board's approval of a \$1.2 billion disbursement next month under the \$7 billion programme. The Washington-based lender said policy efforts under the EFF have already delivered "significant progress" in stabilising the economy and rebuilding confidence. The IMF notes that Pakistanis are often compelled to make continuous payments to officials to obtain basic services, while funds lost to corruption could otherwise support higher production and development. While vulnerabilities exist at all levels of government, the IMF finds that the most economically damaging manifestations involve "privileged entities" that exert influence over key economic sectors, including those owned by or affiliated with the state. The report says political and economic elites have obstructed economic development by seizing control of policies and capturing public benefits for their own gain.

Arabia Wolves target spot in United Series after beating Karachi Monarchs

DUBAI: The Arabia Wolves beat the Karachi Monarchs 11-3 at Baseball United Ballpark in Dubai on Wednesday night. The victory leaves the Dubai franchise with a 2-2 record and improves their chances of reaching the United Series in Baseball United's inaugural season. Karachi's Faisal Hayat, right-handed pitcher, gave up three consecutive walks with the bases loaded and the Money Ball in play, invoking a double advance on the second and third batters he faced for a total of five runs. A Money Ball play allows the batting team to double their runs in the case of a home run. Alex Dubord (RHP) also gave up three walks with the bases loaded and threw a wild pitch, leading to a nine-run outbreak for Arabia in the fifth inning. Paul Myro hit a runs-batted-in bunt-single in the fifth inning, and Taylor Darden hit a sacrifice fly in the sixth, to bring in more runs for the Wolves. Liverpool suffer heavy defeat to PSV, extend worst run in 71 Years

LIVERPOOL: Liverpool endured a crushing 4-1 defeat to PSV here at Anfield on Wednesday, extending their worst run of form in 71 years. The heavy loss marked their ninth

defeat in 12 games across all competitions, increasing doubts over Arne Slot's ability to arrest the club's ongoing decline. PSV struck early, taking the lead in the 6th minute after Virgil van Dijk conceded a penalty for a handball inside the box. Ivan Perisic made no mistake from the spot, giving the visitors the advantage.

Liverpool responded swiftly, with Dominik Szoboszlai levelling the score just 10 minutes later. After Matej Kovar fumbled a shot from Cody Gakpo, Szoboszlai was on hand to tap in the rebound and restore parity.

The Reds pressed for control, with Gakpo coming close to putting them ahead, and van Dijk's header rattling the post. However, Liverpool were punished once again in the 37th minute when Mauro Junior broke through



the defence and squared the ball for Guus Til, who calmly finished to put PSV back in front. The second half saw Liverpool's woes deepen. Substitute Couhaib Driouech pounced on a rebound from Ricardo Pepi's shot to make it 3-1, sending the travelling PSV supporters into raptures. Driouech then struck again in stoppage time, firing into the bottom corner after a swift counter-attack to seal PSV's first win over an English side since 2008. Mbappe Fires Stunning Four-Goal Masterclass as Real Madrid Edge Olympiacos 4–3 in Thrilling Champions League Clash to End Winless Run and Set New European Records for the French Superstar

PIRAEUS: Kylian Mbappe delivered a sensational four-goal performance as Real Madrid edged Olympiacos 4-3 in a pulsating Champions League clash here at the Georgios Karaiskakis Stadium on Wednesday, ending their threematch winless run in all competitions. Olympiacos stunned the visitors early on when Francisco Chiquinho drilled a 20-yard strike into the bottom corner. However, Madrid responded with a devastating burst of attacking football, led by Mbappe, who produced the second-fastest hat-trick in Champions League history.

The French forward levelled the score after latching on to a perfectly weighted pass from Vinicius Junior, before heading in Arda Guler's cross moments later. He completed a remarkable seven-minute treble soon afterwards, beating the offside trap and finishing calmly from Eduardo Camavinga's through ball.

Madrid continued to threaten, with Aurelien Tchouameni striking the bar and Vinicius having a goal ruled out for offside in the build-up. Despite being without five defenders and their first-choice goalkeeper through injury and illness, Los Blancos dominated large spells of the encounter. Olympiacos refused to give in. Substitute

Hong Kong searches for missing

after city's deadliest blaze

HONG KONG: Hong Kong firefighters were scouring a still-burning apartment complex for hundreds of missing people

on Thursday, a day after the blaze tore through the high-rises, killing at least 44. The inferno - the financial hub's worst

in decades - took hold on Wednesday afternoon in an eight-building housing estate with 2,000 apartments and sent shock-

waves through the city, which has some of the world's most densely populated and tallest residential blocks. Flames were

still spotted in some of the windows while multiple fire hoses sprayed the scorched exteriors, an AFP reporter saw around

noon on Thursday. Crowds gathered in nearby streets and public areas to organise aid for displaced residents and firefight-

ers, part of a spontaneous effort that drew people from across the city. "It's truly touching. The spirit of Hong Kong people

is that when one is in trouble, everyone lends support... It shows that Hong Kong people are full of love," said Stone Ngai,

38, one of the organisers of an impromptu aid station. Police said early on Thursday they arrested three men in connection

with the fire, after flammable materials left during maintenance work caused the blaze "to spread rapidly beyond control"

Officers searched premises in a separate neighbourhood on Thursday morning, taking away documents in binders in

relation to the three people arrested, who police suspect "acted with gross negligence" by leaving foam packaging at the

site of the fire. Hong Kong authorities will immediately inspect all housing estates undergoing major works following the

disaster, the city's leader John Lee said. Multiple residents of Wang Fuk Court, located in Hong Kong's northern district

of Tai Po, told AFP that they did not hear any fire alarm and had to go door-to-door to alert neighbours to the danger. "The

fire spread so quickly. I saw one hose trying to save several buildings, and I felt it was far too slow," said a man surnamed

Suen, recalling his plight the day before. "Ringing doorbells, knocking on doors, alerting the neighbours, telling them to

leave - that's what the situation was like." Another displaced resident, Wong Sik-kam, recalled how his son was one of the

firefighters dispatched to the scene. "My son called me and told me about the fire... I thought it was just a normal fire, like

a kitchen accident that would be put out. Who knew it would get so bad?" Wong said. Hong Kong's fire department raised

the death toll to 44 on Thursday morning. Among the dead was a 37-year-old firefighter, who was found with burns on his

face half an hour after losing contact with colleagues, according to the fire service director Andy Yeung. A government

spokesman told AFP that 61 people were being treated in hospital. Fifteen were in a critical condition, 27 in a serious

condition and 19 were stable. City leader Lee said in the early hours of Thursday that 279 were unaccounted for, though

firefighters said later that they had established contact with some of those people. Lee said more than 900 people sought

refuge at temporary shelters overnight. The Indonesian consulate said around noon that two of the deceased were Indo-

nesians working as migrant domestic workers. On Wednesday night, sections of charred scaffolding fell from the burning

blocks and flames could be seen inside apartments, sometimes belching out through windows into the night sky, casting

an eerie orange glow on surrounding buildings. "The temperature at the scene is very high and there are some floors

where we have been unable to reach people who requested help, but we will keep trying," said Derek Armstrong Chan,

the deputy director of fire service operations. He said the wind and drifting debris likely spread the fire from one building

to another, although he added that authorities are investigating the cause of the blaze. Chinese President Xi Jinping ex-

pressed condolences to the victims, including "the firefighter who died in the line of duty", according to state media. Lee

said he was "deeply saddened" and that all government departments were assisting residents affected by the fire. -DNA

IRBIL, Iraq: A drone strike on Wednesday targeted an Emirati-owned gas complex in Iraq's autonomous Kurdistan region, disrupting the gas supply to the region's power plants, local authorities said "At 11:30 p.m. (2030 GMT), a drone attacked the Khor Mor gas field facility, cutting off all gas supplies to power plants," the regional natural resources and electricity authorities said in a statement. AFP correspondents in Kurdistan reported power cuts across the region, including in the city of Sulaimaniyah. The Khor Mor gas field lies between the cities of Kirkuk and Sulaimaniyah and supplies most of the Kurdistan region's power. Omed Ahmed, the regional electricity authority spokesperson, said the attack resulted in the loss of 2,600 megawatts of electricity, disrupting 80 percent of the region's power grid. Authorities said they were coordinating with the United Arab Emirates company Dana Gas to investigate the attack and restore operations. A local security source told AFP that the attack "targeted gas storage tanks, causing a major explosion and large fire." Iraq's Joint Operations Command, which coordinates between security forces and the military, said the attack, which set fire to a major storage tank, did not cause casualties. It added that the attack aims at "hindering security and economic stability" in a country that has just recently regained a sense of stability There was no immediate claim of responsibility. Long plagued by conflict, Iraq frequently suffers such attacks. Unclaimed Katyusha rocket and drone attacks have target ed the Khor Mor complex several times in recent years. In April 2024, four Yemeni workers were killed in a drone attack on the facility.-APP

Iran bans access to most forests

TEHRAN: Iranian authorities have imposed a temporary ban on public access to most forested areas, a local media outlet reported, as the country struggled to extinguish a fire in a UNESCO World Heritage-listed site. The fire in northern Iran's Hyrcanian forests, which started on Nov. 1, was brought under control in a few days. However, it reignited on Nov. 15, fueled by strong winds and an unusually severe drought, according to Iranian media. "We have notified the provinces to ban entry into forest areas outside protected zones and parks before the autumn rains occur in order to prevent similar incidents from occurring," Majid Zakariaei, commander of the unit responsible for forest protection, told the Mehr news agency. Iran has requested foreign assistance to combat the fire ravaging the Hyrcanian forests which stretch 1,000 km along the shores of the Caspian Sea and the northern slopes of the Alborz Mountains into Azerbaijan. The ancient forests are home to the endangered Persian leopard as well as brown bears and other large predators and was designated a UNESCO World Heritage Site in 2019. The fire comes with the country facing one of its most severe droughts since records

MINSK: Myanmar will receive shipments of pharmaceutical products manufactured by the Belarusian companies Belmedpreparaty and Minskintercaps. The signing of the pharmaceutical agreements took place as part of the Belarusian-Myanmar business forum in Yangon, BelTA learned from the press service of the Belarusian Healthcare Ministry. The Healthcare Ministries of the two countries have signed a memorandum of understanding and cooperation in healthcare. In 2025, three delegations from Myanmar visited Belarus, touring Belarusian pharmaceutical plants and healthcare institutions. Cooperation on the supply of Belarusian medicines to Myanmar has been ongoing

As noted at the forum, regular ministerial contacts have been established between the two countries, and the legal framework is being developed. During a meeting at the level of the two states' leaders, it was stated that Belarus and Myanmar are systematically deepening mutually beneficial and friendly relations, with the goal of increasing the prosperity of their citizens. The primary task now is to reinforce this high-level political engagement with solutions to specific economic and humanitarian challenges.-APP

Syria will build new 150,000 bpd oil refinery

DAMASCUS: Syria will build a new oil refinery with a capacity of 150,000 barrels per day, the Syrian energy minister told government-owned Ekhbariya television on

Thursday. The channel reported on Sunday that Syria's Baniyas refinery was operating at a reduced capacity of 95,000 bpd due to degradation in some of its facilities, and estimated the country's current total oil production capacity at around 130,000 bpd Syria exported 380,000 barrels of oil per day (bpd) in 2010, a year before protests against Bashar Assad's rule spiralled into a nearly 14-year war that devastated the country's economy and infrastructure - including oil production. Assad was toppled in December last year and the Islamist-led government that replaced him pledged to revive Syria's economy.—APP

Russia sentences eight to life for 2022 Crimean bridge blast

MOSCOW: A Russian court on Thursday jailed eight people for life over huge 2022 explosions that partially destroyed the Crimean bridge, an attack both Kyiv and Moscow said was organized by Ukraine's secret services Five people were killed when the 19-kilometer (12mile) bridge which links the Crimean Peninsula to Russia was hit by a truck bomb blast on October 8, 2022, eight months after Moscow attacked Ukraine. Kviv later claimed responsibility for the blasts, saying they were aimed at hampering Moscow's logistics.

The Crimean Peninsula – annexed by Russia in 2014 has been a key supply route for Moscow's troops fighting in the south of Ukraine. "The defendants were found guilty and sentenced to life imprisonment," Russia's southern military court in the city of Rostov-on-Don said on Telegram. The men were tried in a closed-door hearing at a military court. They have maintained their innocence throughout the trial and a lawyer told state media that the decision would be appealed. The bridge is seen by both Ukraine and Russia as a symbol of Moscow's 2014 seizure of the Crimean Peninsula. President Vladimir Putin

personally inaugurated the bridge, which links Russia to Crimea, in 2018 - even driving a truck across it. Moscow had maintained

the crossing was safe despite the fighting, but it has been targeted repeatedly throughout the war.

The men were charged with carrying out a "terrorist act" that caused death and illegally obtaining weapons as an organized group, the court said. Two were also charged with smuggling explosives._APP

ISLAMABAD: Minister for Poverty Alleviation and Social Safety, Syed Imran Thursday Ahmad Shah announced to launch a new Poverty Graduation Economic Prosperity (PGEP) programme, a \$134.2 million initiative designed to expand proven poverty graduation interventions across the country and support extremely poor and flood-affected households.

Implemented from 2017 to 2025 with financial and technical support from IFAD, NPGP provided integrated assistance across 21 districts and achieved what the Minister called truly transformative results.

Government to hold final PIA bidding by mid-December, NA told

KARACHI: The government plans to hold the final bidding for Pakistan International Airlines (PIA) by mid-December, the Privatisation Division secretary told the National Assembly's standing committee on Wednesday. Briefing the panel chaired by MNA Farooq Sattar, the secretary said that four pre-qualified consortia are currently in the final stage of negotiations over commercial terms, The News reported. He said that talks are underway with the pre-qualified bidders on the share purchase and shareholders' agreements. Pre-bid qualification talks have been continuing for the past three days, while approval of the reserve price will be sought from the federal cabinet, the secretary said.

In early July, the Privatisation Commission Board prequalified four bidders Fauji Fertiliser Company Ltd, Air Blue (Pvt) Ltd, a consortium of Lucky Cement, Hub Power Holdings, Kohat Cement and Metro Ventures, and a consortium led by Arif Habib Corporation with Fatima Fertiliser, City Schools and Lake City Holdings. On November 7, the board approved the inclusion of AKD Group Holdings (Pvt) Ltd in the Arid Habib-led consortium.

Only passengers with incomplete documents being stopped: FIA

ISLAMABAD: Amid prevailing rumours and speculations about alleged offloading of passengers, the Federal Investigation Agency (FIA) has issued a clarification on the issue saying that no passengers were being offloaded from flights. "No passenger is being offloaded at Lahore airport,' said FIA Lahore Zone Director Captain (retd) Ali Zia, adding that the authority facilitates those passengers whose documents are legal and complete. "Even authorities immigration cannot stop you with legal documents," he remarked. The official, however, noted that only those passengers with incomplete documents were being stopped.

Train hits China railway workers, killing 11

BEIJING: A train hit railway workers in southwest China on Thursday, killing 11, local railway authorities said after the crash in Yunnan province. The train "used for seismic equipment testing" collided with construction workers at Kunming's Luoyang Town station in the early morning, killing 11 and injuring two, the Kunming Railway Bureau said in a statement.

The train was "passing normally through a curve inside Kunming Luoyang Town Station when a collision happened with construction workers who had entered the track area", it said. The cause of the crash was under investigation, authorities added. Transportation had returned to normal by midday Thursday, with those injured receiving treatment, they said. Industrial accidents are fairly common in China due to vague regulations and lax safety standards. - APP

ECP notifies five winners

ISLAMABAD: The Election Commission of Pakistan (ECP) on Thursday formally notified the victory of five candidates elected to the National Assembly in the bye-elections held on November 23. According to the notifica-

tion, all five seats were secured by nominees of the Pakistan Muslim League-Nawaz (PML-N). The successful candidates are Babar Nawaz Khan from NA 18 Haripur, Danival Ahmed from NA 104 Faisalabad, and Muhammad Numan from NA 129 Lahore.

Security forces gun down 22 terrorists in DI Khan IBO

Sanitisation operation being conducted to eliminate other terrorists found in area, says ISPR

RAWALPINDI: The security forces have killed 22 India-backed terrorists in Khyber Pakhtunkhwa's Dera Ismail Khan district, the Inter-Services Public Relations (ISPR) said on Thursday. The terrorists, belonging to the Indian proxy, Fitna al-Khwarij, were gunned down during an intelligence-based operation (IBO), the military's media wing said in a statement. The ISPR's statement mentioned that a sanitisation operation was being conducted to eliminate any other Indian-sponsored terrorists found in the area. It reiterated that a relentless counter terrorism campaign under

vision "Azm-e-Istehkam" by security forces would continue and supported terrorism from the country. Pakistan has witnessed an alarming 46% surge in overall violence in the third quarter (Q3) of 2025, as per the statistics issued by the Centre for Research and Security Studies (CRSS). The country reported at least 901 fatalities and 599 injuries, including civilians, security personnel and the terrorists, in a total of 329 incidents of violence, which also included terror attacks and counter-terror operations. The CRSS report highlights that by Q3, the ongoing year has proven nearly as deadly as all of 2024, with 2,414 fatalities recorded compared to the entire tally of 2024, which reported 2,546 deaths in total. Out of the total 901 fatalities in Q3, 516 (57%) were those of the outlaws, whereas there were 385 civilian and military martyrdoms. Further breakdown reveals that civilian deaths stood at 219 (24%), whereas 166 (18%) security personnel embraced martyrdom. Khyber Pakhtunkhwa (KP) and Balochistan - both of which share a porous border with neighbouring Afghanistan faced the brunt of the terrorism incidents, accounting for more than 96% of the total violence across the country. KP was the worst-hit region, suffering nearly 71% (638) of the total violence-linked fatalities, and over 67% (221) of the incidents of violence, followed by Balochistan, with over 25% fatalities (230) and incidents (85). - Agencies

Chief Minister Afridi faces media 'character Assassination' drive

PESHAWAR: Chief Minister Khyber Pakhtunkhwa Muhammad Sohail Afridi has come under increasing criticism from segments of the media allegedly aligned with the federal government, with some outlets accusing him of links to opium and hashish production in the province. The chief minister has so far refrained from responding to the allegations. However, while chairing a high-level meeting on Monday, he reiterated his government's commitment to "eradicating all forms of narcotics" from KP.

According to an official statement, the chief minister directed law enforcement agencies to launch "effective and result-oriented action" against drug suppliers and manufacturers, terming the elimination of narcotics "a foremost priority" of his administration. He stressed that protecting youth from drug abuse was a "collective responsibility" and warned that

negligence in this regard would not be tolerated. Political observers note that narcotics cultivationparticularly in Tirrah valley, which connects Khyber, Orakzai and Kurram districts with Afghanistan's Nangarhar and Logar provinces-is not a new phenomenon. The region has historically witnessed poppy growth, with international attention intensifying during the Afghan war.

Reports released by the US Task Force on Terrorism and Narcotics in 1989 90 had cited the involvement of various Afghan groups and some Pakistan-based individuals in narcotics production and trafficking. Later, a 1991 92 documentary by a German broadcaster also alleged the participation of certain regional politicians in the illicit trade. Afridi's supporters, PTI workers and members of the Afridi tribe have strongly reacted to the recent media narratives, terming them a "baseless and targeted campaign." A group of tribal youths also expressed concern over what they described as "a planned attempt to malign an entire community.'

India says examining Bangladesh request for Hasina's extradition

Ex-Bangladesh PM Hasina remains in hiding in India since her autocratic rule was overthrown in August 2024

NEW DELHI: India is examining a request from Bangladesh for the extradition of the country's former Prime Minister Sheikh Hasina, the Indian foreign ministry spokesperson said on Wednesday. The request – first made in December and reiterated this month after Hasina was sentenced to death for her role in the killing of student protesters last year - was being examined in India as part of ongoing internal judicial and legal processes, he said.

Hasina fled to India in August 2024 at the height of the protests. Bangladesh's government said on Sunday it had asked New Delhi to extradite Hasina, 78, who has been in hiding in India since her autocratic rule was overthrown in August 2024. As prime minister, she had had New Delhi's

backing. Following the court ruling on Monday, convicting Hasina of crimes against humanity and sentencing her to death, the foreign ministry in Dhaka said in a statement that Delhi had an "obligatory responsibility" under a bilateral treaty to facilitate the former leader's return.

Bangladesh has been in political turmoil since the end of Hasina's rule, and violence has marred campaigning for elections expected in February 2026. The United Nations said up to 1,400 people were killed in crackdowns as Hasina tried to cling to power, deaths that were central to her trial. India's past support for Hasina has frayed relations between the two neighbours since her overthrow. But tensions appear to have eased slightly when Bangladesh's National Security Adviser Khalilur Rahman visited India this week for a regional security summit and met with his counterpart Ajit Doval. Media reports in Bangladesh said Rahman has invited Doval for a visit.

Flash floods leave 29 dead in Indonesia's North Sumatra

JAKARTA: 29 people have been killed after flash floods and landslides struck multiple regencies and cities across Indonesia's North Sumatra province, a local official said on Thursday. Sri Wahyuni Pancasilawati, head of emergency handling, equipment, and logistics at the provincial Disaster Management and Mitigation Agency, said the disasters also left 67

people injured and nine others missing. "The total casualties are 29 people, with nine others missing. The figures may rise as risk assessment is still being carried out," she told Xinhua by phone. The disasters destroyed more than 400 houses, several bridges, and various public infrastructure facilities. Over 7,000 residents have been forced to flee their homes and take shelter, according to her. States of emergency have been declared in the regencies of Mandailing Natal, South Tapanuli, and North Tapanuli, she added.
