India airspace blockade delays Pak aid for Sri Lankans

ISLAMABAD: Pakistan's humanitarian mission to assist cyclone-hit Sri Lanka has been delayed after India refused to allow the use of its airspace for the delivery of aid, creating an unexpected obstacle for the relief effort. A 45-member Urban Search and Rescue team of the Pakistan Army - prepared for deployment through a C-130 aircraft with the support of the National Disaster Management Authority (NDMA) and the Pakistan Air Force - was ready to depart for Sri Lanka. However, the mission could not proceed after India declined airspace permission for what Pakistan termed a purely humanitarian operation. Efforts to send 100 tonnes of aid through commercial cargo aircraft have also stalled, as these flights too require passage through Indian airspace. With New Delhi's refusal, the dispatch of relief goods has slowed significantly, forcing Pakistan to send the supplies via sea – a route that will take approximately eight days to reach Sri Lanka.

Cop martyred, six injured in Lakki Marwat

PESHAWAR: At least one police personnel was martyred and six others injured in a suicide blast targeting a police mobile in Lakki Marwat district of Khyber Pakhtunkhwa on Monday. The suicide bomber, accompanied by his accomplice, was standing by the roadside and blew himself up as the police mobile drove past in the Bakhmal Ahmadzai area of Lakki Marwat, said the police. After being informed, the police and rescue officials rushed to the scene and shifted the body and the injured to the hospital. The bomber's accomplice managed to escape after the attack, the police said, adding that a search operation was underway to arrest the suspect. Talking to the media, Lakki Marwat district police officer (DPO) said that the two attackers arrived at the crime scene on a motorcycle.

Inflation edges down to 6 per cent

ISLAMABAD: Inflation edged lower in November to 6.1 per cent, official data showed on Monday, easing slightly after a jump last month and staying within the finance ministry's projected range. Food items and energy spiked the inflation, measured by CPI, to 6.24 per cent in October against 5.6pc in September, the Pakistan Bureau of Statistics (PBS) reported in early November. According to a report published by PBS today, general inflation was just a touch lower than October's figures, increasing by 6.1pc on a year-on-year (YoY) basis. On a month-on-month (MoM) basis, inflation stood at 0.4pc after a 1.8pc jump in October. "SPI inflation on [a] YoY basis increased by 4.2pc in November 2025, as compared to an increase of 4.8pc a month earlier and an increase of 7.3pc in November 2024," the report read.

Army Staff (COAS), at General Headquarters Rawalpindi. Both sides reaffirmed their commitment to strengthening coordination in security and strategic matters, highlighting the historic, fraternal bond between Pakistan and Egypt.

ISLAMABAD: Interior Minister Mohsin Naqvi has rebuffed widespread speculation regarding the delay in issuance of the notification of the Chief of Defence Forces (CDF) - a top military post created under the recently passed 27th Constitutional Amendment – saying that creation of a new system cannot be done simply by "pressing a button". "[...] let these people speculate for a few [more] days. Changes have been made to the Constitution, and a new institution is being established. They [rumour mongers] believe such things can be done simply by pressing a button. 
Official process underway, says law minister

Pakistan's economic potential hinges on managing population

ISLAMABAD: Federal Minister for Finance and Revenue, Senator Muhammad Aurangzeb, while chairing a session titled "Accelerating Economic Growth for a More Optimal Balance" on the opening day of the two-day "The Pakistan Population Summit 2025" in Islamabad today, underscored that climate change and population growth remain the two most critical existential challenges for Pakistan.

He said that while the government continues to focus on economic recovery and the transition from stabilisation to growth, the country's long-term potential envisioned in various studies projecting Pakistan as a three-trillion-dollar economy by 2047, cannot be realised without addressing these core issues. He acknowledged the leader-



ship role played earlier in the year by the Dawn Media Group in building public discourse on climate change and noted that population must now be approached with the same seriousness. The Minister stressed that Pakistan has long understood the "what" and the "why" of population challenges, and that the real task now lies in the "how" of implementation. Drawing parallels with global engagements on climate financing, he said that while technical ministries lead on policy, it is ultimately finance ministries that mainstream these issues through budgeting and planning. He expressed hope that the sessions over the next two days would collectively produce actionable pathways for implementation. Senator Aurangzeb welcomed the inclusion of sensitive yet essential dimensions

Crackdown against traffic violators intensified

MULTAN: Following recent directives from the Punjab government to take strict action against traffic violators. the City Traffic Police (CTP) in Multan issued 8,773 challans and collected Rs. 6.63 million in fines during a three-day crackdown from November 27 to 30, 2025.

The intensified operation focused on violations identified by the provincial government as key contributors to road accidents.

to the per-According formance report, 1,125 motorists were fined for driving without a license, resulting in penalties totaling Rs. 640.700. Another 456 challans, worth Rs. 139,200, were issued for non-standard number plates. Helmet violations were also a significant issue, with 1,339 motorcyclists fined a total of Rs. 2.678,000 for riding without helmets. The crackdown went beyond routine ticketing, with 1,258 vehicles impounded and 954 drivers arrested. FIRs were registered for serious traffic breaches.-APP

NCCIA unearths notorious blackmailing network


PESHAWAR: The National Cyber Crime Investigation Agency (NCCIA) Peshawar has uncovered a dangerous blackmailing network following a complaint filed by a woman The agency registered a case, arrested the suspect and initiated further investigation. According to NCCIA officials on Monday, the complaint was filed on November 25 by the brother of the victim, Haris Masaleh, During the investigation, the woman revealed that the accused, Imran, contacted her and lured her into trusting him by falsely promising marriage. He then obtained her photos and videos, which he later used for blackmail. The accused also demanded Rs 2 million from the woman's brother and brother-in-law, Mujeeb, threatening to release her videos on websites and share them with family members if the money was not paid. Evidence showed that the suspect even sent one of the videos to her brother-in-law to pressure them into paying the extortion amount.-APP

Minister reveals major drug bust in Karachi

KARACHI: Sindh's Home Minister Zia-ul-Hassan Lanjar, Excise and Taxation Minister Mukesh Kumar Chawla. and senior police officials on Monday jointly briefed the media at the Karachi Police Office, announcing what they described as the biggest anti-narcotics operation in the history According to the Home Minister, the Special Investigation Unit (SIU) carried out major raids in Gulistan-e-Jauhar and Pak Colony, recovering 508 kilograms of narcotics. The seized drugs are estimated to be worth around Rs 280 million. Police arrested 14 suspects during the operation. Officials said all of them belong to Balochistan and have previously been detained in similar drug-related cases. Police added that 50 kilograms of narcotics were recovered from the home of a drug dealer identified Saif-ur-Rehman, alias Pappu. His disclosures led to the arrest of Assistant Excise & Taxation Officer Javed Rasheed from the Excise Narcotics Control Wing. where 10 kilograms of ice and hashish were seized from his residence. Excise Minister Mukesh Chawla acknowledged that several Excise Department personnel were found involved in drug trafficking. So far, 28 employees have been arrested and dismissed

OGRA hikes LPG price by Rs87 per cylinder for Dec

ISLAMABAD: The Oil and Gas Regulatory Authority (OGRA) has increased the price of Liquefied Petroleum Gas (LPG) for December 2025, pushing up the cost of the essential household fuel for millions of consumers nationwide amid winter season

According to the notification issued on Monday, the maximum consumer price of LPG has been set at Rs 208.991.40 per metric ton, compared to Rs 201,600.43 per ton in November. This reflects an increase of Rs 7,390.97 per ton.

For households - who commonly buy LPG in 11.8 kg cylinders - the revised rate translates into a price of Rs 2,466.10 per cylinder, up from Rs 2,378.89 last month. Consumers will representing a monthly increase of 3.66% OGRA attributed the upward revision to two global and financial factors. The Saudi Aramco Contract Price (CP), which directly influences Pakistan's LPG producer price, rose by 4.93% this month. Additionally, a 0.15% depreciation in the average US dollar exchange rate contributed to

higher import-linked LPG rates. The producer price has also been revised upward, with the cost increasing from Rs 160,300.43 per ton in November to Rs 167,691.40 per ton in December. This reflects the same increase of Rs 7,390.97 per ton and an impact of Rs 87.21 per cylinder at the producer level. The detailed breakdown shows that the maximum LPG consumer price includes the producer price with GST, plus Rs 35,000 per ton in marketing, distribution margin, and transportation charges. The new producer price with GST stands at Rs 167,691.40, while the marketing and distribution charges contribute to the final consumer rate of Rs 208,991.40 facing rising winter-season energy costs, the increase in LPG rates adds further pressure on households - especially in regions without access to natural gas. LPG remains the primary cooking and heating fuel in millions of Pakistani homes, making any increase in its price immediately felt by low-

and middle-income households. OGRA stated that the revised prices are effective December 1, 2025 and will remain in place for the month unless revised due to global market fluctuations. LPG is widely used across Pakistan, especially in areas where natural gas is unavailable or unreliable. Millions of households rely on LPG for cooking, room heating, and water heating, particularly during the winter when gas load-shedding increases. In rural and mountainous regions such as Gilgit-Baltistan, Azad Kashmir, Balochistan, and remote villages without pipeline networks, LPG serves as the primary fuel source. It is also used commercially tandoors, bakeries, and small businesses, while small industries utilize it for heating, cutting, and processing. Due to its portability and easy availability, LPG remains an essential energy option for both domestic and commercial consumers across the country.-DNA

Sindh okays Rs 6.6b railway project, blacklists fraudulent firm

KARACHI: Sindh Chief Minister Syed Murad Ali Shah, while presiding over a cabinet meeting, discussed and decided on 27 agenda items, including approving the release of Rs6.6 billion for constructing a railway line from Thar Coalfield to Chhor, ordering the blacklisting of a company involved in alleged fraud in the solar project, and endorsing the use of brownfield sites with strategies to attract carbon finance and prioritise climate-friendly solutions The cabinet also granted an extension for the deployment of Pakistan Rangers in Karachi and approved a reduction in water rates for DHA from Rs0.75 per gallon to Rs0.60 per gallon. The meeting, held at CM House, was attended by provincial ministers, advisers, special assistants, Chief Secretary Asif Hyder Shah, and other relevant officers. The Cabinet considered a proposal from the Local Government Department regarding the revision of the water sale rate applicable to the project "Laying of Pipeline from Dumlottee to DHA and Construction of Pumping Station, Forebay, Filtration Plant and Ancillary Works (through Government-to-Government Agreement)." Originally, the KWSC set a water sale rate of Rs. 0.85 per gallon for supply to DHA, as approved by the Cabinet and made a condition precedent for the Sindh government's loan assistance of Rs10.566 billion towards the project's completion. Following negotiations with DHA, KWSC proposed revising the water sale rate to Rs. 0.60 per gallon while retaining the payment schedule of 10 years. The revised rate seeks to balance affordability for DHA - already supplying water at Rs. 0.75 per gallon through bowsers - with the project's financial sustainability. The Cabinet approved the revised water sale rate of Rs. 0.60 per gallon for DHA. Digitalisation of authenticated Record of Rights & e-transfer of land titles. The Sindh Cabinet, in principle, has approved a groundbreaking project aimed at overhauling the province's land management. This project, led by the Board of Revenue, assigns Sukkur IBA University the task of developing and implementing a digital land record system. In its pilot phase, data entry work is nearly complete, and there is a clear plan to extend this digitisation effort to every district within three years. At the core of these changes, the government will first verify and rewrite all current land records, moving them into a blockchain-based digital database. Sukkur IBA University will handle both software creation and technical support to keep the project on track. A new Sindh Land Records Authority will supervise this transition and ensure land transfers become fully digital. The platform integrates with national bodies like NADRA and the FBR and uses GIS mapping to visualise land boundaries. The new system introduces an online portal where people will upload documents, verify their identities using biometrics, pay fees, and receive a digital land title all securely recorded on the blockchain To make this happen, the government is proposing updates to existing land revenue laws, paving the way for digital management and electronic title transfers. The CM directed the Board of Revenue (SMBR) to prepare a bill and bring it to cabinet to review and, if passed, set up a transparent, fully digital land registration process for Sindh.-DNA

ICCI calls meeting against CDA's crackdowns, mulls shutter down strike

ISLAMABAD: The leadership of the Islamabad Chamber of Commerce and Industry (ICCI) has announced an emergency meeting of all industrialists and traders of Islamabad on Tuesday, December 2, 2025, at 3:00 p.m. at the Chamber House. The session aims to chalk out a decisive future course of action against the Capital Development Authority (CDA) in light of its ongoing unjustified raids on industries and commercial establishments across the capital The Chamber noted that the business community is already deeply frustrated and disheartened due to the unilateral, oppressive, and anti-business actions being taken under the directives of the Chairman CDA which have led to the closure and shifting of industries, ultimately causing irreparable financial losses and long-term damage to Islamabad and country's economic landscape. ICCI leadership said it appeared as though the Chairman CDA was deliberately undermining the pro-business policies of Prime Minister Muhammad Shehbaz Sharif, acting on one pretext or another to disrupt industrial and commercial operations instead of facilitating them because whenever the economy is on the verge of takeoff some hidden hands come out to hinder it. During the last three days alone, the CDA's Enforcement Directorate has conducted multiple raids without any prior notice, sealing industrial units in an abrupt and heavy-handed manner. These coercive actions have caused severe financial harm, created an atmosphere of fear and uncertainty, and resulted in immense disrespect and harassment for the business community. The Chamber strongly condemned these measures, calling them unacceptable, unjustified, and detrimental to the already challenging business environment in the federal capital. The emergency meeting will be addressed by ICCI President Sardar Tahir Mehmood.

40,000 people living with AIDS in KP: Dr. Tariq

PESHAWAR: Around 40,000 people in Khyber Pakhtunkhwa (KP) are currently living with HIV/AIDS, while 15 to 20 new cases are being registered on a daily basis.

Dr. Tariq Hayat Taj, Director of the Provincial AIDS Control Program shared these alarming statistics during a media briefing at the Peshawar Press Club on World

AIDS Day on Monday. He said 9,800 HIV/AIDS patients are registered in KP, but the actual number is much higher because many people avoid getting tested due to social stigma and dis-

criminatory attitudes. He emphasized that illegal clinics and unqualified practitioners are playing a major role in spreading the disease. "The Health Regulatory Authority must take strict action because this is a matter affecting society as a whole,"

he added. Dr. Hayat clarified that AIDS is no longer considered untreatable and the KP govmedication to all registered patients. Reuse of syringes, especially among drug users, is one of the major causes of transmission, he noted.

According to a UN survey, approximately 40,000 people in KP and about 330,000 across Pakistan are living with HIV/AIDS – a situation Dr. Hayat described as extremely alarming. Sharing specific data, he

said that during vaccination drives at Peshawar's Igbal Plaza and other transgender community hotspots. 197 transgenders were diagnosed with HIV/AIDS. "This caused emotional distress among them, but their treatment is ongoing," he said.

Dr. Hayat stressed that HIV can spread not only through sexual contact but also through unhygienic practices such as using contaminated blades, unsterilized equipment at hair salons and beauty parlors and Gender-wise statistics show that in KP, 60% of HIV-positive individuals are men, 30% women and 10% are transgenders and others. He urged citizens to get tested and adopt preventive measures, warning that HIV is slowly spreading into the general population as well. UNICEF Health Specialist Dr. Inamullah Khan, speaking at the event, urged the public to treat HIV nationts with respect "They deserve dignity and support because they are already vulnerable and dependent on God's mercy,' he said. IHC rejects ex-wildlife board chair's case dismissal plea

ISLAMABAD: The Islamabad High Court (IHC) on Tuesday rejected a petition filed by former chairperson of the Wildlife Management Board, Raina Saeed Khan, seeking the dismissal of a corruption case registered against her by the Federal Investigation Agency (FIA). Justice Muhammad Azam Khan dismissed the plea to quash the case. Islamabad city guide A detailed written order outlining the reasons for the rejection will be issued at a later date. This marks another legal setback for the former official. Earlier, on November 3, 2025, the same judge had rejected her application to stop the FIA's inquiry into the matter. Raina Saeed Khan had also approached the court with a separate request to prevent what she termed as "harassment" by the

FIA. However, the IHC Registrar's Office raised technical objections to this plea, which were subsequently upheld by the court. The Registrar's Office questioned the legal basis of combining a request to prevent harassment with pleas for pre-arrest bail and protection from arrest. The FIA had initiated a formal investigation against the former chairperson, which led to the registration of a case. The charges allege corruption and misuse of authority, resulting in a financial loss to the national exchequer. The case will now proceed in accordance with the law following the high court's decision to reject the petition for dismissal.It may be mentioned here that So-called climate activist Rina Saeed Khan, widely known for her role in the Supreme Court case that led to the closure of Islamabad's iconic Monal Restaurant, has hired one of the country's top legal minds to defend herself in an ongoing FIA investigation. Islamabad city guide According to official documents, Khan has submitted a power of attorney authorizing Barrister Salman Safdar, Advocate Supreme Court of Pakistan, to represent her in all legal proceedings related to the inquiry. The document grants the counsel full authority to appear, plead, file applications, receive records, and pursue all necessary legal remedies.Pakistan travel guide Sources familiar with the matter say Khan's decision to hire a high-priced, top-tier lawyer has raised eyebrows in various quarters. Critics allege that her move reflects concerns that the FIA inquiry could lead to serious legal challenges. Some officials claim that Khan may be attempting to "shield herself from possible financial misconduct findings"-allegations she has

consistently rejected. According to indi-

viduals close to the FIA investigation, the probe revolves around claims of financial irregularities during her association with wildlife-related projects. Some insiders allege that donor-funded initiatives suffered major setbacks due to mismanagement and improper financial transfers. These accusations are currently under review by investigators. While environmental groups hailed the ruling as a win for conservation of the Margalla Hills National Park, large segments of the public, business community, and civic groups strongly opposed the closure. Many accused environmental activists - including Khan - of exercising undue influence and using personal connections to secure the verdict. The decision, delivered during the tenure of then-Chief Justice Qazi Faez Isa, sparked intense debate about the balance between environmental protection and tourism development.

Education Board extends SSC form submission date

RAWALPINDI: Board of Intermediate and Secondary Education (BISE) Rawalpindi, on Monday announced a significant extension in the admission submission schedule for the First Annual Examinations 2026 The exams, which will mark the first full-scale annual matric examinations after years of pandemic-disrupted cycles, are set to begin on March 3, 2026. However, a large number of both regular and private candidates had been struggling to meet the original deadlines due to delays in result announcements, school registrations, and online portal issues. Responding to repeated requests from students, parents and school heads, the Board has pushed the deadlines well into the new year. Speaking to reporters, a BISE Rawal-

pindi spokesman confirmed that candidates can now submit their online admission forms with single fee until December 10, 2025. Those who miss this window will still have until December 23 with double fee and until January 6, 2026 with triple fee. Even after the third last date, the admission forms will continue to be accepted until February 10, 2026 with triple fee plus a daily late fine of Rs. 200, and till February 20, just ten days before the papers begin with an enhanced daily penalty of Rs. 700.0 "The decision has been taken purely in the interest of students," the spokesman said.

"We don't want any child to miss the examination just because of procedural delays", he said.

He emphasized that while the online

submission window remains open, the hard copy of the admission form, cut list (for institutions), original bank challan of MCB, and printed copy of the online submission receipt must reach the Board office by hand or registered post within the respective deadlines. "Online submission alone is not enough," he informed and added "If the hard copies are not received on time, the higher fee slab will automatically apply."

Students and private candidates have been directed to use the official portal www.biserawalpindi.edu.pk for form submission and fee deposit.

For technical or procedural help, the Board has activated dedicated helplines, including direct access to Assistant Controller (Matric).-APP

Sherry urges to address timely Pakistan's escalating population

ISLAMABAD: The 'Pakistan Population Summit' being held here aims to hold an urgent, coordinated national action to address Pakistan's escalating population, water, climate, and resource crises.

The two-day national dialogue summit organised by DawnMedia in collaboration with the Population Council brought toge-ther politicians, economists, development specialists, private sector leaders, and experts to develop a shared vision as the rising population continues to place pressure on health systems, food and water security, and employment, said a press releases issued here on Monday.

One of the key speaker Senator Sherry Rehman, the chairperson of the Parliamentary Forum on Population, in her opening address stated that "Population is a crisis of scarcity."

She described the three ticking time bombs namely "Unchecked Population growth, Water scarcity and Climate stress" as they are no longer ticking rather they have noiselessly exploded all around us. "Water is scarce in 2025, as predicted by UN; Climate is at its frontline heat as we are the most vulnerable globally; and population growth has passed the danger line. It's at 6 million more people per year. Do we wonder why, then, our children go hungry? Or our health clinics can't service the sick? Or why we have 26 million children out of school? Or where the 3 million jobs will per year come from ?", she said.

Highlighting the acute water scarcity now defining 2025, Senator Rehman stressed "Our water consumption is way higher than resources and with this population growth rate we will need 60 MAF of water by 2050 to match basic needs as the population rises toward 315 million" she emphasized that "every drop is now competing with millions of new claimants every year. She stressed that Pakistan must urgently find its "pivot of balance," noting "What are we thinking? Why are our children going hungry, out of school, and undernourished while our population growth outpaces our capacity to sustain it?", she enquired. Senator Rehman while underscoring an alarming demographic trends said that according to UNFPA, Pakistan's population has reached 241.5 million, ranking fifth largest in the world. Annual growth rate: 2.55%, among the highest in Asia. 6 million people are added every year. She warned that when population growth matches or outpaces GDP growth, every macroeconomic indicator deteriorates. A 1% increase in population growth reduces per-capita income by Rs. 35,000 annually. "If fertility is reduced to 2.1 births per woman by 2030," she said, " the per-capita income could rise by 37% and GDP growth to 3.9% by 2033." Senator Rehman stressed that population pressure is not neutral-it is a gendered public health crisis, borne overwhelmingly by women and girls. She noted that every 50 minutes, a woman in Pakistan dies from pregnancy or childbirth complications, 82% of children have been deprived of a meal according to WFP and 40% of children under 5 face stunting (World Bank). Women face a massively disproportionate burden in water collection-72% of women, especially in rural areas, spend nearly

nine hours a day fetching water. "When women carry the burden of water, food insecurity, reproductive health, and inadequate services, the scarcity vector becomes a gendered crisis," she said. She stressed that unmet need for contraception-17.3% of couples-and a contraceptive prevalence rate of only 34% fuel population momentum not by choice, but by lack of access and agency. Senator Rehman proposed to include integrating family planning into major social protection programmes that includes ensuring national coordination across ministries of health, education, women's development, social welfare, water, and climate; scaling the Lady Health Worker (LHW) Program, launched by Shaheed Benazir Bhutto, which contributed significantly to reducing fertility from 6.2 in the 1980s to 4.8 by 2000; making contraceptives affordable and easily accessible, including eliminating taxes; engaging faith leaders to emphasize responsible parenting and birth spacing, echoing the Council of Islamic Ideology's endorsement grounded in the principle of balance advocating for the proposed 10 billion population fund. Senator Rehman concluded by thanking the Dawn-Group for their support and for "helping sustain a conversation the country urgently needs." She added that "This issue demands national attention-not the burden of a single council or ministry. If we can feed our population. provide clean water, and give women agency, Pakistan can reclaim its future. I hope we continue to address this sub-

ject at the highest level".-DNA

Cataract burden rising with diabetes, weak rural access

RAWALPINDI:Pakistan's cataract burden continues to rise despite an expansion in treatment facilities, driven by the fast-growing diabetes epidemic, an ageing population, malnutrition, ultraviolet exposure and late diagnosis. Prof Dr Sabihuddin Ahmed, Head of the Cataract Department at Al Shifa Trust Eve Hospital, said these pressures are outpacing the system's ability to deliver timely care, especially in areas with limited specialist coverage. He said closing the treatment gap requires a shift toward decentralized services, including mandatory

screening for diabetic patients and integrating basic eye exams into primary healthcare networks. He said doctors under the Al Shifa network carry out about 8500 free cataract surgeries every month across six hospitals. This expansion is donor-supported but remains insufficient as diabetes driven cataract rises. Pakistan ranks first globally in diabetes prevalence with 34.5 million adults suffering from the disease, which could reach 70.2 million by 2050. Provincial prevalence stands at 16 percent in Punjab, 15 percent in Baluchistan, 14 percent in Sindh, and 11 percent in Khyber Pakhtunkhwa. About 230000 Pakistanis die annually due to diabetes

Talking to the media, Prof Ahmed said the cataract surgical rate is

now more than double the 2002 level, yet millions remain untreated. There are about 570000 adults blind from cataract and 3.56 million with visual issues. Meeting needs by 2030 will require at least 1.84 million surgeries annually. He said economic losses are widening because untreated cataract reduces labour participation, lowers household productivity, and increases dependency among older earners. WHO estimates show global productivity losses of 411 billion dollars from vision impairment. IN Pakistan, the private sector performs 42.4 percent of surgeries, NGOs 39.9 percent, and the public sector 17.7 percent, keeping most of the

burden on non-state providers. Pakistan has only 15 ophthalmologists per million population, far fewer than in developed countries. Many districts have none, and most specialists are urban-based, limiting rural access. He said women face mobility barriers, fewer financial resources, and delayed hospital visits, resulting in higher untreated cataracts. Private surgery costs remain a major barrier, while public hospitals struggle with outdated equipment and long queues. He said provincial health systems should adopt routine diabetes screening, embed eye care in basic health units, and expand training to prevent avoidable blindness.


Saira enthralls Islamabad with spellbinding opera performance

Prime suspect in Martyr ASI case killed

Trump has delivered tangible results to the region

THE intensity of American reactions to President Donald Trump remains intriguing. I saw it in Boston among both students and faculty during the traumatic 2016 elections. His victory was totally unexpected and there was an emotional, almost visceral response that transcended normal political disagreement. He was the establishment's worst nightmare and they projected all sorts of fears on to him. The same goes with the media. And this is still the case in his second term, with the polarization persisting beyond what I would consider rational. Trump is unpredictable, full of contradictions, breaks every rule and it is sometimes difficult to interpret what he means from what he says. I have made the effort. I listened to 20 interviews conducted with Trump by the journalist Bob Woodward while on mountain hikes in Greece and I may have gotten a feel of some patterns. But I still cannot claim to understand him.

No matter. We in the Middle East do not share America's emotional extremes about Trump. As allies who depend on American partnership, the region's leaders have to adjust and build a working relationship with whoever is in power. What concerns us more is the polarization itself - when foreign policy swings dramatically with each administration for what seem like purely domestic reasons. Trump may represent something genuinely revolutionary in American politics – a fundamental challenge to established norms and institutions. In the 2020 election, Joe Biden received more than 90 percent of votes in Washington. This demonstrated how uniformly the permanent bureaucracy opposed Trump. The intelligence agencies, diplomatic corps, civil service, media and universities aligned against him with remarkable consistency. Trump's method is familiar to people around the Mediterranean but totally alien to societies like those in Northern Europe or the US.

Trump's response was to bypass these institutions entirely, conducting governance through personal relationships rather than bureaucratic channels. His supporters see liberation from entrenched bureaucracy; his opponents see threats to democratic guardrails. The intensity reveals deeper conflicts about who holds power and how it should be



exercised. Trump did not create America's divisions, rather he has exposed existing fault lines in the most unexpected places. What makes Trump revolutionary is his willingness to violate every convention. He dramatically says things that provoke outrage. He bypasses normal policy processes, makes announcements via social media and uses undiplomatic language. There is a parallel to Silicon Valley, which emerged by breaking established rules and challenging administrative authority. Rules can protect necessary standards but they can also become barriers preserving existing power structures. Americans struggle with the question: Which rules did Trump break that were arbitrary constraints and which were fragile pillars of the democratic process?

Trump operates through personal relationships, loyalty and dramatic gestures rather than institutional process. This is a method that is familiar to people around the Mediterranean but totally alien to societies like those in Northern Europe or the US. A parade of foreign leaders has been subjected to live Oval Office meetings. These would have normally been polite diplomatic photo ops for the media, but Trump turned them into reality TV on a dramatic scale. During Trump's recent meeting with Crown Prince Mohammed bin Salman, the crown prince stood firm about Saudi Arabia's conditions for normalization with Israel. Trump's relational, theatrical approach is more Mediterranean or Middle Eastern than American institutional style.

From a regional perspective, Trump has delivered tangible results. Ending the Gaza war should have happened much earlier, but he did it as he said he would. While experts and political rivals often mock Trump's foreign policy approach, he also delivered the Abraham Accords. Trump ignored the experts as well as the rules and whatever consensus stood in the way. He pursued direct relations with leaders, whether in Israel or the UAE, Bahrain, Sudan or Morocco. He achieved what generations of traditional diplomacy could not.

His relationship with the crown prince has followed similar patterns - partnership rather than patronage. His earlier withdrawal from the Iran nuclear deal aligned with regional security concerns. His current Gaza ceasefire efforts continue the same approach: personal engagement and dramatic gestures in pursuit of the deal.

Arab policymakers have achieved significant gains under Trump – the Abraham Accords, partnership resets and maximum pressure on Iran. Yet, even while welcoming these moves, they have maintained careful contact with the Democratic Party, understanding that the pendulum will swing. The fundamental question is: Is America reliable when its foreign policy reverses completely every four to eight years based on domestic cultural wars that are unrelated to the region?

Population: the silent crises

OPULATION management is often misunderstood as an attempt to control reproduction. It is rather a broader strategy to harmonize population growth with national resources, economic capacity, and quality of life. It includes shaping demographic trends through education, health strategies, urban planning, economic incentives, and behavioral change, aiming not merely for fewer people, but for better-prepared, better-educated, and more productive populations. Many countries faced population challenges in recent past and tackled them effectively. For instance, China initially used restrictive policies like the one-child law, but in recent years shifted to encouraging births due to aging demographics, showing that population policies must adapt over time. Bangladesh successfully reduced its fertility rate through grassroots education, community-based female health workers, and empowering women economically not just by providing contraceptives. Iran drastically lowered fertility rates in the 1990s through premarital family planning courses, high literacy among women, and widespread reproductive health awareness.

While a young population can be a strategic asset, it becomes a burden when job creation does not match workforce growth, education systems are overstretched, urban infrastructure is overloaded, healthcare resources are limited and agricultural never happens with a magic wand. land shrinks while food demand rises

Pakistan's population grows by roughly 2% annually, meaning we add around 4 million people each year, equivalent to another Karachi every decade. No economy, however ambitious, can absorb such increases without pressure on housing, employment, and public services. For Pakistan, the issue is not just population size; it is quality. Too many births occur in households unable to afford education, healthcare, or nutrition perpetuating cycles of poverty.

Why did past policies and population management plans fail? Pakistan has introduced many policies, written many frameworks, and signed many declarations. Yet implementation lags for key reasons like i) cultural and religious sensitivities; as family planning is often misunderstood as anti-family or anti-faith, ii) low female literacy; studies have established the fact that women's empowerment strongly correlates with reduced fertility, iii) weak health communication: policies exist on paper but don't reach rural communities effectively, iv) inconsistent political will because government restarts the conversation rather than continuing a long-term roadmap, v) perception of children as economic security; as in poor households, more children mean more potential earners, vi) rural-urban disparity; stats show that urban fertility is declining, while rural fertility remains high. Though each reason is a contributing factor and needs serious deliberation, but in the context of Pakistan cultural/religious sensitivities and women empowerment appears to be a larger contributor to the problem.

Our policy makers and executors must recognize the fact that population management is far more than distributing pills, devices, or running isolated and irregular campaigns. It is about changing mindset, and indeed it

Changing the mindset of a society is a gradual, layered process that involves education, leadership, cultural evolution, and real-life demonstration of improved outcomes. It begins with awareness, where people are introduced to new perspectives through public dialogue, evidence-based communication, media engagement, and educational content. The next step is community-level engagement, because mindsets rarely shift through national messaging alone. Trusted figures such as teachers, religious scholars, community elders, and healthcare workers play a central role in reshaping norms. When messages are delivered through familiar voices, they carry greater legitimacy and acceptance. Then comes policy alignment and leadership example. Government programs, school curricula, economic incentives, and local support systems need to reinforce the desired values: it signals that the mindset shift is not just aspirational but institutional. Another critical phase is real-life reinforcement. When smaller families witness improved household stability, better child development, financial relief, and upward mobility, these visible improvements validate the mindset shift. Others observe these results and replicate the choices. Finally, the mindset truly transforms when it becomes self-sustaining; when societal norms, peer expectations, and cultural identity begin endorsing the new thinking. Over time, what once required persuasion becomes common sense, and society internalizes a new vision of progress, opportunity, and responsible planning. Look at history, social mindset never changed with a magic wand, but with clarity, commitment and consistency.

The big question is, who is going to do it? And simple answer is 'WE', the people.

Swamy's Tweet Leaves Modi Exposed

UBLIC life, especially in South Asia, has long been shaped by the uneasy intersection of personal morality, political authority, and the public's expectation of virtue from those who govern. In recent days, Indian politics has been unsettled by a series of remarks posted on X (formerly Twitter) by veteran politician and economist Subramanian Swamy. In one such post, Swamy suggested that "It will be difficult for Modi to avoid the Blackmail of US and Modi, using the ugly sex revelations of Hardip Puri, Modi's former Cabinet Minister. Modi claims to be a Brahmachari, but in truth he is a Bachelor who has had flings with women, willing or unwilling. The US agencies have the photos to blackmail. This hurts India's national interests".

The idea that the personal life of a national leader might intersect with matters of state is neither new nor unique to India. Yet Swamy's intervention carries weight because it comes from a figure long known for his insider knowledge, frankness, and unpredictability. Whether one agrees with his assertions or dismisses them as political provocation, they have undeniably opened a debate on the delicate boundaries between private conduct and public responsibility. In a geopolitical environment as complex as India's, even the perception that a leader could be susceptible to external manipulation becomes a matter of strategic concern. India's political history offers numerous examples where the personal lives of national icons were woven-fairly or unfairly-into political narratives. Mahatma Gandhi's lifelong experiments with celibacy remain a subject of historical debate, puzzling admirers and critics alike. What differentiates the present moment from earlier eras is the unprecedented power of digital communication. A comment posted online-whether measured or reckless—can shape global perceptions within minutes. Allegations that once required months of political manoeuvring now travel instantly, creating narratives that policymakers, diplomats, and security institutions must urgently address. Even if the underlying claims lack verification, the velocity of modern discourse ensures that their political impact precedes their factual scrutiny.

From a national security perspective, Swamy's implication-that hypothetical personal secrets could be used by foreign powers to influence India's highest office-raises disturbing questions. It suggests a scenario in which statecraft might be compromised not by ideology or policy failure but by the vulnerabilities of individuals. Such a prospect, even as a theoretical concern, invites deeper reflection on the institutional safeguards that protect democratic governance.

History shows that scandals-real, perceived, or fabricated-often become turning points in Indian politics. Indira Gandhi's Emergency-era decisions, Rajiv Gandhi's entanglement in the Bofors controversy, and the scandals involving various chief ministers all shifted political trajectories, in some cases altering the direction of the nation. When moral allegations become entangled with political contestation, they seldom remain confined to private criticism; they spill into questions of governance, legitimacy, and public trust.

The current episode, driven by Swamy's comments, may influence the future of Indian politics in several possible ways. First, it may intensify internal tensions within the ruling party, especially if the controversy

saw regional leaders ensnared in scandals, some fuels debates over leadership direction, succession, or ideological purity. Second, it may embolden opposition parties to frame new narratives around transparency, accountability, and character, themes that have often resonated with India's middle and urban classes. Third, it may shape India's diplomatic posture if foreign governments perceive political fragility or internal discord at the top.

Yet beyond the immediate political ripples lies a broader truth; modern democracies often expect their leaders to embody moral perfection, even though history repeatedly shows that statesmen, like all human beings, are complex, flawed, and sometimes contradictory. The danger lies not in acknowledging this humanity but in allowing unverified allegations to overshadow critical issues of policy, governance, and national strategy. When political discourse becomes dominated by personal insinuation rather than substantive debate, the democratic process itself is diminished. India today aspires to great-power status, seeking a central role on the global stage. Such ambition requires political stability, institutional maturity, and a leadership that commands confidence both domestically and internationally. Allegations—whether rooted in fact or born of rivalry-must therefore be handled with seriousness, transparency, and due process. Neither blind acceptance nor dismissive rhetoric strengthens the nation; only truth, accountability, and institutional robustness do. Whether Swamy's remarks prove to be a fleeting controversy or a catalyst for deeper political shifts will become clear in time. What already stands revealed, however, is the immense power of digital communication to reshape national conversations and the enduring importance of integrity-both perceived and real-in the life of a democracy. In India's political theatre, where personalities are as consequential as policies, the intersection of private life and public duty will remain a subject of scrutiny, speculation, and debate for years to come.

YLIAN Mbappe has become the second Real Madrid player, after Cristiano Ronaldo, to score 53 or more goals in a calendar year. The Frenchman achieved the milestone during a 1-1 draw against Girona, scoring the goal for his team. Mbappe is in brilliant form and continues to break or match the records of his idol, Ronaldo at Madrid, and added another one on Sunday, November 30. The Frenchman achieved the landmark in his first full calendar year with the Spanish club; the Portuguese star has done it five times in his nine seasons at the club. The achievement comes just days after Mbappe joined an exclusive list of four players who scored four goals in a UEFA Champions League match for Real Madrid. The former PSG player netted the ball four times in a match against Olympiacos on November 27. Ronaldo did it against Malmö in the 2015/16 campaign. In the same match, the French striker also broke Ronaldo's record of fastest hat-trick, scoring it in seven minutes. While the Portugal captain had done it in 11 minutes against Malmö in an 8-0 win in 2015/16. Kohli hits century as India beat SA in first ODI

Virat Kohli's Record 52nd ODI Century Powers India to Thrilling 17-Run Victory Over South Africa as Kuldeep Yadav Shines and Late Fightback Falls Short in High-Scoring Series Opener On Sunday

RANCHI: Star batsman Virat Kohli hit a record-extending 52nd one-day century to set up India's 17-run win over a spirited South Africa in the first match on Sunday. Kohli's 135 came off 120 balls and he shared a second-wick-

et partnership of 136 with fellow stalwart Rohit Sharma to set India on course for 349-8 in the eastern city of Ranchi. Corbin Bosch made a valiant 67 off 51 balls as South Africa fought until almost the end. Entering the 50th over, the visitors needed 18 for victory with one wicket left. Bosch fell on the second ball and the South Africa were 332 all out.

Matthew Breetzke, who made 72, and Marco Jansen, with 70, put on a fighting stand of 97 for the sixth wicket to revived the chase after South Africa slipped to 11-3 and then 77-4. Left-arm wrist spinner Kuldeep Yadav stood out with figures of 4-68 in the high-scoring contest. His double strike to remove Jansen and Breetzke in the space of three balls was the turning point for India who took 1-0 lead in the three-match series.

The 37-year-old Kohli remained the hero with his 83rd ton across the three international formats after he raised his hundred with a boundary off Jansen and lifted his bat to a raucous home crowd.

An Indian fan breached security and raced to the pitch to touch Kohli's feet before he was dragged away.



Kohli has the most ODI hundreds, with Indian great Sachin Tendulkar second with 49.

The Indian cricket star tops the list of hundreds in a single format with Tendulkar's count in Tests being 51.

Kohli and 38-year-old Sharma, who made 57, only play the 50-over format after they retired from T20 and Test cricket. Their presence boosted India, led by KL Rahul in the absence of the injured Shubman Gill, after a 2-0 Test white-

wash against South Africa. Sharma lost fellow opener Yashasvi Jaiswal early for 18 but Kohli walked in to a huge roar from a 38,000-strong capacity crowd. The pair steadied the innings and then took on the bowlers before Sharma was trapped lbw by Jansen. Sharma hit three sixes in his 51-ball knock. That took

him to 352 sixes in this format, overtaking Pakistan batter Shahid Afridi's recird of 351. Kohli switched gears soon after reaching his first hundred since February.

He hit off-spinner Prenelan Subrayen for two fours and two sixes in a 21-run 39th over. He finally fell to Nandre Burger, caught by Ryan Rickelton,

"Our greatest fear is that something irreversible is being hidden from us." The family has repeatedly sought access for İmran's personal physician, who has not been allowed to examine him for more than a year, he added. The interior ministry did not respond to a request for comment. Speaking on condition of anonymity, a jail official told Reuters that Imran was in good health, adding that he was not aware of any plan for a move to a higher-security facility. Khan, 72, has been in jail since August 2023, convicted in a string of cases that he says were politically driven following his ouster in a 2022 parliamentary vote. His first conviction centred on accusations that he unlawfully sold gifts received in office, in a proceeding widely referred to as the Toshakhana case. Later verdicts added lengthy jail terms, including 10 years on accusations of leaking a diplomatic cable and 14 years in a separate graft case tied to the Al-Qadir Trust, a charity project prosecutors say figured in improper land deals. Imran's party, the Pakistan Tehreek-e-Insaf (PTI), says the prosecutions aim to exclude him from public life and elections. Family anxiety deepened by lack of information The family says the lack of communication has fuelled fears over what it calls a deliberate effort to push Khan out of public sight. Dozens of Hamas fighters are holed up in southern Gaza's tunnels, beneath areas controlled by the Israeli military. Over the past 40 days, troops have been concentrating their efforts around eastern Rafah, "with the aim of dismantling the underground tunnel routes that remain in the area and bringing about the elimination of the terrorists hiding out within them", the military said in a statement. It added that "more than 40 terrorists were eliminated" in the last week. "Additionally, dozens of tunnel shafts and terrorist infrastructure sites, both above and below ground, were dismantled in the area.

Zelensky meets **Macron to** shore up support for Ukraine

PARIS: Ukrainian President Volodymyr Zelensky meets French counterpart Emmanuel Macron in Paris on Monday, seeking to shore up European support as US President Donald Trump expressed optimism of a deal to end Russia's war in Ukraine US and Ukrainian negotiators held hours of what both sides called "productive" talks in Florida on Sunday on a plan Washington wants to form the basis of a peace deal between Russia and Ukraine. The diplomatic flurry after nearly four years of conflict comes as Kyiv battles military pressure and reels from a domestic corruption scandal that forced Zelensky to remove his close aide and top negotiator. The Ukrainian leader has been a regular visitor to Paris since Russia launched its full-scale invasion in February 2022 - this latest visit due to get under way at 10:00 am (0900 GMT). French Foreign Minister Jean-Noel Barrot said in comments to the La Tribune Dimanche newspaper on Sunday that the meeting aimed "to move the negotiations forward." "Peace is within reach, if (Russian President) Vladimir Putin abandons his delusional hope of reconstituting the Soviet empire by first subjugating Ukraine," he added. Washington put forward an initial 28-point proposal to halt the war. drafted without input from Ukraine's European allies and regarded as too close a reflection of Moscow's maximalist demands on Ukrainian territory.-APP

PKK urges Turkiye to free Ocalan to advance peace process

KANDIL: A senior Kurdistan Workers' Party commander told AFP the group will take no further steps in the peace process with Turkiye, urging it to advance negotiations and free PKK founder Abdullah Ocalan "All the steps the leader Apo has initiated have been implemented... there will be no further actions taken," commander Amed Malazgirt told AFP on Saturday in a bunker in the Qandil mountains in northern Iraq. "From now on, we will be waiting for the Turkish state and they have to be the one taking steps," he said. The group has two demands, he added. "First, the freedom of leader Apo... without this, the process will not succeed. The second is the constitutional and official recognition of the Kurdish people in Turkiye." Female senior commander Serda Mazlum Gabar told AFP that "as long as the leadership is inside, the Kurdish people cannot be free. Nor can we, as guerrillas, feel free." "Our path to freedom passes through the freedom of our leadership," she added. Ocala, 76, has led the peace process from his cell on Imrali island, where he has been held in solitary confinement since 1999 Turkish lawmakers from a committee tasked with fleshing out the peace process with the Kurds visited Ocalan earlier this week. In recent months, the PKK, which maintains a rear base in the mountains of northern Iraq, has taken several historic steps toward ending its decades-old fight against Turkiye that has claimed some 50,000 lives. In May, the PKK formally renounced its armed struggle against Turkiye. It then held a ceremony in northern Iraq during which 30 fighters burned their weapons in a symbolic move to show their commitment to the peace process. Last month, the group said it had begun withdrawing all of its forces from Turkish soil into northern Iraq Earlier this month, the PKK announced their forces had withdrawn from a key border area in northern Iraq. "We have committed to not using weapons against the Turkish state," Malazgirt told AFP on Saturday. Ankara began indirect talks with the PKK late last year, with Ocalan in February urging the group's militants to lay down their weapons and embrace democratic means to advance the Kurdish cause. Turkiye has set up the cross-party parliamentary commission to lay the groundwork for the peace process and prepare a legal framework for the political integration of the PKK and its fighters. "By establishing this committee, the Turkish state has made a positive move, but it is not the only action needed. We are closely monitoring this mission," Malazgirt said. The PKK says it wants to pursue a democratic struggle to defend the rights of the Kurdish minority. But "the guerrilla is also the prototype of free life, the prototype of free humans, the prototype of free women," Serda Mazlum Gabar said.-DNA

UK special forces leaders covered up

LONDON: Senior UK special forces leaders covered up potential war crimes in Afghanistan, a former high-ranking officer has told a public inquiry probing the claims, according to evidence released on Monday The officer alleged two former directors of the special forces and others failed to act on concerns that units carried out unlawful killings while operating in the country more than a decade ago. The inquiry, which opened in 2023 at London's Royal Courts of Justice, is investigating the accusations about the special forces' conduct in Afghanistan between 2010 and 2013, including the killing of women and children. "I was deeply troubled by what I strongly suspected was the unlawful killing of innocent people," the whistleblowing officer - known only to the inquiry as N1466 said in witness testimony. He added he came "to the view that the issue of extrajudicial killings was not confined to a small number of soldiers or a single sub-unit ... but was potentially more widespread." Mansour Aziz, the uncle of two Afghan children seriously injured by UK special forces while their parents were allegedly shot dead in their beds, spoke to the inquiry in a short 2023 video, the Guardian reported. "Even to this day they are grieving the incident that happened to us... We are asking for the court to listen to these children and bring justice," he said. The whistleblower said senior officers had impeded his efforts to "do the right thing" and that he lost confidence" in their willingness to report the allegation

in a probe into the city's deadliest fire in decades, pointing to substandard renovation materials for fueling a blaze that has claimed at least 146 lives. Police have completed sweeps of four of the seven towers engulfed in Wednesday's disaster at the Wang Fuk Court estate, finding bodies of residents in stairwells and on rooftops, trapped as they tried to flee the flames. Around 40 people are still missing. Tests on several samples of a green mesh that was wrapped around bamboo scaffolding on the buildings at the time of the blaze did not match fire retardant standards, officials overseeing the investigations told a news conference. Contractors working on the renovations used these substandard materials in hard-to-reach areas, effectively hiding them from inspectors, said Chief Secretary Eric Chan. Foam insulation used by contractors also fanned the flames and fire alarms at the complex were not working properly, officials have said. Thousands have turned out to pay tribute to the victims, who include at least nine domestic helpers from Indonesia and one from the Philippines, with lines of mourners stretching

US sanctions won't Pope arrives in Lebanon change court's with message of peace for crisis-hit country handling of cases: ICC THE HAGUE: The president of the International Criminal

Court said on Monday US sanctions imposed on senior court officials disrupt their personal lives but vowed the institution would not yield to outside pressure. President Donald Trump's administration slapped targeted sanctions on nine ICC officials, including prosecutors and judges, earlier this year in retaliation for investigations into suspected Israeli war crimes. Sources have said Washington is also mulling sanctions against the entire court. "We never accept any kind of pressure from anyone on issues of interpretation of the statutory framework and adjudication of cases," Judge Tomoko Akane said on the first day of the annual meeting in The Hague of the court's governing body, made up of representatives of its 125 member states. Akane said the sanctions had unsettled the family lives of targeted officials and disrupted their financial transactions, even in ICC member states in Europe. The sanctions freeze any US assets the individuals may have and essentially cut them off from the US financial system, with which almost all internationally operating banks have close ties. The ICC has issued arrest warrants for Israeli Prime Minister Benjamin Netanyahu and former Defense Minister Yoav Gallant, as well as figures from the Palestinian Hamas militant group, for alleged crimes committed during the Gaza war. They have all denied the charges mentioned in the warrants. Washington has previously targeted court officials with sanctions for their roles in those cases and in a separate investigation into suspected crimes in Afghanistan, which initially had examined actions by US troops. The ICC was founded in 2002 under a treaty giving it jurisdiction to prosecute genocide, crimes against humanity and war crimes that were either committed by a citizen of a member state or had taken place on a member state's territory.-DNA

Lebanon rolled out the red carpet and a 21-gun salute for Leo, who was also greeted at the airport by children and a brass band as ships at the port sounded their horns. Two Lebanese military aircraft escorted his plane on descent. "I came to say that the Lebanese are one people and we are united," said Zahra Nahleh, 19, from Lebanon's war-ravaged south, who was waiting along the road from the airport to welcome the pontiff. "The pope is not just for Christians but for Muslims too, and we love him a lot," she told AFP. "We want him to bless our land, we wish he could visit the south." The two-nation tour is something of a test for the first American pope, whose understated style contrasts with that of his charismatic and impulsive predecessor, Francis. Although Leo's four-day visit drew little attention in Turkiye, a Muslim-majority nation whose Christian community numbers only around 100,000, his 48-hour stopover has been eagerly awaited in Lebanon, a religiously diverse country of around six million people. Long hailed as a model of coexistence, Lebanon since 2019 has been ravaged by successive crises, from economic collapse, to

militant group Hezbollah and Israel, which largely ended with a ceasefire last November. The last papal visitor was Benedict XVI in 2012. Christians play a key political role in Lebanon, where the post of president is reserved for a Maronite Christian - but they have seen their numbers dwindle, particularly due to emigration. Leo held talks with Aoun, Prime Minister Nawaf Salam and parliament speaker Nabih Berri at the presidential palace, and made a speech to authorities and diplomats. A group of traditional dancers welcomed him at the entry to the presidential palace despite the rain. Youth scouting groups affiliated with Hezbollah had waited to welcome the pope along the road in Beirut's southern suburbs, where the Iran-backed militants hold sway and where posters of slain chief Hassan Nasrallah appeared near billboards welcoming the pontiff. On Saturday, Hezbollah had urged the pope to reject Israeli "injustice and aggression" against Lebanon. Israel has kept up regular raids on Lebanon, usually saying it is striking Hezbollah targets, despite the truce that was supposed to end more than a year of hostilities, including two months of open war with the group. The pope said that a two-state solution was the only one likely to resolve the conflict between Israel and the Palestinians. "The Holy See has publicly backed the proposal for a two-state solution for several years. We all know that Israel still does not accept it, but we consider it the only solution likely to resolve the current conflict," he said during a brief exchange He said he discussed the issue on Thursday in Ankara with Turkish President Recep Tayyip Erdogan "who fully supports this proposal," adding that "Turkiye has an important role to play in this process."-DNA

PN evacuates family stranded in Sri Lanka floods

ongoing Humanitarian Assistance and Disaster Relief (HADR) efforts in Sri Lanka, the embarked Z-9 helicopter on Pakistan Navy Ship SAIF conducted rescue operations in the flooded Kotikawatta area. During search and rescue operation a stranded family for the last five days, including a 7-month-old infant were safely recovered from a rooftop. Subsequently, the evacuated family was transported to safe location in coordination with local authorities. The successful conduct of rescue operation is a testimony of Pakistan Navy's professionalism and commitment to international obligations. Jordan, Japan chiefs of **staff discuss** expanding COOD

LONDON: Maj. Gen. Yousef Huneiti, the Jordanian chairman of the Joint Chiefs, met his Japanese counterpart, Gen. Hiroaki Uchikura, in Amman to discuss military cooperation. The meeting held on Sunday at the General Command headquarters focused on military training, the exchange of expertise between Jordan and Japan, and regional and international issues of mutual interest. Landmine casualties swell amid ban challenges

GENEVA: New land mine use in Myanmar, Ukraine and other conflicts coupled with funding cuts for clearance saw casualty numbers surge in 2024, a monitor said Monday, warning the international ban faced "unprecedented challenges."According to the Landmine Monitor, 6,279 people were wounded or killed by land mines and explosive remnants of war (ERW) across 52 countries and areas last year. Civilians – nearly half of them children – made up 90 percent of global casualties, it said. The number of overall casualties, which included 1,945 people killed, was nearly 500 more than a year earlier and marked the highest annual figure since 2020. The report "reveals a stark reality: civilians are bearing the consequences, as efforts to clear mined areas face waning global donor support for essential humanitarian activities," the International Campaign to Ban Landmines (ICBL) cautioned in a statement. The organization also decried "unprecedented challenges" to the long-standing international ban on land mines after five NATO countries announced in March they would quit the treaty amid fears over "Russian aggression. "The norms of the Mine Ban Treaty are under direct threat as Estonia, Finland, Latvia, Lithuania, and Poland are in the process of withdrawing under the treaty's Article 20," ICBL said. It also highlighted Ukraine's attempt to "suspend" its compliance due to the conflict raging since Russia began its full-scale invasion nearly four years ago, stressing that such an action was "not permitted under the treaty." With no cash, **Sudanese** turn to barter and credit

CAIRO: Surviving in Sudan these days means going back to basics: with the banking system in ruins after more than two years of war, barter and IOUs have become the only way for many people to secure the essentials.

"I haven't held a banknote in more than nine months,' said civil servant Ali in Dilling, South Kordofan state. The town has been besieged by the paramilitary Rapid Support Forces (RSF), who have been battling the army since April 2023. In Dilling, as elsewhere, clothing and household appliances are sometimes used as currency to exchange for a couple kilos of flour or rice, or a few litres of fuel for vehicles or generators. "I once exchanged a hoe and a chair for three bags of sorghum,' a staple cereal in many parts of Africa, said Ali, 33.

With no cash and much of Sudan under a total communications blackout, many people like Ali are resorting to the barter system. "Motorcycle and tuk-tuk (motorised tricycle) drivers are given oil and soap as payment for fares," said Al-Sadiq Issa, a local volunteer contacted by AFP. "Some families offer corn, flour or sugar in exchange for things like vehicle maintenance," he added.

When fighting between the army and the RSF engulfed Khartoum at the start of the war, the Central Bank, connected to the secure SWIFT interbank network, was set ablaze and then occupied by paramilitary fighters for nearly two years. - Agencies

PADANG: The toll in deadly flooding and landslides across parts of Asia climbed past 1,000 on Monday as hardest-hit Sri Lanka and Indonesia deployed military personnel to help survivors. Separate weather systems brought torrential, extended rainfall to the entire island of Sri Lanka and large parts of Indonesia's Sumatra, southern Thailand and northern Malaysia last week. Much of the region is currently in its monsoon season but climate change is producing more extreme rain events and turbocharging storms. The relentless rains left residents clinging to rooftops awaiting rescue by boat or helicopter, and cut entire villages off from assistance. Arriving in North Sumatra on Monday, Indonesian Presi-

dent Prabowo Subianto said "the worst has passed, hopefully". The government's "priority now is how to immediately send the necessary aid", with particular focus on several cut-off areas, he added. Prabowo has come under increasing pressure to declare a national emergency in response to flooding and landslides that have killed at least 502 people, with more than 500 still missing. Unlike his Sri Lankan counterpart, he has also not publicly

called for international assistance. The toll is the deadliest in a natural disaster in Indonesia since a massive 2018 earthquake and subsequent tsunami killed more than 2,000 people in Sulawesi. The government has sent three warships carrying aid and two hospital ships to some of the worst-hit areas, where many roads remain impassable. At an evacuation centre in North Aceh, 28-year-old Misba-

hul Munir described walking through water that reached his neck to get back to his parents. "Everything in the house was destroyed because it was

submerged," he told AFP. "I have only the clothes I am wearing," he said, dissolving into tears. "In other places, there were a lot of people who died. We are grateful that we are healthy." In Sri Lanka meanwhile, the government called for international aid and used military helicopters to reach people stranded by flooding and landslides triggered by Cyclone Ditwah.

At least 340 people have been killed, Sri Lankan officials said on Monday, with many more still missing.

Floodwaters in the capital Colombo peaked overnight, and with rain now stopped there were hopes that waters would begin receding. Some shops and offices began to reopen. The floodwaters came as a surprise to some around Colombo. "Every year we experience minor floods, but this is something else," delivery driver Dinusha Sanjaya told AFP. "It is not just the amount of water, but how quickly everything went under." Officials said the extent of the damage in the worst-affected central region was only just being revealed as relief workers cleared roads blocked by fallen trees and mudslides. President Anura Kumara Dissanayake, who declared a state of emergency to deal with the disaster, called the flooding the "largest and most challenging natural disaster in our history." The losses and damage are the worst in Sri Lanka since the devastating 2004 Asian tsunami that killed around 31.000 people there and left more than a million homeless. – **Agencies**

India orders smartphone makers to preload stateowned cyber safety app

INDIA'S telecoms ministry has privately asked smartphone makers to preload all new devices with a state-owned cyber security app that cannot be deleted, a government order showed, a move likely to antagonise Apple and privacy advocates.

India is one of the world's largest telephone markets, with more than 1.2 billion subscribers, and government figures show the app, launched in January, has helped recover more than 700,000 lost phones, including 50,000 in October alone.

Apple, which has previously locked horns with the telecoms regulator over development of a government anti-spam mobile app, is among the companies, such as Samsung, Vivo, Oppo and Xiaomi, bound by the new order. The November 28 order, seen by Reuters, gives major smartphone companies 90 days to ensure that the government's Sanchar Saathi app is pre-installed on new mobile phones, with a provision that users cannot disable it. For devices already in the supply chain, manufacturers should push the app to and was sent privately to select companies. The government said the app was essential to combat "serious endangerment" of telecom cyber security from duplicate or spoofed IMEI numbers, which enable scams and network misuse.

Apple's iOS powered an estimated 4.5% of 735 million smartphones in India by mid-2025, with the rest using Android, Counterpoint Research says.

Telecom cybersecurity: While Apple pre-installs its own proprietary apps on phones, its internal policies prohibit the installation of any government or third-party app before sale of a smartphone, a source with direct knowledge of the matter said.

"Apple has historically refused such requests from governments," said Tarun Pathak, a research director at Counterpoint. "It's likely to seek a middle ground: instead of a mandatory pre-install, they might negotiate and ask for an option to nudge users towards installing the app." Apple, Google, Samsung and Xiaomi did not respond to requests for comment. India's telecoms ministry also did not respond. A 14- to 17-digit number unique to each handset, the IMEI, or International Mobile Equipment Identity, is most commonly used to cut off network access for phones reported to have been stolen. -Agencies

PTI protest, Prosecutor Zaheer Shah told the court that Aleema's CNIC number had been sent to the State Bank with the request to freeze her personal bank accounts. British MP Tulip Siddig handed two-year prison sentence in **Bangladesh graft case**

Court also sentences lawmaker's aunt, ex-Bangladesh PM Sheikh Hasina, to five years

DHAKA: A Bangladesh court sentenced British parliamentarian and former minister Tulip Siddiq to two years in jail in a corruption case involving the alleged illegal allocation of a plot of land, local media reported. The verdict was delivered in absentia as Siddiq, her aunt and former Bangladesh Prime Minister Sheikh Hasina, and Hasina's sister Sheikh Rehana all co-accused in the case - were not present in court. Hasina was sentenced to five years in jail and Rehana to seven, the local media reports said. Hasina, who fled to neighbouring India in August 2024 at the height of an uprising against her government, was sentenced to death last month over her government's violent crackdown on demonstrators during the protests.

Last week, she was handed a combined 21-year prison sentence in other corruption cases. Prosecutors said that the land was unlawfully allocated through political influence and collusion with senior officials, accusing the three powerful defendants of abusing their authority to secure the plot, measuring roughly 13,610 square feet, during Hasina's tenure as prime minister.

Most of the 17 accused were absent when the judgement was pronounced. Siddiq, who resigned in January as the UK's minister responsible for financial services and anti-corruption efforts following scrutiny over her financial ties to Hasina, has previously dismissed the allegations as a "politically motivated smear". Britain does not currently have an extradition treaty with Bangladesh. - Agencies
