UN chief urges fresh global action on refugees

NEW YORK: UN Secretary-General Antonio Guterres on Monday urged renewed international action on the refugee crisis, warning the situation has deteriorated since the last Global Refugee Forum as conflicts grow, displacement rises, borders tighten and humanitarian funding is cut, Anadolu reported. The second Global Refugee Forum Progress Review, organised by the UN Refugee Agency (UNHCR) and the Swiss government, has begun in Geneva, with Guterres addressing partici pants via a video message.

He called for stronger back ing for countries hosting refugees, noting that low- and middle-income nations shelter nearly three-quarters of the world's displaced people. Guterres also urged governments to do more to include refugees in local economies and support self-reliance. "We must boost refugee inclusion and self-reliance a dignified way to unlock human potential," he said, adding that it could strengthen local economies and reduce dependence on aid.

Mazari case Witnesses statements afresh: IHC

IHC's Justice Mohammed Azam Khan passed the directives while hearing a petition filed by Mazari challenging the trial court's November 19 order, when the court had recorded the testimonies of all prosecution witnesses. Chattha had appeared before the court while Imaan's lawyers had marked her presence. The court, however, had ordered the prosecution to proceed with the witnesses' testimonies. On Tuesday,

BANGKOK: Thailand said Tuesday that Cambodia must be first to announce a truce to halt fighting between the two nations after more than a week of deadly clashes in a reignited border conflict. "As the aggressor onto Thai territory, Cambodia must announce the ceasefire first," Thai foreign ministry spokeswoman Maratee Nalita Andamo told reporters in Bangkok, adding that Cambodia must also cooperate in de-mining efforts

at the border "sincerely". Renewed fighting between the Southeast Asian neighbours this month has killed at least 32 people, including soldiers and civilians, and displaced around 800,000, officials said. Each side has blamed the other for instigating the clashes, claiming self-defence and trading accusations of attacks on civilians. Cambodia did not immediately respond to Thailand's statement. - APP

SYDNEY: Indian police said on Tuesday that one of the gunmen in Australia's Bondi Beach shooting, Sajid Akram, was originally from the southern Indian city of Hyderabad but had limited contact with his family in India. The death toll in one of Australia's worst mass shootings stands at 16, including 50-year-old Akram, who was shot by police. The man's 24-year-old son and alleged accomplice, identified by local media as Naveed Akram, was in critical condition

Bondi Beach hero becomes source of pride

ALNAYRAB: Bondi Beach hero Ahmed al Ahmed, who put his life on the line by wresting a gun from an attacker in Australia's deadly mass shooting, has become a source of pride for his hometown in Syria. "His act is a source of pride for us and for Syria," Ahmed's uncle Mohammed, a farmer, told AFP in the town of Al-Nayrab.

Ahmed, a fruit seller and father of two children, emigrated to Australia from Syria in 2007, 60-year-old Mohammed said. On Sunday, 44-year-old Ahmed became a hero when he intercepted an attack on a gathering for a Jewish festival marking the start of Hanukkah. The attackers killed 15 people,

Pakistan renews pledge against terrorism on APS attack anniversary

President Zardari, PM Shehbaz reaffirm nation's resolve to eliminate terrorism from country

ISLAMABAD: The country is observing the 11th anniversary of the 2014 Army Public School (APS) attack in Peshawar today (Tuesday), with Prime Minister Shehbaz Sharif and President Asif Ali Zardari reaffirming the nation's resolve to combat terrorism and paid tribute to the victims of one of the deadliest school attacks in modern history. The heinous attack claimed the lives of 147 innocent students and teachers on December 16, 2014, and remains the bloodiest and most painful in the country's history, as six terrorists wearing military uniforms entered the school premises and

indiscriminately fired at students, teachers and staff. At least 147 people, including 122 students, embraced martyrdom, while the school's principal, Tahira Qazi and teacher Sofia Hijab were also martyred in the attack. President Asif Ali Zardari, in a statement issued on the 11th anniversary of the tragedy, said that Pakistan's commitment to defeating terrorism was absolute and reiterated that there could be no soft corner for terrorists or those who supported, financed, sheltered or justified them. "There can be no negotiations with those who raise arms

National gemstones policy finalized to enhance exports


ISLAMABAD: Special Assistant to the Prime Minister (SAPM) on Industries and Production Haroon Akhtar Khan on Tuesday chaired a meeting to review and finalize the National Gemstones Policy, aimed at unlocking the vast untapped potential of Pakistan's gemstones sector. During the meeting, specialized working groups on Import-Export, Banking and Finance, and Return & Refund Policies presented their recommendations for inclusion in the policy framework, said a news release. Haroon said that, following extensive consultations with experts, the policy and quality standards have been aligned with international benchmarks. In line with the vision of Prime Minister, the policy focuses on accelerating growth, promoting value addition, and transforming the gemstones industry into a competitive export-oriented sector. He emphasized that there is a strong consensus that Pakistan can emerge as a leader in the global gems and jewelry market. Highlighting existing challenges, the SAPM noted that the gemstones sector currently suffers from high wastage, limited value addition, and declining exports. Due to unscientific extraction and processing methods, up to 50 percent wastage occurs at various stages. Despite enormous potential, gemstone exports have remained limited to \$5-7 million in recent years. Haroon Akhtar underscored that, following stakeholder consultations, formalization and documentation of the entire gemstones value chain has been made a top priority of the policy. To stimulate growth, the government will provide targeted financing, streamlined facilitation, and smart incentives for the sector. - APP

Sindh cabinet okays several uplift projects

KARACHI: Sindh Chief Minister Syed Murad Ali Shah, presiding over a cabinet meeting, approved a wide-ranging financial and development package covering public transport, policing, wheat price relief, Thar coal connectivity, internal audit reforms, social protection, and the establishment of an IT Tower in the city The meeting, held at CM House on Tuesday, was attended by provincial ministers, advisers, special assistants, Chief Secretary Asif Hyder Shah, Principal Secretary to CM Agha Wasif and other concerned officers. It also confirmed the minutes of the Cabinet Committee on Finance presented by Local Government Minister Syed Nasir Hussain Shah. Among the major approvals, the cabinet sanctioned Rs964.4 million for the procurement and operation of public transport buses under a non-ADP scheme, Rs1 billion for the production of films, dramas and documentaries for public awareness, and

Rs5.84 billion for the procurement and financial discipline. The Sindh of arms and ammunition to strengthen the capacity of Sindh Police. The cabinet also approved funds for sports events, including assistance for the IMC Over-40s T20 Cricket World Cup, grants for SOS Children's Village in Tharparkar, establishment of a Project Implementation Unit under STEVTA, creation of posts in newly established colleges, procurement of vehicles for Sindh Prisons, and support for cultural initiatives, including the 10th Adab Festival. Additionally, funds were cleared for emergency water supply schemes in Malir, construction of an additional ramp at Korangi Causeway, renovation of a government girls' school in Saddar, and hosting of the 2nd Joint CPA Asia and CPA South-East Asia Regional Conference at the Sindh Assembly. The chief minister directed all departments to ensure the timely utilisation of funds and strict adherence to transparency

Cabinet approved a revision of the Wheat Release Policy for 2025-26, allowing the immediate release of government wheat at an issue price of Rs8,000 per 100 kg bag to flour mills, chakkies, and traders, thereby reducing the price from Rs9,500 per 100 kg. The decision aims to ensure market stability. The CM noted that early release would help maintain wheat quality, free up storage space and support affordable flour prices for the public. A sub-committee was constituted to closely monitor wheat prices and, if required, recommend adjustments to the government wheat issue price for cabinet consideration. The Sindh Cabinet approved the Regulatory Framework for Internal Audit under the Sindh Public Finance Administration Act, 2020, aimed at strengthening financial discipline, transparency and governance across government departments. - APP

Balochistan adonts hydroponics to transform agriculture

QUETTA: In a landmark move to modernize agriculture and tackle severe water scarcity, the Balochistan government has approved the introduction of hydroponics technology across the province The decision was finalized during a meeting of the Parliamentary Committee on the Public Sector Development Program (PSDP), chaired by Chief Minister (CM) Mir Sarfraz Bugti at the Chief Minister's Secretariat on Tuesday. The meeting, attended by parliamentary leaders from coalition parties, provincial ministers, and senior officials, endorsed a major project to establish hydroponic facilities and promote horticulture. The committee agreed that hydroponics-an advanced farming system that uses minimal water while delivering higher yields is ideally suited for Balochistan's arid climate. In the pilot phase, the project will begin in ten districts as successful results will pave the way for province-wide adoption. - APP

ITA issues 6,254 emission stickers so far

ISLAMABAD The Islamabad Transport Authority (ITA) on Tuesday released a 15-day performance report under its vehicle emission testing drive, showing inspections of 6,254 vehicles, issuance of 6,254 emission stickers, and action against 12 smoke-emitting vehicles In the last 24 hours, teams issued 486 stickers during inspections across the city. The campaign is part of ongoing efforts to limit air pollution through regular checks, roadside action, and expanded inspection points. The ITA said the vehicle emission testing system remains active across Islamabad with daily inspections and enforcement against vehicles found releasing smoke. The authority shared details of inspections, sticker issuance, and enforcement steps taken during the past 15 days, highlighting progress and future plans to improve access for citizens. According to the report, inspection teams checked 6,254 vehicles over the 15-day period and issued emission stickers to vehicles that met the required standards. These stickers confirm that a vehicle has passed

emission checks and can operate on city roads. In the last 24 hours alone, teams inspected vehicles at multiple locations and issued 486 emission stickers, showing steady daily activity. The authority also reported enforcement actions against vehicles found emitting smoke. During different operations, 12 vehicles were taken to police stations for further action under the relevant rules. Officials said these steps are meant to ensure compliance and discourage the use of vehicles that contribute to air pollution. ITA spokesperson said inspection teams are continuing checks across the city. He said teams are deployed on major roads and busy areas to identify vehicles that release smoke and to guide drivers on emission testing requirements. He added that the inspection process is being carried out regularly to cover more areas and maintain continuity. The report noted that roadside operations are ongoing on different highways and main roads. These operations focus on checking vehicle emissions, issuing stickers to compliant vehicles, and taking action

against those that fail to meet the standards. Officials said the presence of teams on key routes helps improve coverage and allows quick checks during peak traffic hours. The report also highlighted coordination among inspection teams working in different sectors of Islamabad. Teams are assigned routes and schedules to ensure citywide coverage. This approach, the authority said, allows inspections to continue without interruption and helps collect daily data on vehicle compliance. During the reporting period, teams focused on awareness alongside enforcement. Drivers were informed about the importance of emission testing and the process for obtaining stickers. Officials said guidance at inspection points helps drivers understand requirements and encourages voluntary compliance. The authority also urged vehicle owners to cooperate with inspection teams and ensure their vehicles undergo emission testing. Officials said compliance helps reduce pollution and supports public health goals.-DNA

EECP as non-invasive life-saving option for cardiac patients

ISLAMABAD: Senior cardiologist, Dr Raja Mehdi Hassan has highlighted Enhanced External Counterpulsation (EECP) therapy as an effective, non-invasive treatment for heart patients, particularly those with chronic angina, heart failure, or post-heart attack complications.

Talking to APP here on Tuesday, he said that cardiovascular diseases are increasing rapidly in Pakistan due to unhealthy diets, sedentary lifestyles,

and delayed diagnosis. "Many patients suffer fatal heart attacks during their first episode, with younger adults at higher risk due to underdeveloped collateral blood vessels", he added. Dr Mehdi explained that arterial blockages develop gradually, often beginning in early childhood, as fats and calcium accumulate in arterial walls. He said that most patients remain symptom-free until blockages exceed 70 per cent, after which chest pain,

breathlessness, and fatigue appear. He noted that early screening, including lipid profile, blood pressure, blood sugar and Body Mass Index (BMI) is crucial for prevention. Conventional treatment options include medications, angioplasty with stenting, and coronary artery bypass surgery, he said adding that some patients are either unfit for surgery, elderly, or reluctant to undergo invasive procedures.—APP

Within a year, the federal administration has moved to digital workflows that enhances transparency, enabling real-time oversight, and generating measurable savings for the public exchequer. Connectivity emerged as another central theme of the conversation. COP-30: Delivery, not discussion, experts agree

ISLAMABAD: The Institute of Regional Studies (IRS) convened the inaugural post-COP30 seminar to examine the outcomes of the UN climate conference held in Belém, Brazil, and its implications for Pakistan and other climate-vulnerable countries.

Ambassador Jauhar Saleem opened the discussion by highlighting Pakistan's disproportionate exposure to climate risks despite contributing less than 1% to global greenhouse gas emissions. He spoke about shrinking glaciers, increased water scarcity, deforestation, and worsening air pollution. He noted that cities like Lahore now rank among the most polluted globally. He also emphasized that fossil fuel consumption continues to dominate global energy use, while non-fossil sources remain far lower. While acknowledging Pakistan's progress in solar energy, especially micro-solar initiatives, he stressed that resilience alone is insufficient without measured finance and implementation. Ms. Zainab Naeem, Associate Research Fellow, SDPI, described COP as an important diplomatic space shaped as much by politics as by science. She highlighted discussions on transitioning away from fossil fuels, deforestation, and mitigating black carbon, a short-lived but highly dangerous pollutant from biomass and crop residue burning Hamza Haroon, Regional Director of South Asia for Climate Vulnerable Forum (CVF-V20) focused on climate finance and adaptation and highlighted the mismatch between climate losses and available funding. He noted that while new financing windows offer USD \$150 to 250



million, these amounts are inadequate compared to losses from climate disasters worth tens of billions. Tahanyat Satti, negotiator at UNFCCC, stressed the importance of

continuity in negotiations and warned that frequent changes in negotiators weaken developing countries' positions. SP judicial protection reviews security at red zone

ISLAMABAD: Superintendent of Police (SP) Judicial Protection Unit Muhammad Iqbal Khan visited the Red Zone and security duty points at the superior courts to review security arrangements and ensure effective performance by deployed personnel. Effective national security policies' implementation stressed

ISLAMABAD: Participants of a roundtable discussion emphasized the need for effective implementation of national security policies and developing a sustained narrative against terrorist violence. They were speaking at a roundtable discussion on the evolving counterterrorism response of Pakistan and the challenges of cross-border terrorism organized by the Institute of Regional Studies (IRS) in the backdrop of the 11th anniversary of the terrorist attack on the Army Public School (APS) in Peshawar in December 2014President IRS Ambassador Jauhar Saleem termed the 2014 APS tragedy a defining moment in Pakistan's history which paved the way for formulation of the National Action Plan (NAP) with a political consensus. He called for countering the terrorists' propaganda through a sustained counter-terrorism narrative. Former National Coordinator NACTA Mr Ihsan Ghani Khan highlighted the gaps in implementation of various good policy documents, including NAP. He maintained that tactical counterterrorism had a limited scope and needed to be bolstered by strategic counterterrorism that included well-thought-out policymaking and effective policy implementation. He added that since terrorism was

a crime, the law enforcement mechanisms needed to be strengthened through the revamping of the criminal justice system which was also the last point in NAP. Pakistan's former Special Representative for Afghanistan Ambassador Asif Ali Durrani also called for adopting a unified national narrative against terrorism. He urged the strengthening of the police force as first responders in countering terrorism and called for better interagency coordination among various government agencies and departments dealing with counterterrorism. The Founder and Editor of The Khorasan Diary Mr Iftikhar Firdous said that even though APS was a tragedy in scale and scope, Pakistani policymakers needed to take even attacks targeting the school buildings and not the schoolchildren seriously because in doing that the terrorists were targeting symbols of education in the country. He called for better governance in the merged districts of Khyber Pakhtunkhwa to counter terrorism in those areas. The Executive Director of the Centre for Law and Security (CLAS) Mr Rehman Azhar said that Pak-Afghan border has certain unique characteristics that need to be considered when devising border security strategies. He also called for implementation of NAP and an effective counter-narrative strategy against terrorism, especially in the two provinces most affected by it. In addition, he also called for seriously addressing the terror and crime nexus in the country.



RCCI terms SBP rate cut insufficient

RAWALPINDi: The Rawalpindi Chamber of Commerce and Industry (RCCI) has termed the State Bank of Pakistan's (SBP) recent policy rate cut as overdue but insufficient, stating that the reduction falls short of what is required to meaningfully revive economic activity.

President RCCI, Usman Shaukat, said that while the cut is a welcome step, the business community was expecting a substantial reduction bringing the policy rate into single digits (9% or below). He noted that the current cut is marginal and ineffective in boosting local production, exports, and overall industrial growth Usman Shaukat stressed that Pakistan's economy urgently needs a more competitive and growth-oriented interest rate regime to revive industrial activity, attract domestic and foreign investment, and enhance regional competitiveness. He recalled that in the previous Monetary Policy Committee meeting, concerns were raised about possible inflationary pressures due to floods, which ultimately did not materialize. "Given this, there was sufficient room for a deeper rate cut in the latest policy decision," he added. The RCCI President further stated that the finance minister had announced during his address at RCCI on 14 August that interest rates should be reduced, and while that commitment has now been partially fulfilled, the reduction remains too little to make a real difference for businesses struggling with high cost of capital. He expressed hope that in the upcoming monetary policy meeting, the SBP will announce a further reduction of at least 200 basis points or more, bringing the policy rate closer to single digits. Such a move, he emphasized, is critical for supporting industrial revival, export-led growth, and sustainable economic recovery. -DNA

forced masses of people to flee their homes and live in tents. The daily images and videos pouring in from Gaza were shocking and cruel and left the viewer with bitterness and a feeling of pent-up frustration. This in no way, however, justifies the targeting of civilians and their killing with such savagery.

The terrorist attack in Sydney took place at a precarious time in the Middle East. The region is awaiting the meeting between Donald Trump and Benjamin Netanyahu at the end of the month. People in the region are hoping that the master of the White House can persuade or force his visitor to facilitate the transition to the second phase of the Gaza ceasefire.

The Sydney attack also took place weeks after the international community broadly recognized a Palestinian state, marking an unprecedented diplomatic success and a step forward in resolving the Palestinian-Israeli conflict based on the two-state solution. Several countries, including Australia, took a step forward and concluded that there can be no resolving this long and bitter conflict without recognizing the Palestinian people's right to live in an independent state. The attack took place after countries and organizations came to realize that Israel is not the victim after discovering the extent of the oppression and injustice endured by the Palestinian people. There can be no choice but to corner extremist ideology and reject any justification for its behavior and savagery The most dangerous aspect of the attack is that it has helped fuel discourse about antisemitic practices. It has helped the Netanyahu government again portray itself as a victim by saying that Israel alone is a safe haven for Jews who are being targeted across the globe. The government has a successful record of exploiting such developments, as evidenced by Israeli officials quickly tying the Sydney attack to Australia's recognition of the state of Palestine.

Extremism is always ready to pounce. A day before the Sydney attack, Syria's Palmyra was the scene of a significant attack that targeted American and Syrian military personnel. The attack was a reminder that Daesh may have been defeated but it has not been eliminated. The attack was a reminder that building the new Syria under the leadership of Ahmad Al-Sharaa will not be at all easy and that difficult confrontations with extremists lie ahead. The Middle East has for decades paid the price of unprecedented injustice and practices that sought to eliminate the other. Countries in the region and their people have lost decades of their lives. They have lost opportunities to advance and catch up with the current era. There can be no escaping the endless cycles of injustice, killing and extremism without insistence on pursuing peace and justice. There can be no choice but to build a state of law and institutions and to have respect for international law, human rights and dignity. There can be no choice but to corner extremist ideology and reject any justification for its behavior and savagery. For far too long, extremism has fed on injustice to justify its existence and proliferation. Tackling extremism starts with tackling injustice against peoples, groups and individuals. Peace can only be built on justice and equality under law.

How Narratives Become Weapons

N recent years, the information warfare has become a convenient label for nearly every dispute-taking place on television screens, social media timelines, and diplomatic platforms. Information warfare does not begin with technology; it begins with intent. At its core, it is the organized effort to influence what people believe, how they interpret events, and how they make decisions. The actors involved identify a strategic objective perhaps to discredit an opponent, create doubt around an institution, soften resistance to a policy, or simply distract the public from a sensitive issue. Once the objective is defined, the next step is to design a message that serves this purpose. This message may be entirely false, partly distorted, or based on selective truth. What matters is not factual accuracy, but its ability to achieve the intended psychological effect.

The second layer of information warfare involves identifying the audience. Contrary to the impression created by the sheer chaos of online communication, the targeting of audiences is far from random. Different groups are mapped according to their political leanings, social grievances, emotional triggers, and information habits. Some audiences are chosen because they are sympathetic and can amplify the message; others because they are vulnerable and can be manipulated; still others because they are influential and can legitimize the narrative. In many cases, the same message is packaged differently for each audience, giving the impression of organic conversation while serving a coordinated strategy. After the message and the target are determined, the next question is distribution. Here, the digital environment becomes central. Social media platforms enable speed, repetition, and scale. A single post, if amplified by networks of aligned accounts, can travel through thousands of feeds in minutes. Bots and anonymous accounts add layers of noise, making it difficult to identify the original source. Some-

times, false or distorted content is seeded tives find greater room to operate. in smaller online communities where it can grow without scrutiny before being pushed into mainstream discourse. Traditional media may then pick up fragments of these narratives sometimes unintentionally giving them a sense of legitimacy. Information warfare also relies heavily on timing. Messages are often released to coincide with moments when the public is already anxious or confused during political crises, international conflicts, economic downturns, or major social incidents. In these moments, the boundaries of certainty are thinner, and people are more receptive to simplified explanations or emotionally charged interpretations. A narrative introduced at the right moment can overshadow verified information, crowd out alternative perspectives, or redirect attention entirely.

Another key element is repetition. Even the most implausible claims can begin to feel familiar through constant exposure. Repetition does not persuade through logic; it persuades through familiarity. The more frequently a narrative appears, the more "natural" it seems. This is why information warfare rarely depends on a single message. Instead, it unfolds through a steady flow of posts, comments, videos, statements, and commentary all reinforcing the same underlying theme. Information warfare also thrives on ambiguity. Rather than presenting a clear alternative version of reality,

It is also important to understand that not all information warfare is foreign or coordinated. Domestic actors politicians, pressure groups, commercial interests use similar tactics to shape public perception. During elections, governments and opposition parties alike craft selective narratives, highlight or conceal information, and rely on online networks that blur the line between persuasion and manipulation. Similarly, commercial entities may use tailored messaging to influence consumer attitudes or discredit competitors. The techniques may differ in sophistication, but the underlying logic remains similar. A particularly concerning aspect is the speed at which false or misleading content spreads compared to verified information. Verification requires time, evidence, and consistency; misinformation requires none of these. Once a claim circulates widely, corrections rarely achieve the same reach, even when they are clear and authoritative. In some cases, attempts to correct misinformation only reinforce the false narrative by keeping it in public discussion. Information warfare also benefits from a deep-

ening distrust in traditional institutions. When citizens feel isolated from political processes, disillusioned with public service delivery, or suspicious of mainstream media, they become more receptive to simplified explanations and emotionally charged narratives. This creates fertile ground for actors who operate with minimal accountability. It requires rebuilding public trust through transparency, improving media literacy, and strengthening independent journalism. Citizens must learn to recognize patterns of manipulation, question the origins of the information they encounter, and demand evidence rather than emotion. Institutions, for their part, must communicate more clearly, respond to crises more responsibly, and avoid creating information vacuums that others can exploit.

The Fitnah of Fake News

ROM its earliest days, journalism has striven to preserve an identity grounded in authenticity, responsibility, and truth. Across the world, including Pakistan, those committed to this noble craft laboured to ensure that the news reaching the public remained uncoloured by personal motives or sensational distortions. It was a profession that demanded integrity, patience, and respect for facts. For decades, it remained rare that journalists felt compelled to embellish or cloak their work in unrealistic hues merely to attract attention. The craft stood firmly upon the pillars of credibility and public trust.

However, as technology advanced with unprecedented speed, doubts gradually arose about the very foundation upon which journalism was built. The emergence of digital manipulation and artificial intelligence brought with it a crisis that the world had never before experienced in such magnitude. The old lines that separated truth from falsehood became blurred, not due to the failure of journalism itself, but due to tools that enabled falsehood to travel faster than truth and to appear more convincing than reality. Voices could be mimicked with startling precision, images altered without detection, and entire incidents fabricated by a few strokes of digital ingenuity.

The age of fake news dawned quietly at first, but soon its echoes were heard across continents. In the beginning, it led to severe blunders. False reports spread like wildfire, shaping public opinion before the facts could even surface. It was exploited to launch negative trends, destroy reputations, and weaken social harmony. Personalities found themselves accused of actions and statements with which they had no connection, yet the public-bewildered and overwhelmed-struggled to separate the genuine from the fraudulent. Deepfakes intensified this crisis further, creating confusion between states, fuelling misunderstandings, and widening diplomatic and social rifts.

A recent and telling example was the attempt to link the Sydney terror attack to Pakistan. Within hours, a wave of accusations and outrage emerged, particularly from India, Afghanistan, and Israel, even though no credible investigation had yet established the identity or origin of the attackers. The narrative spread rapidly, reinforcing long-held prejudices and political biases. It was only later revealed that the perpetrators were, in fact, from India. By then, the damage had already been done. The initial falsehood had travelled far and wide, while the correction struggled to receive comparable attention. One is compelled to ask whether the silence from these three countries that followed was born of embarrassment, or whether facts themselves had become inconvenient in an age driven by instant outrage rather than patient inquiry. Even state institutions, once considered immune to such distortions, became targets of fabricated material designed to erode public confidence. But perhaps nowhere did this scourge strike more severely than in the realm of politics. There, the misuse of technology became rampant, not for constructive criticism or healthy debate, but for defamation, humiliation, and the systematic dismantling of opposing viewpoints. The very essence of tolerance, once a hallmark of political discourse, began to disintegrate. Respect for dissent faded, replaced by hostility shaped not by facts but by manipulated narratives.

It would not be an exaggeration to call this the greatest tribulation of our time-one that threatens not only journalism but societal stability itself. The Holy Prophet (Peace Be Upon Him) warned of such times near the Day of Judgment, when falsehood would spread rapidly, truth would be suppressed, and people would believe lies as readily as they once believed facts. In one Hadith, the Prophet (PBUH) said that a time would come when "the liar will be believed and the truthful will be rejected; the deceiver will be trusted and the trustworthy will be considered treacherous." This description mirrors the very challenges we witness today, where manipulated voices, forged images, and fabricated reports sow chaos and discord. The question then arises; how should journalism combat this tribulation, and how can countries, institutions, and individuals be protected from its consequences? The answer lies in a return to the core values that once defined journalism. Newsrooms must cultivate rigorous verification systems and embrace transparency in their methods. Journalists must be trained to recognise digital manipulation and armed with tools to detect falsehood. Media organisations should develop ethical codes that clearly reject sensationalism and prioritise accuracy over speed.

On a national scale, countries must establish regulatory frameworks that address the misuse of artificial intelligence without stifling innovation. Public awareness campaigns are vital to educate citizens about identifying fake news, verifying sources, and resisting the impulse to share unverified information. State institutions, too, must strengthen their communication channels so that official information remains clear, timely, and accessible.

Individuals carry a responsibility as well. In an age where every person with a smartphone can amplify news, each citizen must become a guardian of truth rather than an unintentional spreader of falsehood. The principles found in the Qur'an and Sunnahverification, justice, patience, and fairness-should guide the behaviour of every individual consuming or sharing information. Journalism stands today at a crossroads. The tools of deception may be powerful, but the commitment to truth, supported by timeless divine teachings and human conscience, remains stronger. If journalism, state institutions, and individuals unite to uphold authenticity, this tribulation-formidable though it is-can be confronted with clarity, discipline, and faith. Truth has always prevailed over falsehood, and in this technological age, it must do so once again through wisdom, vigilance, and unwavering adherence to principles.

EU set to scrap 2035 ban in car industry boost

landmark 2035 ban on new petrol and diesel cars on Tuesday, as part of a package of reforms aimed at supporting Europe's embattled auto industry. Carmakers and their backers have lobbied hard for Brussels to relax the ban over the past year - in the face of fierce competition from China and a slower-than-expected shift to electric vehicles (EVs). The European Commission is expected to propose replacing it with a less ambitious 90-percent emission-reduction target, in a move critics say risks undermining the EU's green agenda and deterring investments in electrification.

"This is a critical milestone for the future of the sector. There is a lot at stake," Sigrid de Vries, the head of European auto lobby ACEA told a press conference in Brussels on Monday, referring to the expected reforms. Set in 2023, the ban was a cornerstone of the EU's environmental Green Deal, which has come under increased pressure from businesses and right-wing politicians as the EU seeks to bolster its industry. "There is a clear demand for more flexibility on the CO2 targets," commission spokeswoman Paula Pinho told a press conference Friday, saying Brussels was "aiming for balance". Carmakers argue the 2035 goal to have only electric vehicles sold in Europe, and an intermediate 2030 target, are no longer realistic. High upfront costs and the lack of adequate charging infrastructures in parts of the 27-nation bloc mean consumers have been slow to warm to EVs, producers say. Just over 16 percent of new vehicles sold in the first nine months of 2025 run on batteries, according to ACEA. Automakers would like to see continued sales authorised for hybrids with rechargeable batteries or those equipped with range extenders (small combustion engines which recharge the battery instead of powering the wheels). Germany supports this option

as do eastern European nations where German carmakers have set up factories. Others, like Italy, want to see the use of alternative fuels such as those derived from agricultural crops and waste products allowed. "EVs will be the dominant choice, but to make the transition work for society and industry, other options must be available too," de Vries said in a social media post. In the other camp are France, the Nordic countries and Spain who have long called for keeping to the planned trajectory in order not to harm firms that have invested in the transition to electric vehicles. Last week Manfred Weber, the conservative head of the EU parliament's largest group, said the 2035 ban would be discarded with carmakers required to meet a 90-percent reduction in CO2 emissions from their fleet instead. EU sources confirmed to AFP that was likely, adding the review would proba-

Machado previously said she feared for her life during the perilous voyage to receive her Nobel in Oslo. Norwegian daily Aften-

posten said the injury was sustained during a high-risk sea crossing in a small fishing boat battered by high waves. "The vertebra fracture is confirmed," Machado's spokeswoman Claudia Macero said. "For the moment, no addi-

Al-Rashdan Header Sends Jordan Into Historic Arab Cup Final

DOHA: A header by Nizar Al-Rashdan gave Jordan a 1-0 victory in a tense match against Saudi Arabia on Monday and sent them to their first Arab Cup final. Deprived of the services of Yazan Al-Naimat, who suffered a devastating knee injury in their quarter-final against Iraq, Jordan delivered a brave performance, greatly limiting the Saudi attacking threat across the 90 minutes. The semi-final at Al-Bayt Stadium in Qatar attracted the highest attendance of the tournament so far, a vibrant crowd of 62,825. Both sides began cautiously, with Jordan lining up in a robust 5-4-1 formation that sought to restrict Salem Al-Dawsari and Saleh Abou Al-Shamat in the final third. The game opened up a little after the break, as a tactical change from Jordan helped them gain greater control on the counterattack. Mohammed Abu Zrayq in particular proved influential down the right flank as he stretched the Saudi defense and gave the Nashama more attacking momentum. The decisive moment, however, came from the opposite side, Mahmoud Al-Mardi delivered a dipping cross from the left, catching the Green Falcons' defense off guard, and Al-Rashdan rose to head home the only goal of the match in the 66th minute. Saudi Arabia responded with a series of substitutions, including the introduction of Al-Qadsiah midfielder Musab Al-Juwayr. The former Al-Hilal player helped link play between Al-Dawsari and Feras Al-Brikan down the left channel as the Saudis pressed for the equalizer. - Agencies

US kills 8 in eastern Pacific strikes on alleged drug boats WASHINGTON: Strikes on three alleged

drug-trafficking vessels in the eastern Pacific Ocean killed eight people on Monday, according to the US military, the latest in a controversial campaign that has killed dozens of people. Since early September, the US military under Pentagon chief Pete Hegseth has targeted alleged drug-smuggling boats in the Caribbean Sea and eastern Pacific Ocean, destroying at least 26

vessels and killing at least 95 people. The US Southern Command announced the latest three strikes on X, saying the eight men killed had been involved in drug trafficking, without providing evidence. The post included video footage of three separate boats floating in water before they are each hit by strikes. "Intelligence confirmed that the vessels were transiting along known narco-trafficking routes in the Eastern Pacific and were engaged in narco-trafficking," it said. The strikes killed three men in the first vessel, two in the second and another three in the third, the US Southern Command added. The strikes have drawn intense scrutiny from human rights advocates and Democratic lawmakers, with the United Nations's human rights chief warning last month they could violate international law. The US administration has labeled those killed as "unlawful combatants" and said it can legally engage in lethal strikes without judicial review due to a classified Justice Department finding. US authorities have not provided specific evidence that the boats it has targeted were ferrying drugs. Senate Minority Leader Chuck Schumer

said that there would be an all-senators

briefing Tuesday on the "administration's rogue and reckless actions in the Caribbean", with Hegseth and US Secretary of State Marco Rubio.

"The American people deserve oversight. We intend to deliver it," the senior Democratic party lawmaker said in an X post published before the latest strike announcement by the US military.

The strikes have been accompanied by a massive US military buildup in the Caribbean that includes the world's largest aircraft carrier and a slew of other warships. US President Donald Trump has insisted the goal is combating narco-trafficking, while Venezuelan President Nicolas Maduro says he suspects it is a pretext for leadership change in Caracas.

The admiral leading US forces in the Caribbean, Alvin Holsey, stepped down last week, just a year into his tenure and after reportedly expressing concerns about the boat strikes. Neither he nor Hegseth have publicly provided a reason for his early departure. "We must always be there for like-minded partners, like-minded nations who share our values - democracy, rule of law and human rights," Holsey said in a ceremony to mark him relinquishing command. During one of the first strikes in September, survivors of an initial attack on a boat were killed in a second US strike on the vessel, generating accusations of a possible war crime since media reported details of the incident in November. Hegseth has maintained he did not order a second strike, instead attributing

Argentina Hand Pakistan Another Heavy Pro League Defeat

Pakistan's struggles continued in the FIH Pro League as Argentina outclassed them 5-1 in Santiago del Estero, exposing defensive frailties and leaving Pakistan bottom of the standings

SANTIAGO DEL ESTERO: Pakistan men's hockey team continued their difficult debut campaign in the FIH Pro League as they suffered a heavy 5-1 defeat at the hands of Argentina at the Santiago del Estero Hockey Club on Tuesday. Argentina dominated proceedings from the outset, combining clinical penalty-corner execution with sharp aerial play to register a commanding victory and move to the top of the Pro League standings with 11 points. Pakistan, meanwhile, slumped to their fourth consecutive loss and remain rooted at the bottom of the table.

Los Leones opened the scoring through Nicolas Della Torre, whose powerful drag flick from a penalty corner took a deflection off Pakistan defender Muhammad Abdullah and wrong-footed goalkeeper Muneeb Ur-Rehman. One such aerial found Joaquin Toscani, who controlled well before delivering a bouncing ball into the circle for Bautista Capurro to deflect home, giving the hosts a 2-0 lead at the end of the first quarter. Argentina struck again through Capurro in the second quarter after Maico Casella kept the pressure alive following a failed Pakistani clearance. Casella found space and slid a pinpoint pass across the goal,

allowing Capurro to tap in his second and make it 3-0.

Iraq's dreams of wheat independence dashed by water crisis

NAJAF: Iraqi wheat farmer Ma'an Al-Fatlawi has long depended on the nearby Euphrates River to feed his fields near the city of Najaf. But this year, those waters, which made the Fertile Crescent a cradle of ancient civilization 10,000 years ago, are drying up, and he sees few options. "Drilling wells is not successful in our land, because the water is saline," Al-Fatlawi said, as he stood by an irrigation canal near his parched fields awaiting the release of his allotted water supply.= A push by Iraq - historically among the Middle East's biggest wheat importers - to guarantee food security by ensuring wheat production covers the country's needs has led to three successive annual surpluses of the staple grain. But those hard-won advances are now under threat as the driest year in modern history and record-low water levels in the Tigris and Euphrates rivers have reduced planting and could slash the harvest by up to 50 percent this season. "Iraq is facing one of the most severe droughts that has been observed in decades," the UN Food and Agriculture Organization's Iraq representative Salah El Hajj Hassan told Reuters. The crisis is laying bare Iraq's vulnerability. A largely desert nation, Iraq ranks fifth globally for climate risk, according to the UN's Global Environment Outlook. Average temperatures in Iraq have risen nearly half a degree Celsius per decade since 2000 and could climb by up to 5.6 C by the end of the century compared to the period before industrialization, according to the International Energy Agency. Rainfall is projected to decline. But Iraq is also at the mercy of its neighbors for 70 percent of its water supply. And Turkiye and Iran have been using upstream dams to take a greater share of the region's shared resource. The FAO says the diminishing amount of water that has trickled down to Iraq is the biggest factor behind the current crisis, which has forced Baghdad to introduce rationing. Iraq's water reserves have plunged from 60 billion cubic meters in 2020 to less than 4 billion today, said El Hajj Hassan, who expects wheat production this season to drop by 30 percent to 50 percent. "Rain-fed and irrigated agriculture are directly affected nationwide," he said. To wean the country off its dependence on imports, Iraq's government has in recent years paid for high-yield seeds and inputs, promoted modern irrigation and desert farming to expand cultivation, and subsidised grain purchases to offer farmers more than double global wheat prices It is a plan that, though expensive, has boosted strategic wheat reserves to over 6 million metric tons in some seasons, overwhelming Iraq's silo capacity. The government, which purchased around 5.1 million tons of the 2025 harvest, said in September founder of Iraq Climate Change Center - now expect imports to rise again, putting the country at greater risk of higher food prices with knock-on effects for trade and government budgets. "Iraq's water and food security crisis is no longer just an environmental problem; it has immediate economic and security spillovers," Istepanian told Reuters. A preliminary FAO forecast anticipates wheat import needs for the 2025/26 marketing year to increase to about 2.4 million tons Global wheat markets are currently oversupplied, offering cheaper options, but Iraq could once again face price volatility. Iraq's trade ministry did not respond to a request for comment on the likelihood of increased imports.-DNA

Sudan general ready to talk to Trump for peace

PORT SUDAN: Sudan's de facto leader, General Abdel Fattah Al-Burhan, is ready to work with US President Donald Trump to resolve the conflict splitting his country, the foreign ministry said Tuesday. The ministry released a statement after the army chief visited Riyadh as a guest of Saudi Arabia's Crown Prince Mohammed bin Salman, who recently presented Trump with a proposed Sudan peace plan during a Washington visit. According to Sudan's statement, Burhan hailed Trump's "determination to engage in efforts to achieve peace and end the war in the country, with the participation of the Kingdom of Saudi Arabia. "He affirmed Sudan's keenness to work with President Trump, his secretary of state, and his envoy for peace in Sudan to achieve this unquestionably noble goal," it said, referring to Marco Rubio and US envoy Massad Boulos. International peace efforts led by mediators from the United States, Egypt, Saudi Arabia and the United Arab Emirates have been at a standstill since Burhan rejected Boulos's last suggested framework. The RSF says it supports the international ceasefire plan, but heavy fighting continues, notably in the southern region of Kordofan For the moment, no new date has been announced for talks, neither under the US-led mediators nor a parallel United Nations' led effort.= Since April 2023, Sudan has been gripped by a war pitting the army, which controls the north and east of the country, against the RSF, dominant in the west and certain areas of the south. The conflict has killed tens of thousands of people, uprooted millions and triggered what the UN calls "the world's worst humanitarian crisis."-APP

He said the focus was now on enhancing trade and investment flows, adding that energy, oil and gas, as well as minerals and mining, had emerged as key sectors for potential joint projects. "These are clear areas of focus as we move forward," he remarked. oviding details on the proposed investment package, Senator Aurangzeb said discussions

were underway with Azerbaijan's state oil company SO-CAR, which was exploring the possibility of investing in an oil pipeline project in Pakistan. He termed the talks as being at an early stage but expressed hope that it could be among the first projects to materialize Commenting on Azerbaijan's readiness to provide a further \$1 billion loan to Pakistan, the finance minister said the financing could take multiple forms, including placements with the State Bank of Pakistan or support for Azerbaijani investors operating in Pakistan. He emphasized that Pakistan was not seeking aid, but rather sustainable financing linked to trade and investment activities. On cooperation in the digital economy, the minister said Pakistan was keen to learn from Azerbaijan's progress in technology-led service centers, artificial intelligence, fintech, and cyber security. He added that Pakistan's journey towards becoming a "Digital Pakistan" offered scope for collaboration in payment

systems, digital infrastructure, Web 3.0, and AI. Looking ahead, Senator Aurangzeb highlighted the importance of South-South cooperation amid stress in the global trade regime, noting that new trade corridors linking Pakistan with Central Asian republics, particularly Azerbaijan, could become strategically important over the next five years. He said current bilateral trade of less than \$50 million did not reflect the true potential of the two economies, and efforts were underway to identify priority sectors to make trade flows more meaningful. The minister also underscored the need for developing financial instruments such as joint grants, guarantees, export credit insurance, and Islamic finance to support bilateral trade and investment. He said facilitation measures, including opening bank offices and representative branches in both countries, would play a crucial role in advancing the ambitious economic agenda between Pakistan and Azerbaijan.-DNA

India, Jordan agree to twin UNESCO sites of Petra, Ellora

NEW DELHI: Jordan and India have signed an agreement to twin the iconic ancient city of Petra with the Ellora Caves, one of the world's largest complexes of rock-cut Hindu, Buddhist and Iain temples dating from the 6th to 11th centuries C.E. One of the most famous archaeological sites, Petra is situated between the Red Sea and the Dead Sea in southwest Jordan. When the Nabataeans, an Arab tribe, made it the capital of their kingdom around 300 B.C.E., it flourished as a center of the spice trade that involved such disparate realms as China, Egypt, Greece, and India. The Ellora Caves are 34 monasteries and temples, extending over more than 2 km, some 30 km from Aurangabad, in India's Maharashtra state. Their twinning agreement followed Prime Minister Narendra Modi's talks with King Abdullah in Amman on Tuesday and was among a series of cooperation memoranda - including in renewable energy, water resources management, and culture. "These outcomes mark a meaningful expansion of the India-Jordan partnership," Modi said on social media on Tuesday. "The Twinning Agreement between Petra and Ellora opens new avenues for heritage conservation, tourism and academic exchanges."APP

MOSCOW: Russian authorities said a 10-year-old child was killed Tuesday in a stabbing by a fellow student in a school in the Odintsovo District near Moscow, with the suspect now apprehended. "Police received a report that a student had stabbed a security guard, sprayed pepper spray and then stabbed a 10-year-old student, who died from his wound," local police said on Telegram, adding that "the attacker was detained" and taken into custody.-APP

Lebanon approves release of former minister accused of corruption

BEIRUT: Lebanon's judiciary approved the release on bail of former economy minister Amin Salam on Tuesday after six months of detention over corruption linked to contracts deemed suspicious, a judicial official said. Salam, who served in the cabinet of former prime minister Najib Mikati from 2021 to 2025, is the only ex-minister to be arrested since the start of Lebanon's economic crisis in 2019. The official, who requested anonymity, told AFP Lebanon's judiciary "agreed to release former economy minister Amin Salam on bail of nine billion Lebanese pounds, equivalent to \$100,000" and a travel ban. The official added that the bail was paid, with procedures ongoing to secure his release from prison.

In June, another judicial official said Salam had been arrested in connection with alleged "falsification, embezzlement and suspicious contracts." Salam's adviser Fadi Tamim was sentenced in 2023 to one year in prison for blackmail and personal enrichment at the expense of insurance companies The former minister's brother Karim Salam was also arrested earlier this year in a "case of illicit enrichment, forgery and extortion of insurance companies," committed "under cover of the minister himself," the official said in June. Many in Lebanon attribute the economic crisis to mismanagement and corruption that has plagued state institutions for decades. President Joseph Aoun and Prime Minister Nawaf Salam, who both took office this year, have vowed to make the fight against endemic corruption a priority, as part of the reforms demanded by international donors. Both have vowed to uphold the independence of the judiciary and prevent interference in its work, in a country plagued by official impunity. In September, former central bank governor Riad Salameh, who faces numerous accusations including embezzlement, money laundering and tax evasion, was released after being detained for over a year by paying a record bail of more than \$14 million.-APP

IHC turns down Justice **Jahangiri's** objections on CJ

ISLAMABAD: The Islamabad High Court (IHC) has turned down Justice Tariq Mehmood Jahangiri's objections on a division bench, led by Chief Justice Sardar Muhammad Sarfraz Dogar, hearing challenges to the legitimacy of his law degree and appointment as a judge, it emerged on Tuesday.

The objections were raised by Justice Jahangiri, also an IHC judge, during the hearing of the petition challenging his qualification on Monday, with CJ Dogar and Justice Muhammad Azam Khan presiding over the proceedings. The bench comprising Justices Dogar and Khan previously also barred Justice Jahangiri from judicial work in September in the case, but the order was later set aside by the Supreme Court (SC).

Justice Jahangiri appeared in person before the bench yesterday and presented his arguments. A court order issued after the hearing, seen by Dawn, said he had raised preliminary objections on the constitution of a division bench instead of a single bench to hear lawyer Mian Dawood's petition. Moreover, Justice Jahangiri "expressed his no confidence" in the bench on the ground of filing of an intra-court appeal against CJ Dogar in the SC, the order stated.

HRCP concerned over cubs on media

KARACHI: The Human Rights Commission of Pakistan (HRCP) on Tuesday expressed grave concern over the "rapidly shrinking space for independent and critical news reporting in the country", including the ban on government advertisements to the Dawn Media Group and its outlets. The development comes as

several media bodies have condemned the government's unannounced restriction on advertisements to Dawn Media Group's TV and radio outlets - imposed after curtailing ads to its flagship newspaper – and called on the authorities to immediately rescind the ban.

"The HRCP expresses grave concern over the rapidly shrinking space for independent and critical news reporting in the country, including the reported 13-month ban on government advertisements to the Dawn Media Group, which has recently been extended to Dawn News and CityFM89," the commission said in a post on social media platform X on Tuesday. "This is ironic, given that Mohammad Jinnah, the founder of Dawn, championed press freedom," it said.

ISLAMABAD: The Embassy of Ukraine in Pakistan has strongly rejected a recent statement issued by the Embassy of the Russian Federation, describing it as an exercise in "hybrid information warfare" based on propaganda, disinformation and distorted facts. In a detailed rebuttal, Ambassador of Ukraine to Pakistan, H.E. Markiian Chuchuk, said Russia's attempt to label its actions as a "Ukrainian crisis" was misleading and aimed at obscuring responsibility for what he described as a clear act of aggression. He emphasized that under international law, Russia's actions since 2014 – including the annexation of Crimea and the full-scale invasion launched on February 24, 2022 - constitute an international armed conflict initiated by Moscow.

The ambassador cited multiple UN General Assembly resolutions condemning Russia's actions and reaffirming Ukraine's territorial integrity, stating that Ukraine is exercising its lawful right to self-defence under Article 51 of the UN Charter. He dismissed Russian claims of external provocation as "legally null and void."

Addressing Russia's criticism of international legal mechanisms, the Ukrainian envoy said accountability and reparations were essential for a just and lasting peace, adding that asset freezes and damage registers were lawful responses to grave violations of international law.

Ukraine's leadership, stating that elections could not be held due to the war initiated by Russia and that Ukraine's constitutional framework clearly provides for continuity of governance under martial law. Concluding his statement, the Ukrainian envoy said the Russian embassy's remarks demonstrated a lack of genuine willingness to pursue peace based on international law, while reaffirming Ukraine's commitment to negotiations grounded in the UN Charter.

Imran-Faiz May 9 nexus claims lack explicit ISPR backing

ISLAMABAD: Despite repeated assertions by senior cabinet members that a nexus between former prime minister Imran Khan and former ISI chief Lt Gen (retd) Faiz Hamid was behind the May 9 violence, the military's media wing has not explicitly made such a claim in any of its public statements so far. Diesel price slashed

ISLAMABAD: The federal government on Monday decided to keep the petrol price unchanged at Rs263.45 per litre for the next fortnight, following recommendations from the Oil and Gas Regulatory Authority (Ogra) and the relevant ministries. The price of high-speed diesel, meanwhile, has seen a significant decline of Rs14 per litre, effective from December 16, read a notification issued by the Petroleum Division.

Diesel will now be priced at Rs265.65 per litre for the next 15 days. Ogra had earlier rejected reports claiming fuel prices could be cut by up to Rs12 per litre from December 16, terming them "purely speculative" and unrelated to any formal pricing exercise by the regulator. In a press statement issued on December 13, the authority said that it calculates petroleum prices in accordance with federal government instructions and only within the notified timeframe.

Multiple media reports had suggested a reduction in domestic fuel prices, citing official sources. Petrol is mainly used in private transportation, small vehicles, rickshaws, and two-wheelers. Higher fuel prices significantly impact the budgets of the members of the middle and lower-middle classes, who primarily consume petrol for commuting. On the other hand, a significant portion of the transport sector relies on high-speed diesel. Its price is considered inflationary since it is predominantly used in heavy goods transport vehicles, trucks, buses, trains, and agricultural machinery such as tractors, tube wells, and threshers. The consumption of highspeed diesel particularly contributes to the increased prices of vegetables and other food items.

Earthquake shakes parts of Karachi, Balochistan

Seismic monitoring centre says earthquake's epicentre was in Balochistan's

KARACHI: A moderate earthquake measuring 5.2 struck parts of Karachi and Balochistan late on Monday night, causing panic among citizens. The National Seismic Monitoring Centre of the Pakistan Meteorological Department (PMD) said the earthquake's epicentre was in Balochistan's Sonmiani, with a depth of 12 kilometres and was centred about 87 kilometres from Karachi. Sonmiani is a coastal village in southeastern Balochistan. In Balochistan, the tremors were felt in Hub, Vinder, and Gadani. Earlier today, a 3.2-magnitude earthquake rattled Balochistan's Sibi city and surrounding areas, with its epicentre 53 kilometres away from city, with no reports of any casualties or damage.

10 hostages freed in overnight operation

SUKKUR: A night long operation led by DIG Sukkur Capt (Retired) Faisal Abdullah Chachar resulted in the rescue of 10 hostages abducted by dacoits who attacked a bus near Obauro, Ghotki district. According to a press release, issued here on Tuesday, Police and Rangers exchanged fire with the dacoits in Somiani, freeing the hostages. The rescued hostages informed that two dacoits were injured during the operation.

The bus, traveling from Sadiqabad to Quetta, was attacked, and several passengers were abducted. The operation, led by DIG Sukkur with Rangers, blocked the dacoits' escape routes, preventing them from taking hostages to the kachho area. The hostages were safely taken to a secure location. Roadblocks are in place, and the pursuit of dacoits continues. The operation will continue until all involved dacoits are eliminated. - APP

Israel deprioritizing humanitarian aid. **UN warns**

UNITED NATIONS: Humanitarian assistance in Gaza is being delayed because aid cargo is routinely deprioritized by Israel in favour of commercial goods, the UN's aid coordination office (OCHA) warned Monday, as winter storms continue to worsen already dire living conditions for displaced families. Despite sustained efforts by the UN and its partners, needs are rising faster than aid can be delivered, according to Olga Cherevko, an OCHA spokesperson in Gaza.

"We continue to provide a response, but the needs outpace the speed with which we can respond," she said, pointing to the limited volume of supplies entering the Strip and a growing list of items which continue to be blocked by Israeli authorities, including heavy machinery, equipment and spare parts needed to repair damaged infrastructure. With repeated storms flooding large areas in recent weeks, humanitarian agencies have prioritised emergency winterisation. An estimated 1.3 million people are currently in need of shelter assistance.

"When the storms came, many people lost everything – it washed away everything that they had," Ms. Cherevko said.

Over the past few days, aid teams have distributed around 3,800 tents, more than 4,500 tarpaulins and thousands of bedding items, assisting some 4,800 families. The response has included plastic sheeting,

cooking sets and short-term food assistance to help families survive the immediate aftermath of flooding. Some of the most floodprone locations have been identified by local authorities as unsafe, prompting several hundred families to relocate voluntarily. The UN and its partners have supported these moves by preparing and levelling sites and installing tents to ensure minimum conditions for safety and dignity.

Winter conditions continue to pose serious health risks, particularly for infants. "The risks of hypothermia are heightened, and babies are in very high danger," Ms Cherevko warned. UN partners are also raising awareness among caregivers, including guidance on body-to-body contact to help keep young children warm. Beyond shelter, humanitarian operations include food assistance, nutrition screening, health service points and the gradual reopening of learning facilities. - APP
